(57) **CLAIM**

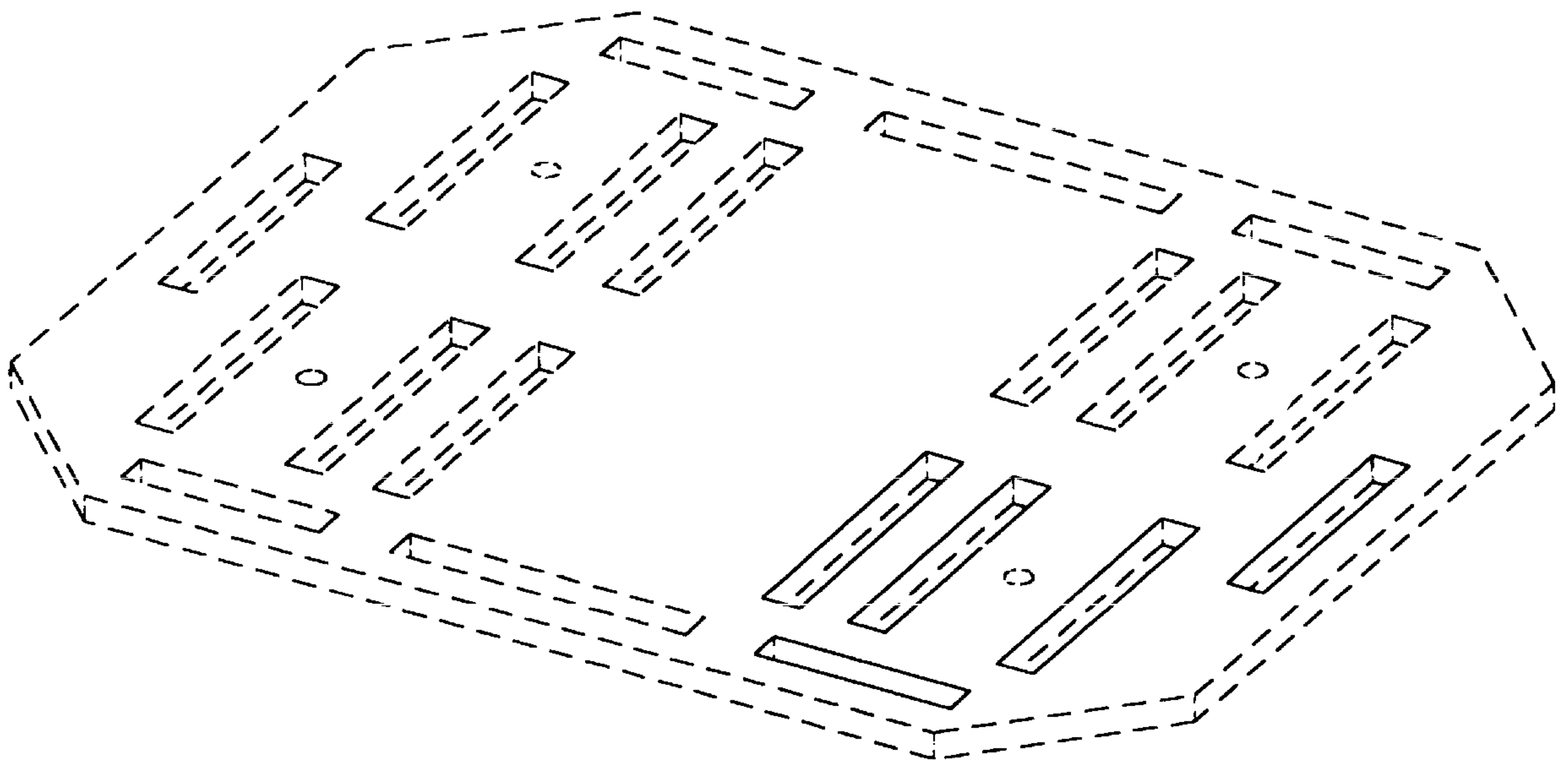
We claim the ornamental design for a mounting interface, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a mounting interface; and, FIG. 2 is a top plan view of the mounting interface.

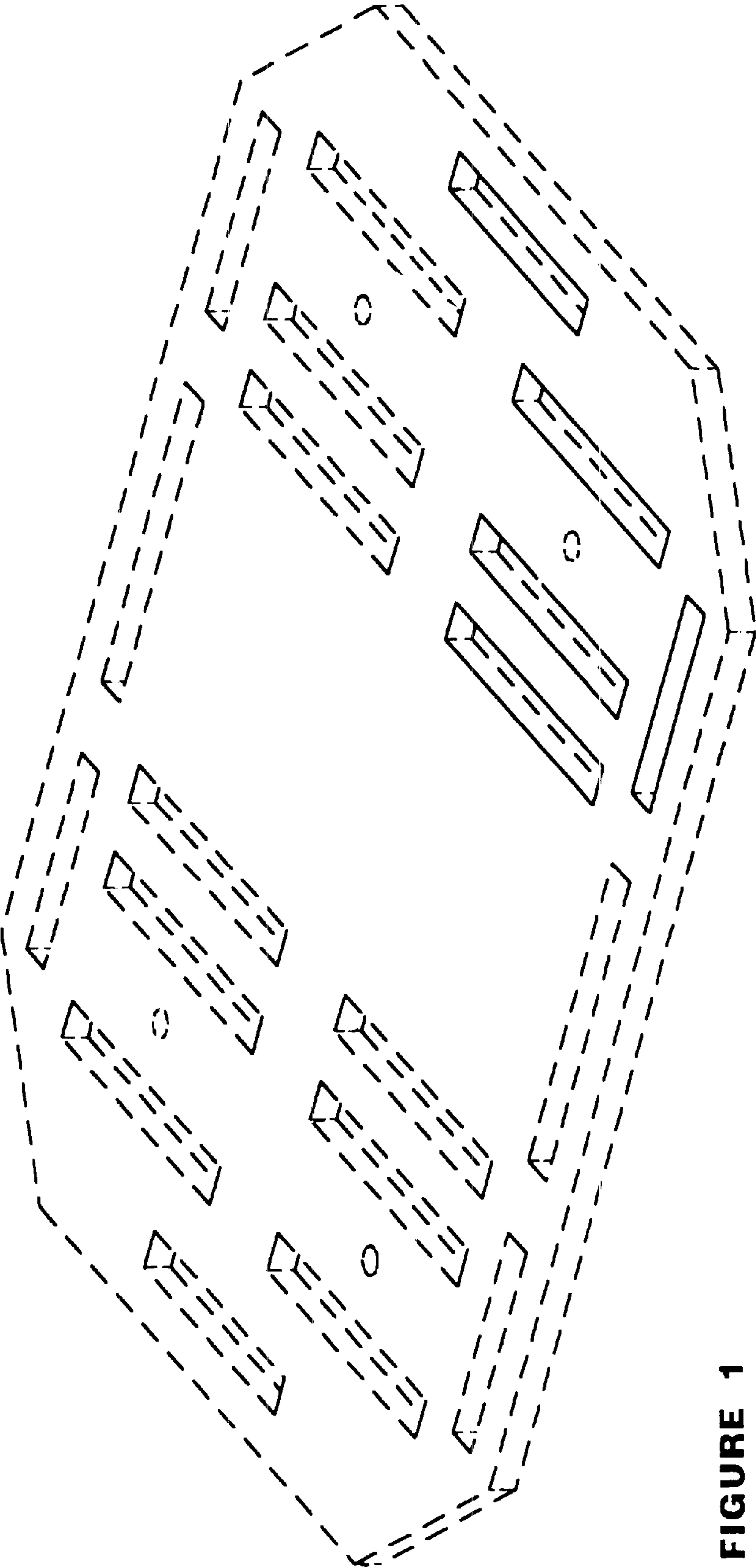

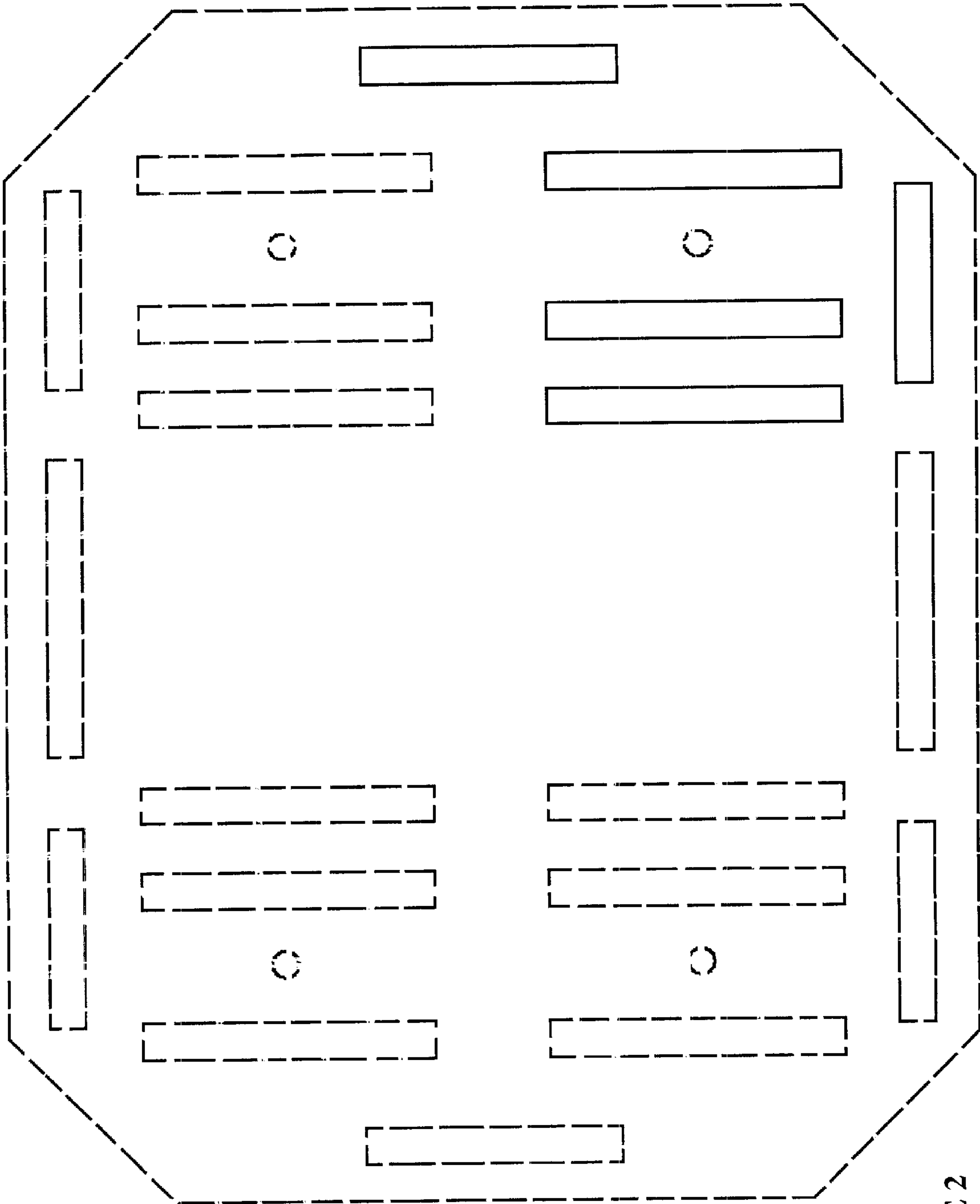
