The ornamental design for a vase, as shown and described.

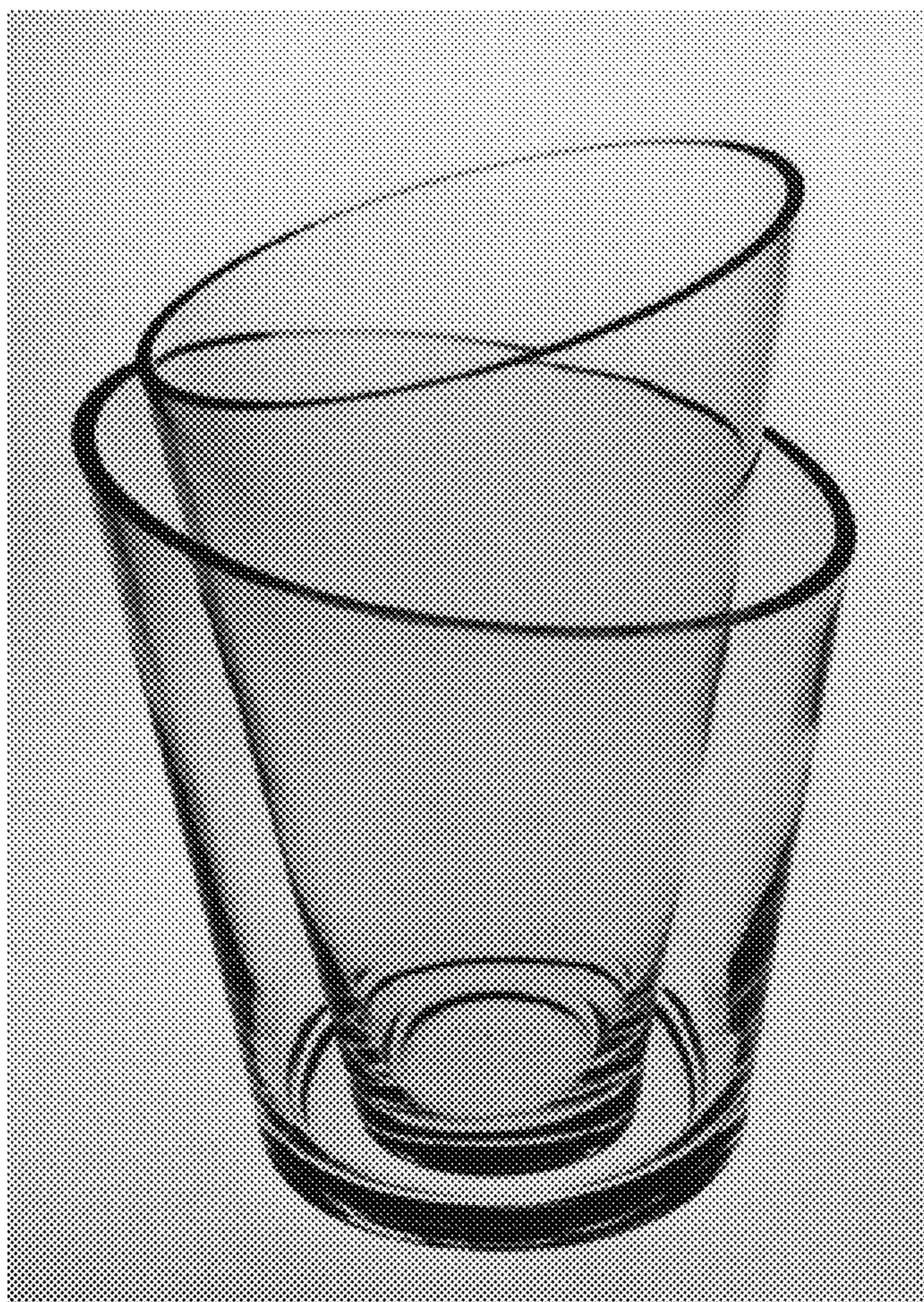
**DESCRIPTION**

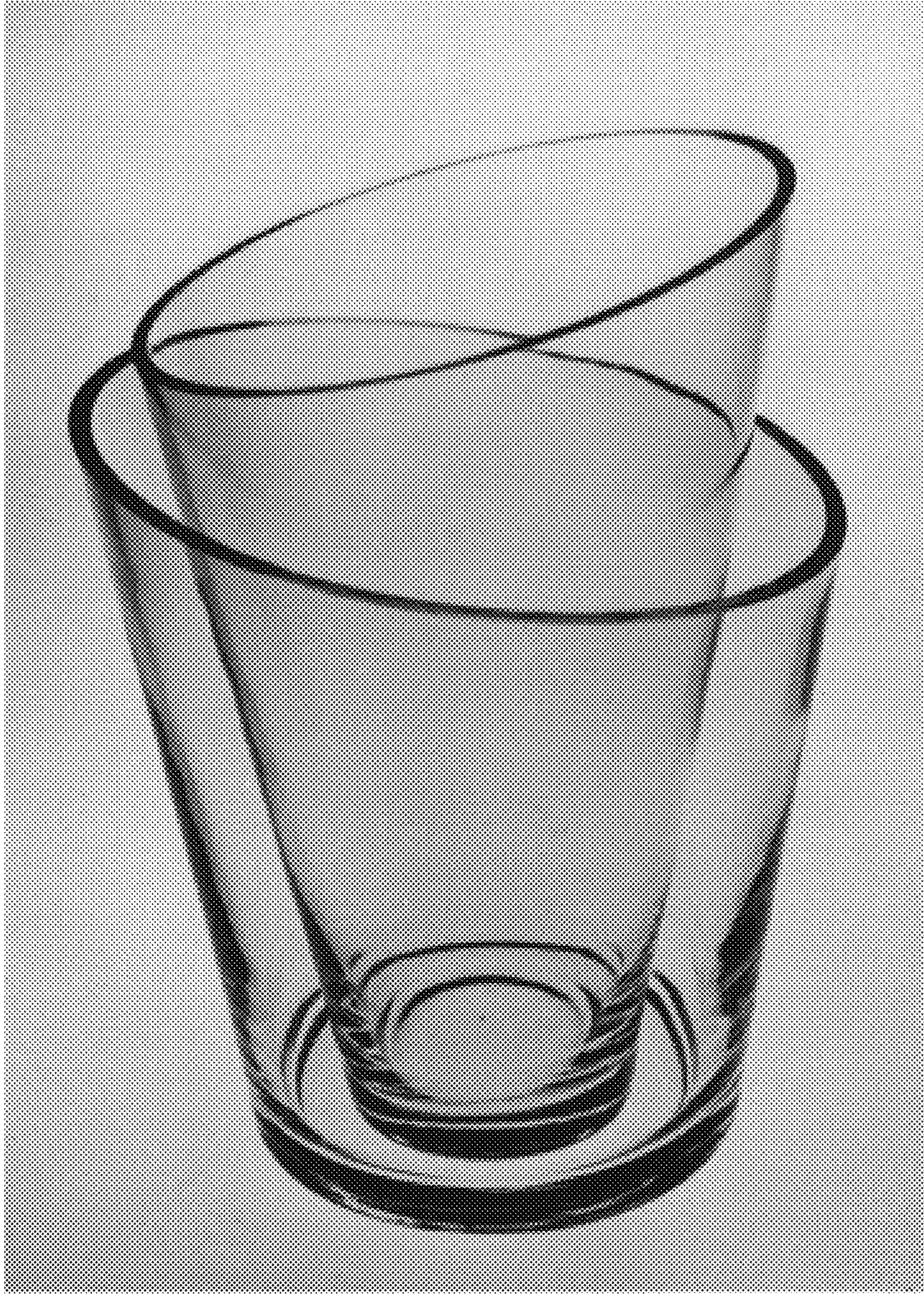
FIG. 1 is a perspective view of a vase showing my new design;

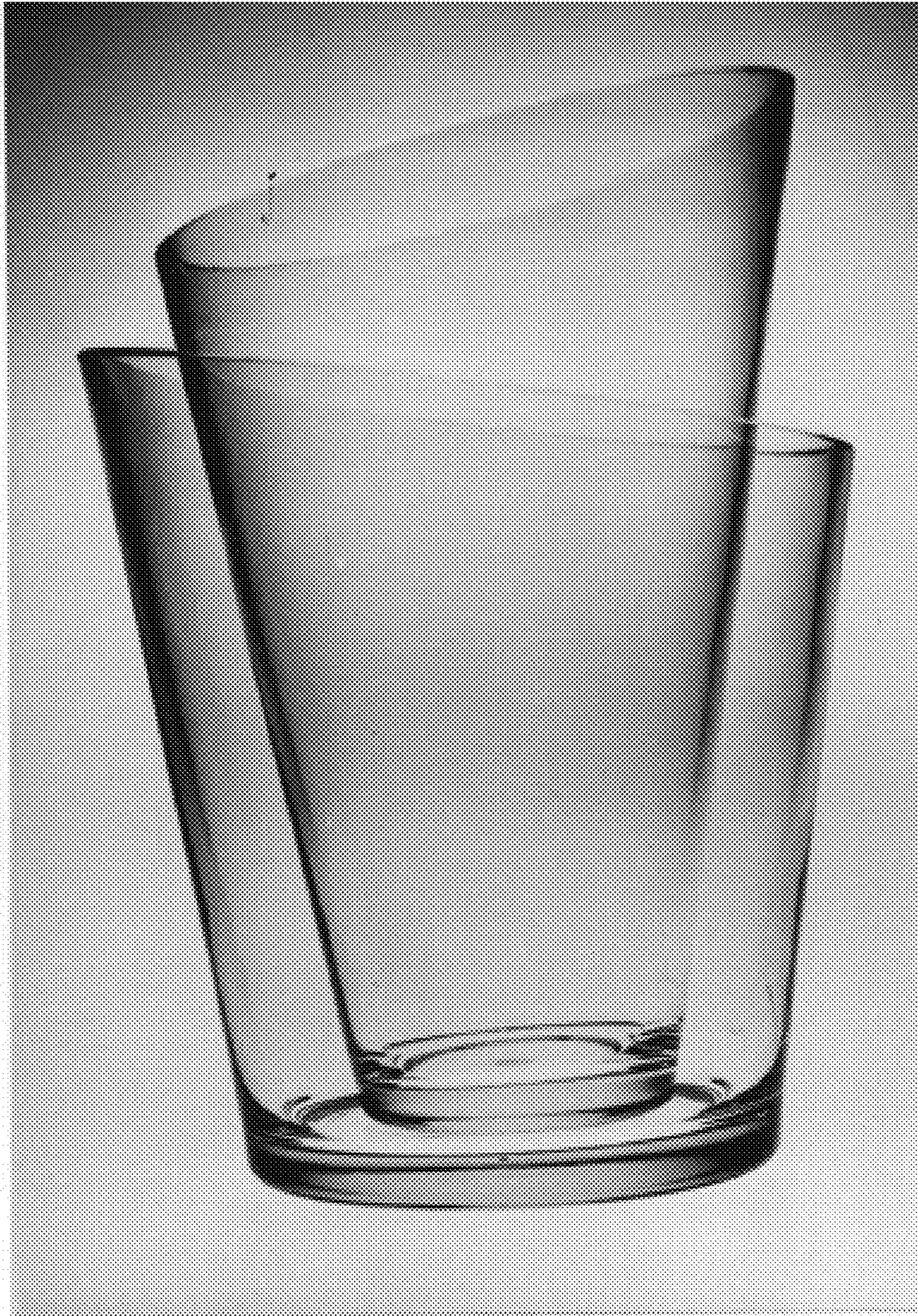

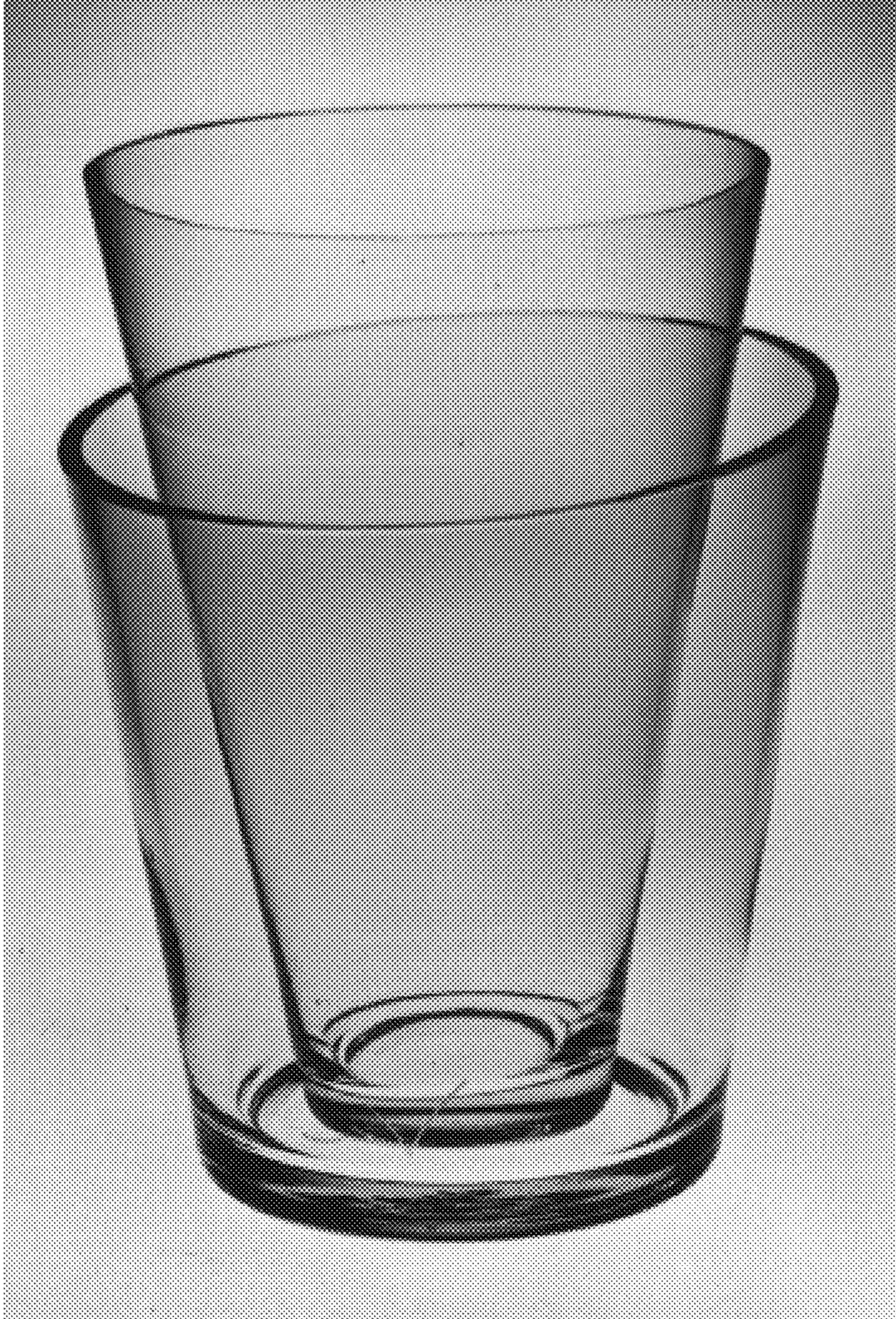




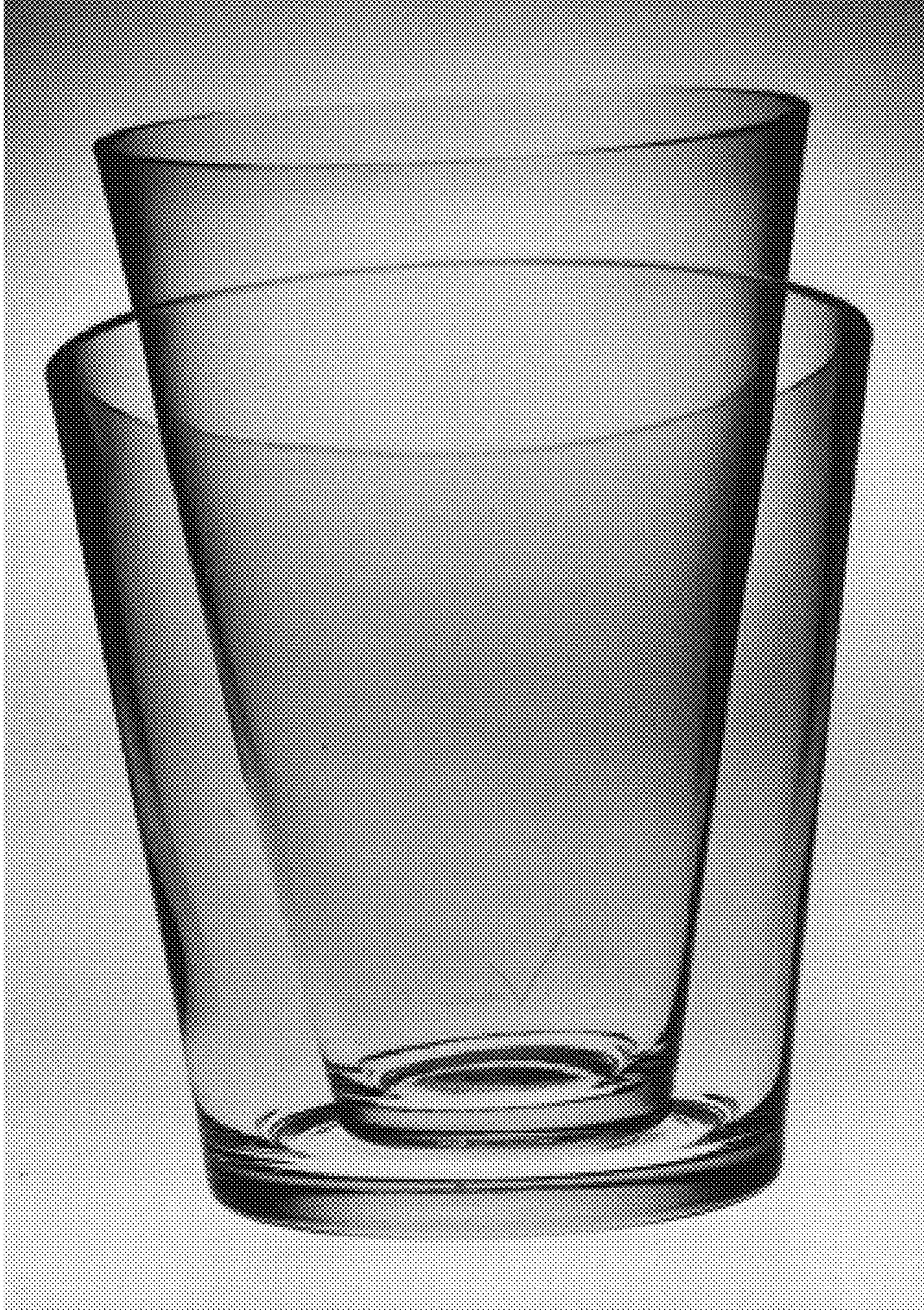

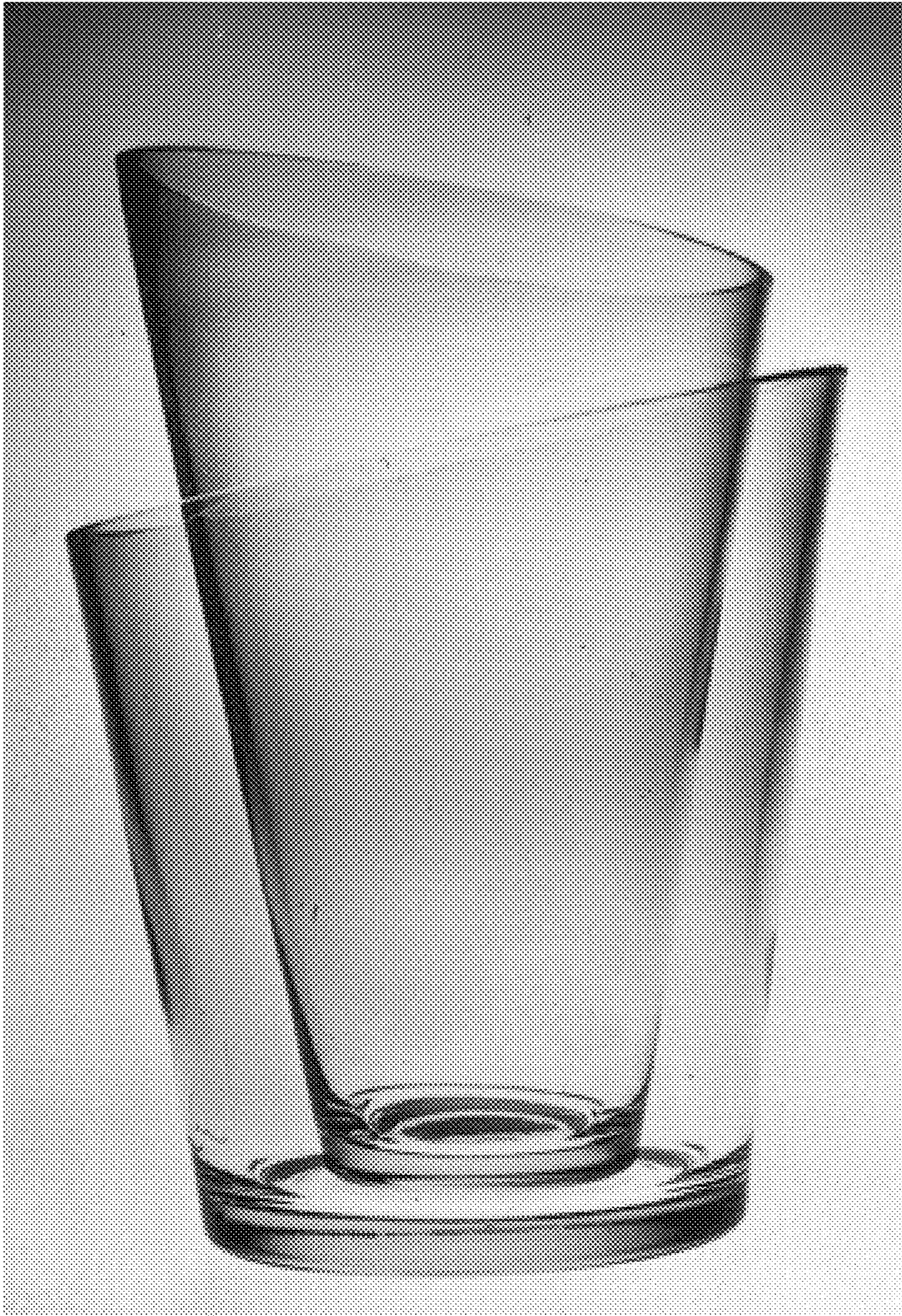

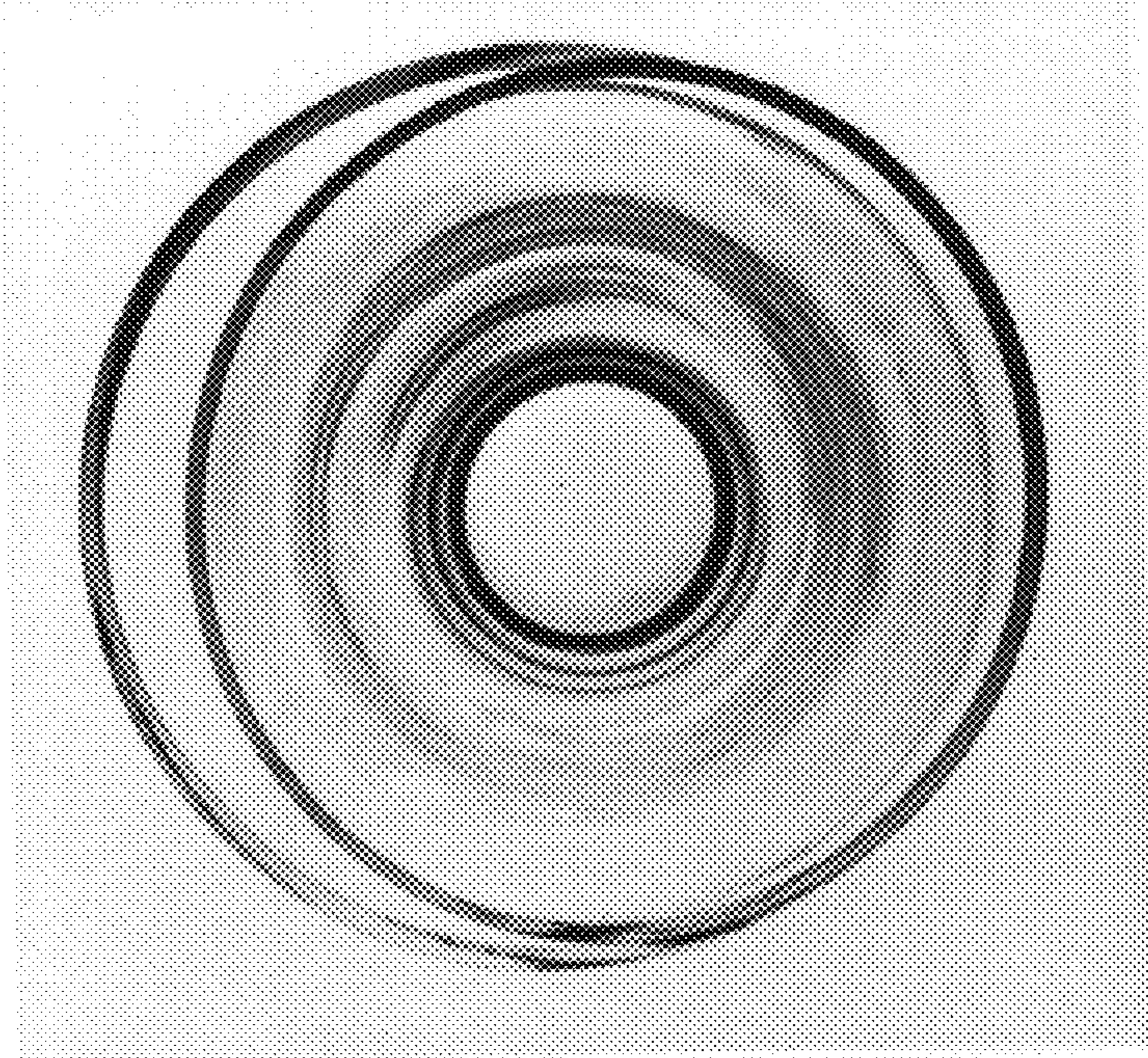

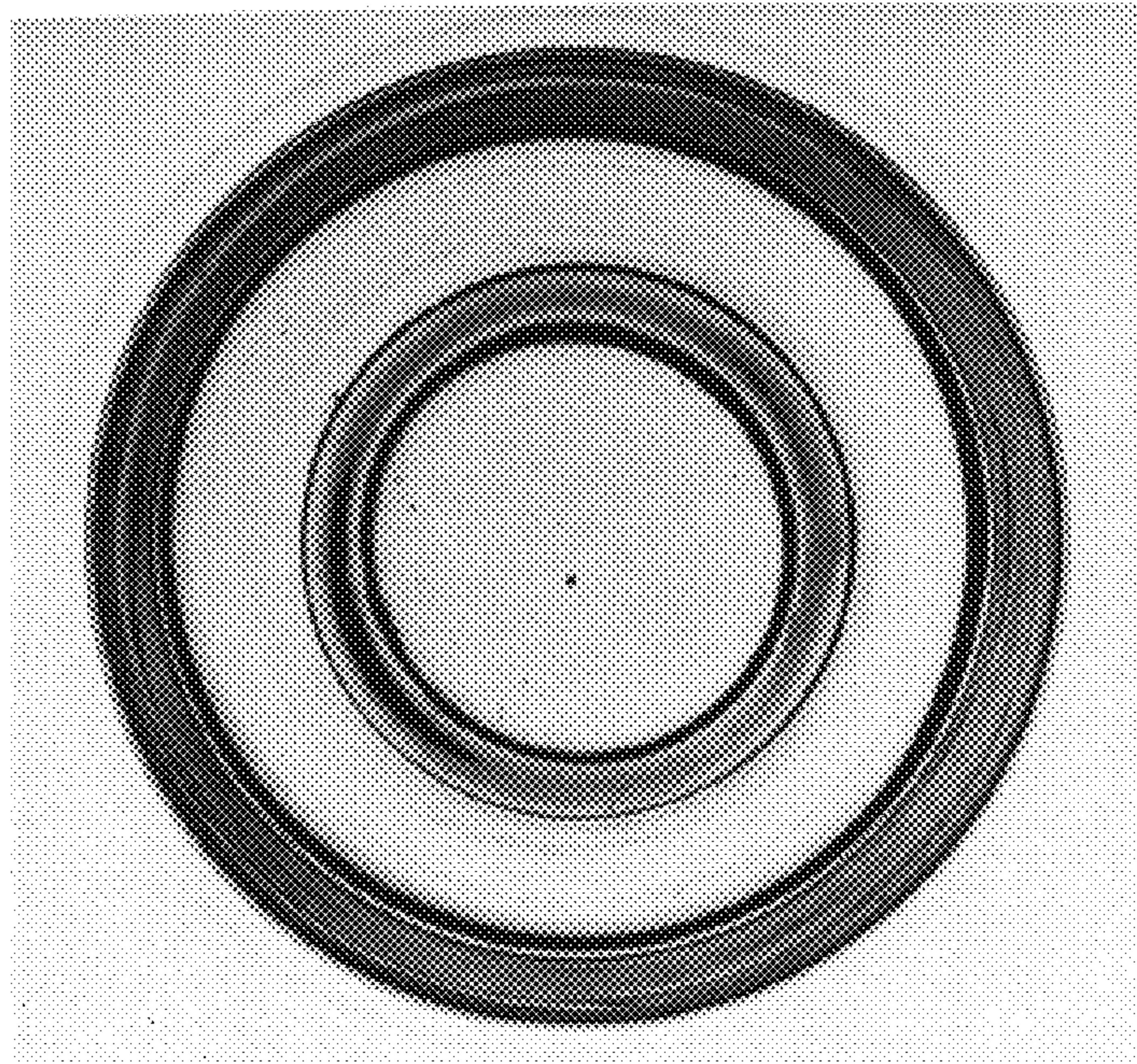
