(57) **CLAIM**

The ornamental design for a modern pick-up truck body, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the modern pick-up truck body, showing the new design.

FIG. 2 is a rear perspective view of the modern pick-up truck body shown in FIG. 1.

FIG. 3 is a side view of the modern pick-up truck body shown in FIG. 1.

FIG. 4 is a top plan view of the modern pick-up truck body shown in FIG. 1.

FIG. 5 is a rear perspective view of the modern pick-up truck body shown in FIG. 1, with the left door opened, and both cargo access panels opened (alternate positions).

FIG. 6 is a rear perspective view of the modern pick-up truck body shown in FIG. 1, with the Cargo bed lid opened, and the rear gate opened (alternate positions).

FIG. 7 is a rear perspective view of the modern pick-up truck body shown in FIG. 1, with the Cargo bed lid folded once, and the rear gate opened (alternate positions).

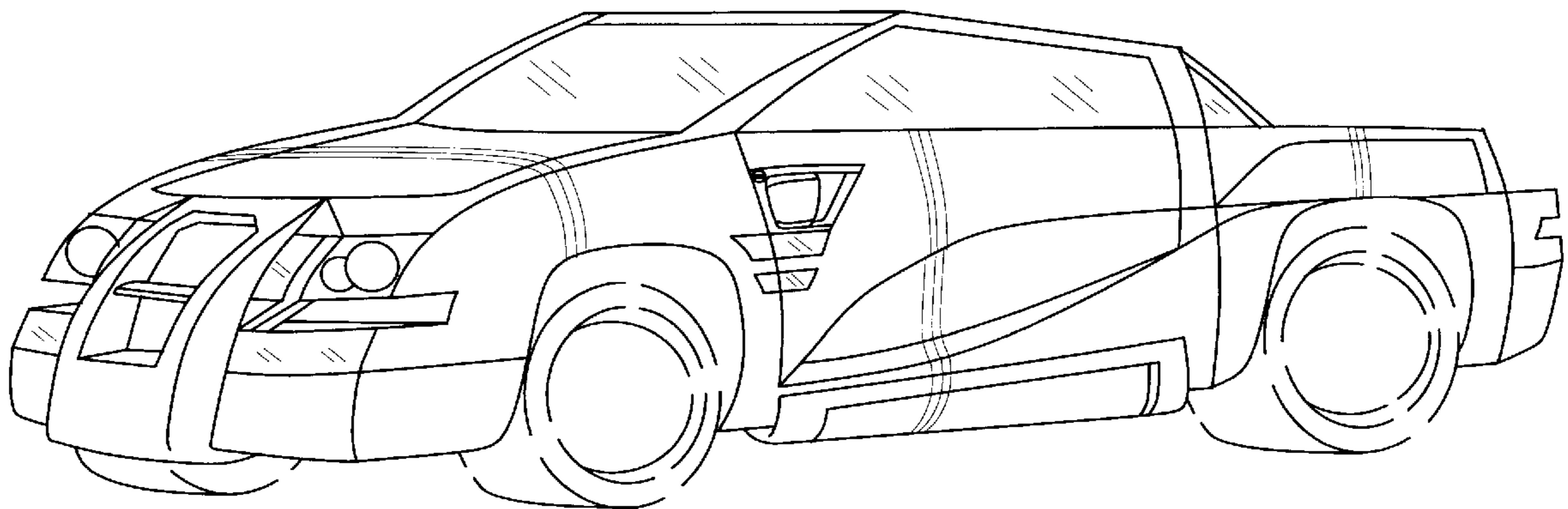
FIG. 8 is a rear perspective view of the modern pick-up truck body shown in FIG. 1, with the Cargo bed lid folded for the second time, to conceal it, and the rear gate opened (alternate positions).

FIG. 9 is a front view of the modern pick-up truck body shown in FIG. 1; and,

FIG. 10 is a rear view of the modern pick-up truck body shown in FIG. 1.

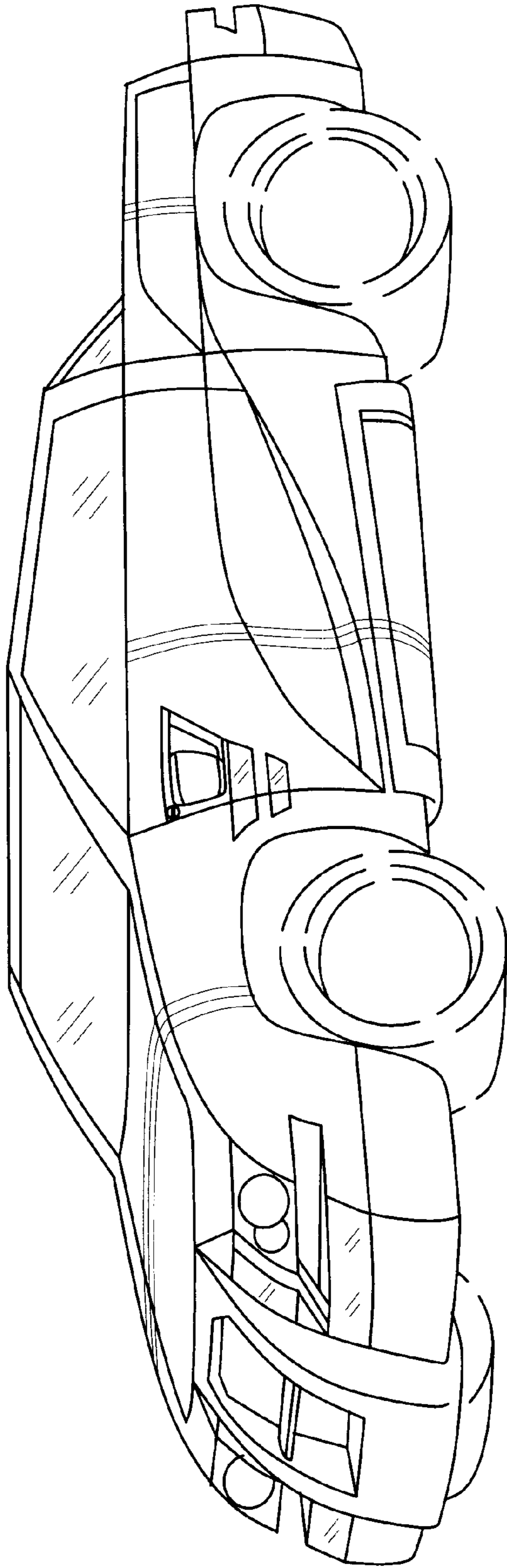

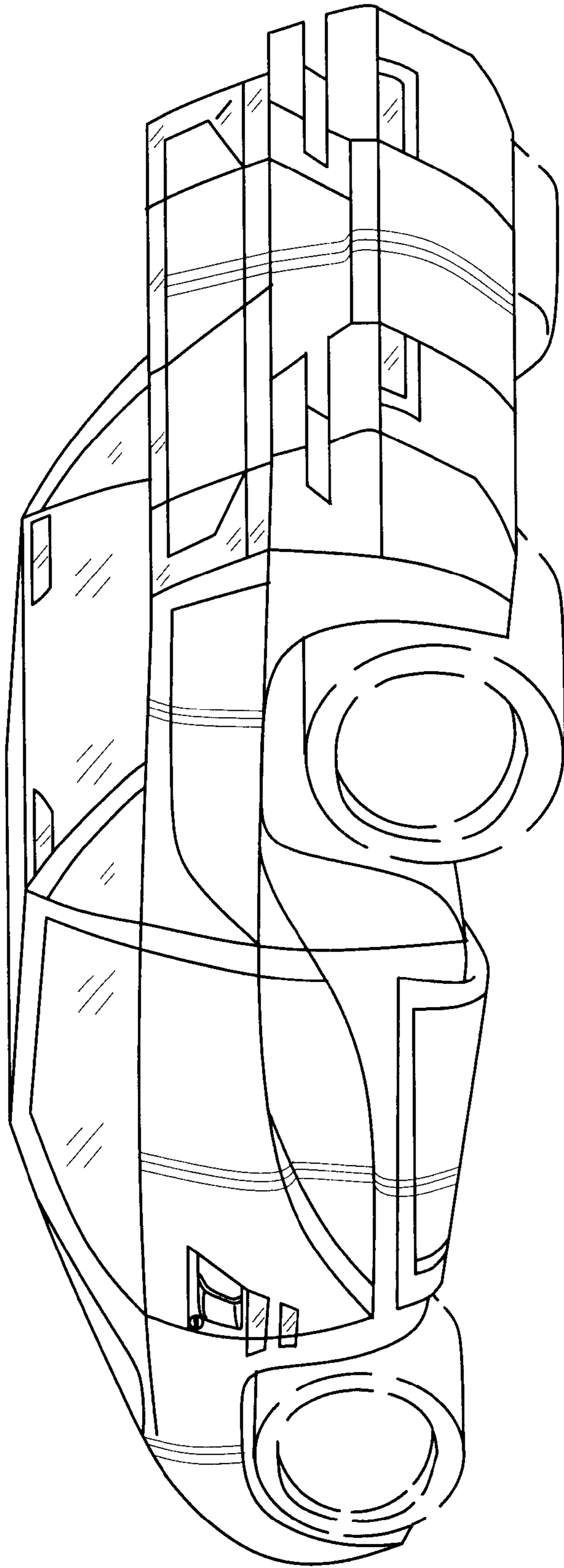

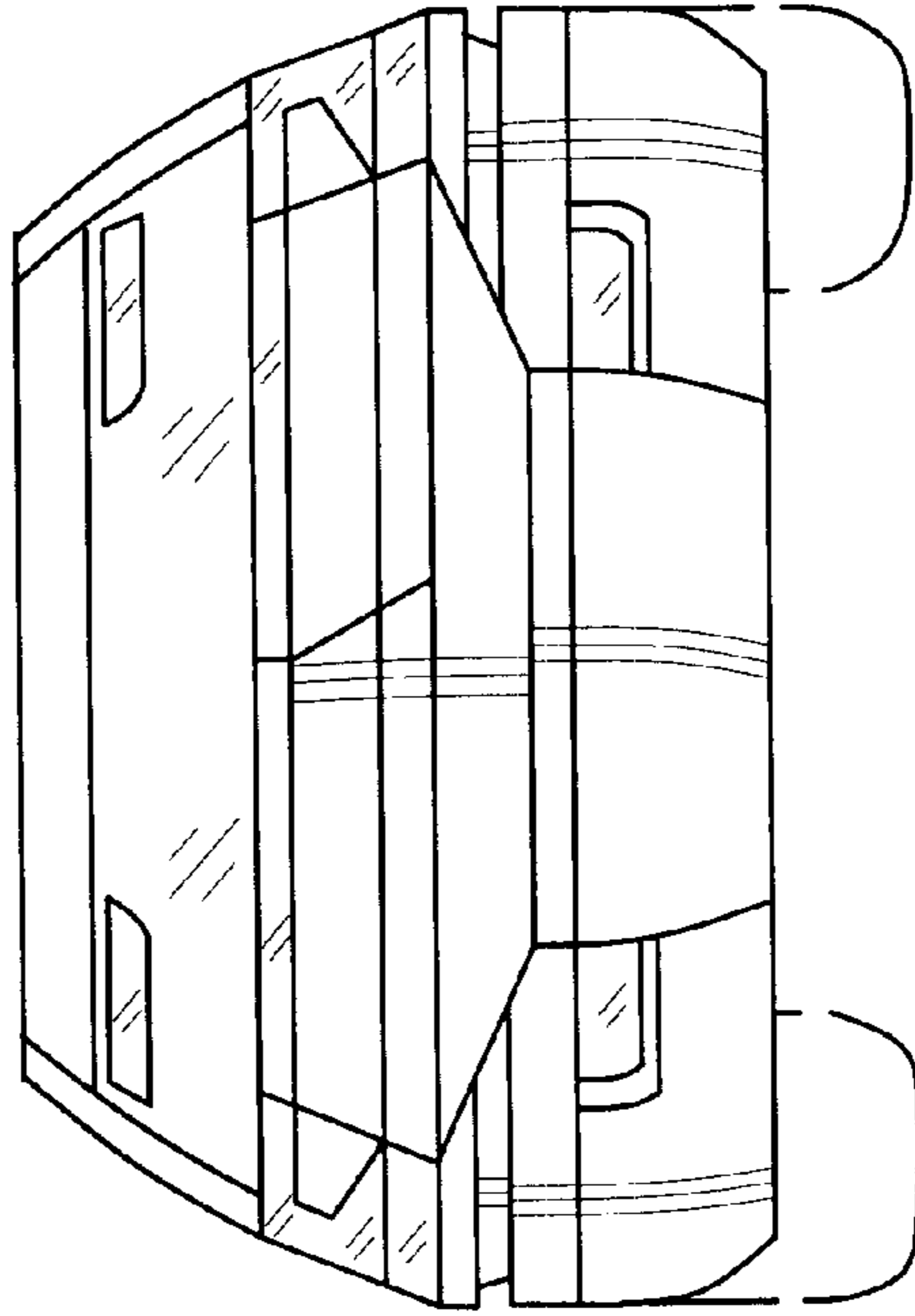

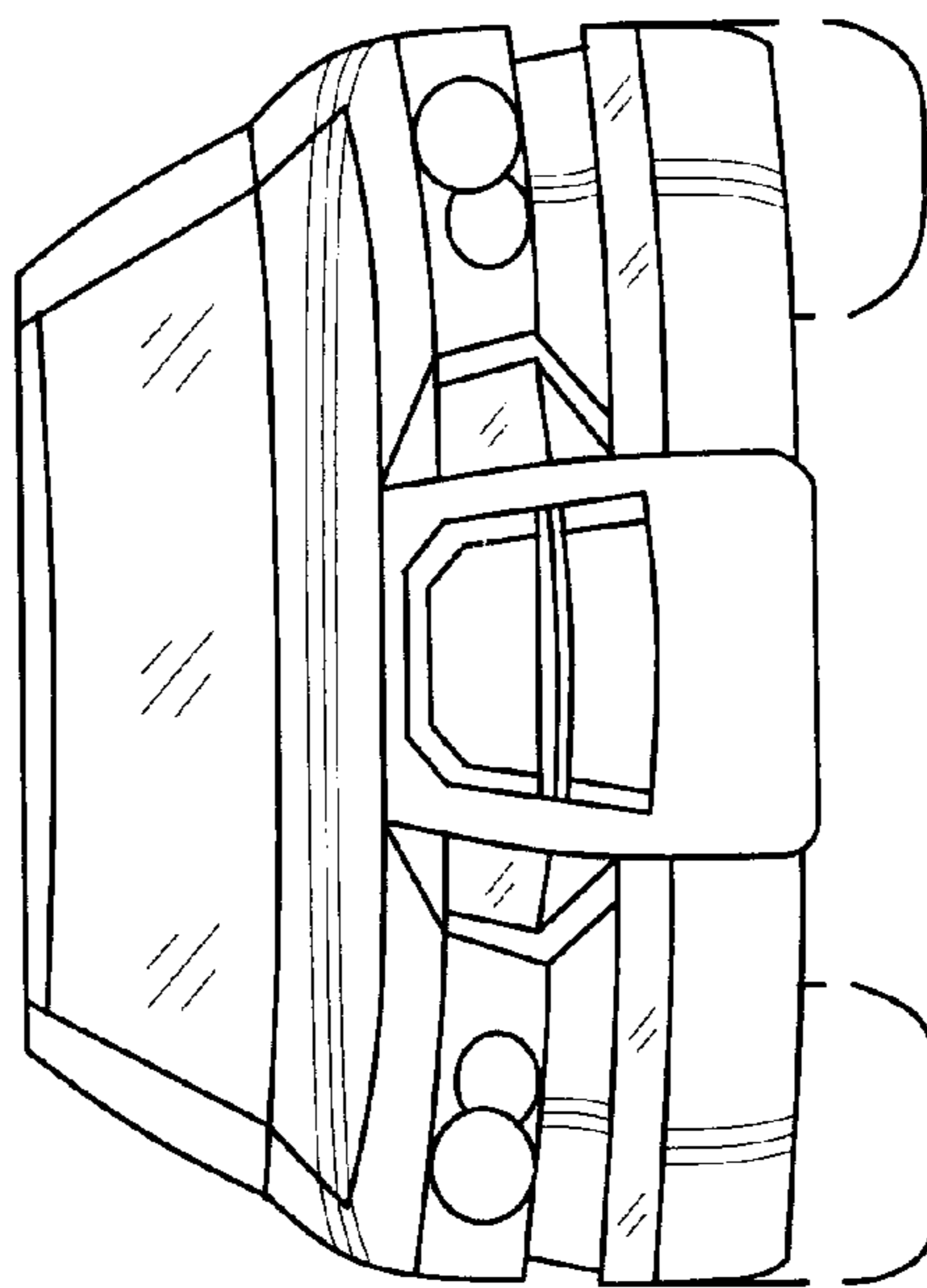

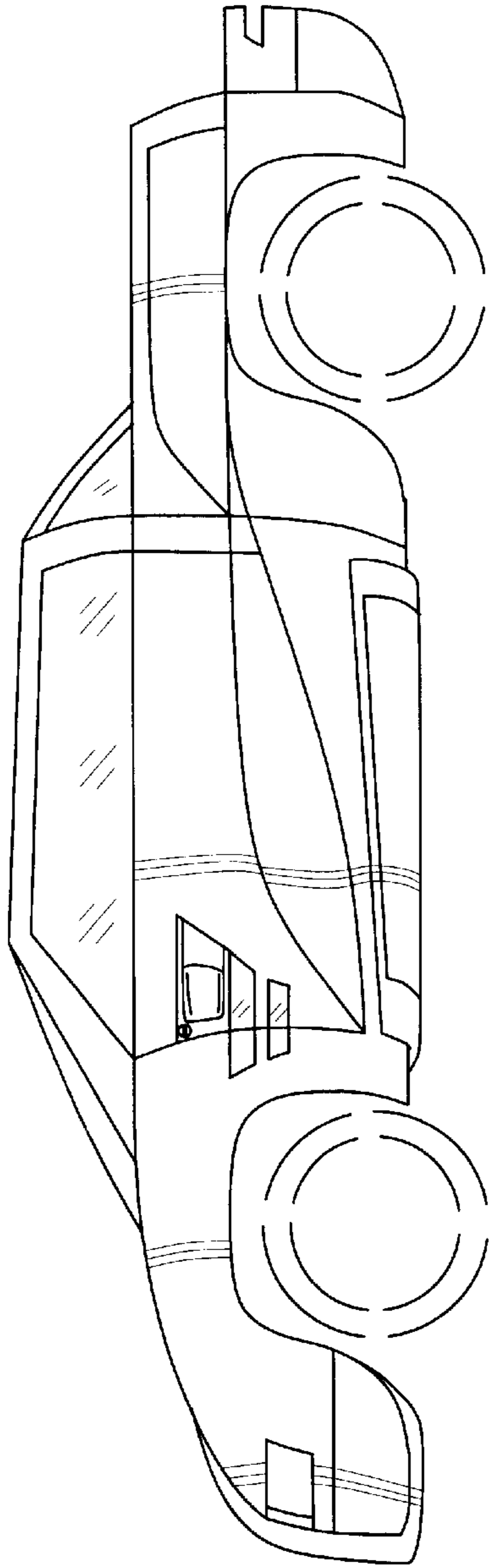

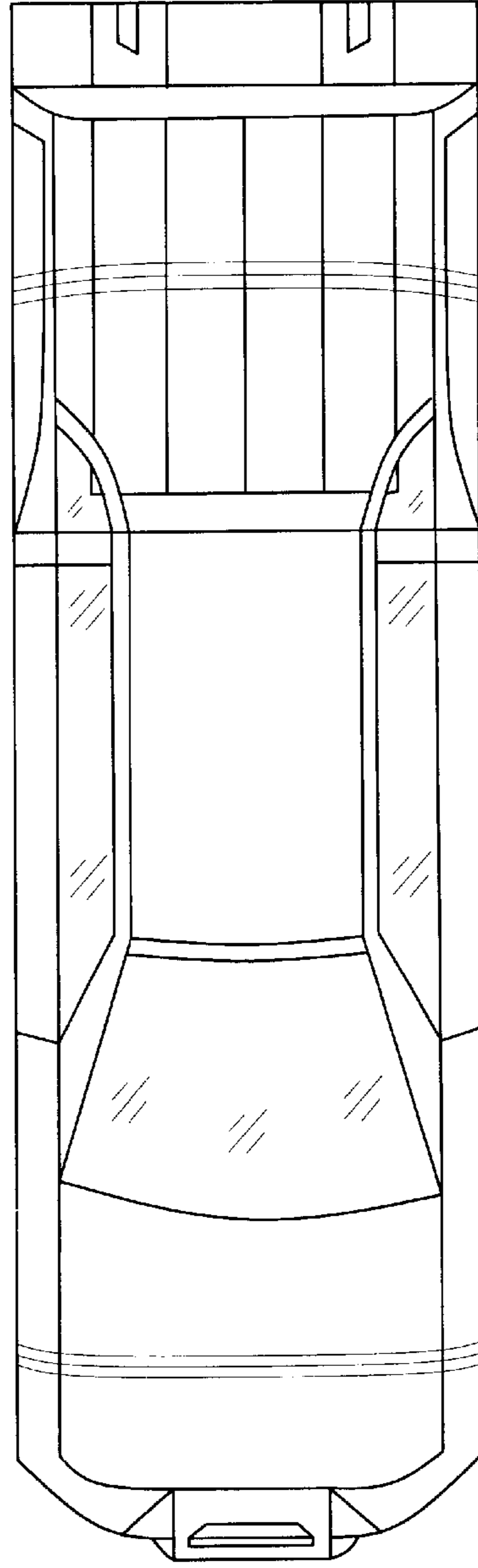

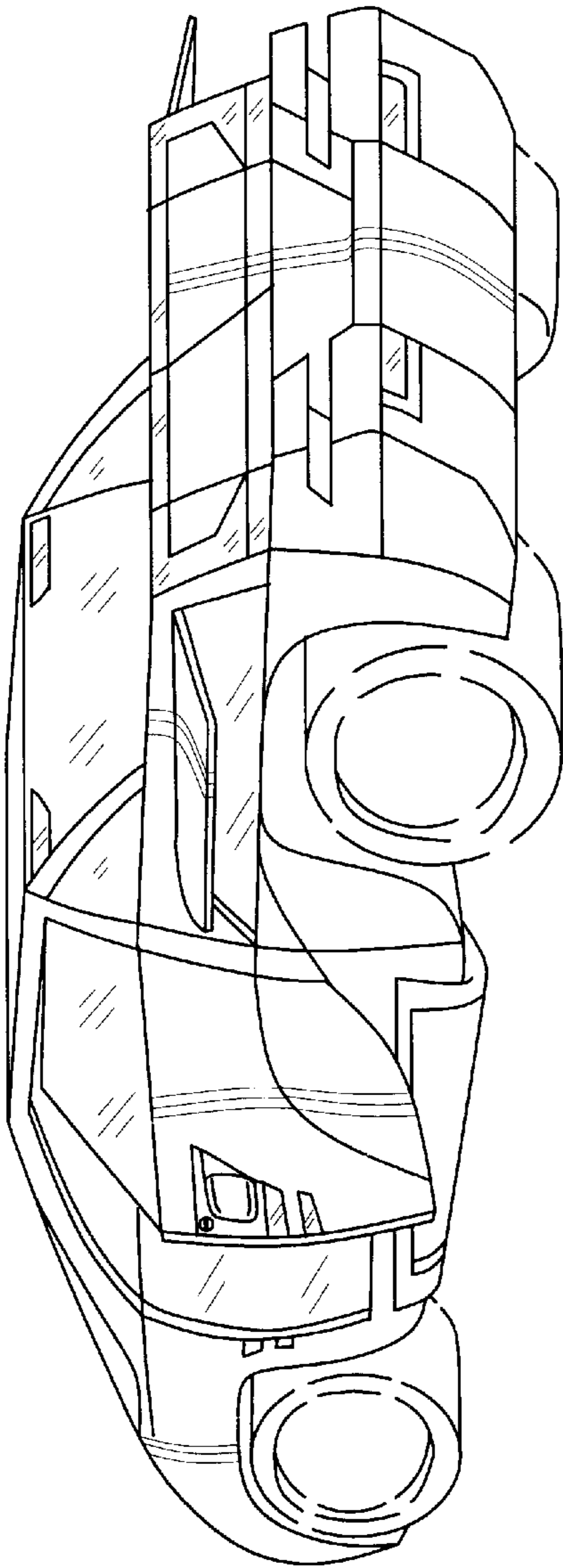

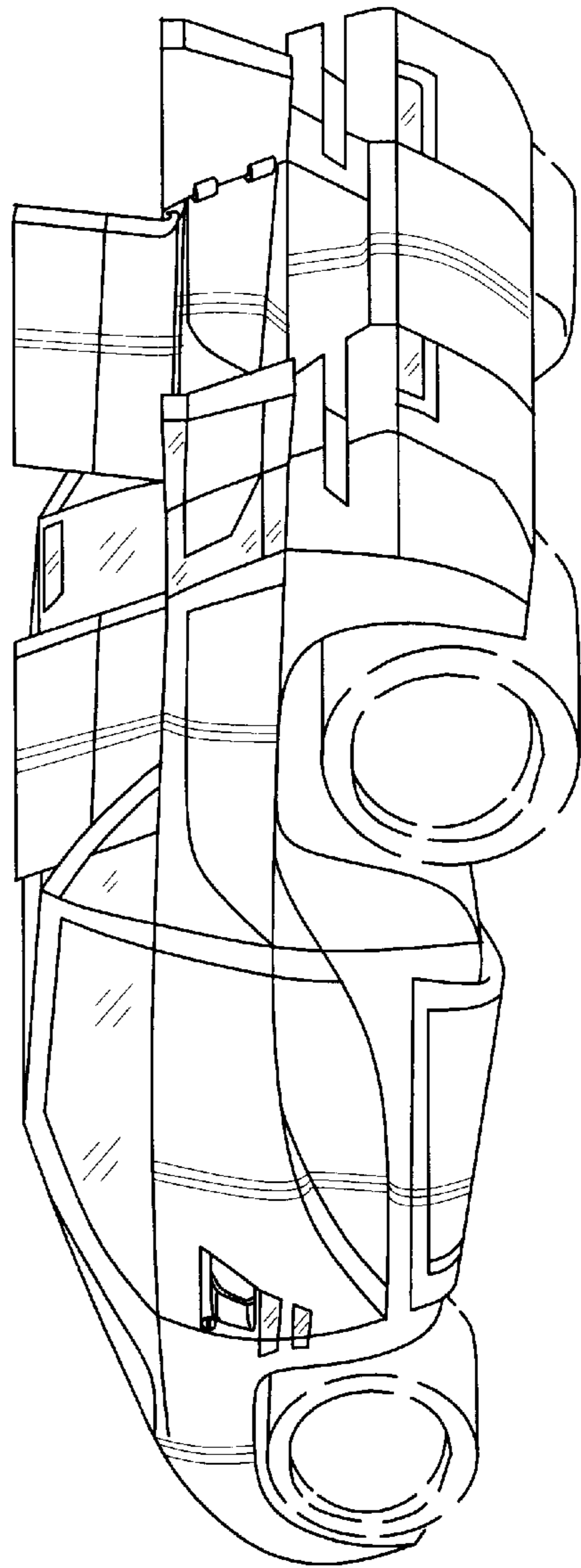

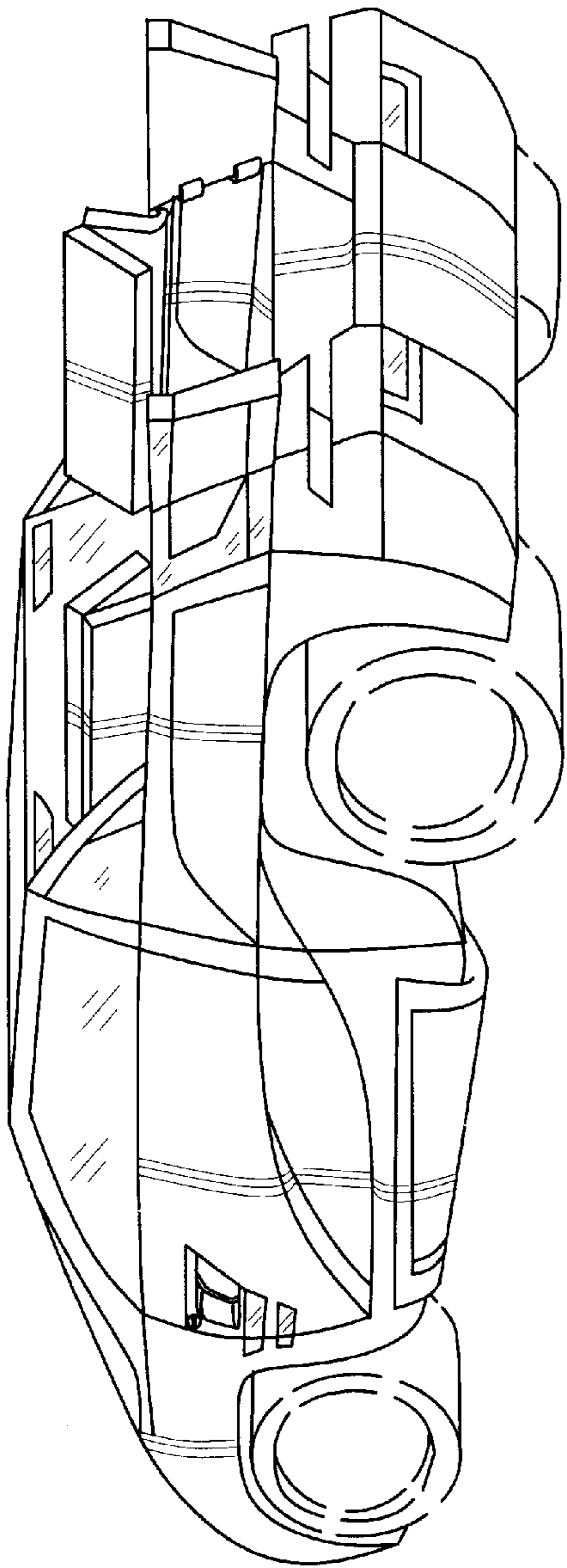

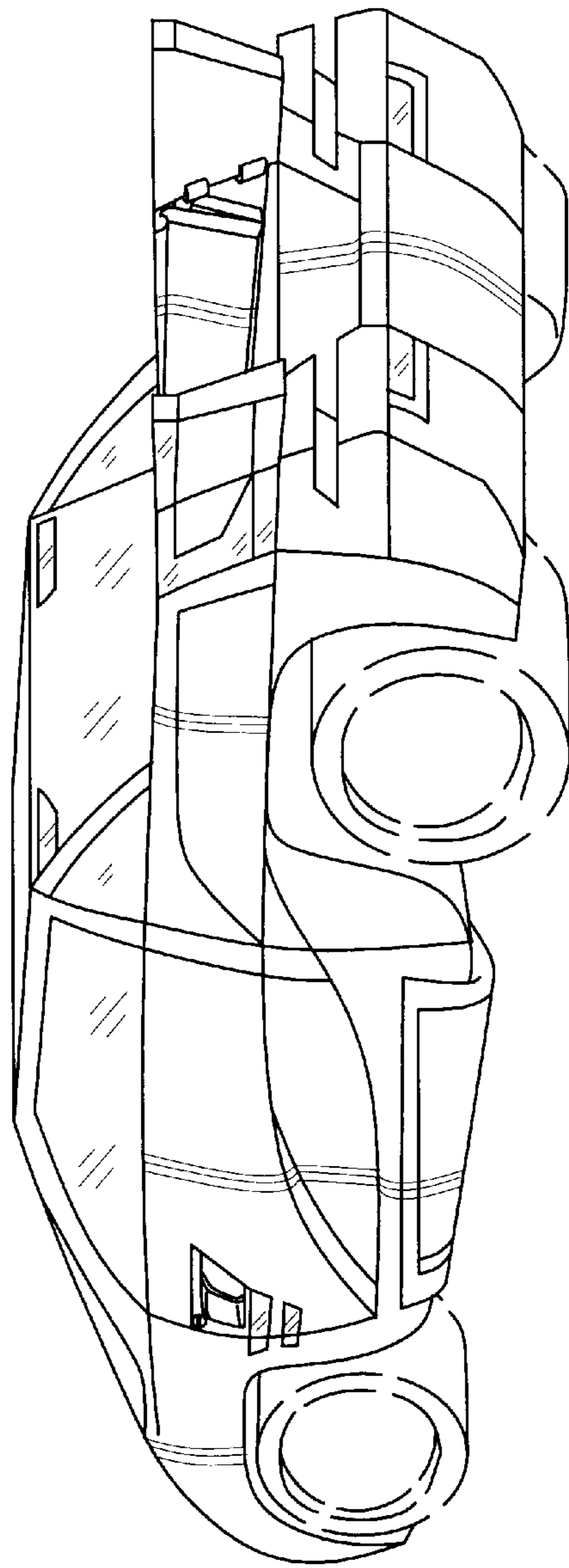
