(57) **CLAIM**

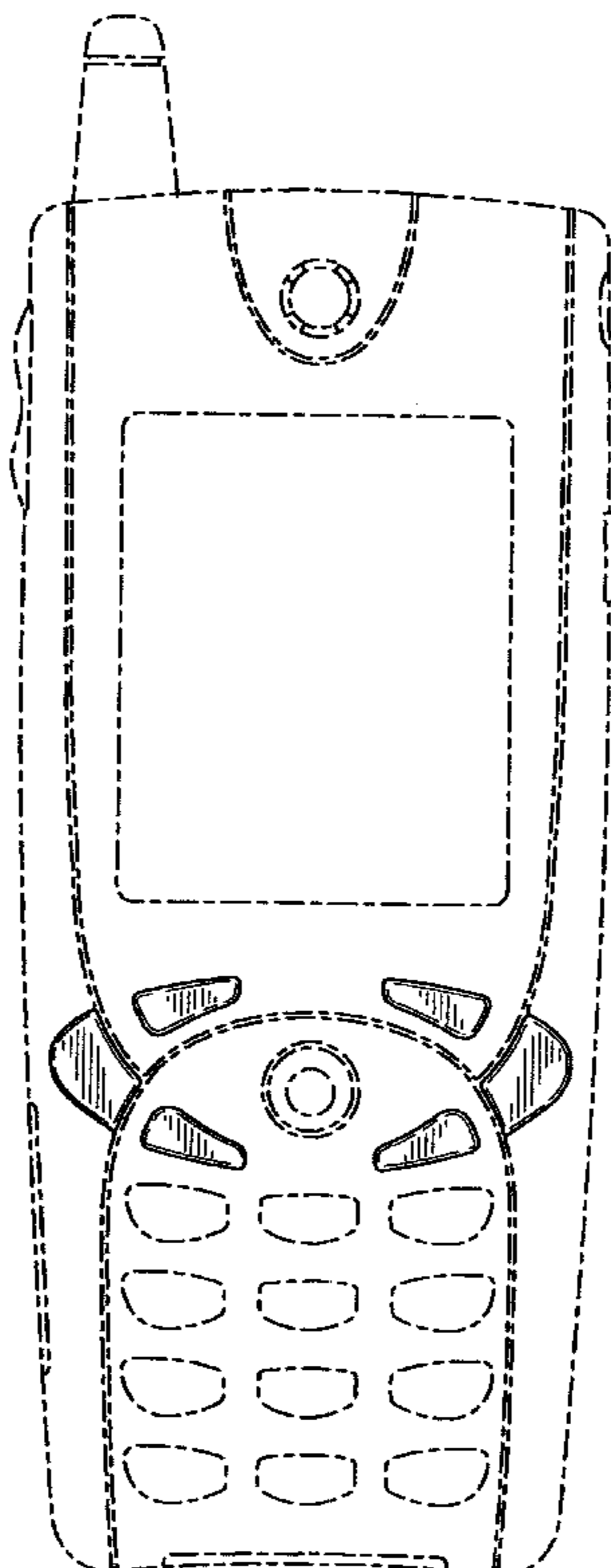
The ornamental design for a key configuration of a handset, as shown and described.

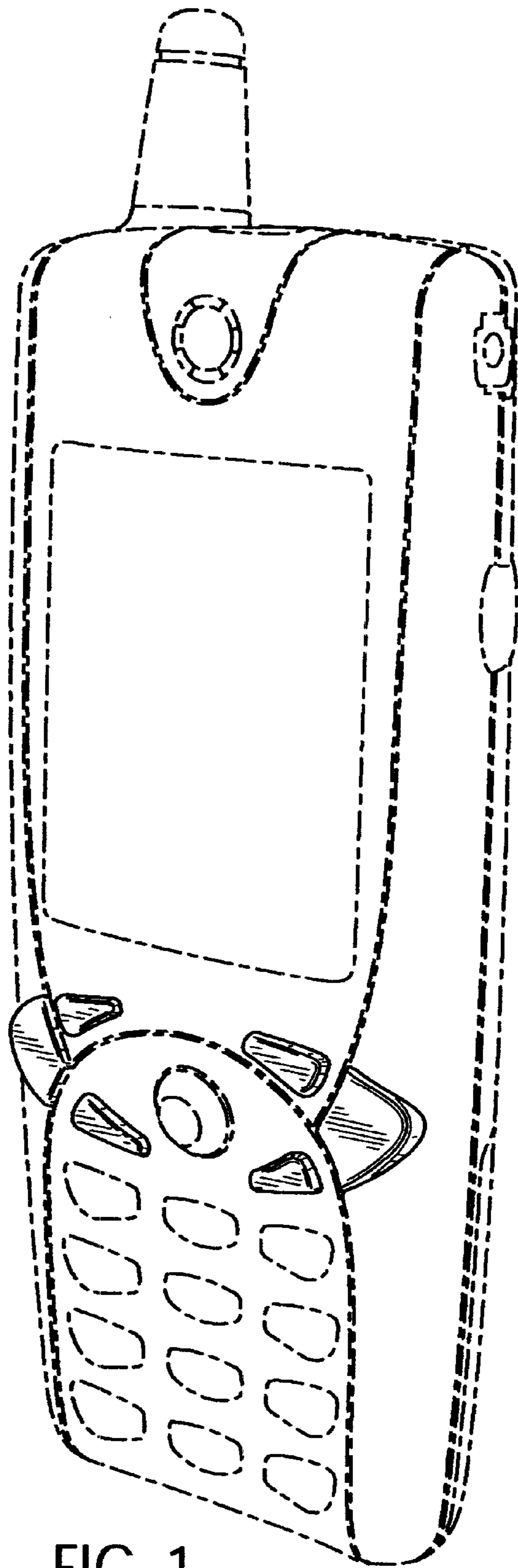

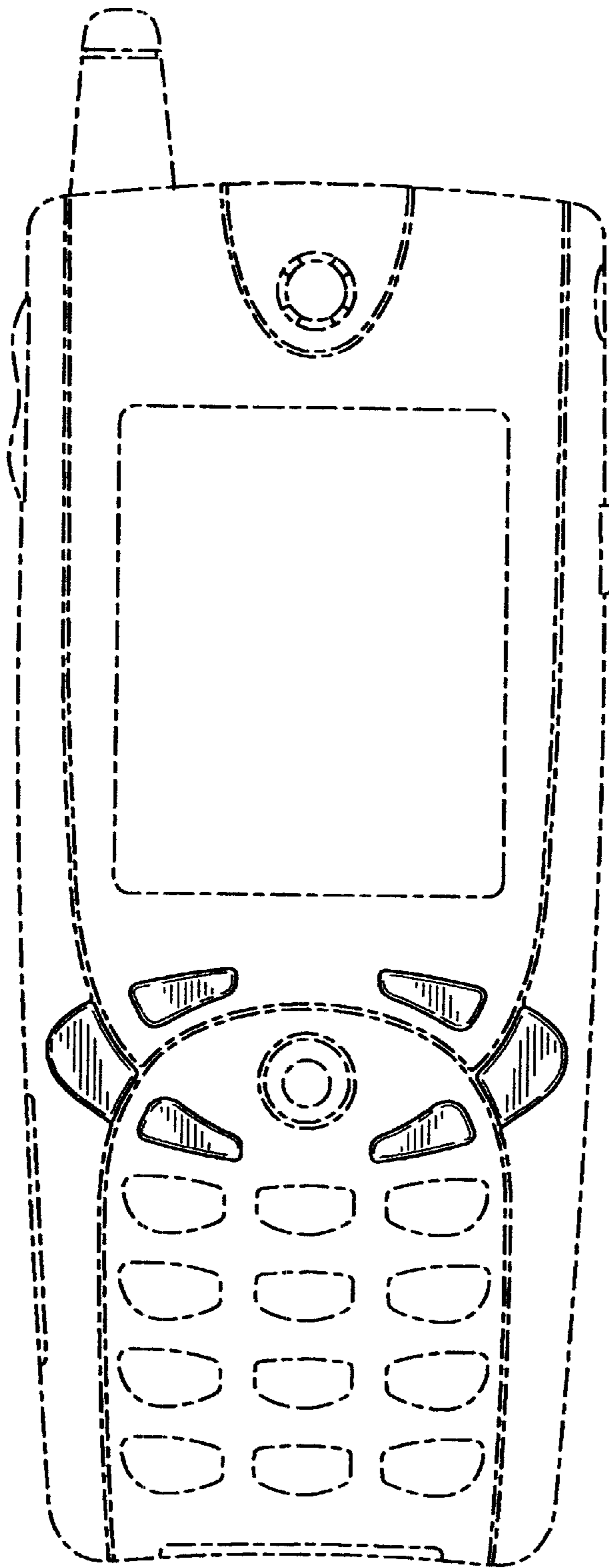

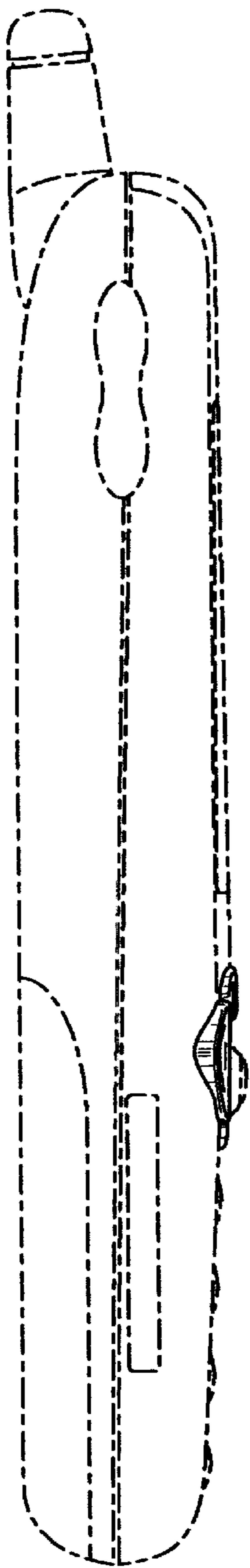

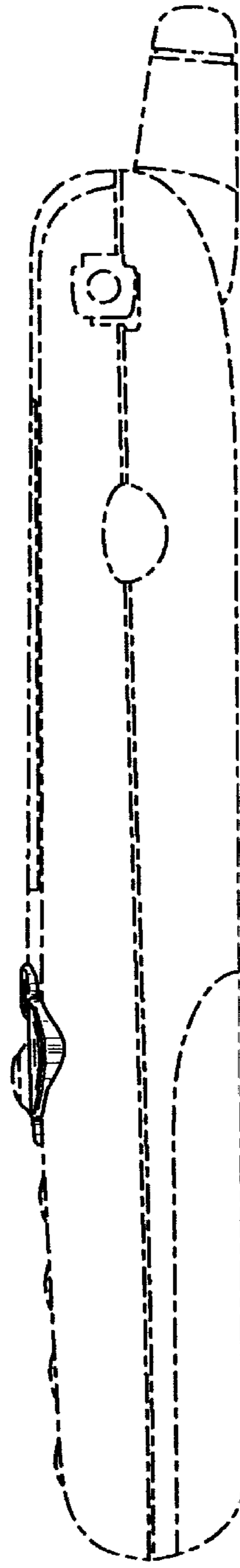

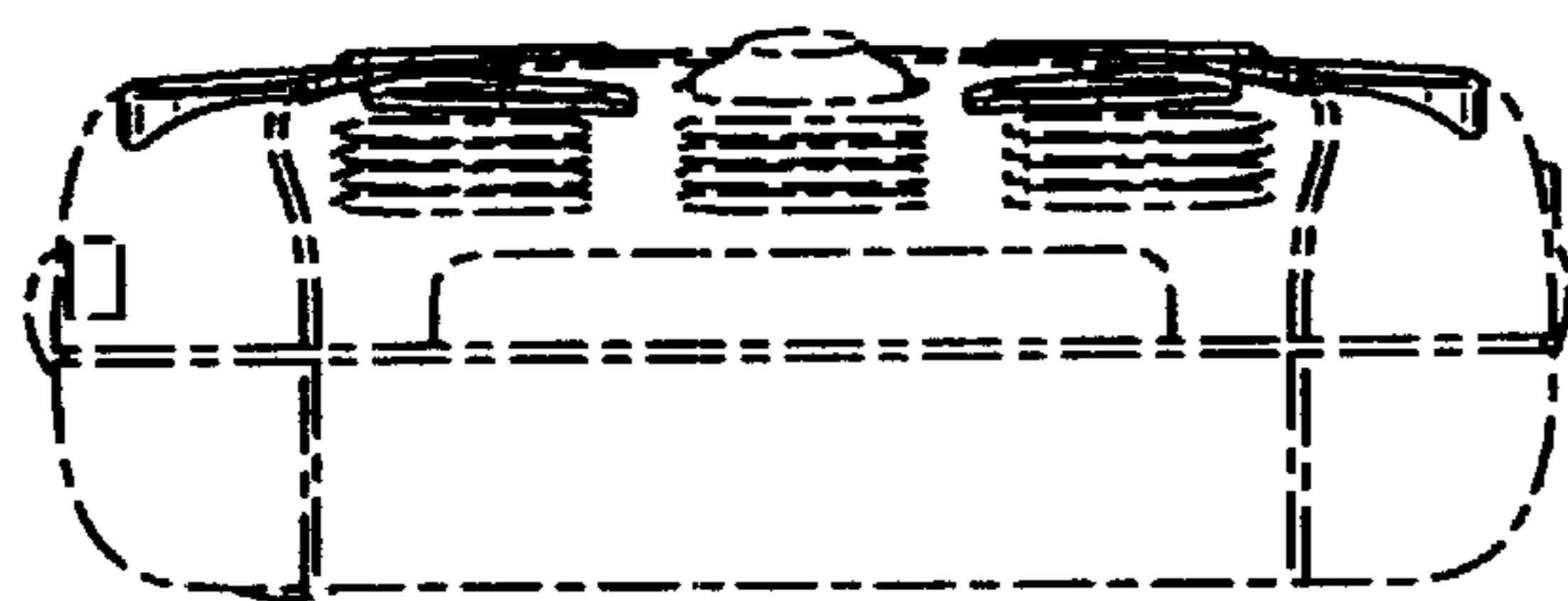
