The ornamental design for a tray for stenciling and painting supplies, as shown.

**DESCRIPTION**

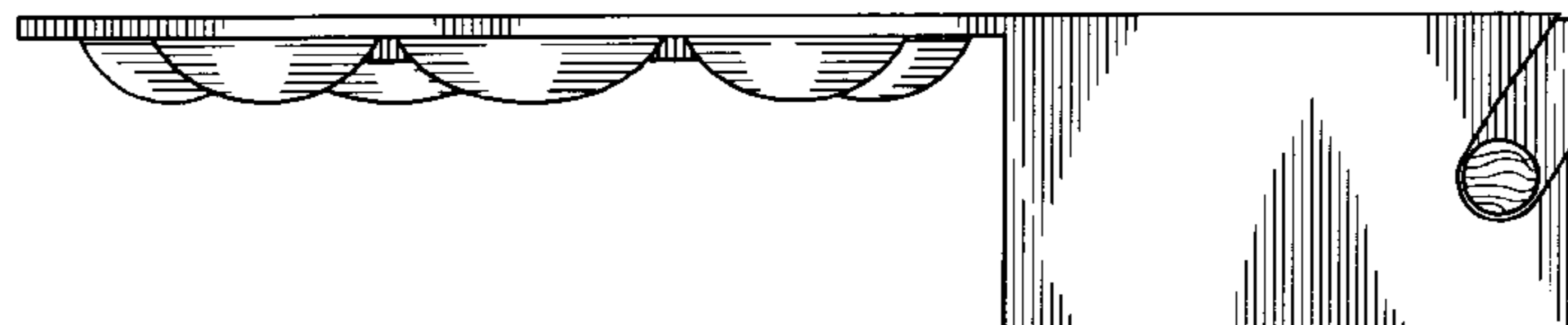
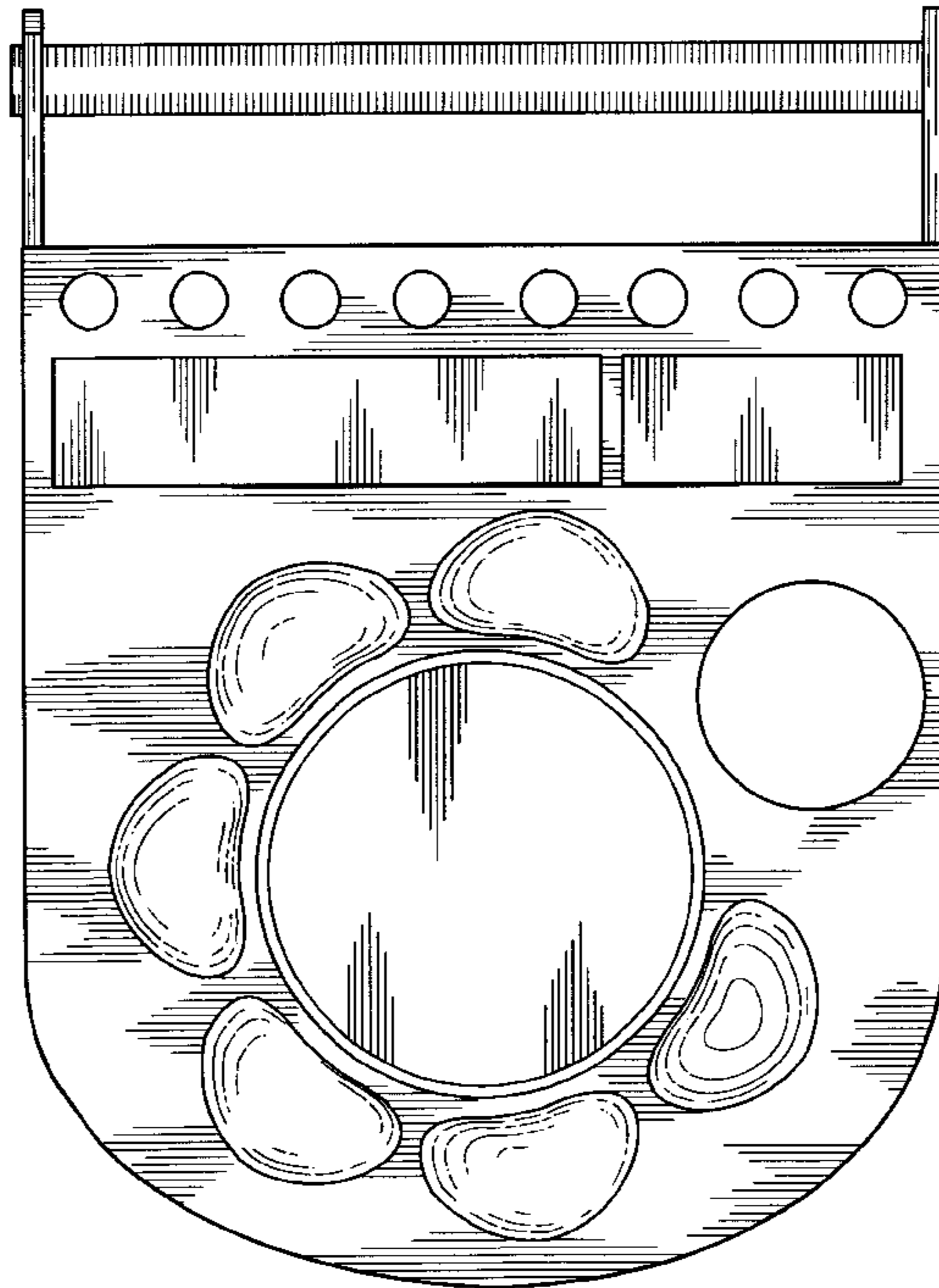

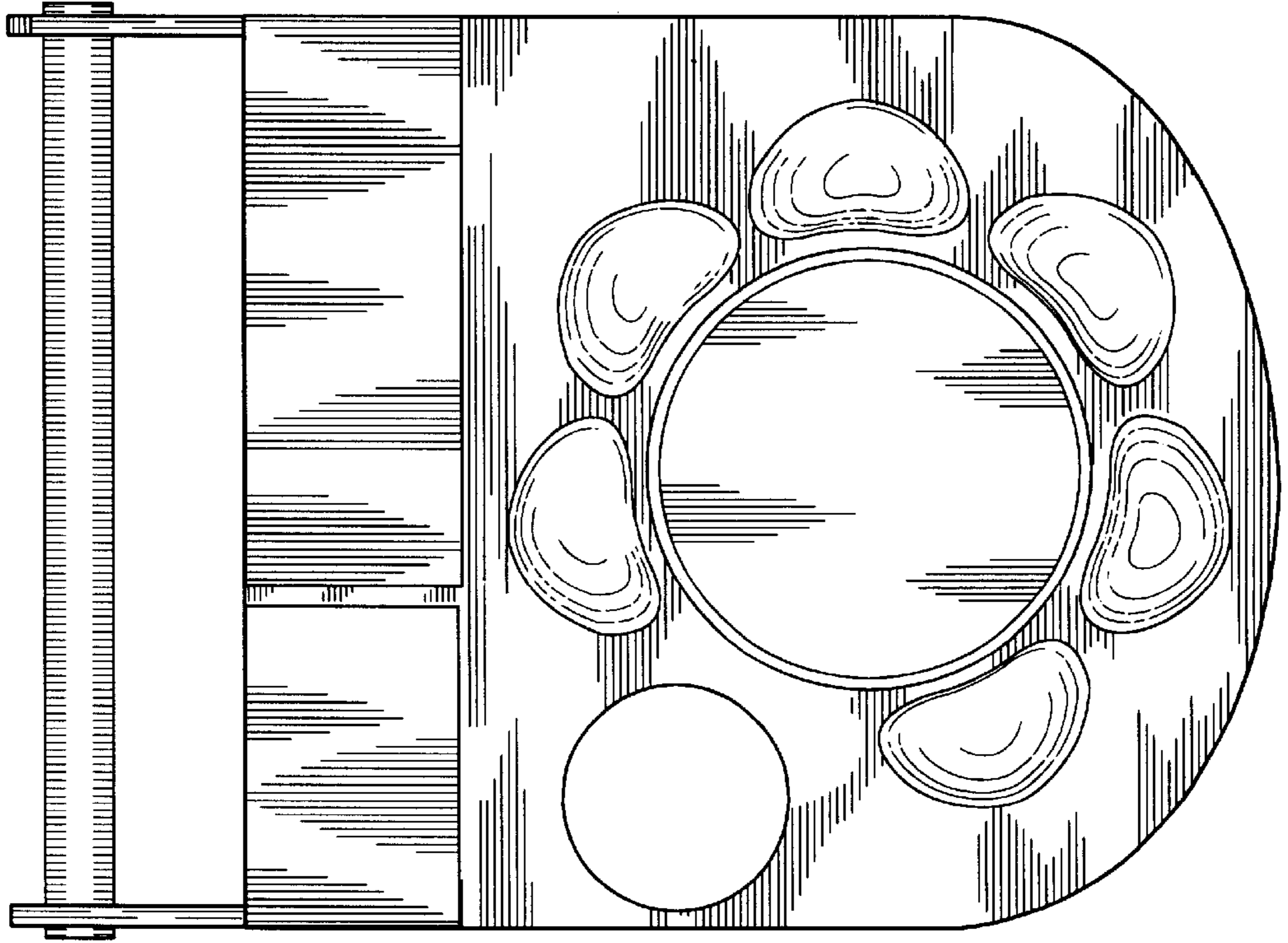

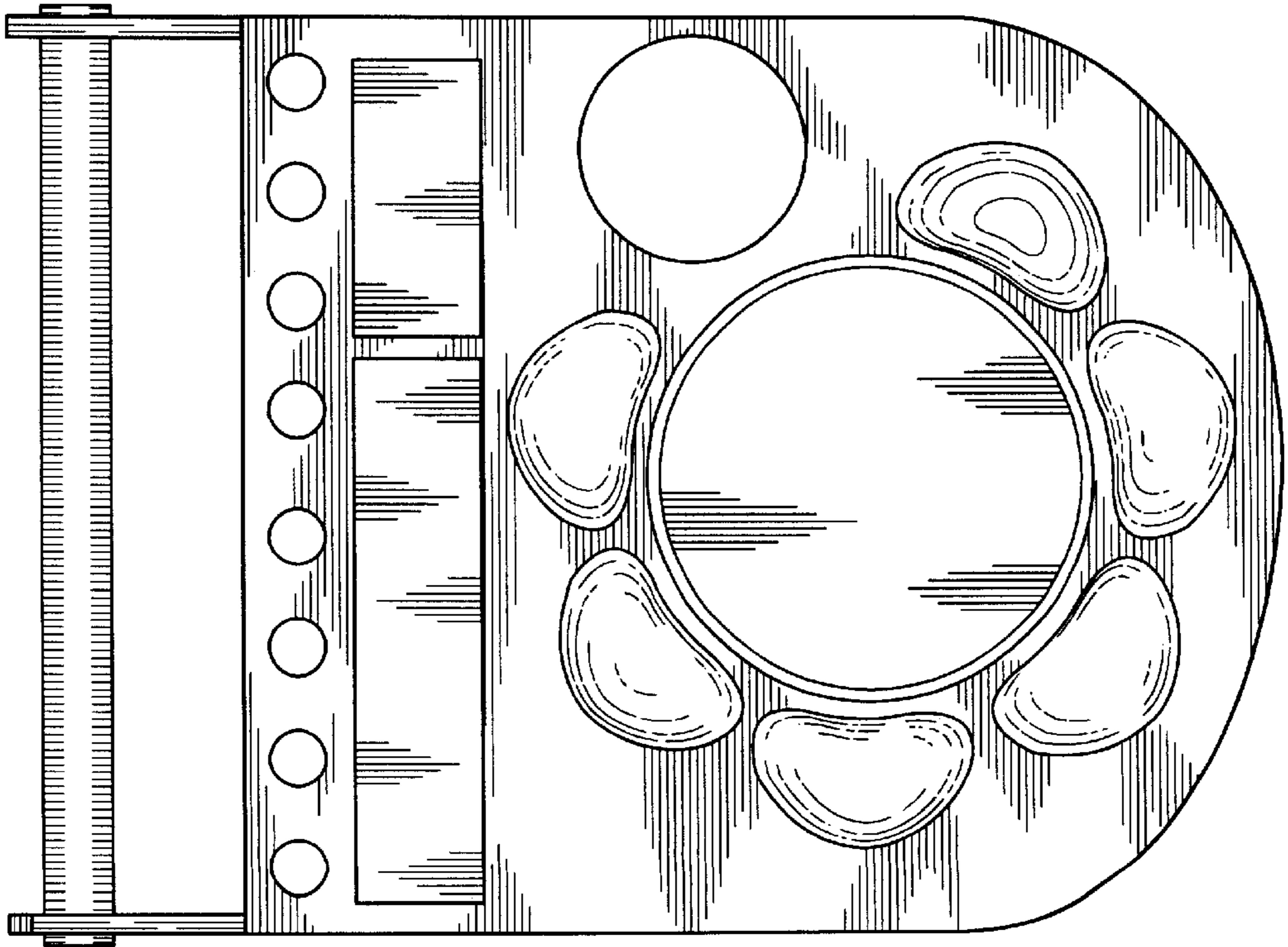

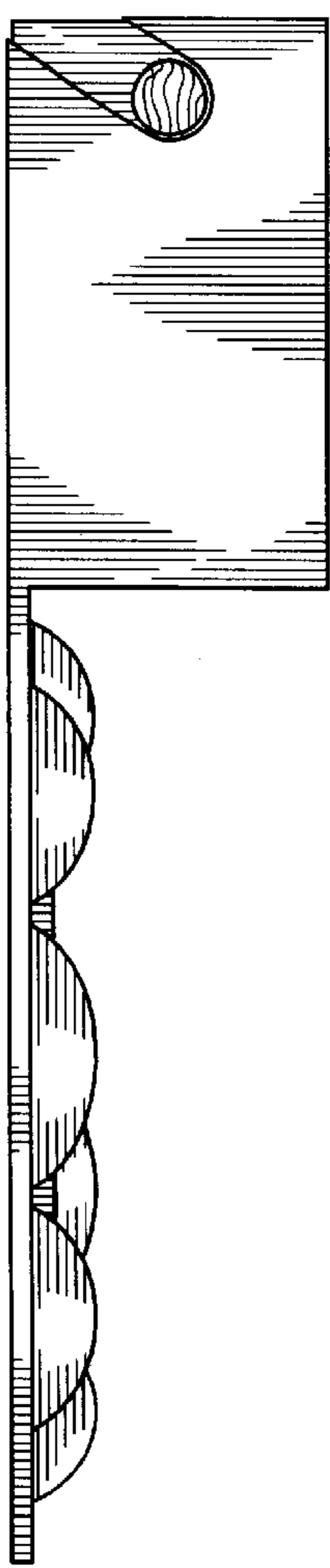

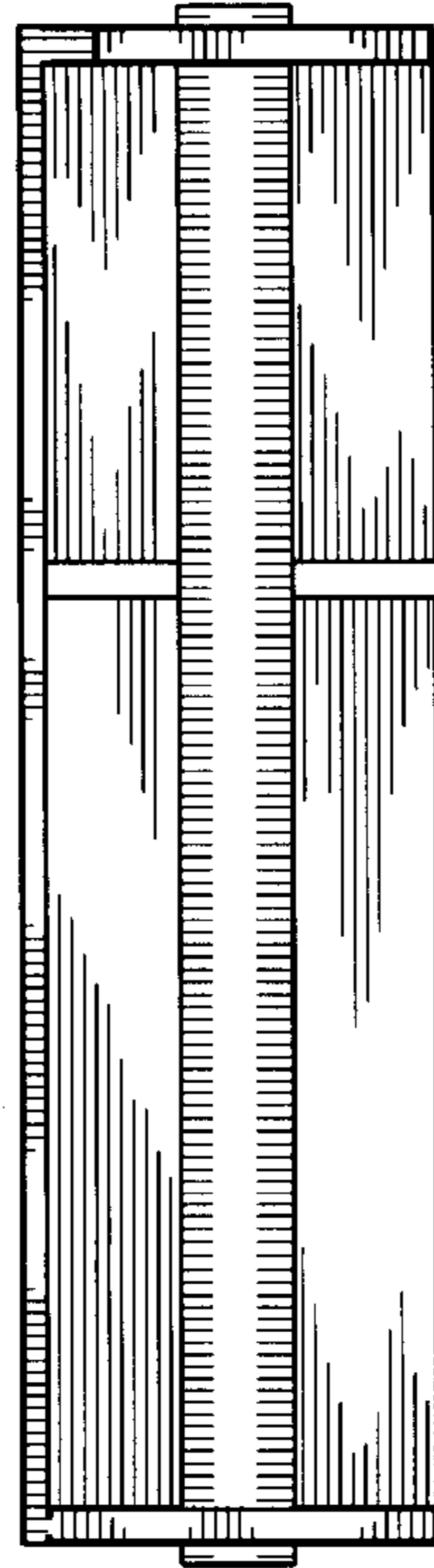
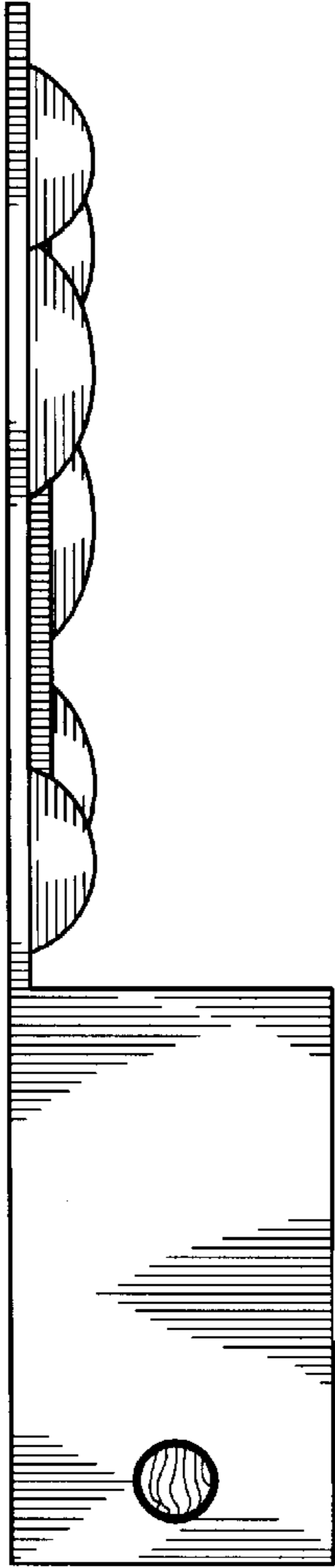

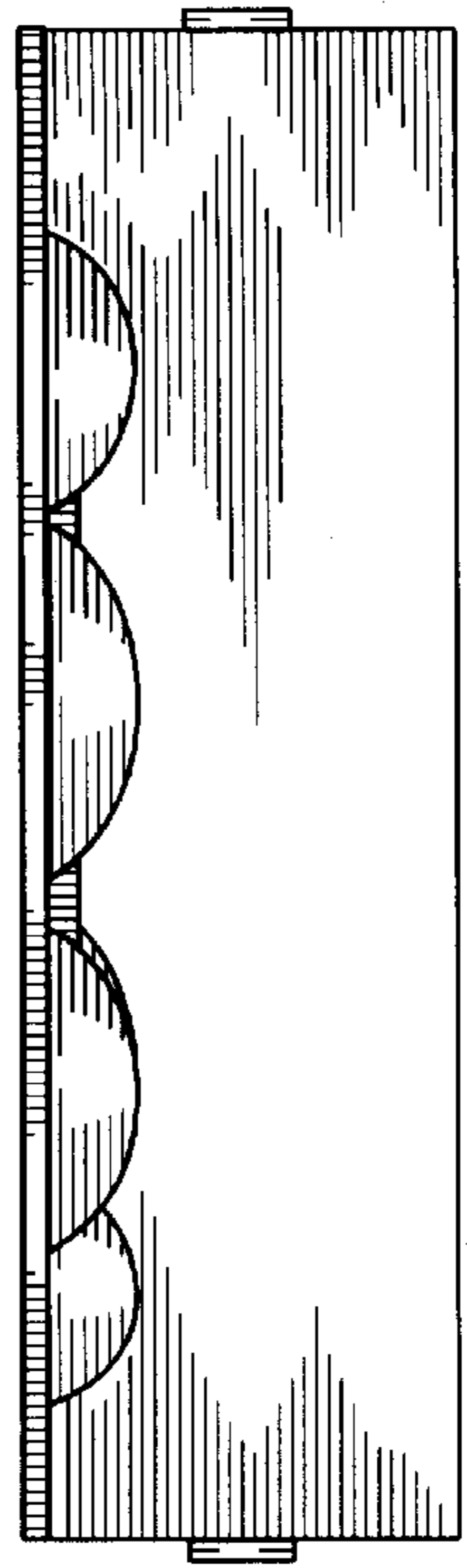
