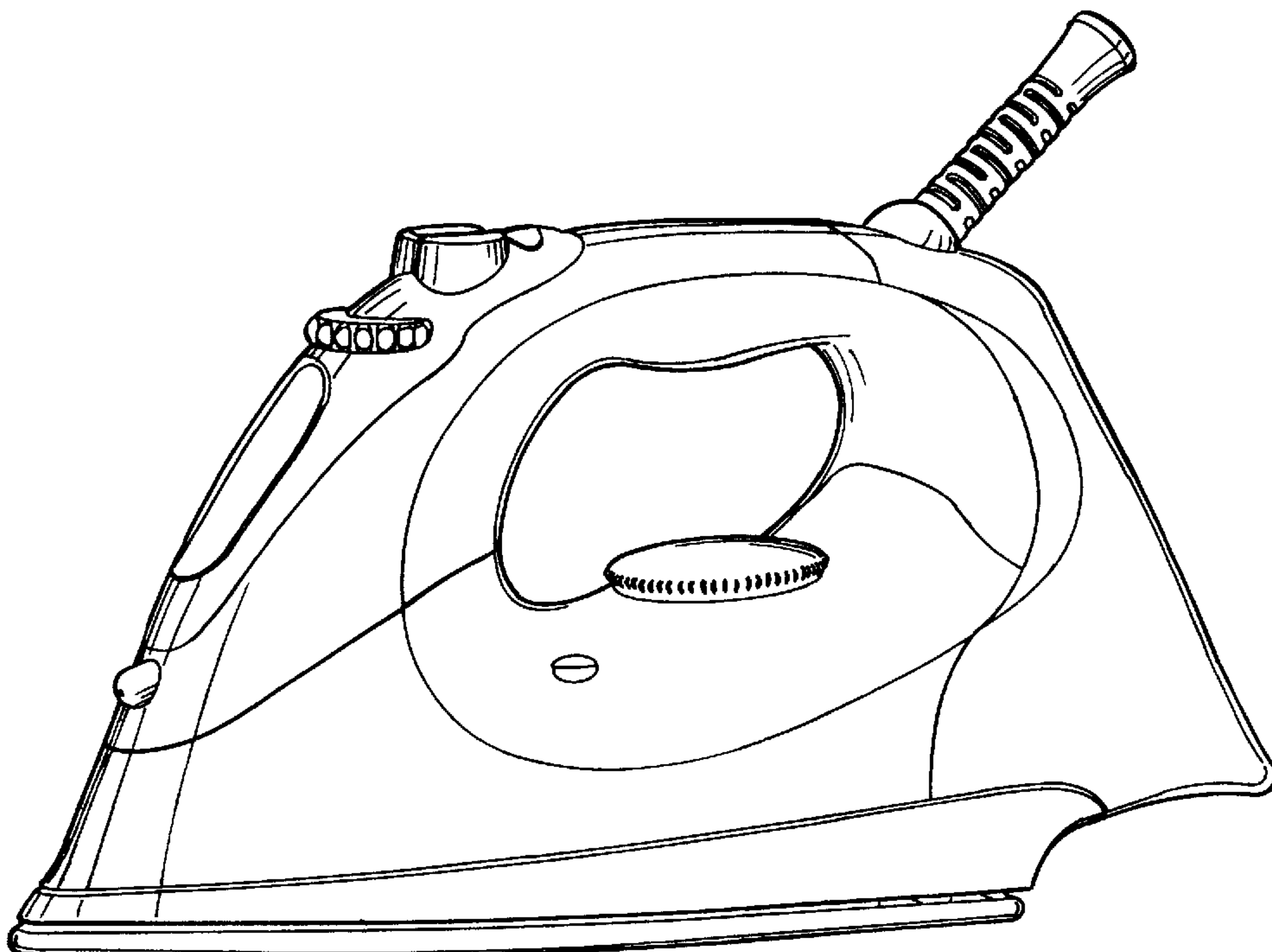
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of my iron;
FIG. 2 is a side elevational view of one side thereof;

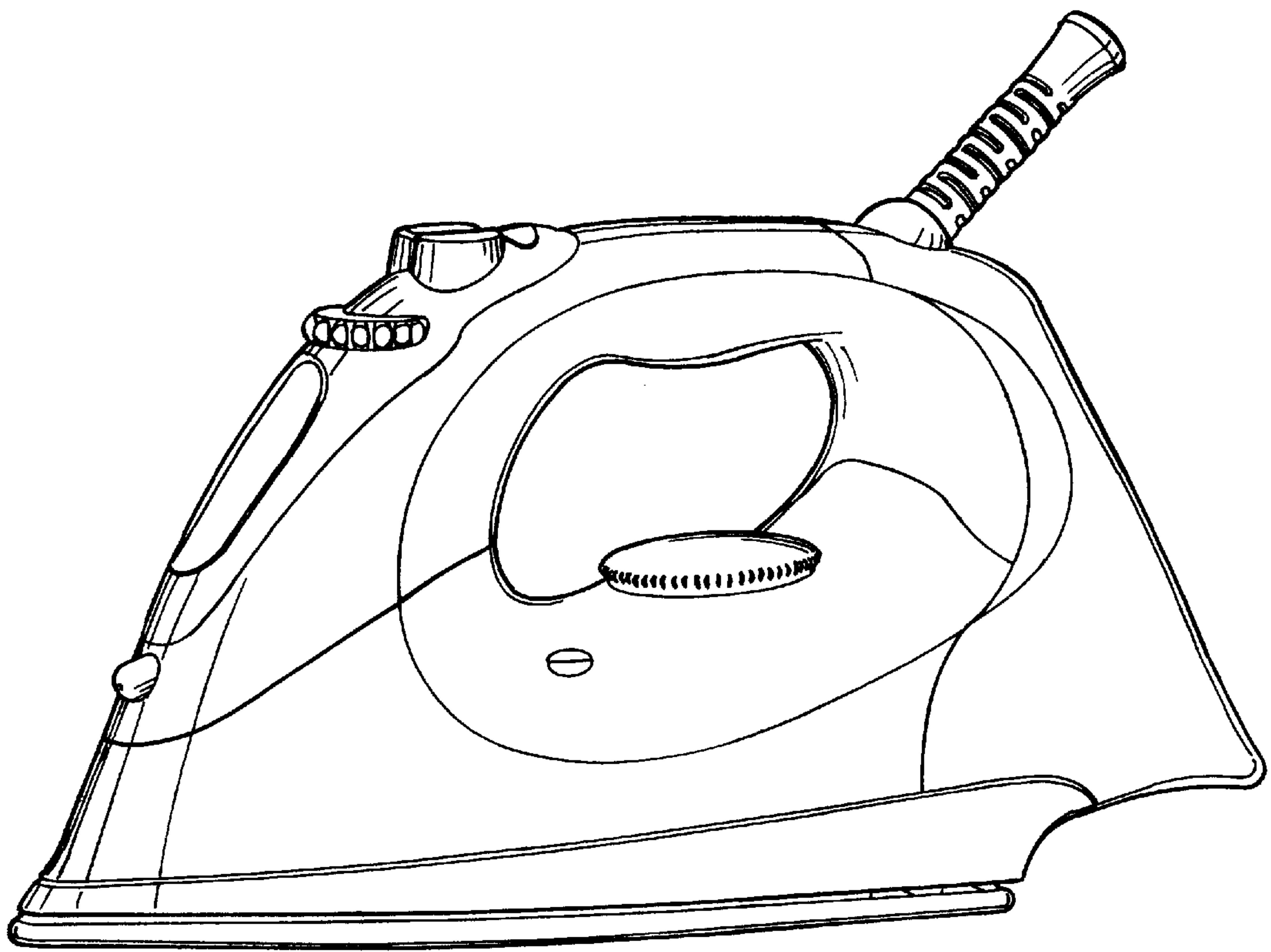

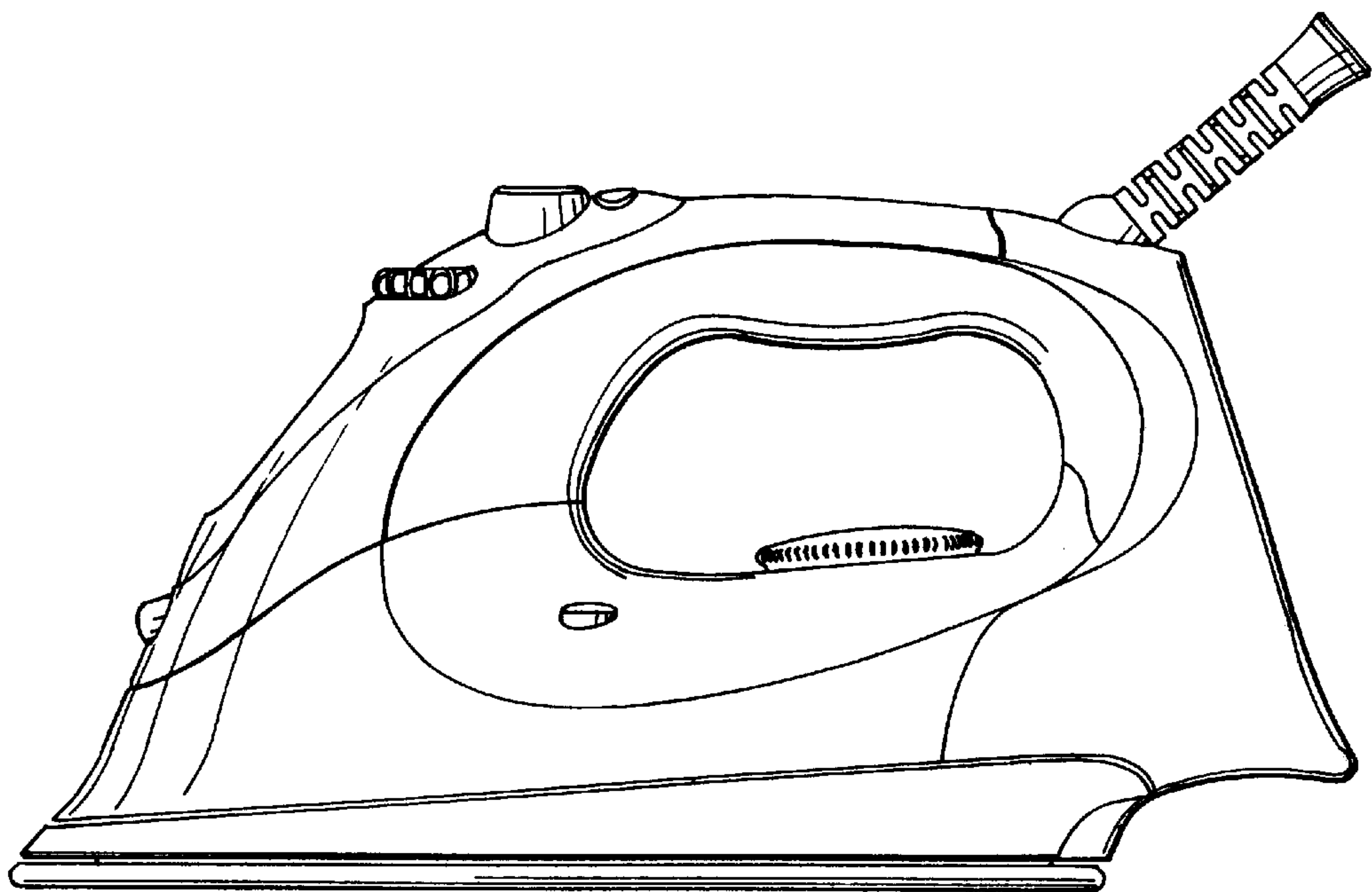

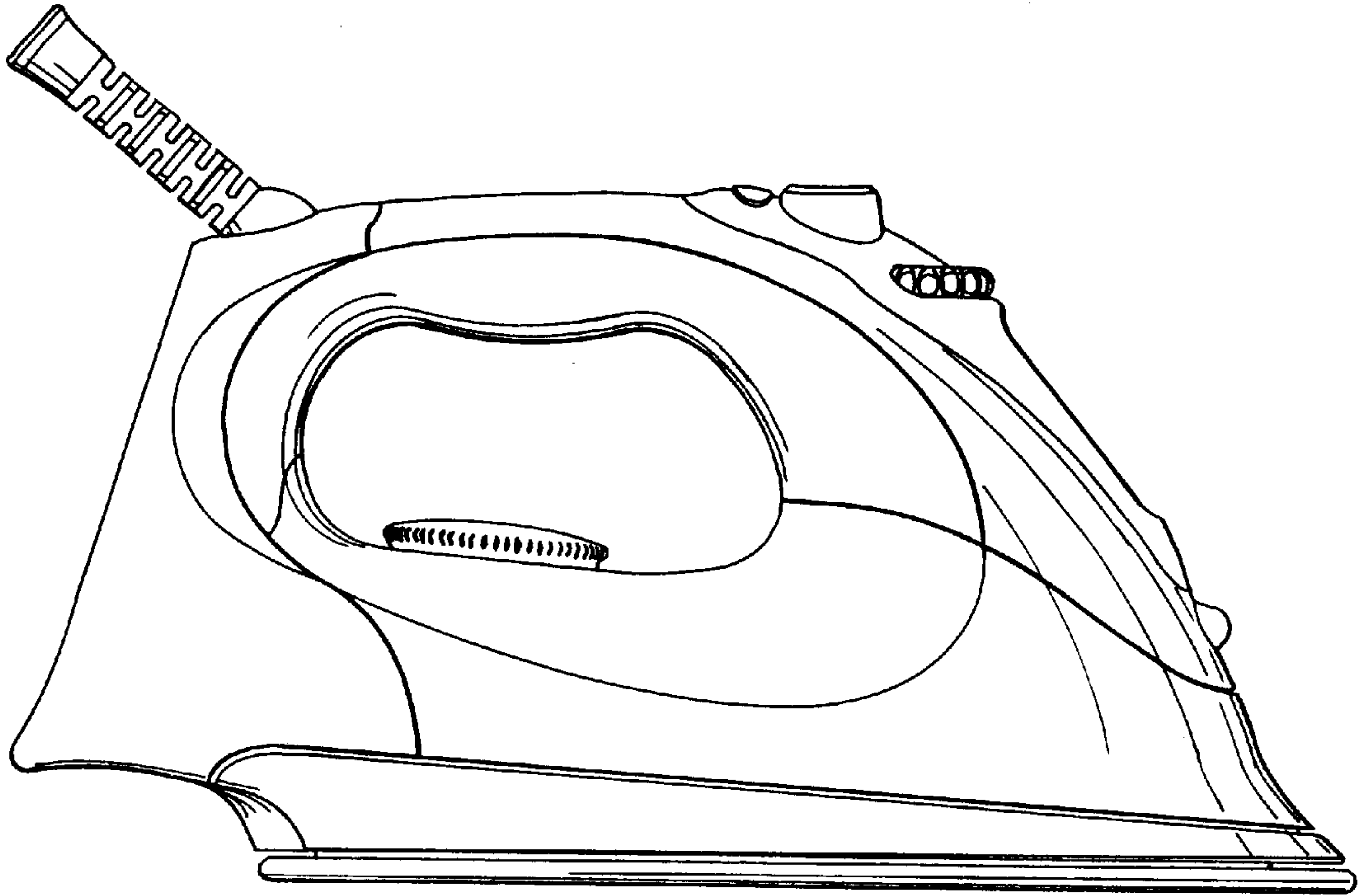

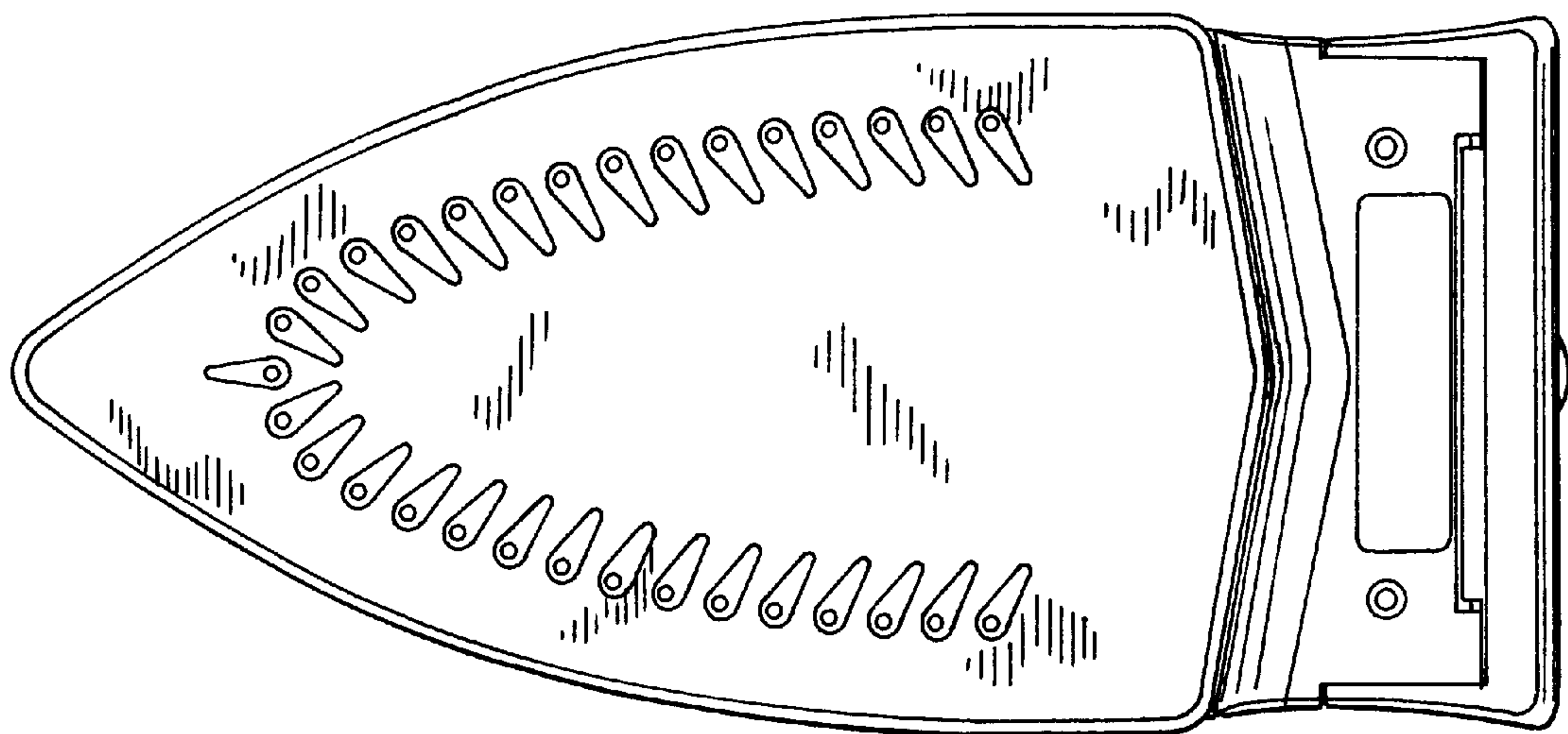

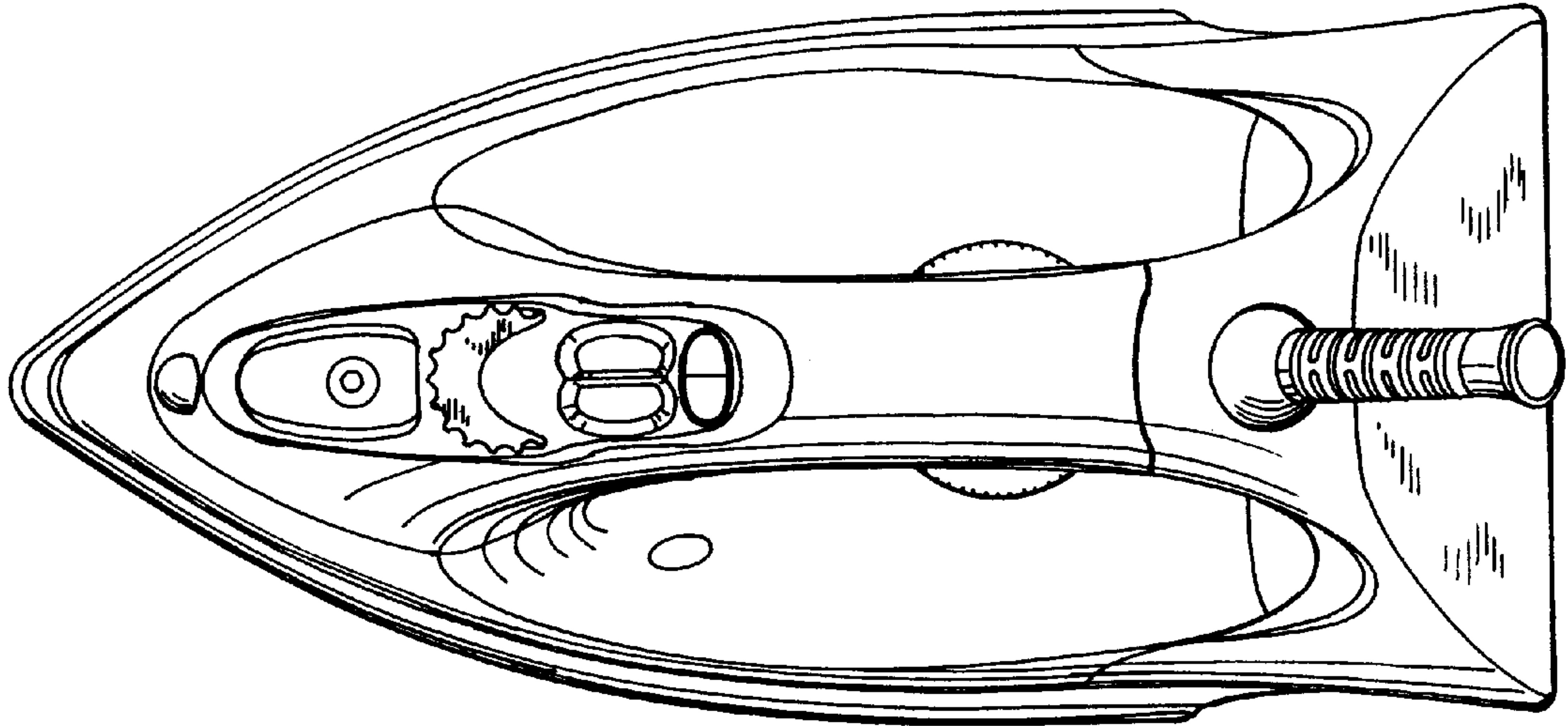

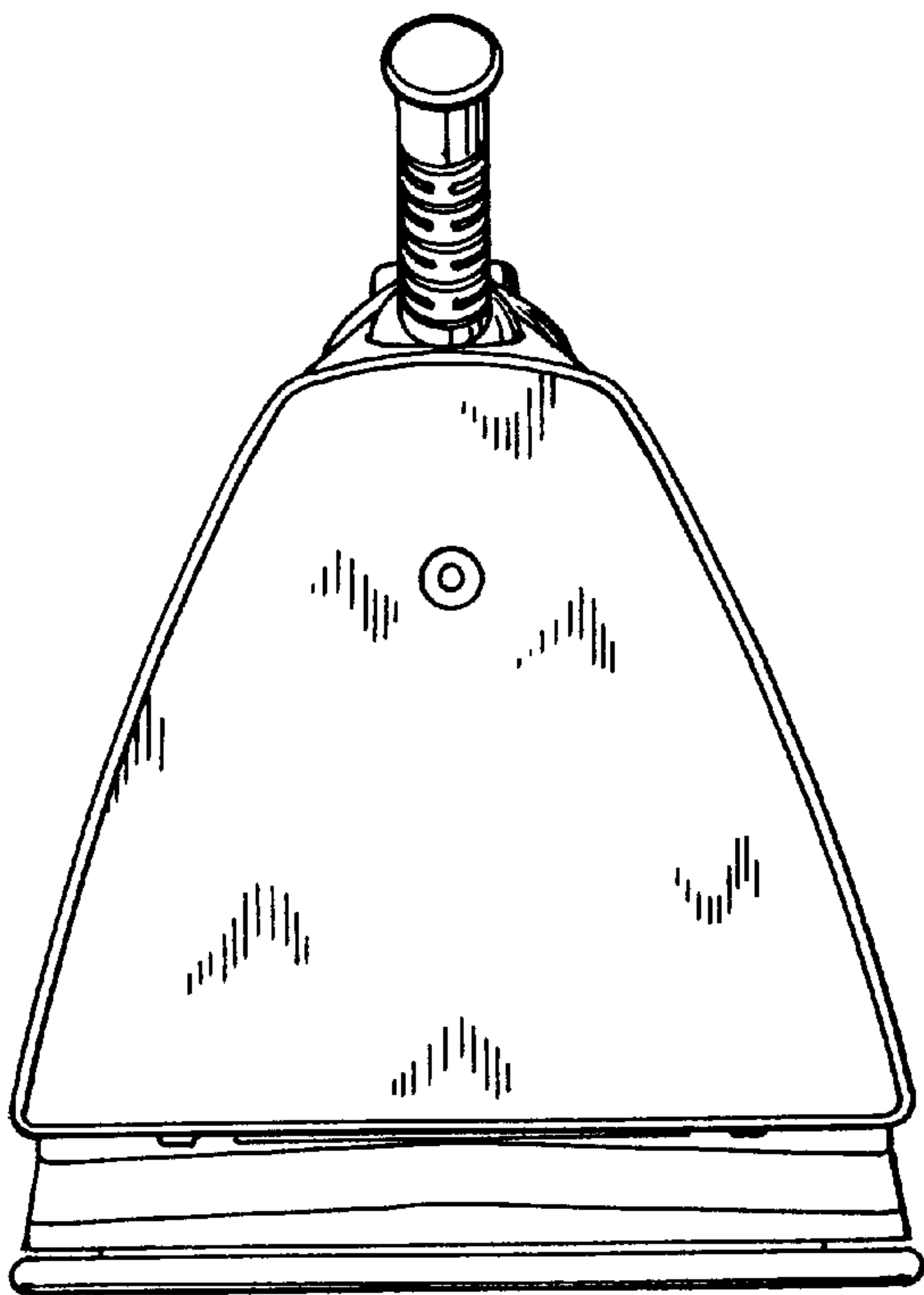

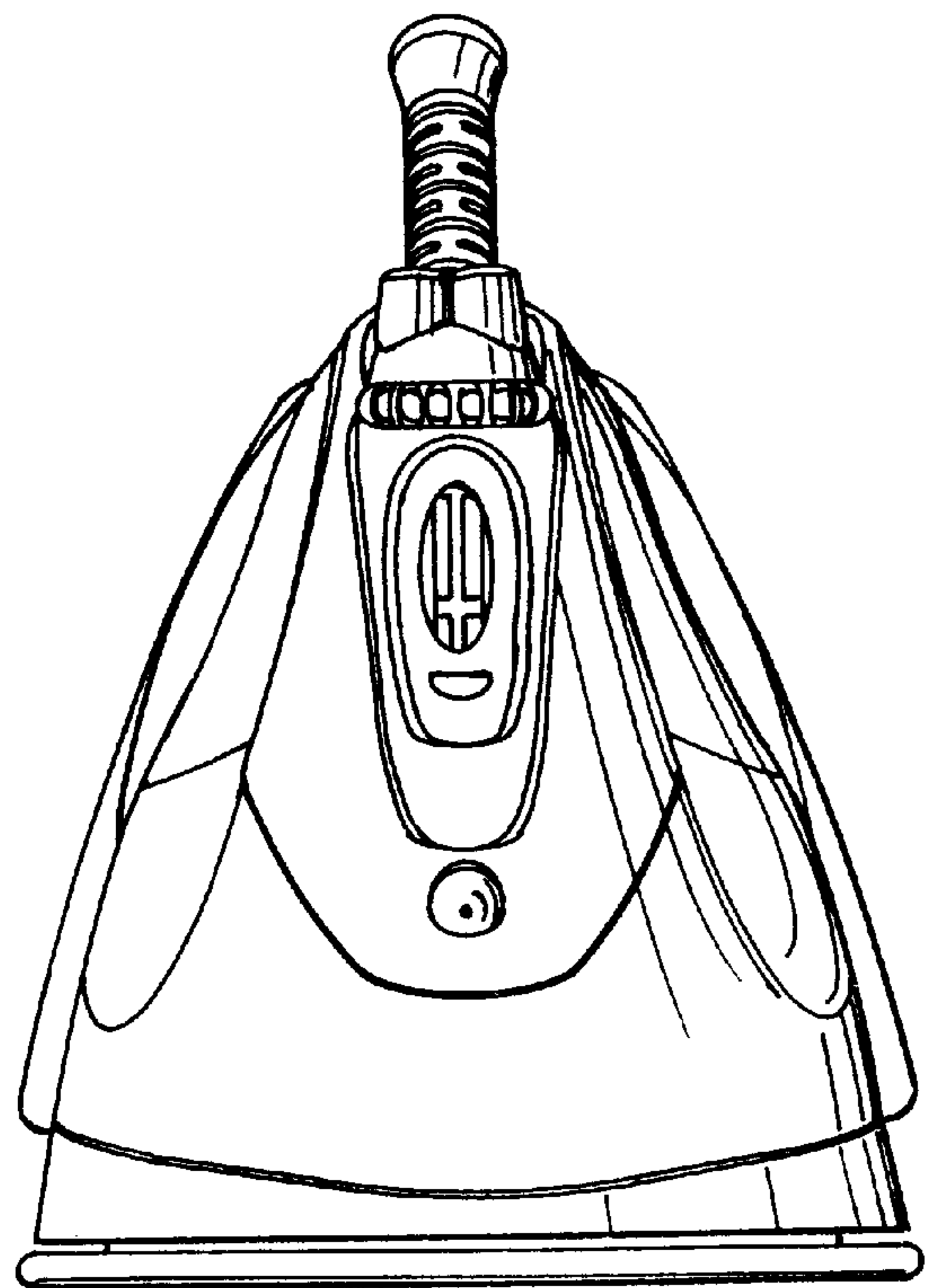
