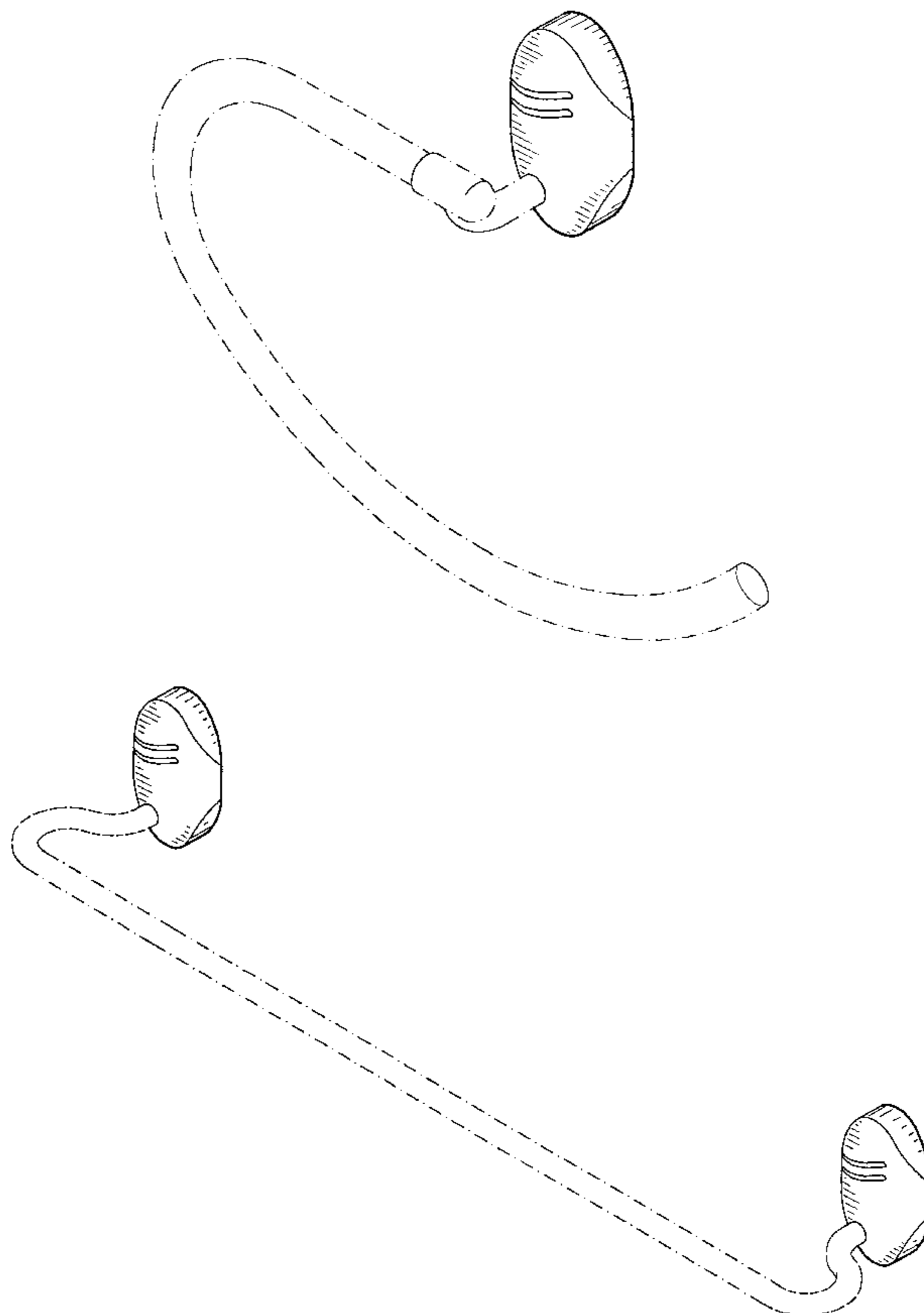
(57) **CLAIM**

The ornamental design for a post for bath accessory, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a post for bath accessory showing a first embodiment of my new design;
 FIG. 2 is a rear elevational view thereof;
 FIG. 3 is a top plan view thereof;
 FIG. 4 is a bottom plan view thereof;
 FIG. 5 is a left side elevational view thereof;
 FIG. 6 is a right side elevational view thereof;
 FIG. 7 is a top, front, and right side perspective view thereof;
 FIG. 8 is a reduced top, front, and right side perspective view thereof, with the broken-line disclosure of a towel ring being for illustrative purposes only and forming no part of the claimed design; and,
 FIG. 9 is a reduced top, front, and right side perspective view of a post for bath accessory showing a second embodiment of my new design, with the broken-line disclosure of a towel bar being for illustrative purposes only and forming no part of the claimed design.

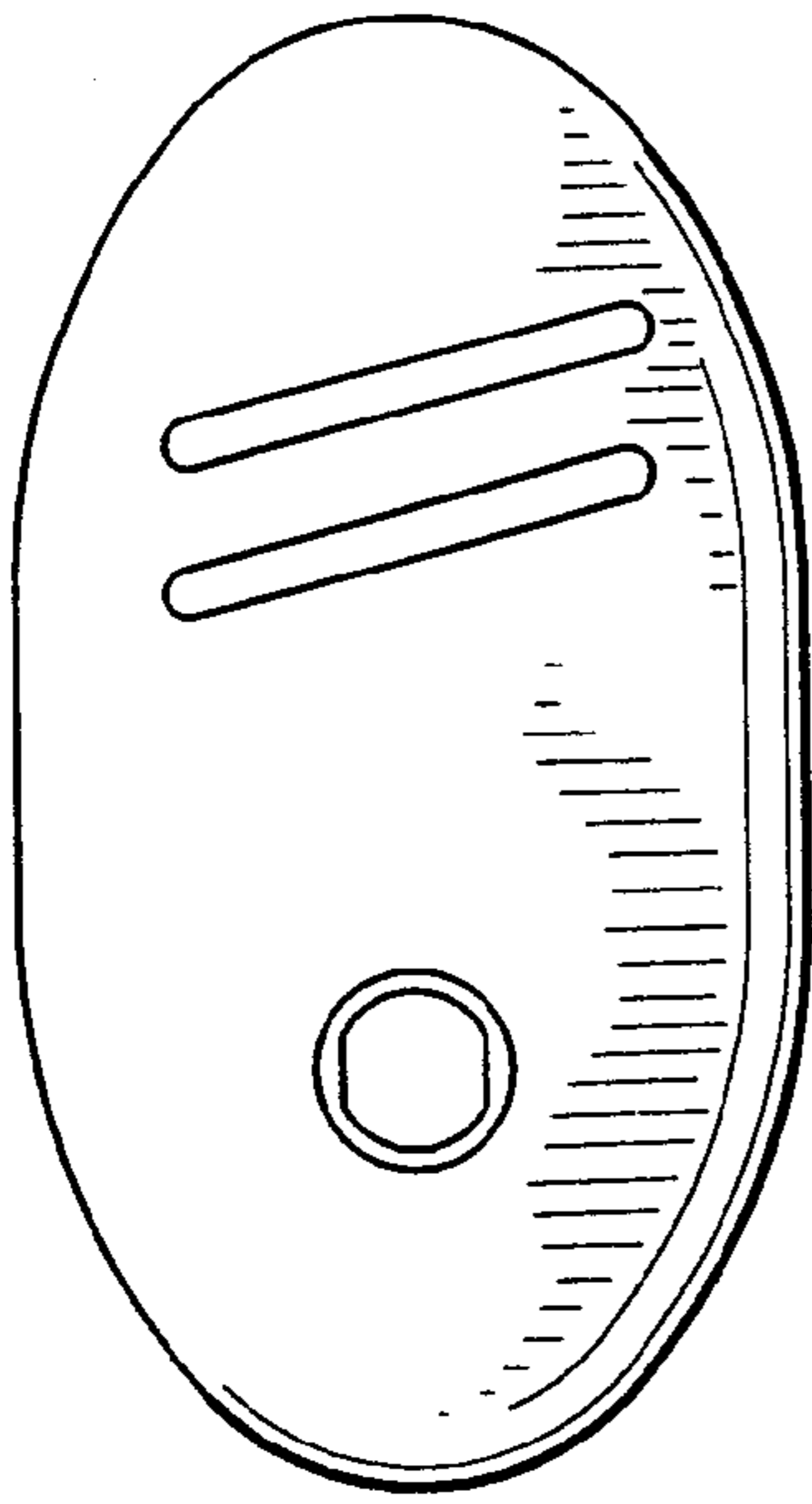

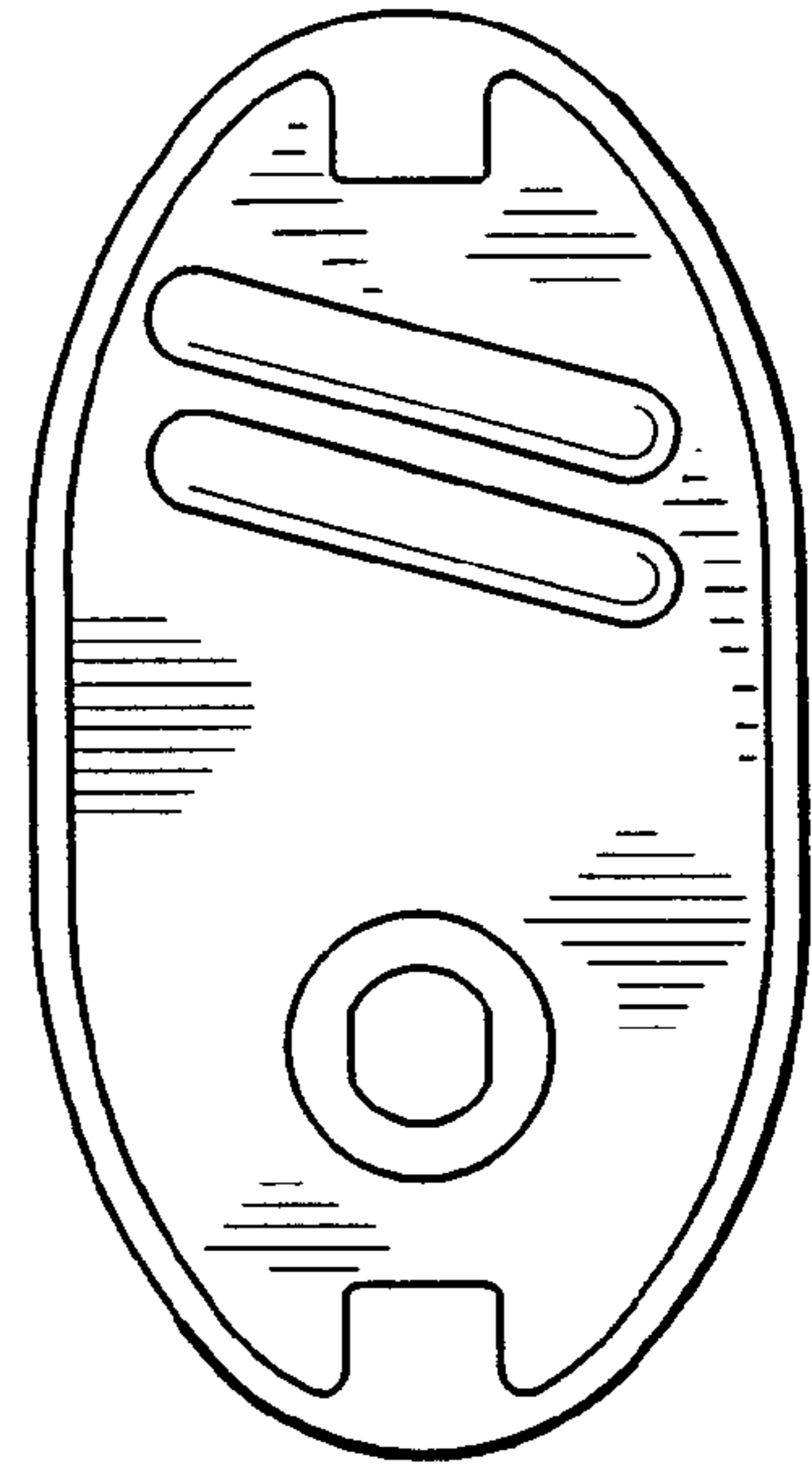

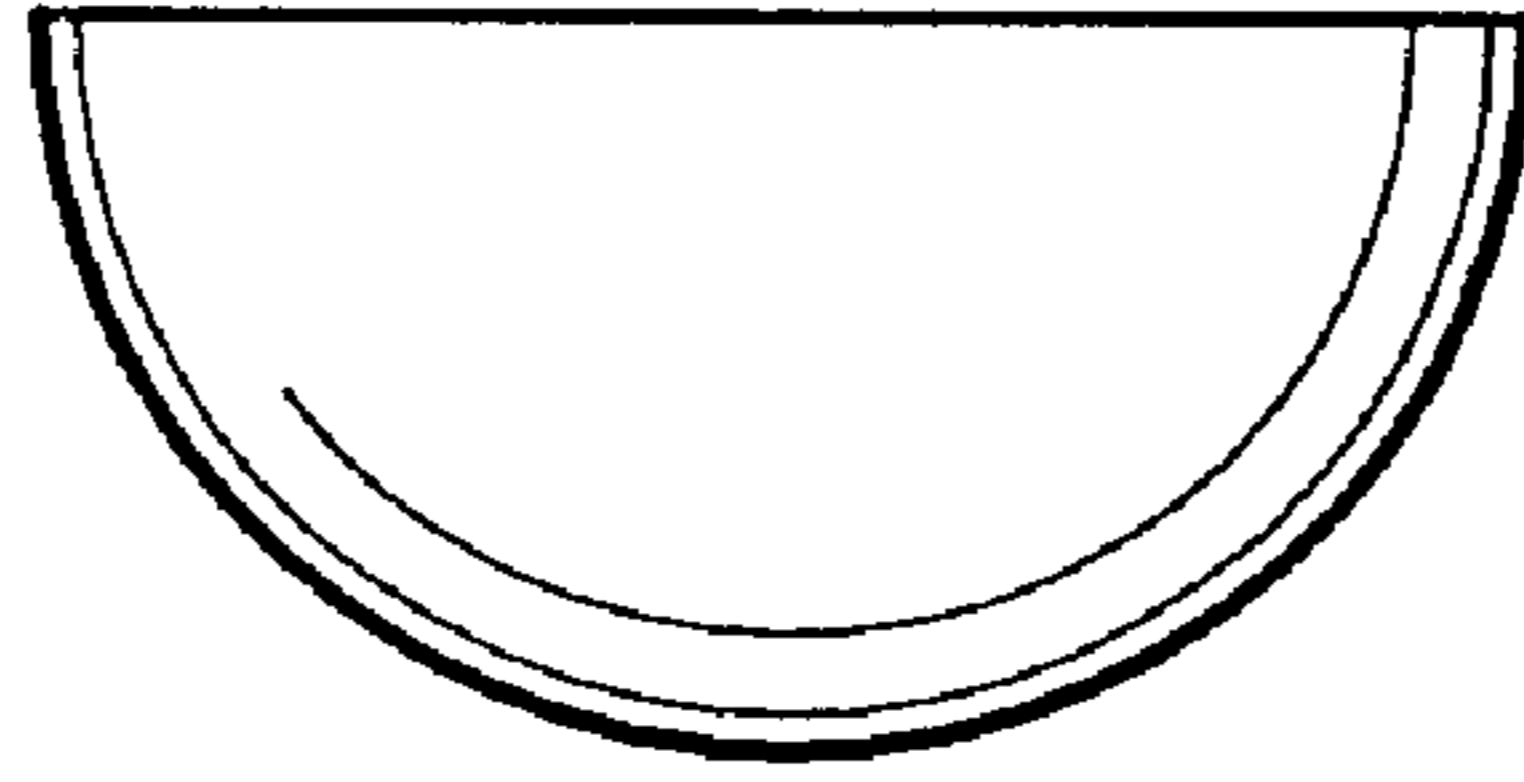

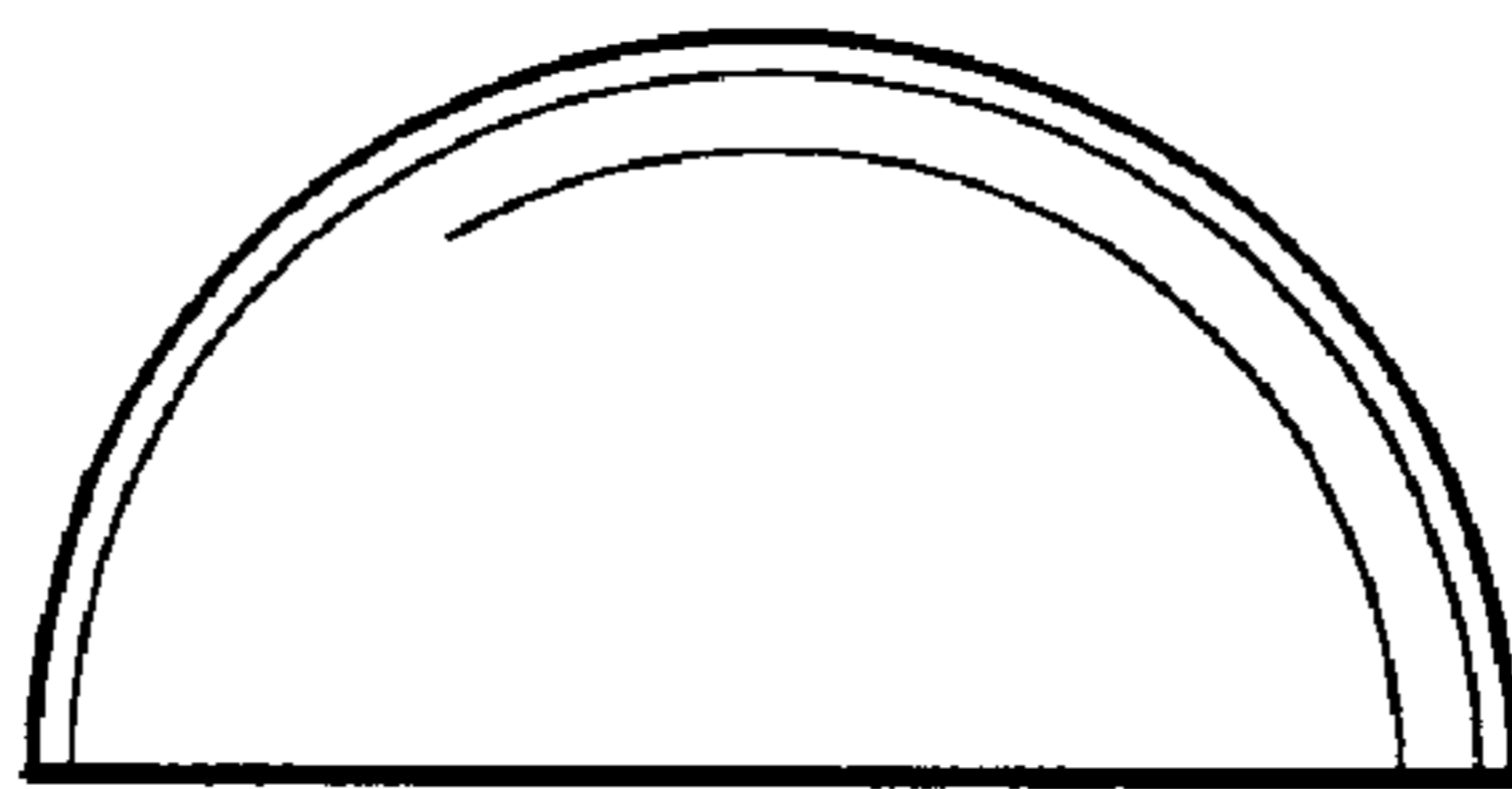

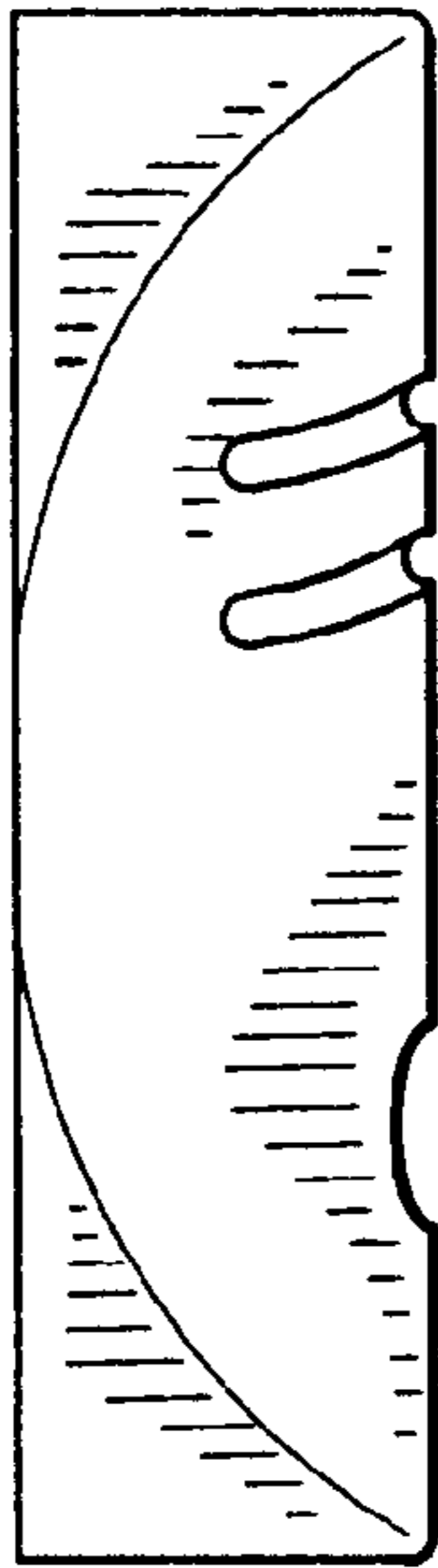

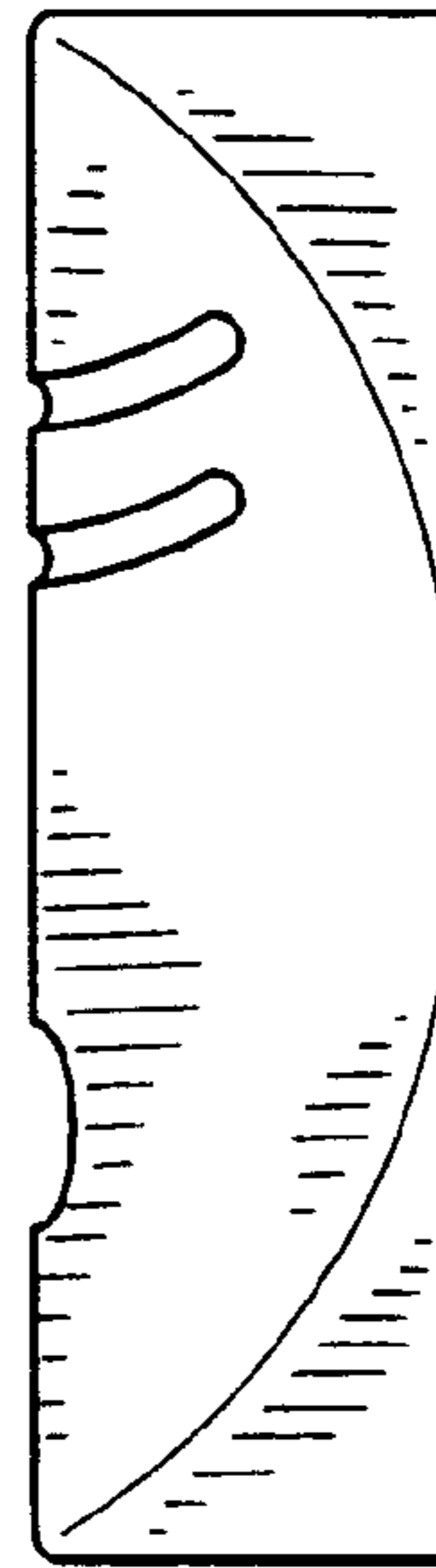

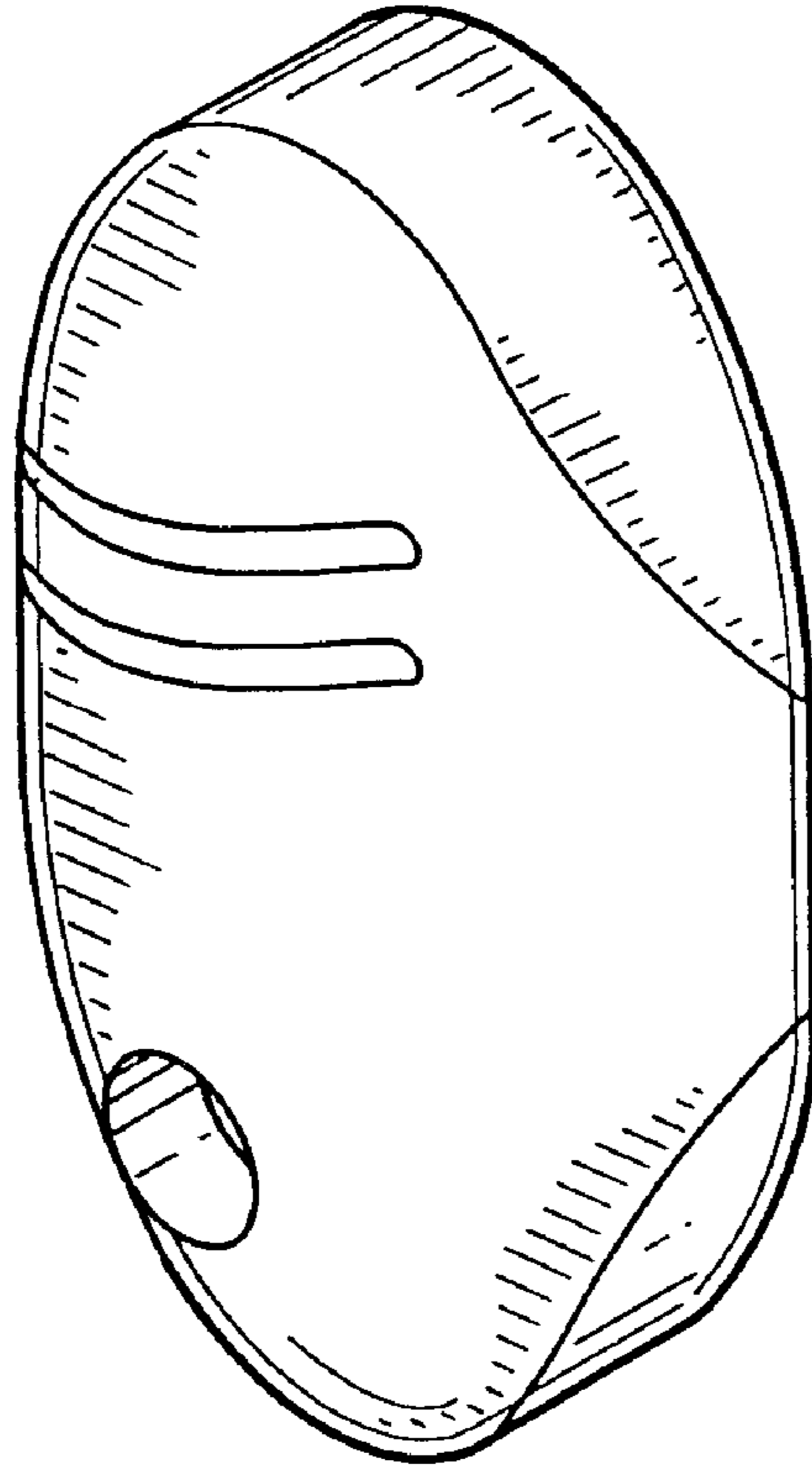

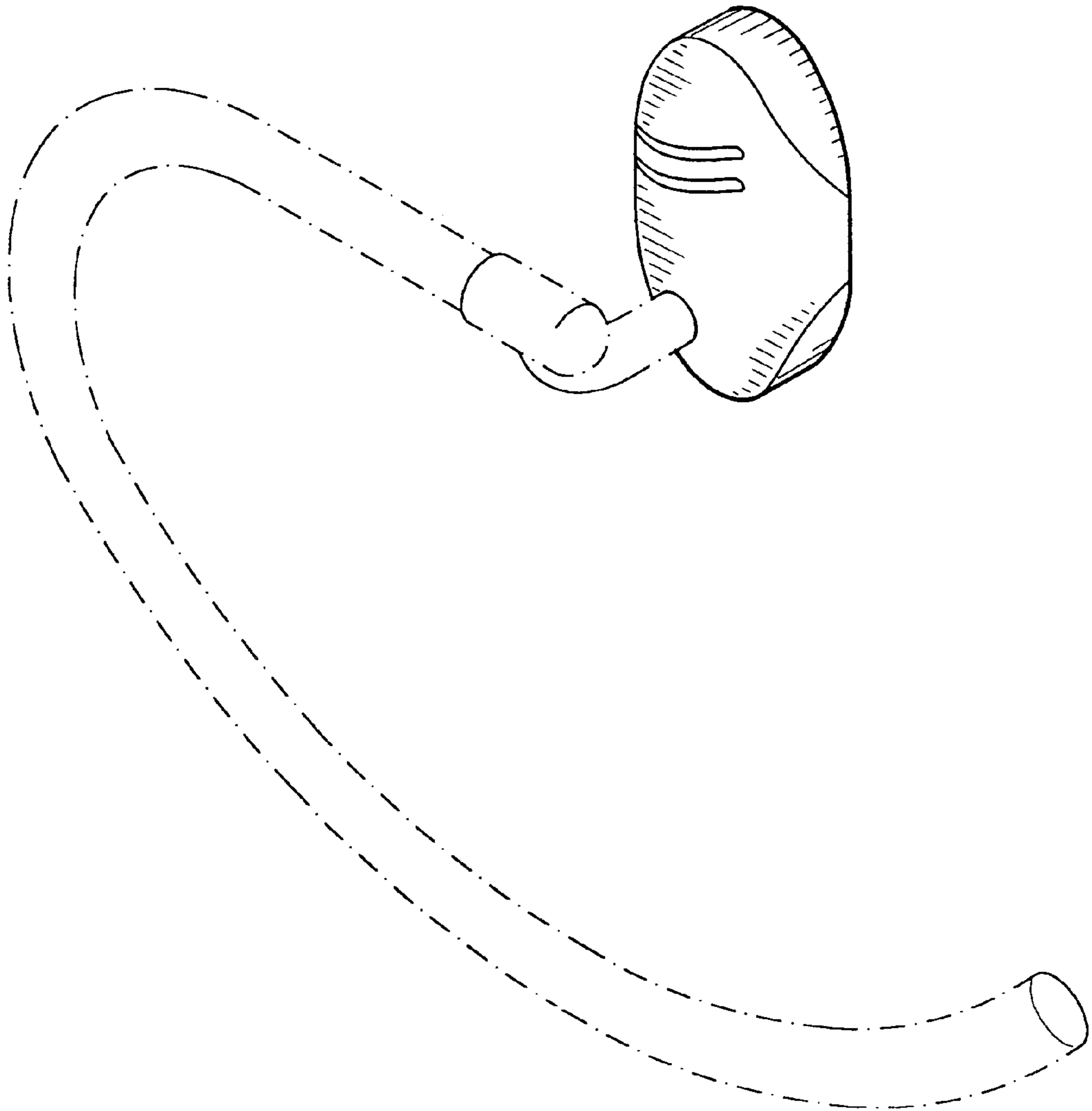

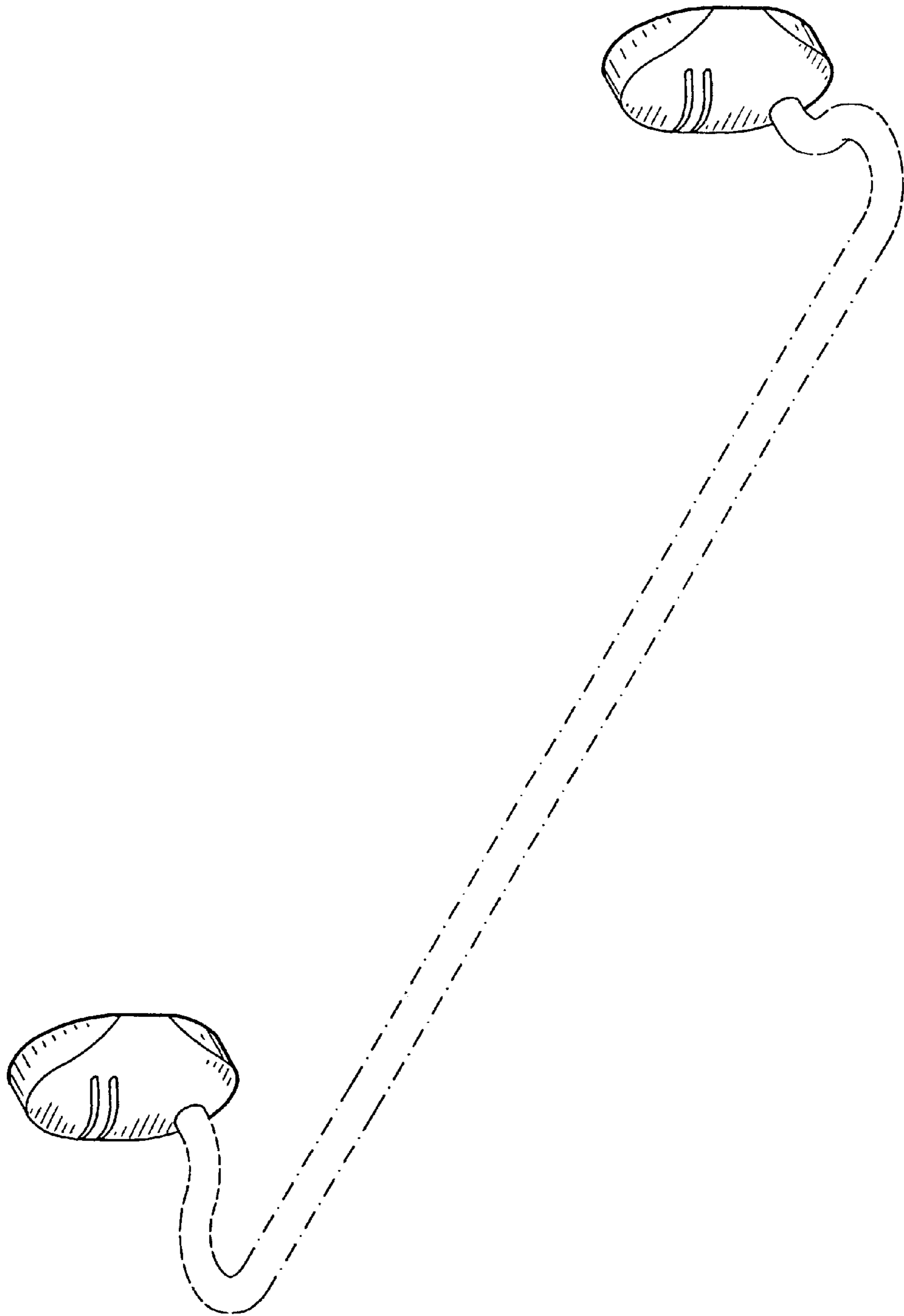
