(57) **CLAIM**

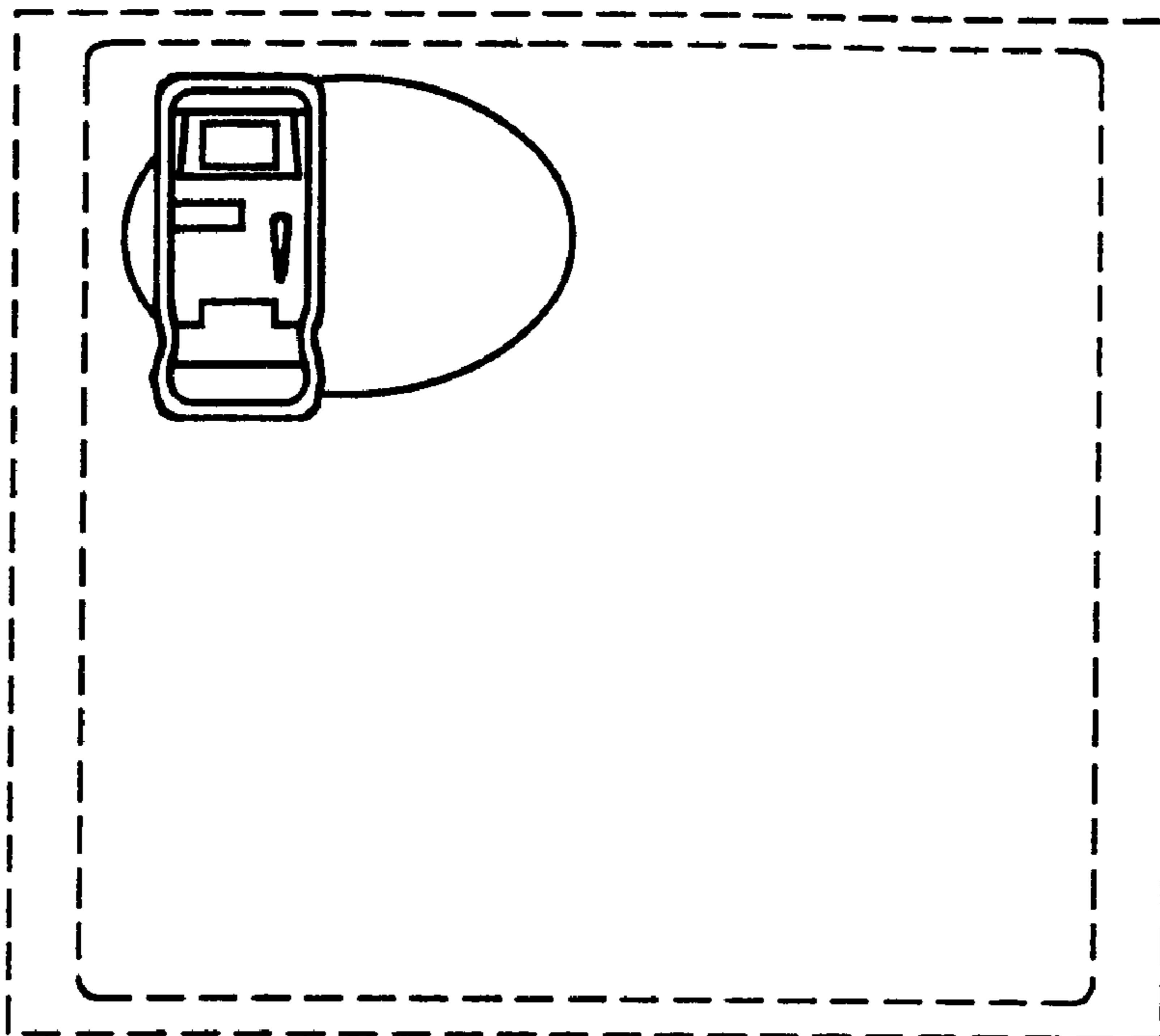
The ornamental design for an icon for a display panel on a medical apparatus, as shown and described.

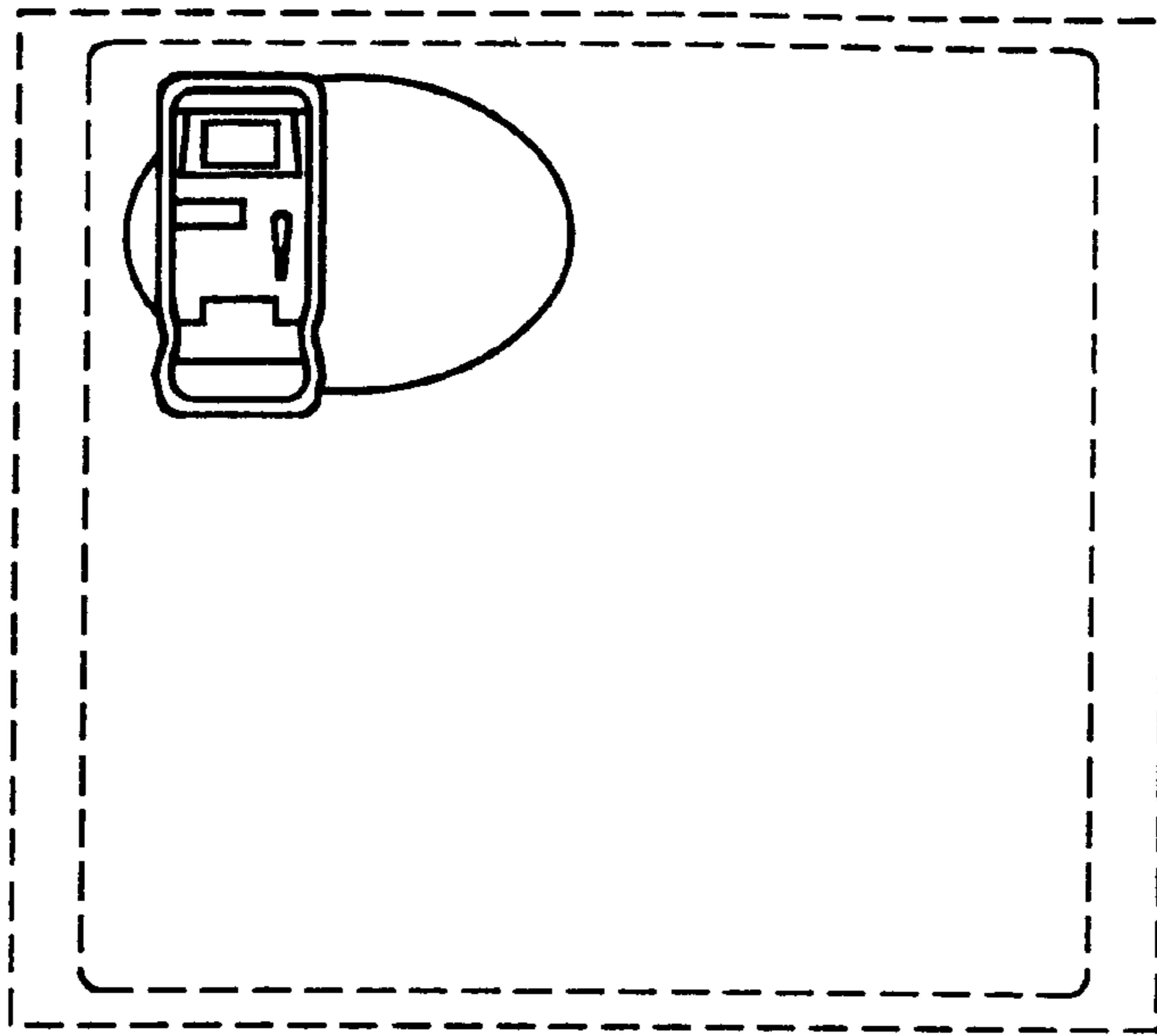

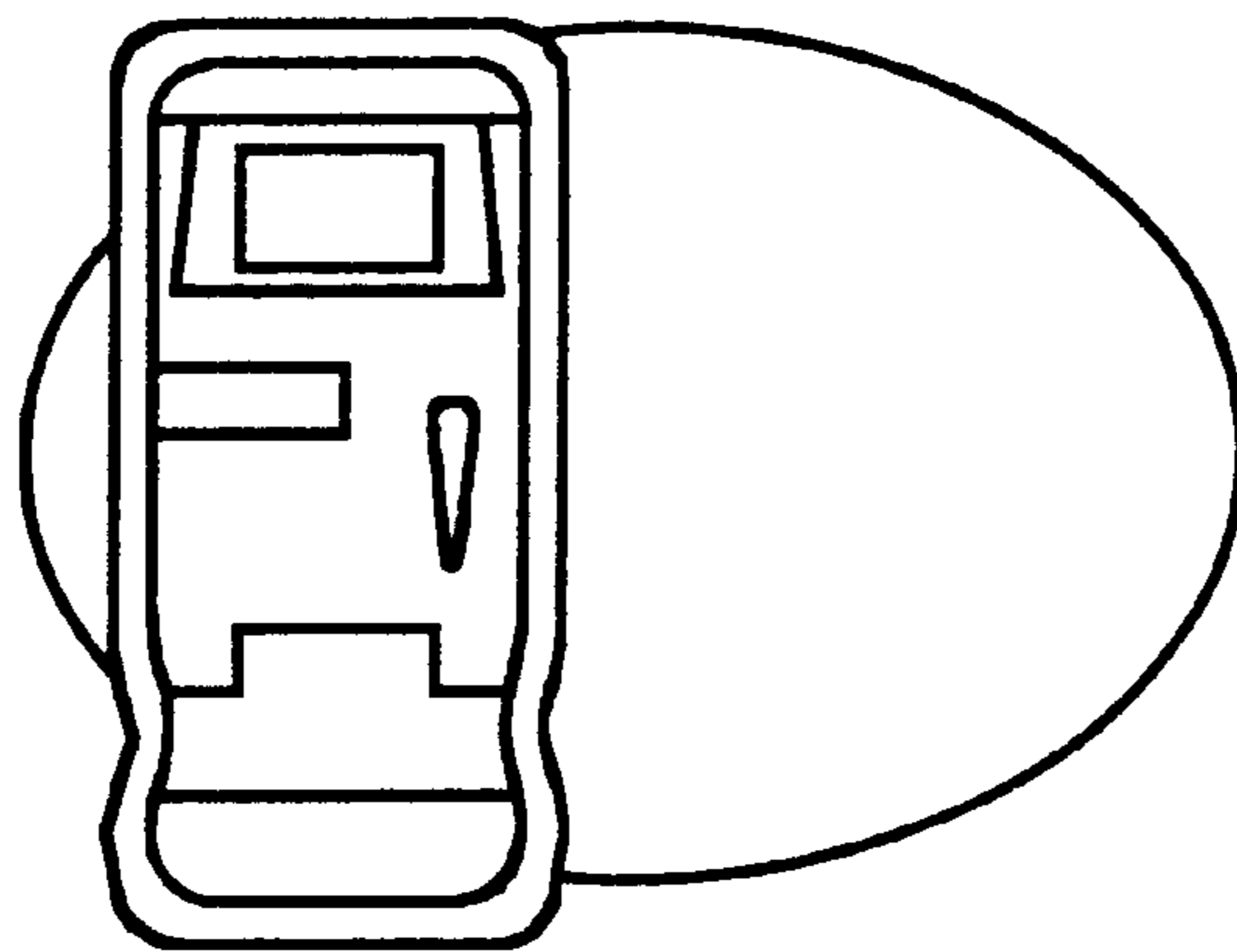

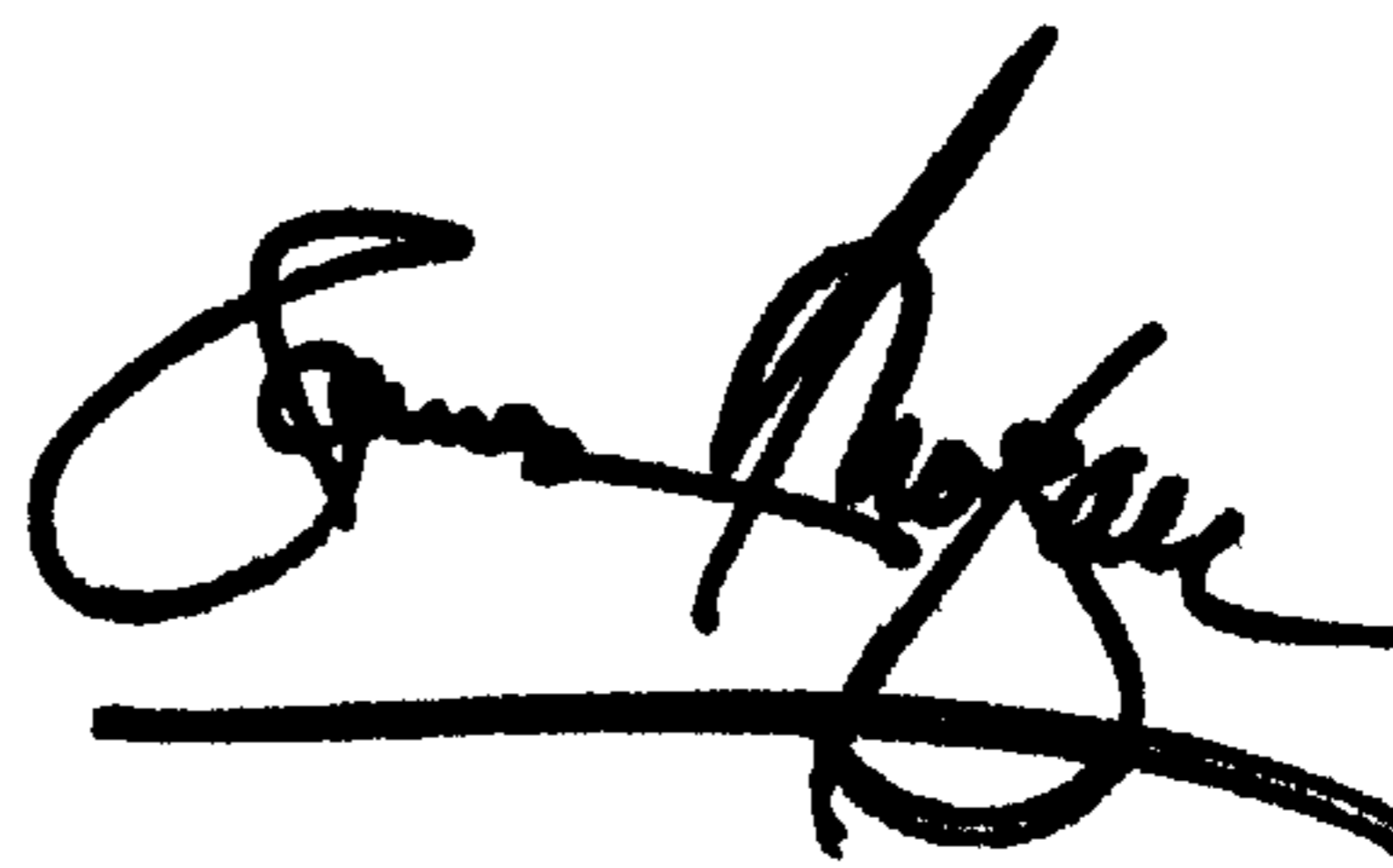
