The ornamental design for an ink tank for printer, as shown and described.

DESCRIPTION

FIG. 1 is a front view of an ink tank for printer showing our new design;

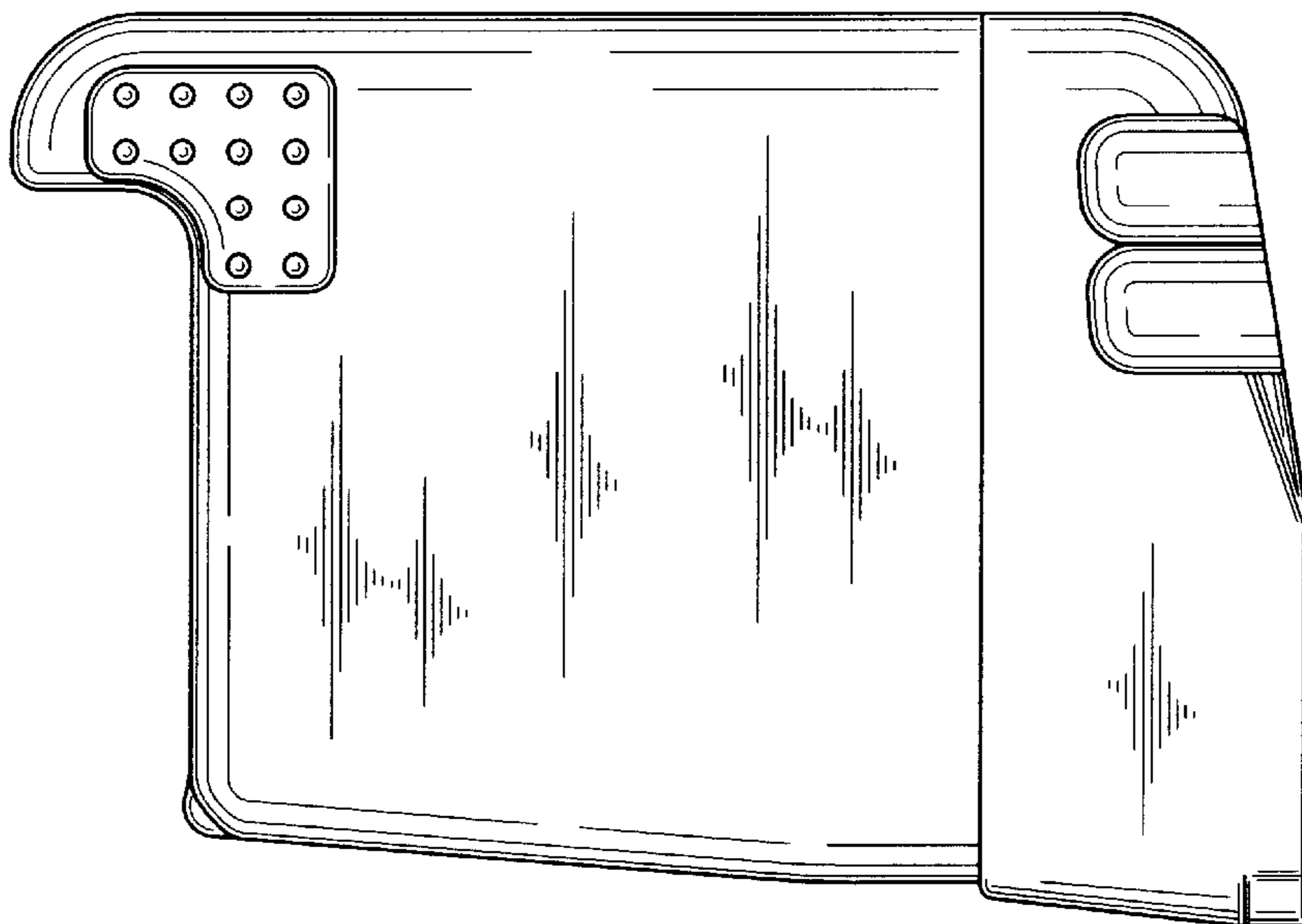

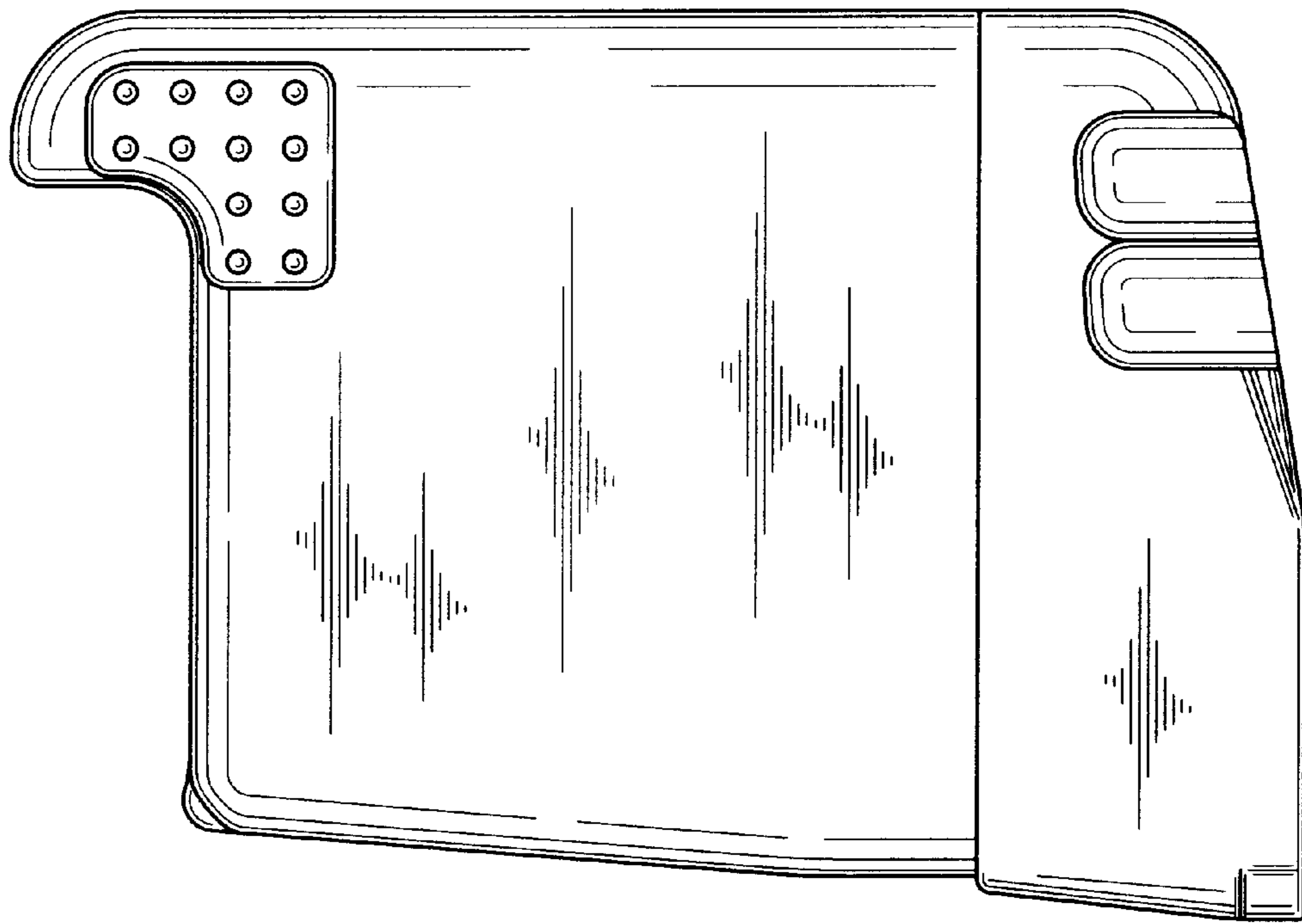

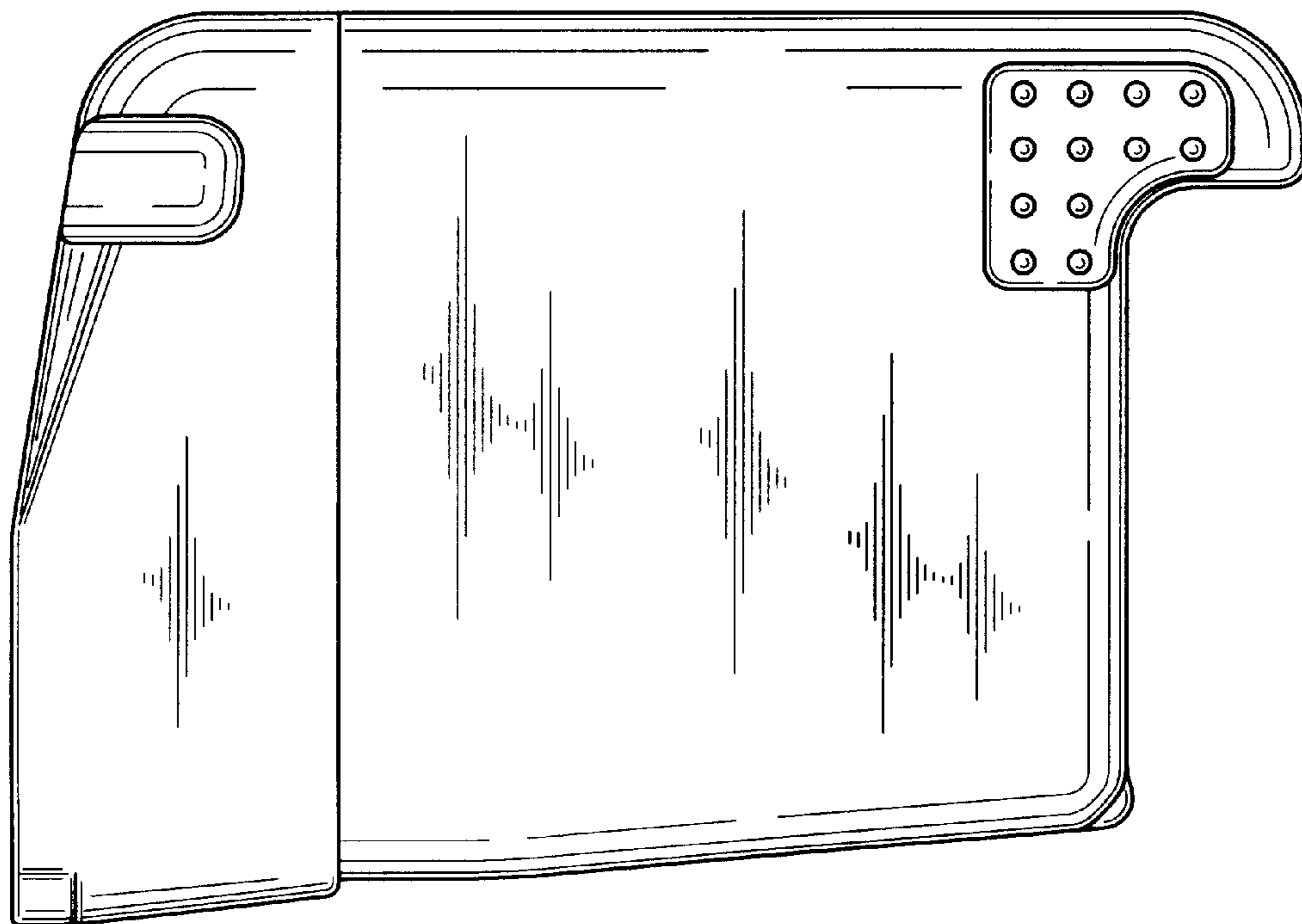

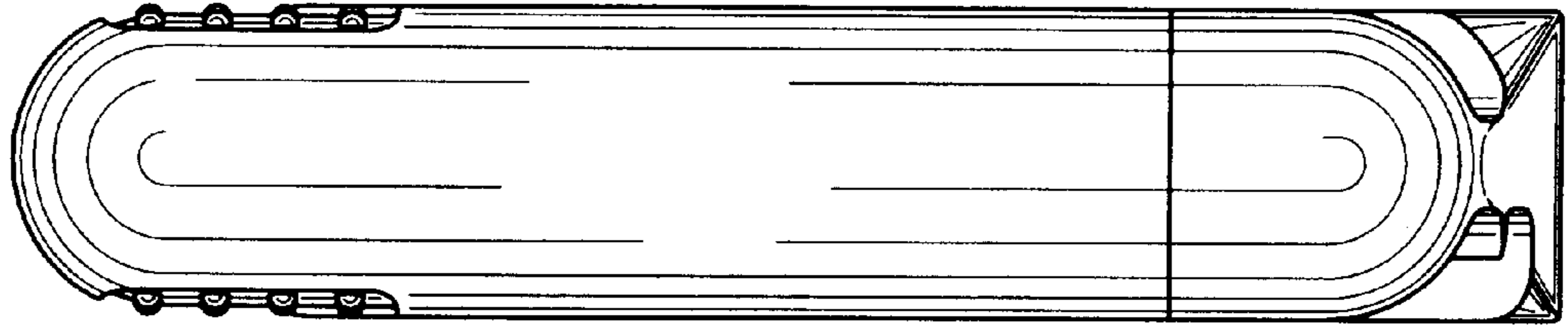

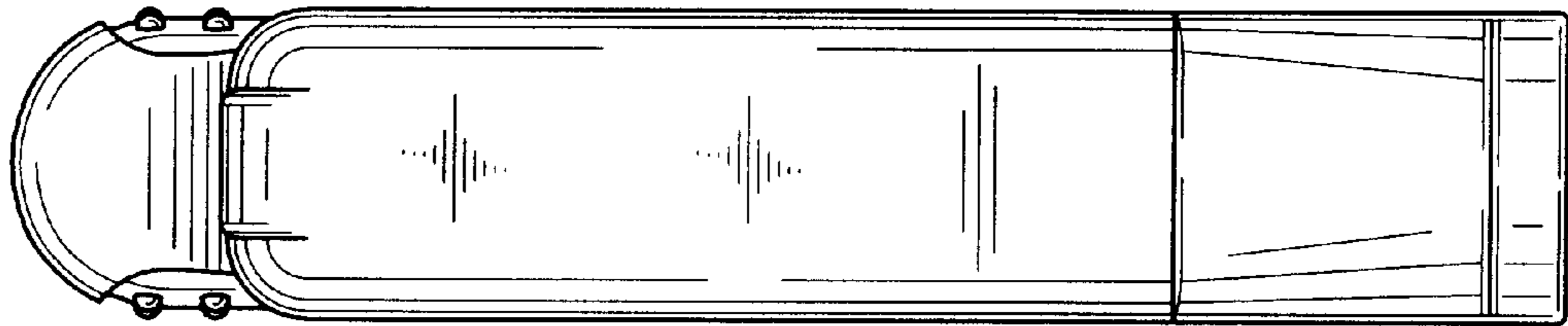

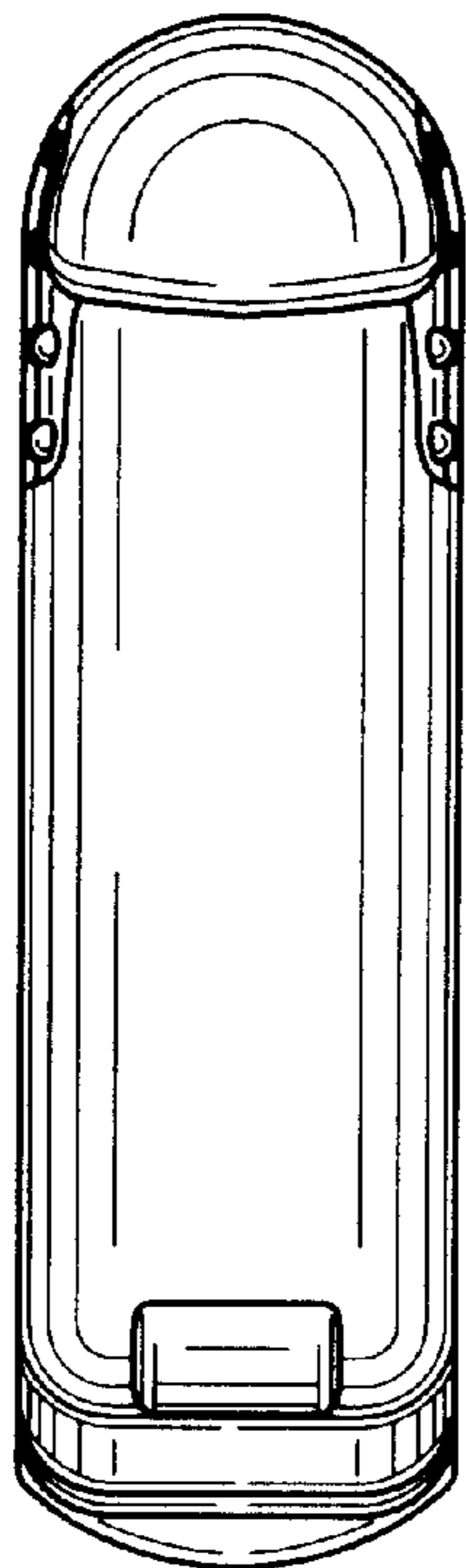

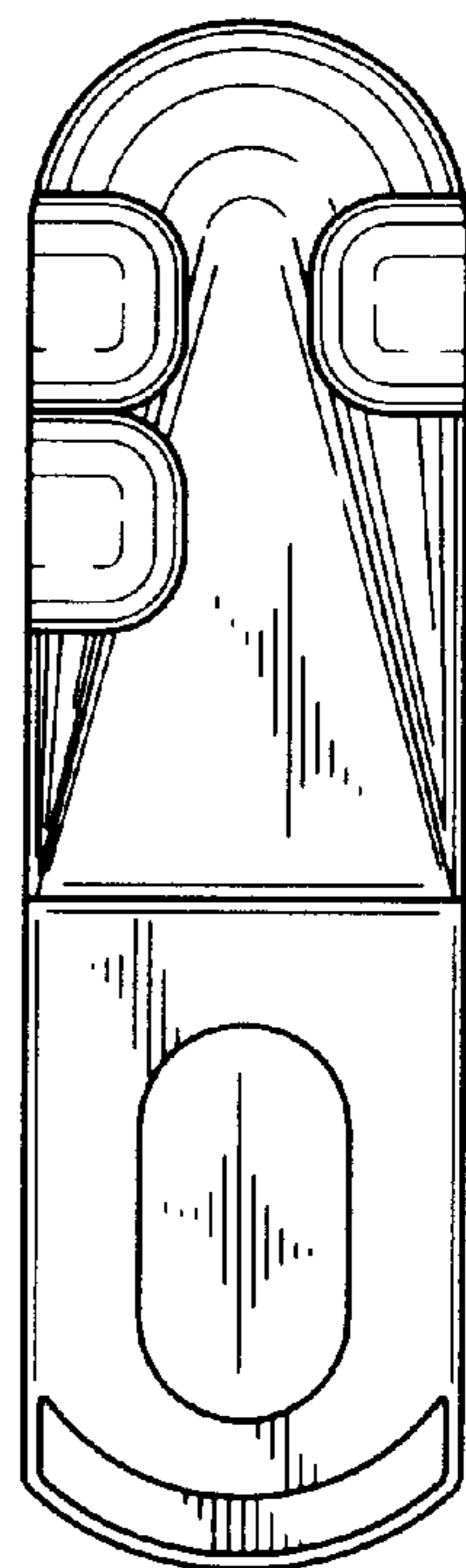
