(57) **CLAIM**

The ornamental design for a pen/pencil holder, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the pen/pencil holder; FIG. 2 is a top plan view of the pen/pencil holder; FIG. 3 is a side elevation view of the pen/pencil holder; FIG. 4 is a front elevation view of the pen/pencil holder; FIG. 5 is a rear elevation view of the pen/pencil holder; FIG. 6 is a bottom plan view of the pen/pencil holder; and, FIG. 7 is a side elevation view of the pen/pencil holder opposite the side shown in FIG. 3.

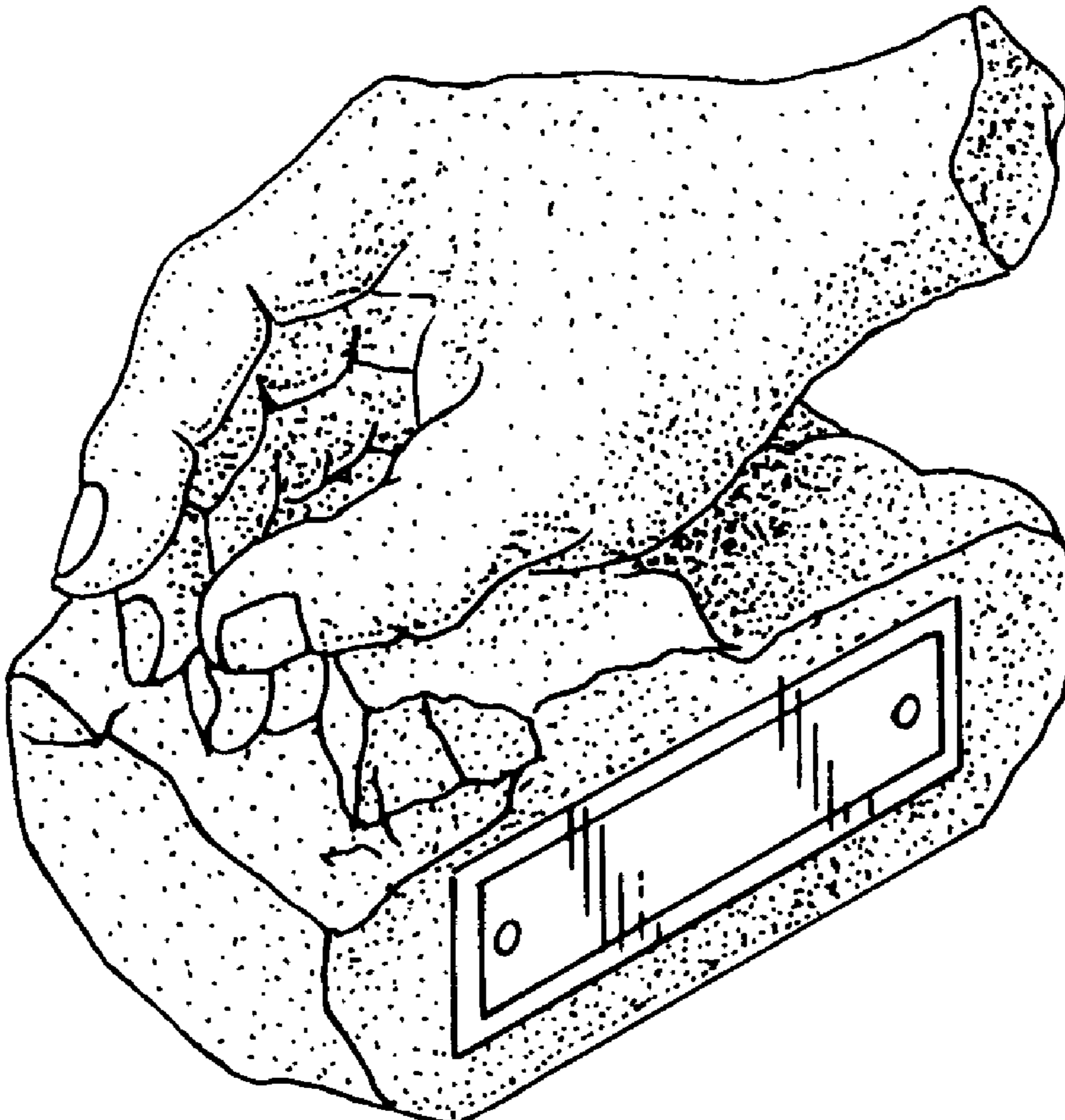

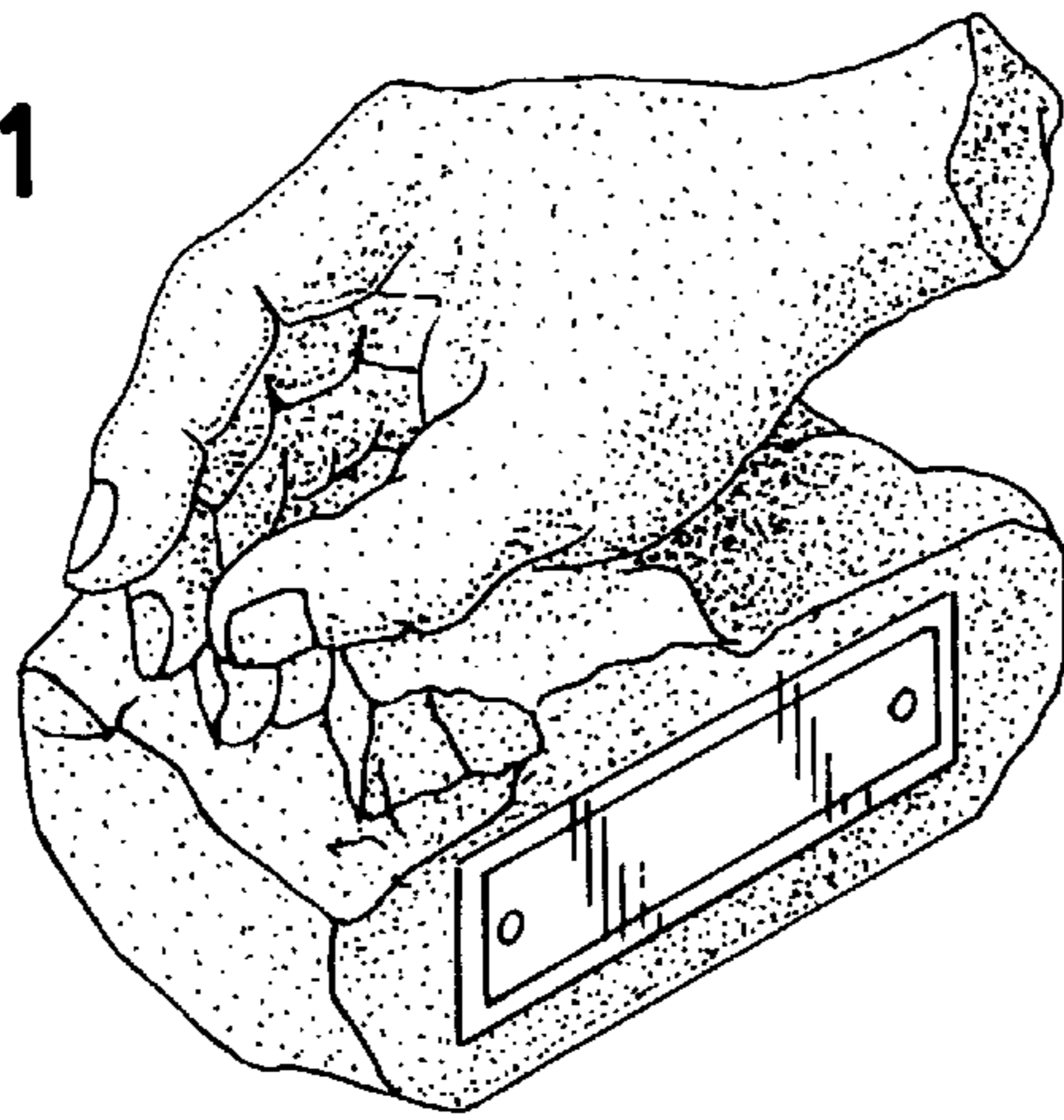

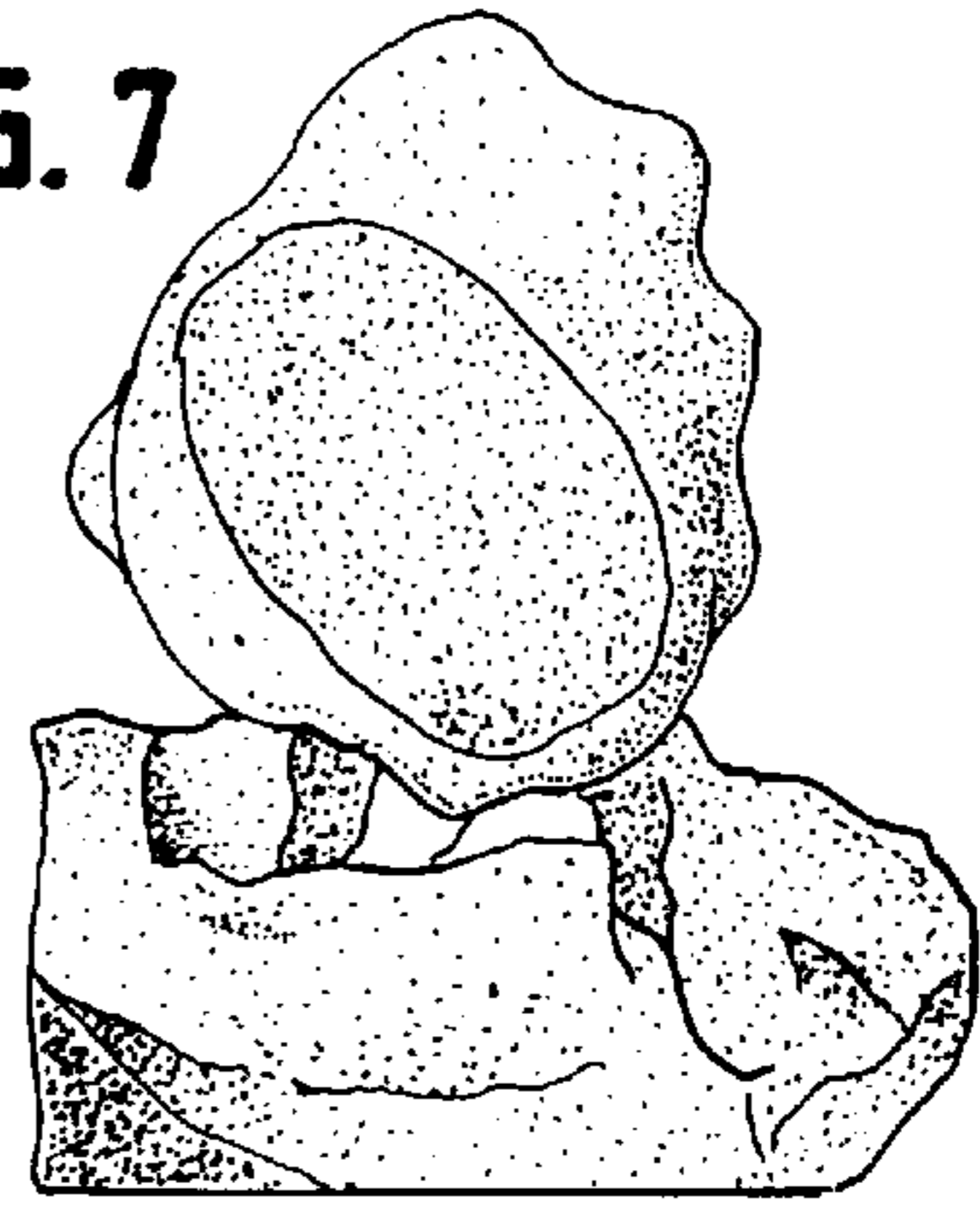

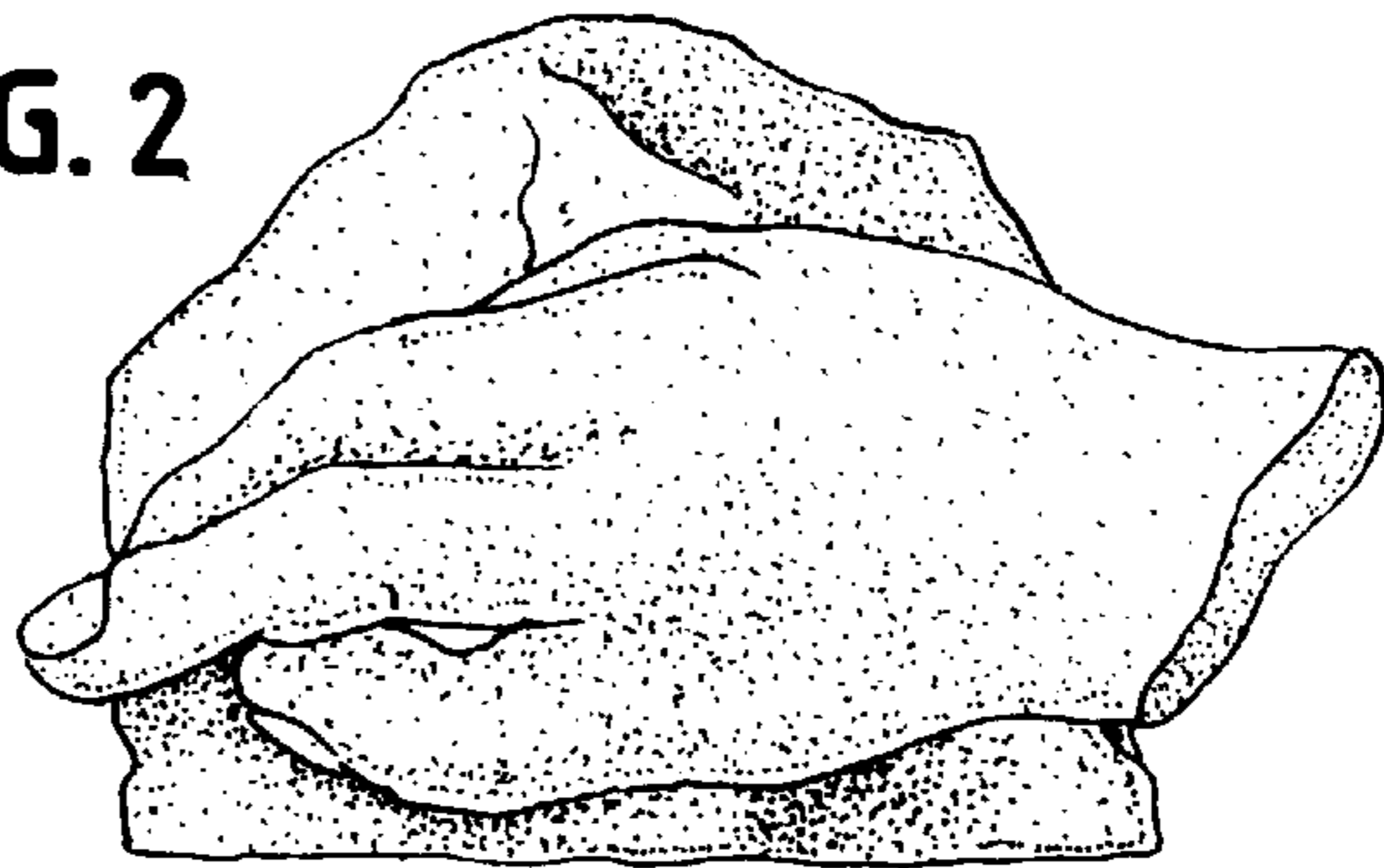

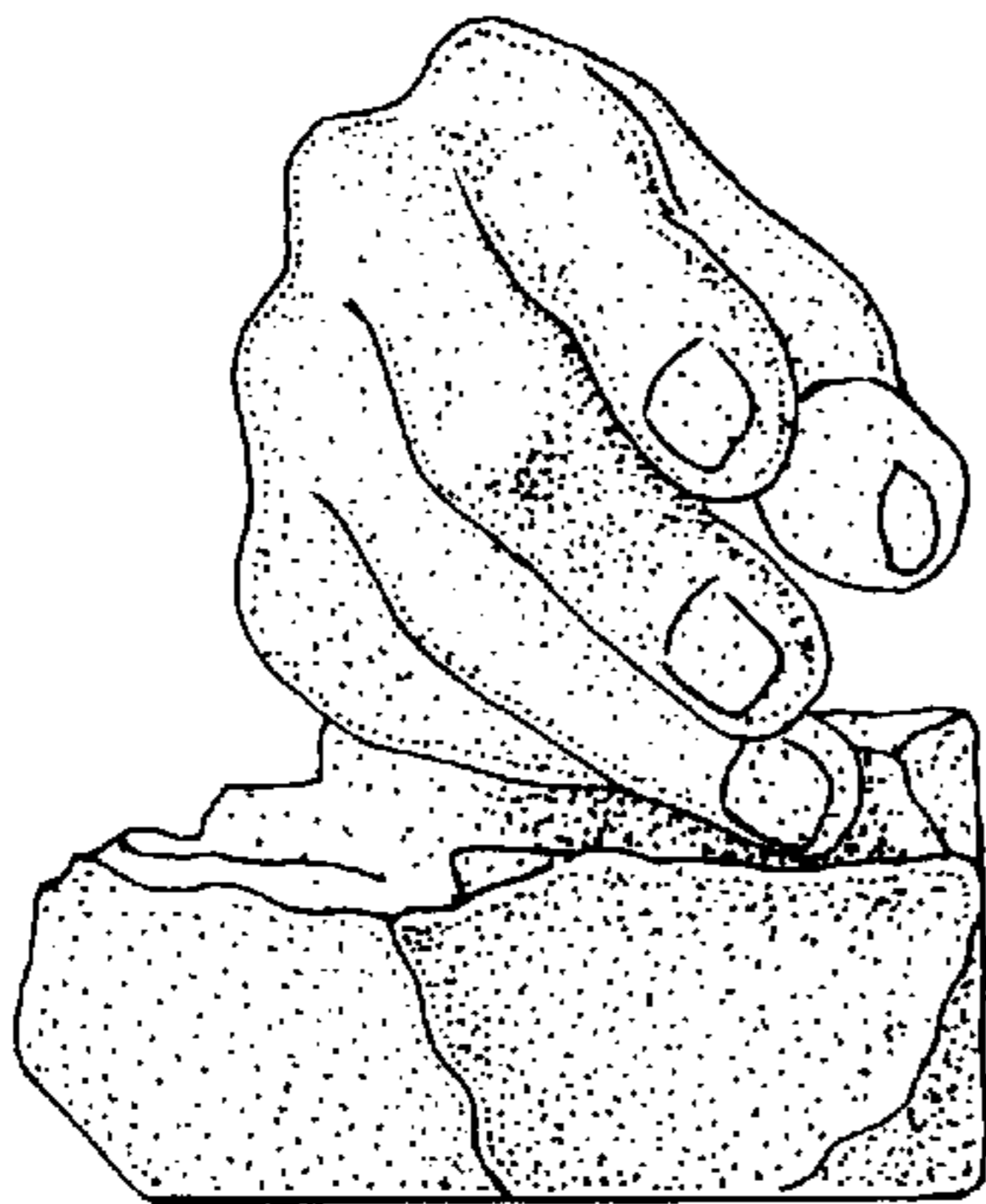

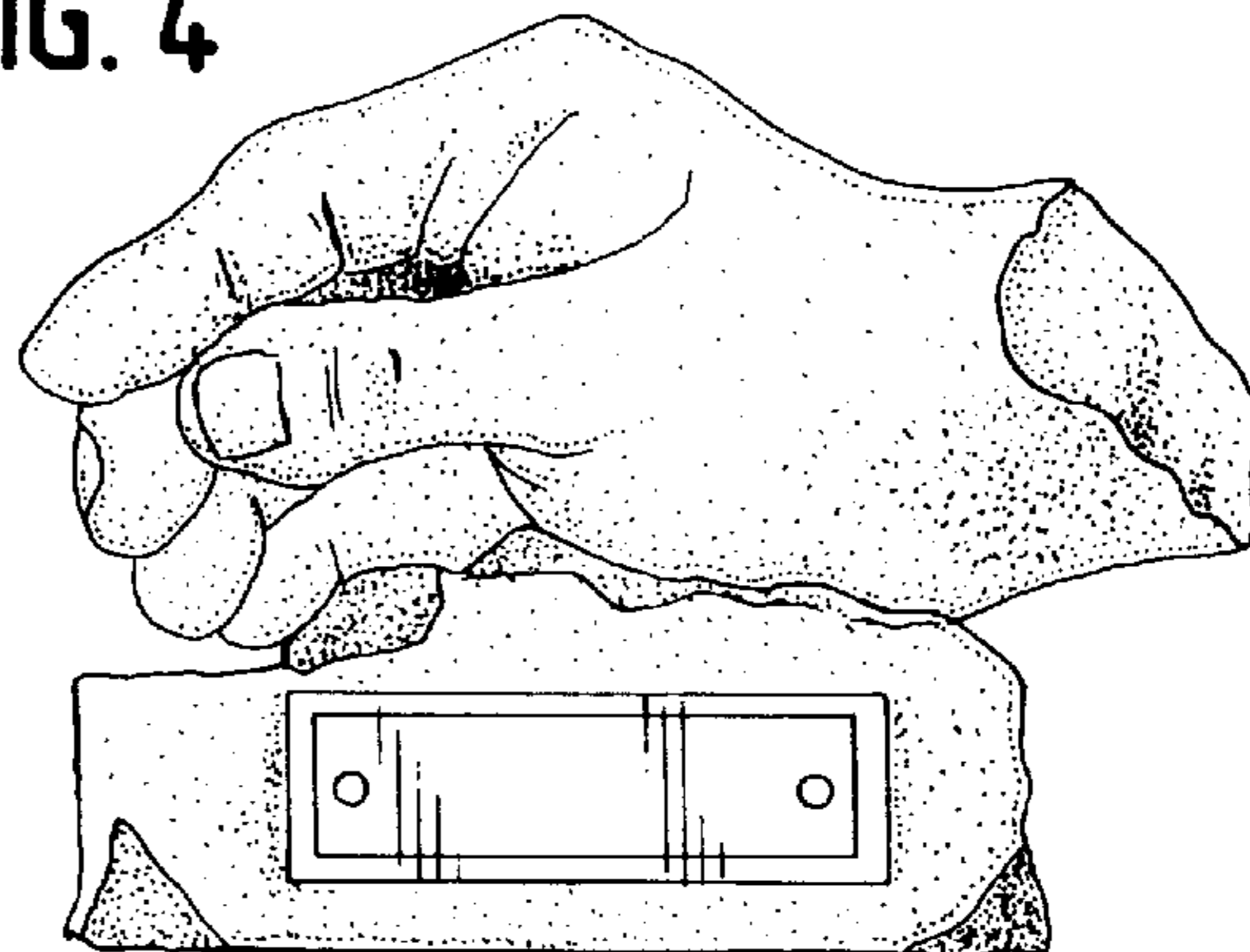

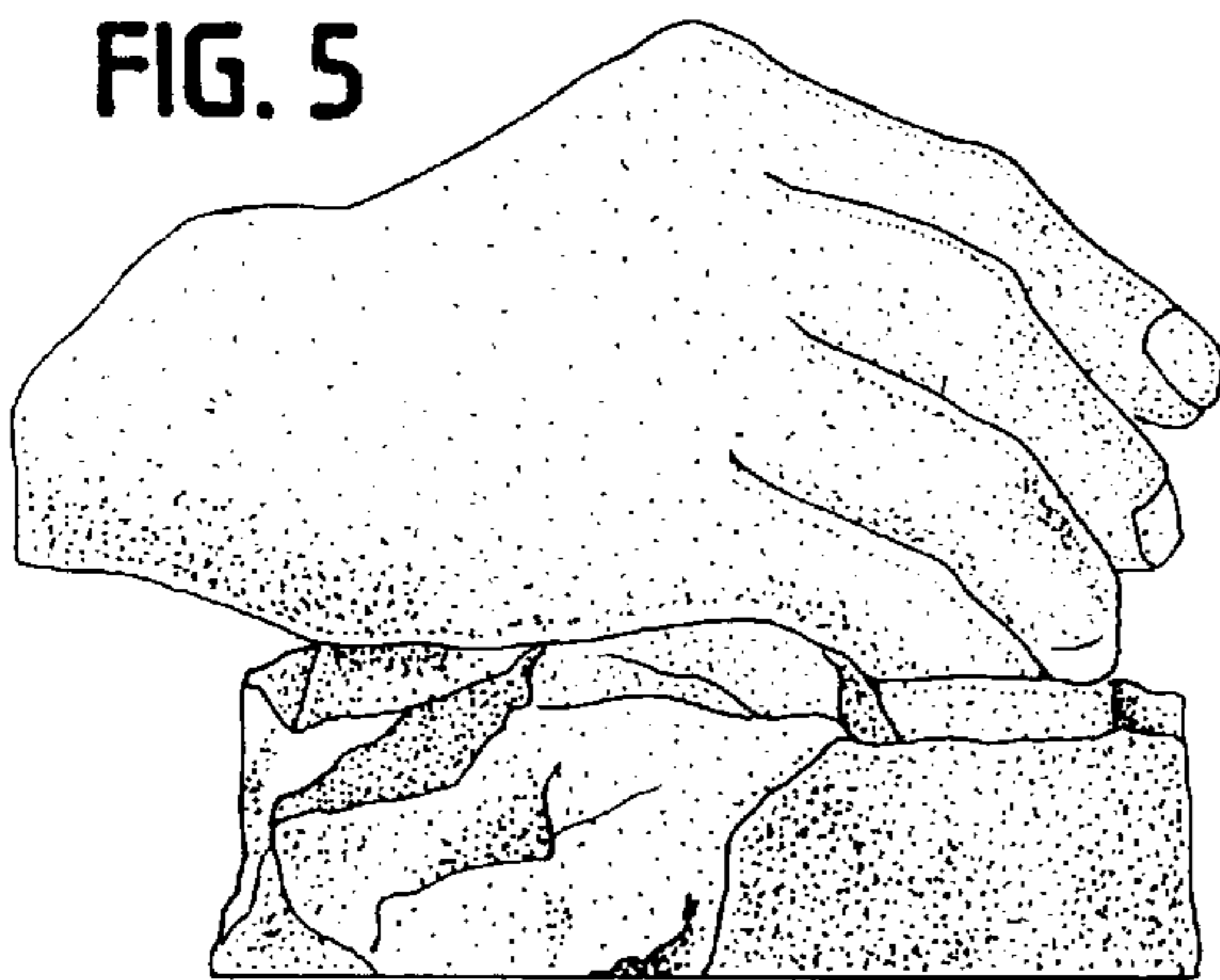
