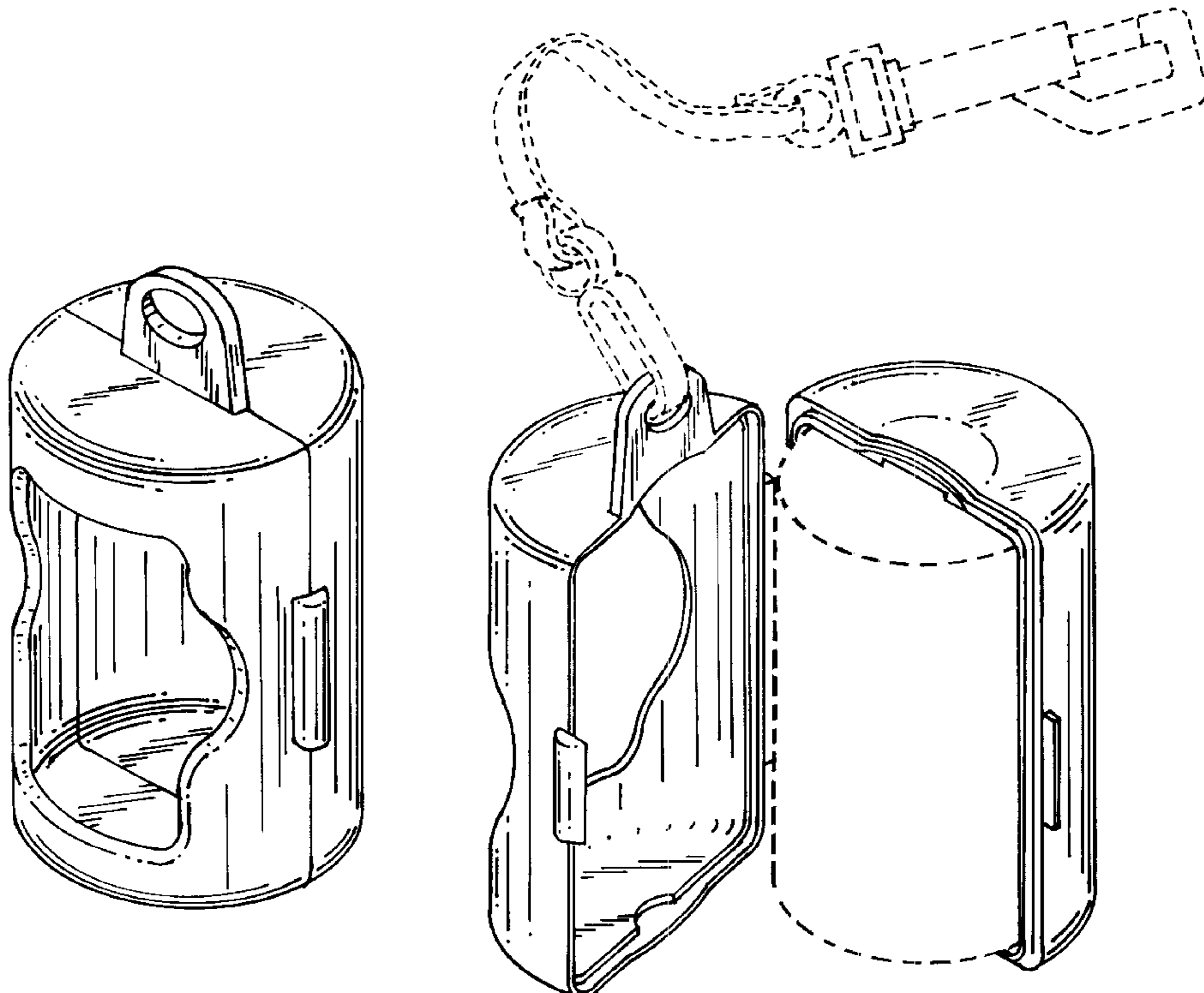
(57) **CLAIM**

The ornamental design for a pet refuse bag dispenser, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the pet refuse bag dispenser of the present invention;
 FIG. 2 is a left side elevational view thereof;
 FIG. 3 is a right side elevational view thereof;
 FIG. 4 is a front view thereof;
 FIG. 5 is a rear view thereof;
 FIG. 6 is a top view thereof;
 FIG. 7 is a bottom view thereof; and,
 FIG. 8 is a perspective view thereof showing the pet refuse bag dispenser in an open position with a roll of bags and a tether in broken lines which are for environmental purposes only and form no part of the claimed design.

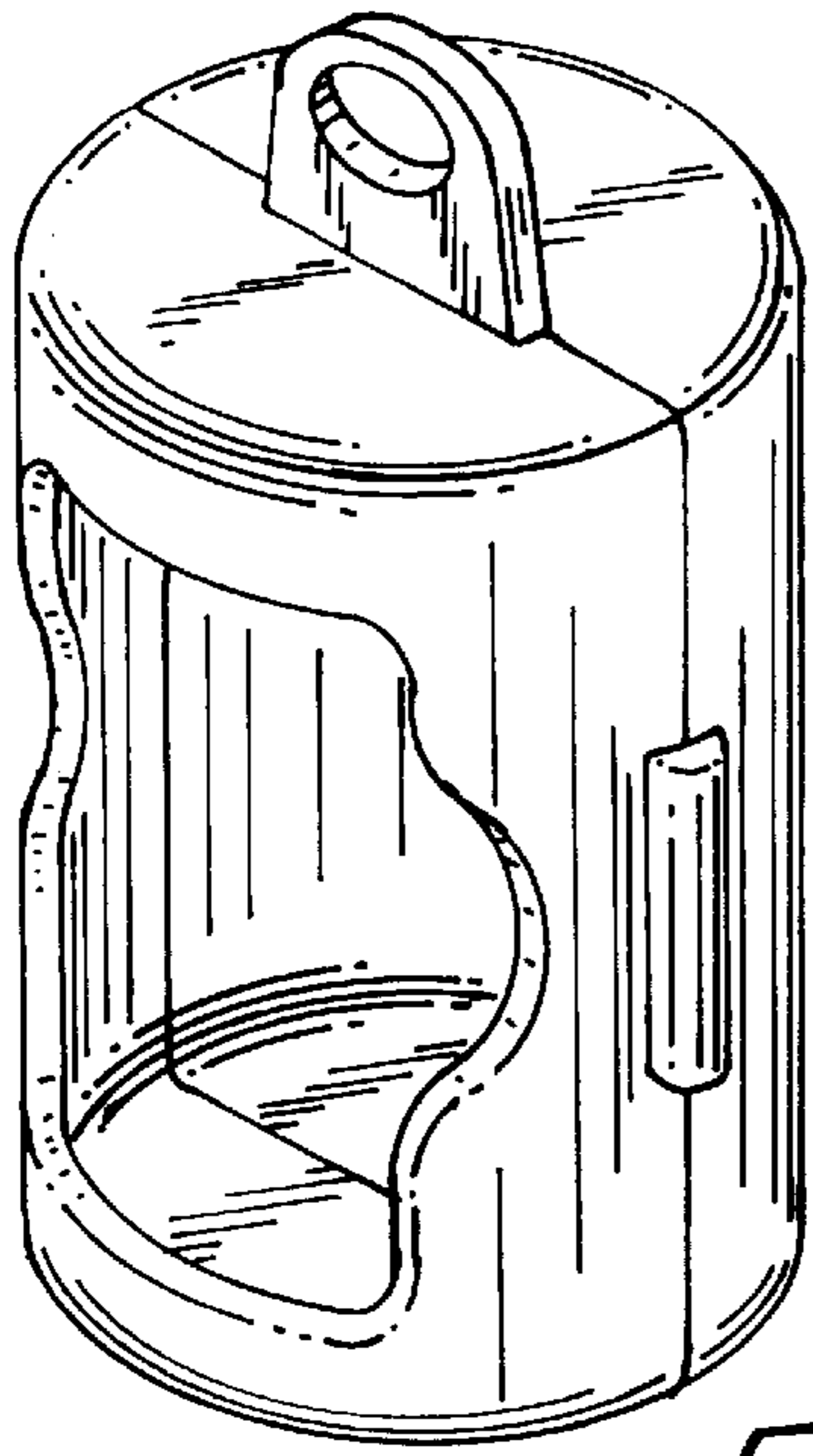

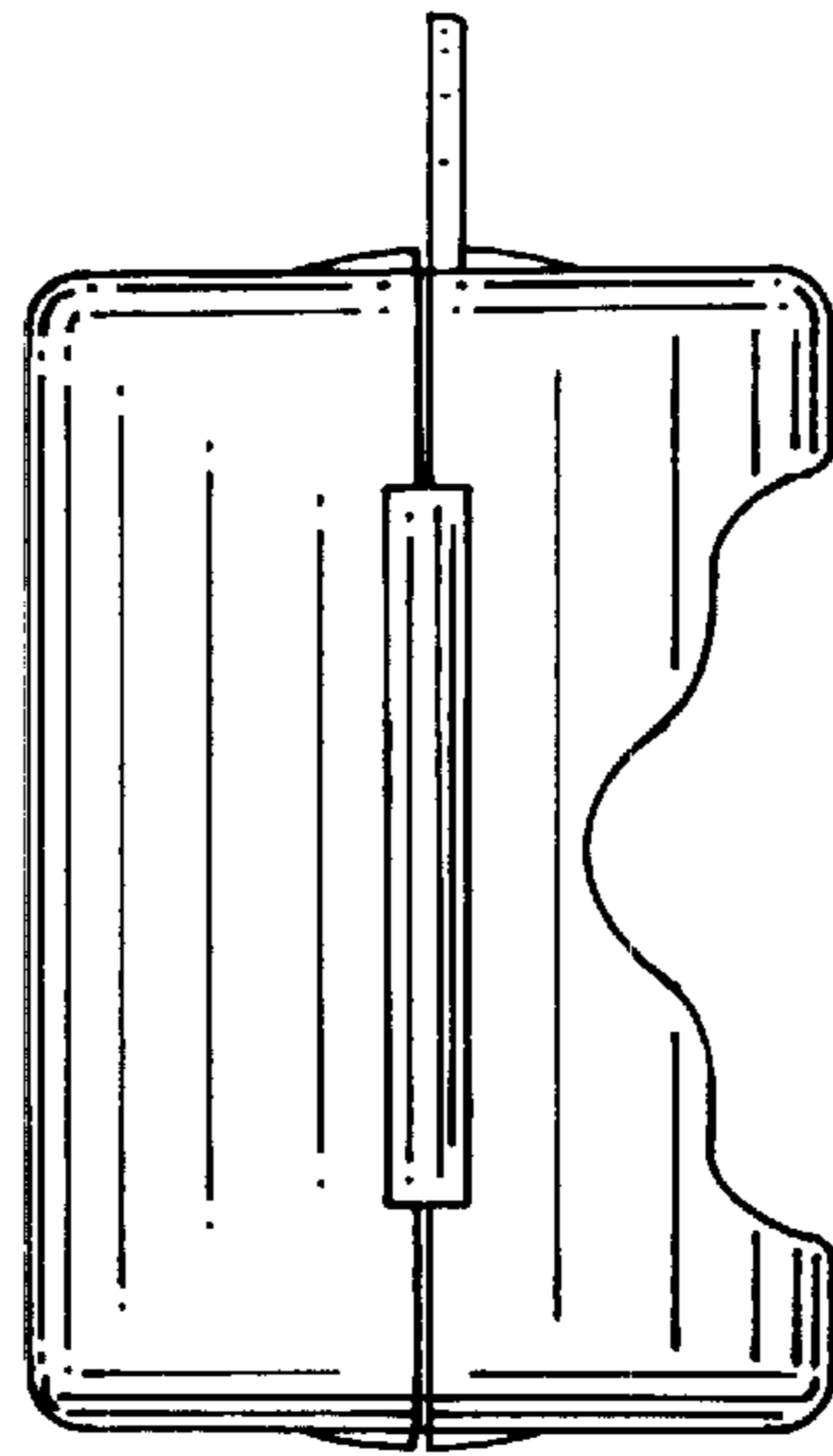

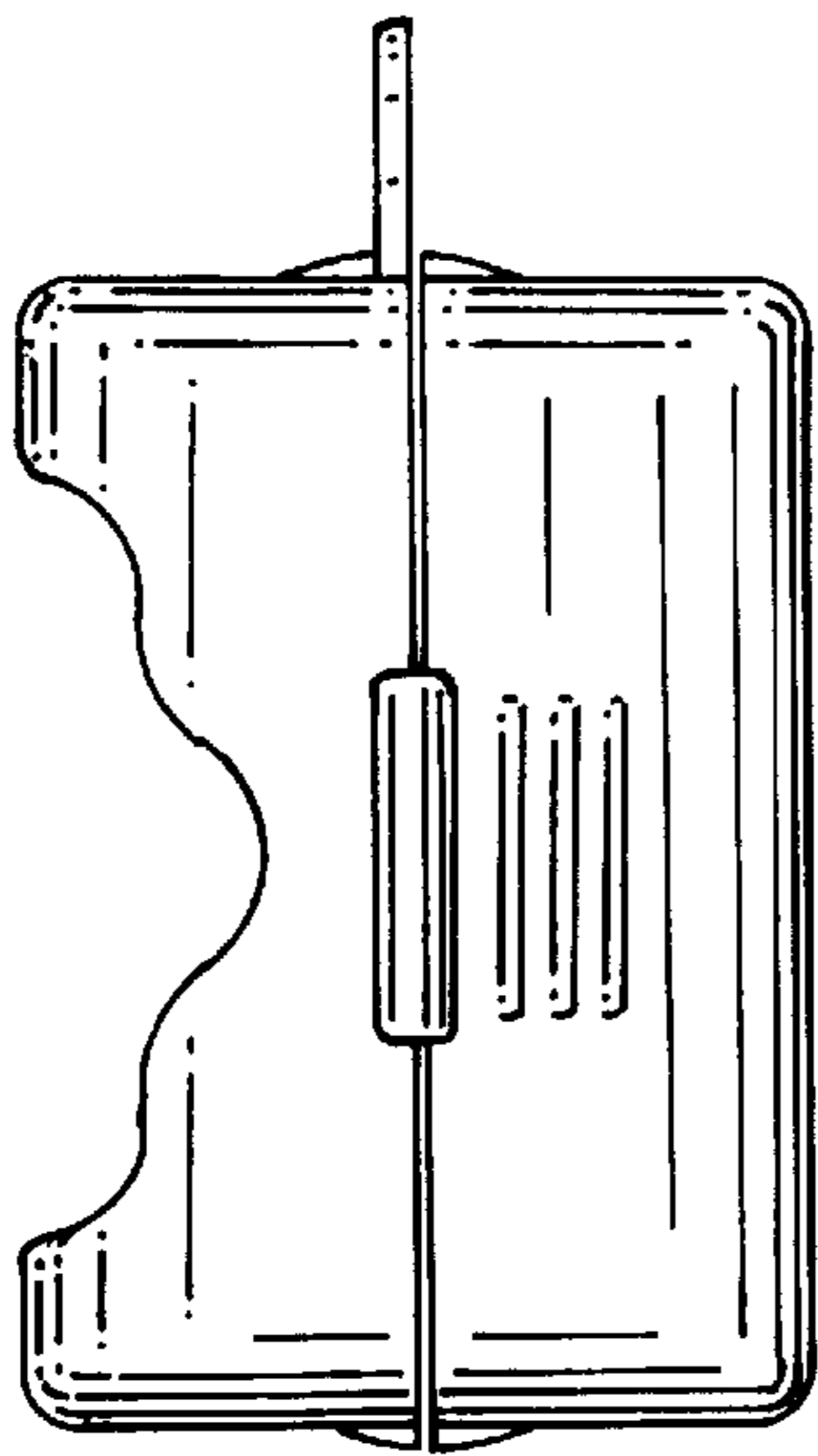

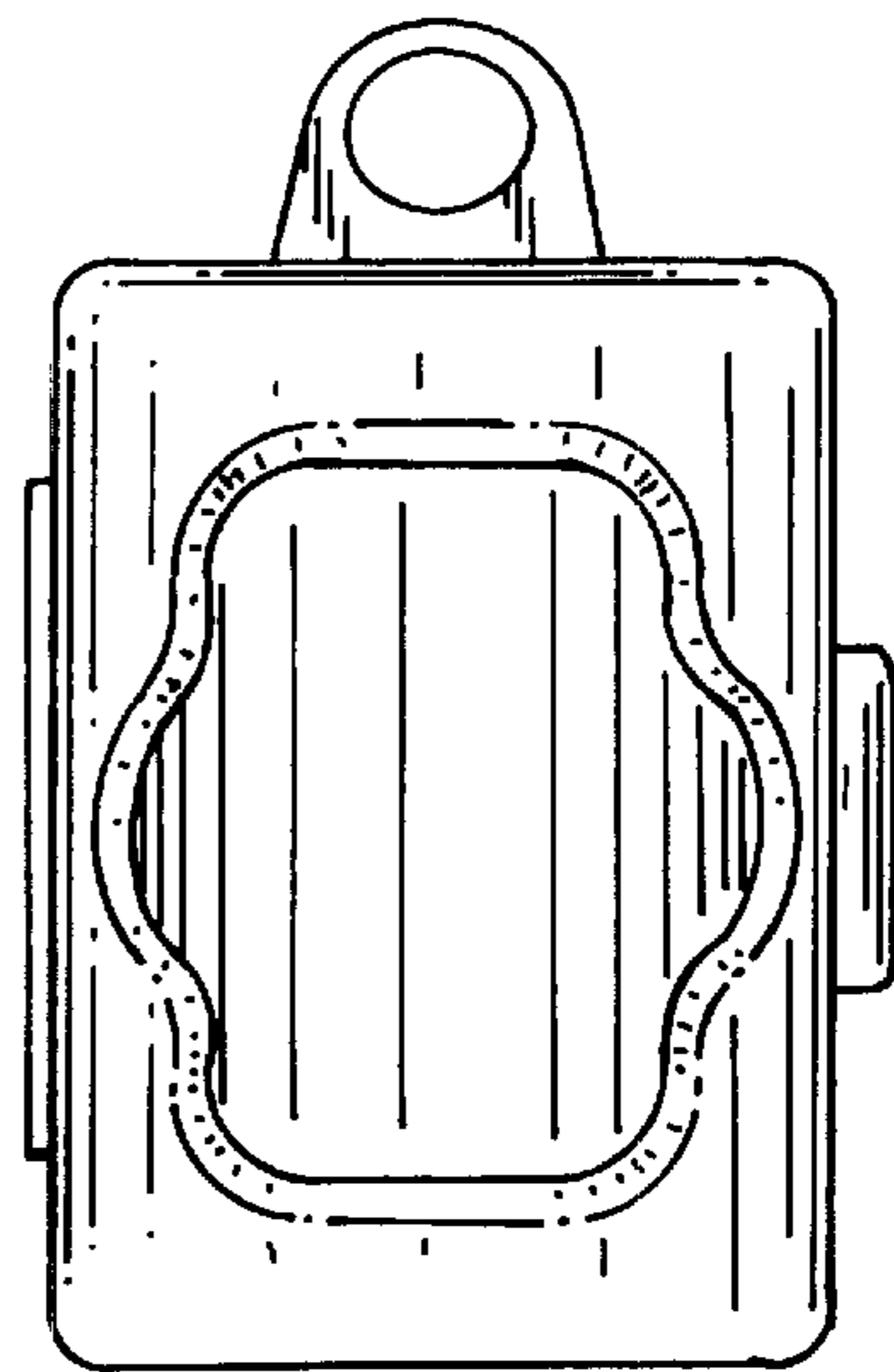

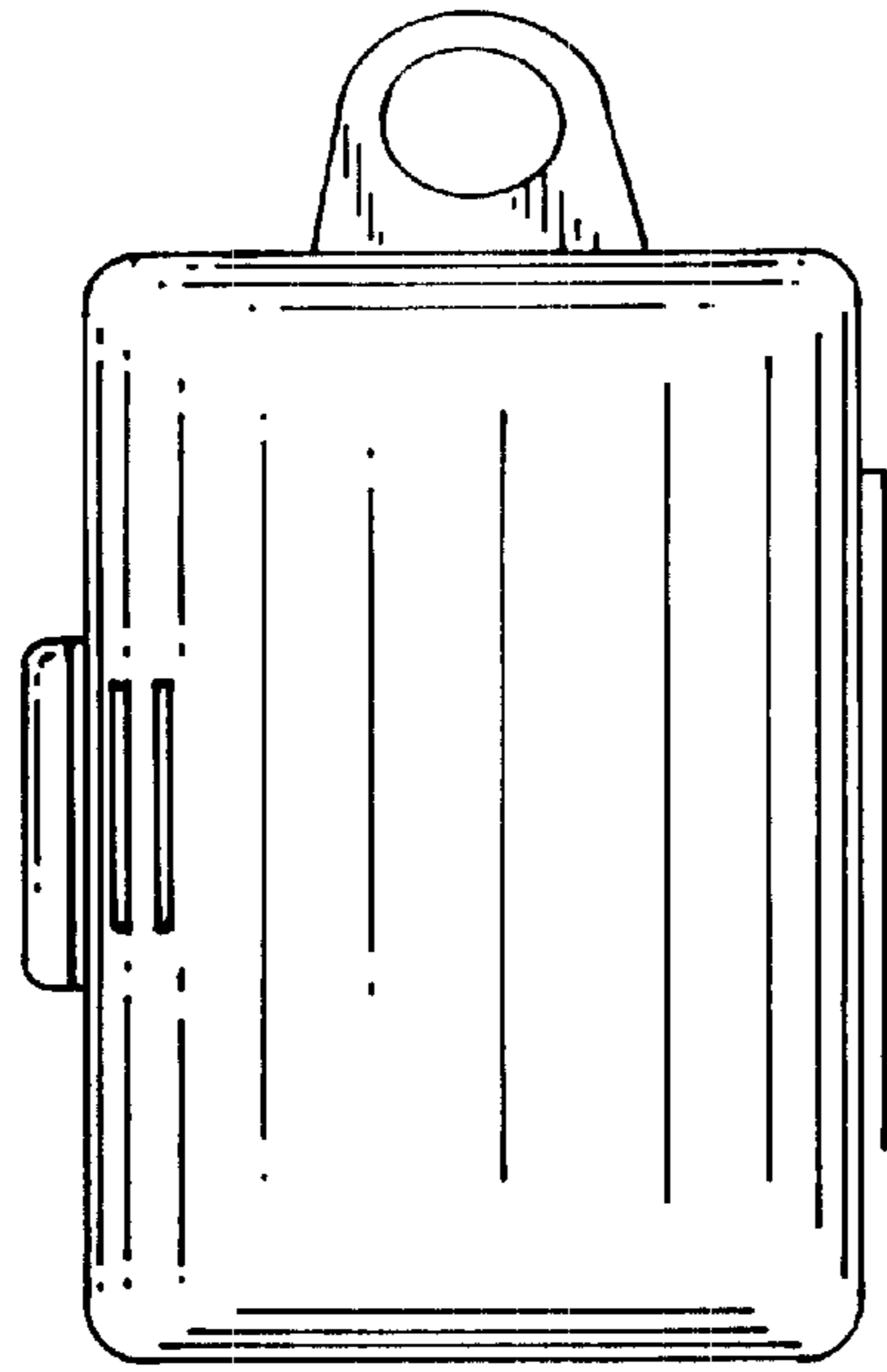

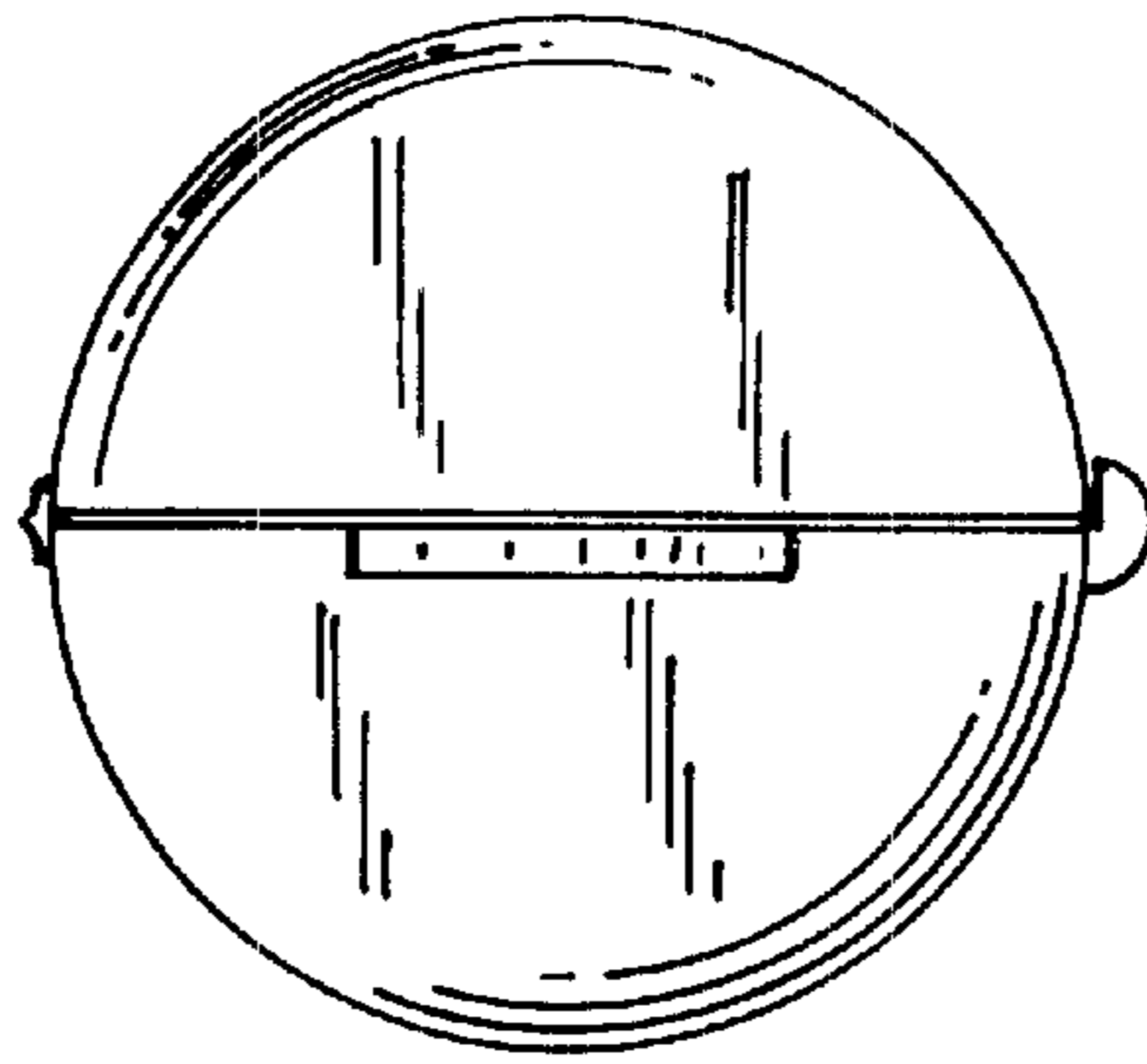

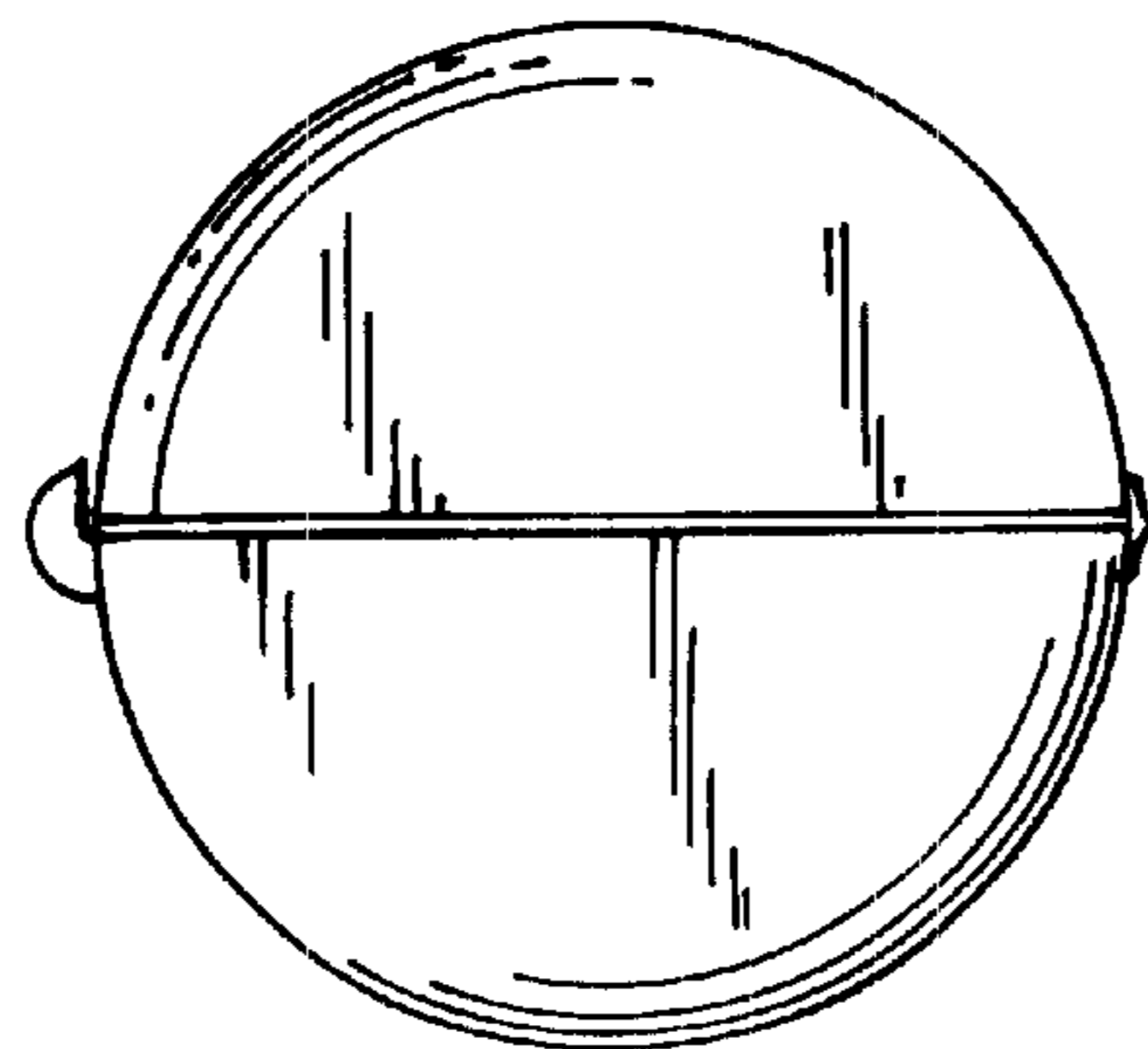

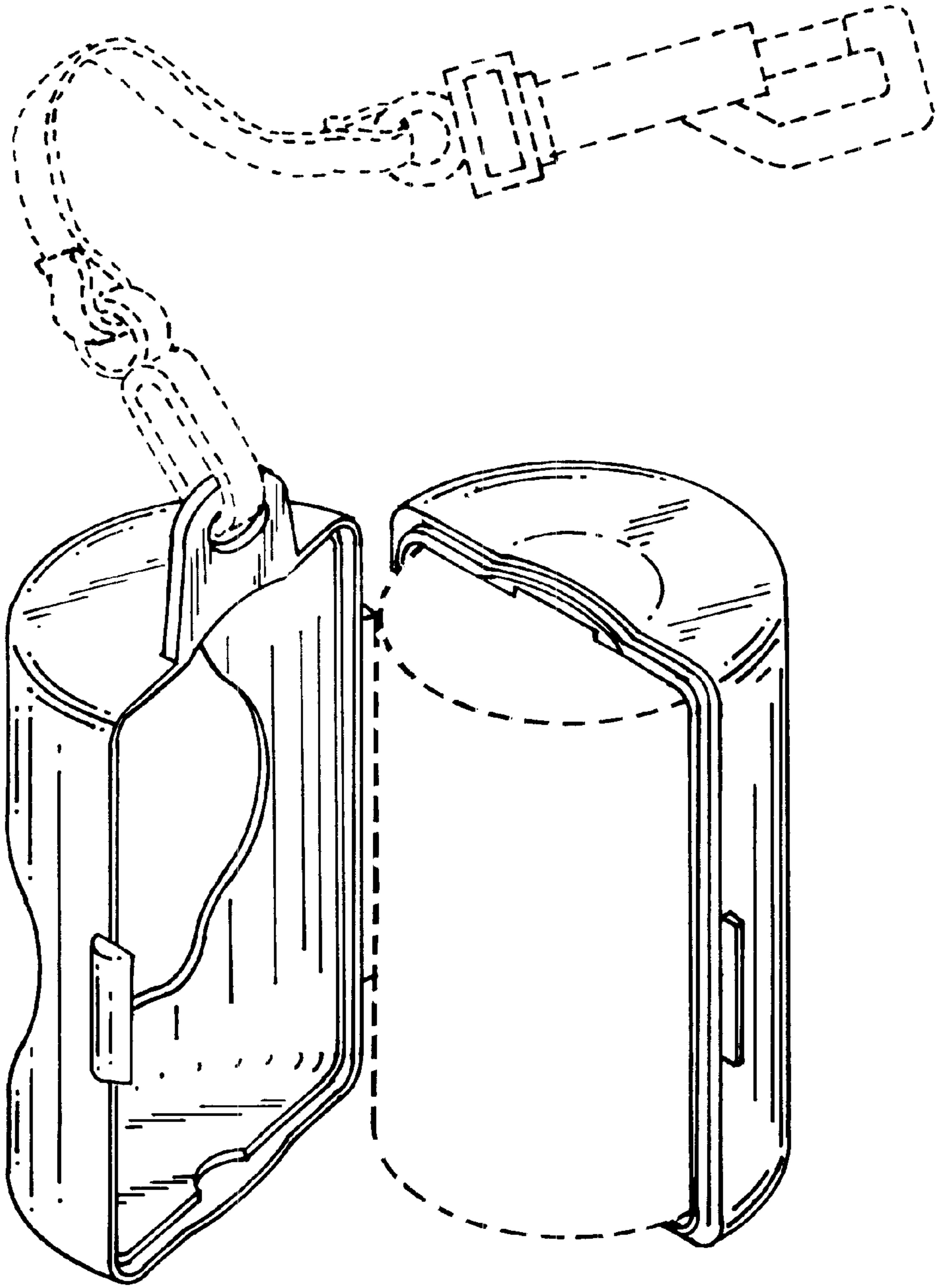
