(57) **CLAIM**

The ornamental design for a housekeeping cart, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the front of a housekeeping cart with the wheels, wire holders on the left side, bottom

shelf, and embossed surface features being shown in phantom (broken lines);

FIG. 2 is a perspective view of the back of the housekeeping cart shown in FIG. 1;

FIG. 3 is a front view of the housekeeping cart shown in FIG. 1;

FIG. 4 is a rear view of the housekeeping cart shown in FIG. 1;

FIG. 5 is a side view of the right side of the housekeeping cart shown in FIG. 1;

FIG. 6 is a side view of the left side of the housekeeping cart shown in FIG. 1;

FIG. 7 is a top view of the housekeeping cart shown in FIG. 1;

FIG. 8 is a perspective view of a second embodiment of the housekeeping cart with the wheels, wire holder on the right side, and embossed surface features being shown in phantom (broken lines);

FIG. 9 is a perspective view of the back of the housekeeping cart shown in FIG. 8;

FIG. 10 is a front view of the housekeeping cart shown in FIG. 8;

FIG. 11 is a rear view of the housekeeping cart shown in FIG. 8;

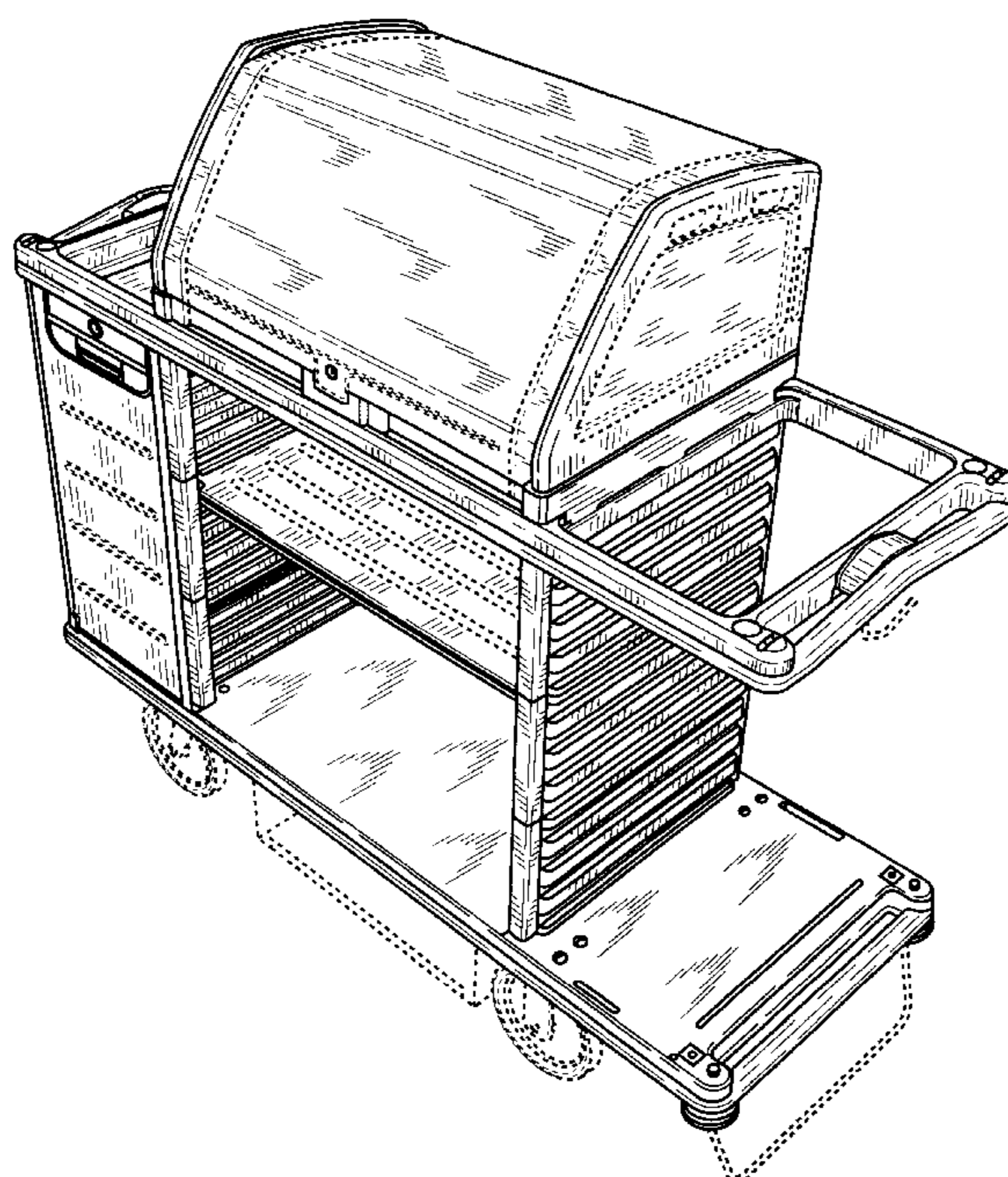
FIG. 12 is a side view of the right side of the housekeeping cart shown in FIG. 8;

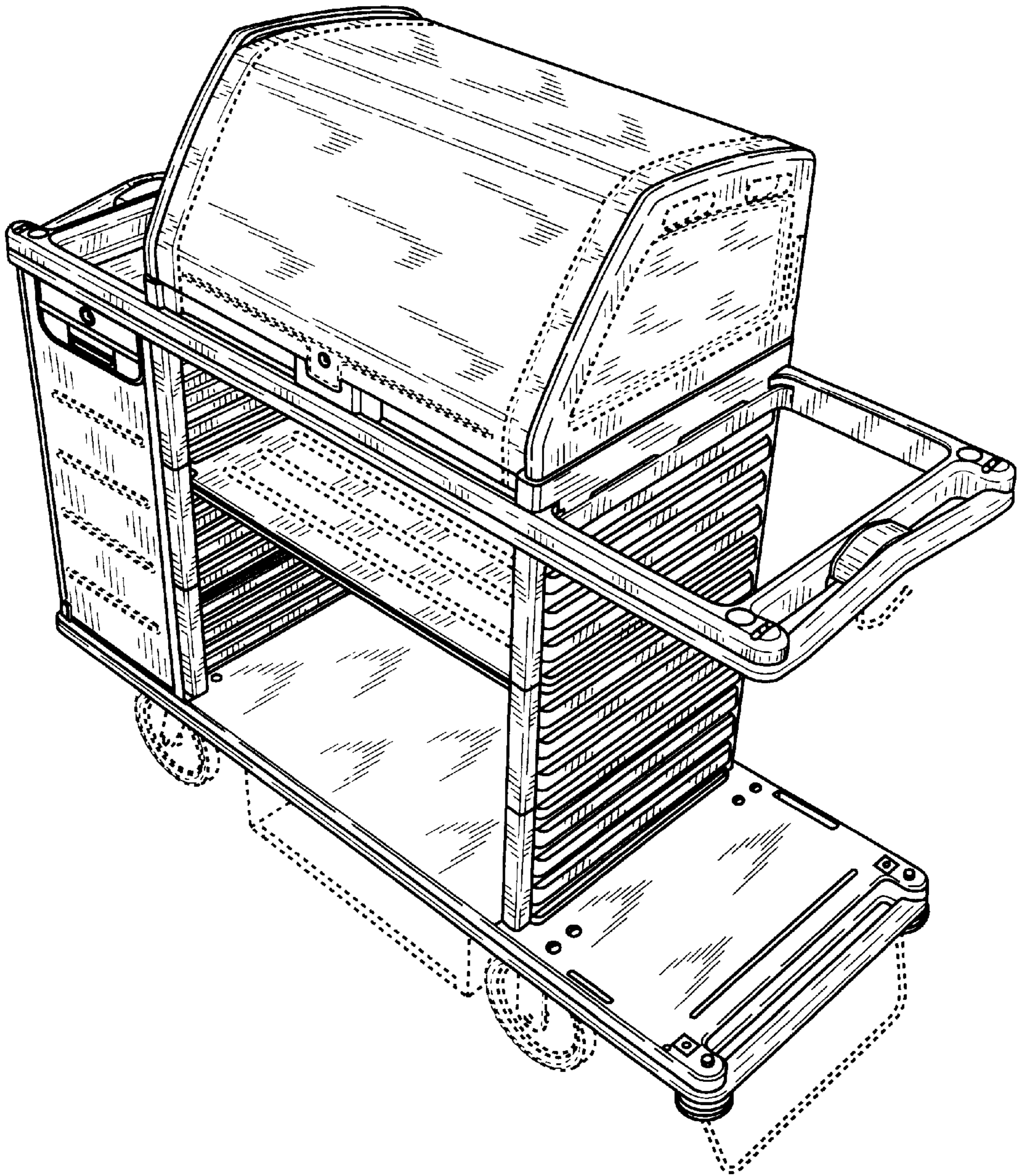

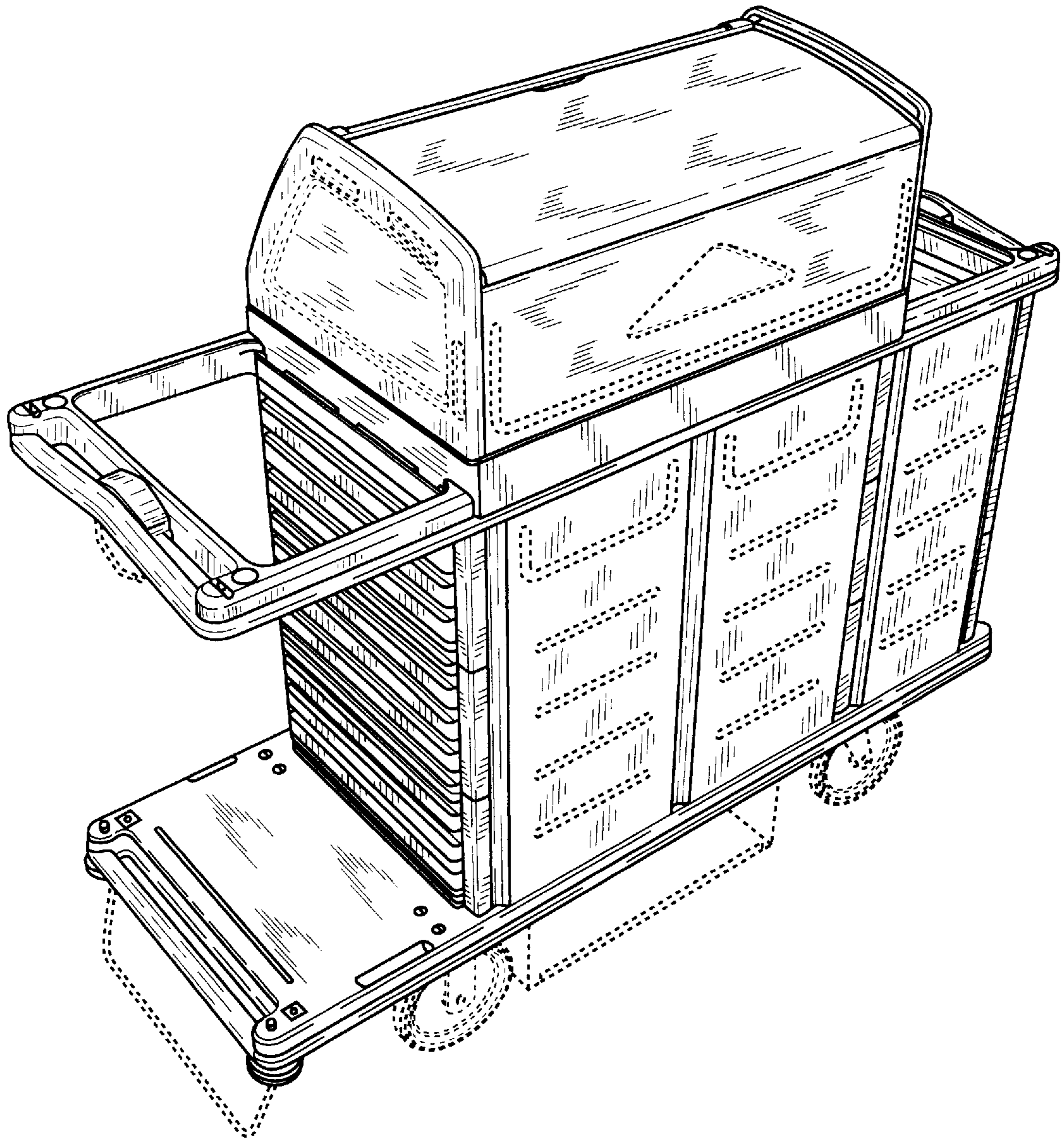

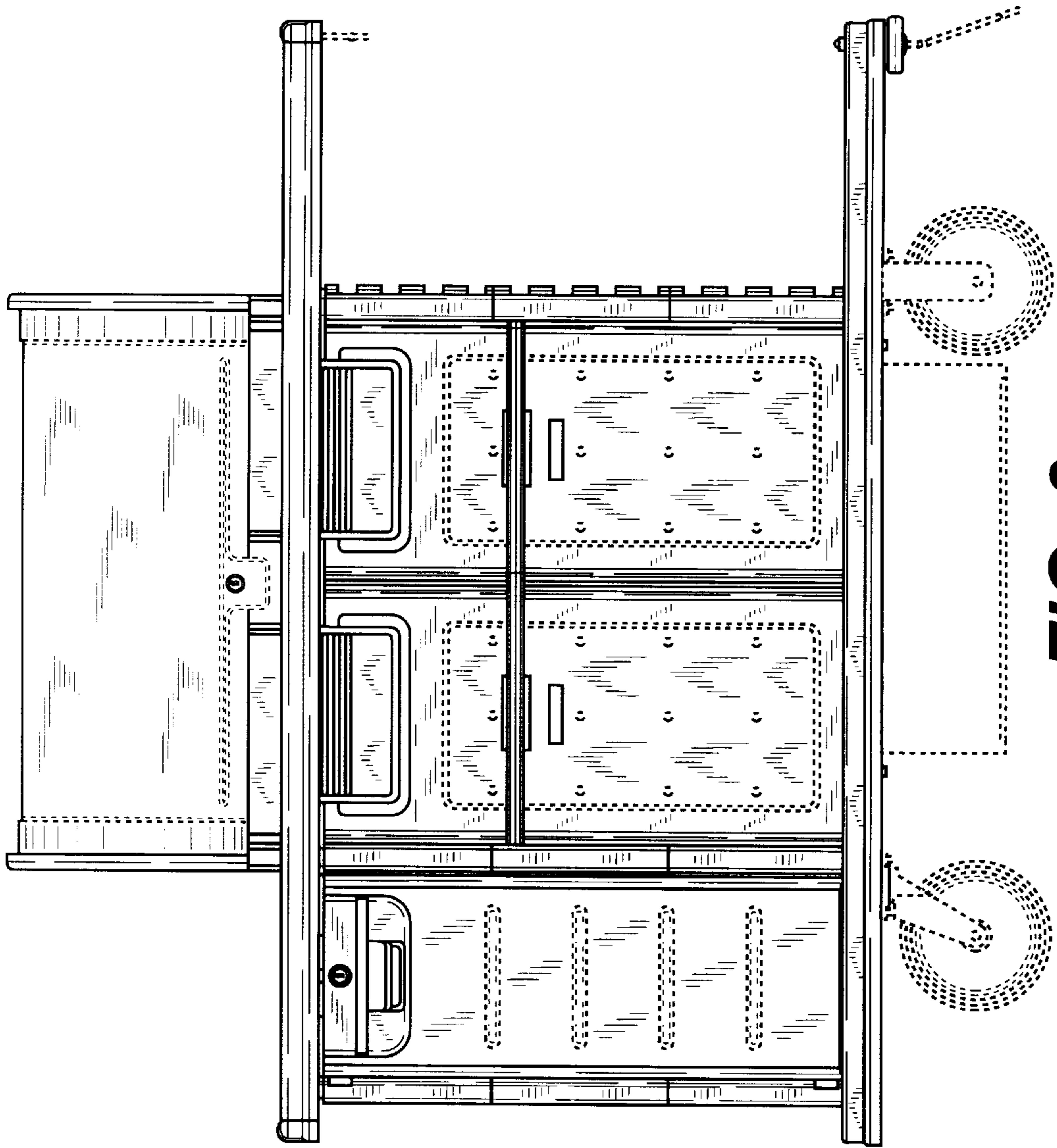

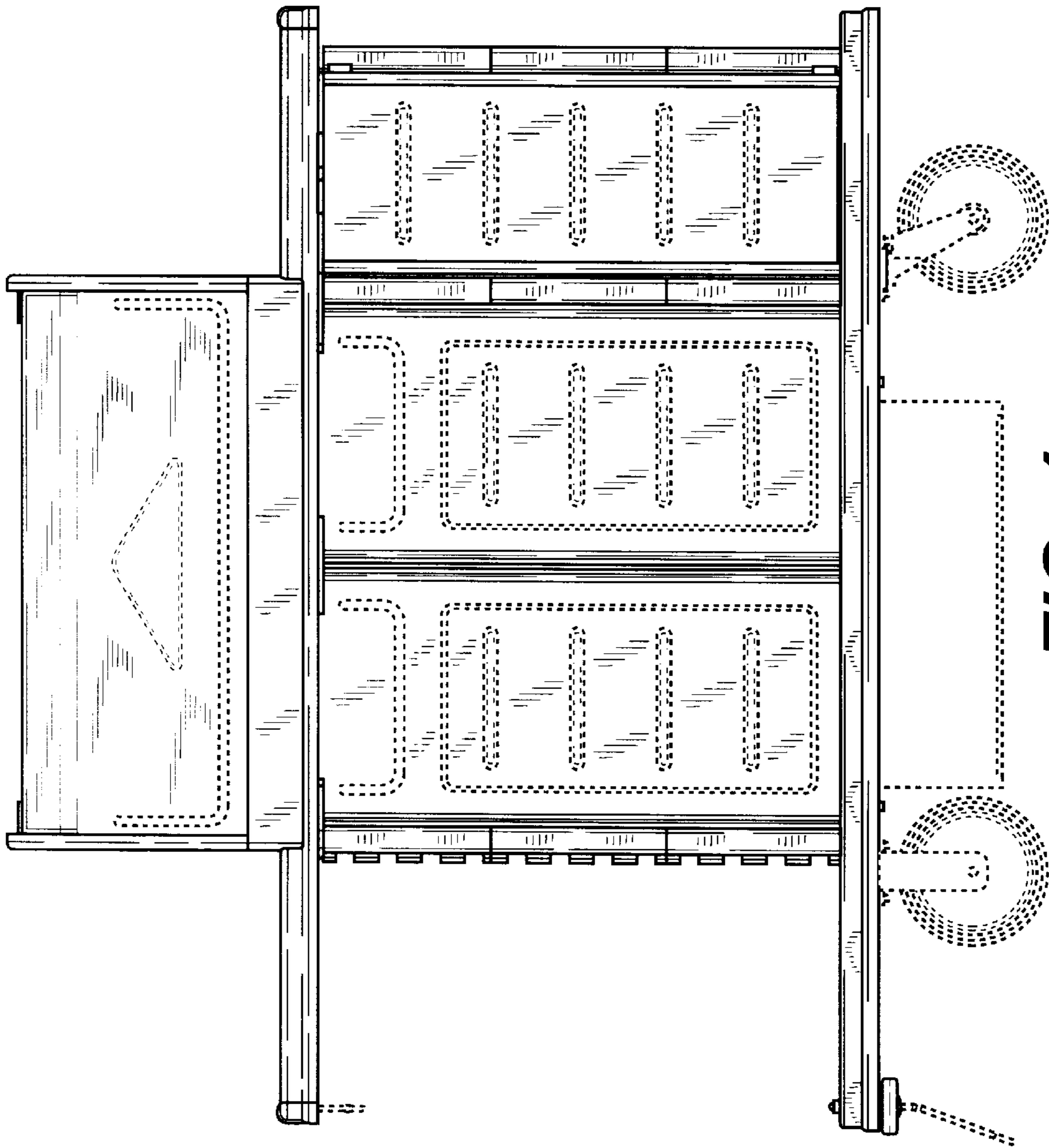

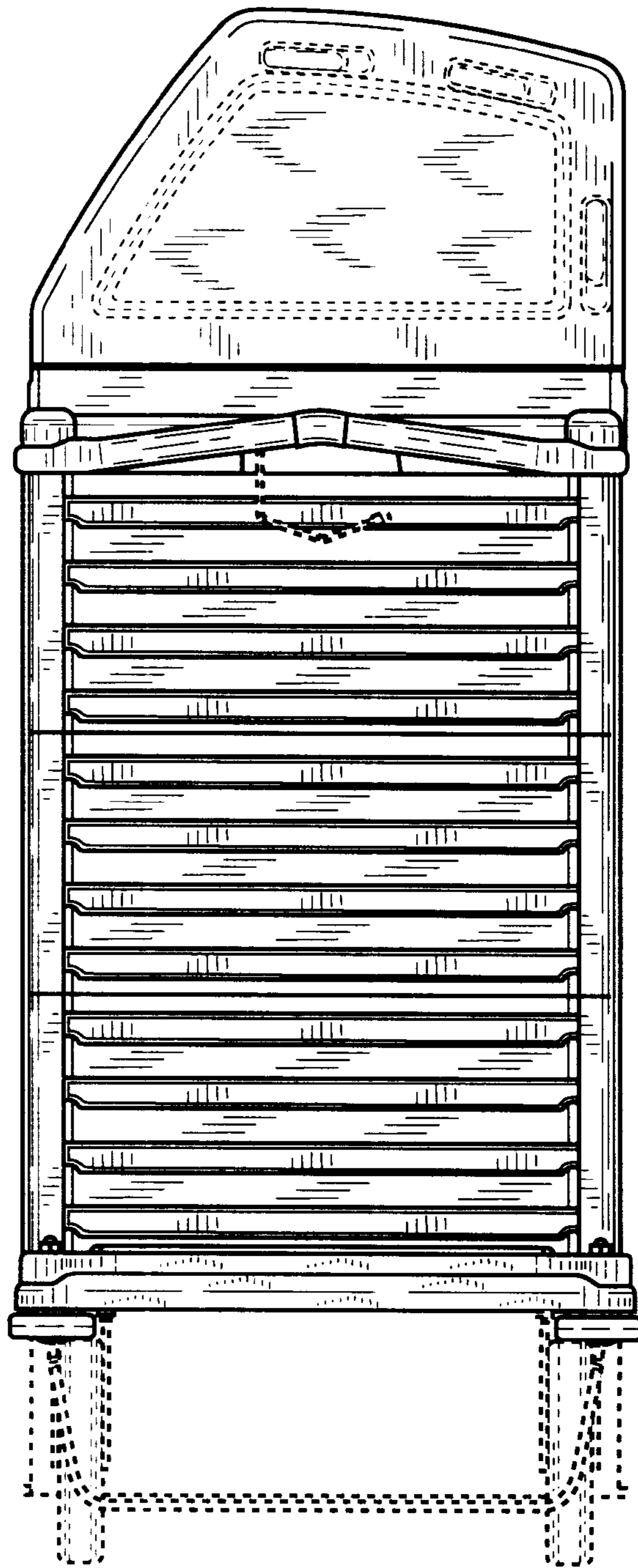

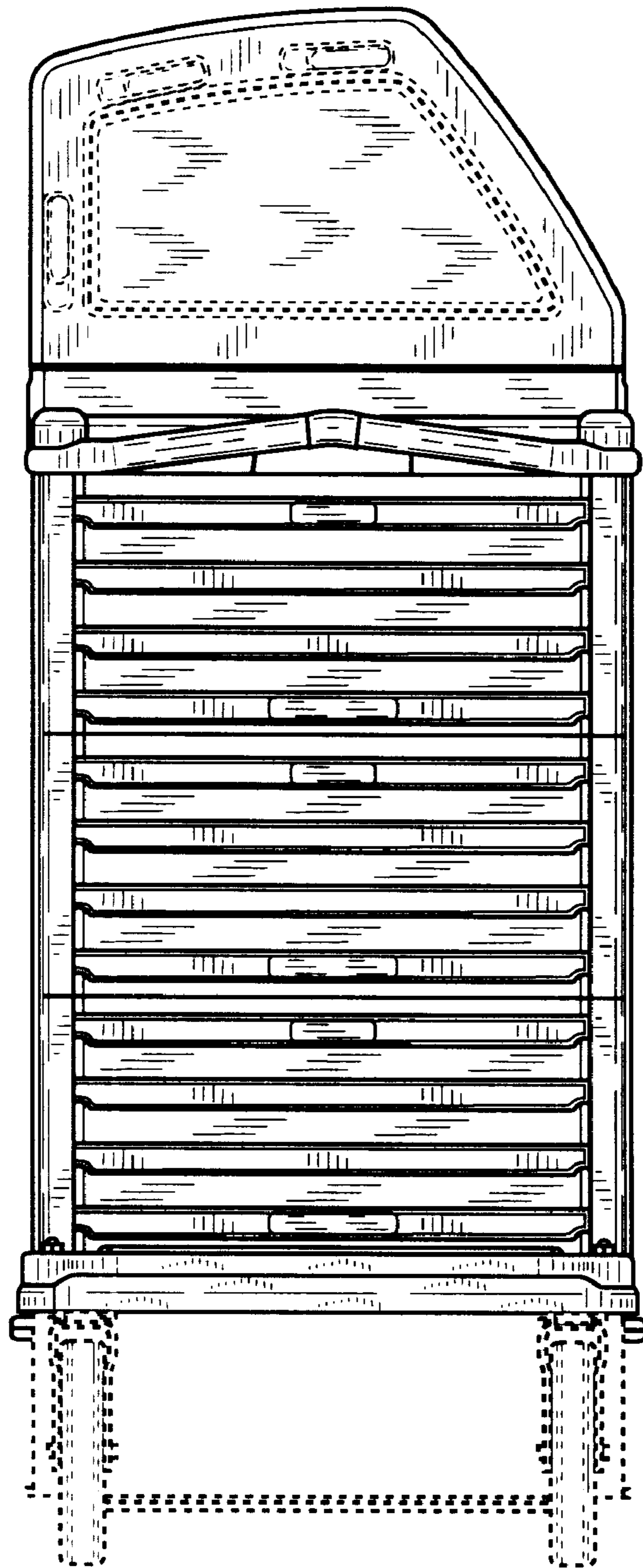

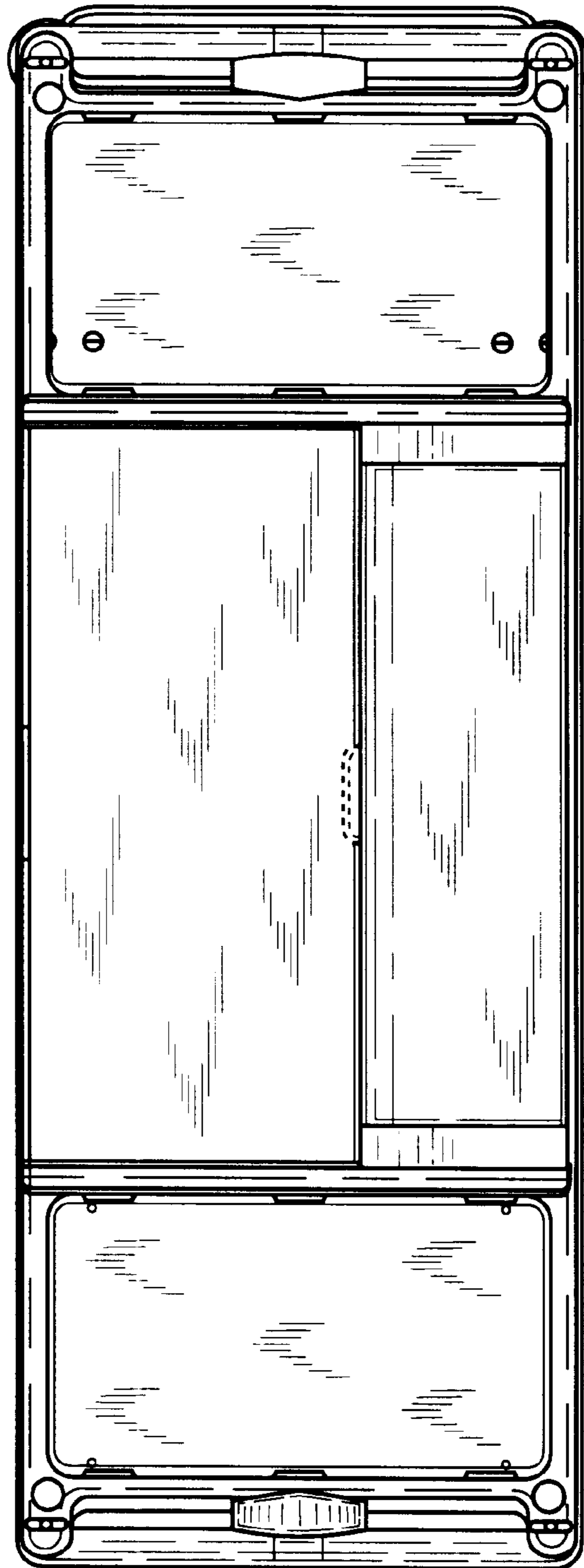

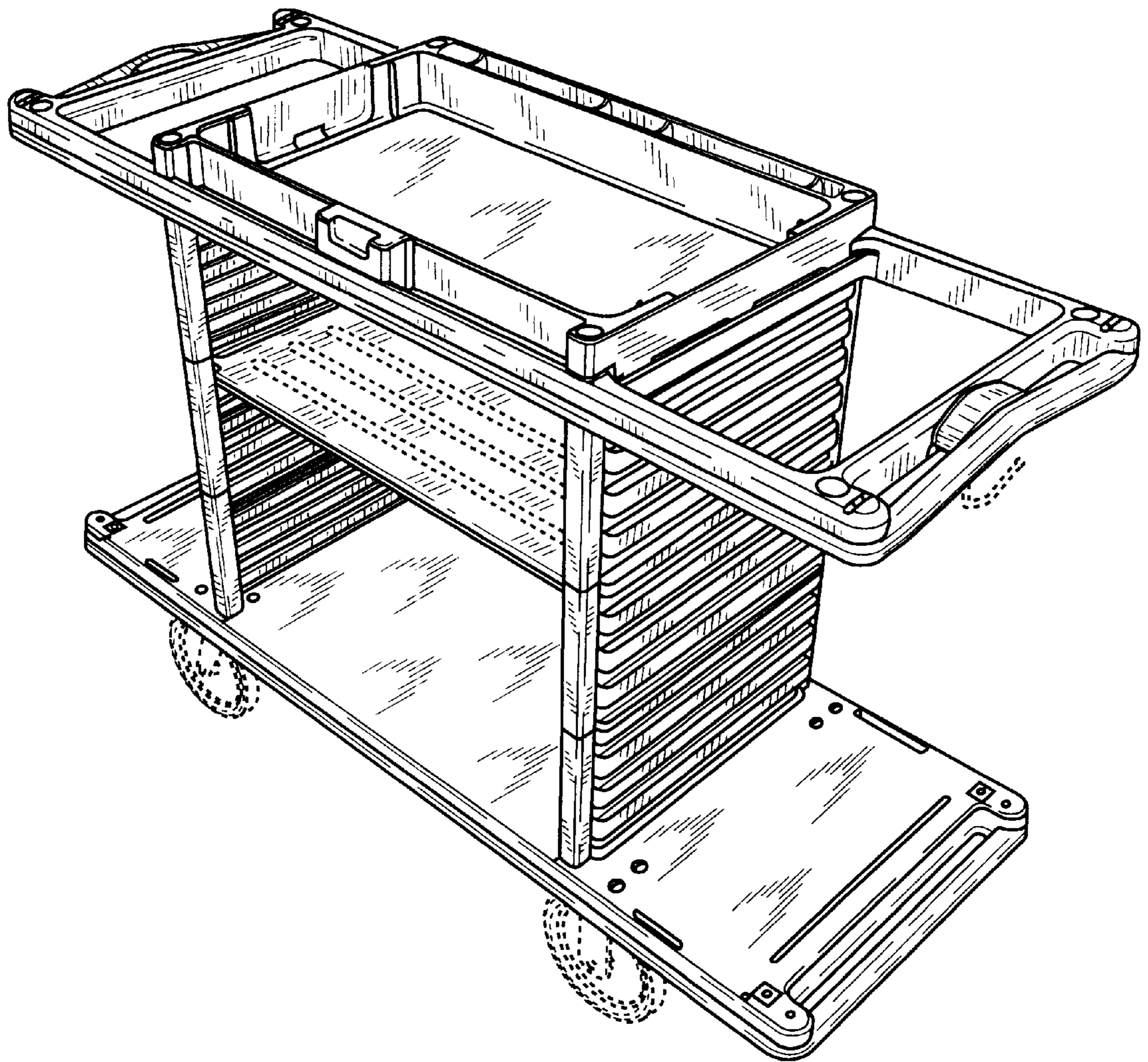

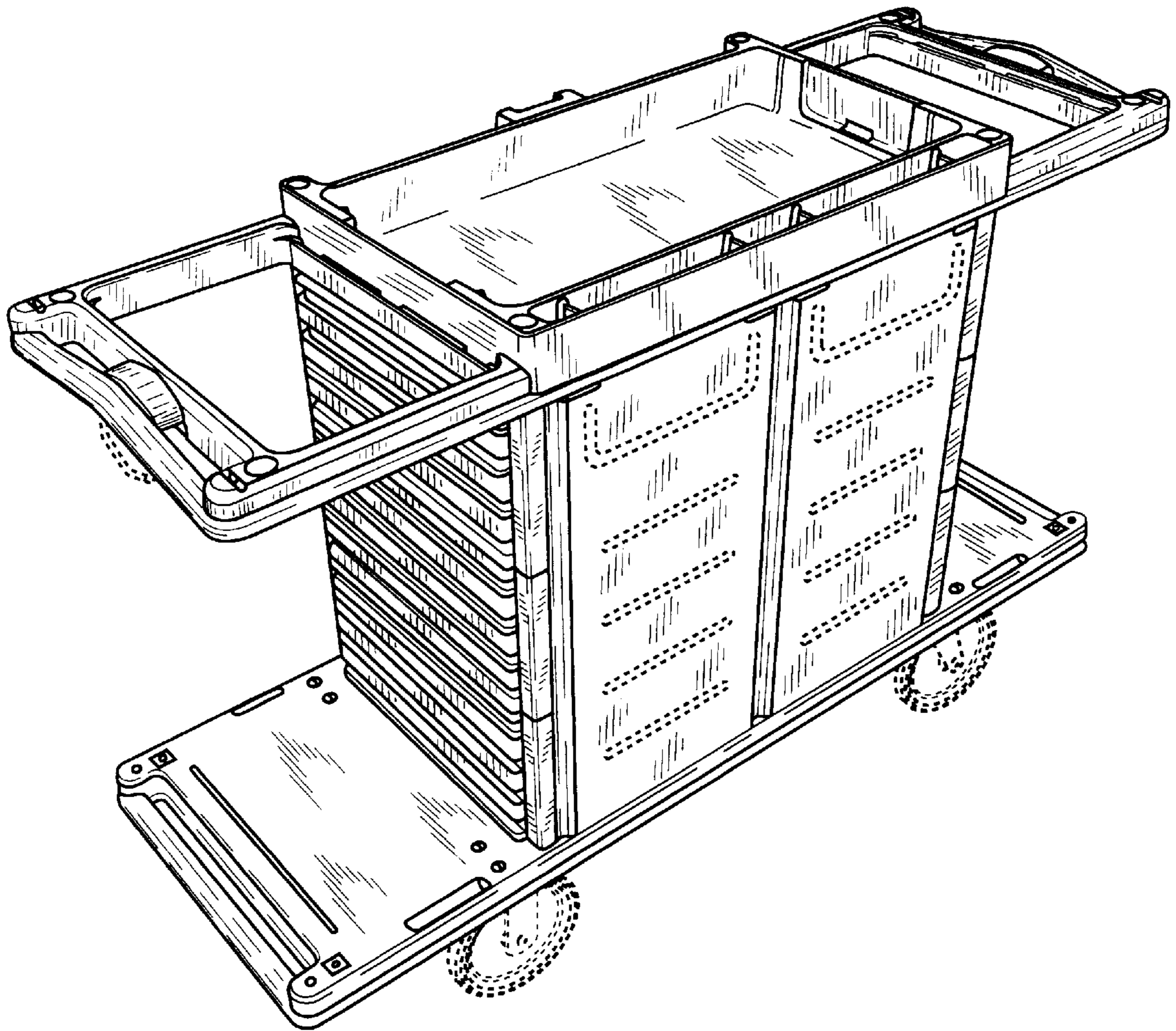

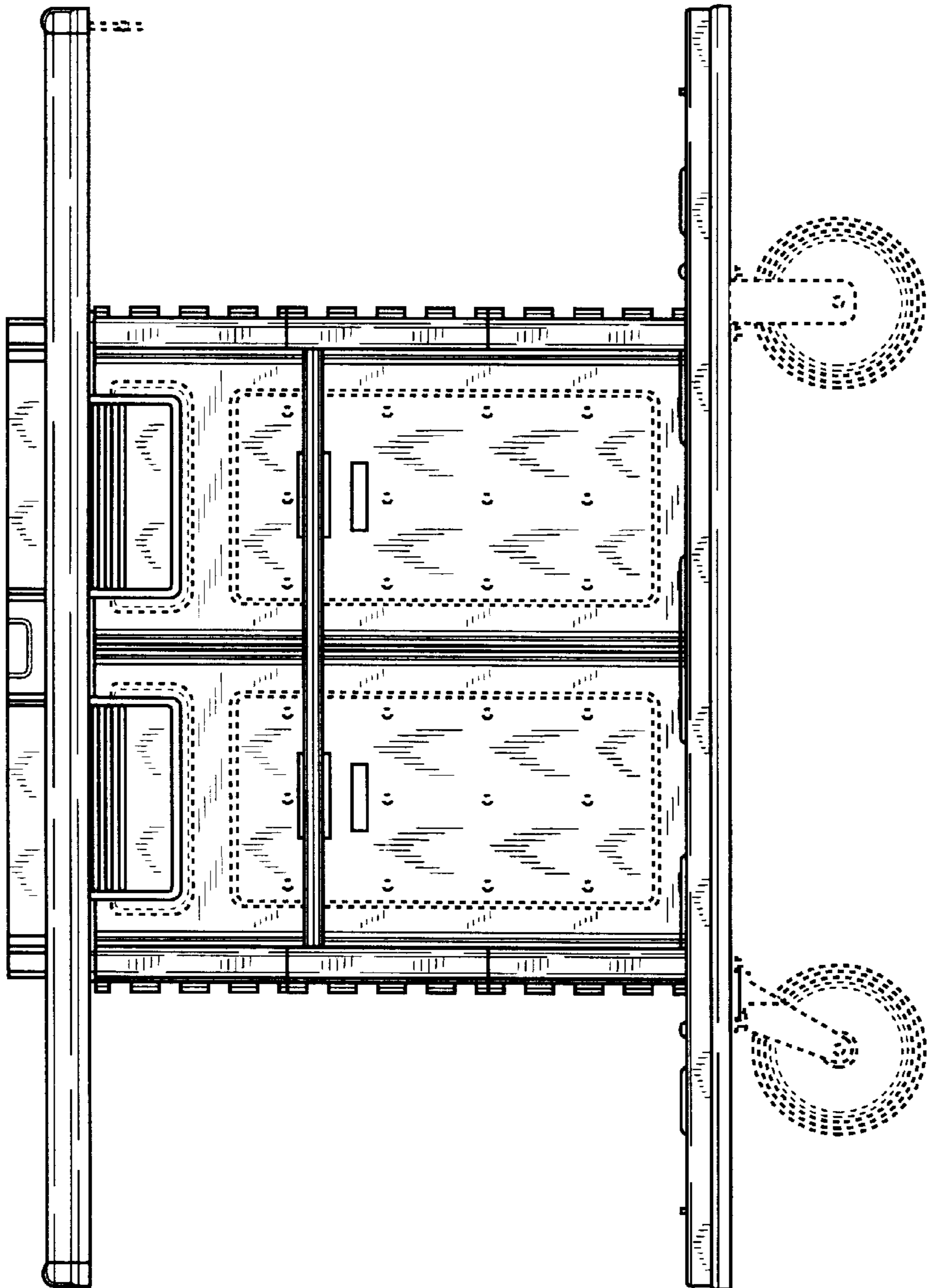

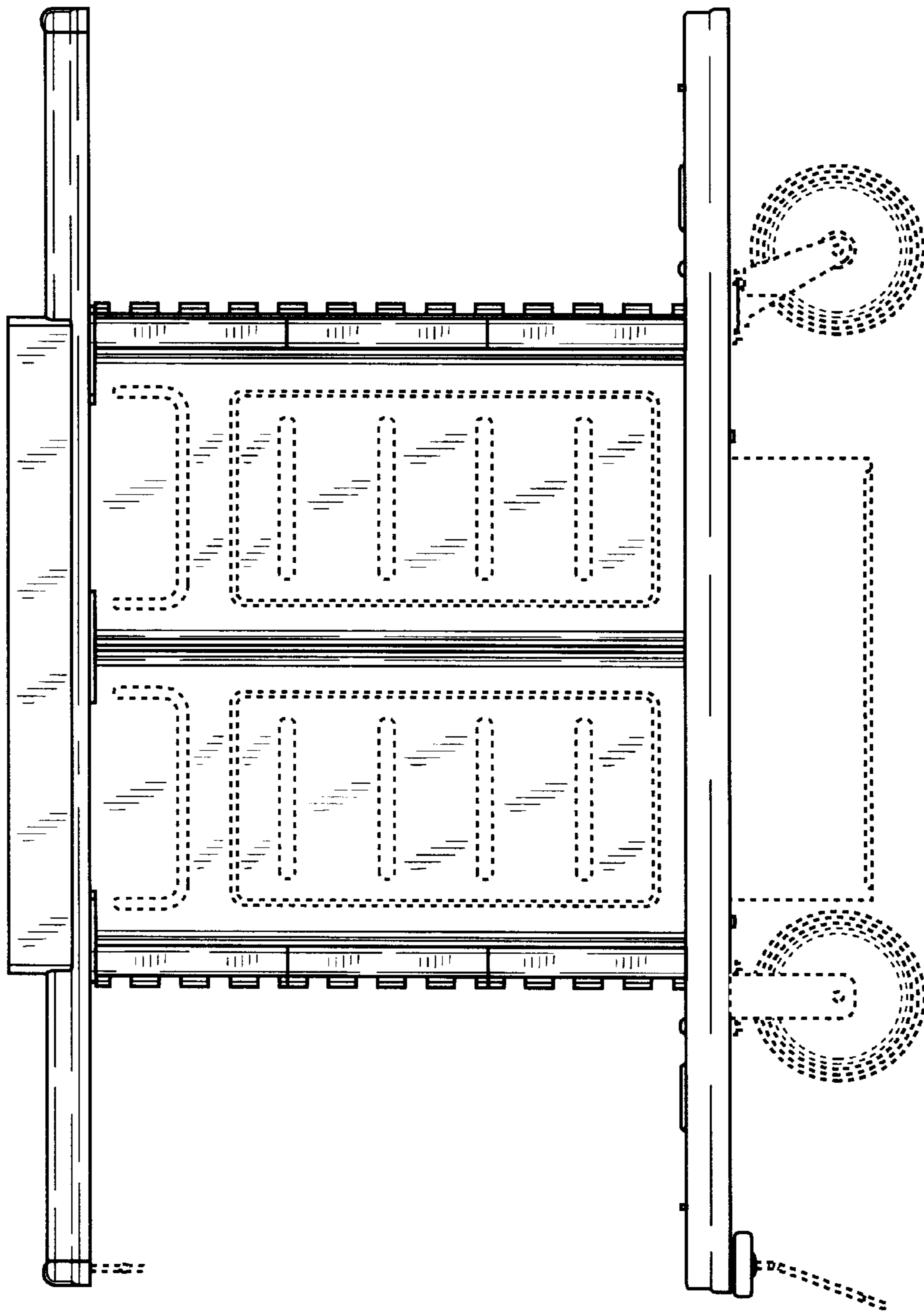

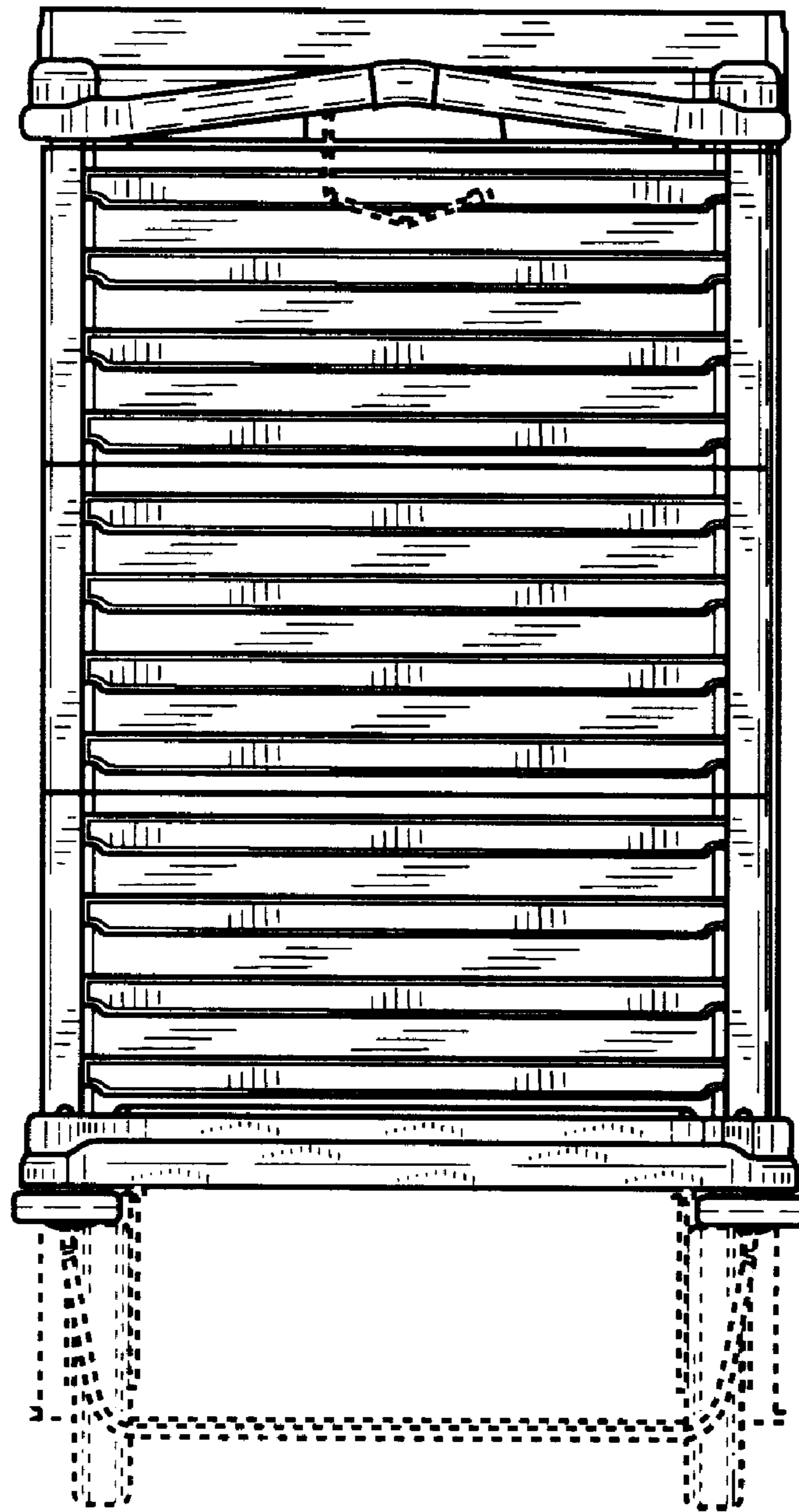

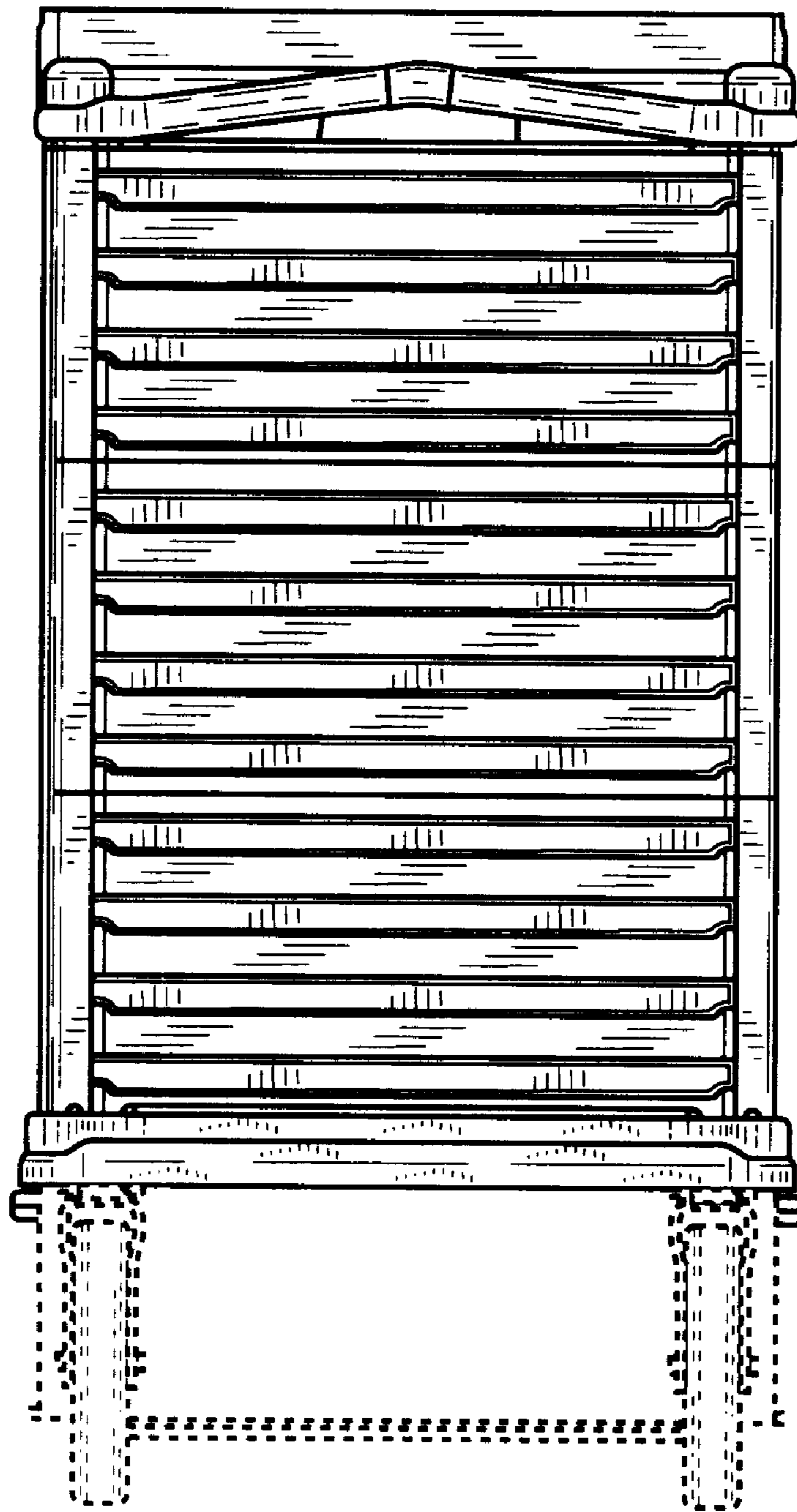

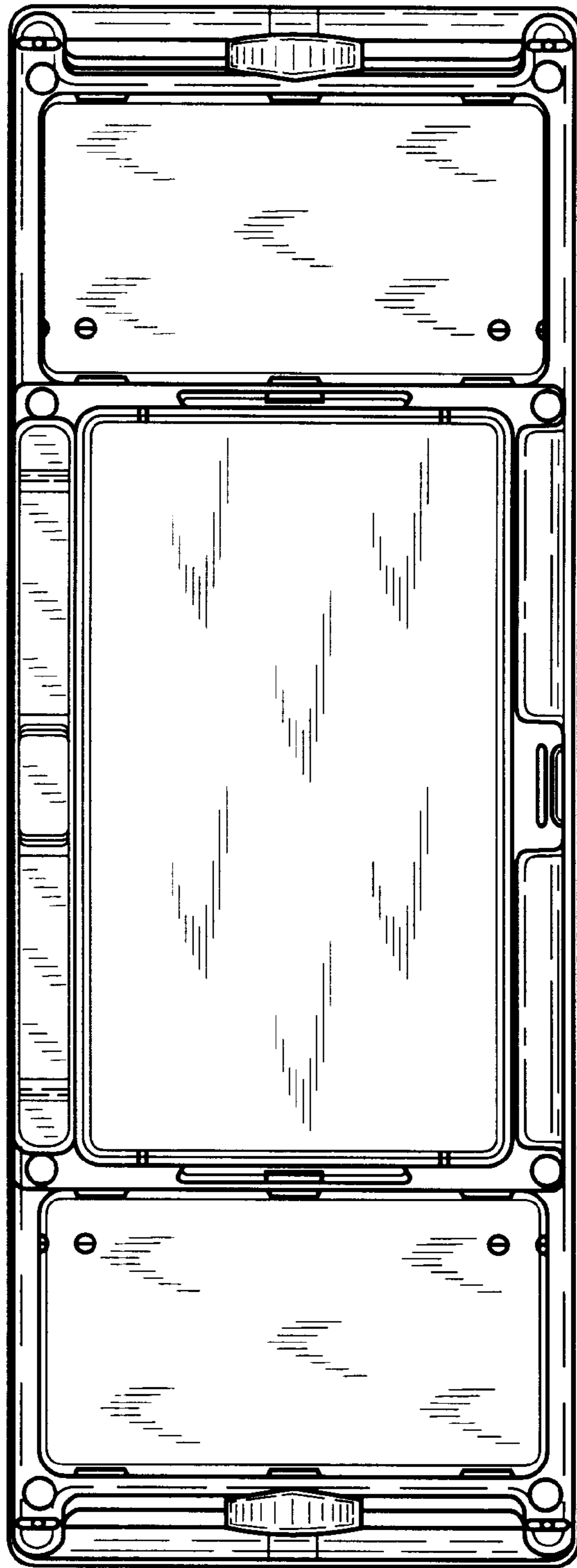
