FIG. 9 is a top elevational view of the bikini glass of FIG. 6; and,

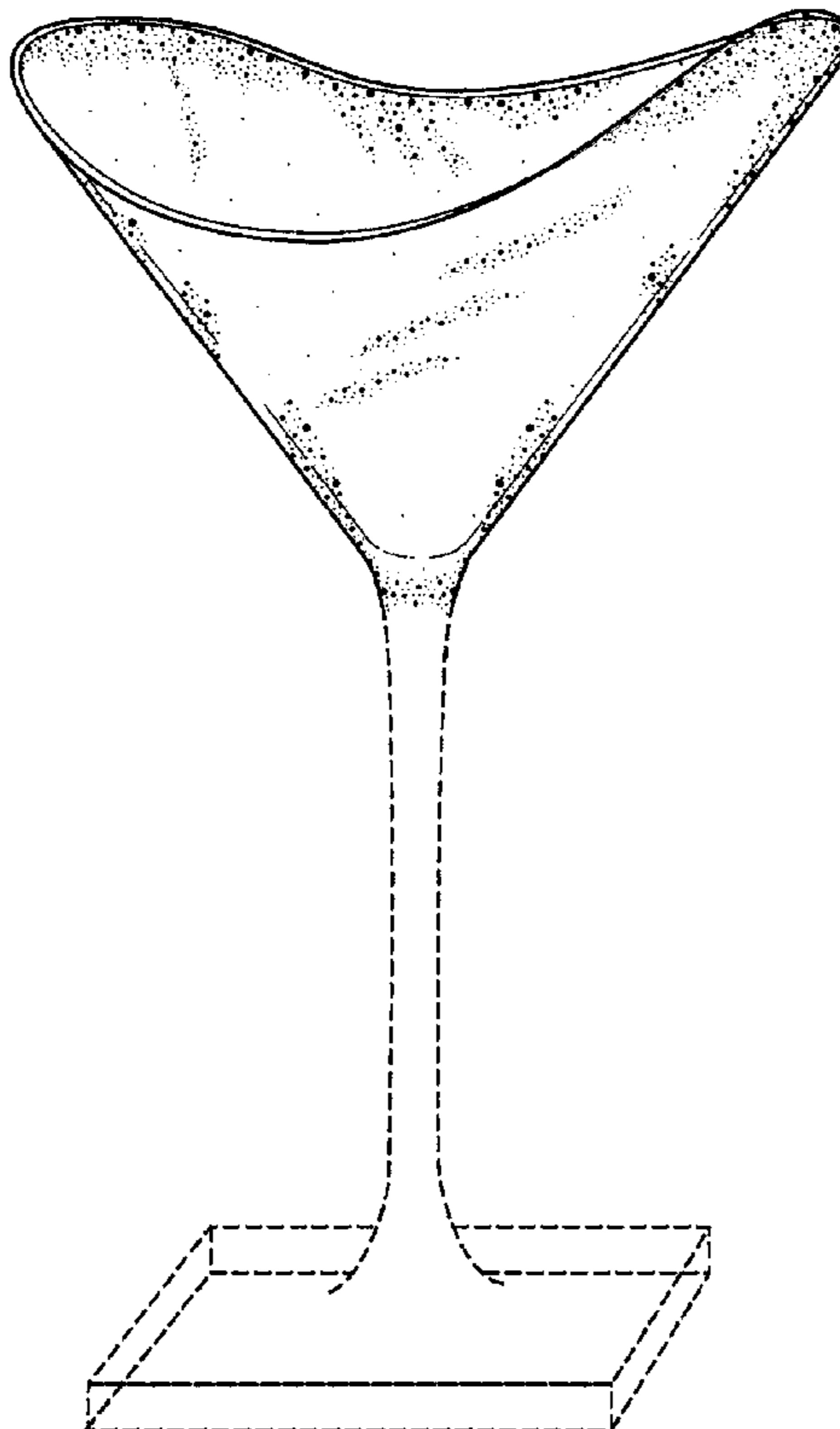
FIG. 10 is a bottom elevational view of the bikini glass of FIG. 6.

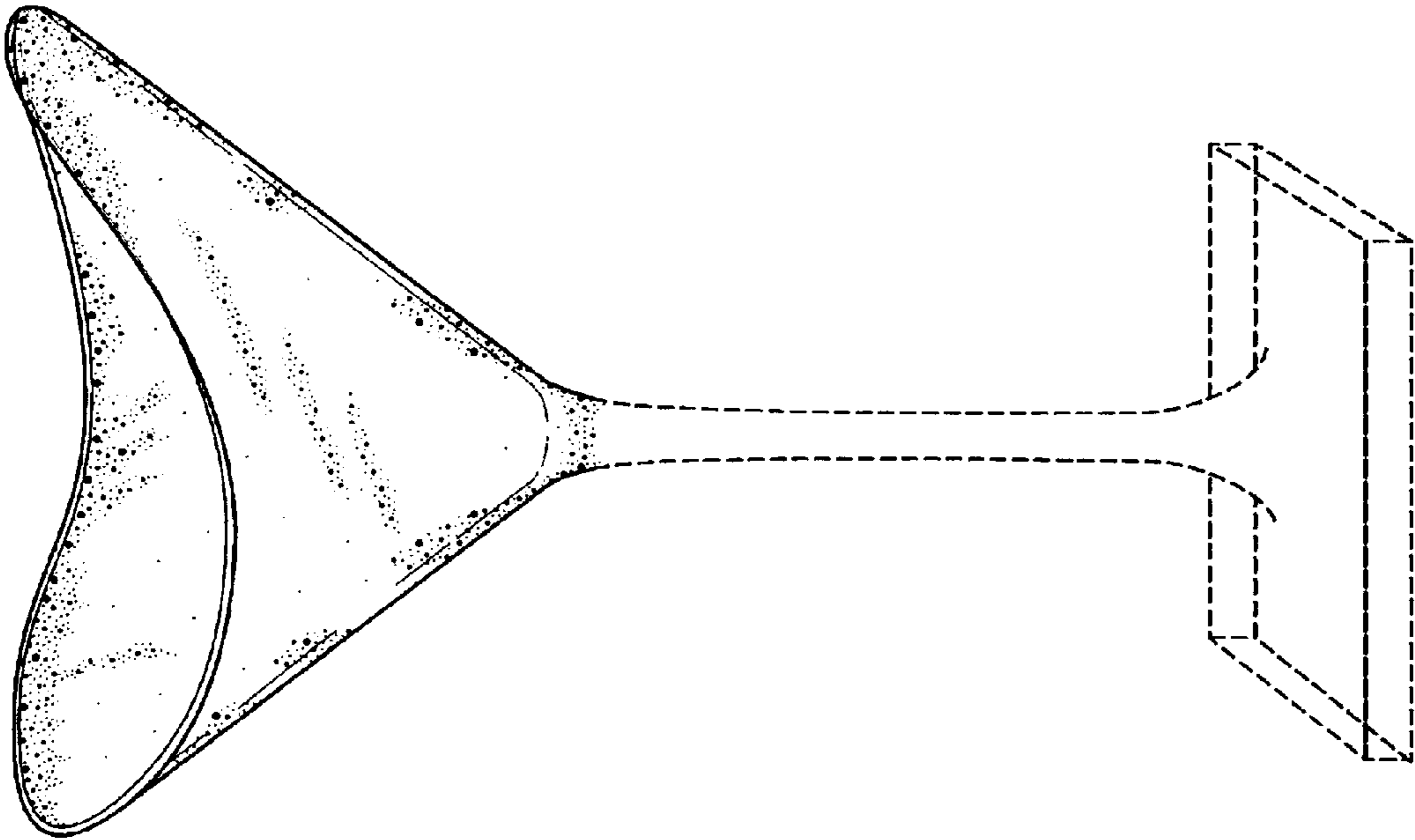

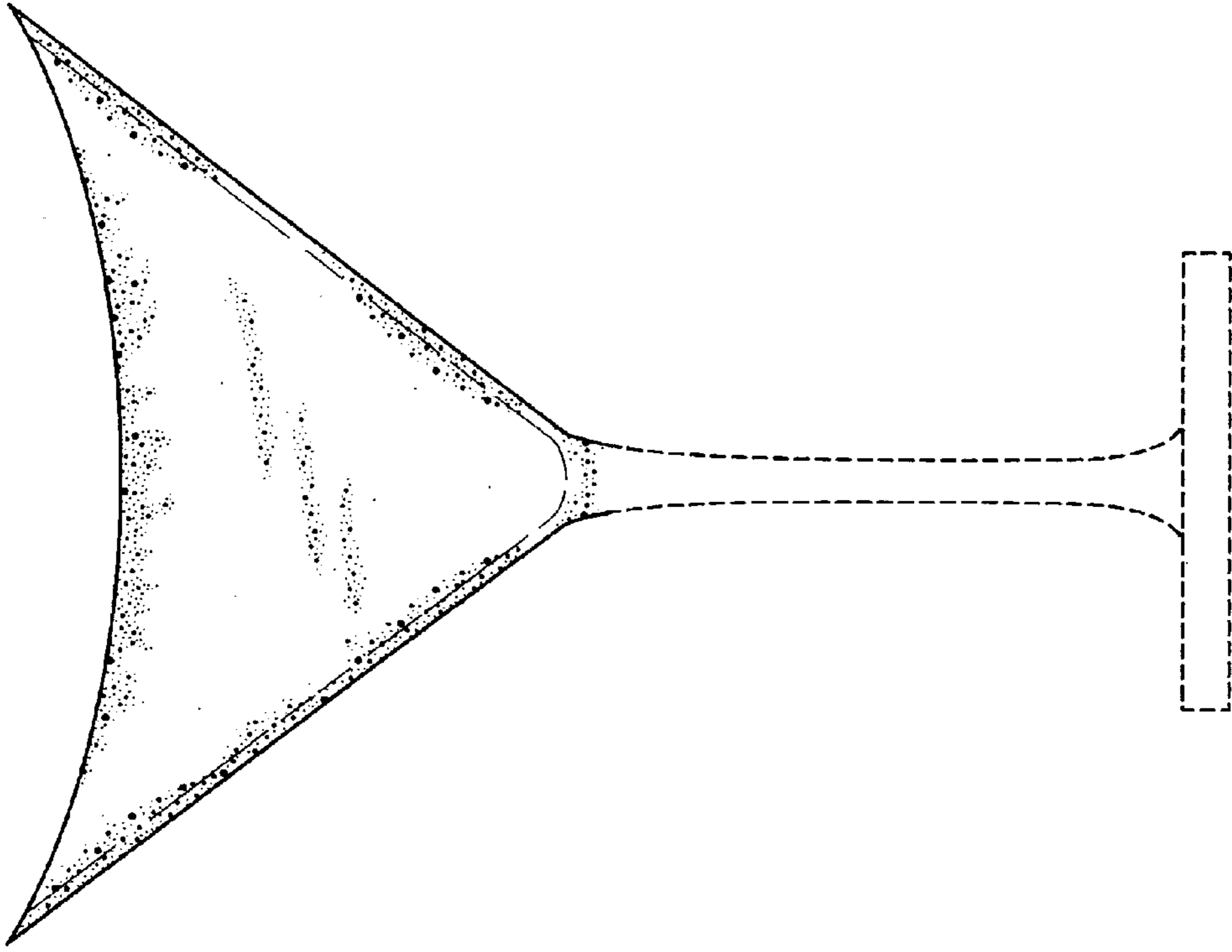

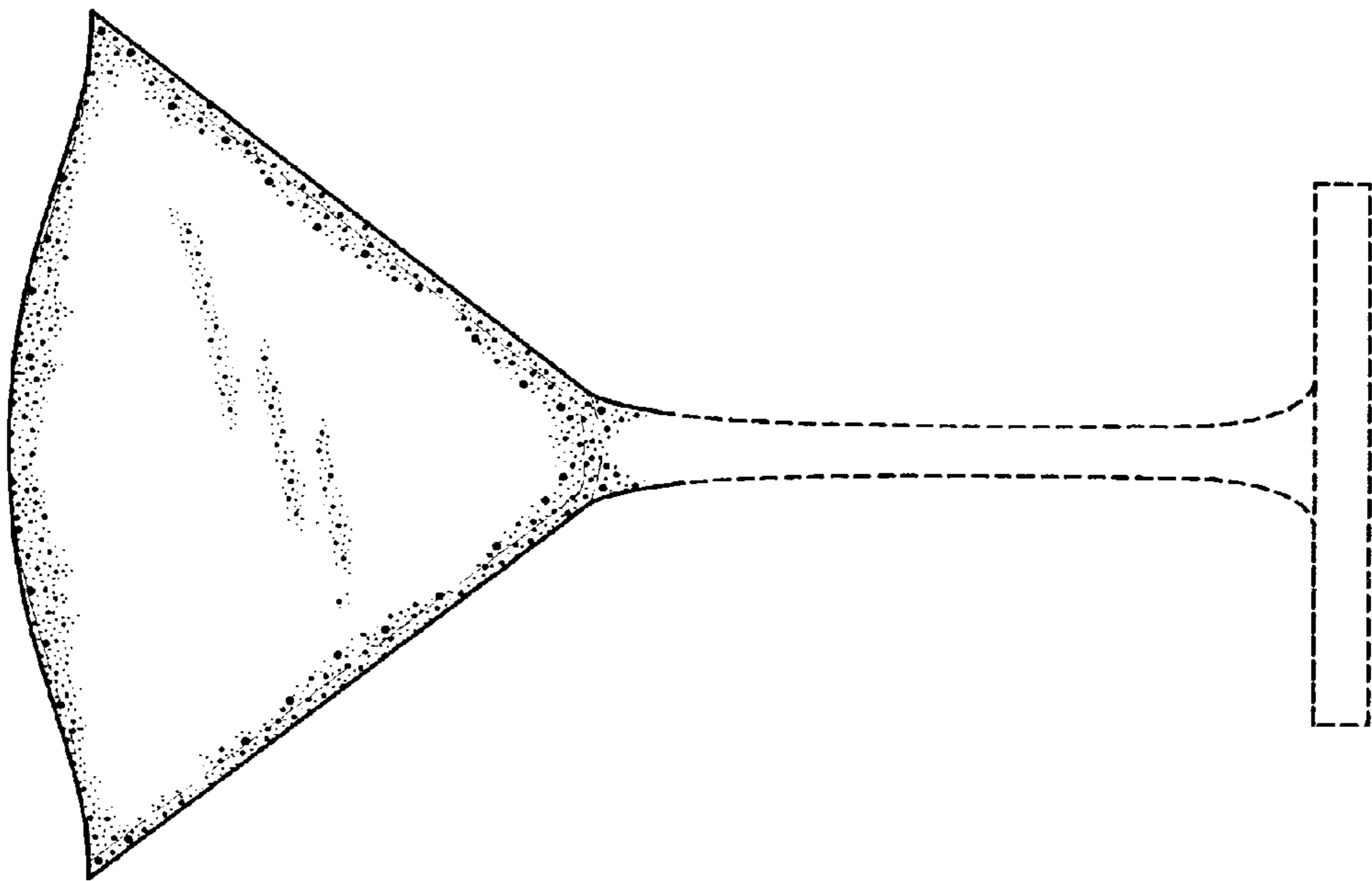




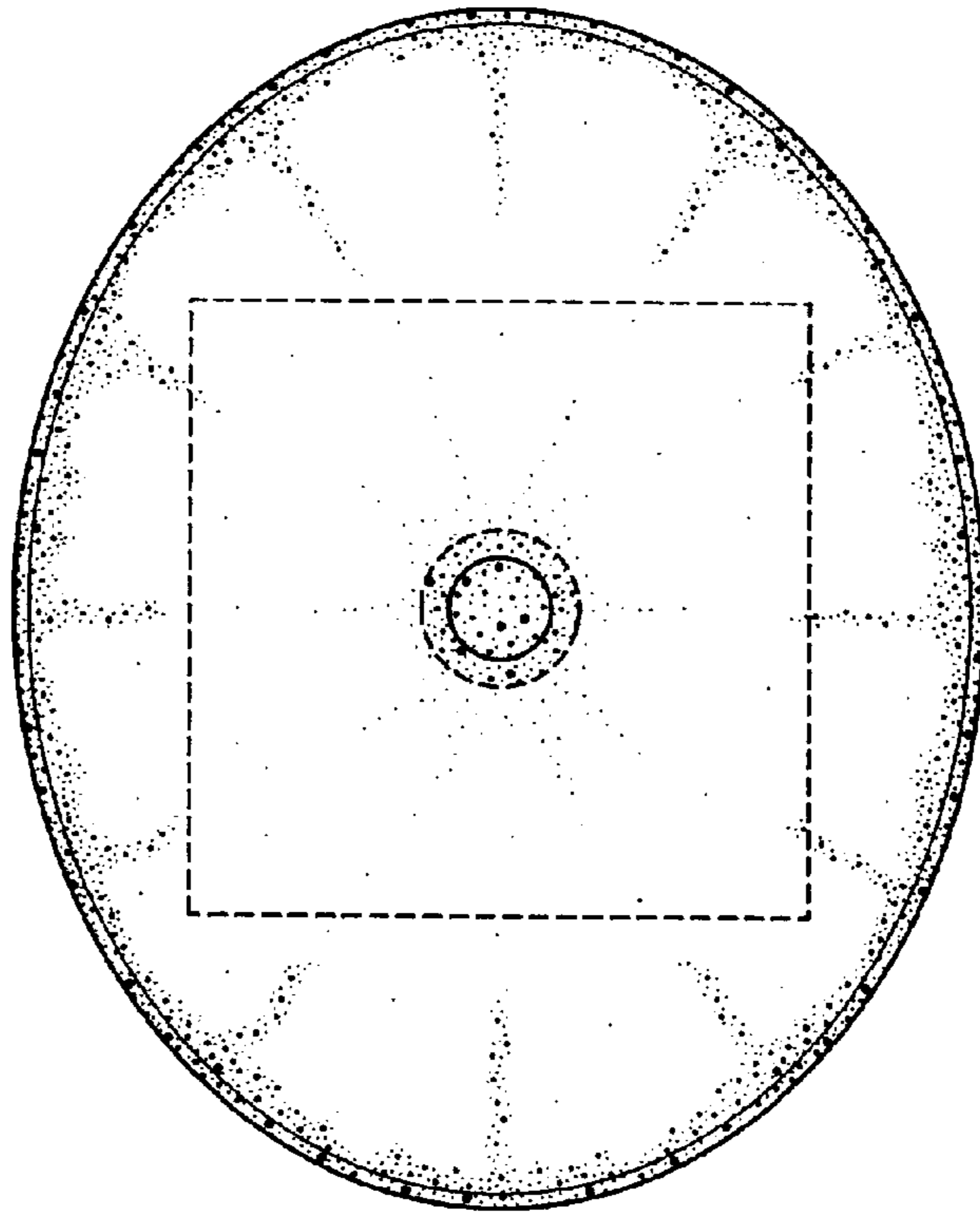

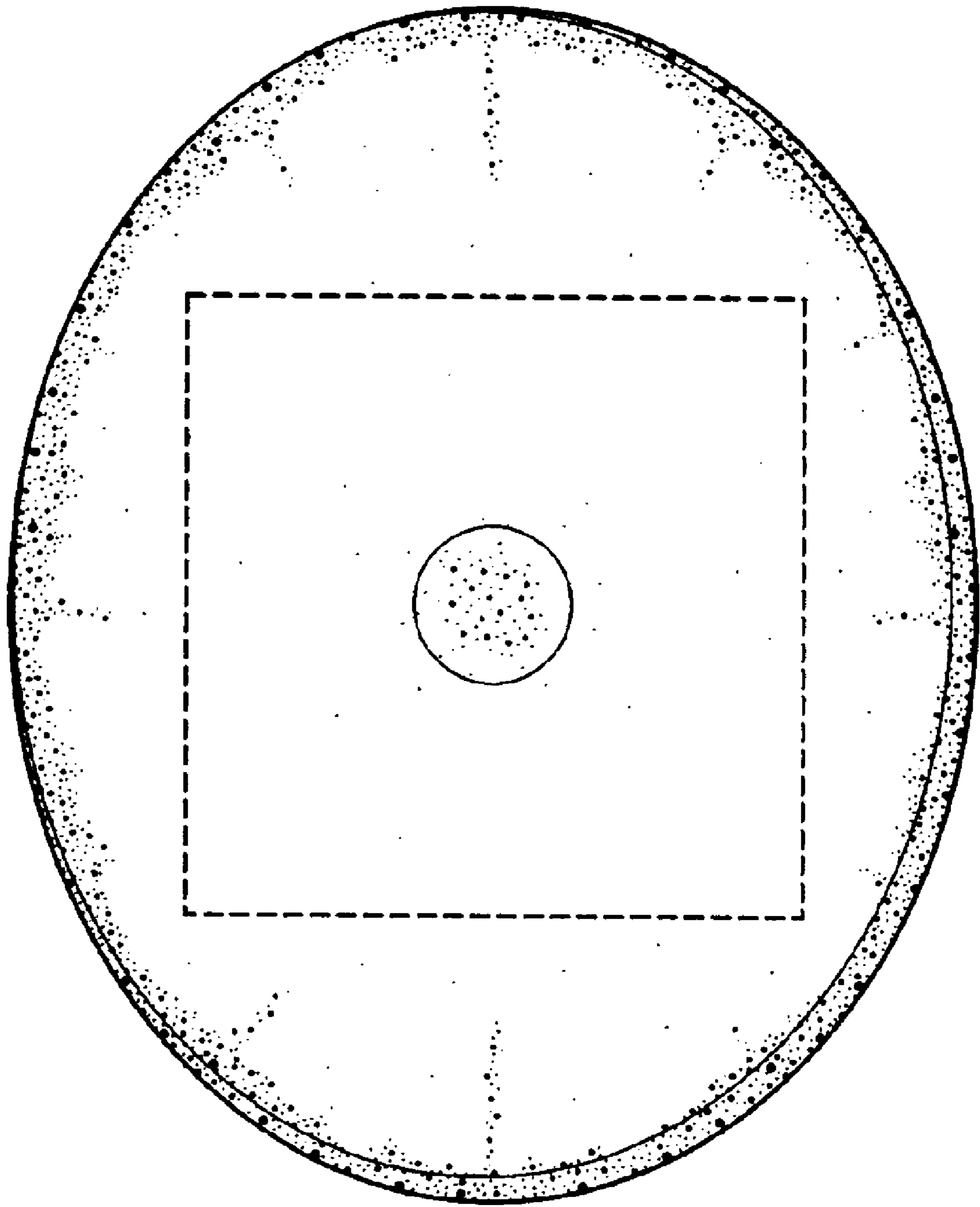

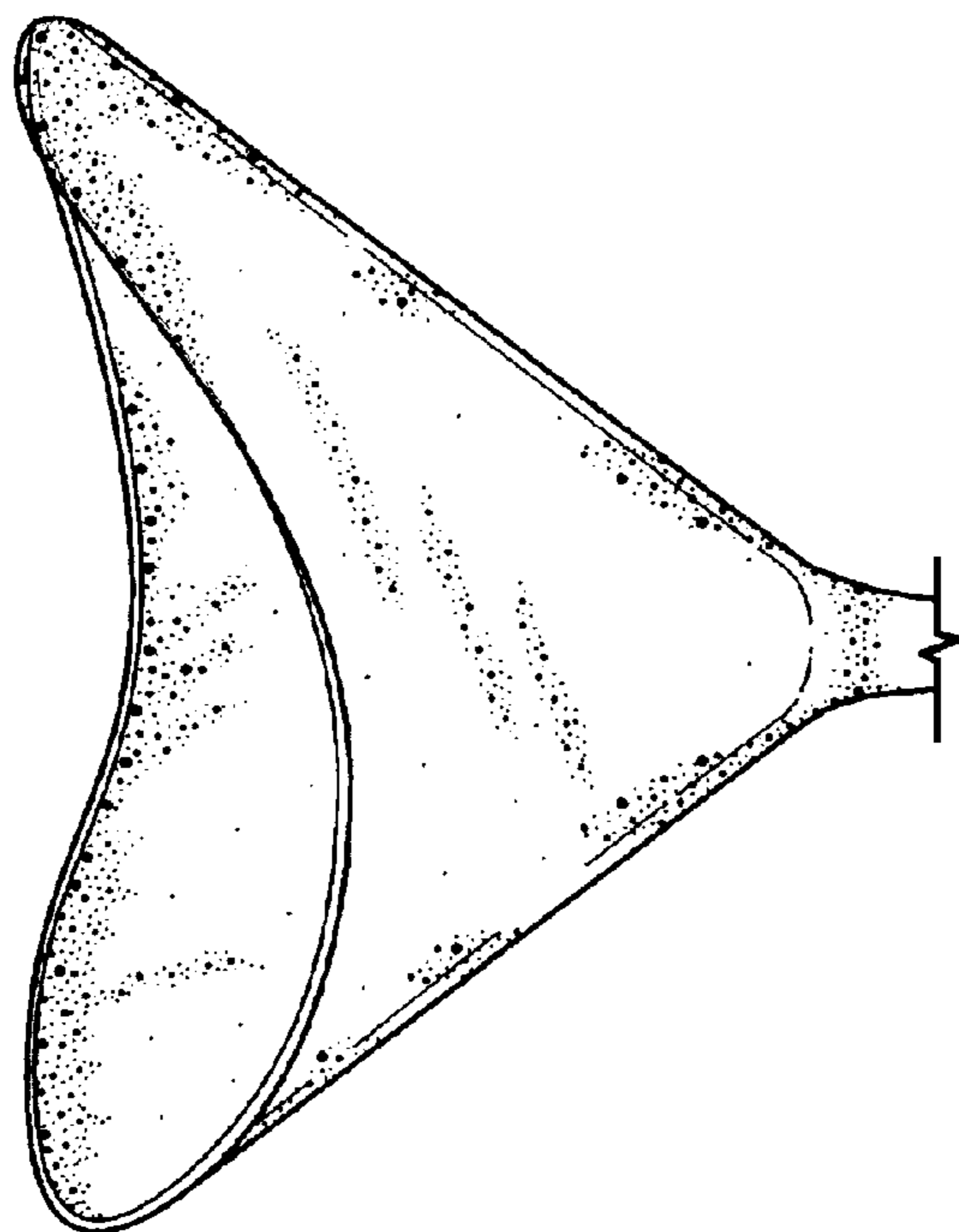

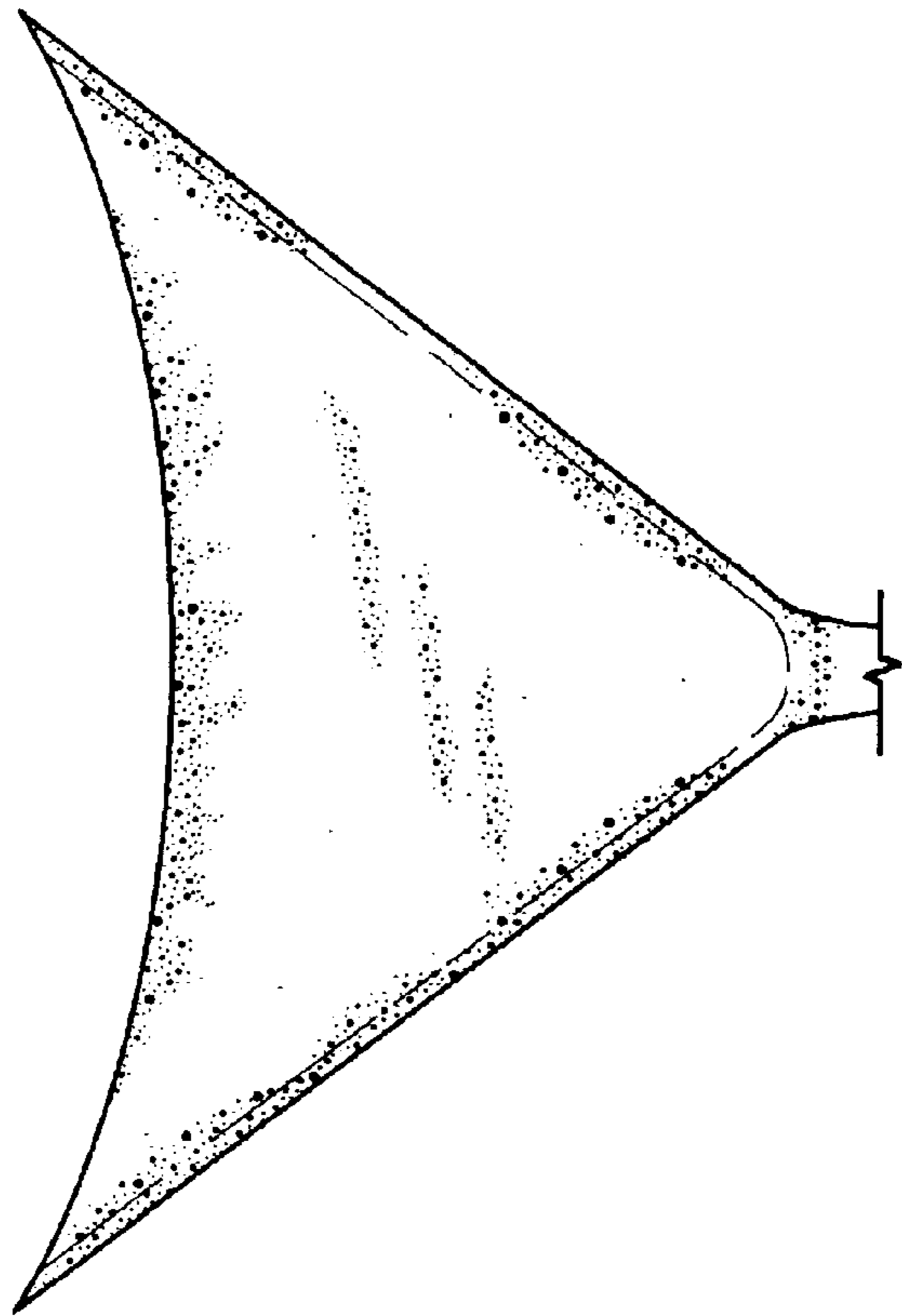

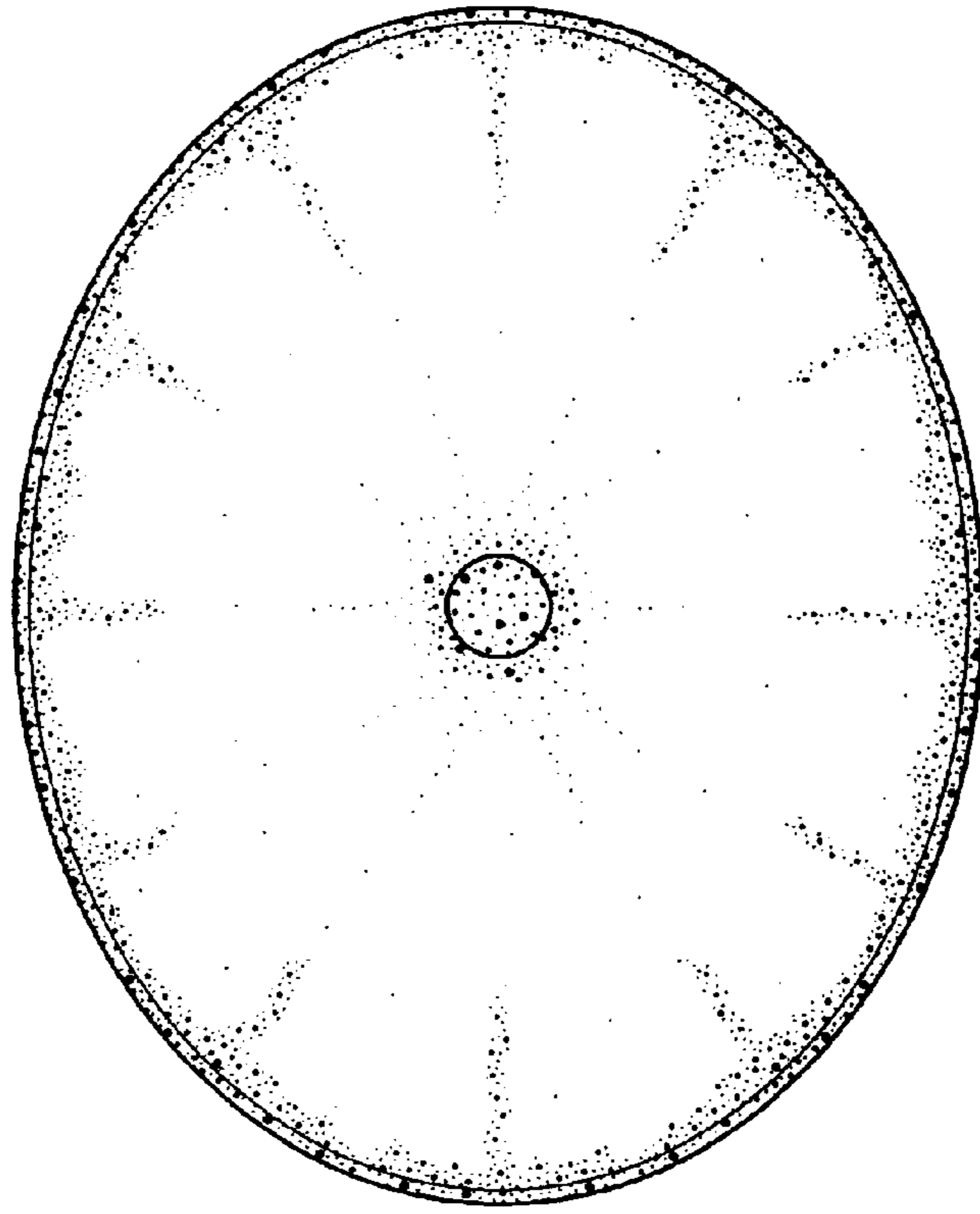

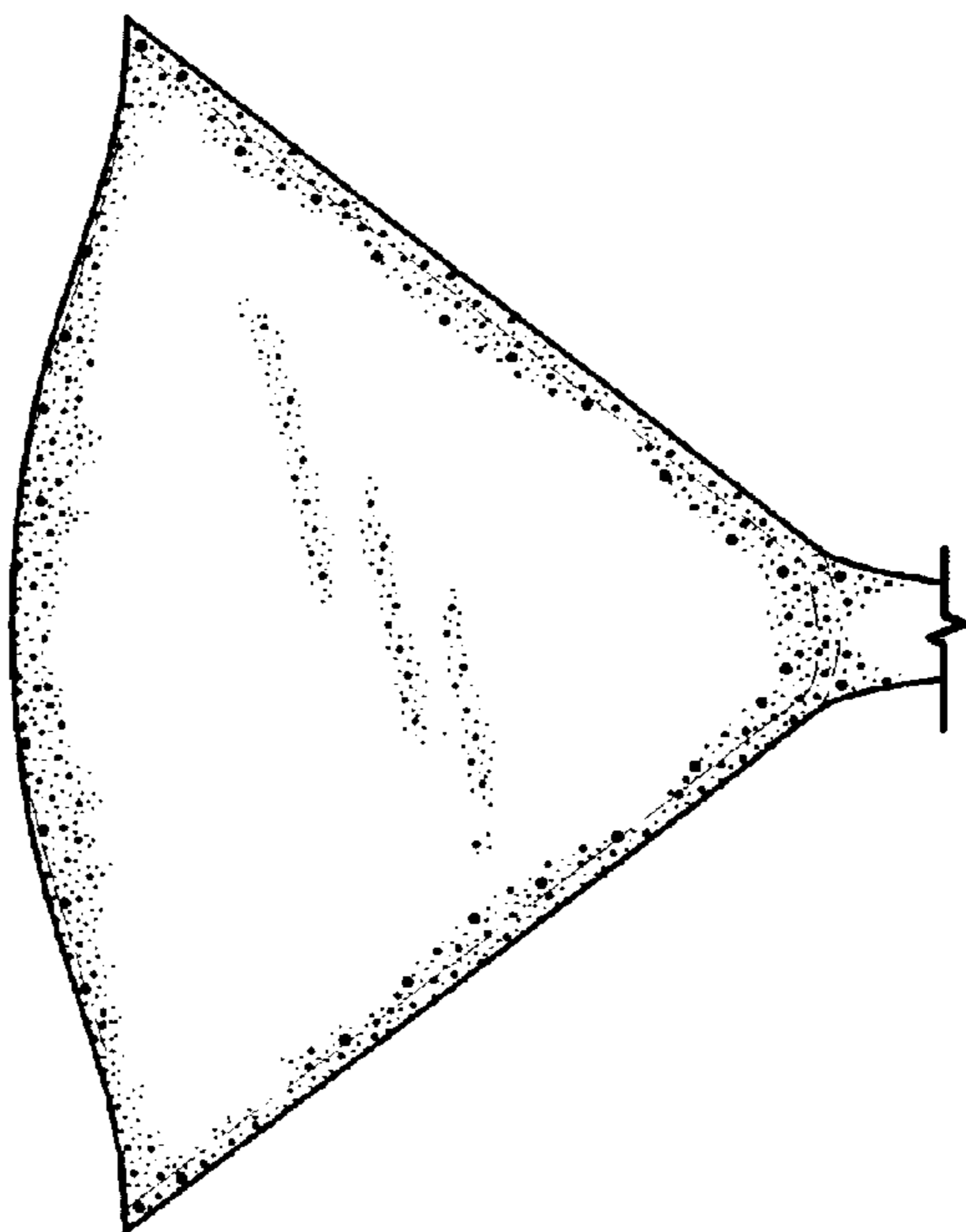
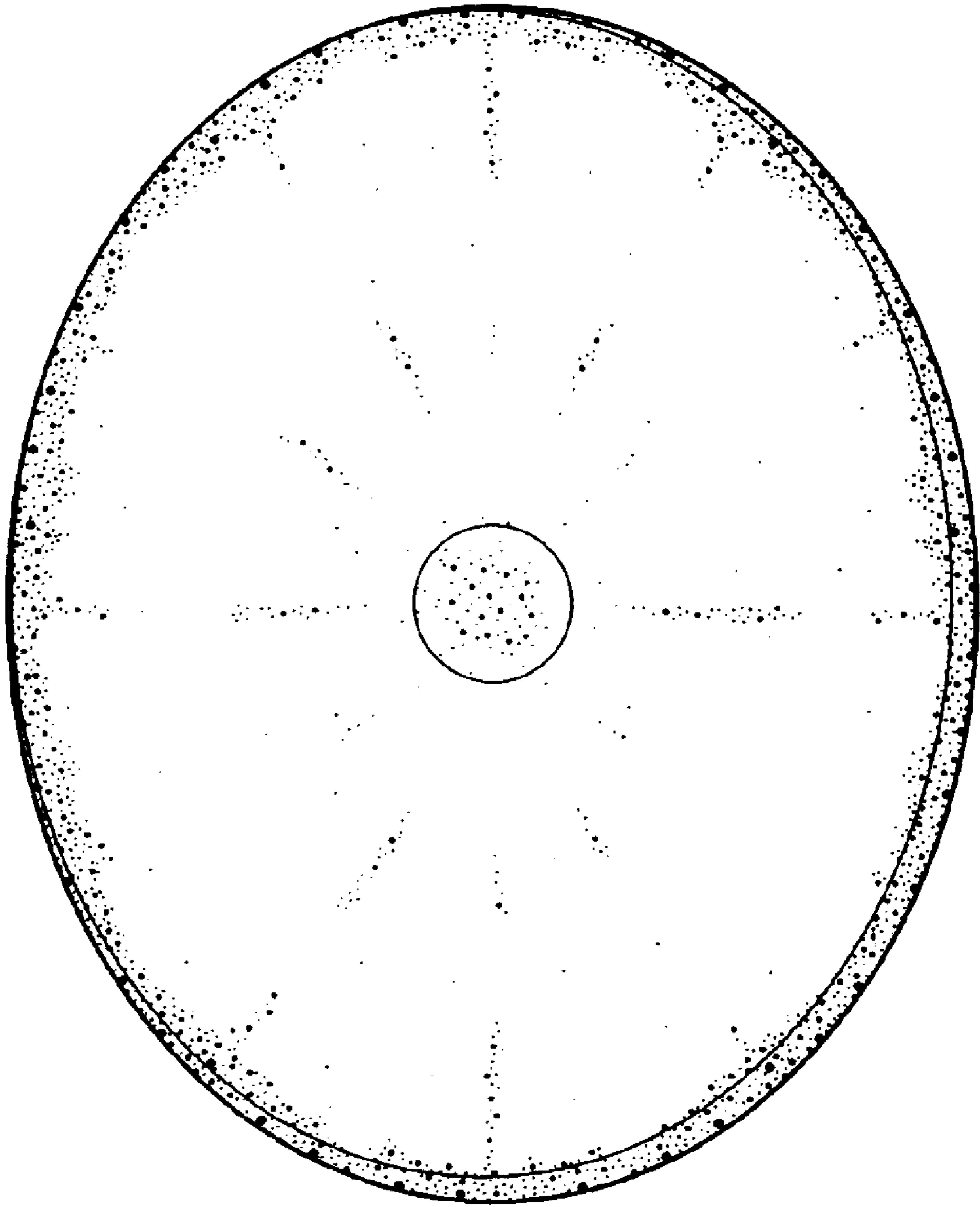
