(57) **CLAIM**

The ornamental design for a cutting cartridge, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the cutting cartridge of the present invention wherein, throughout the views, a blade is shown in phantom lines for illustrative purposes only and forms no part of the present invention;  
FIG. 2 is a top plan view thereof;  
FIG. 3 is a bottom plan view thereof;  
FIG. 4 is a front side elevational view thereof;  
FIG. 5 is a rear side elevational view thereof;  
FIG. 6 is a left side elevational view thereof;  
FIG. 7 is a right side elevational view thereof;  
FIG. 8 is a front side elevational view of the cutting cartridge with a bottom portion thereof relocated in an alternative position wherein the bottom portion is rotated 180° relative to a top cover portion thereof;  
FIG. 9 is a rear side elevational view thereof;  
FIG. 10 is a top plan view thereof;  
FIG. 11 is a bottom plan view thereof;  
FIG. 12 is a left side elevational view thereof; and,  
FIG. 13 is a right side elevational view thereof.

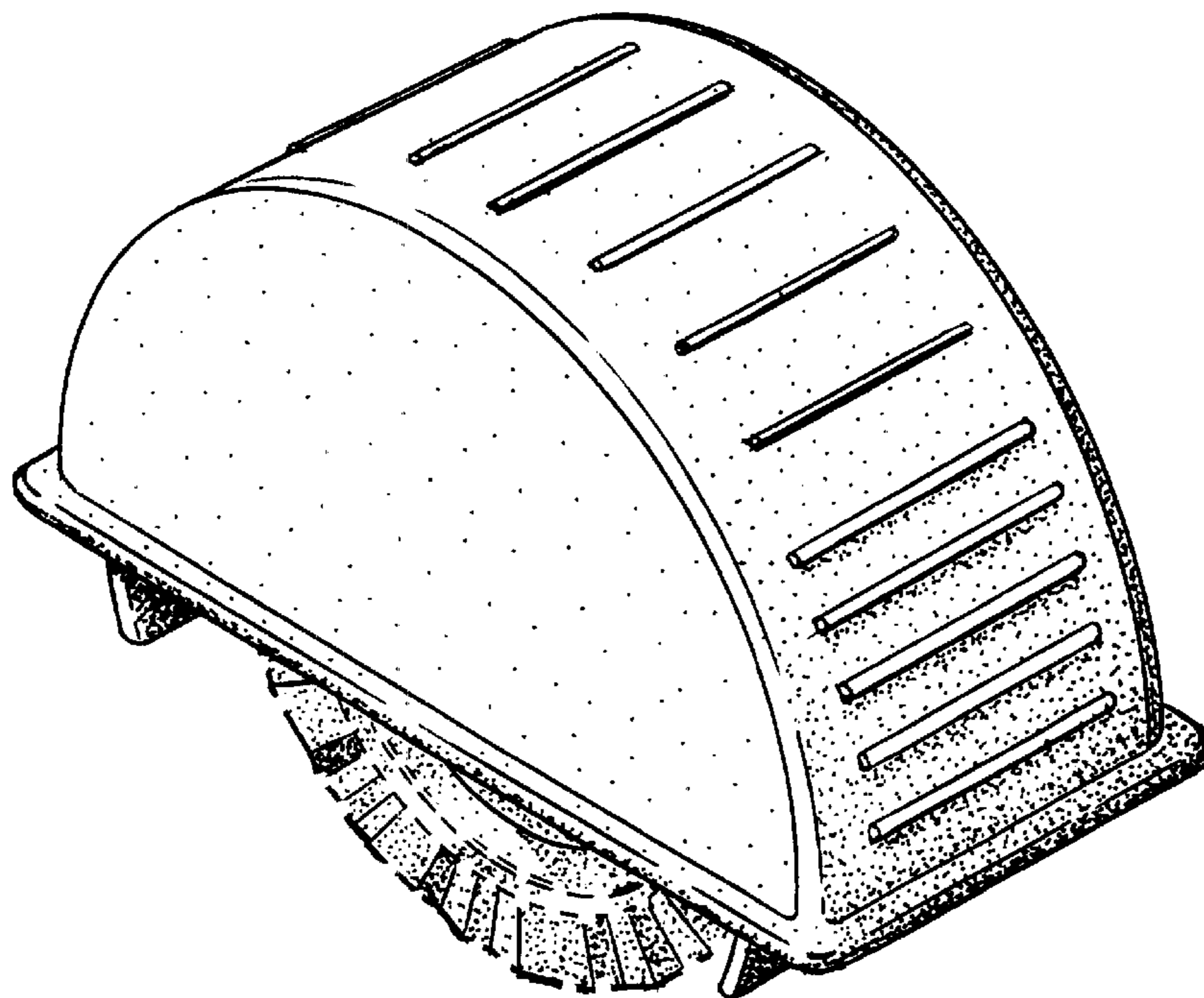

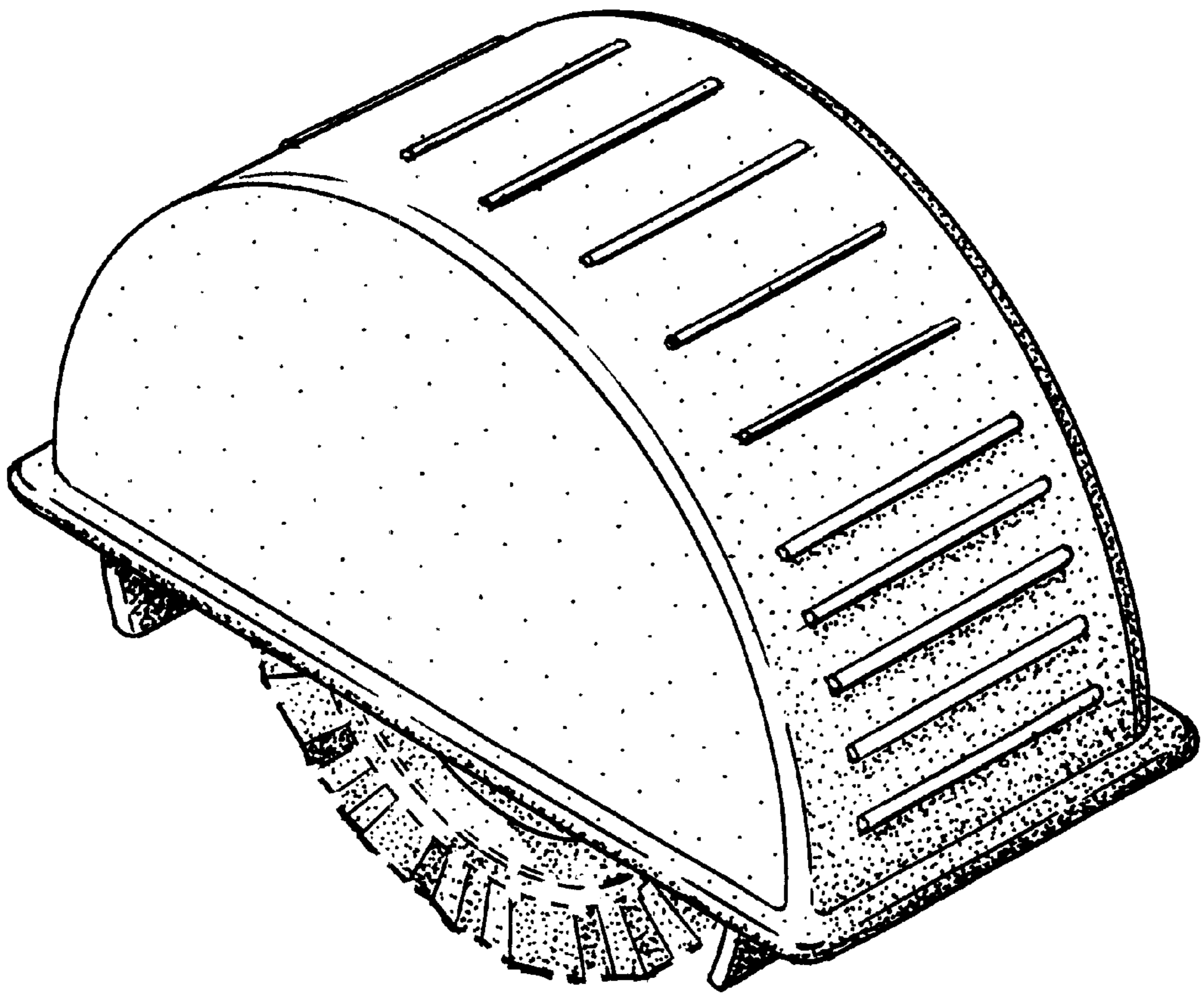

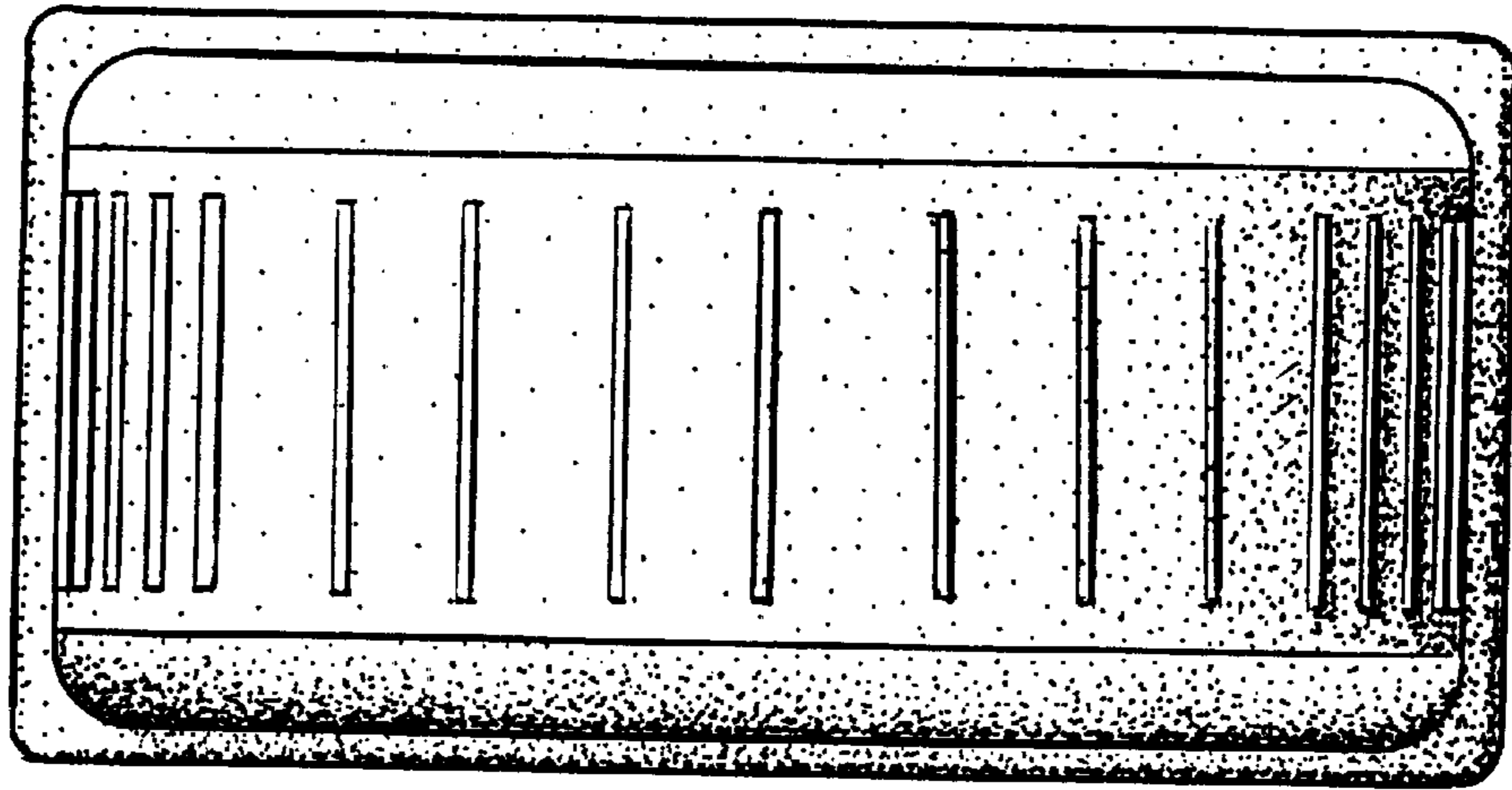

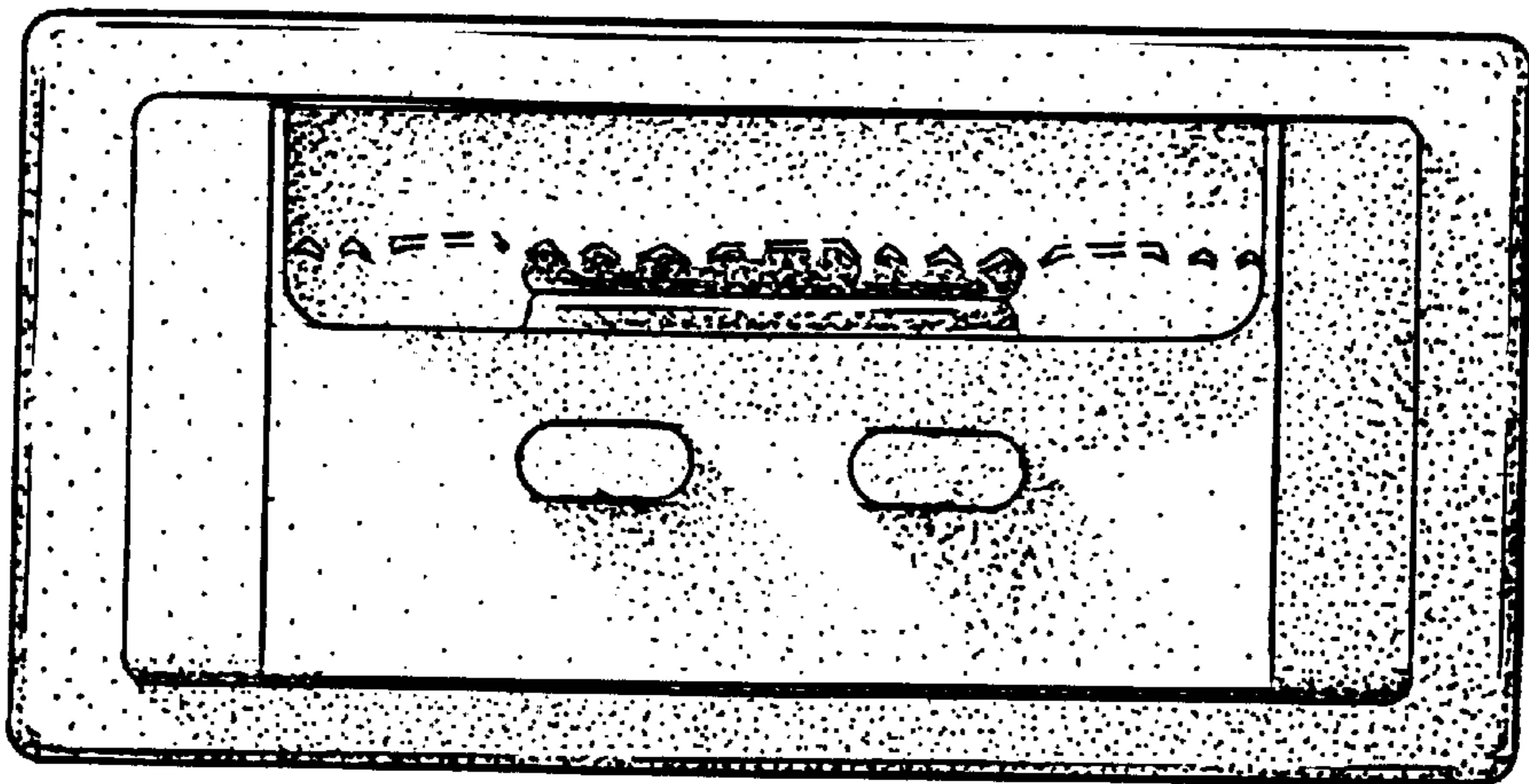

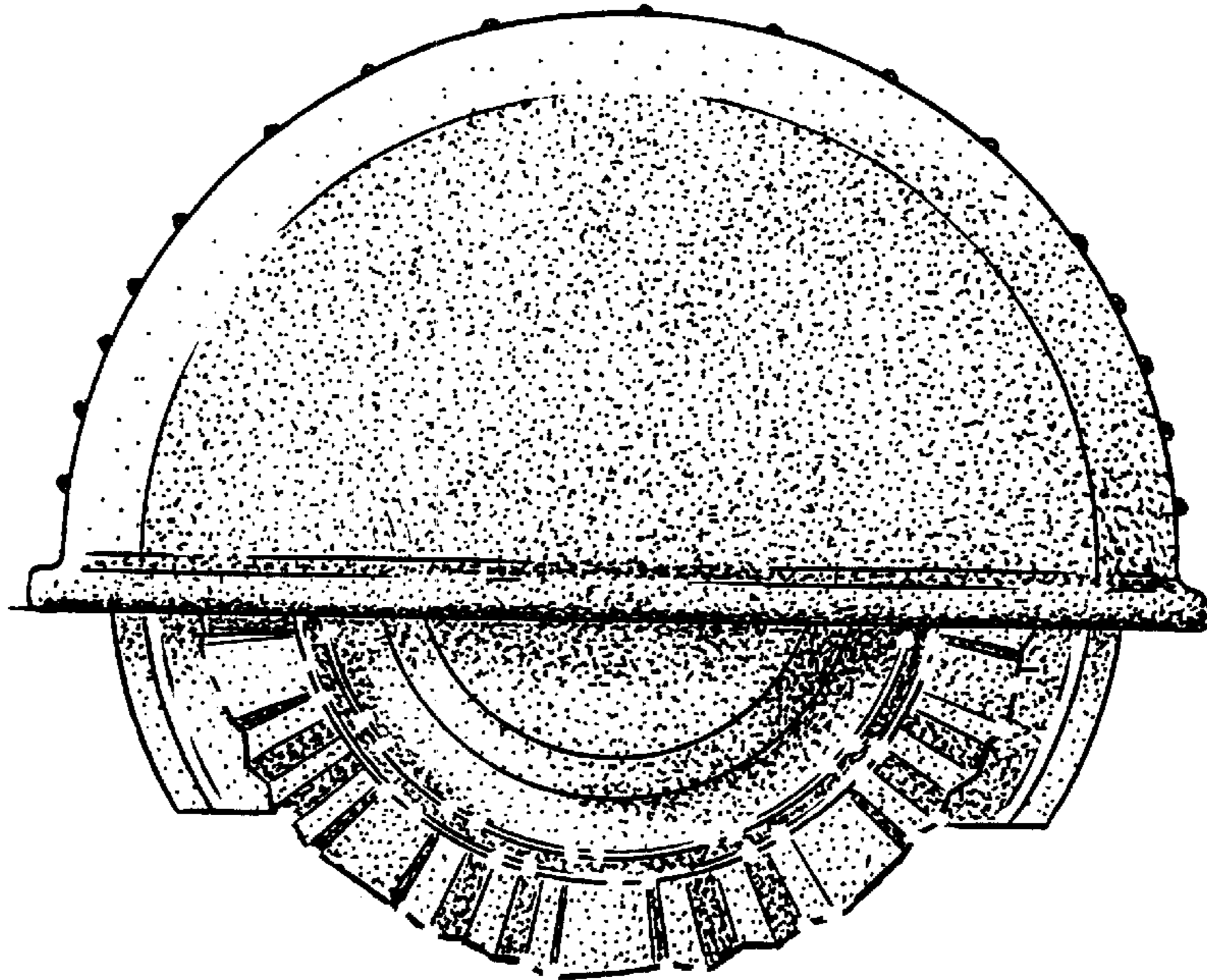

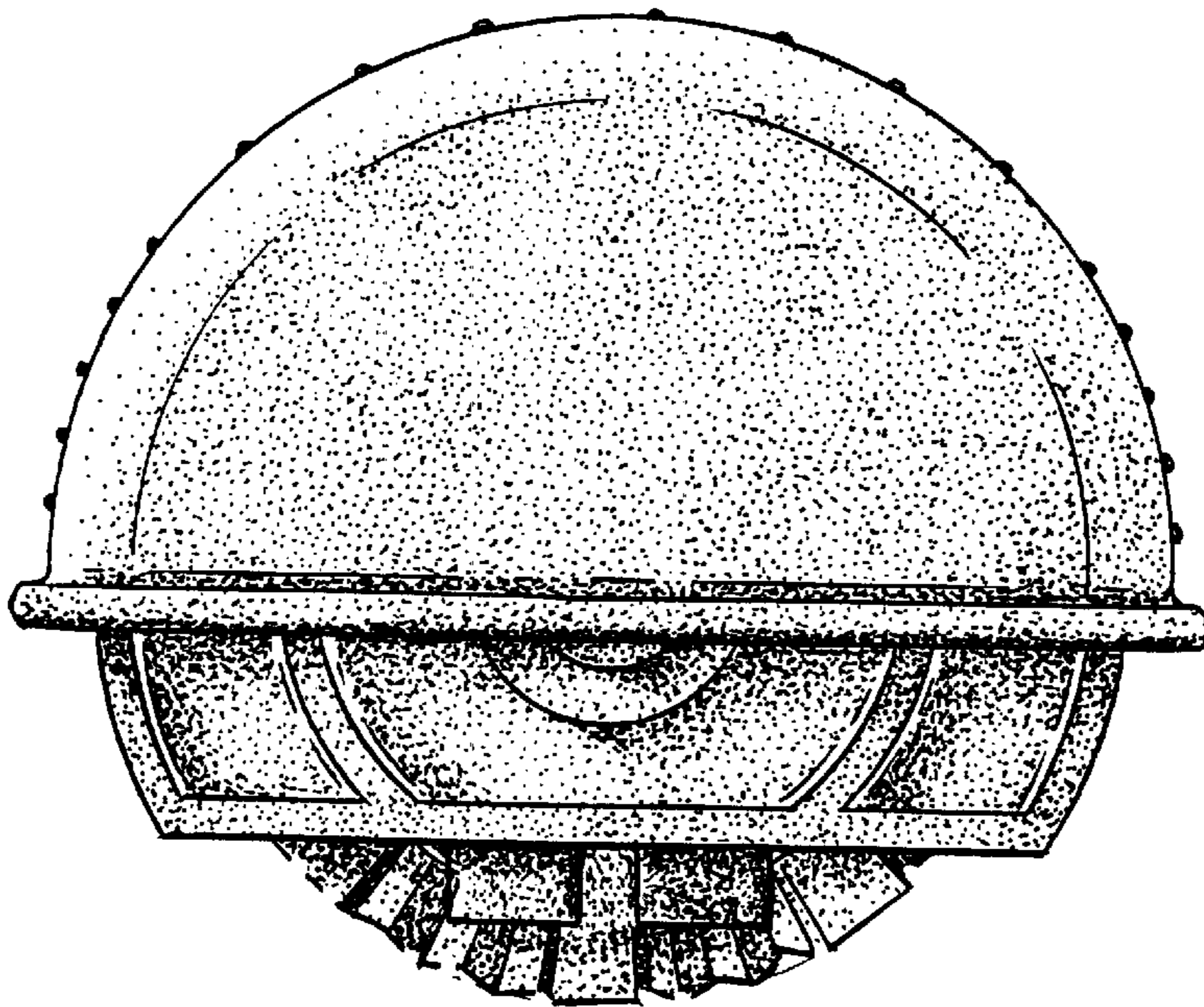

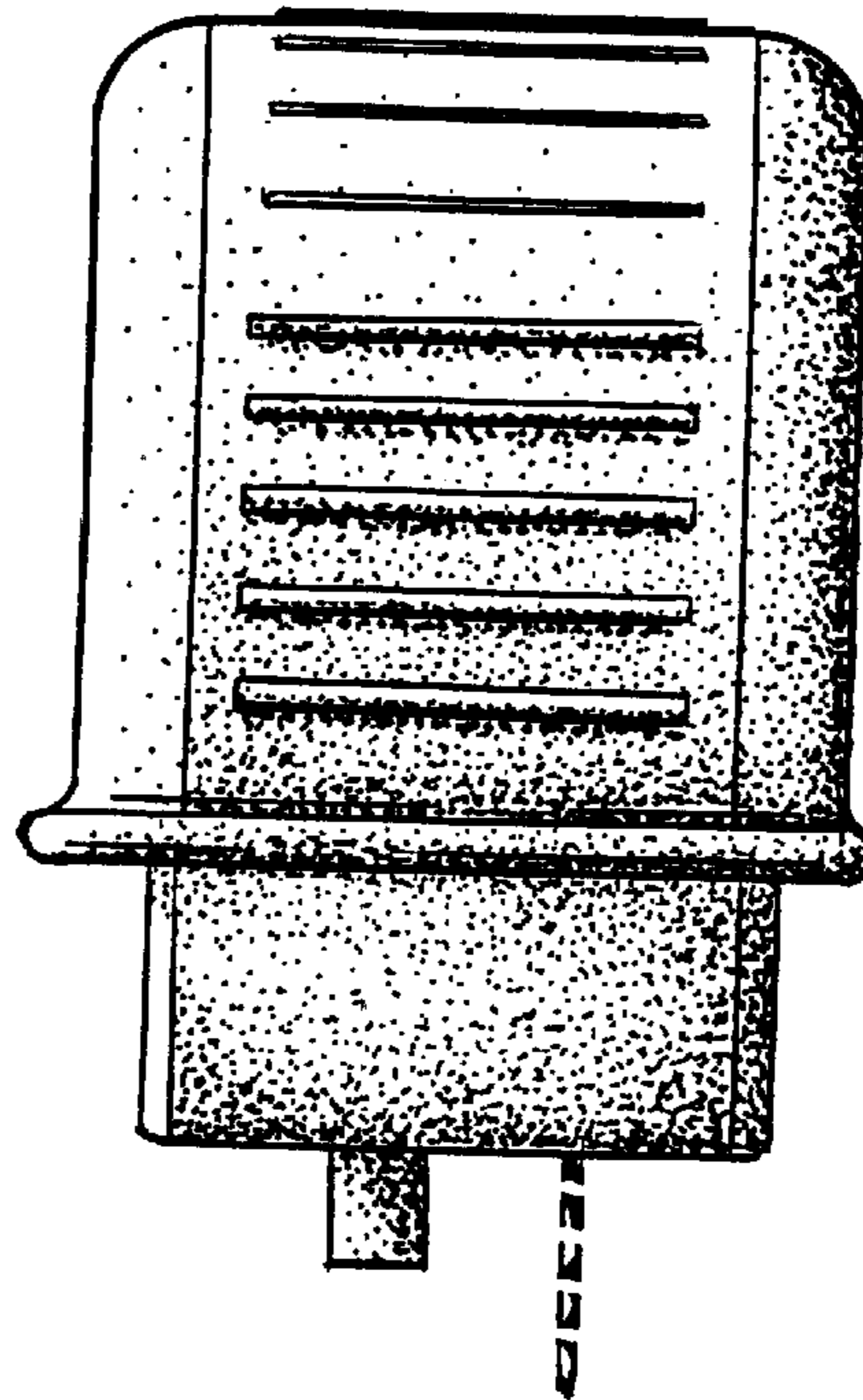

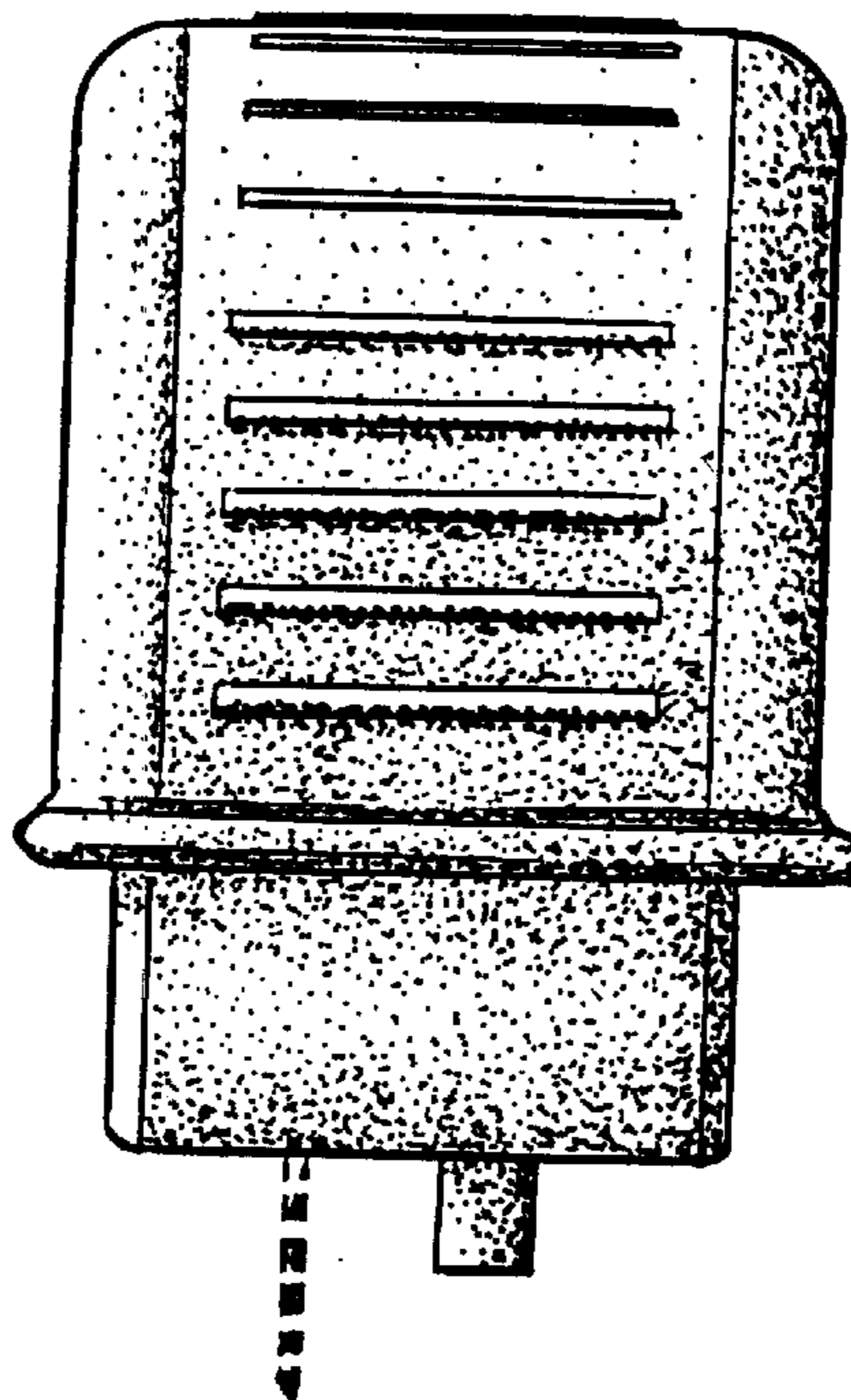

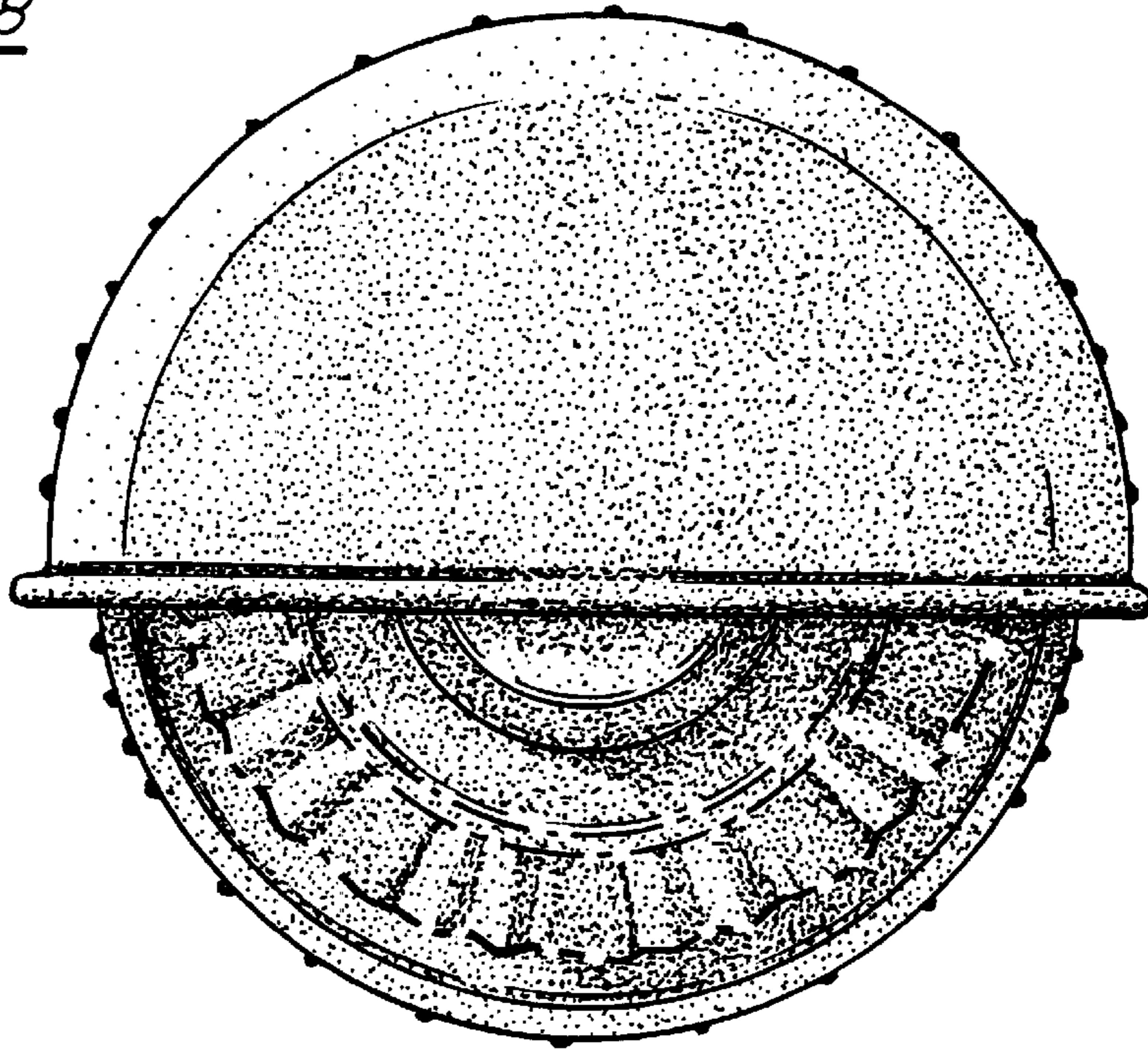

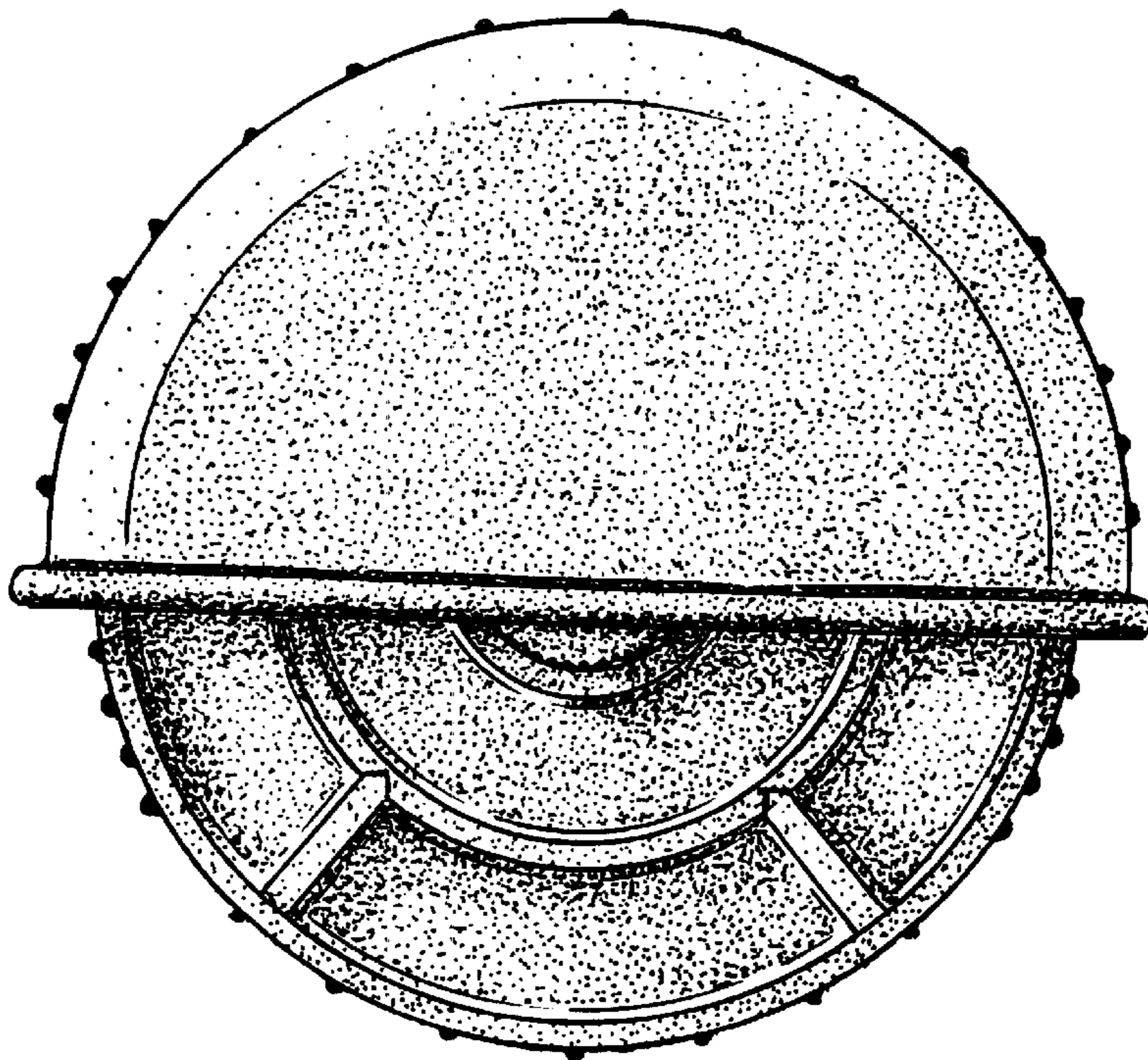

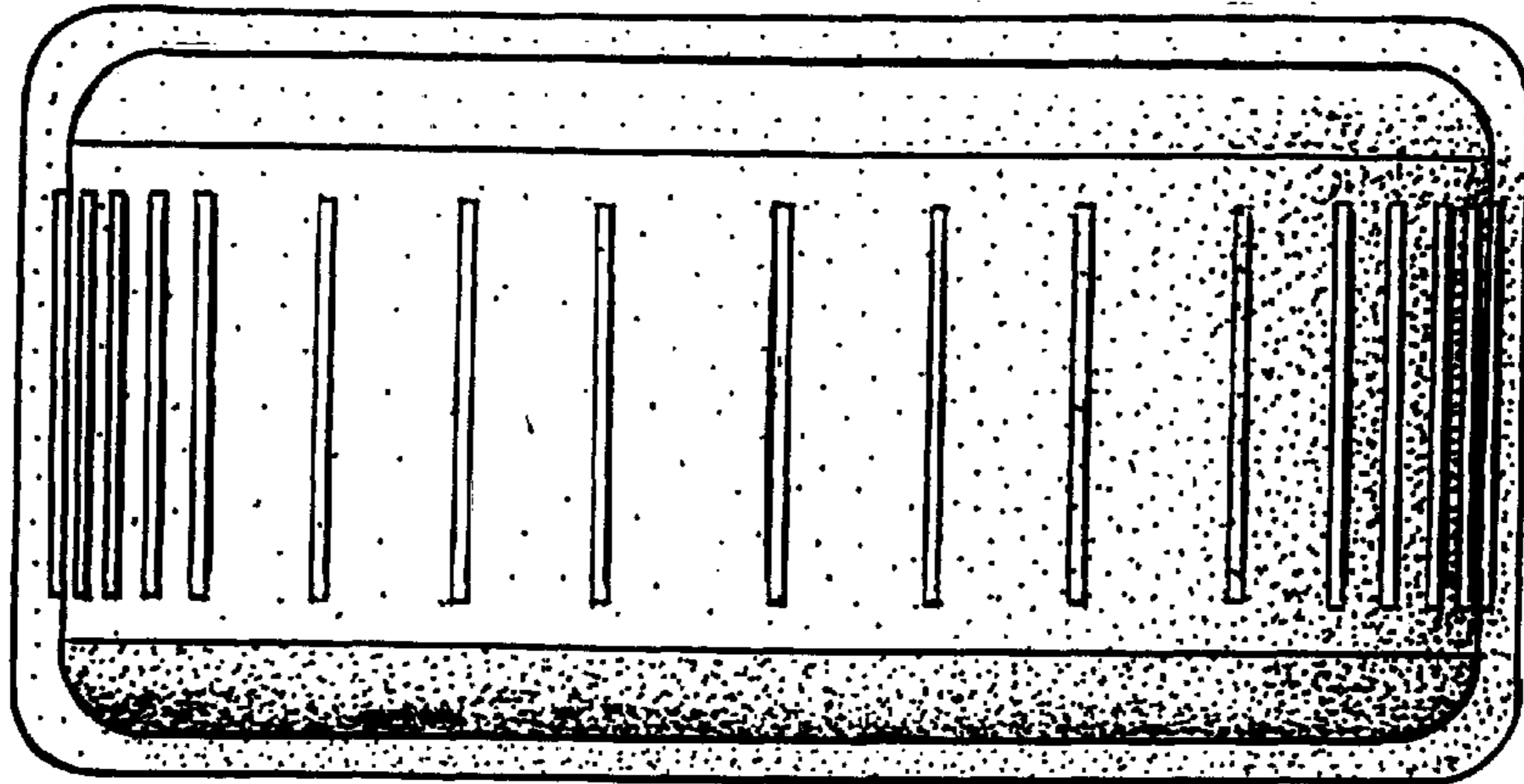

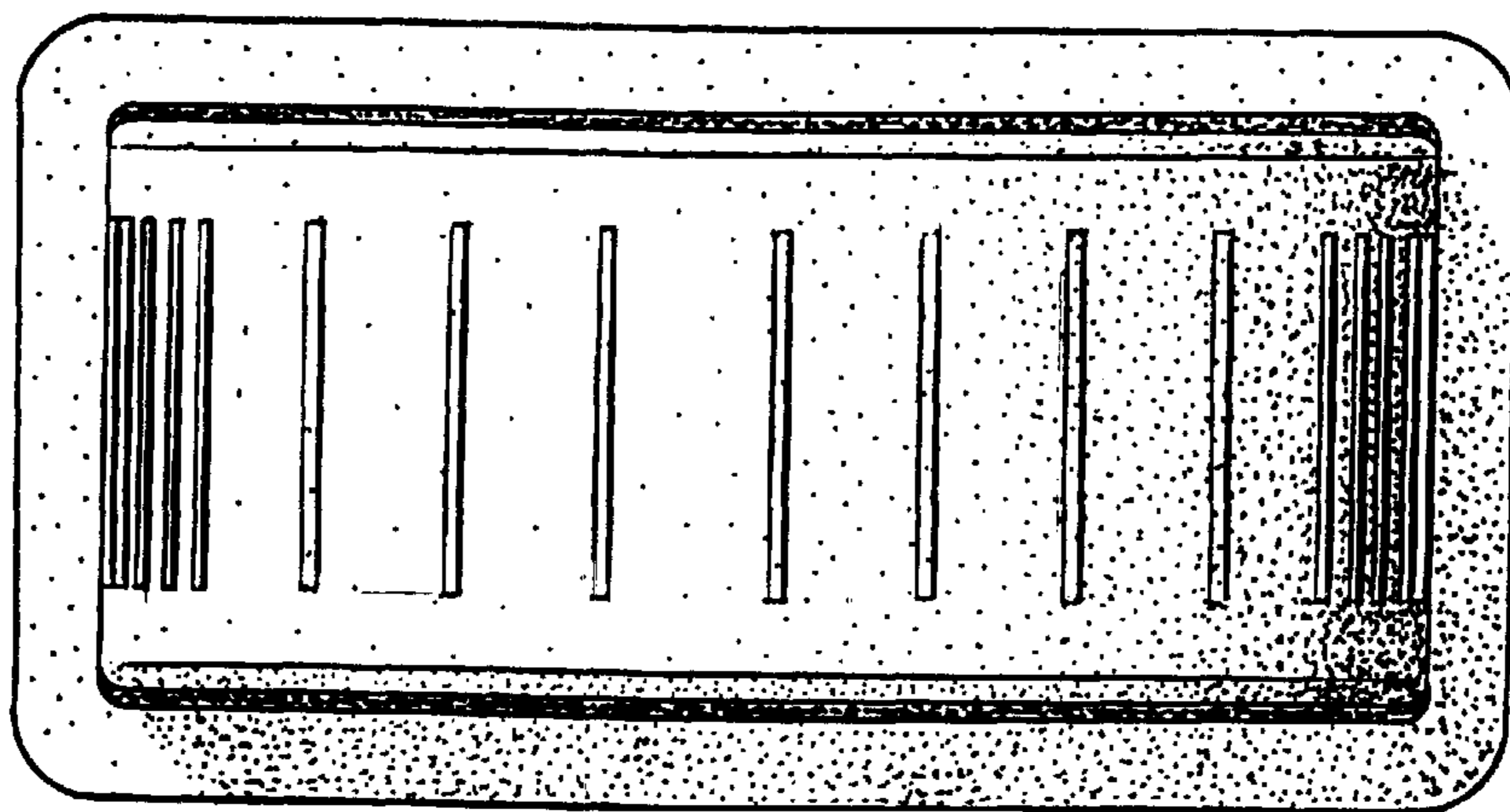

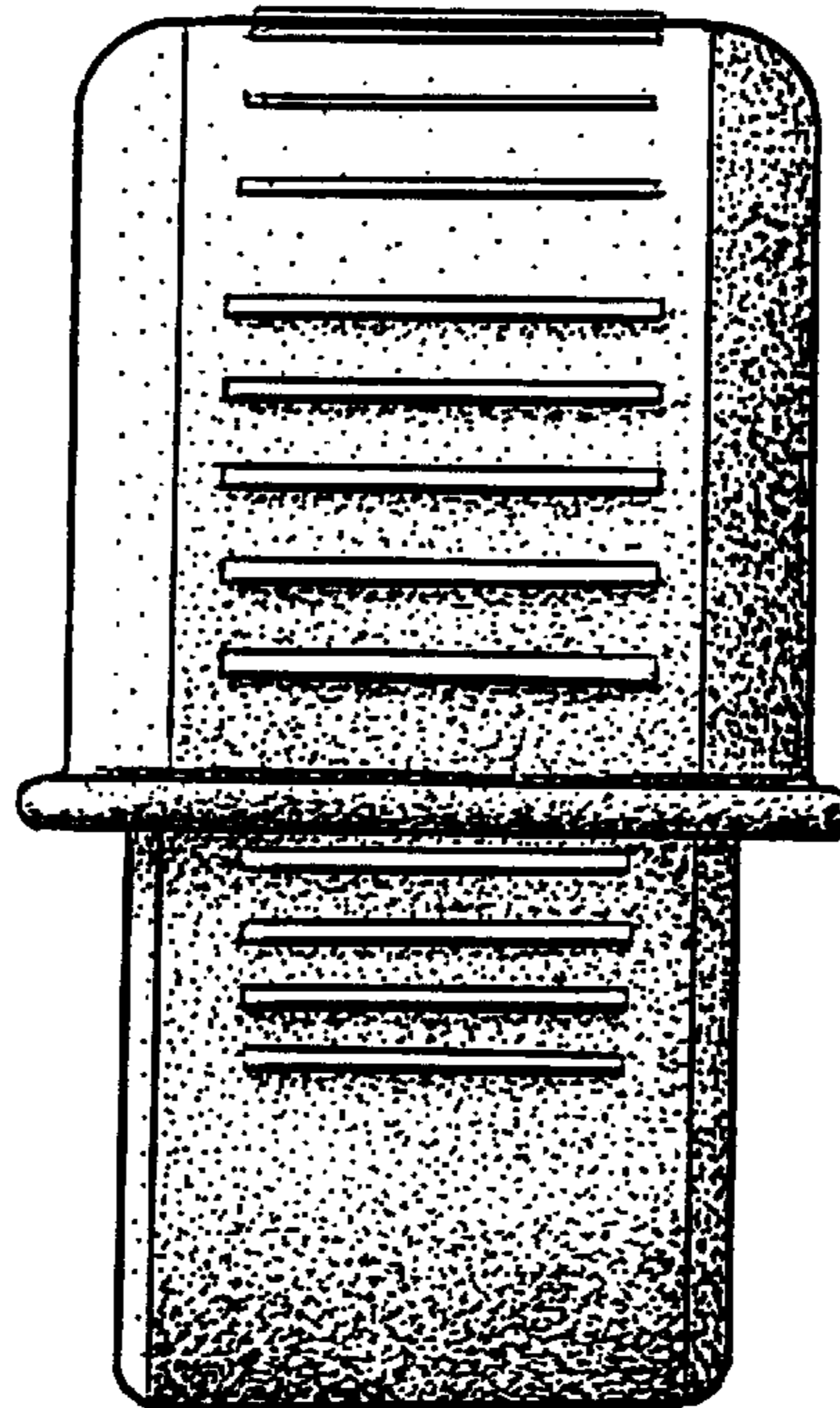
