(57) **CLAIM**

The ornamental design for a thermowell, as shown and described.

DESCRIPTION

FIG. 1 is a side view of a thermowell according to the present invention.

FIG. 2 is a pictorial view of the thermowell shown in FIG. 1.

FIG. 3 is a top view of the probe shown in FIG. 1.

FIG. 4 is a bottom view of probe shown in FIG. 1.

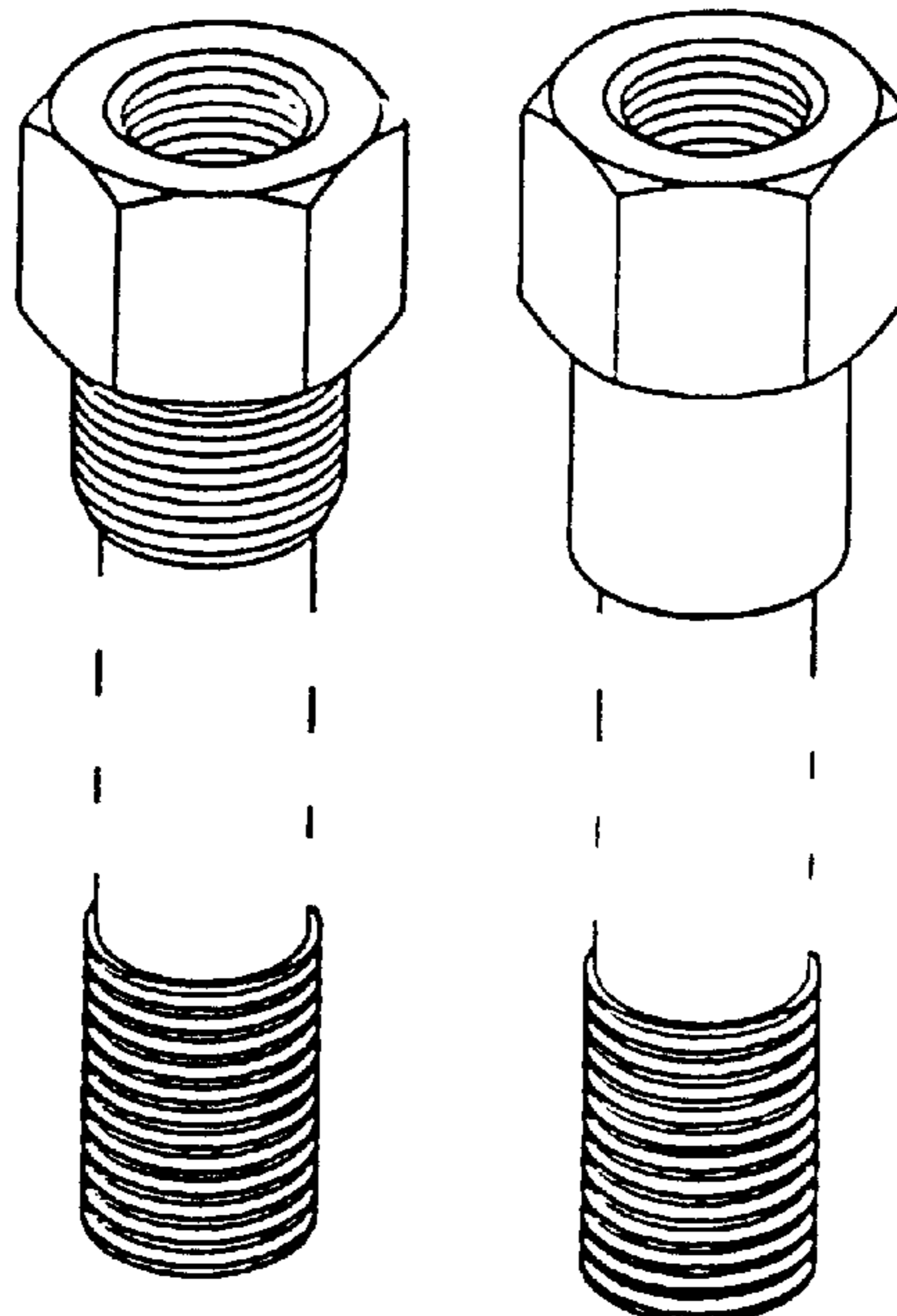
FIG. 5 is a side view of another thermowell according to the present invention; and,

FIG. 6 is a pictorial view of the thermowell shown in FIG. 5.

The FIG. 3 top view and the FIG. 4 bottom view of the thermowell are also the top view and bottom view for the embodiment shown in FIGS. 5 and 6.

The broken line showing of the upper cylindrical body beneath the hex head and the axial length of the lower cylindrical body between the upper cylindrical body and the fins is for illustrative purposes only and forms no part of the claimed design.

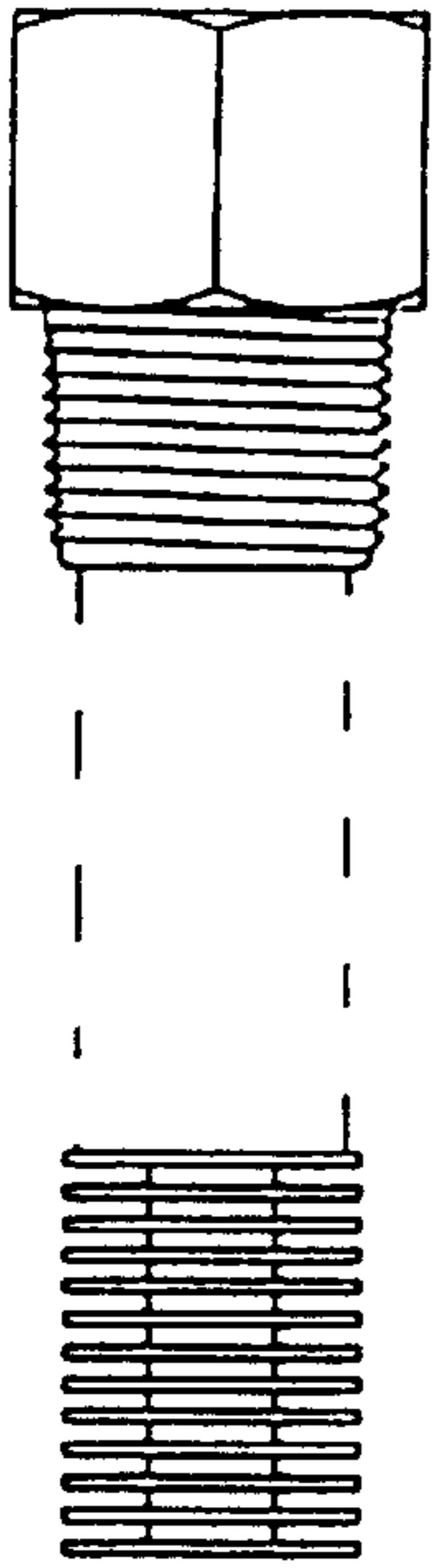

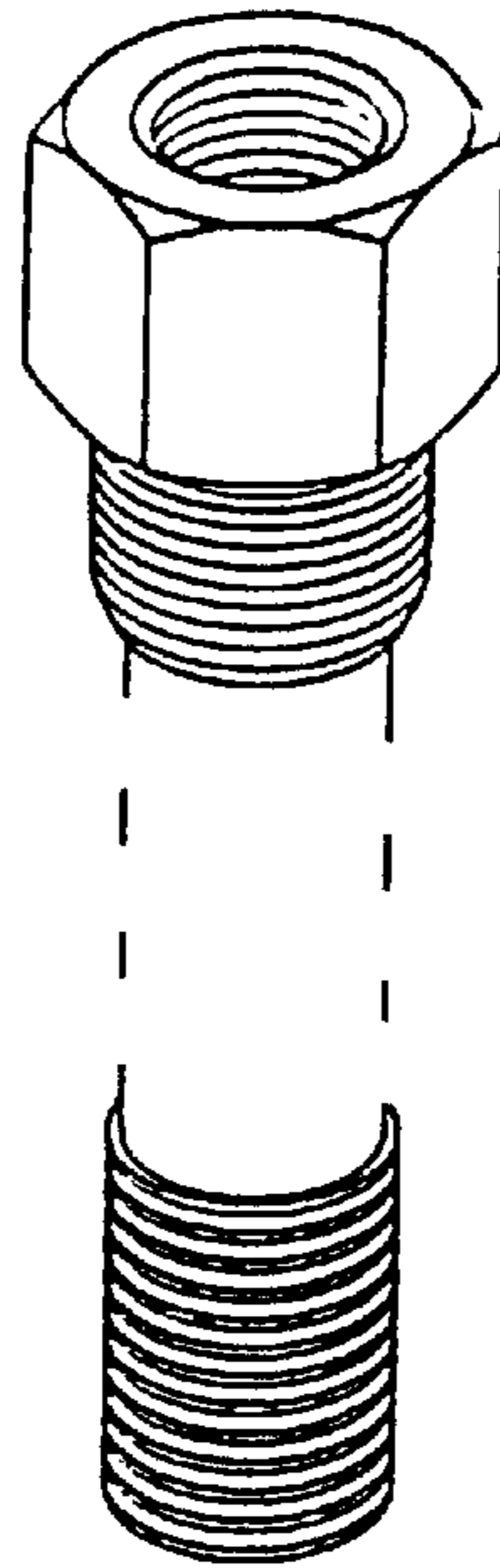

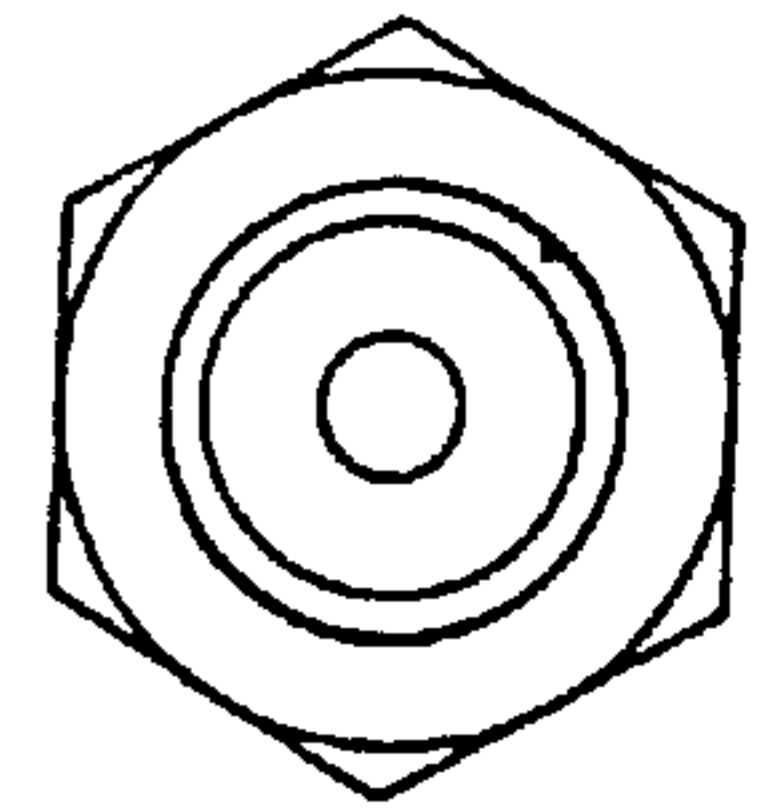

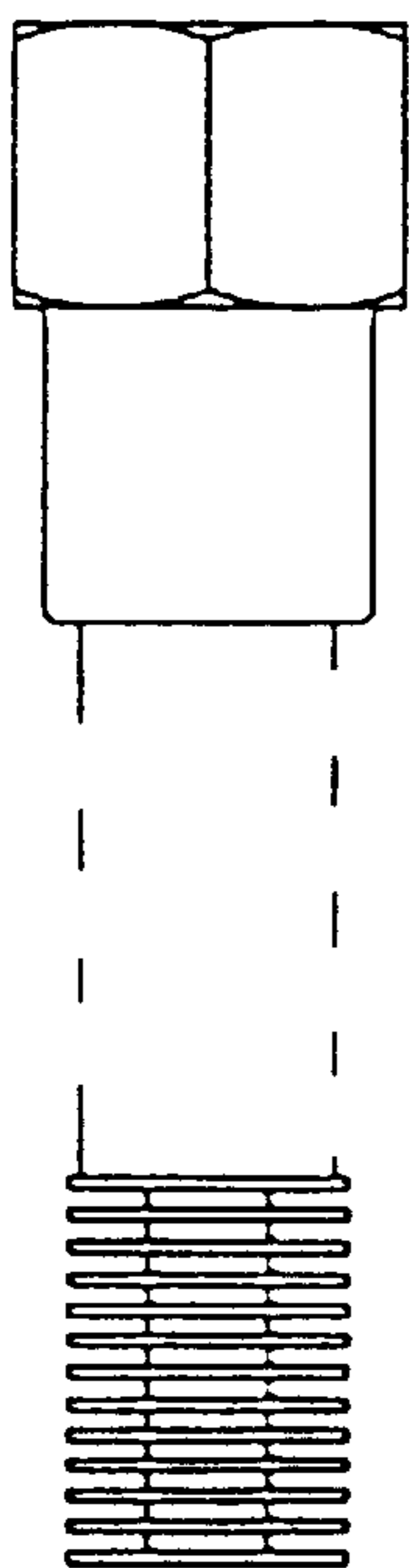

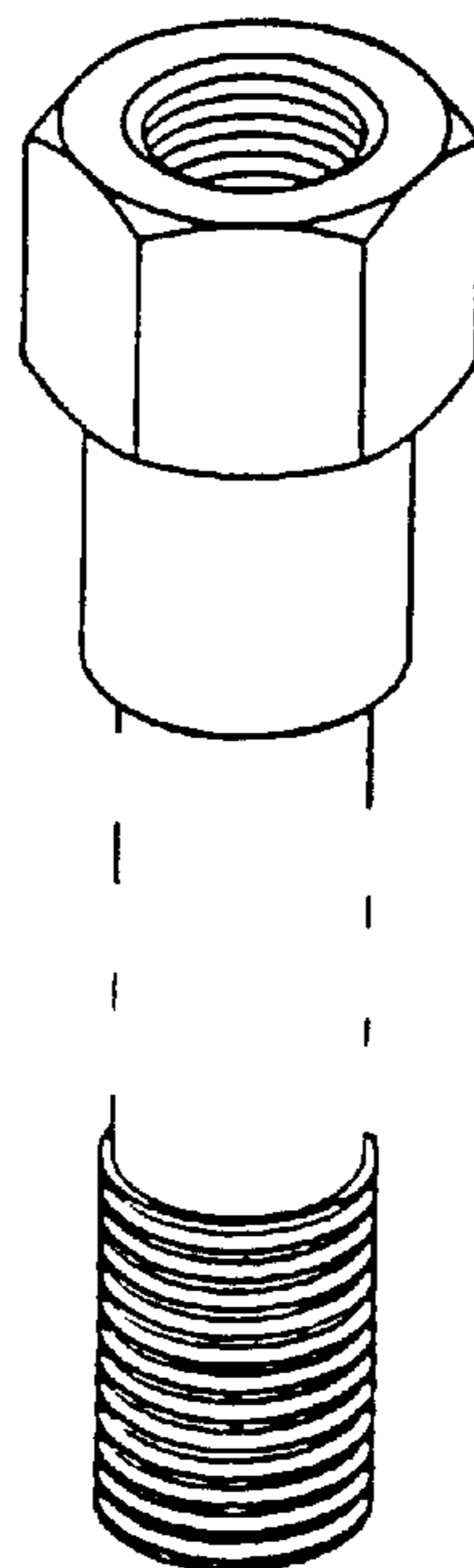

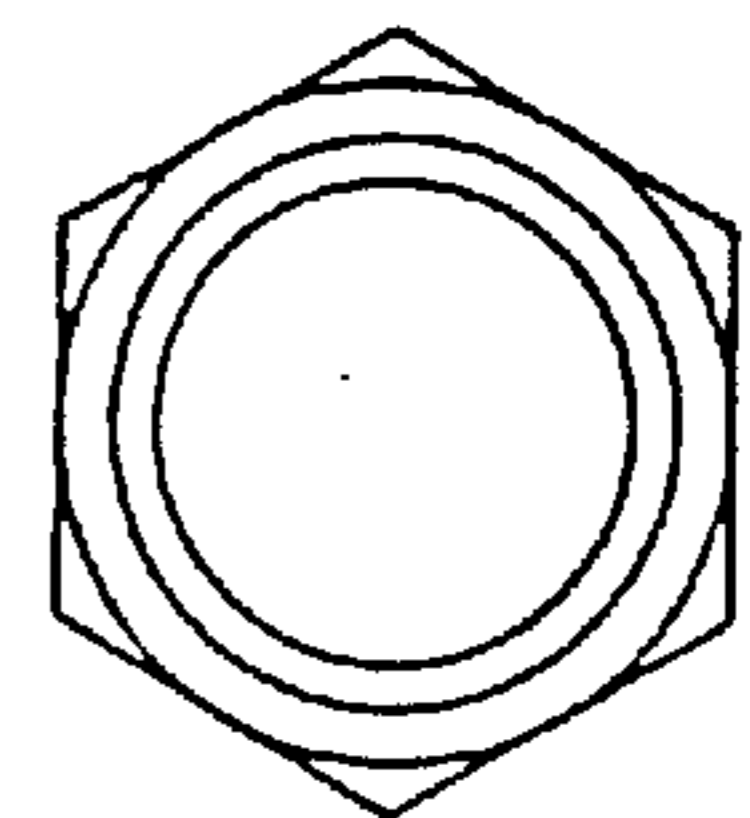
