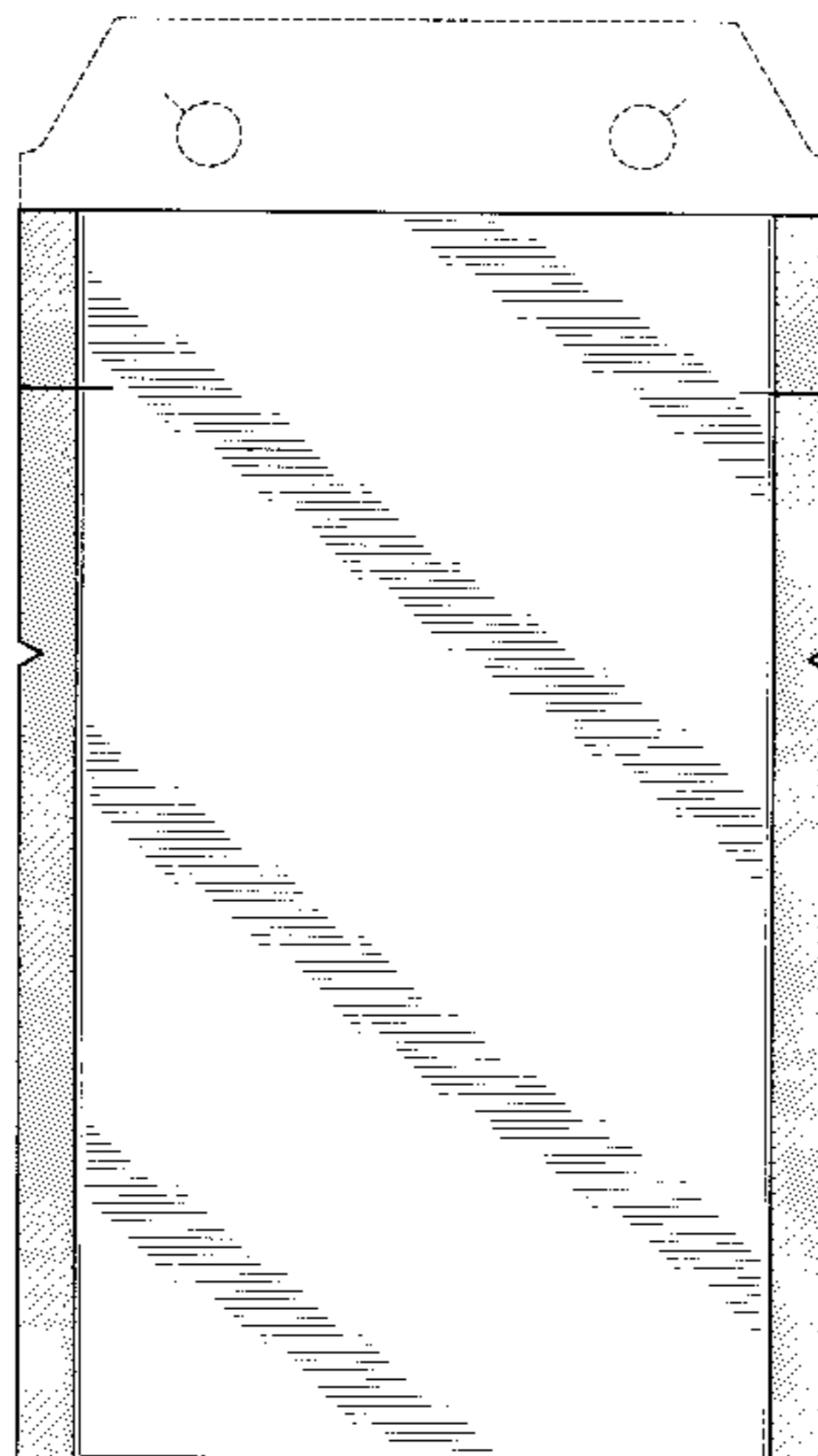
(57) **CLAIM**

The ornamental design for a sealable bag, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a sealable bag showing my new design.
 FIG. 2 is a front elevational view of a sealable bag showing a first alternative embodiment.
 FIG. 3 is a front elevational view of a sealable bag showing a second alternative embodiment.
 FIG. 4 is a front elevational view of a sealable bag showing a third alternative embodiment; and,
 FIG. 5 is a front elevational view of a sealable bag showing a fourth alternative embodiment.
 The broken lines shown in the drawings are for illustrative purposes only and form no part of the claimed design.

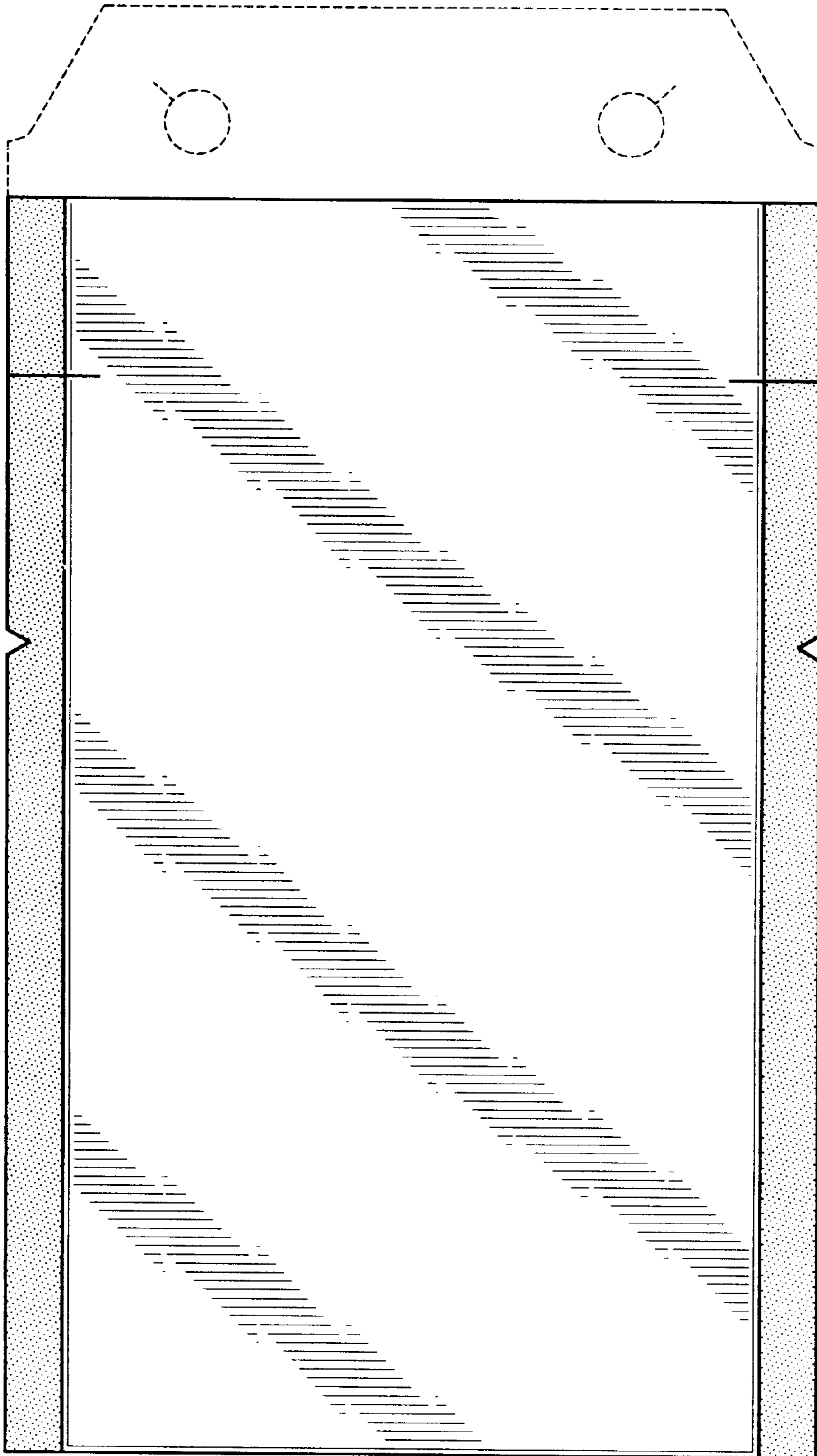

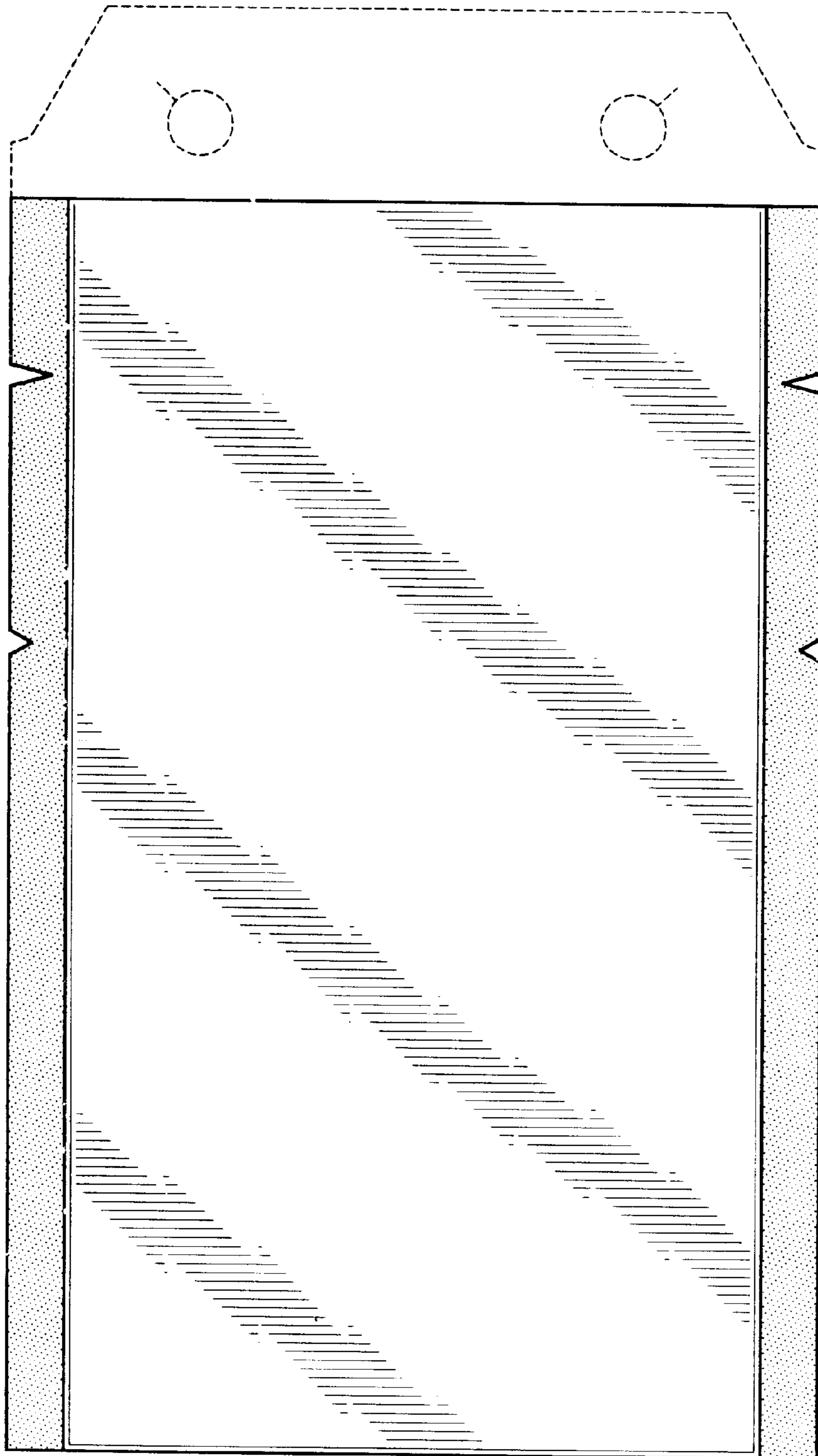

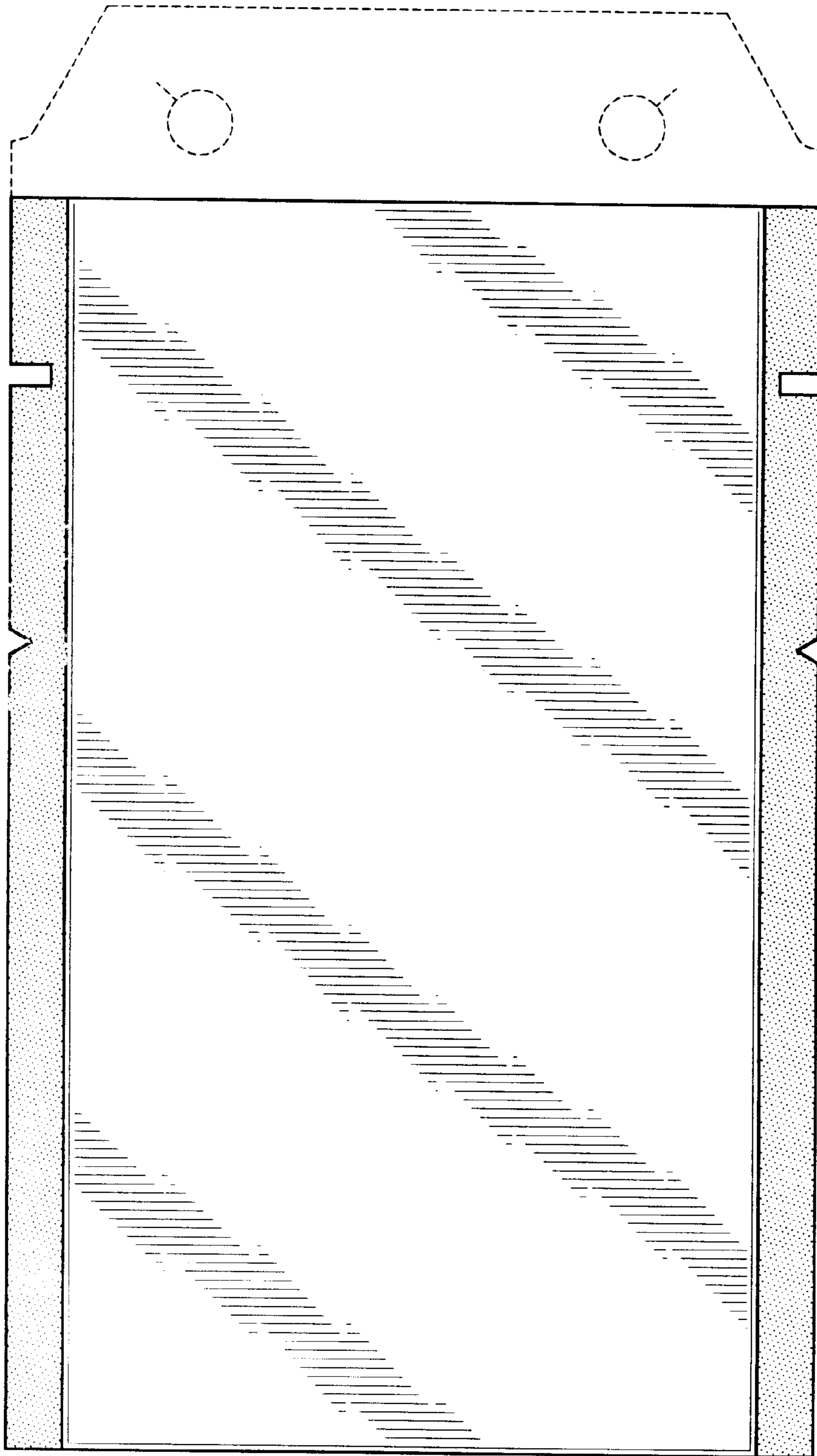

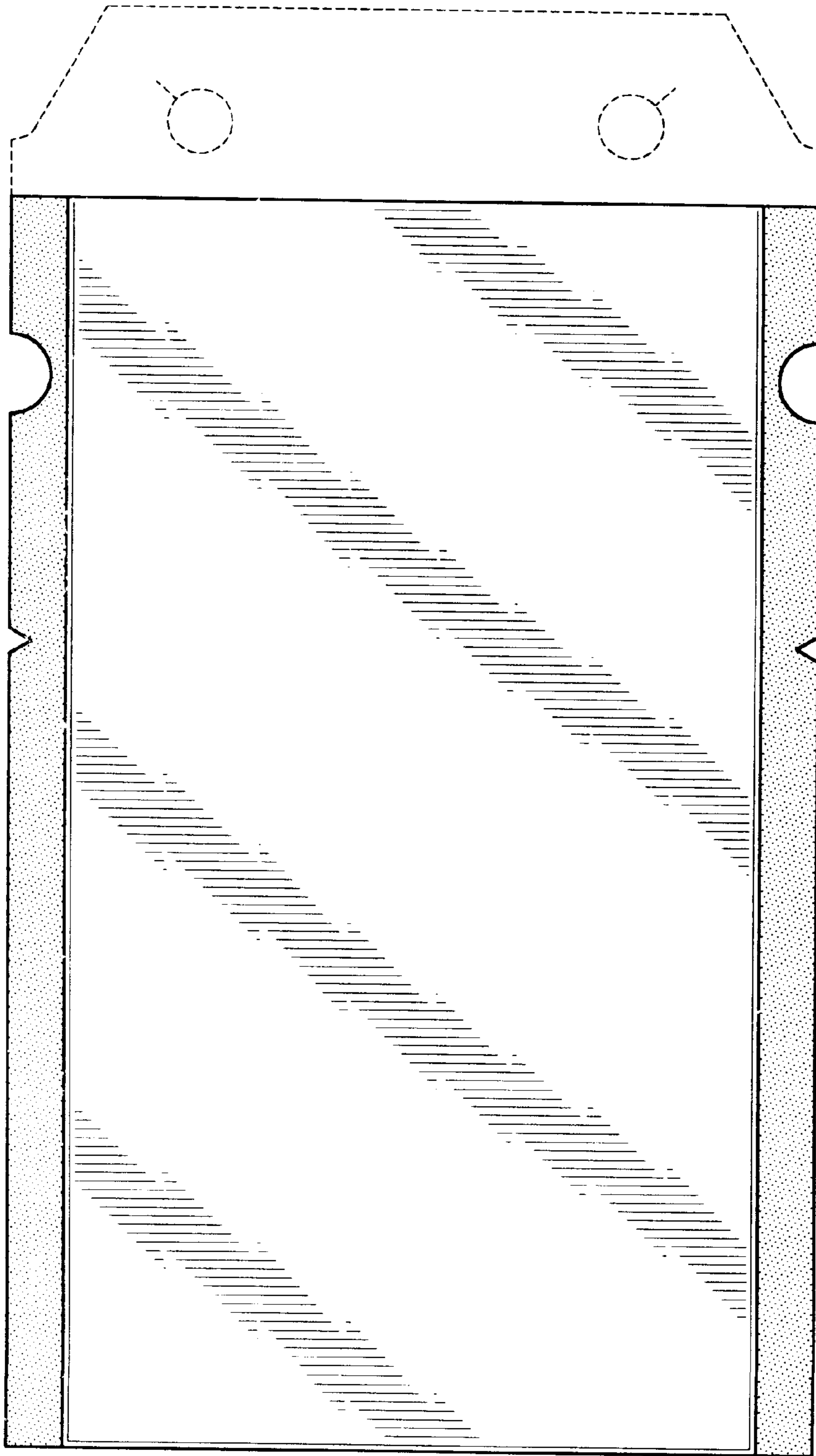

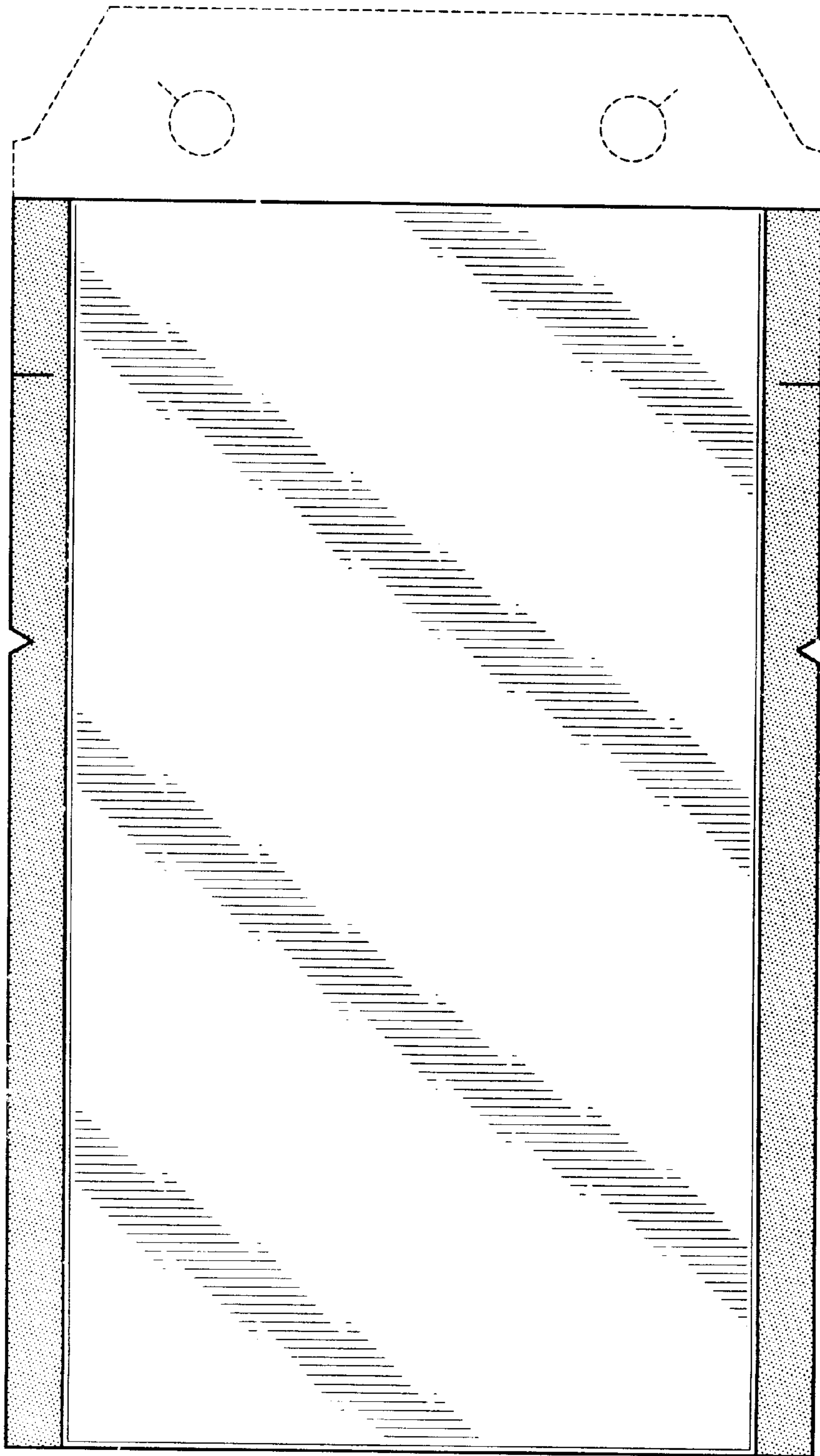
