FIG. 4 is a second side view of the decorative box shown in FIG. 1;

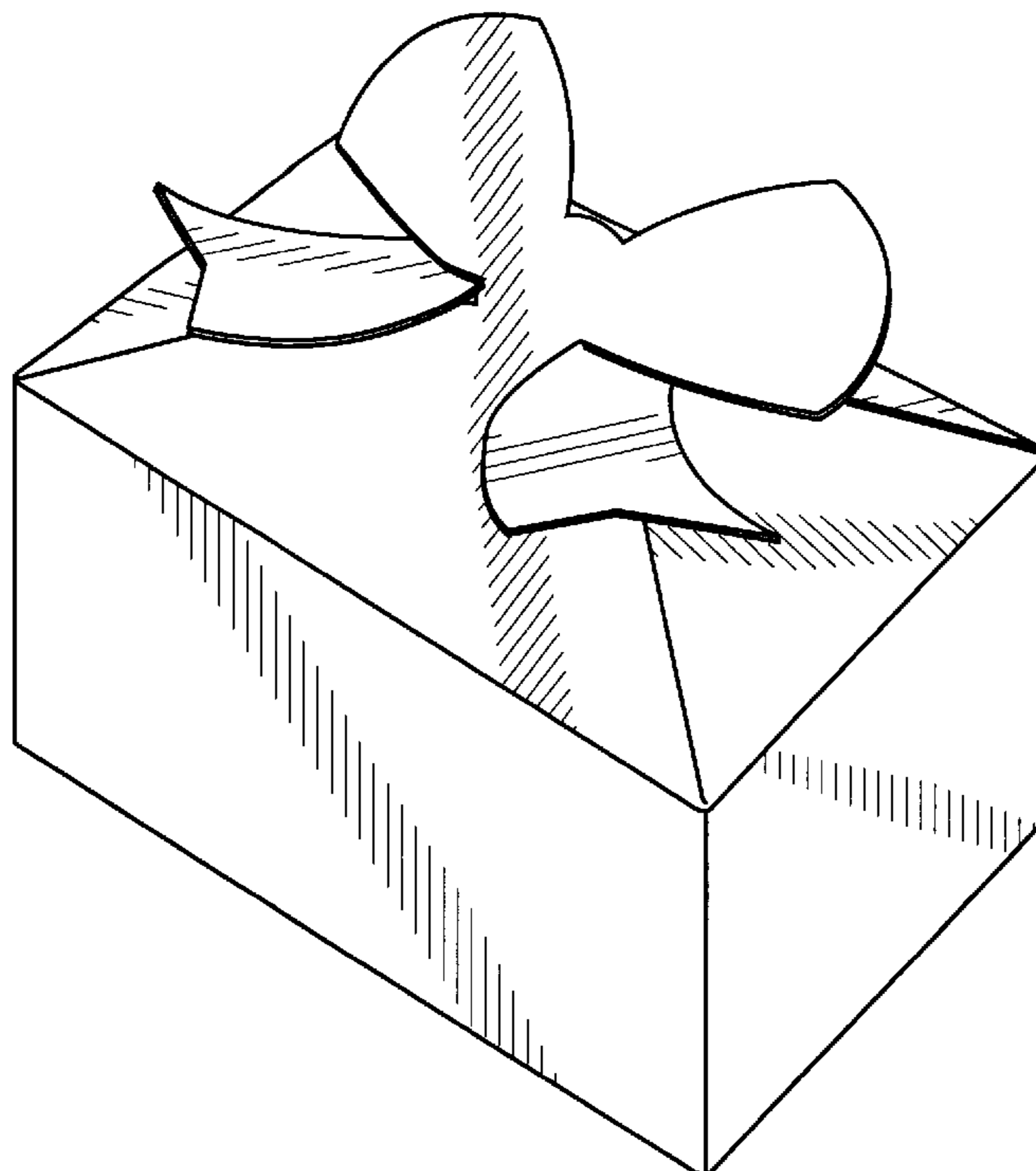
FIG. 5 is a third side view of the decorative box shown in FIG. 1;

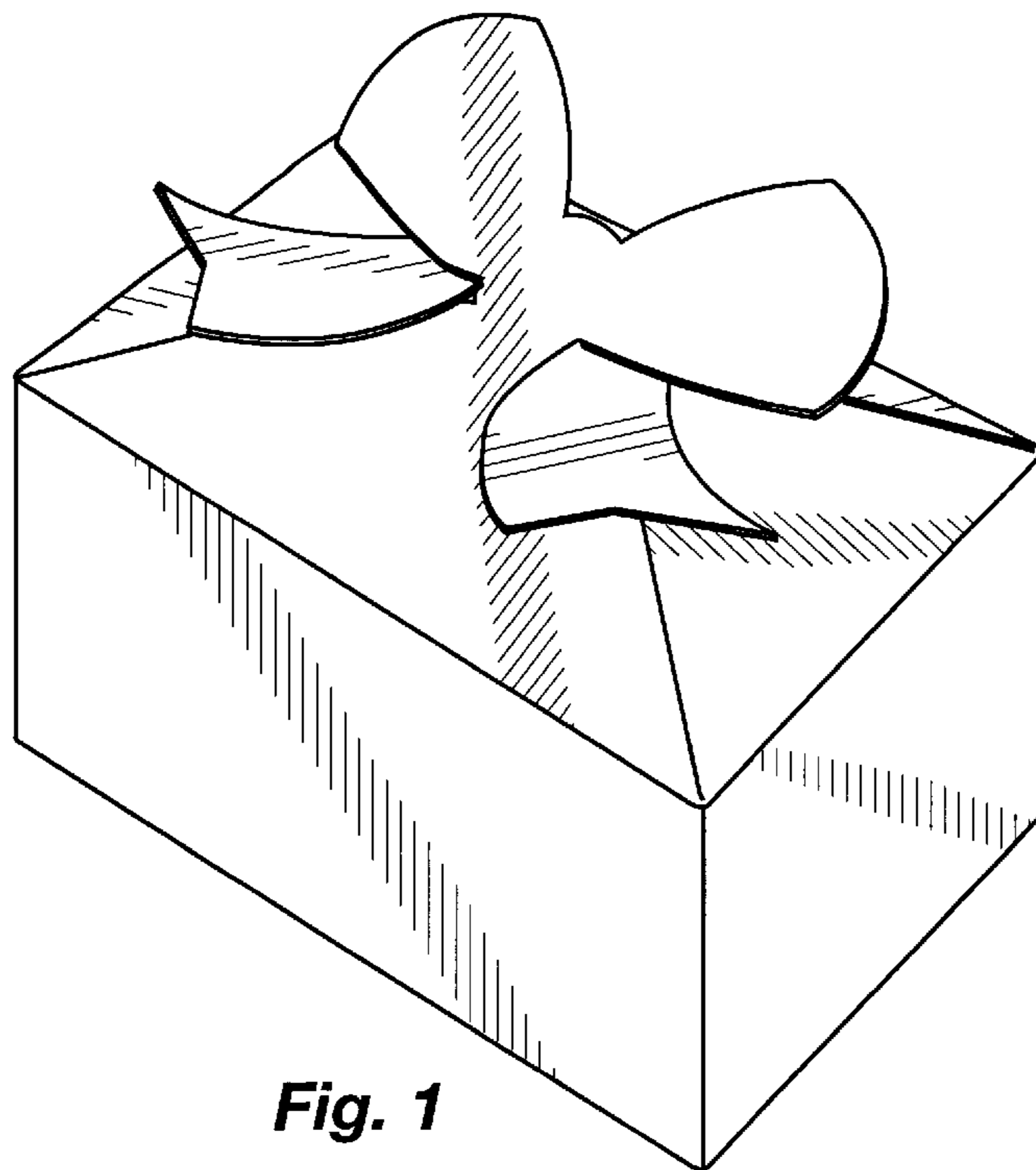

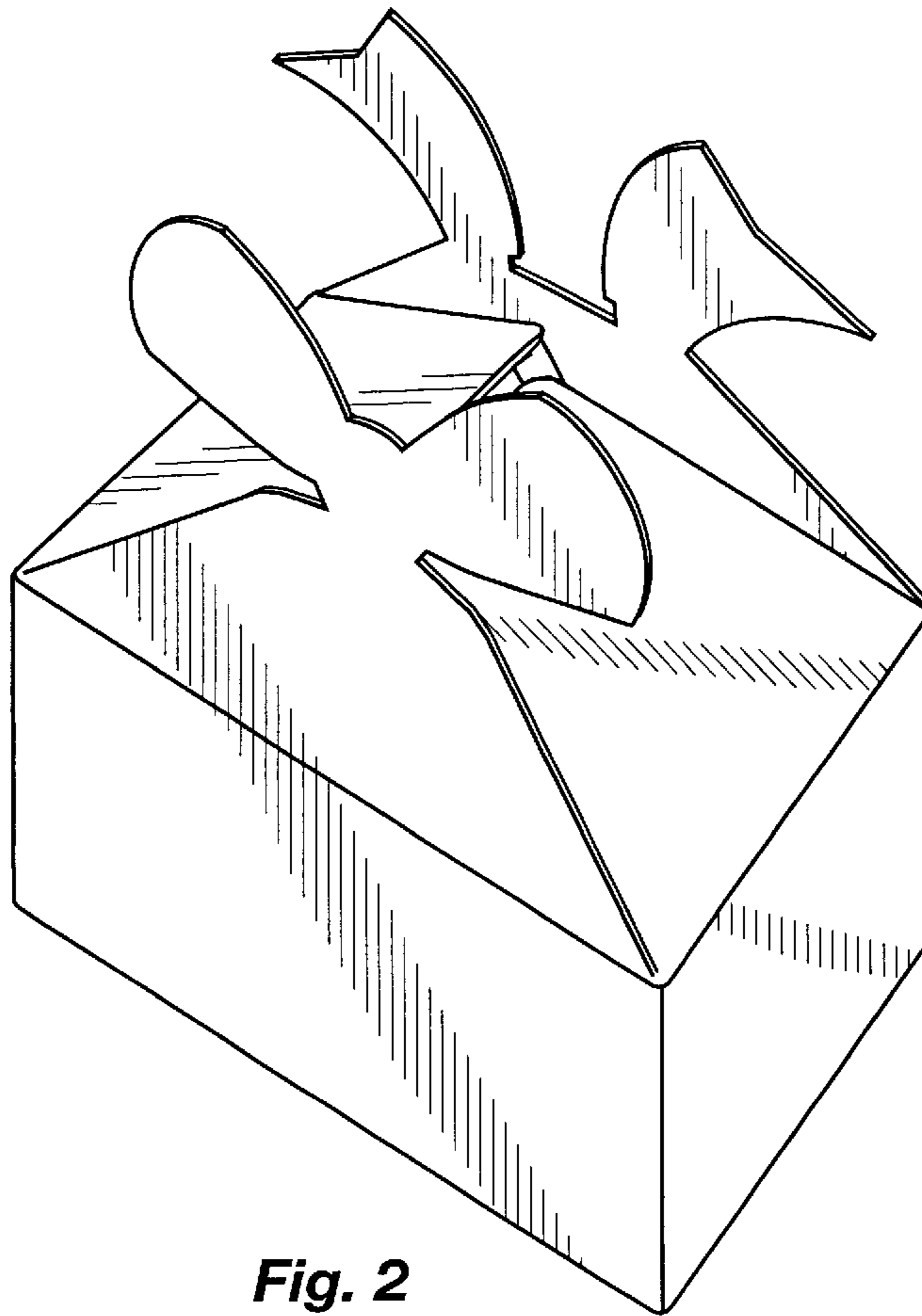

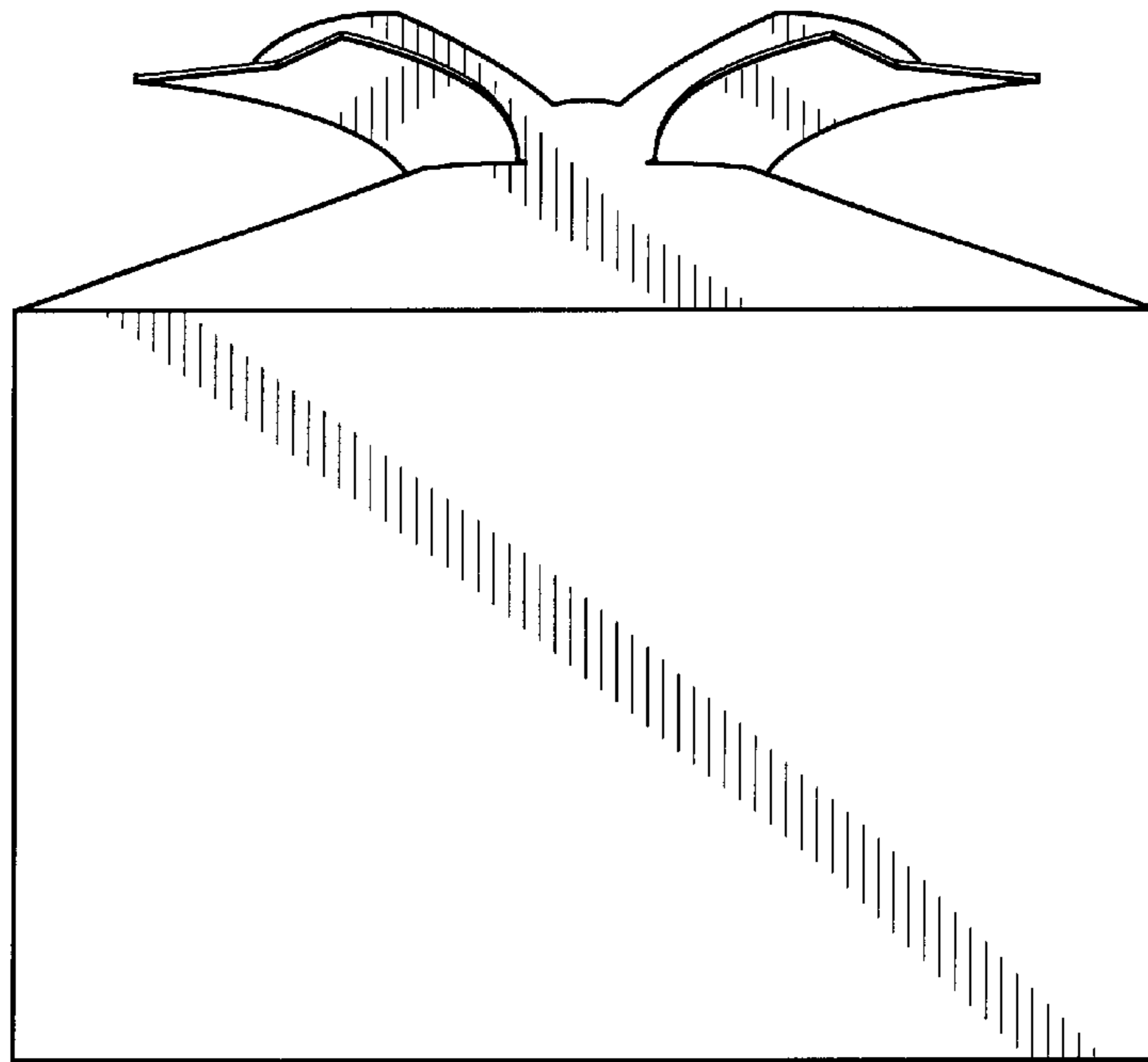

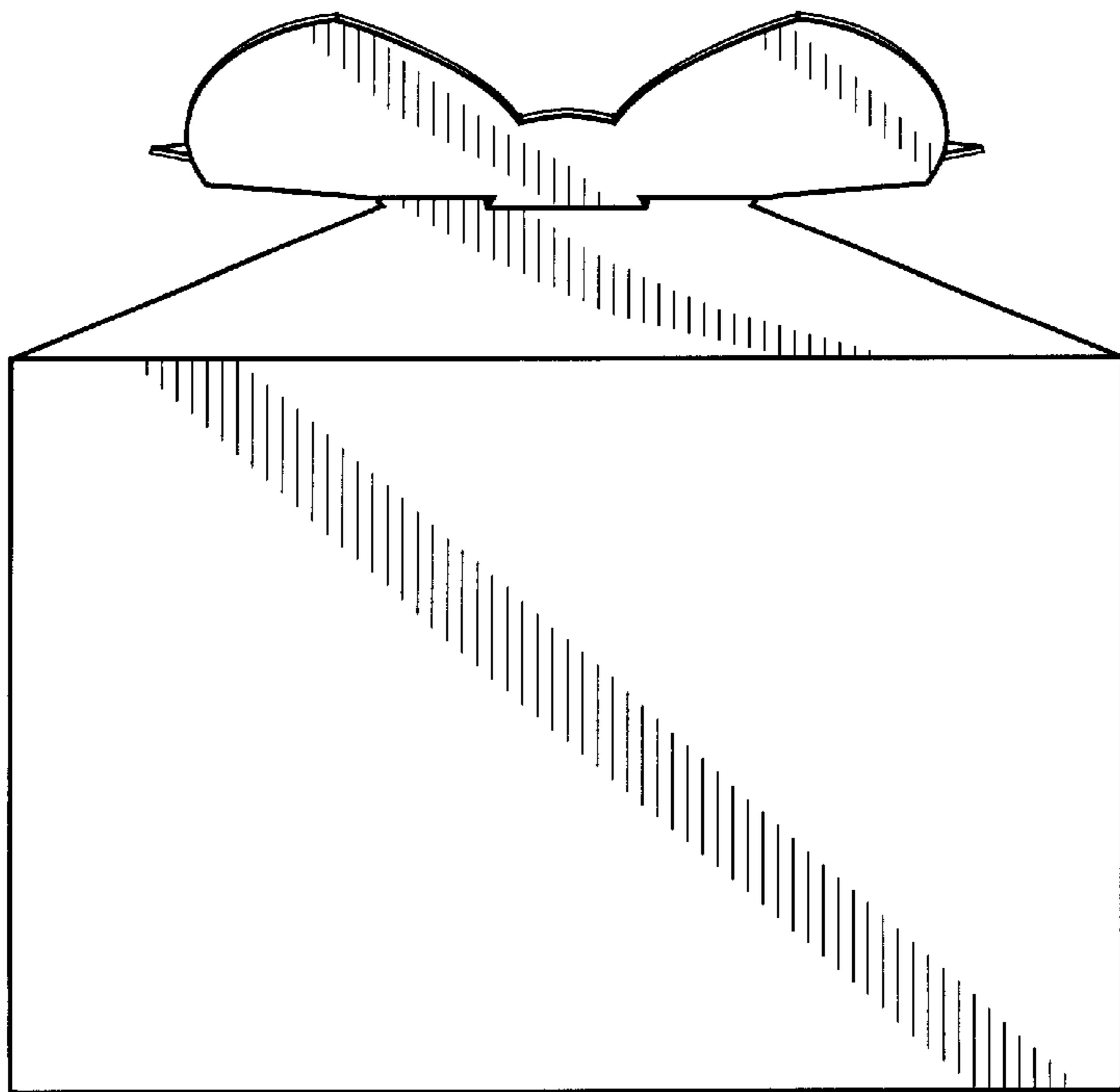

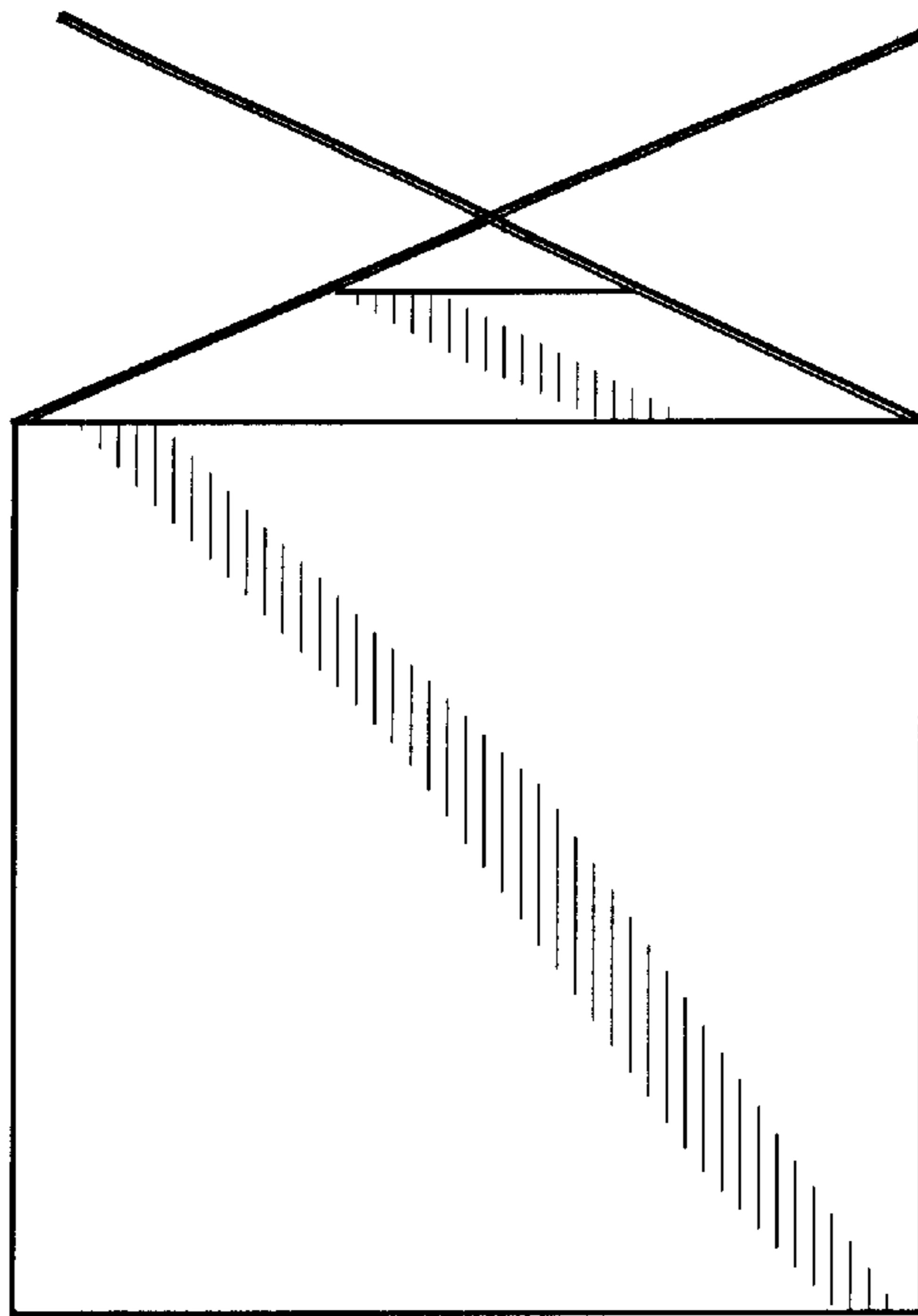

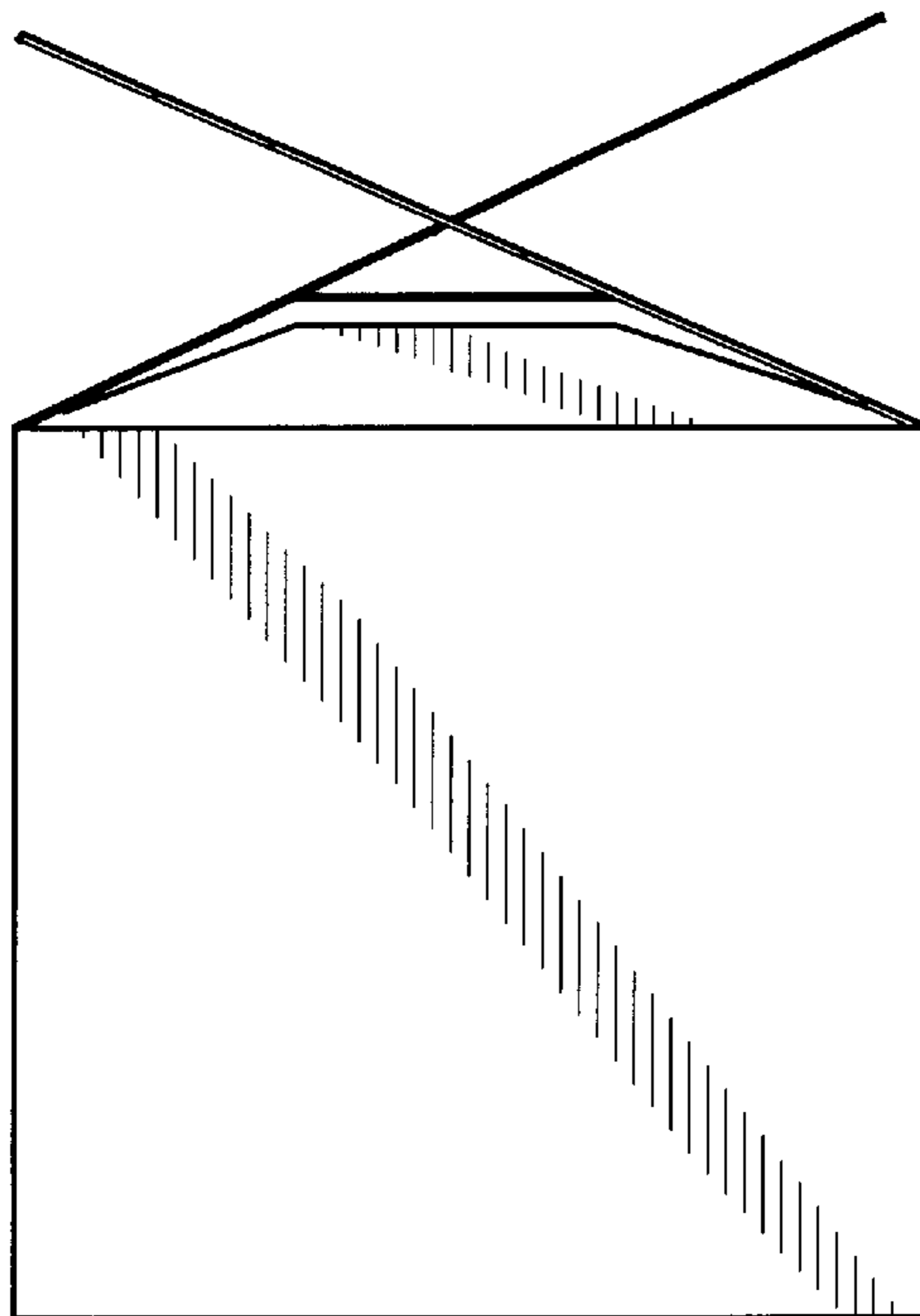

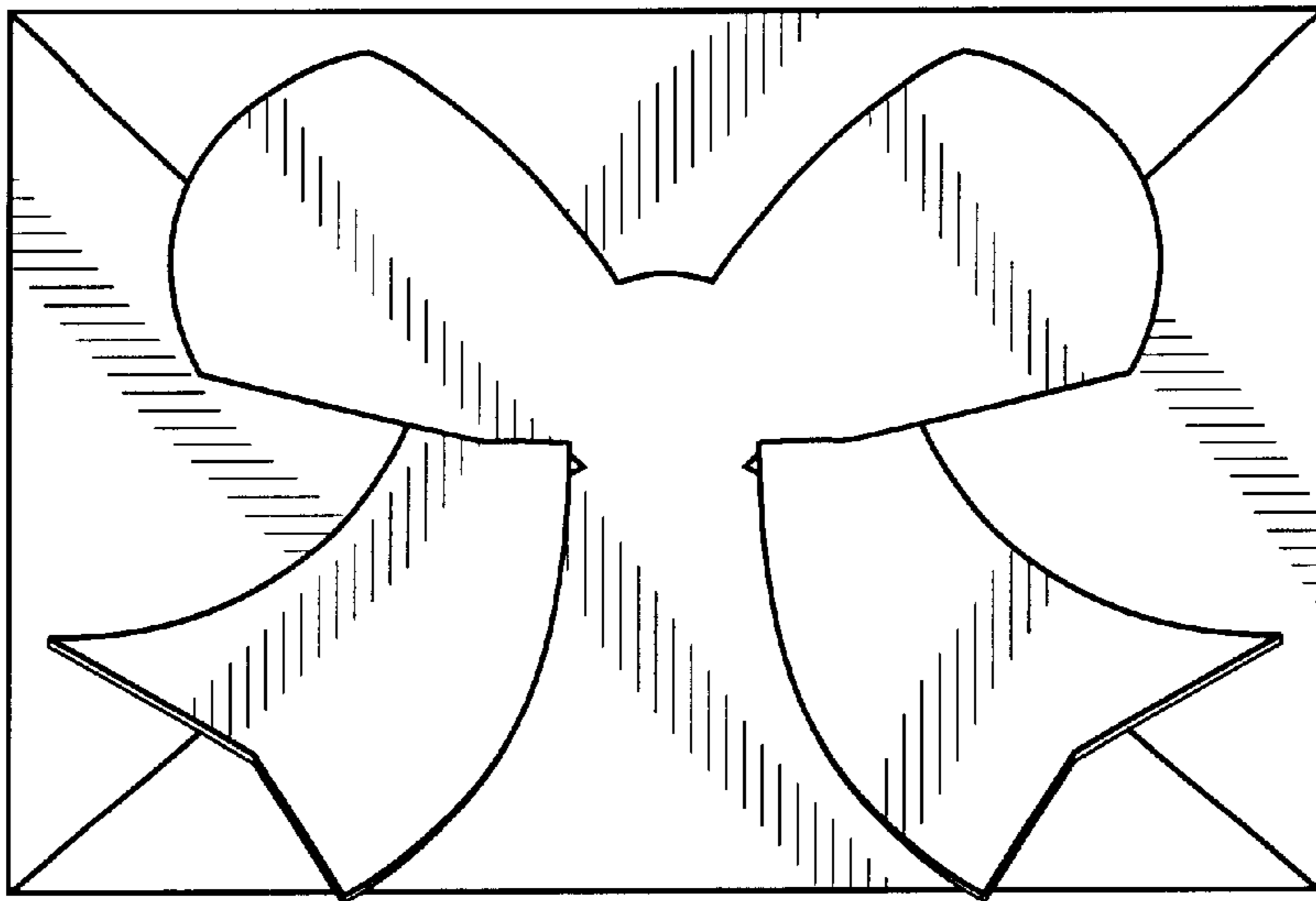

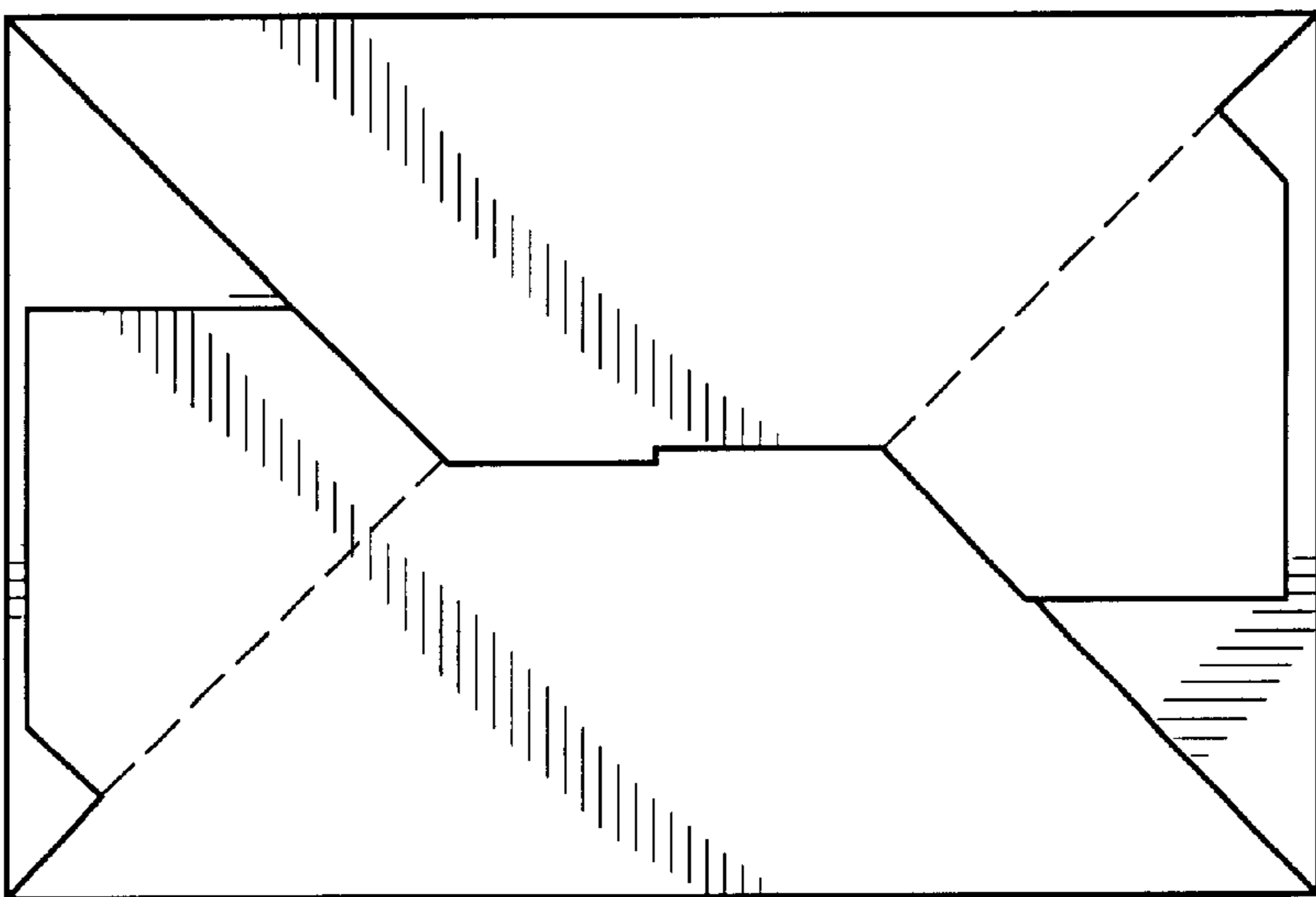
