FIG. 6 is a top plan view thereof;



FIG. 7 is a bottom view thereof;


FIG. 8 is a perspective view thereof with the lid in open condition; and,

FIG. 9 is a perspective view of the top, rear and left side thereof with the stand in raised condition.









***Fig. 1.***








