The ornamental design for a computer front bezel, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a computer front bezel of our new design;

FIG. 2 is a front elevational view thereof;

FIG. 4 is a right side elevational view thereof;

FIG. 5 is a top plan view thereof;

FIG. 6 is a bottom plan view thereof;

FIG. 7 is a view similar to FIG. 1 with the computer front bezel being mounted to a computer case which is shown in broken lines for illustrative purposes only and forms no part of the claimed design;

FIG. 8 is a perspective view of a computer front bezel in accordance with an alternative embodiment of our new design;

FIG. 9 is a front elevational view of FIG. 8;

FIG. 10 is a rear elevational view of FIG. 8;

FIG. 11 is a left side elevational view of FIG. 8;

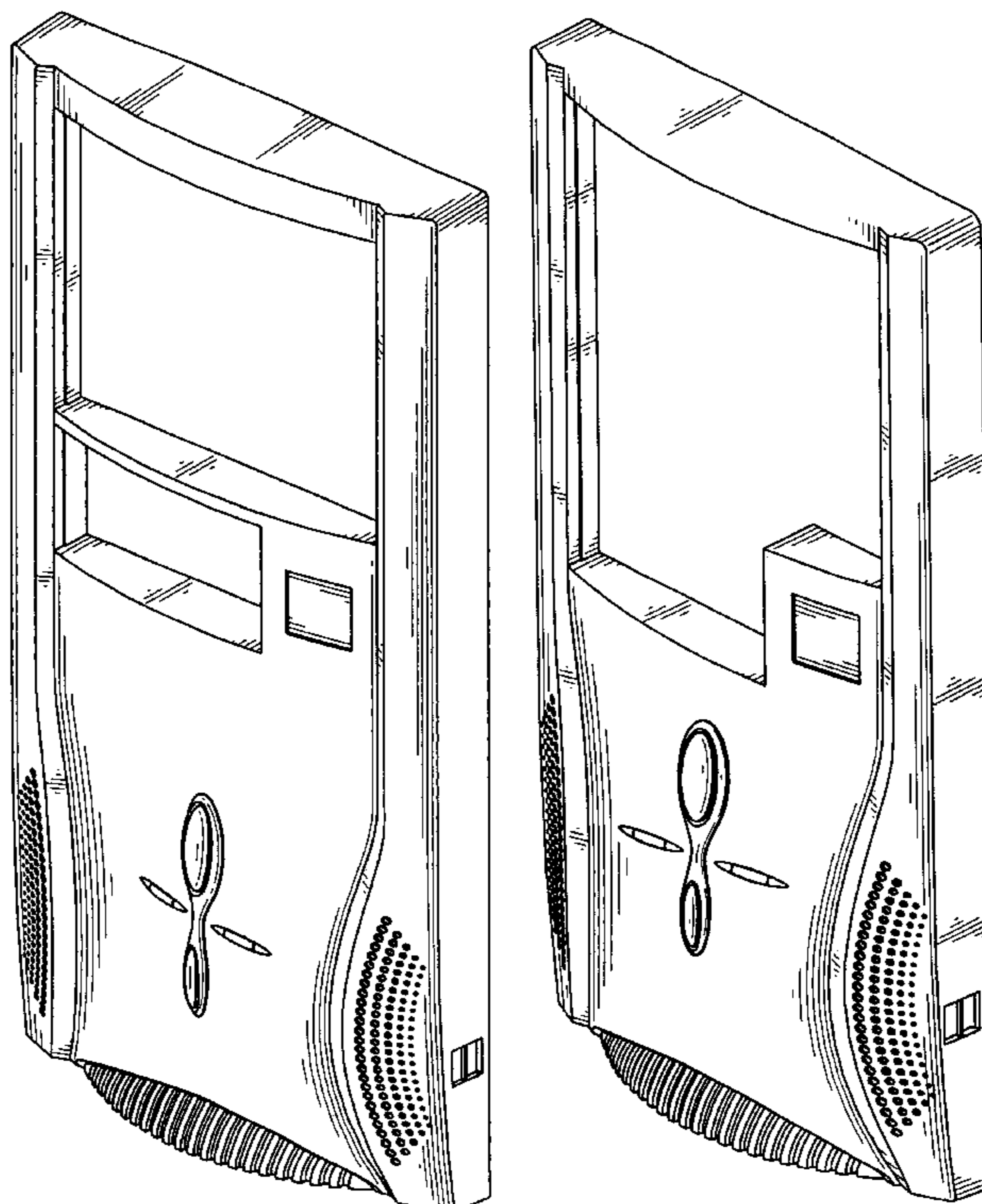
FIG. 12 is a right side elevational view of FIG. 8;

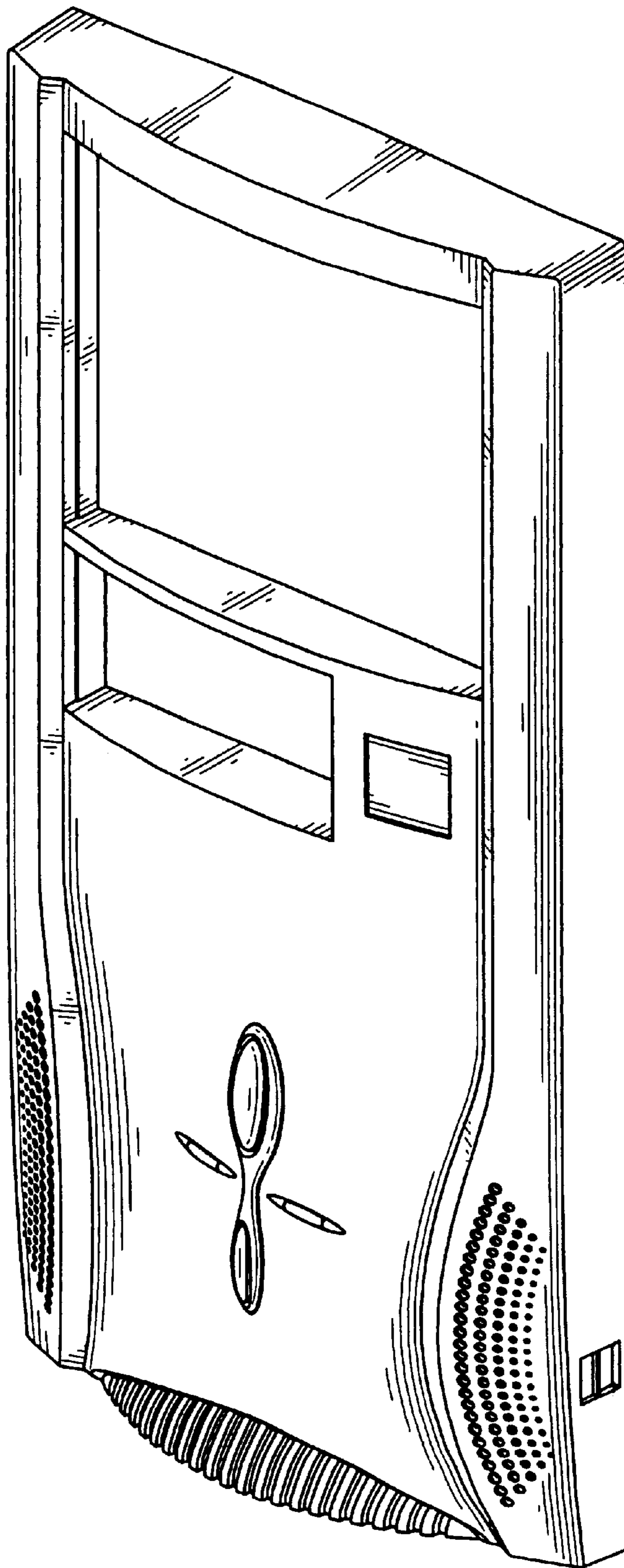

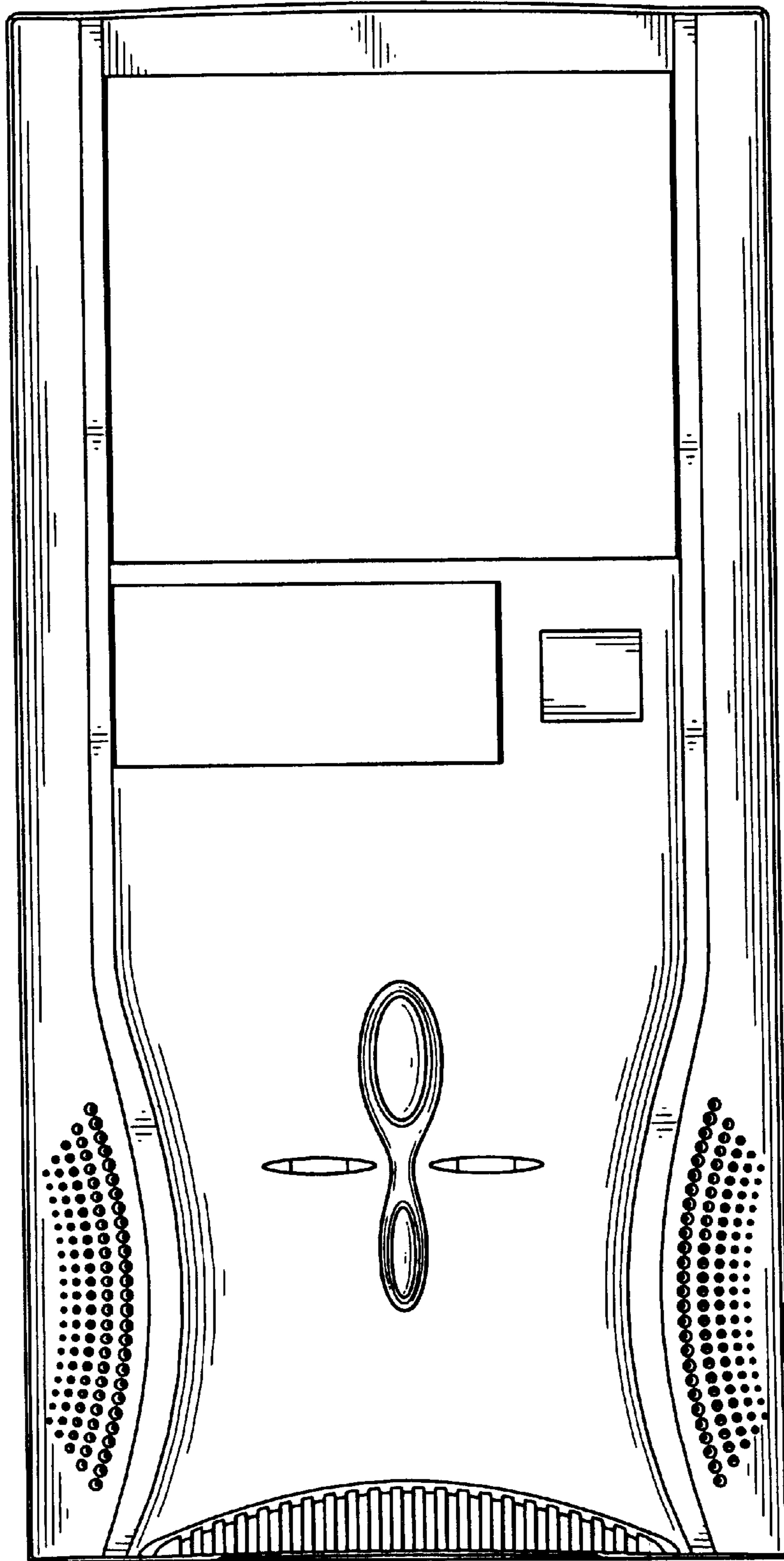

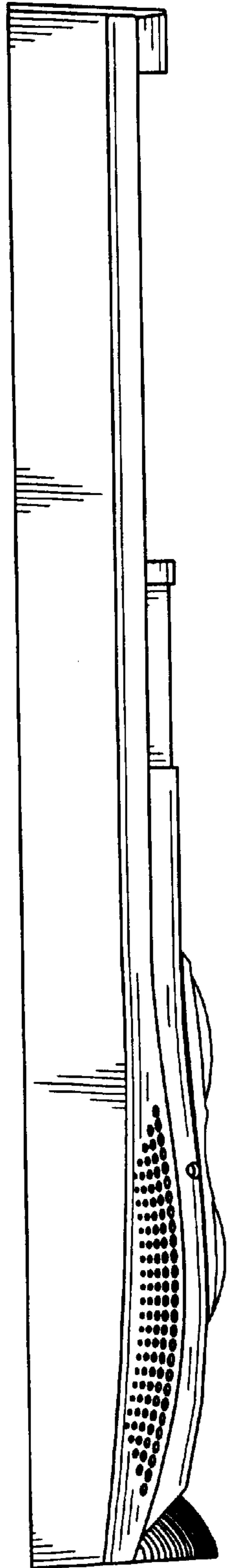

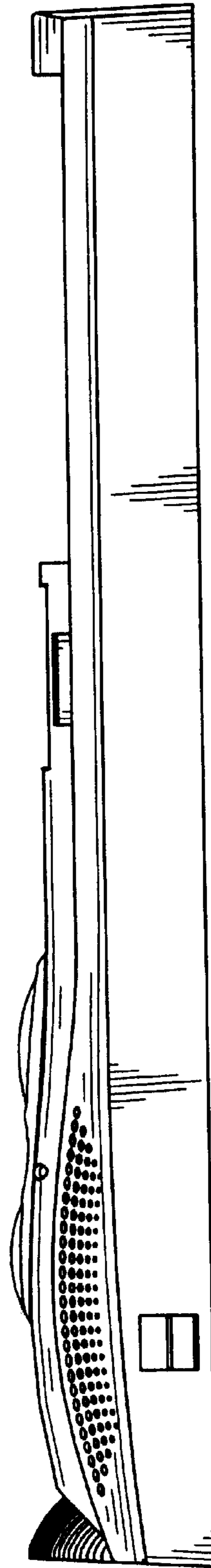

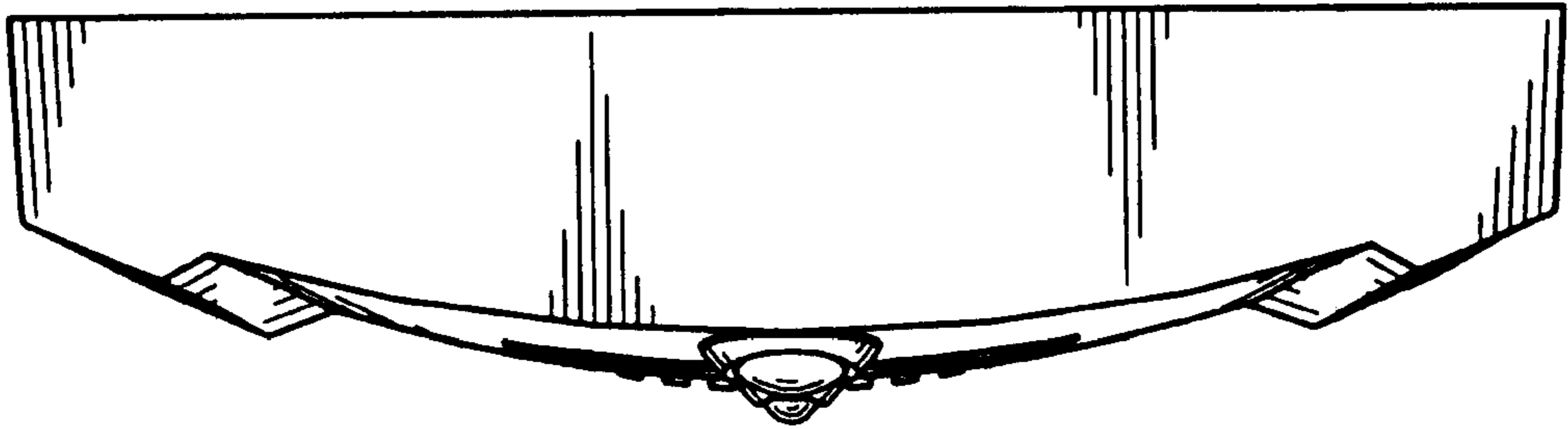

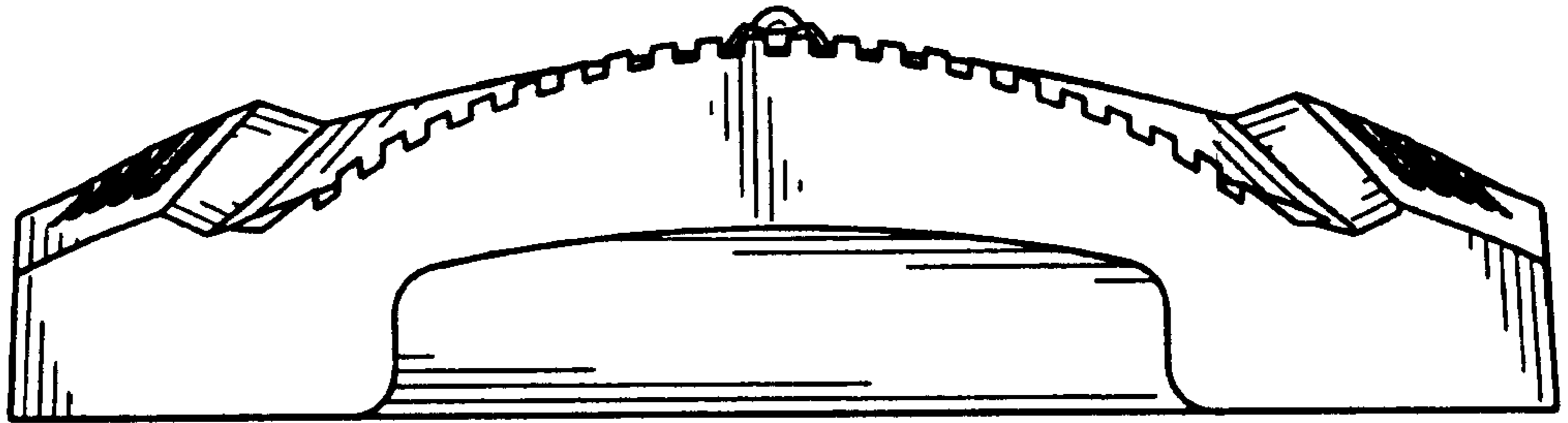

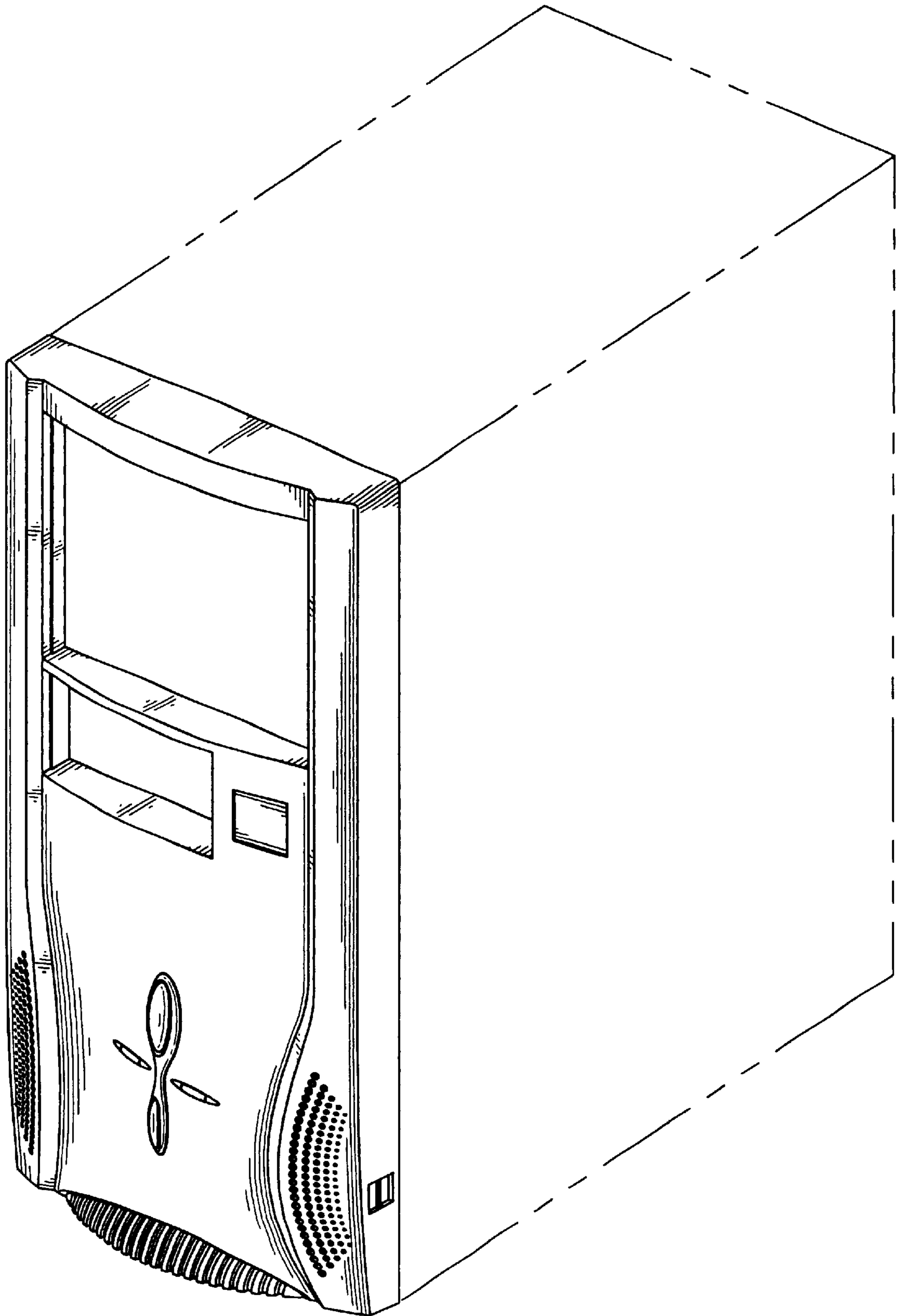

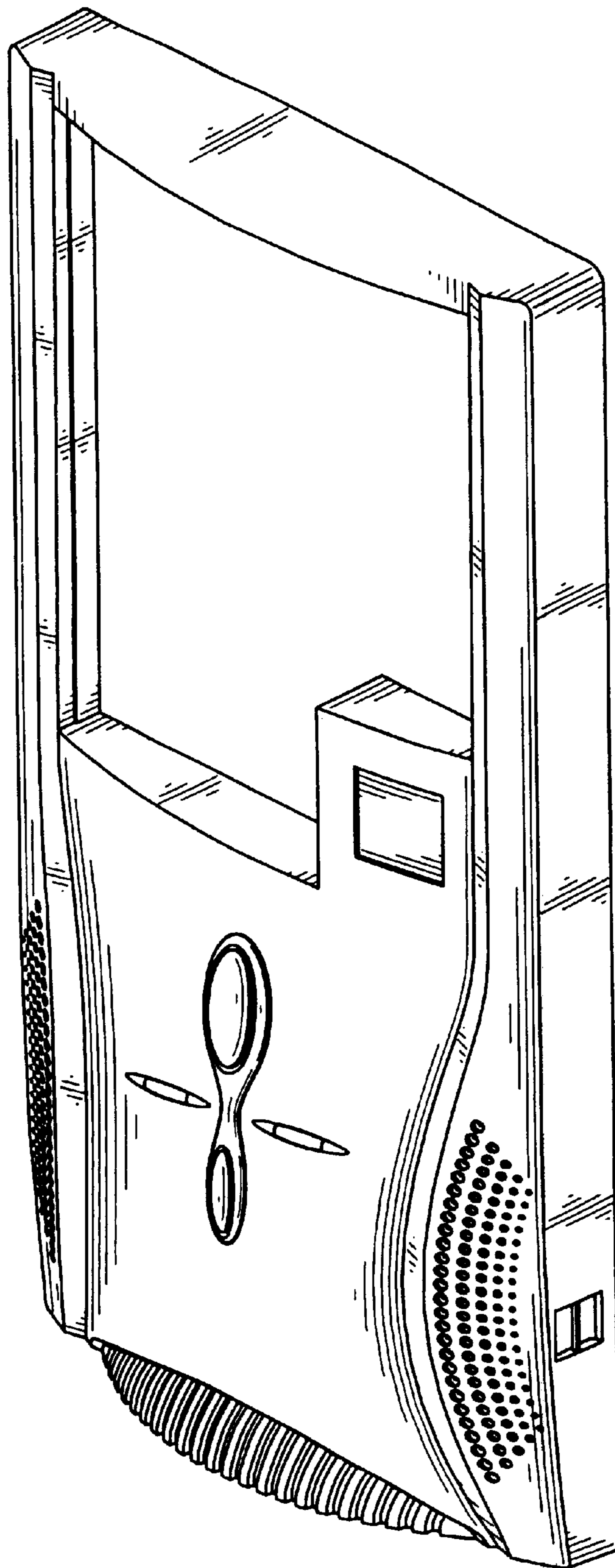

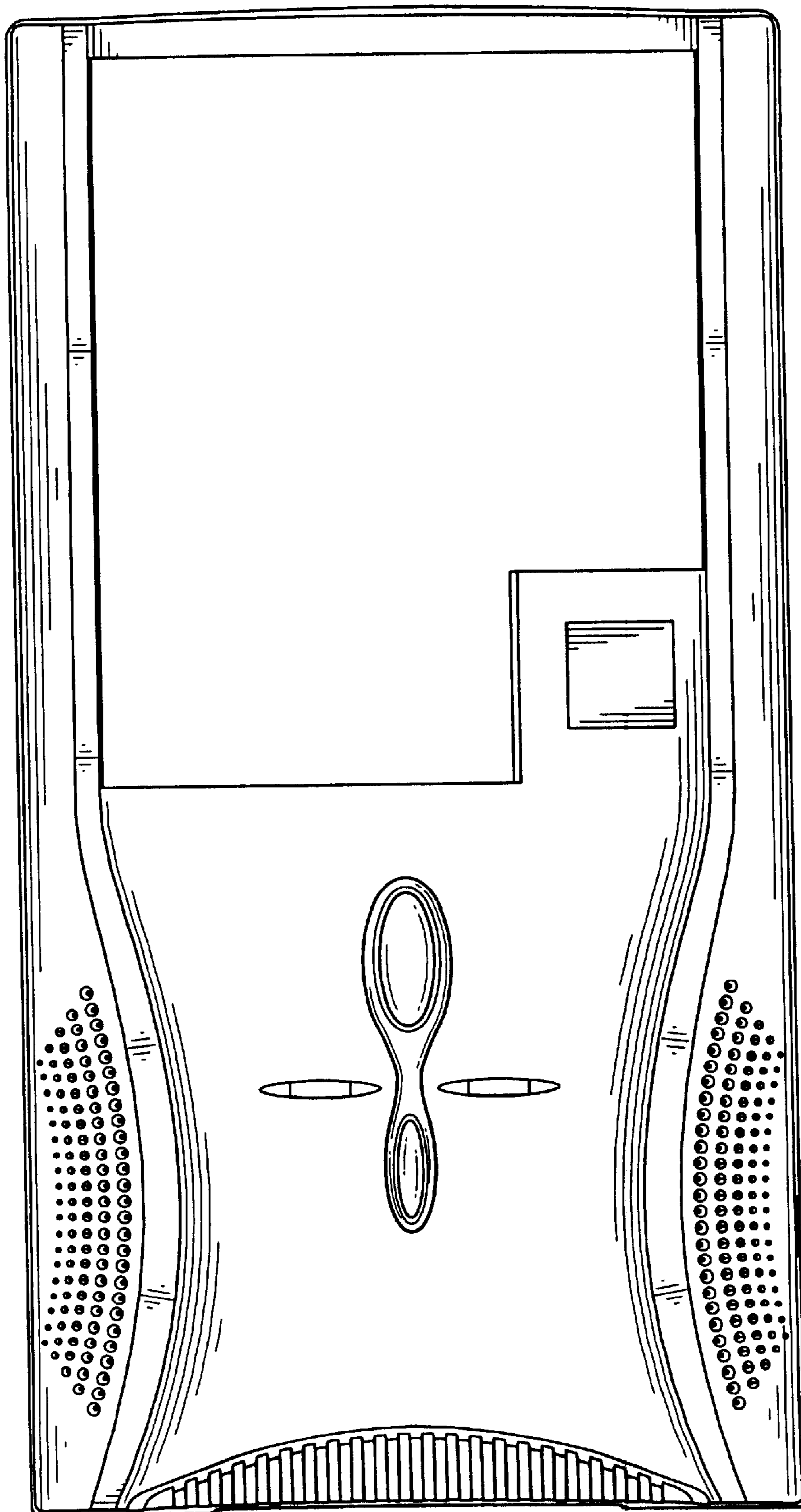

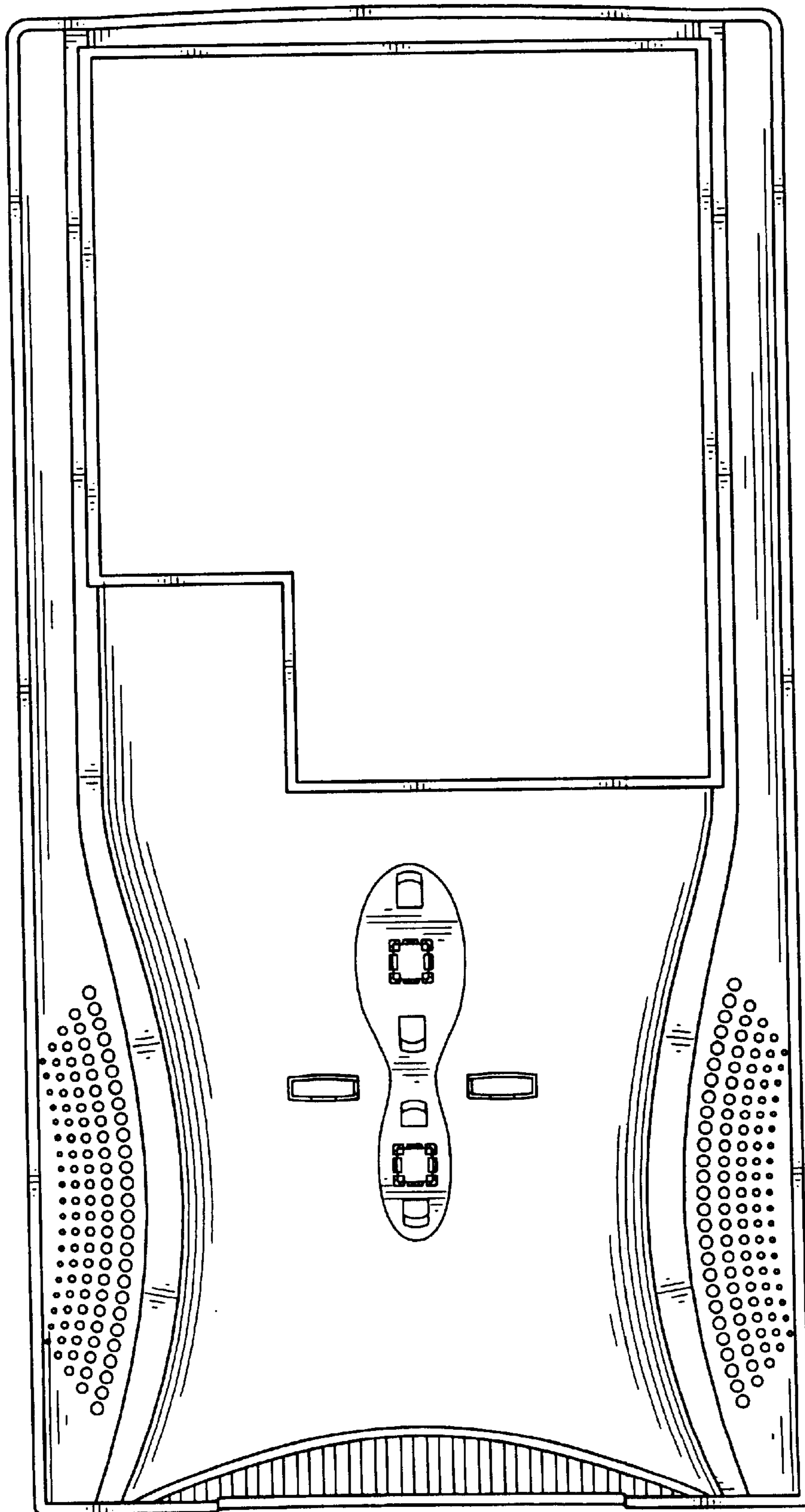

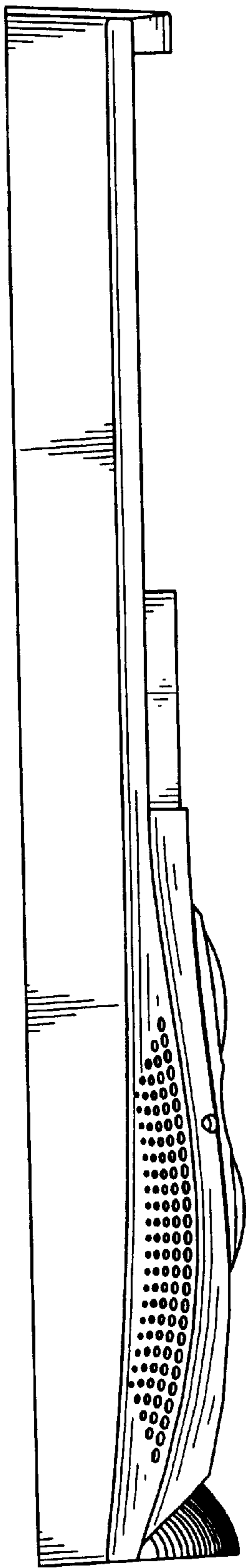

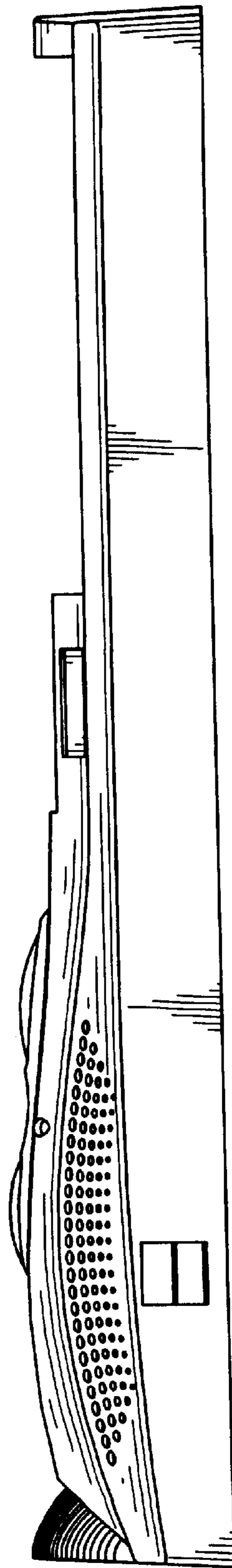

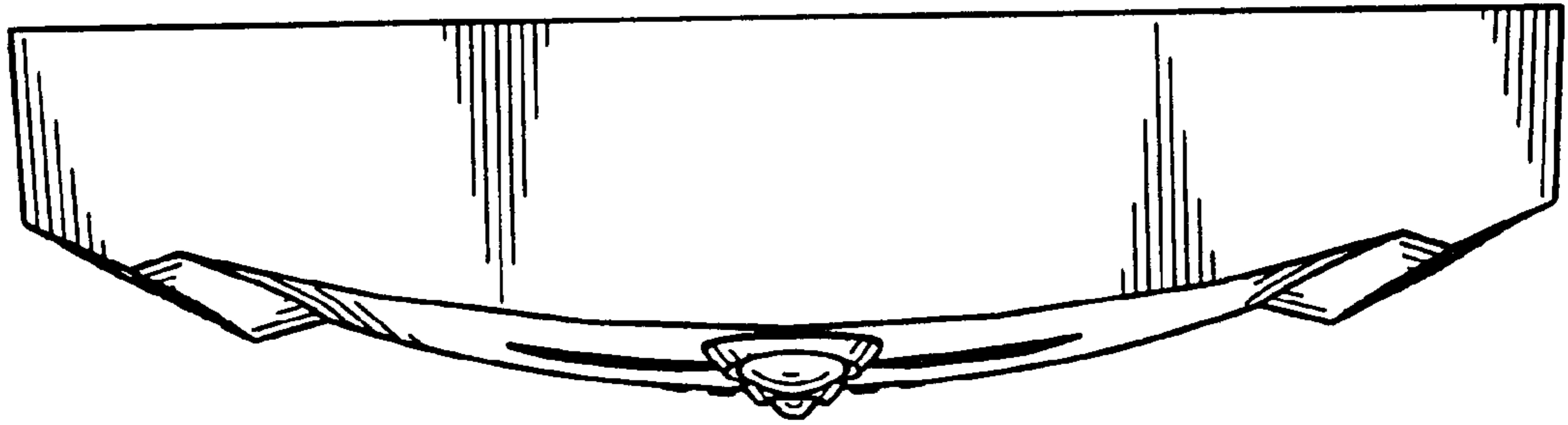

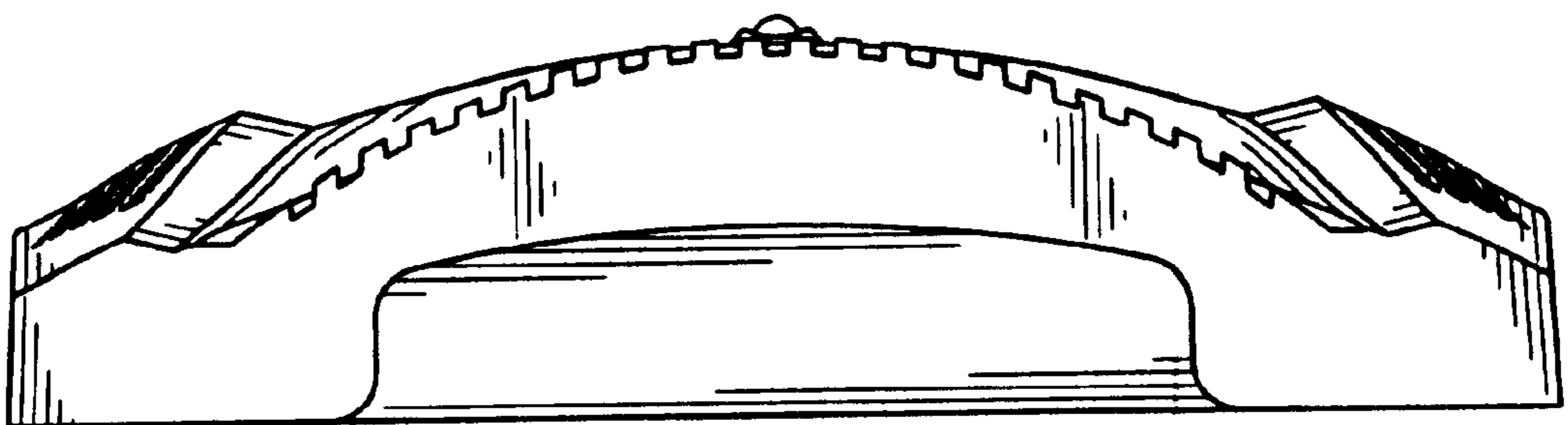

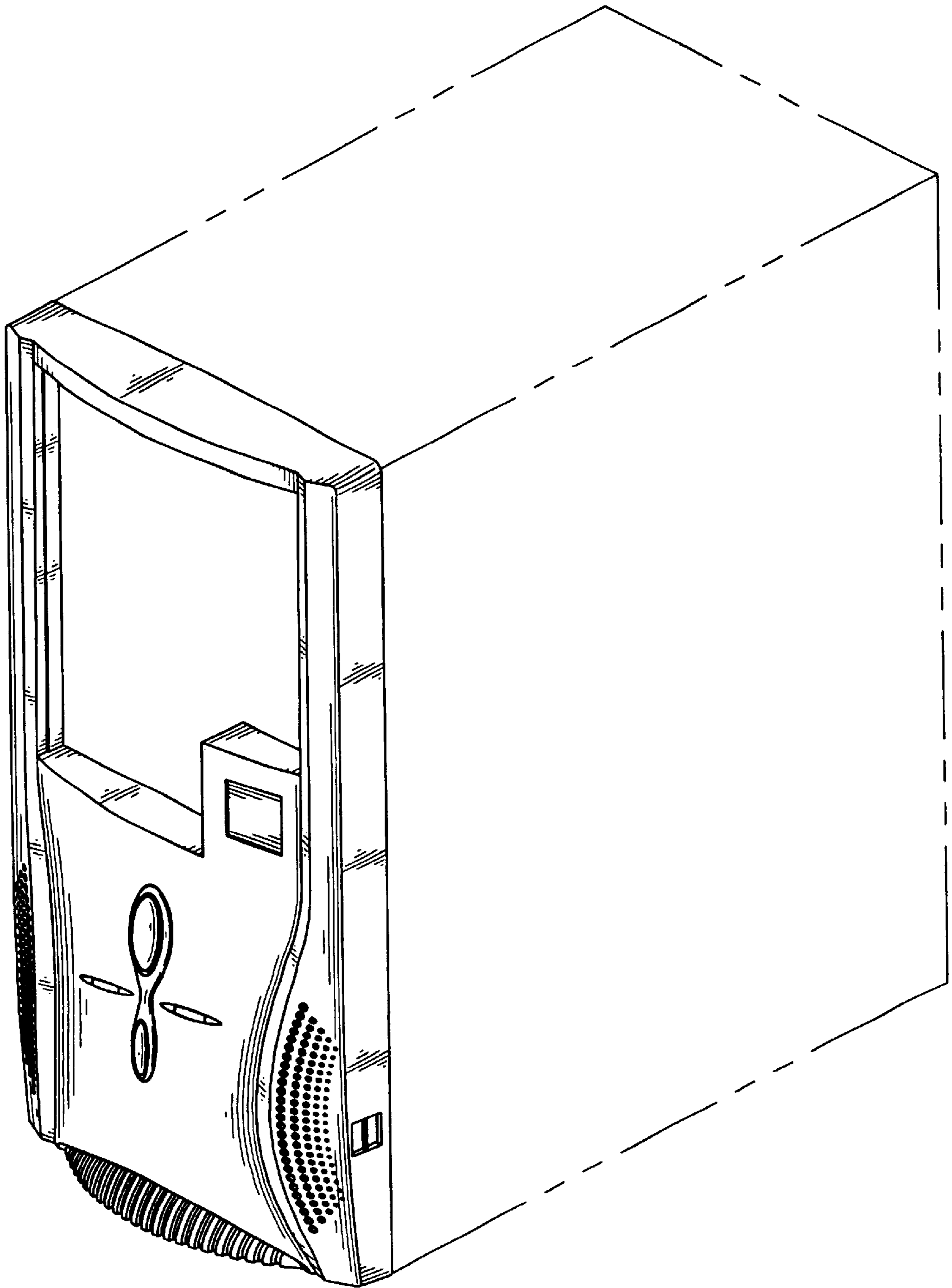
