(57) **CLAIM**

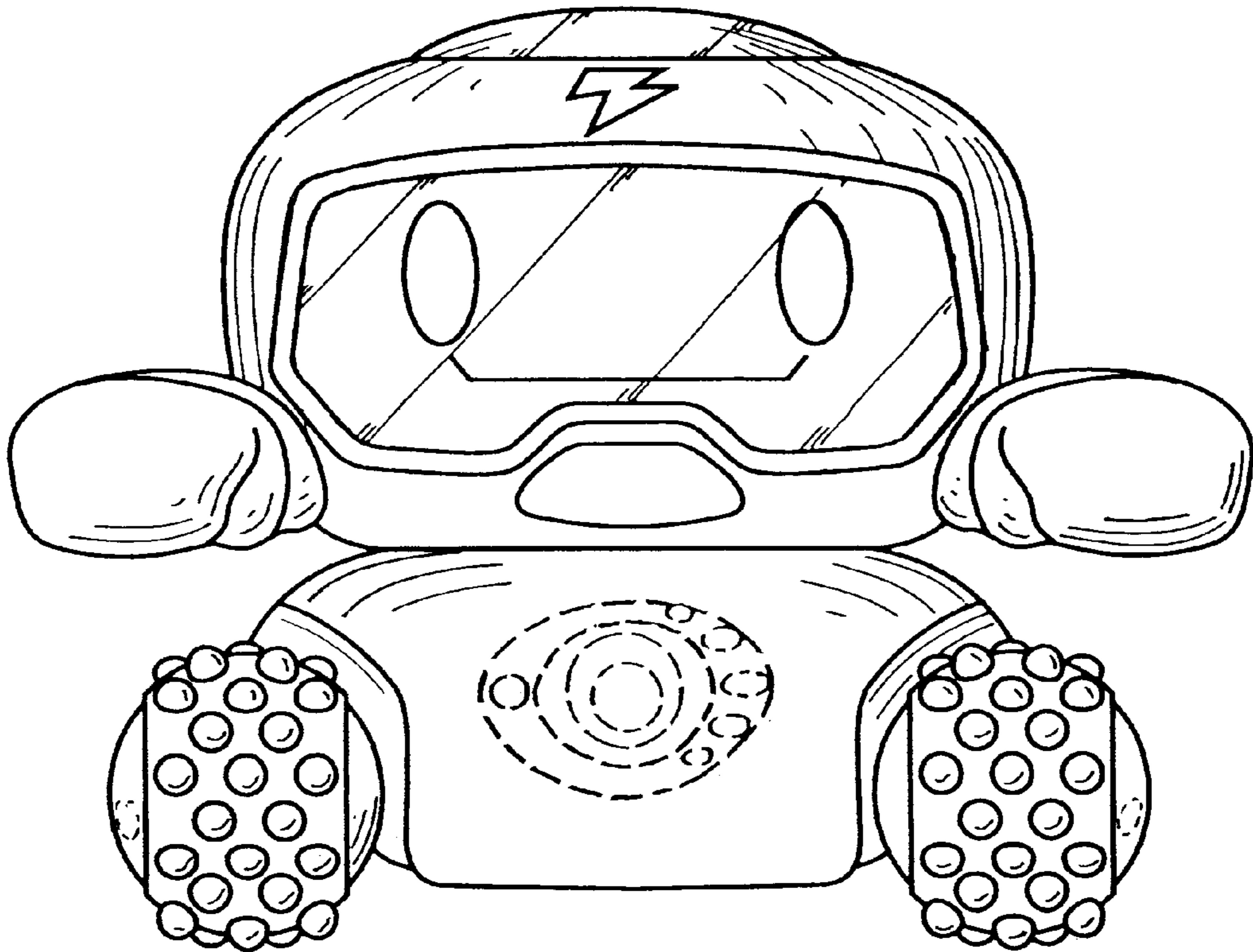
The ornamental design for a toy, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation of a toy showing our new design; FIG. 2 is a top plan view thereof; FIG. 3 is a bottom plan view thereof; FIG. 4 is a side elevation thereof; and, FIG. 5 is a rear elevation thereof.

The elements shown in broken lines on the front of the toy in FIGS. 1 and 4 are for illustrative purposes only and do not form part of the claimed design. The broken lines shown on the wheels in all of the figures represent unclaimed surface ornamentation.

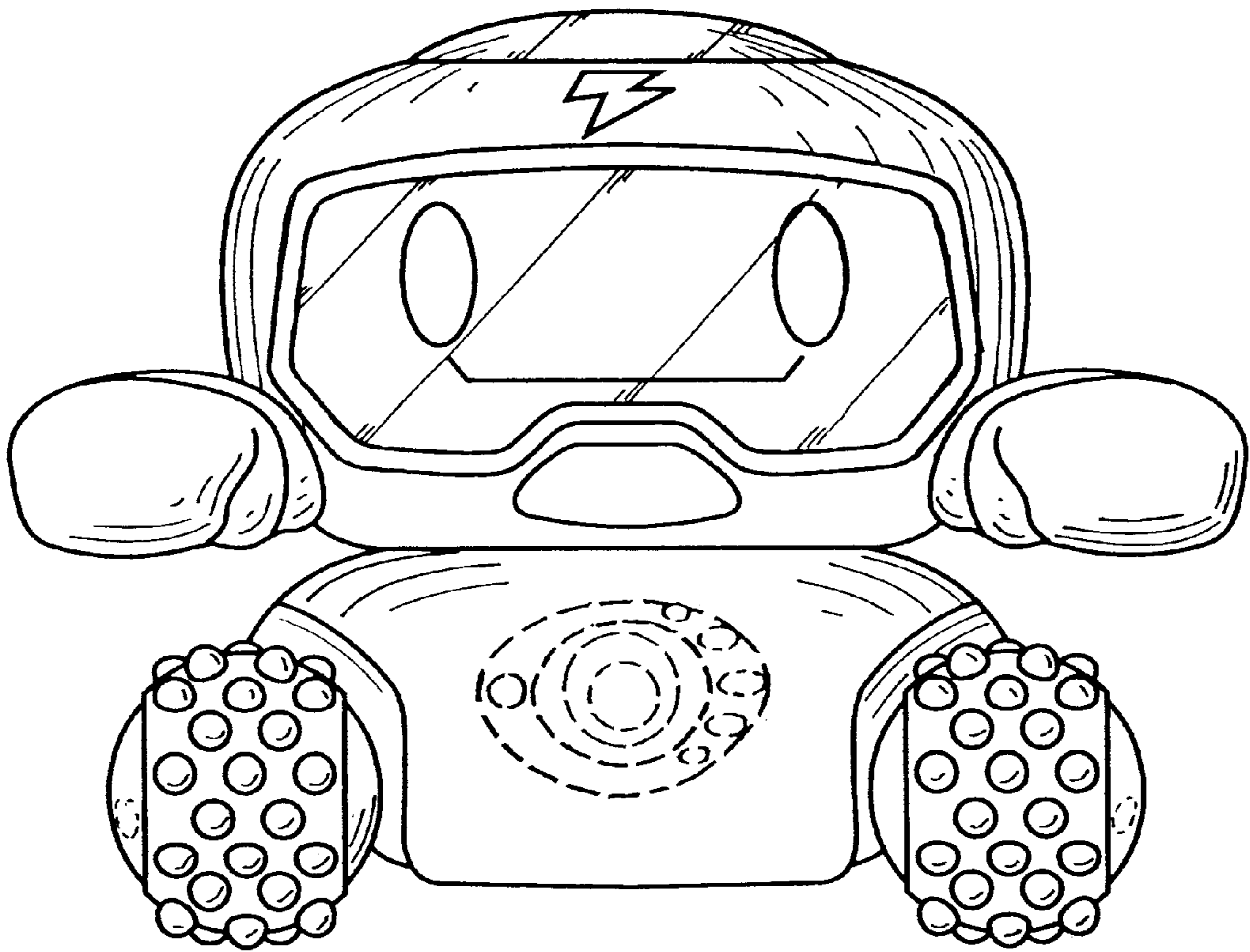

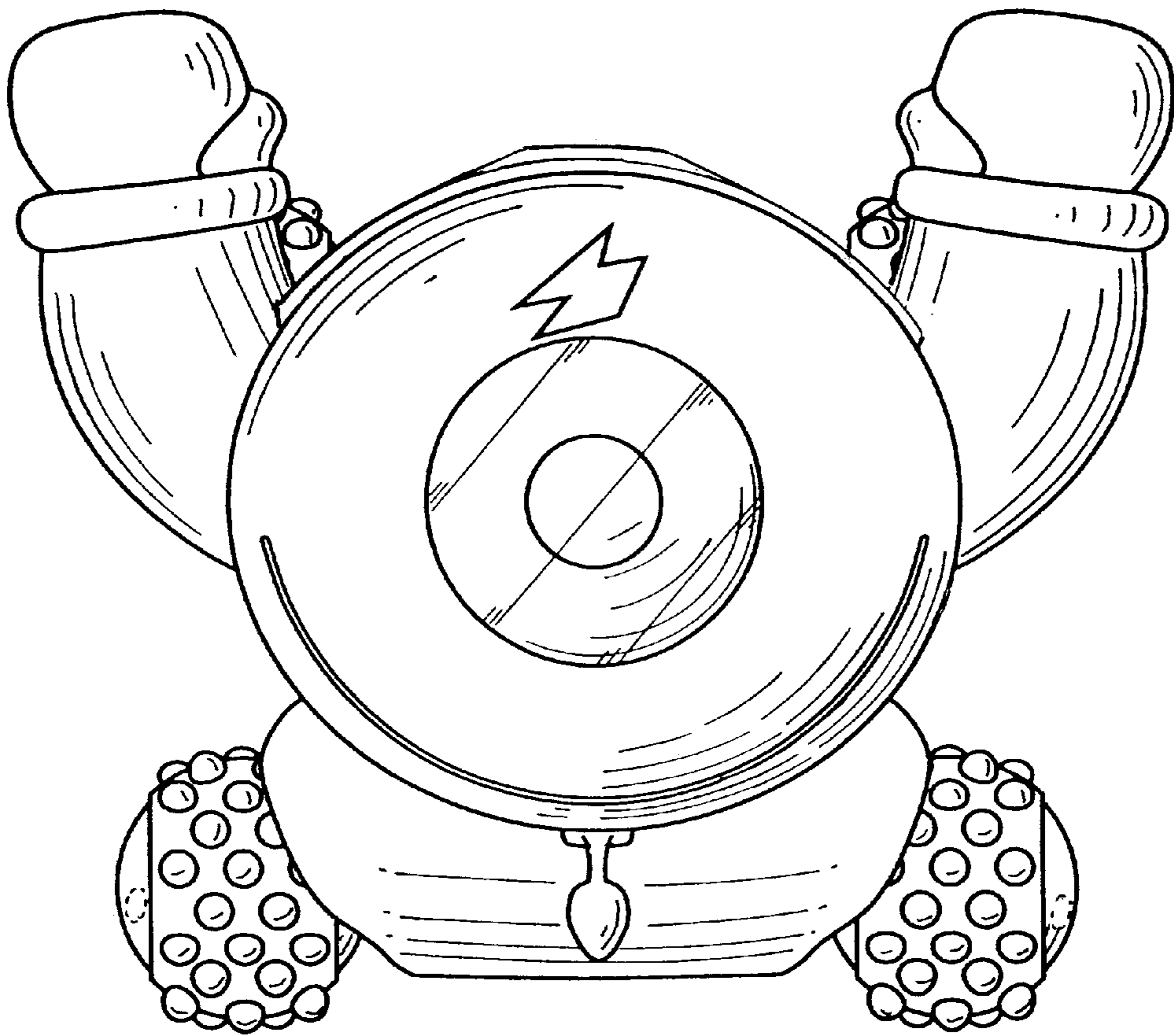

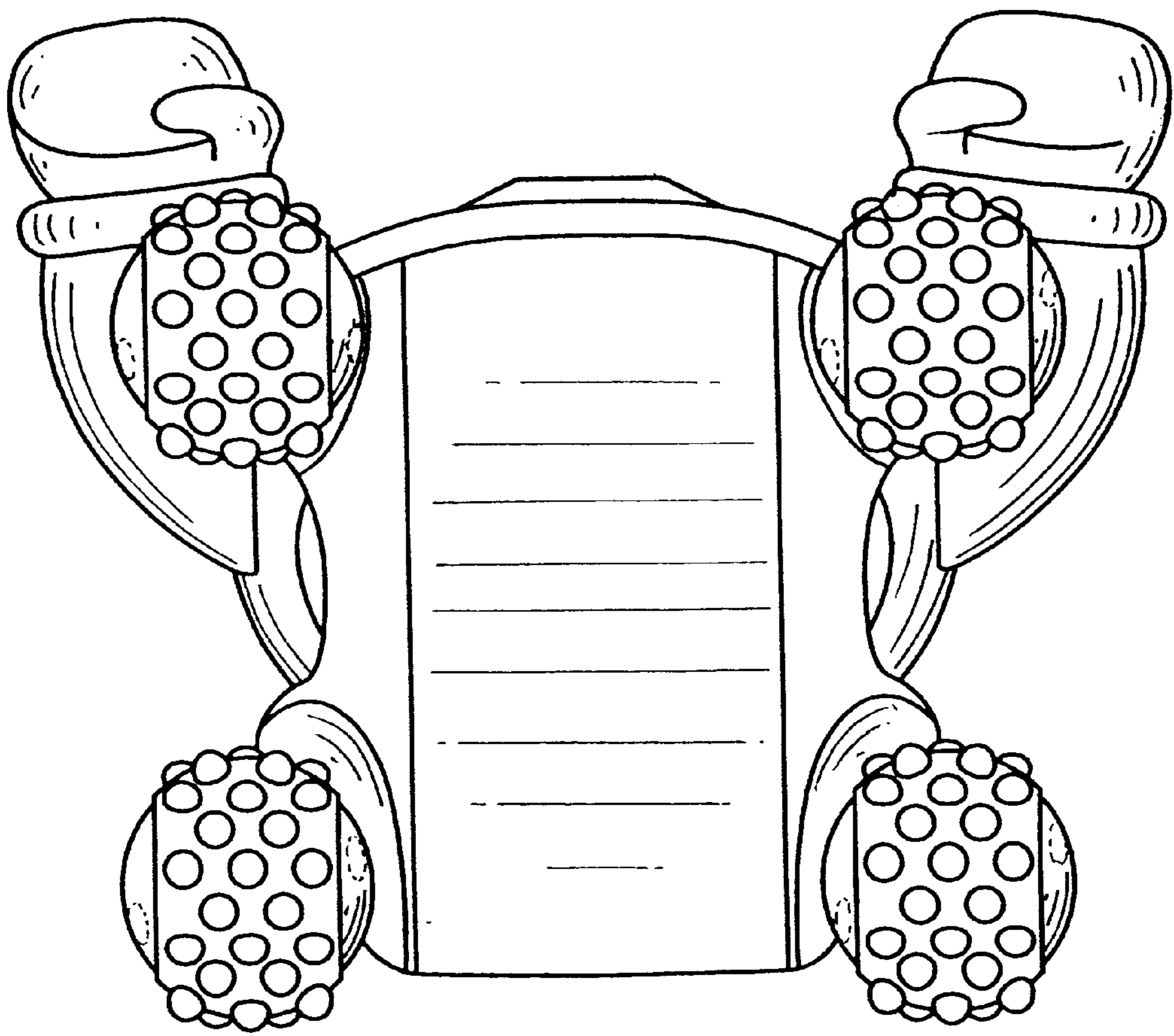

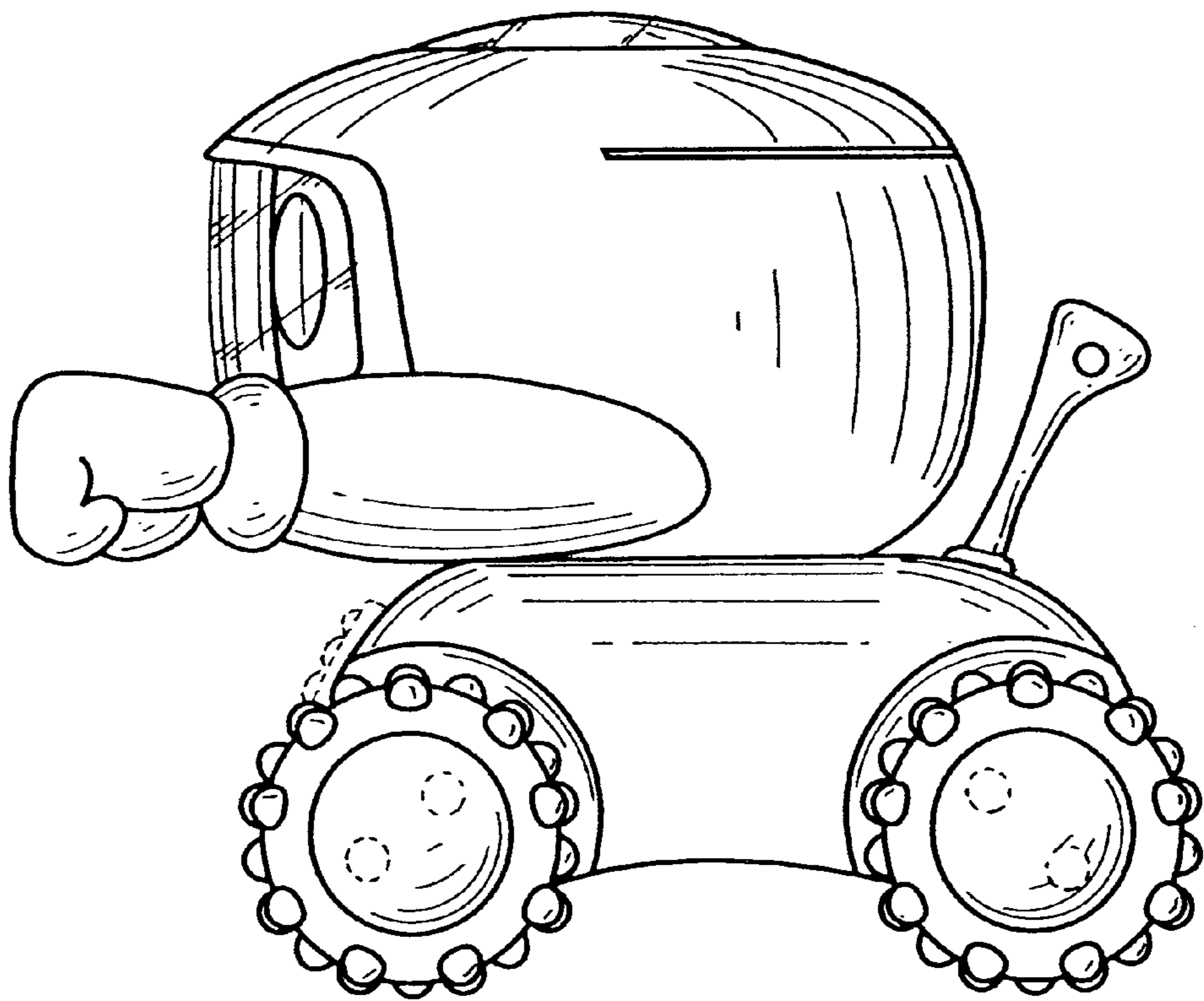

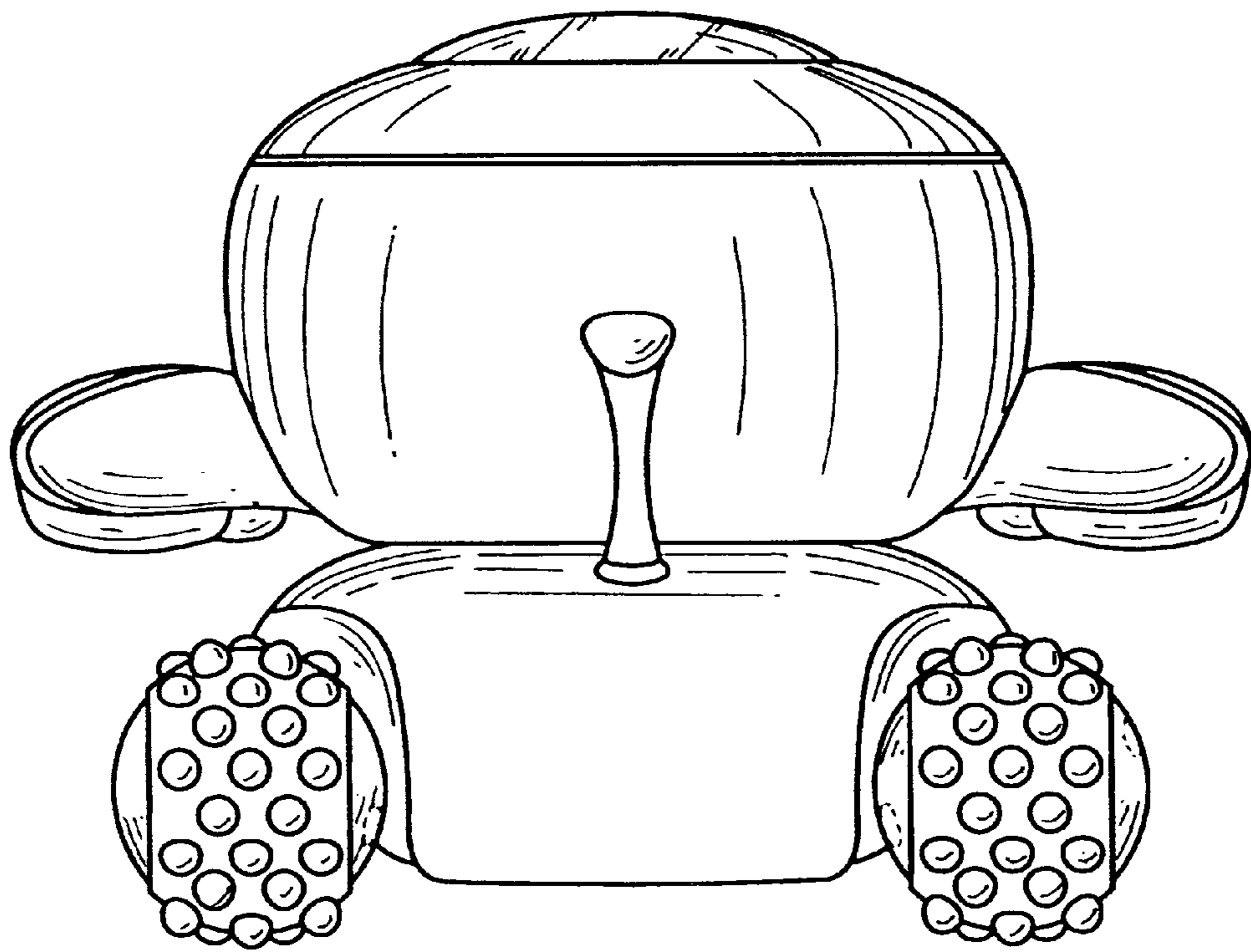
