(57) **CLAIM**

The ornamental design for a cutting tool, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a cutting tool, showing my new design, the broken lines representing environment and being no part of the claimed design;

FIG. 2 is a top plan view of the invention illustrated in FIG. 1;

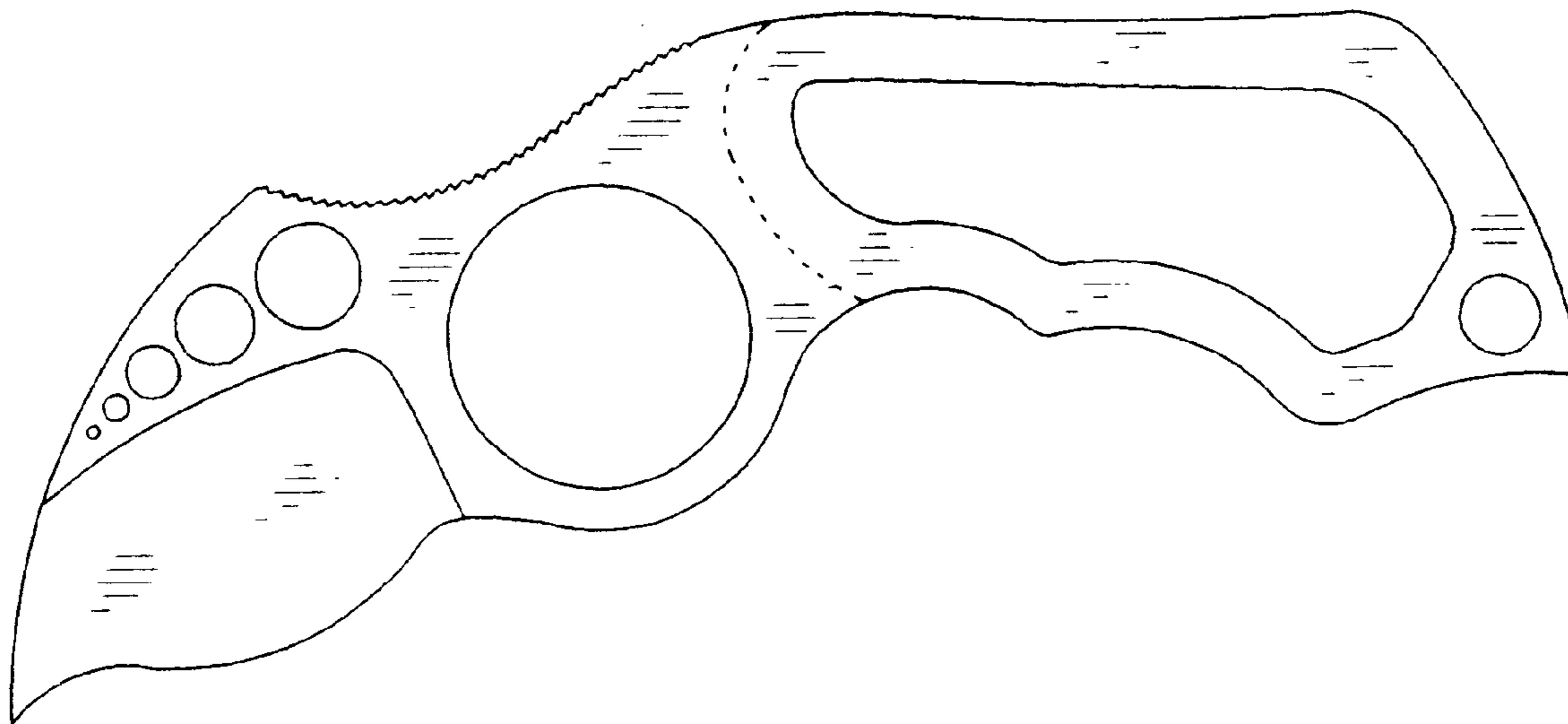
FIG. 3 is a rear elevation view of the invention illustrated in FIG. 1;

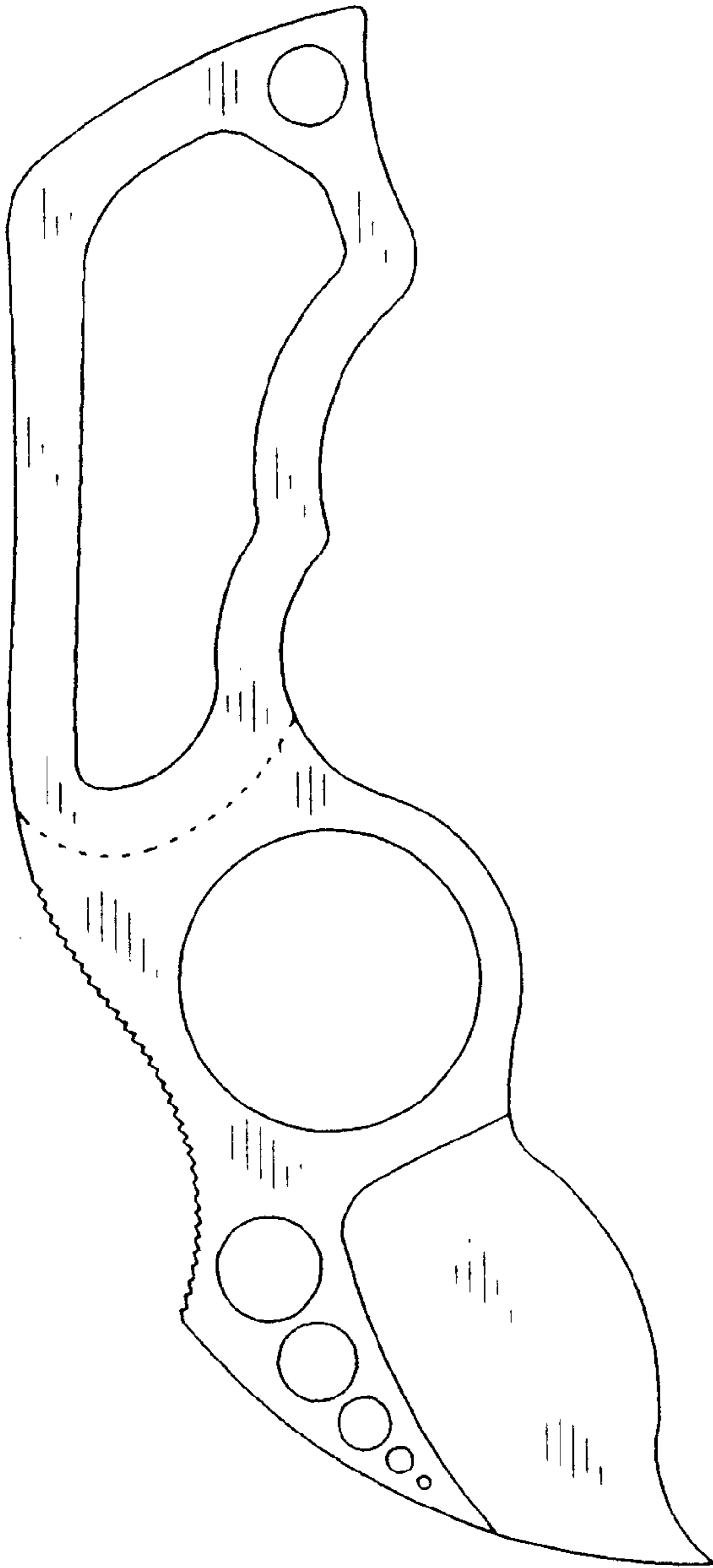

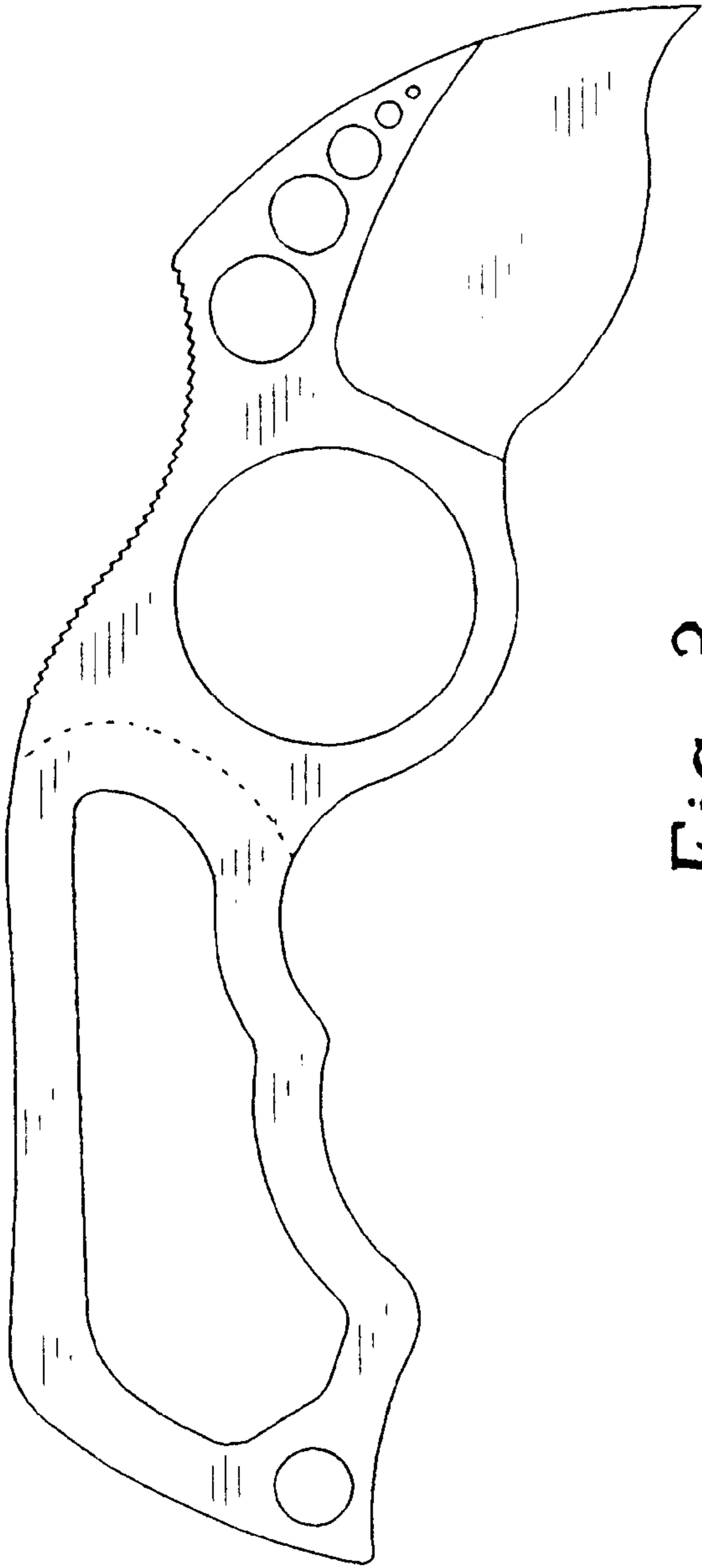

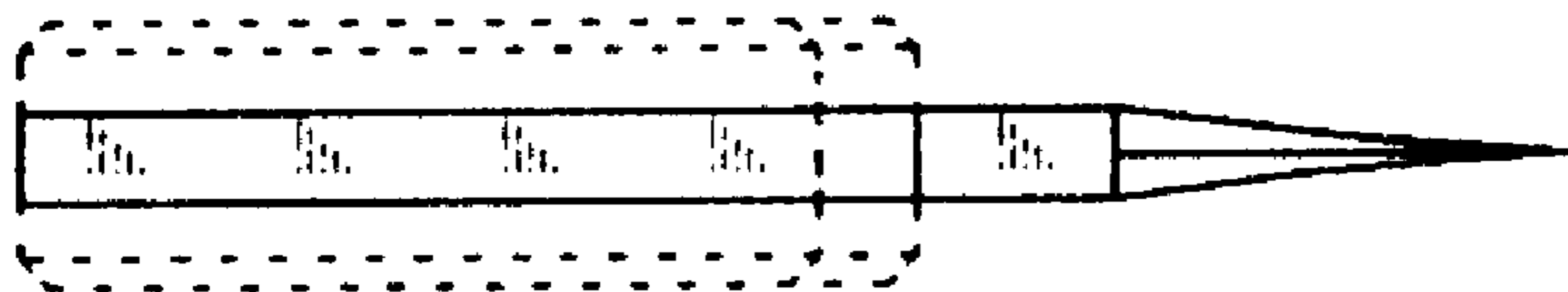

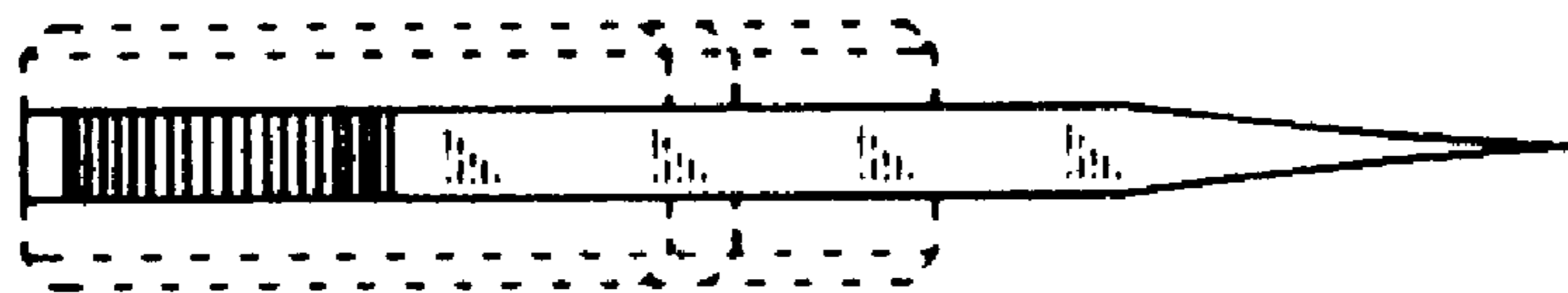
