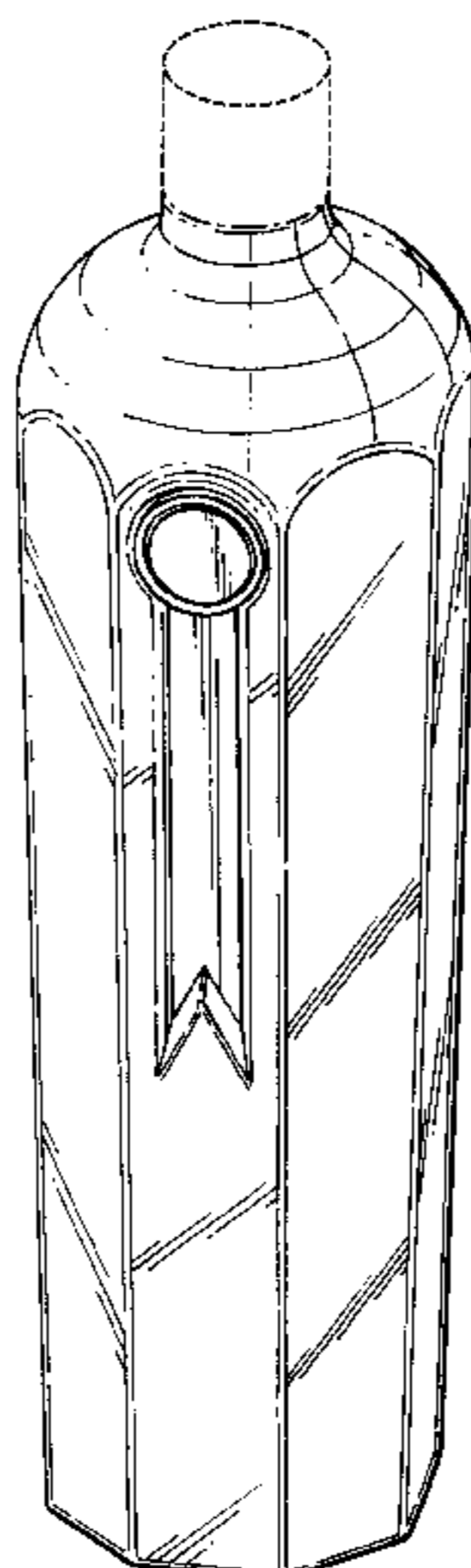
(57) **CLAIM**

The ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a bottle combined with a medallion and ribbon according to my new design; FIG. 2 is a front elevation view of the design shown in FIG. 1; FIG. 3 is a back elevation view of the design shown in FIG. 1, the left-side and right-side views are substantially similar thereto; FIG. 4 is a top plan view of the design shown in FIG. 1; and, FIG. 5 is a bottom plan view of the design shown in FIG. 1. The dot-dash line shown in FIGS. 1-4 represents the boundary of the claim, but is not part of the claimed design. The dashed lines shown in FIGS. 1-4 of the bottle cap are for illustrative purposes only and form no part of the claimed design.

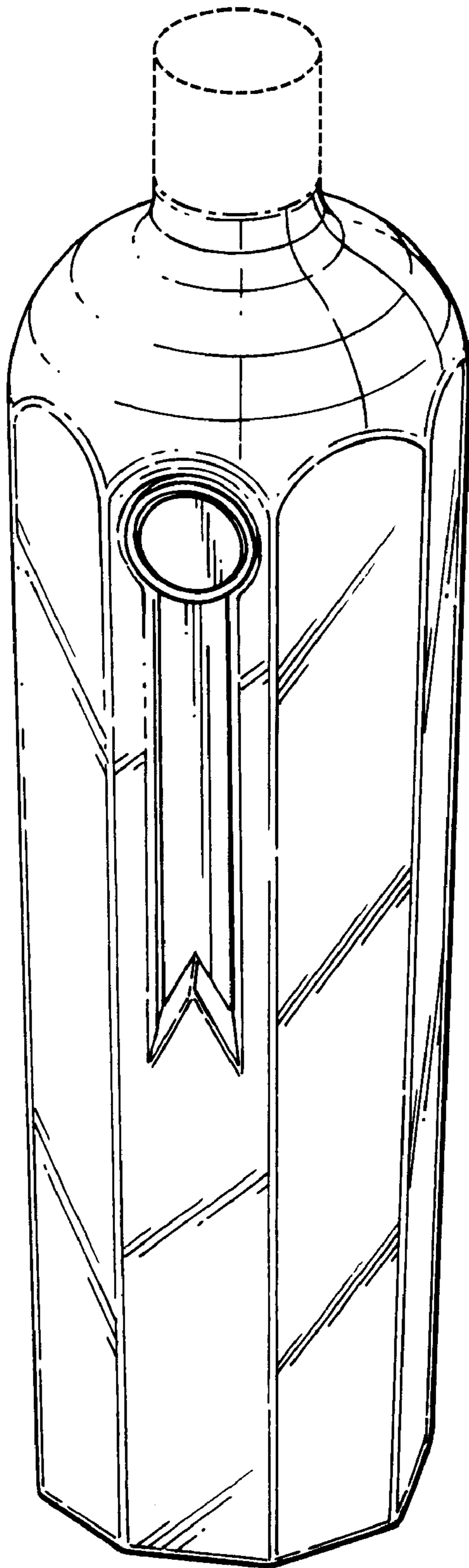

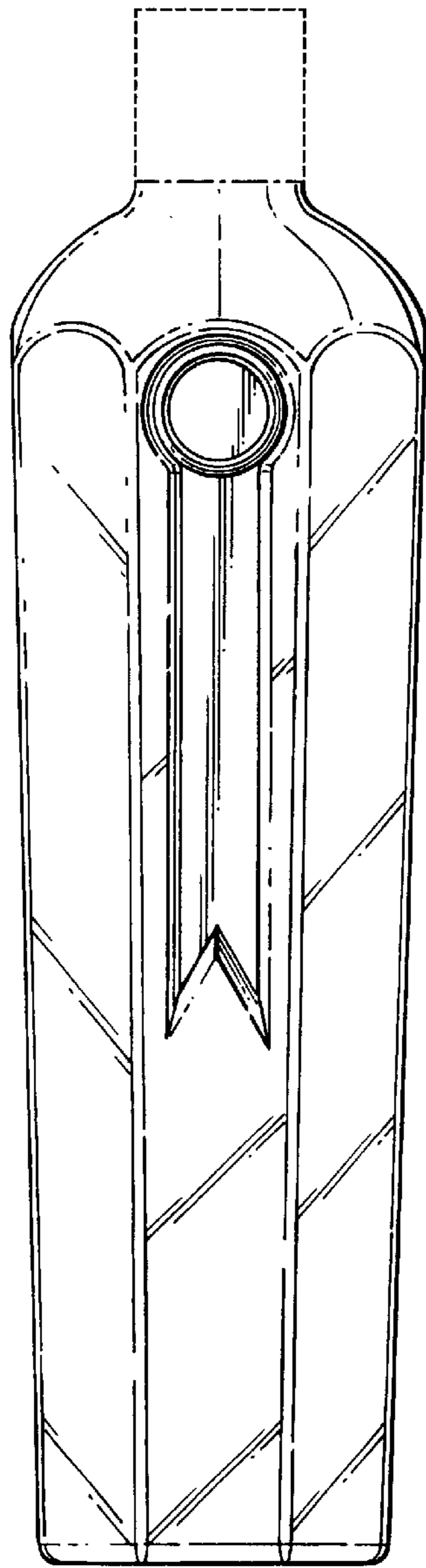

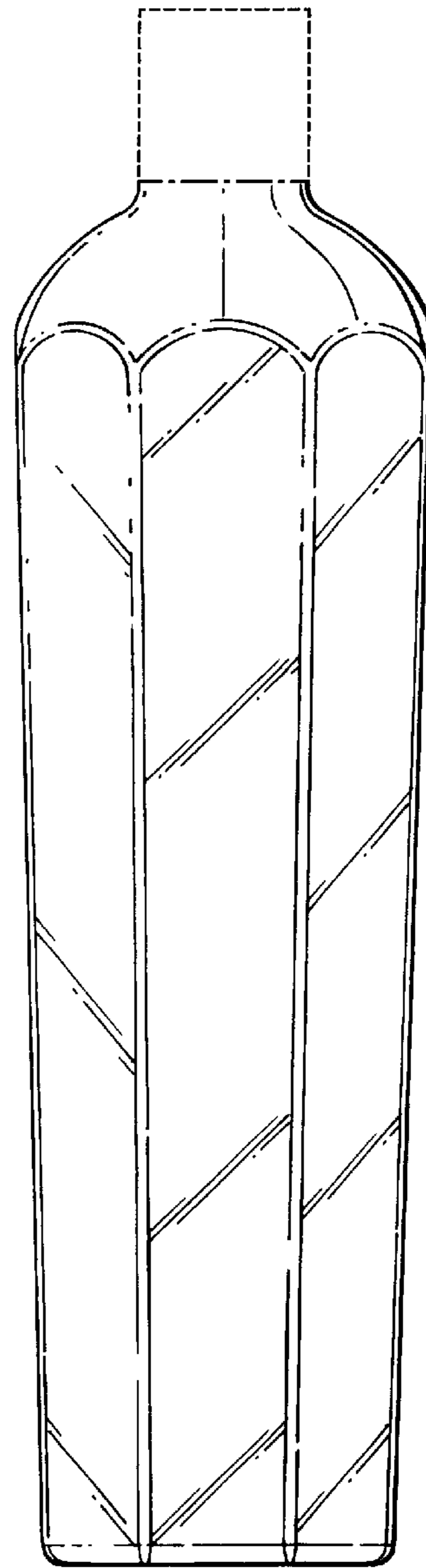

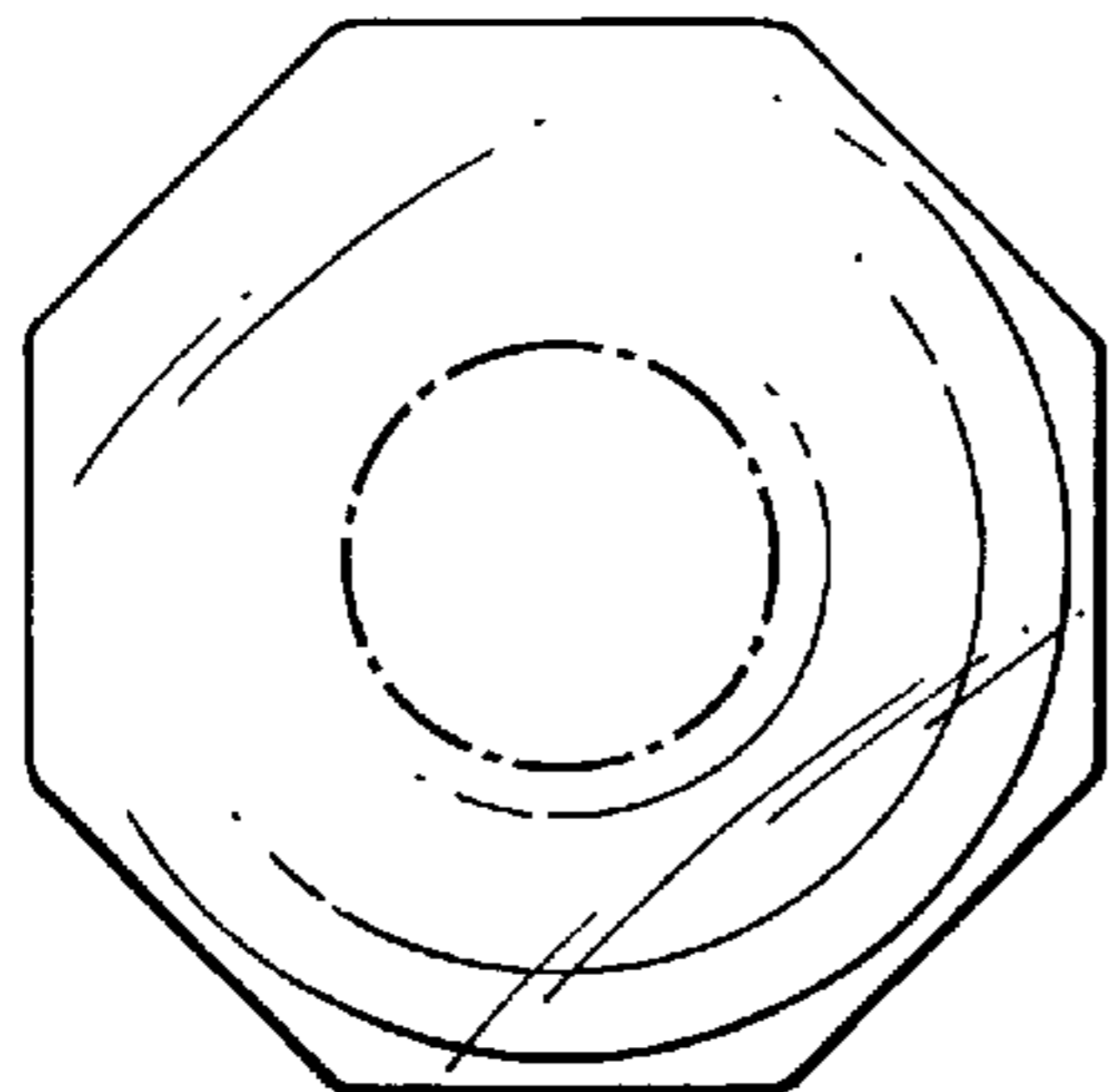

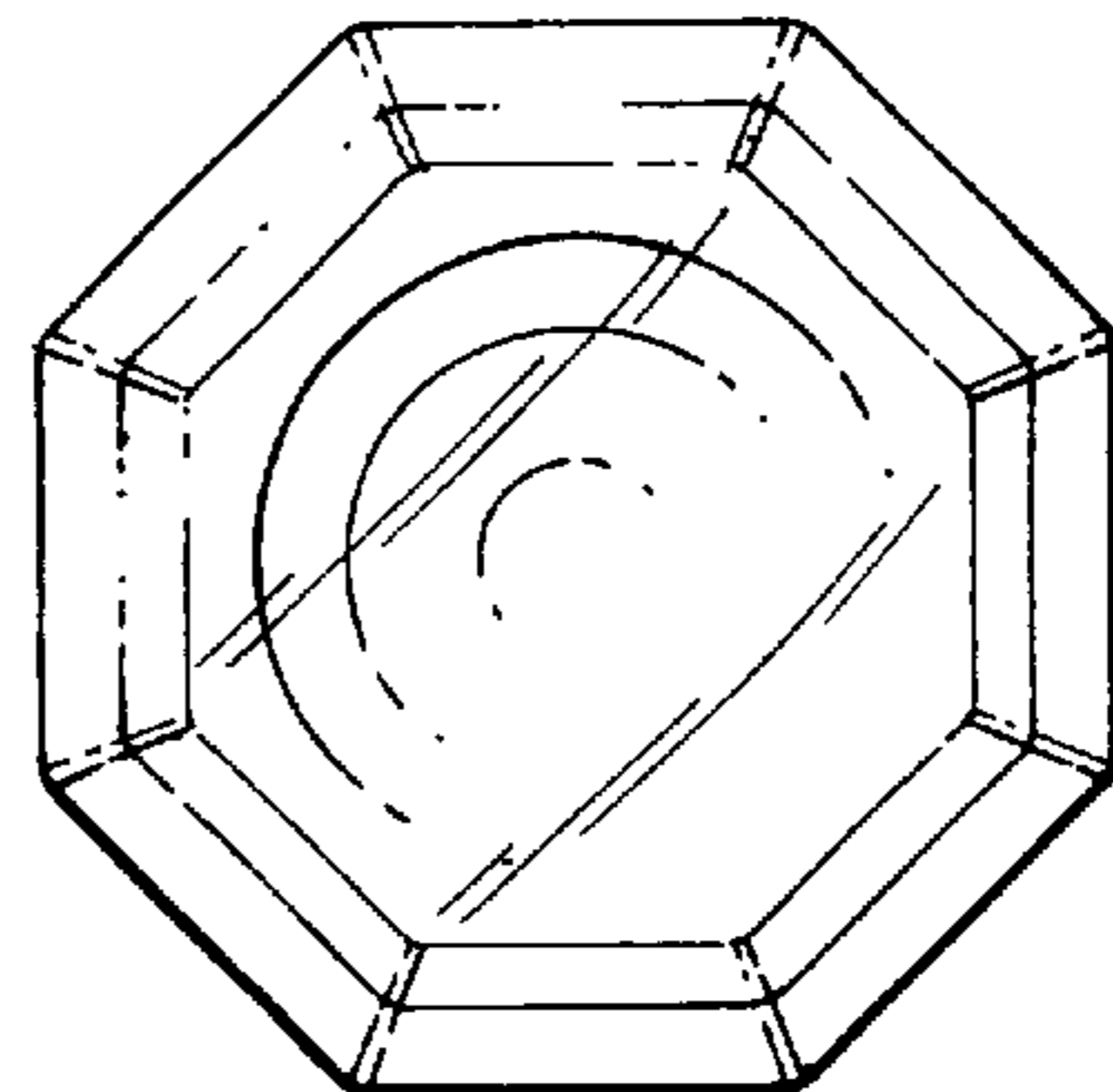
