**DESCRIPTION**

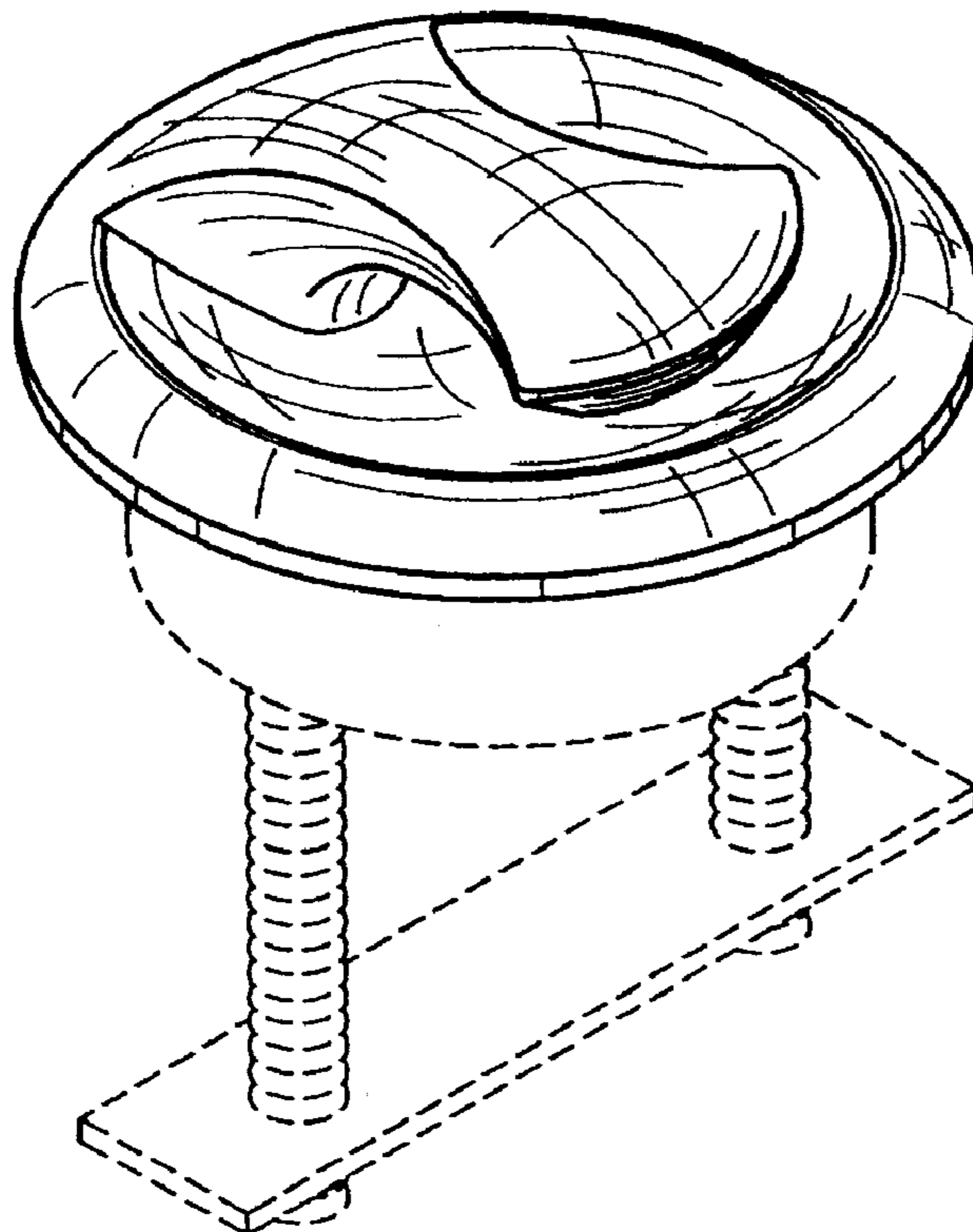
FIG. 1 is a top perspective view of a water ski rope tow, showing my design;  
FIG. 2 is a top plan view of the water ski rope tow;  
FIG. 3 is a front elevational view of the water ski rope tow;  
FIG. 4 is a rear elevational view of the water ski rope tow; and,  
FIG. 5 is a side elevational view of the water ski rope tow the opposite side being a mirror image of that shown.

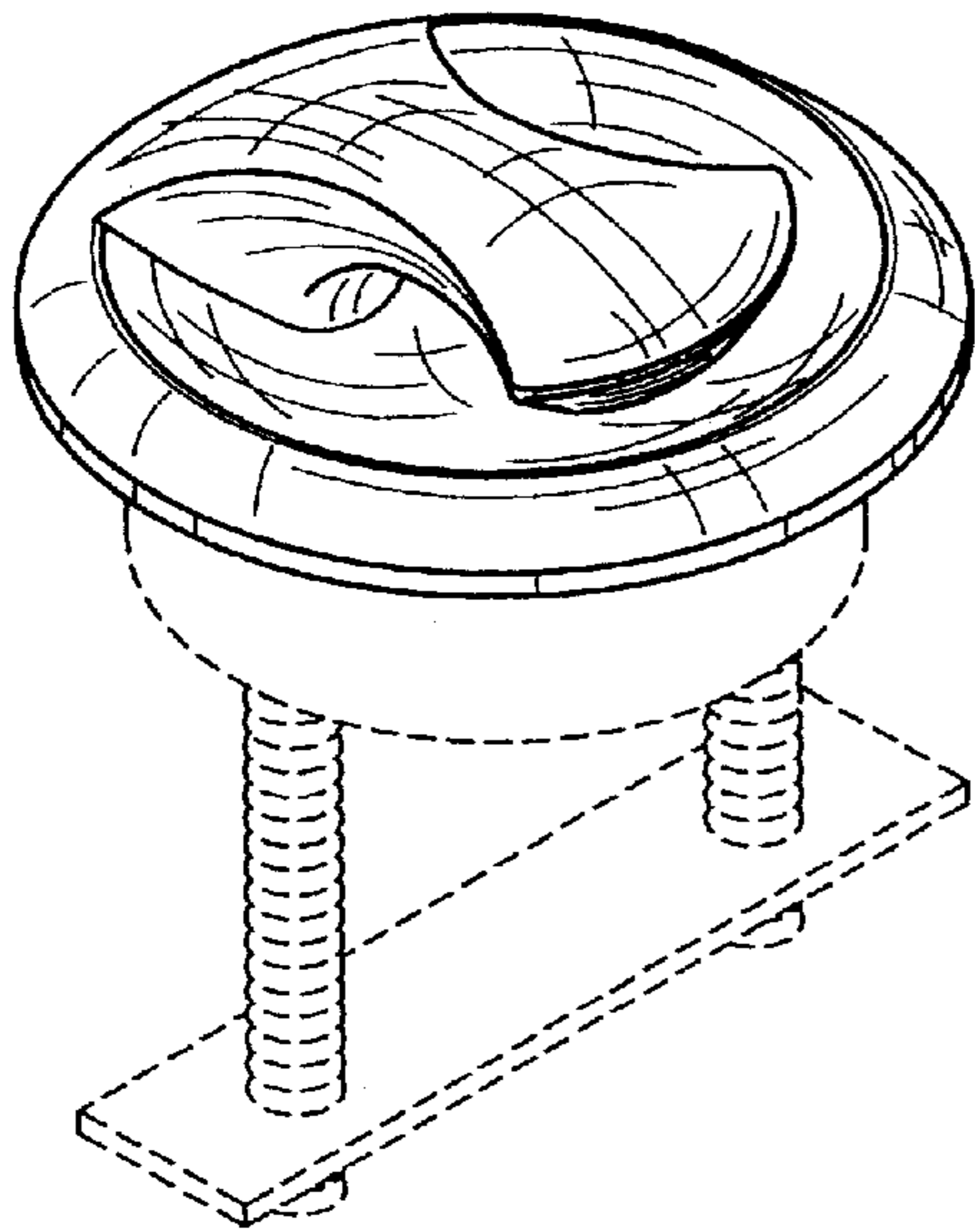

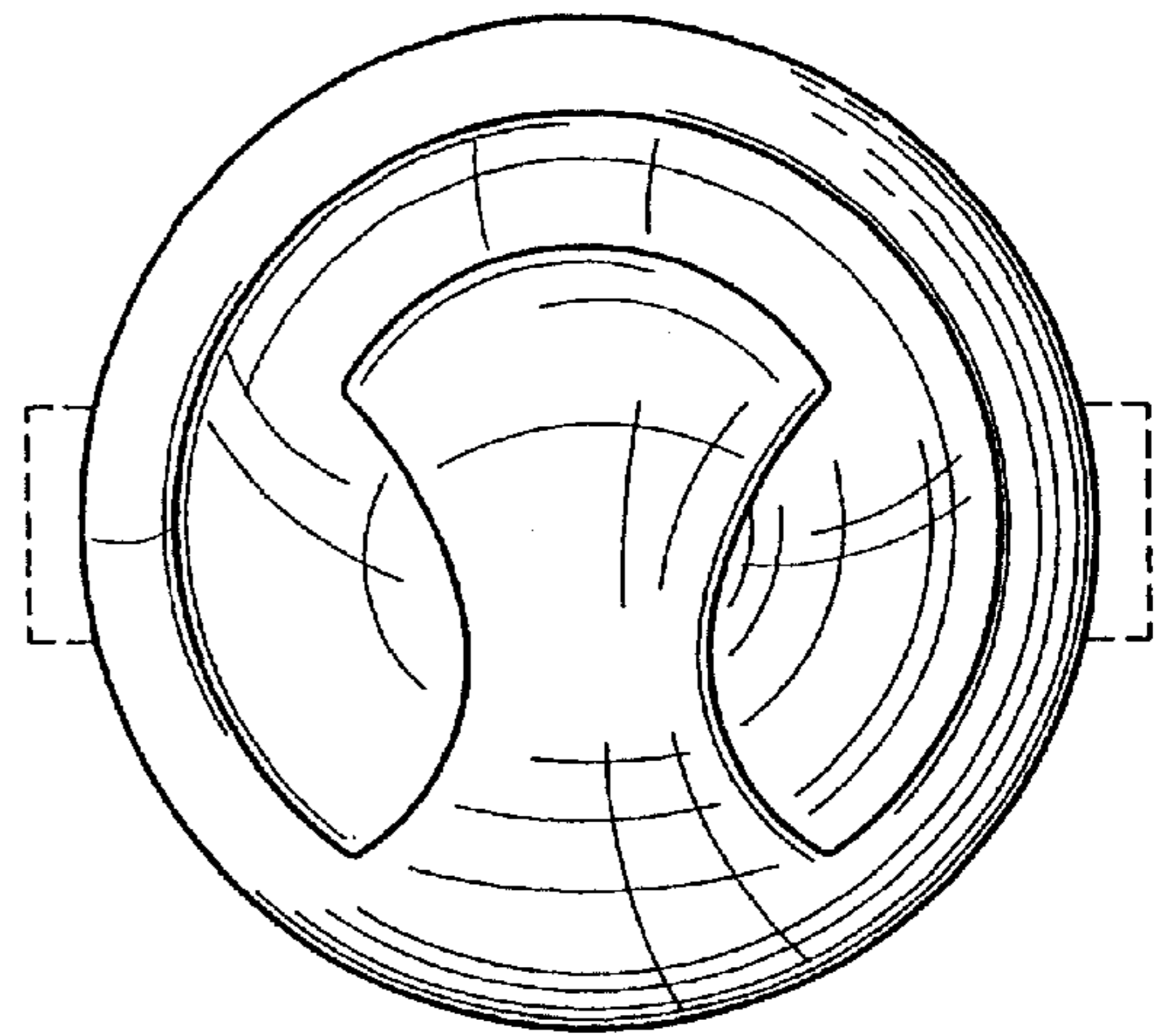

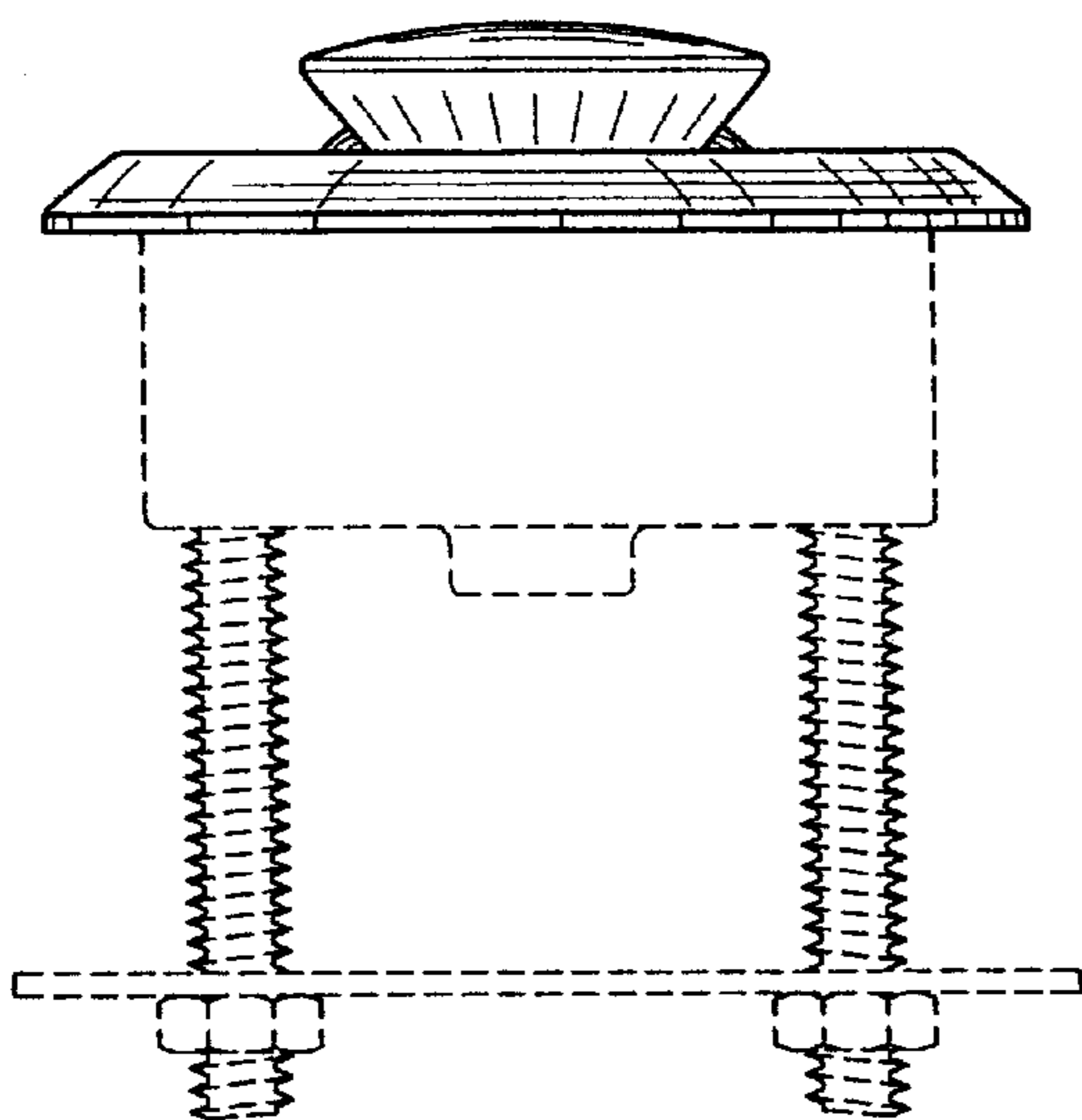

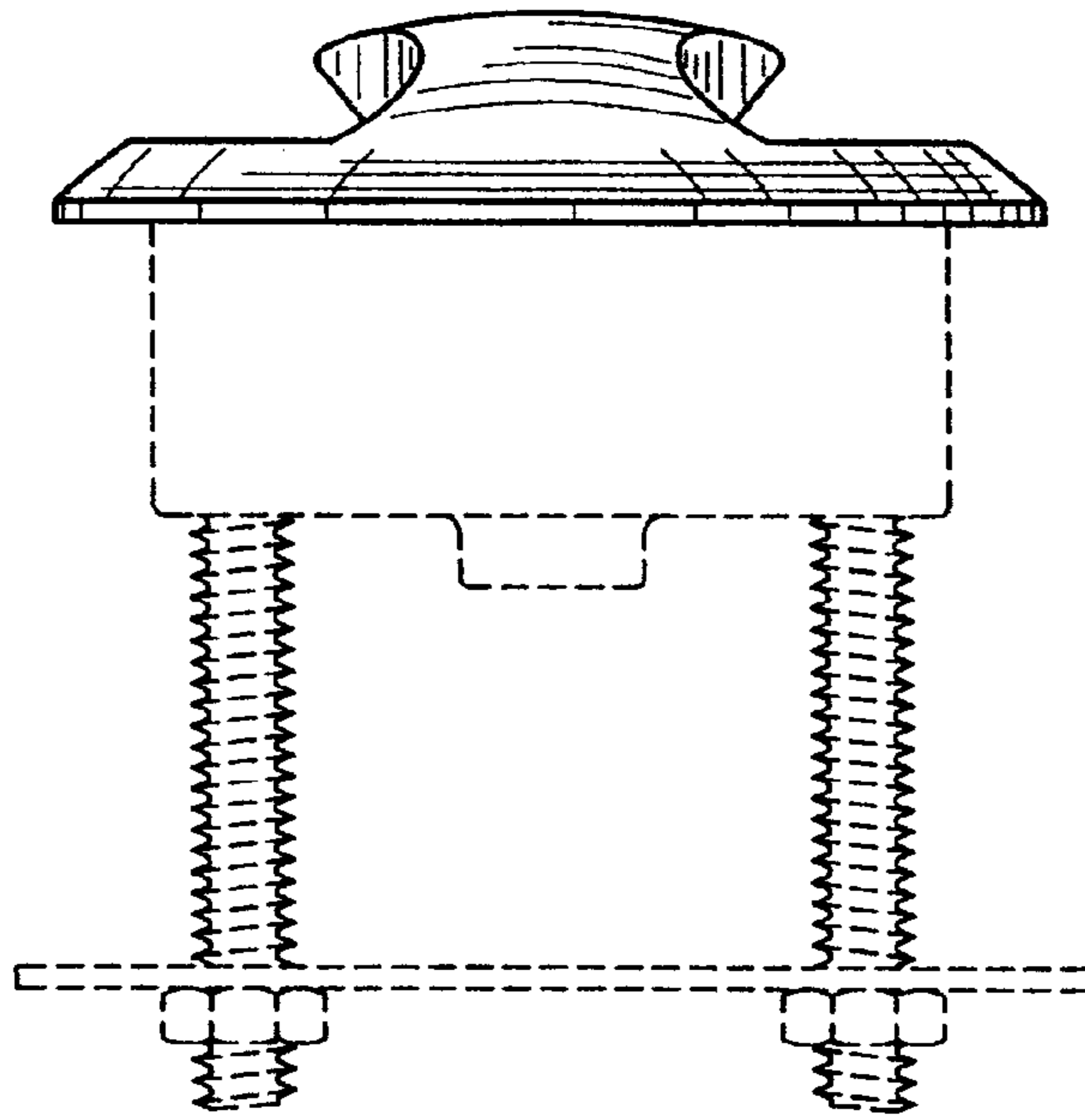

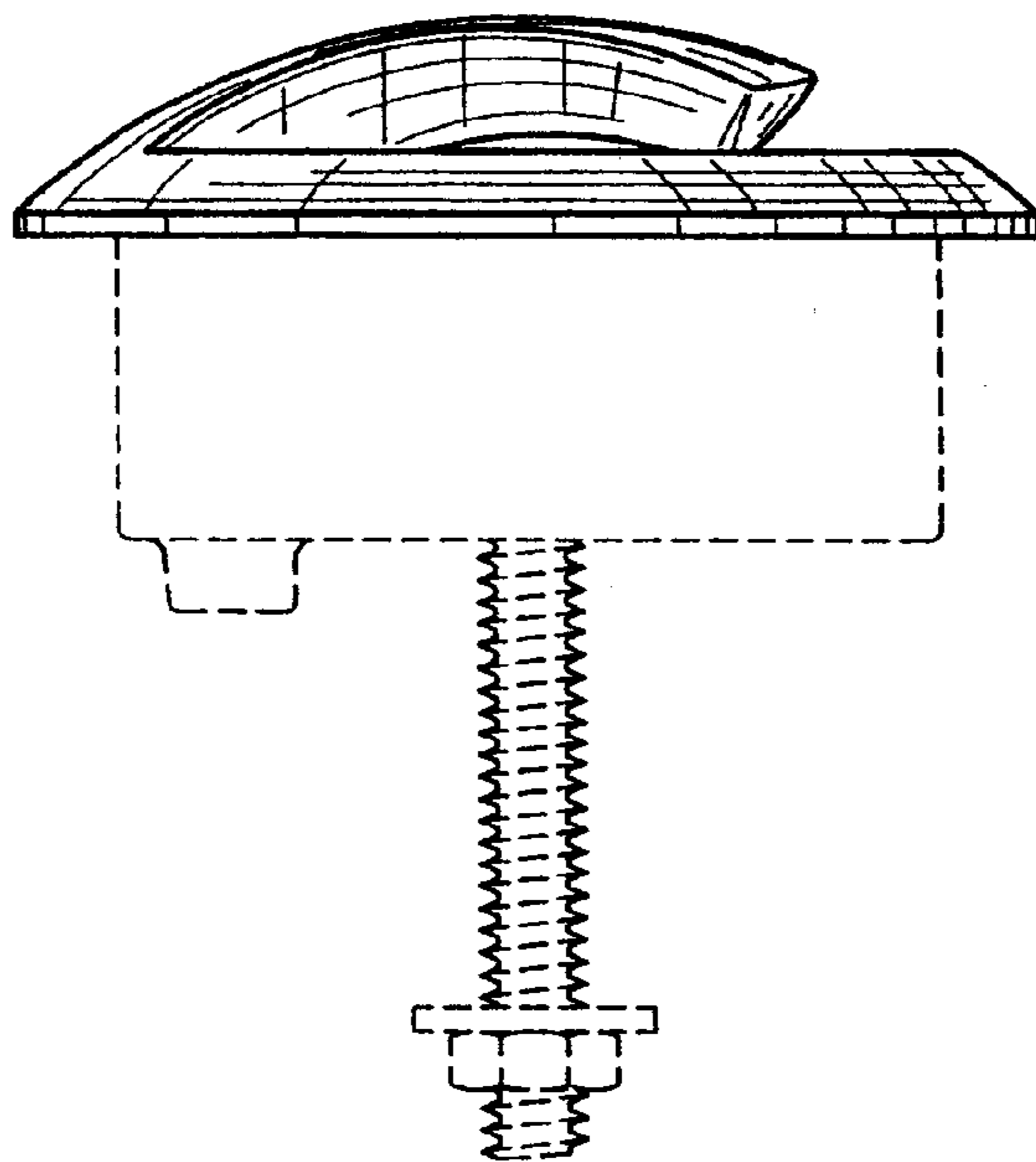
