**DESCRIPTION**

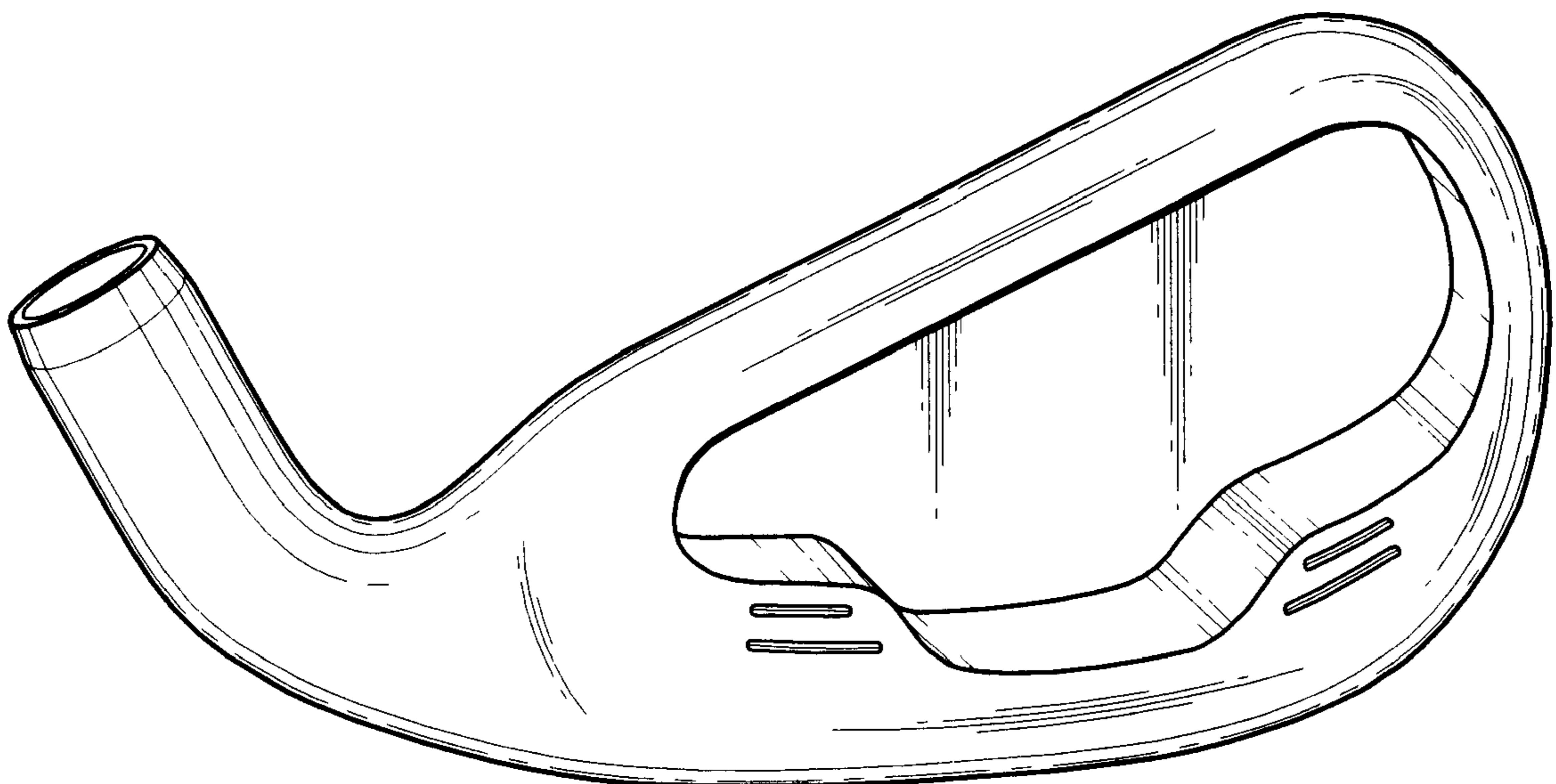

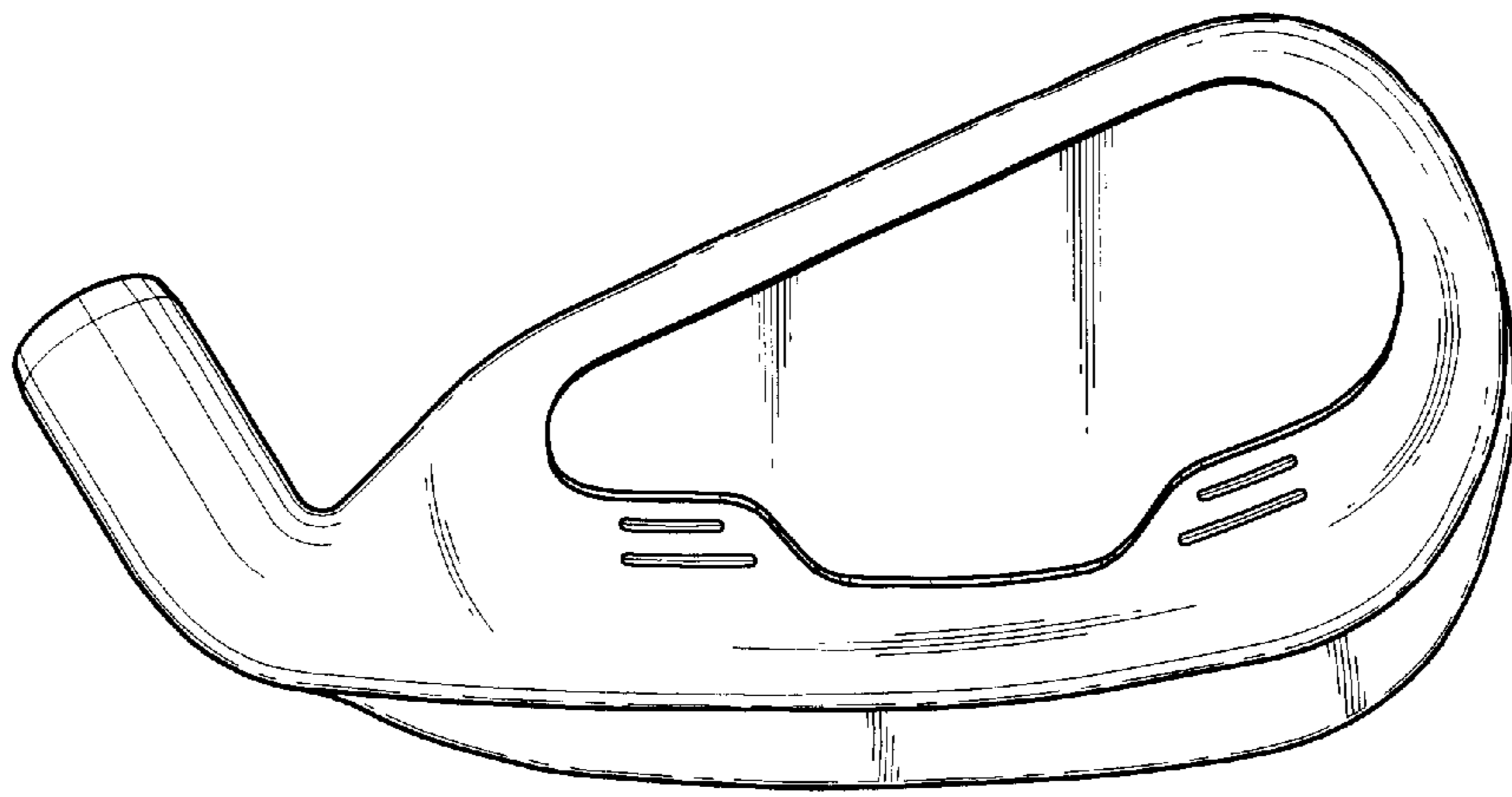

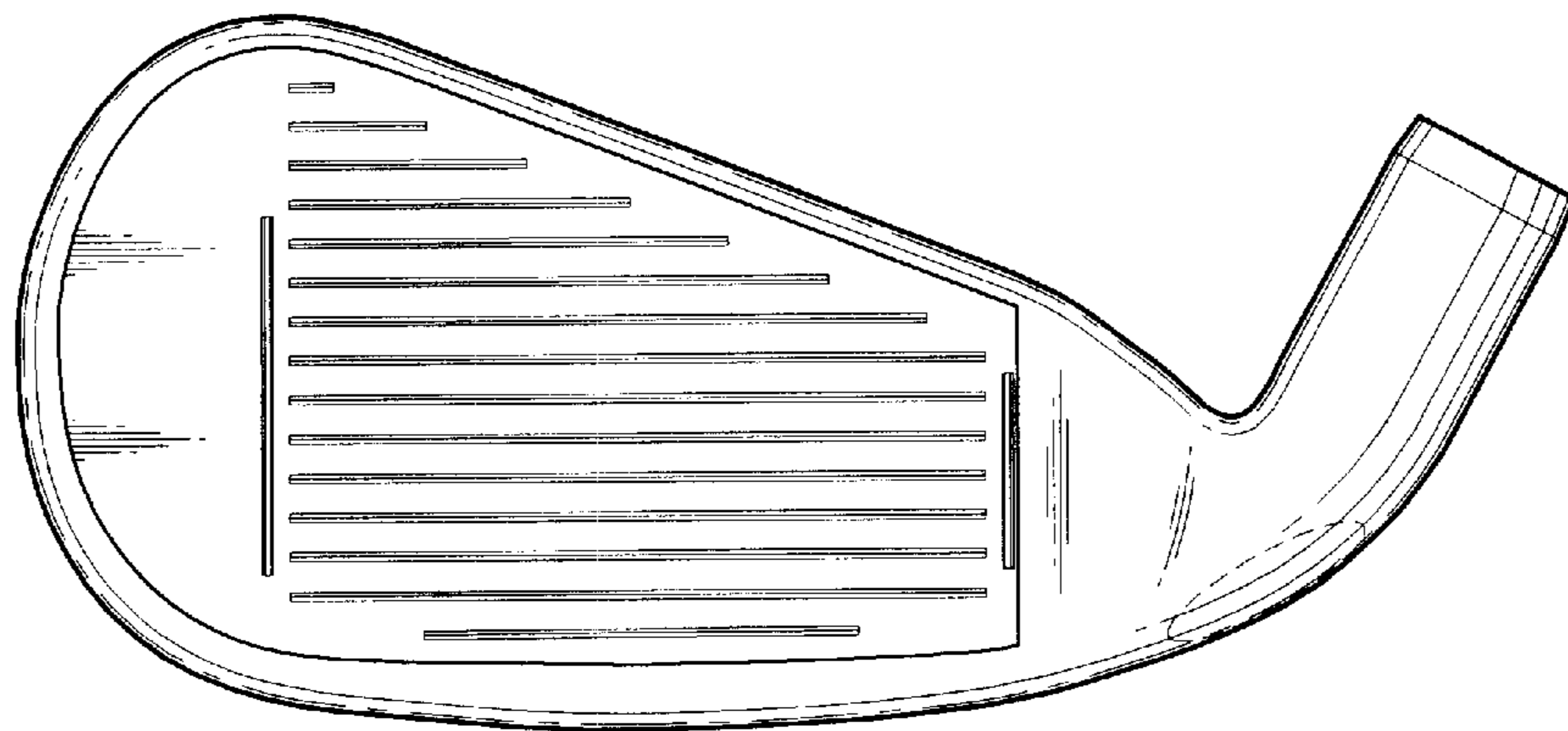

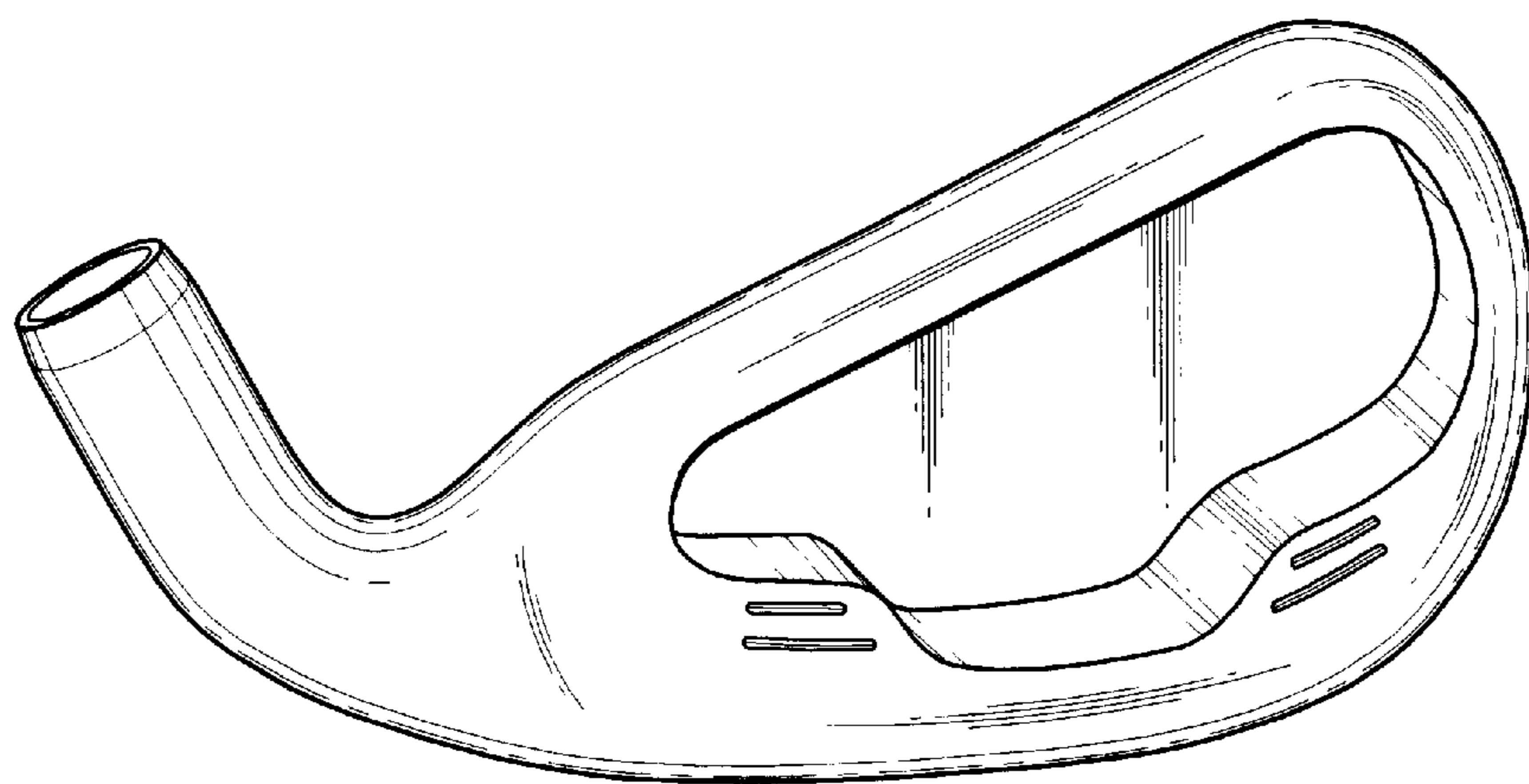




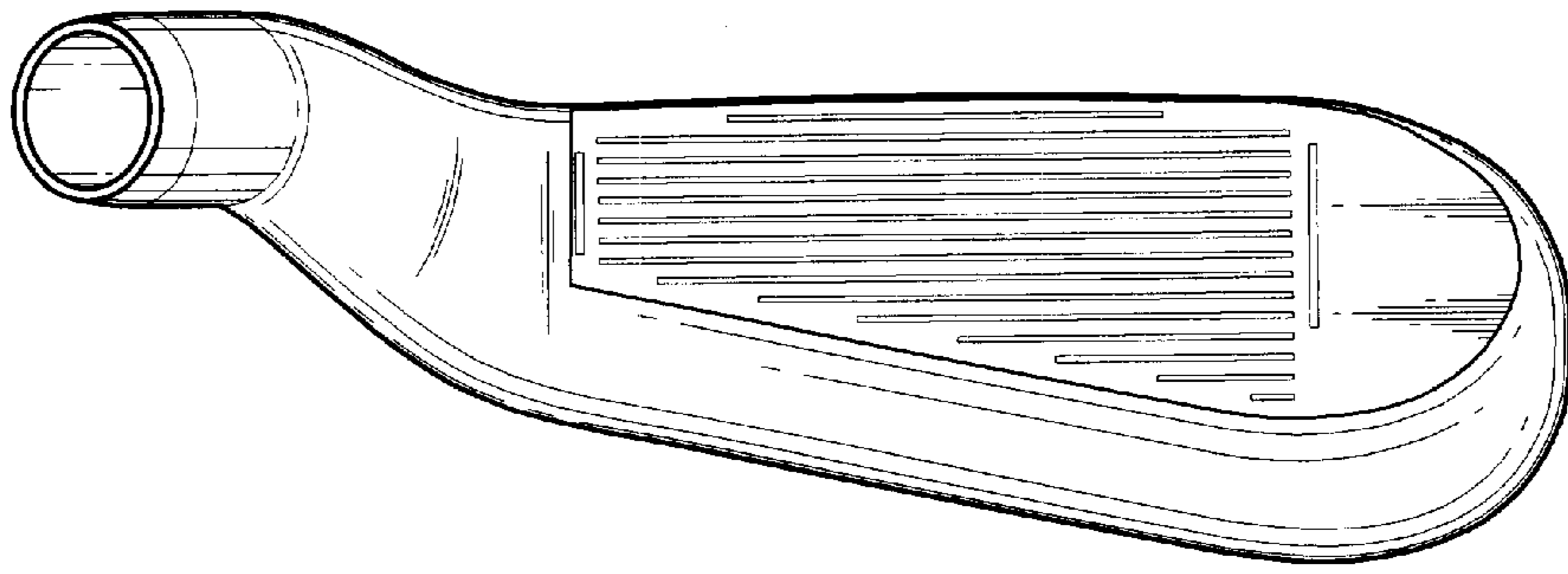

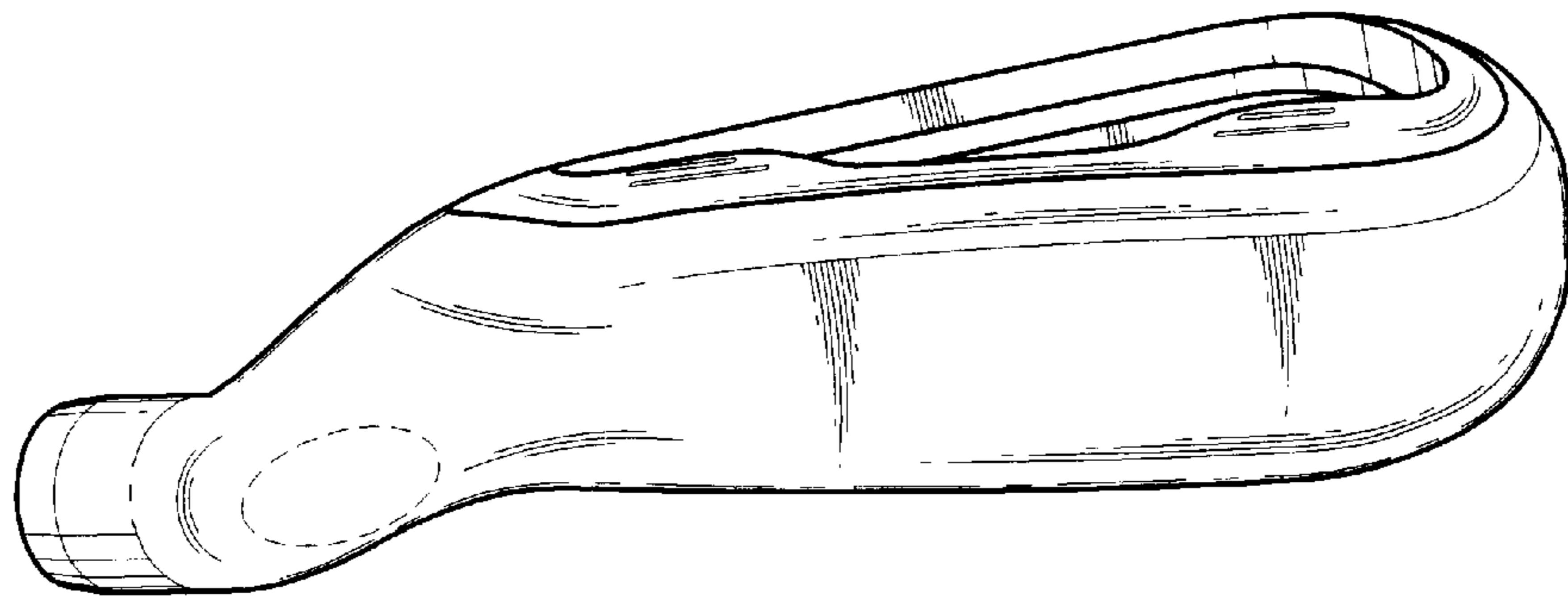

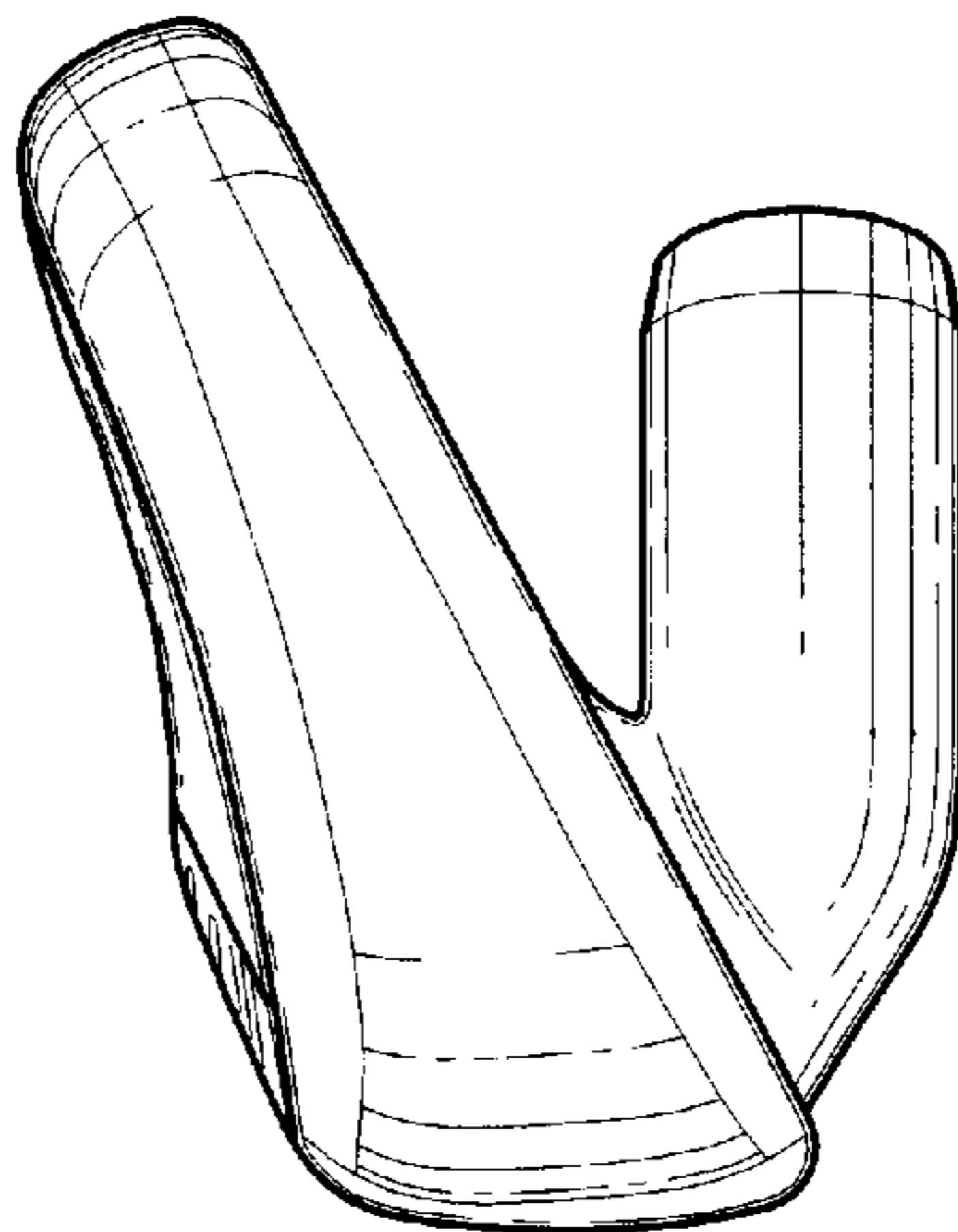
