#### **CLAIM** (57)

The ornamental design for a starting platform top for a swimmer, as shown and described.

### **DESCRIPTION**

The starting platform top for a swimmer can be mounted on a base, stand or pedestal at one end of a swimming pool. A starting platform top for a swimmer is used to position a swimmer in a starting position for a race.

FIG. 1 is a perspective view of a starting platform top for a swimmer showing our new design, as taken from an upper, front, right side vantage;

FIG. 2 is a front view of FIG. 1;

FIG. 3 is a side view of FIG. 1, as seen from the right side, the left side being a mirror image of the right side;


FIG. 4 is a back view of FIG. 1;

FIG. 5 is a top view of FIG. 1; and,

FIG. 6 is a bottom plan view of the starting platform top for a swimmer.

The broken lines shown in FIG. 6 show the boundaries of the claimed design. Both the broken line itself and the unshaded region framed by the broken lines do nto form part of the claimed design.










