The ornamental design for a night light, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a night light;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a top view thereof;
FIG. 4 is a right elevational view thereof;
FIG. 5 is a bottom view thereof;
FIG. 6 is a rear view thereof;
FIG. 7 is a front elevational view of another embodiment of the night light;
FIG. 8 is a top view of the another embodiment thereof; and,
FIG. 9 is a right elevational view of the another embodiment thereof.

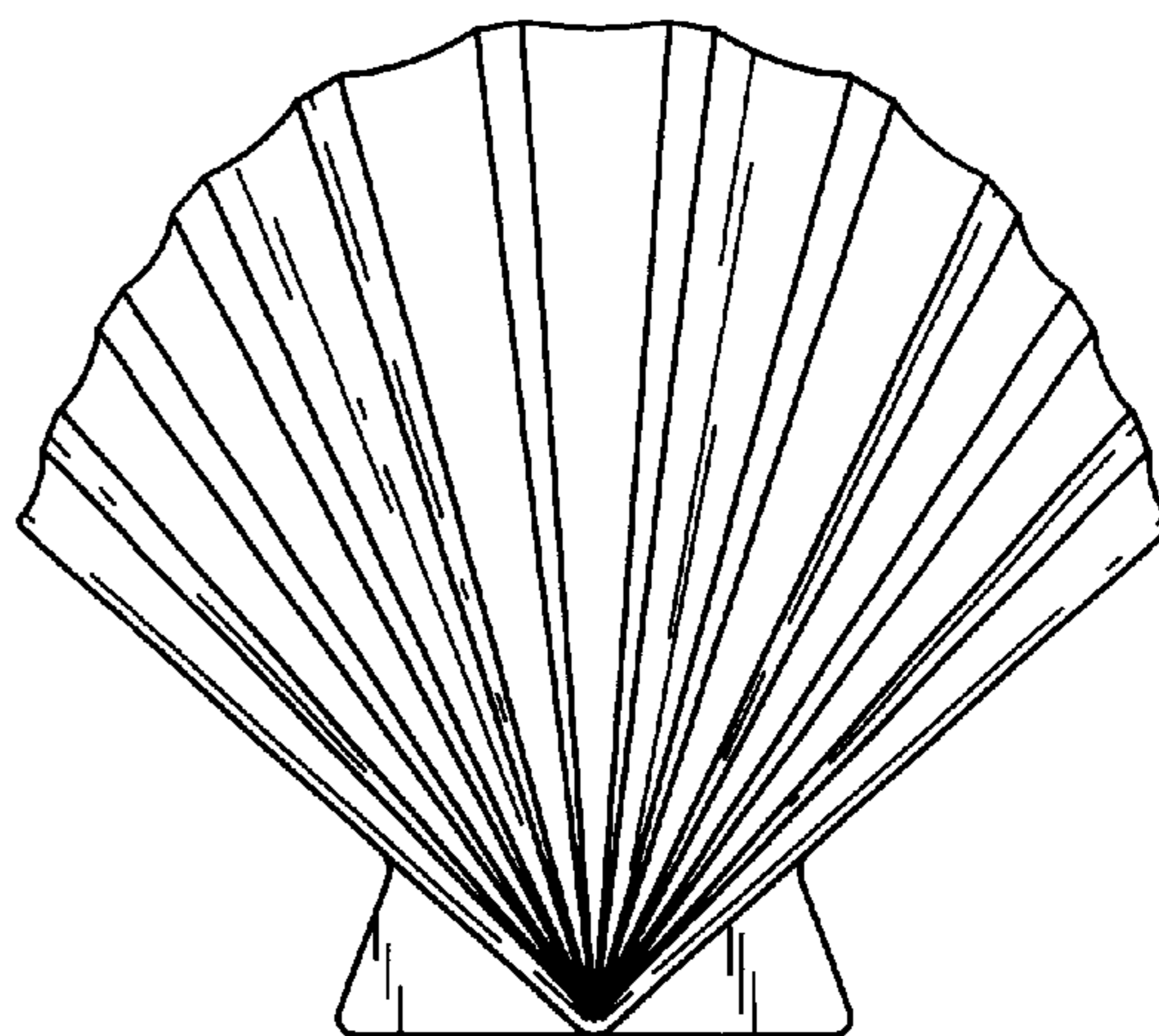
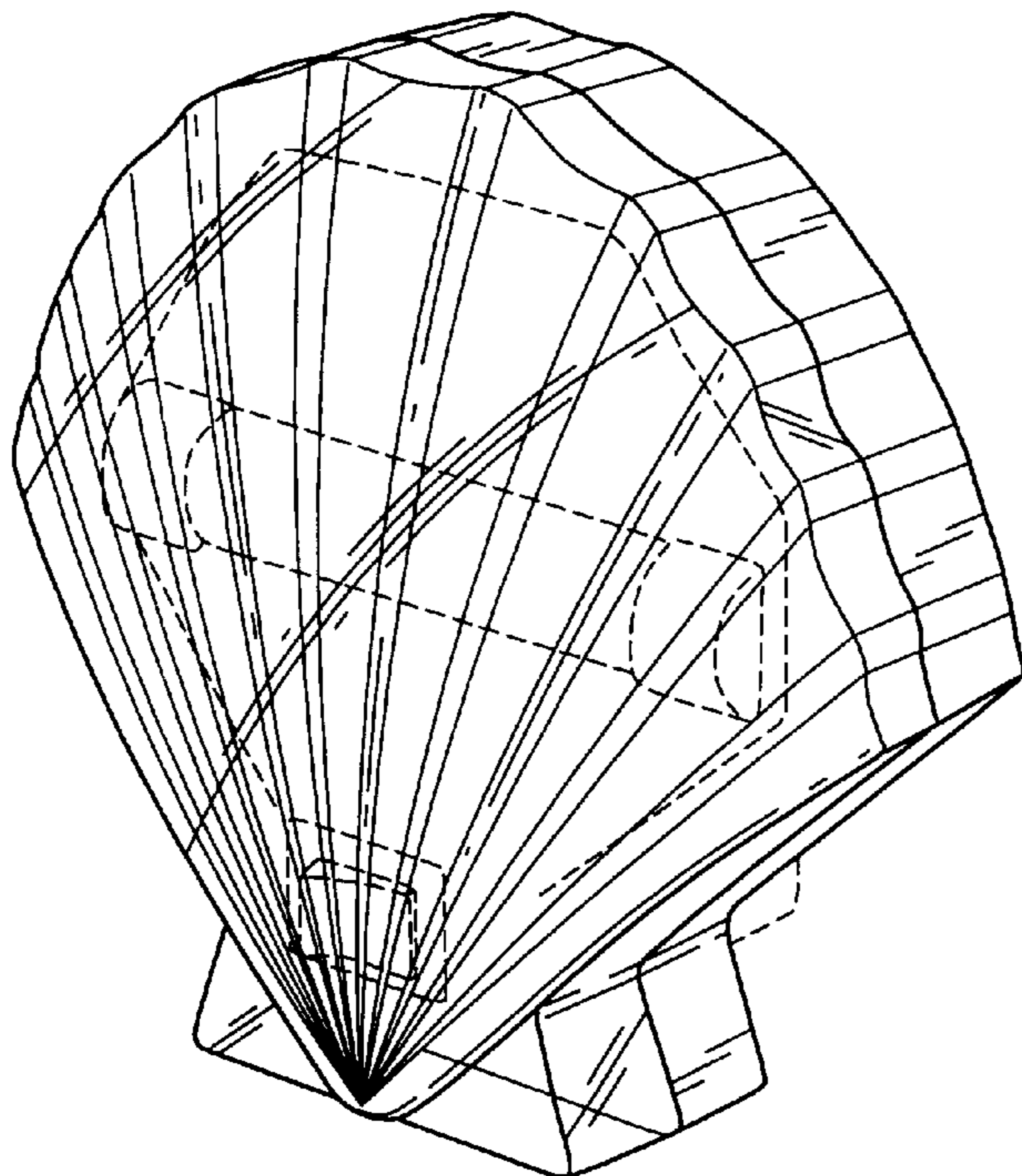

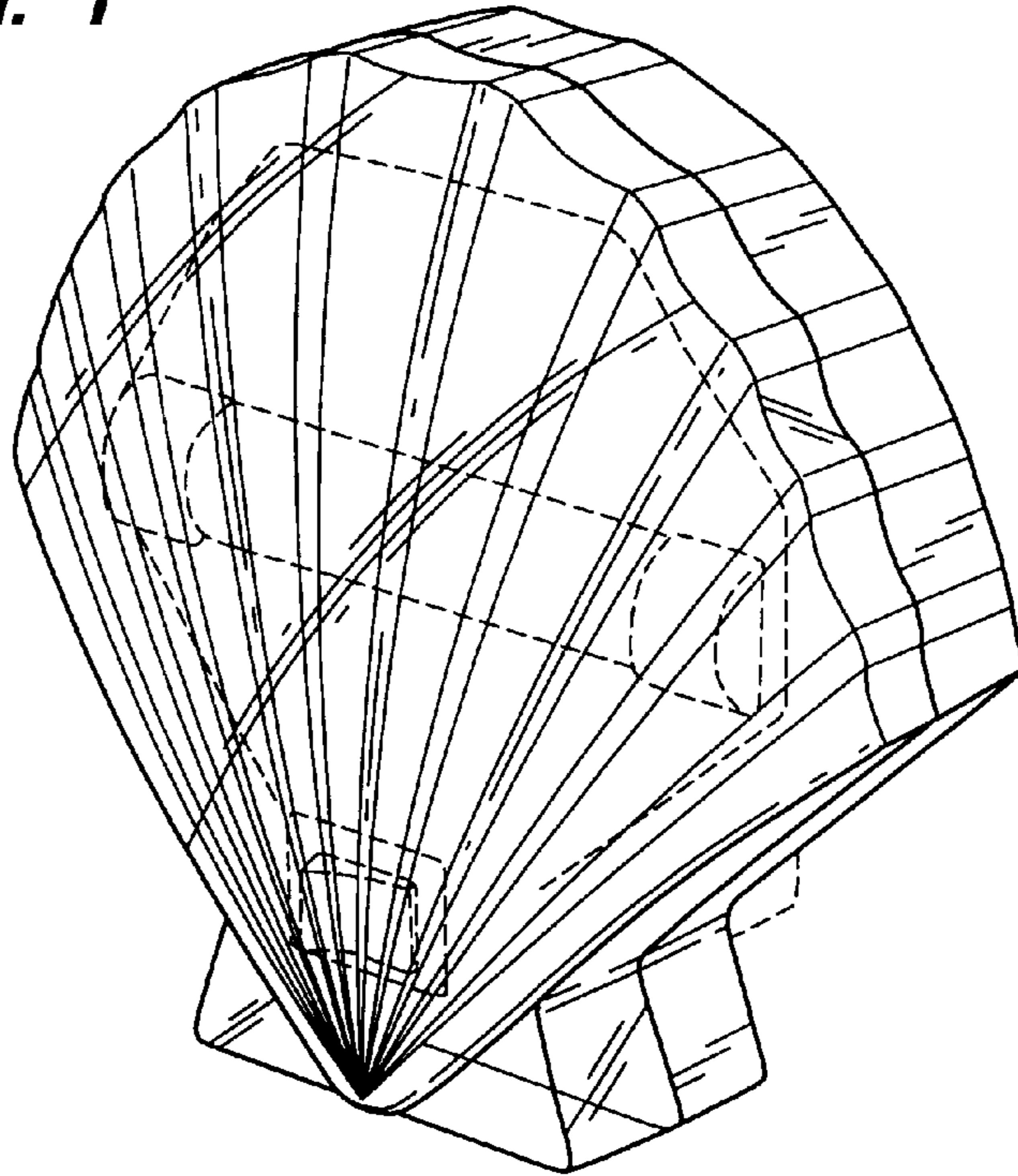

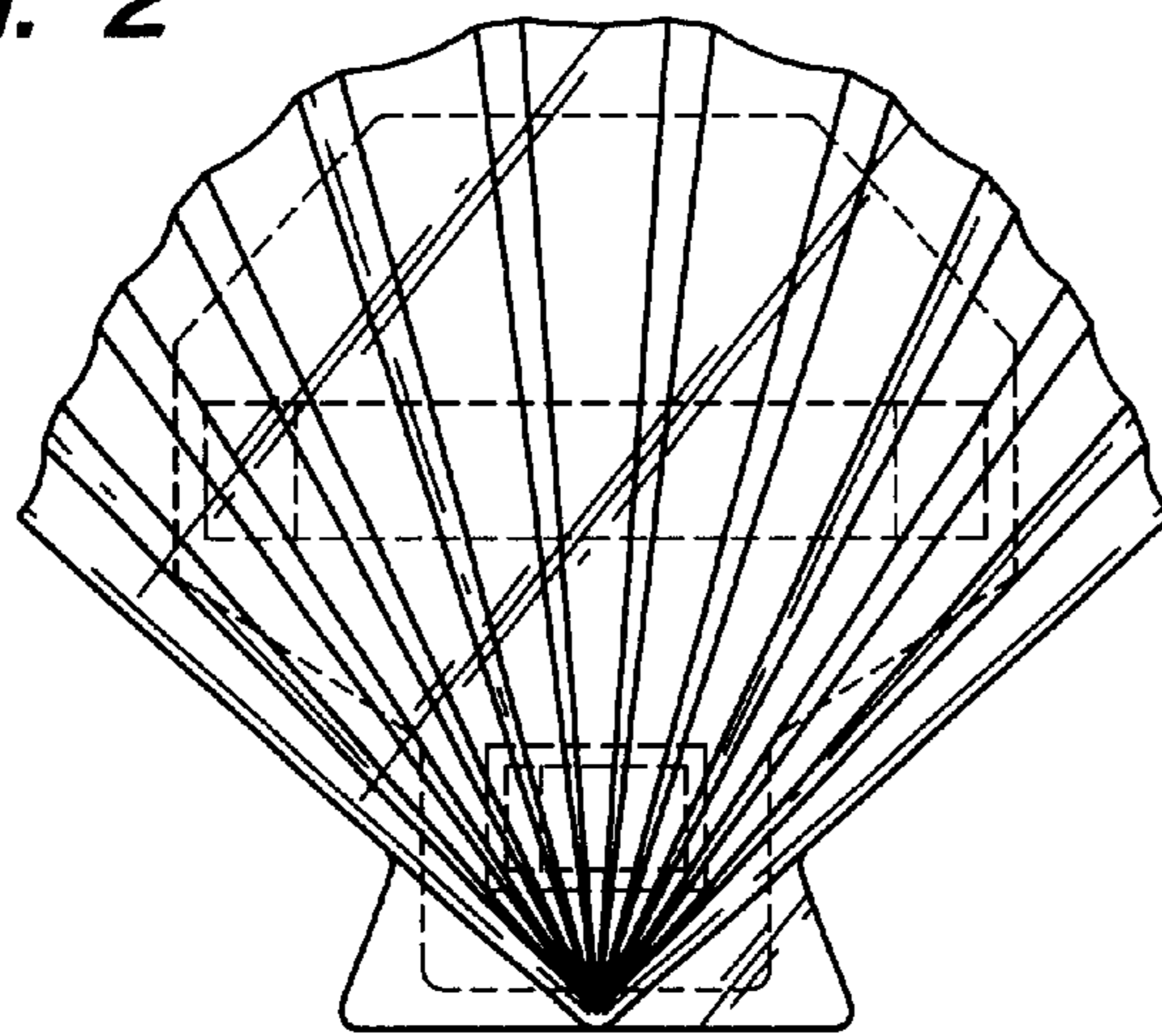

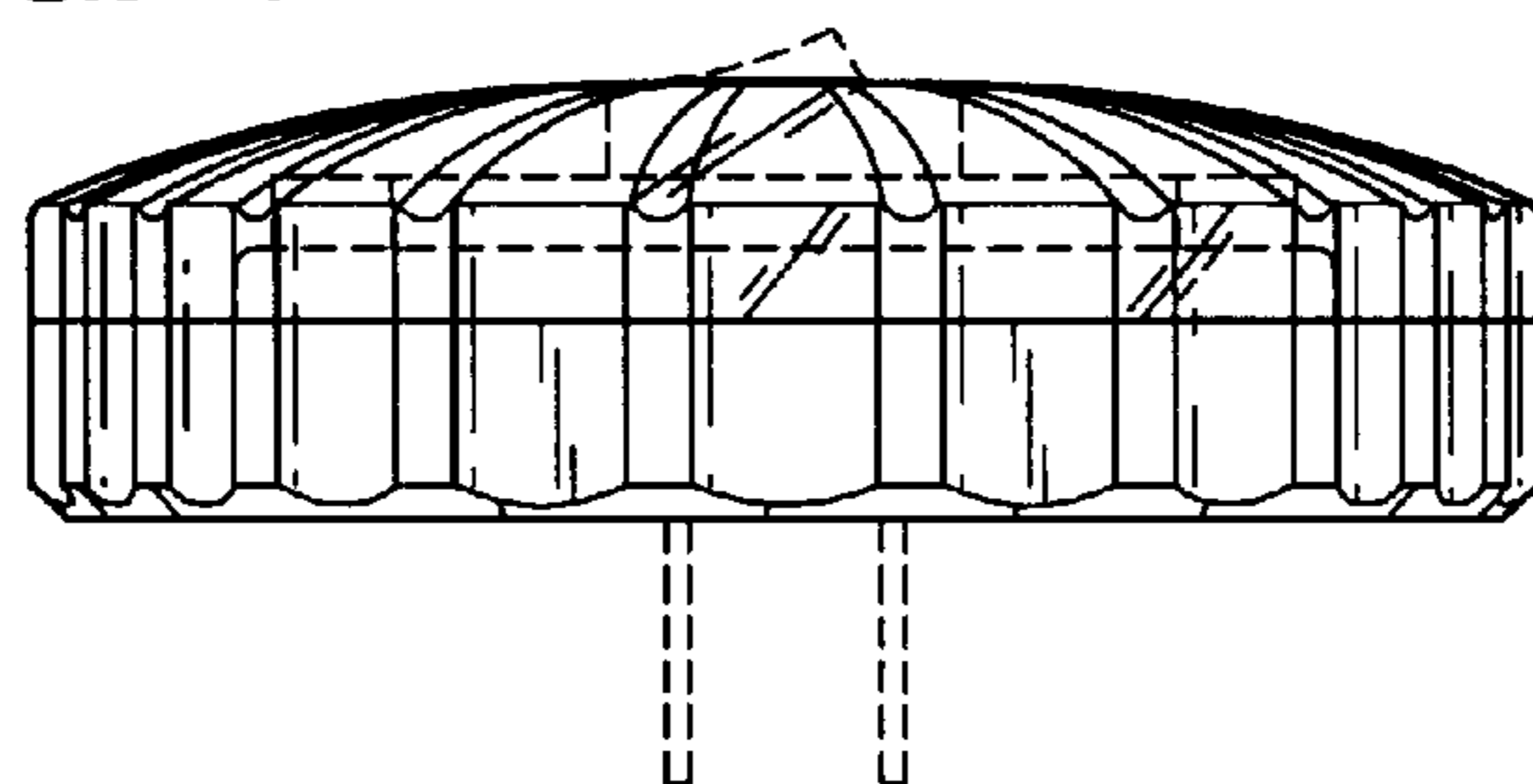

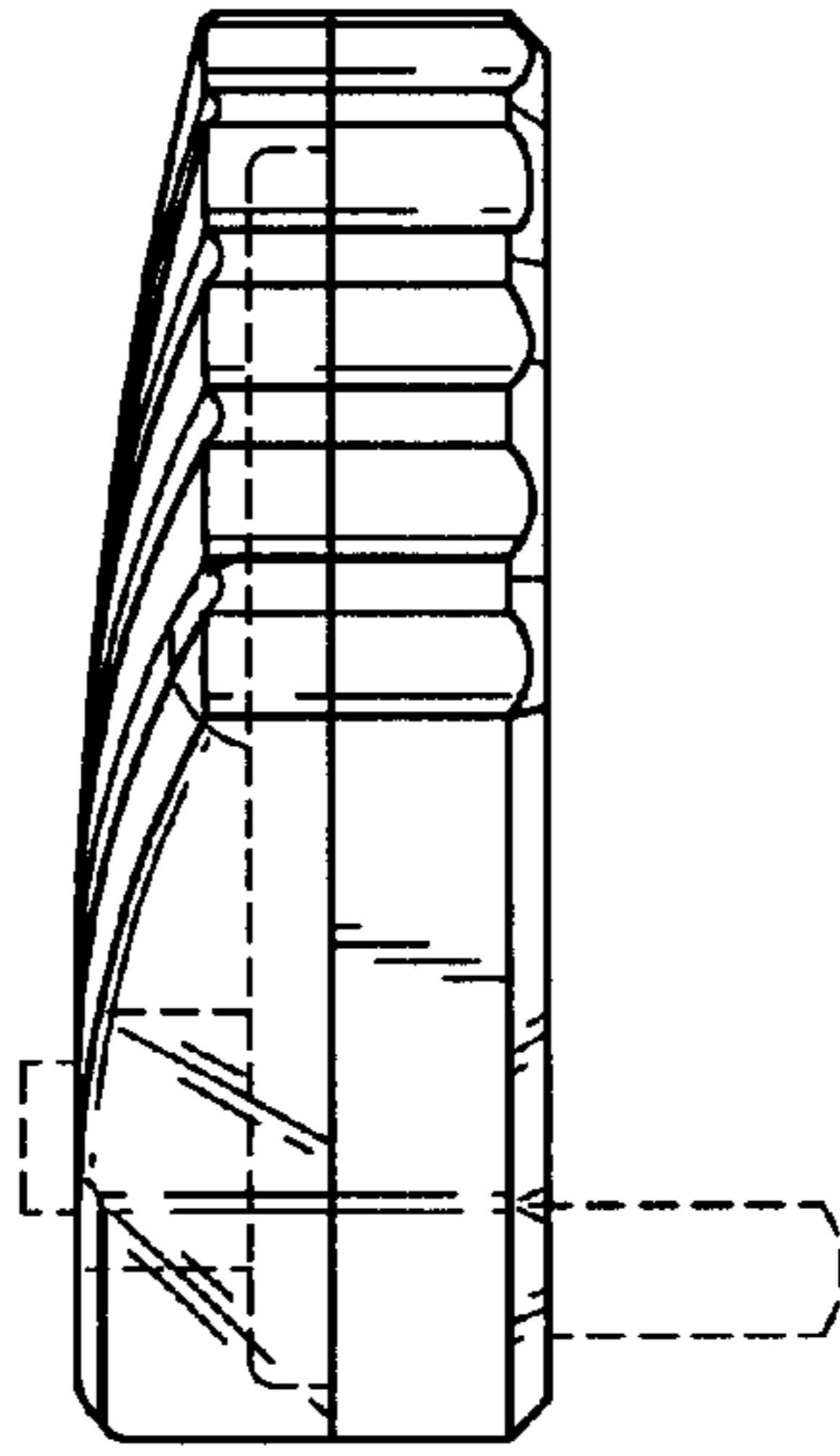

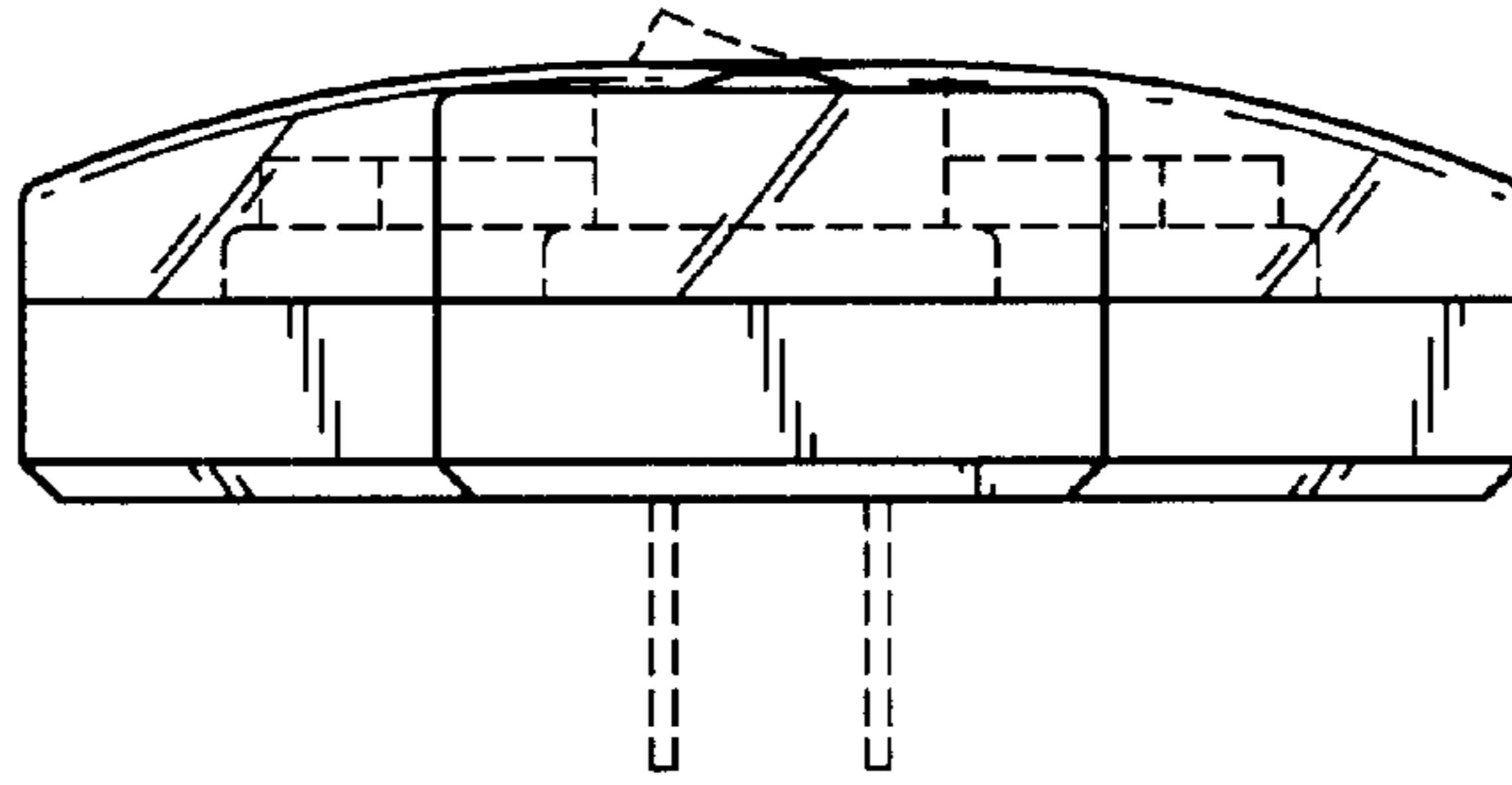

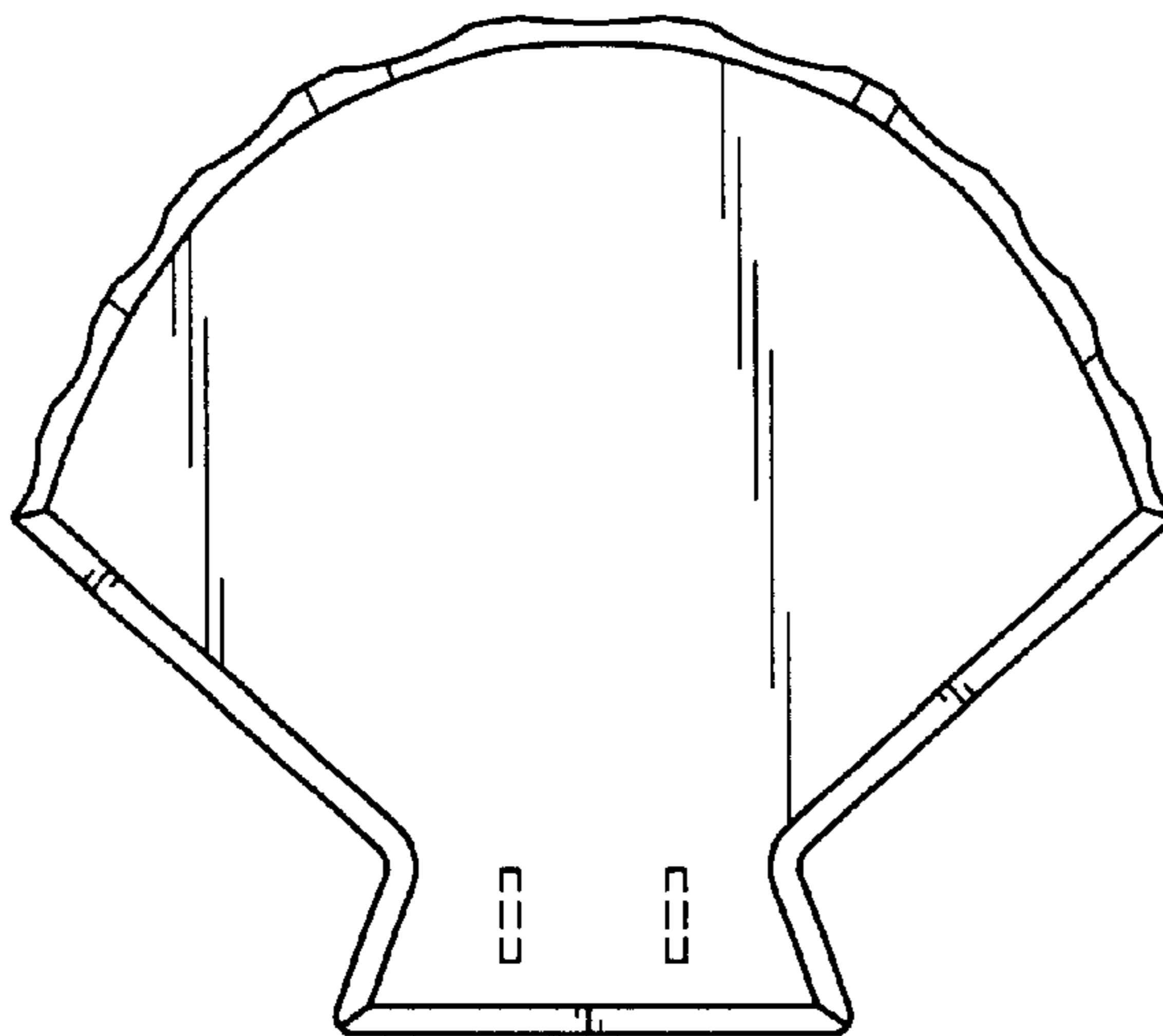

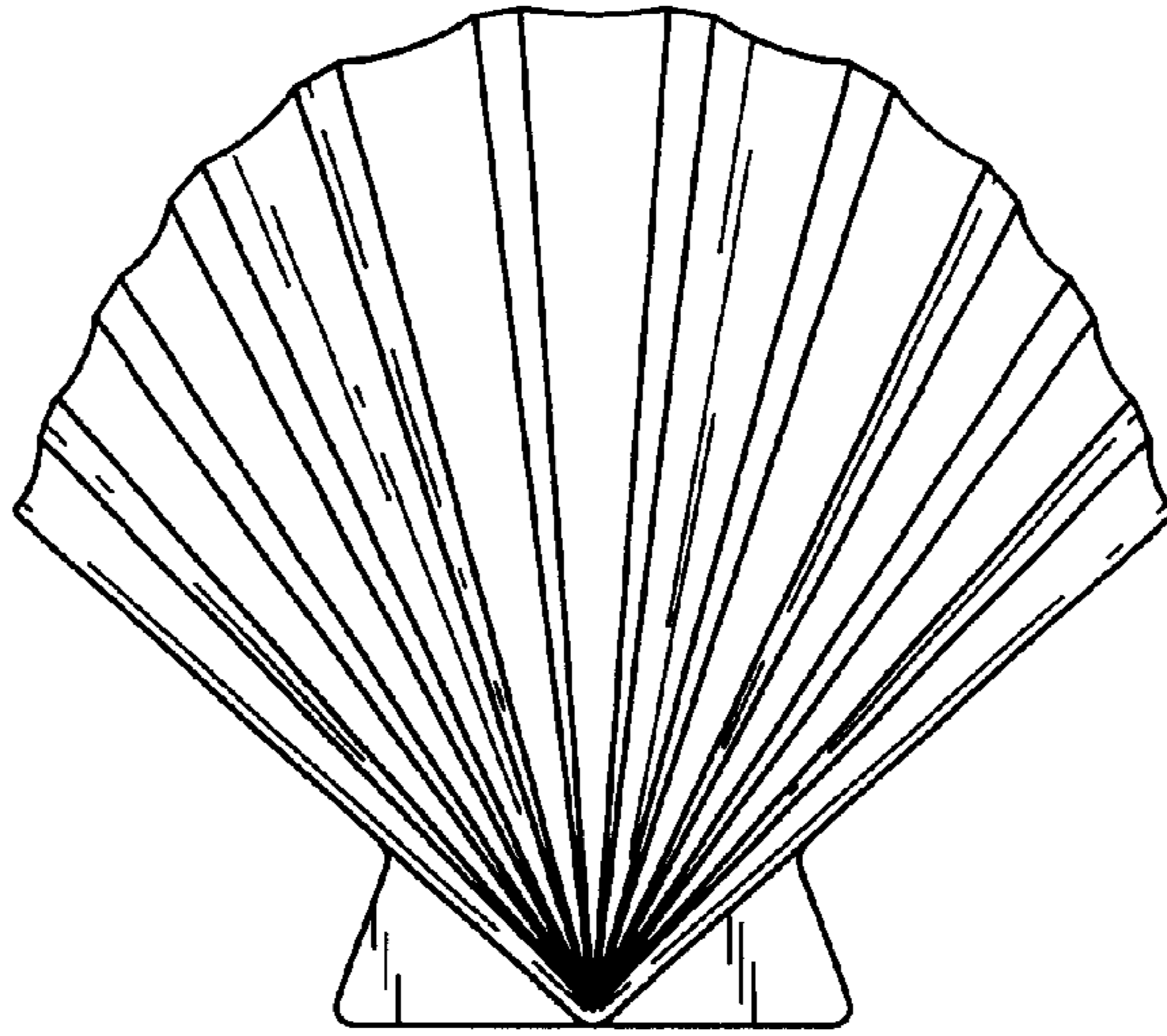

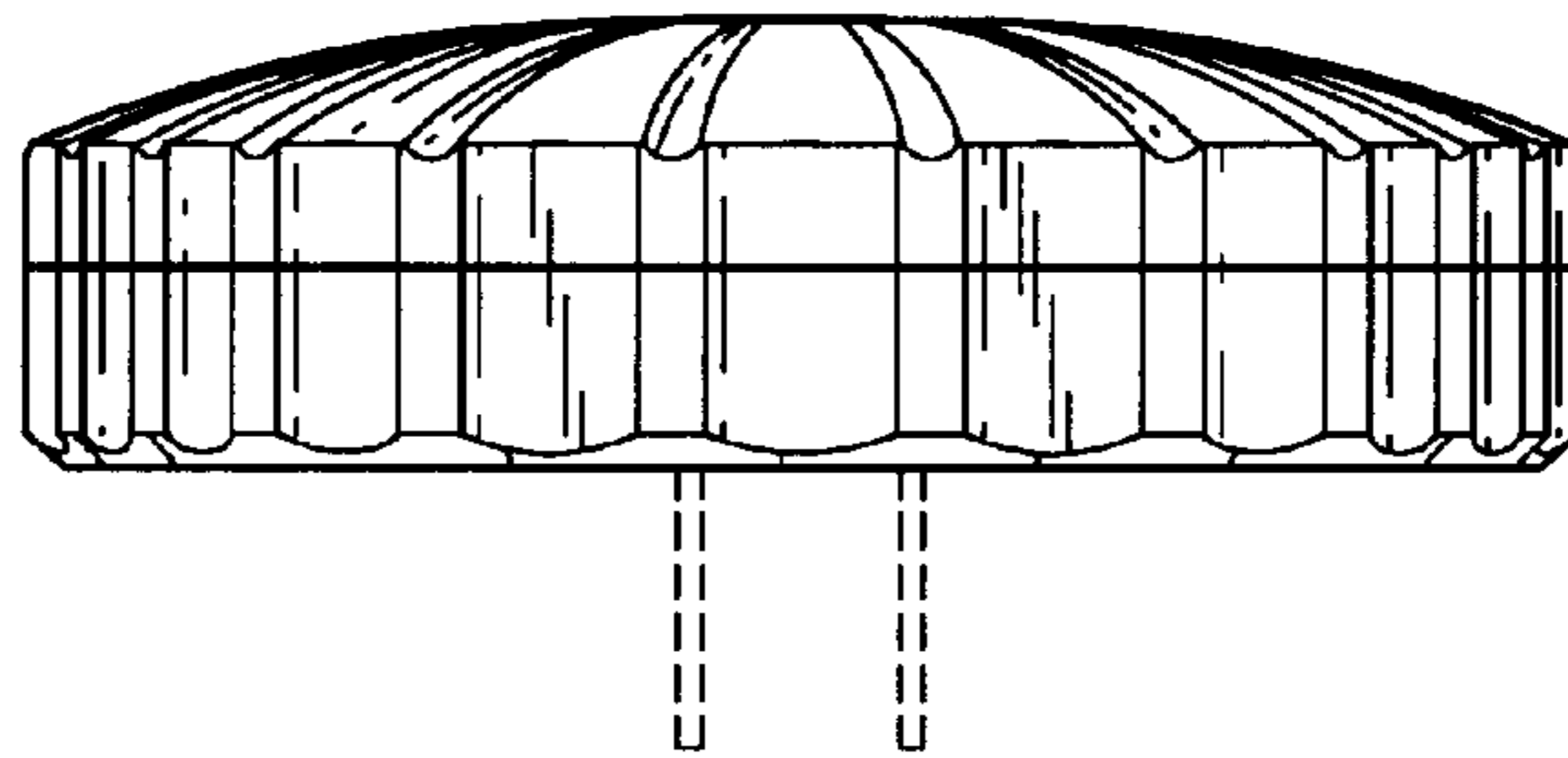
