(57) **CLAIM**

The ornamental design for a “hands free cellular system”, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a hands free cellular system showing my new design, the cord is drawn broken away to show indeterminate length;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

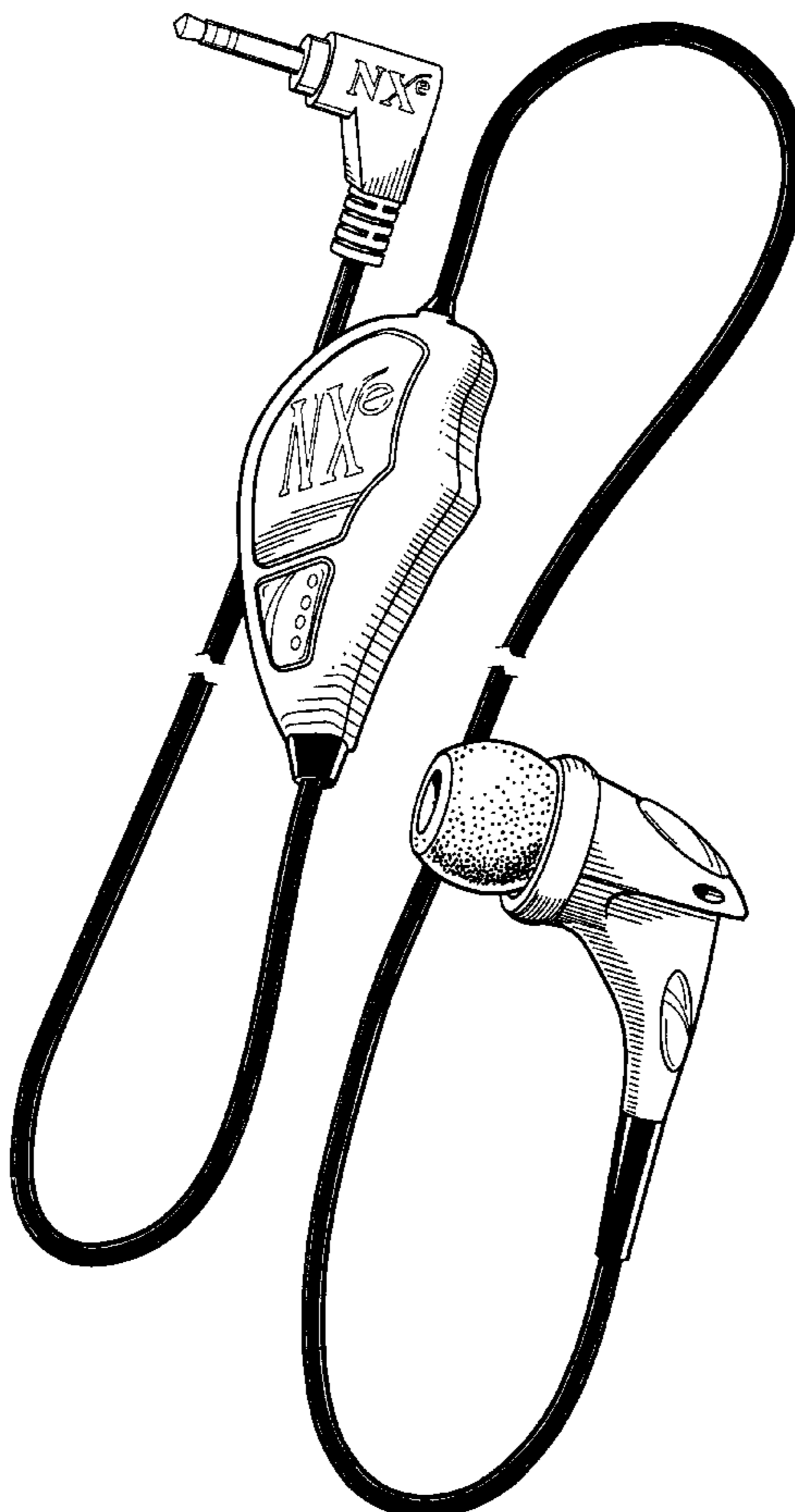
FIG. 4 is a right side elevational view thereof (and also a mirror image of the left side, except as shown in FIG. 5);

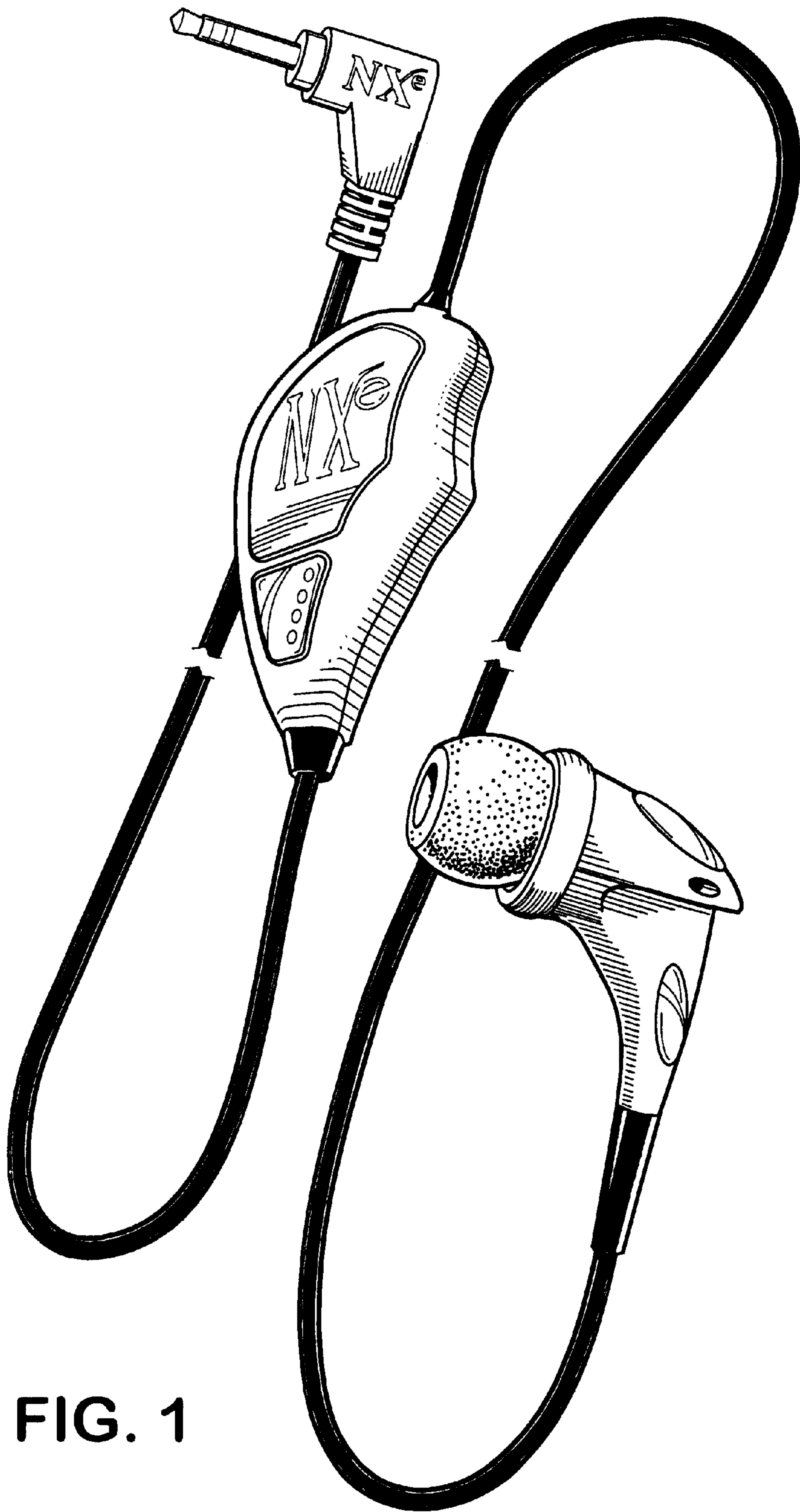

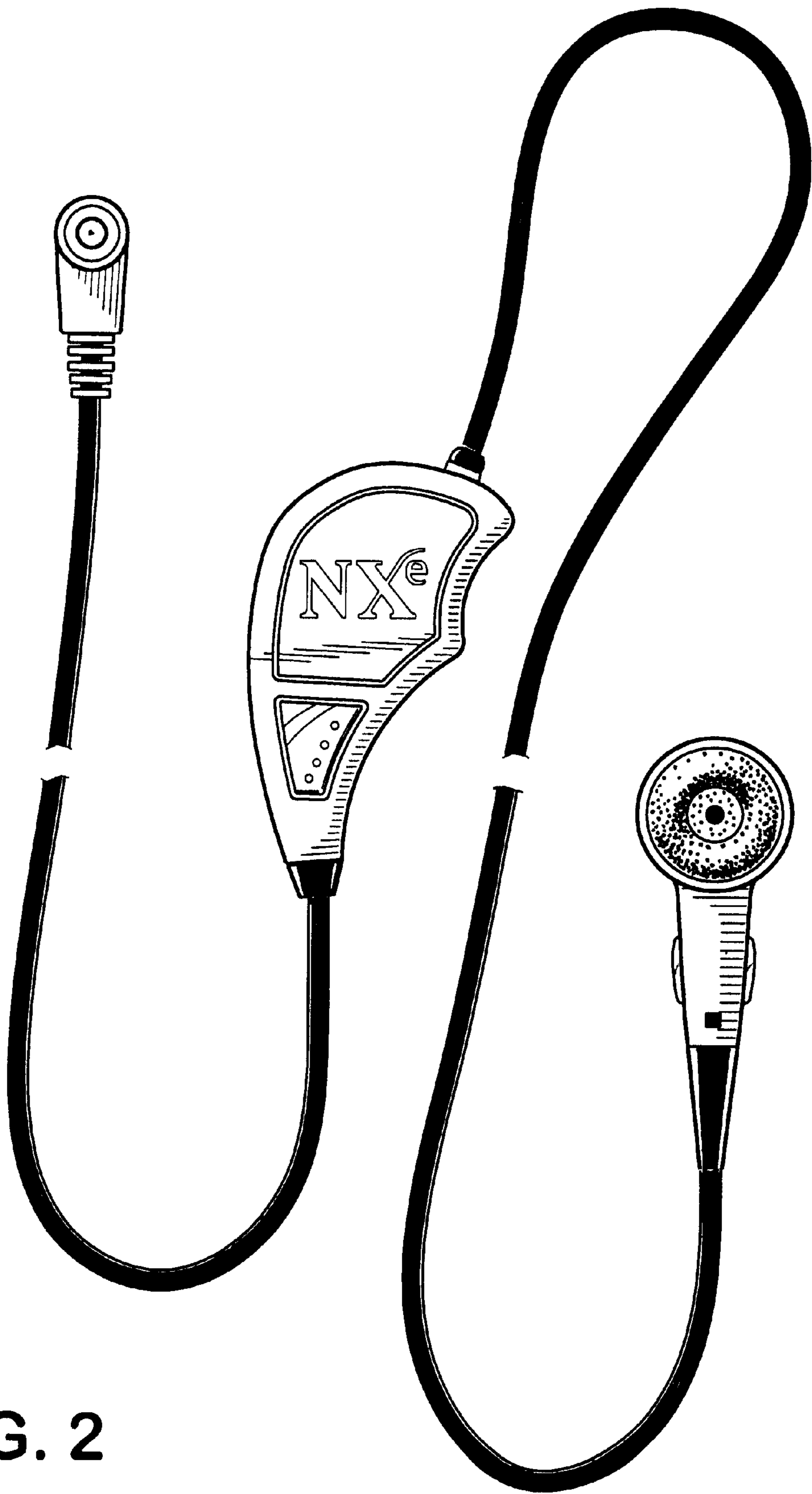

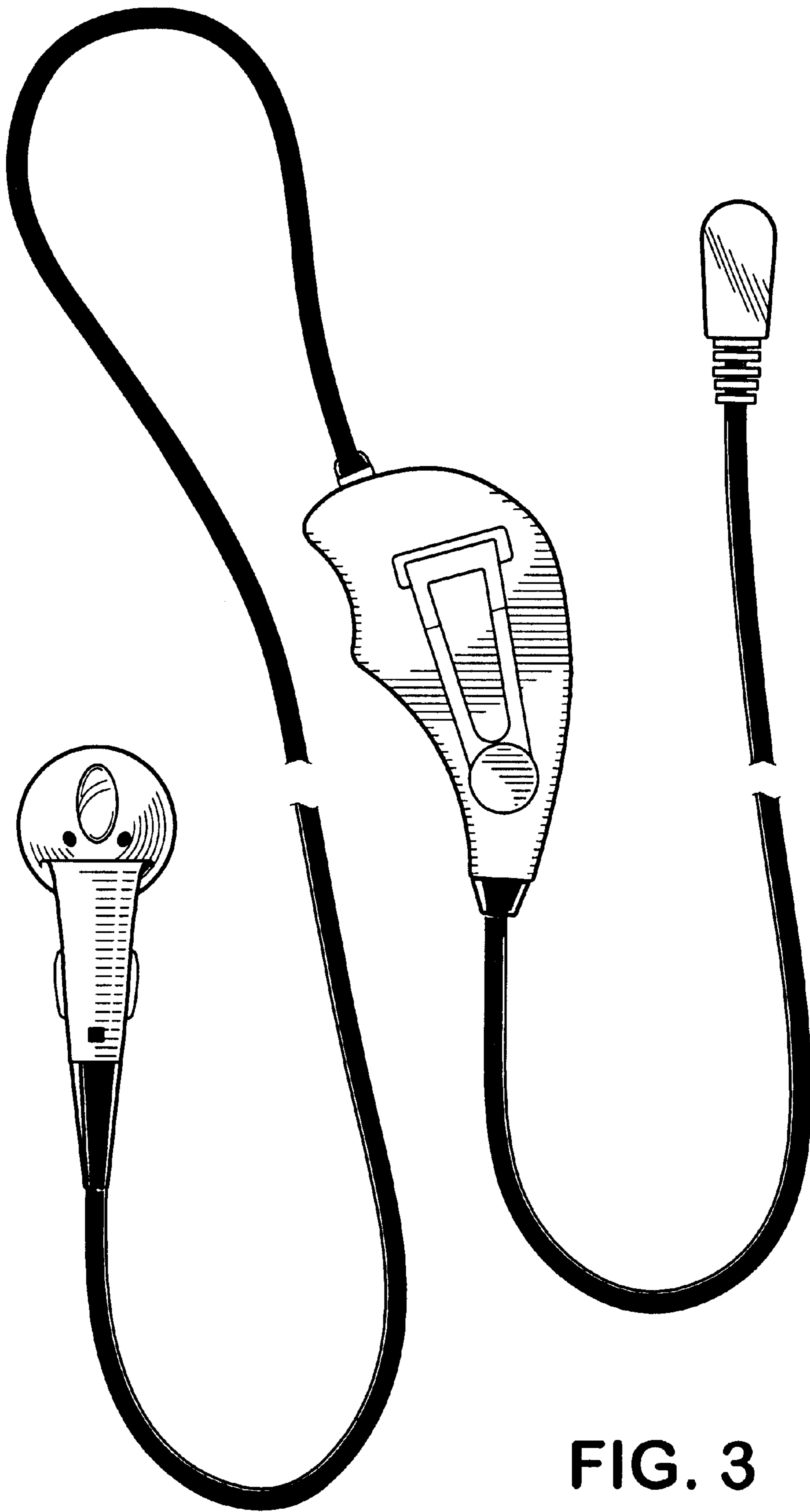

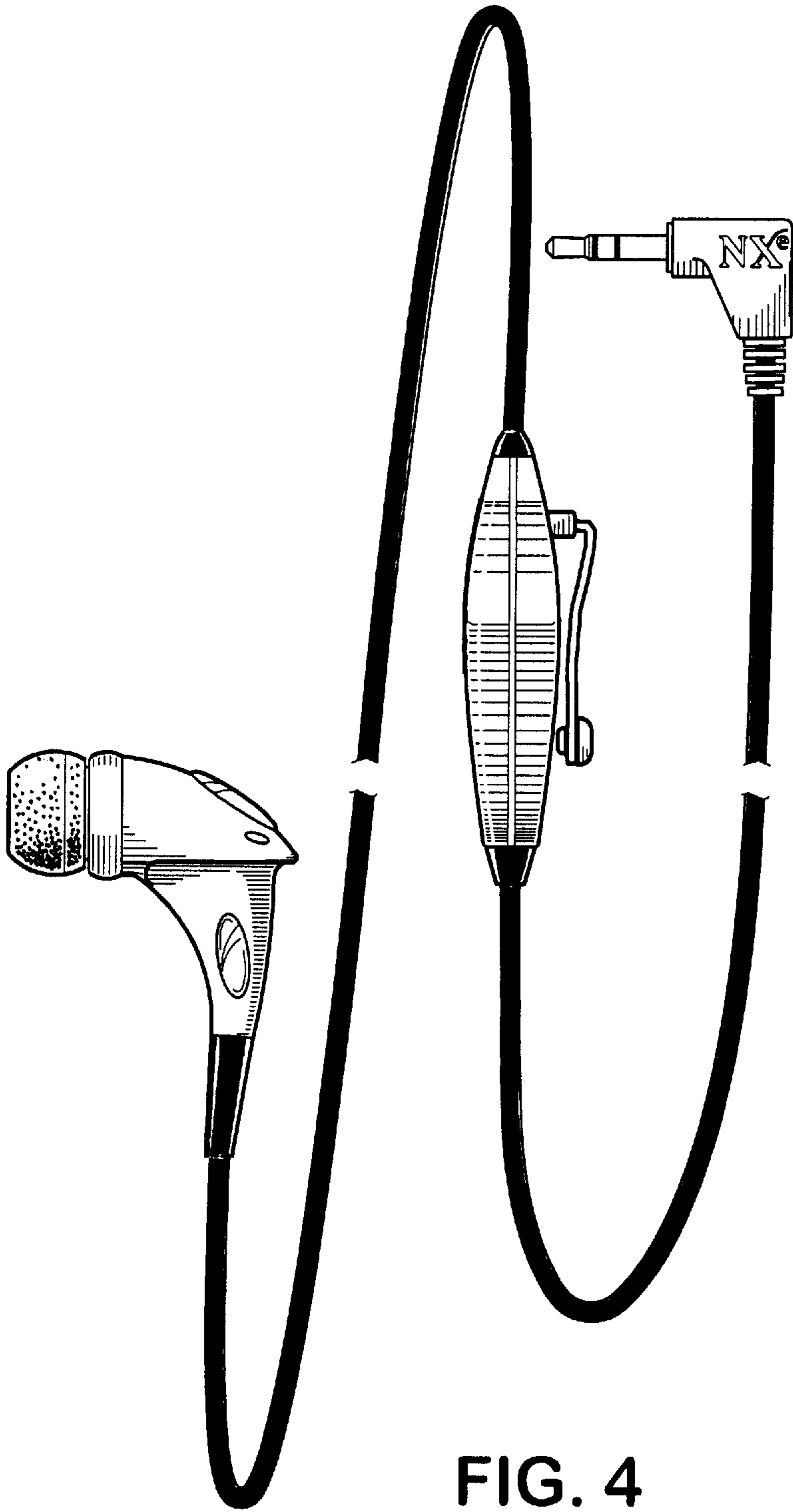

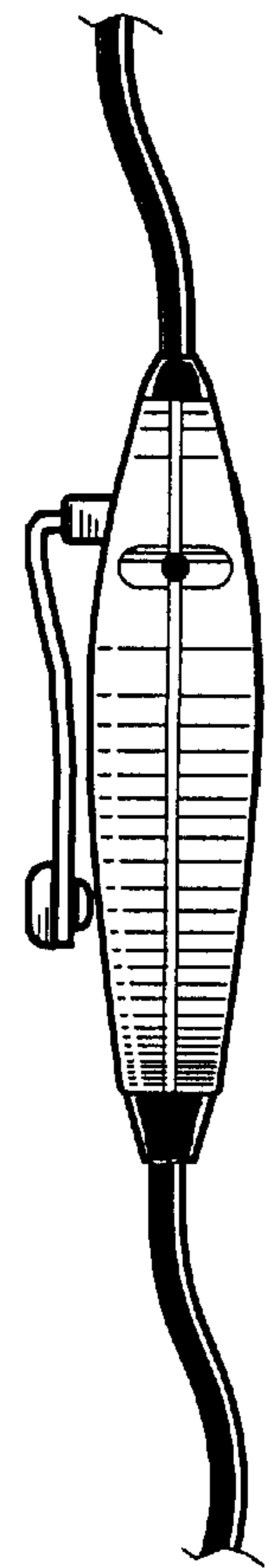

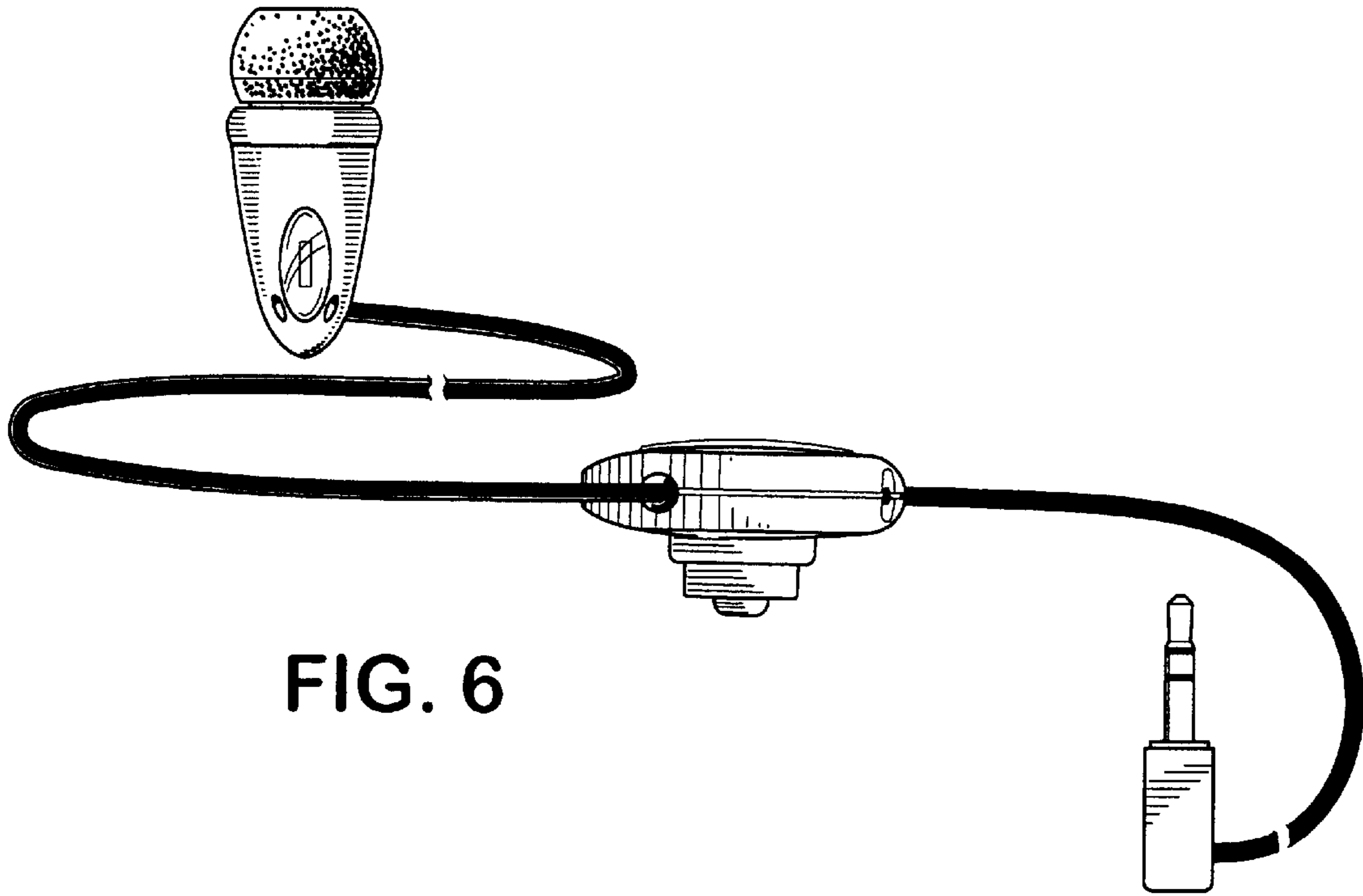

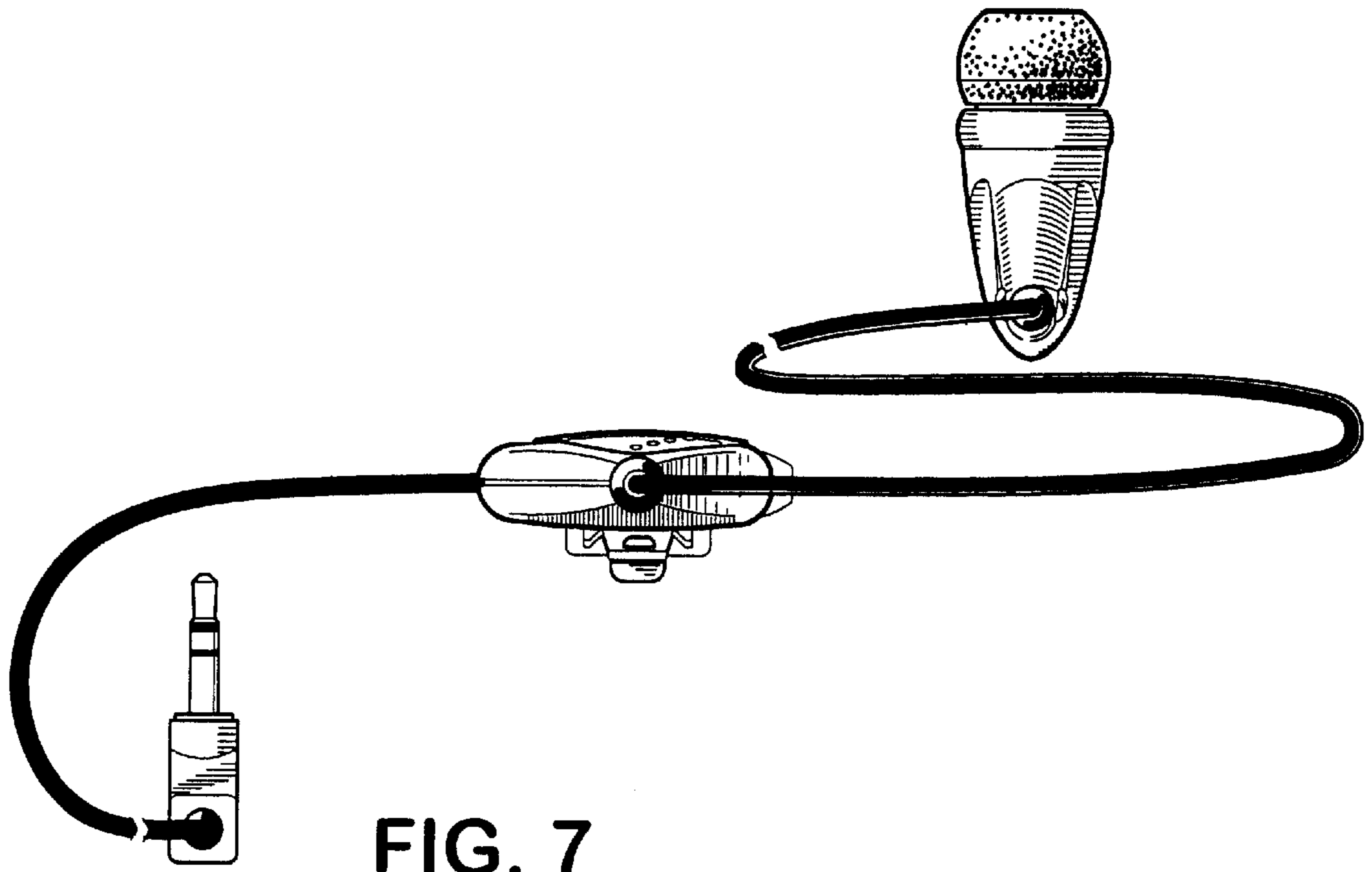
