(57) **CLAIM**

The ornamental design for a pentagon tent, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a pentagon tent of the present invention including a fly;
FIG. 2 is a right side elevational view of the tent of FIG. 1, the left side elevational view being a mirror image thereof;
FIG. 3 is a rear elevational view of thereof;
FIG. 4 is a top plan view thereof;
FIG. 5 is a bottom plan view thereof;
FIG. 6 is a front elevational view thereof, with the fly shown removed;
FIG. 7 is a right side elevational view of the tent of FIG. 6, the left side elevational view being a mirror image thereof;
FIG. 8 is a rear elevational view thereof;
FIG. 9 is a top plan view thereof; and,
FIG. 10 is a bottom plan view thereof.

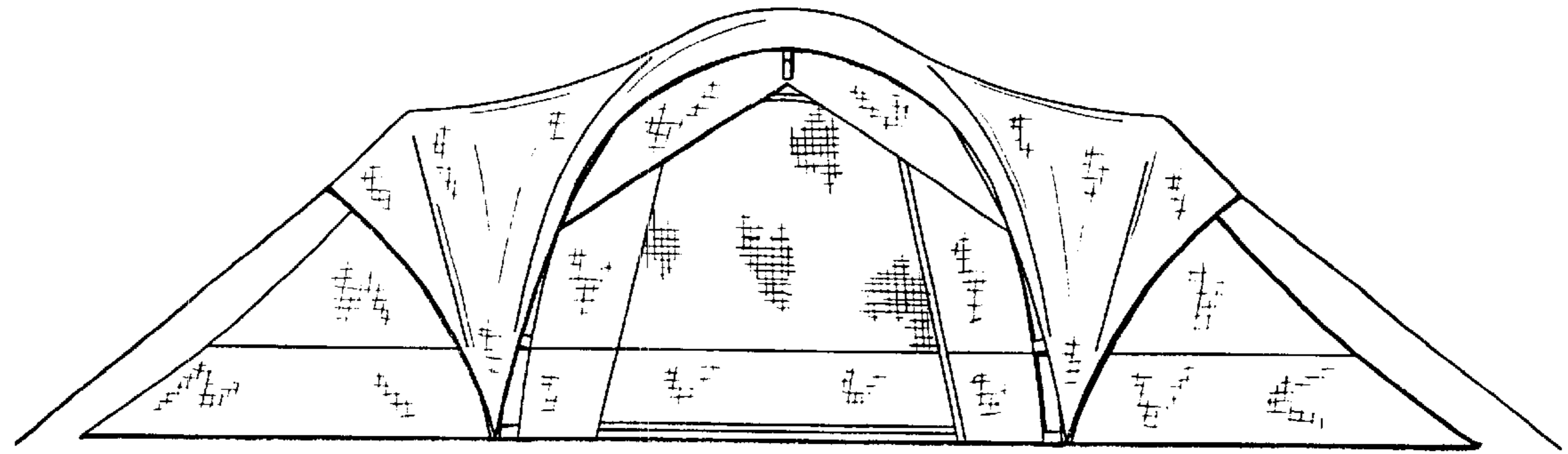

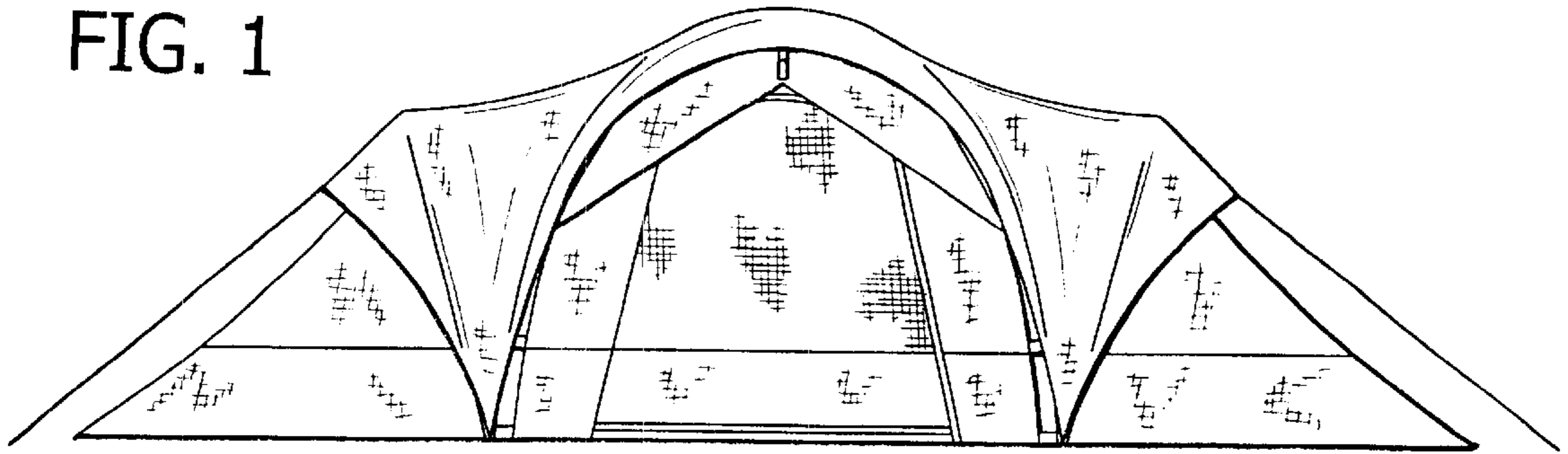

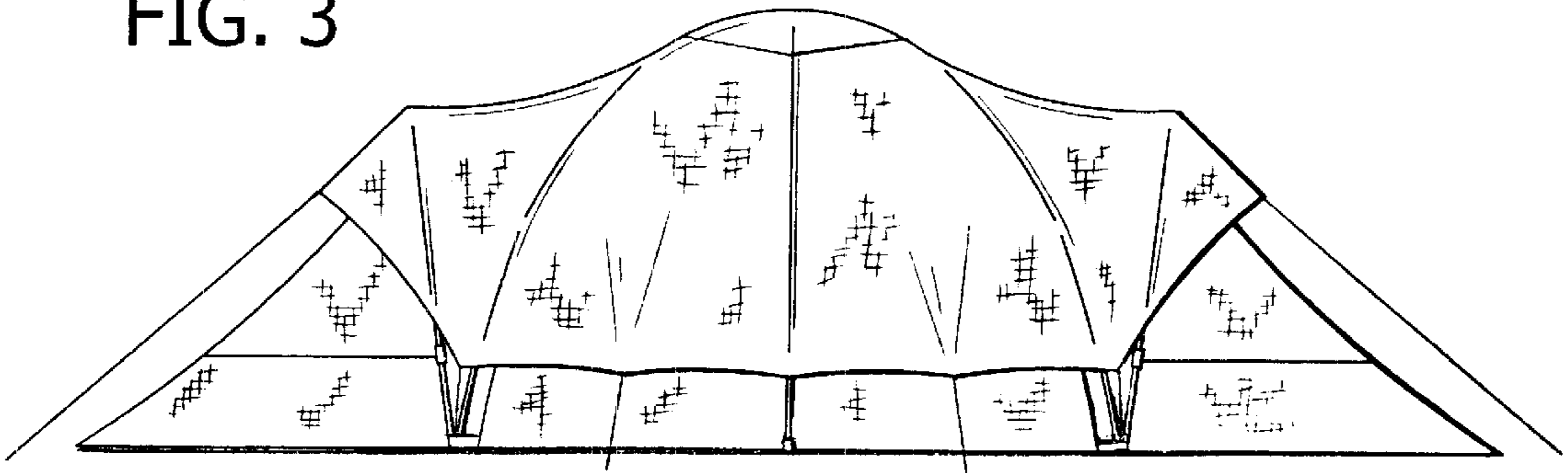

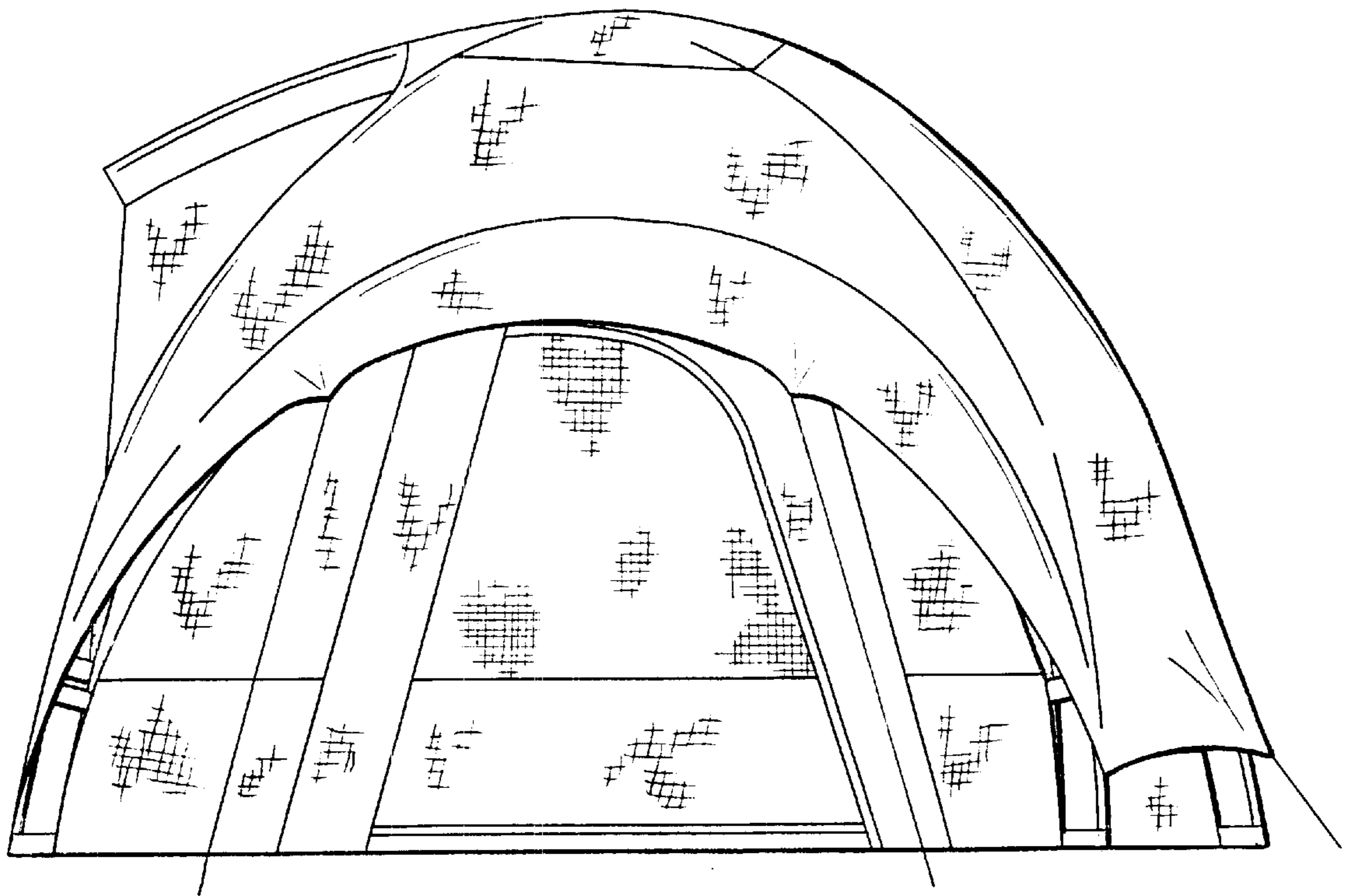

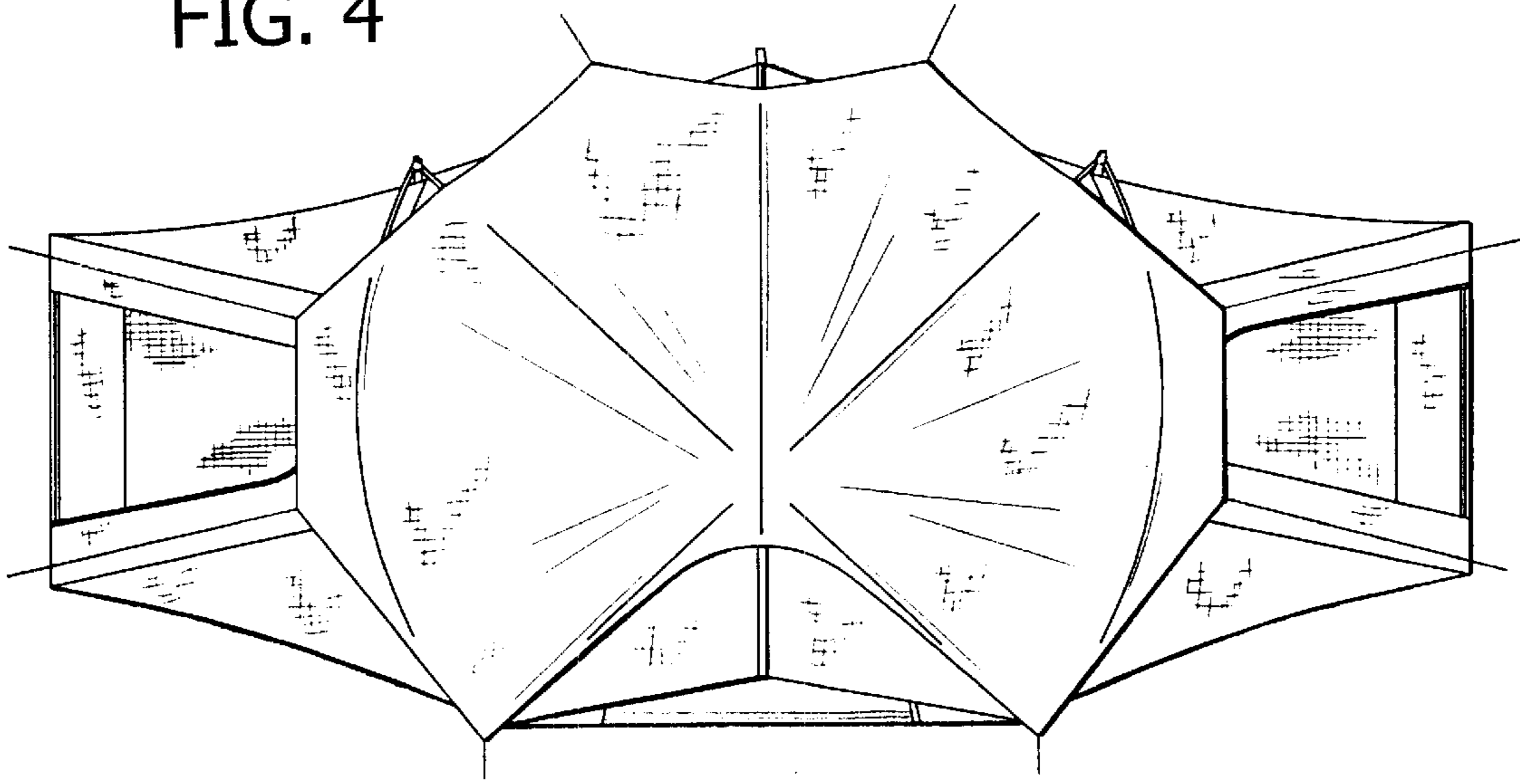

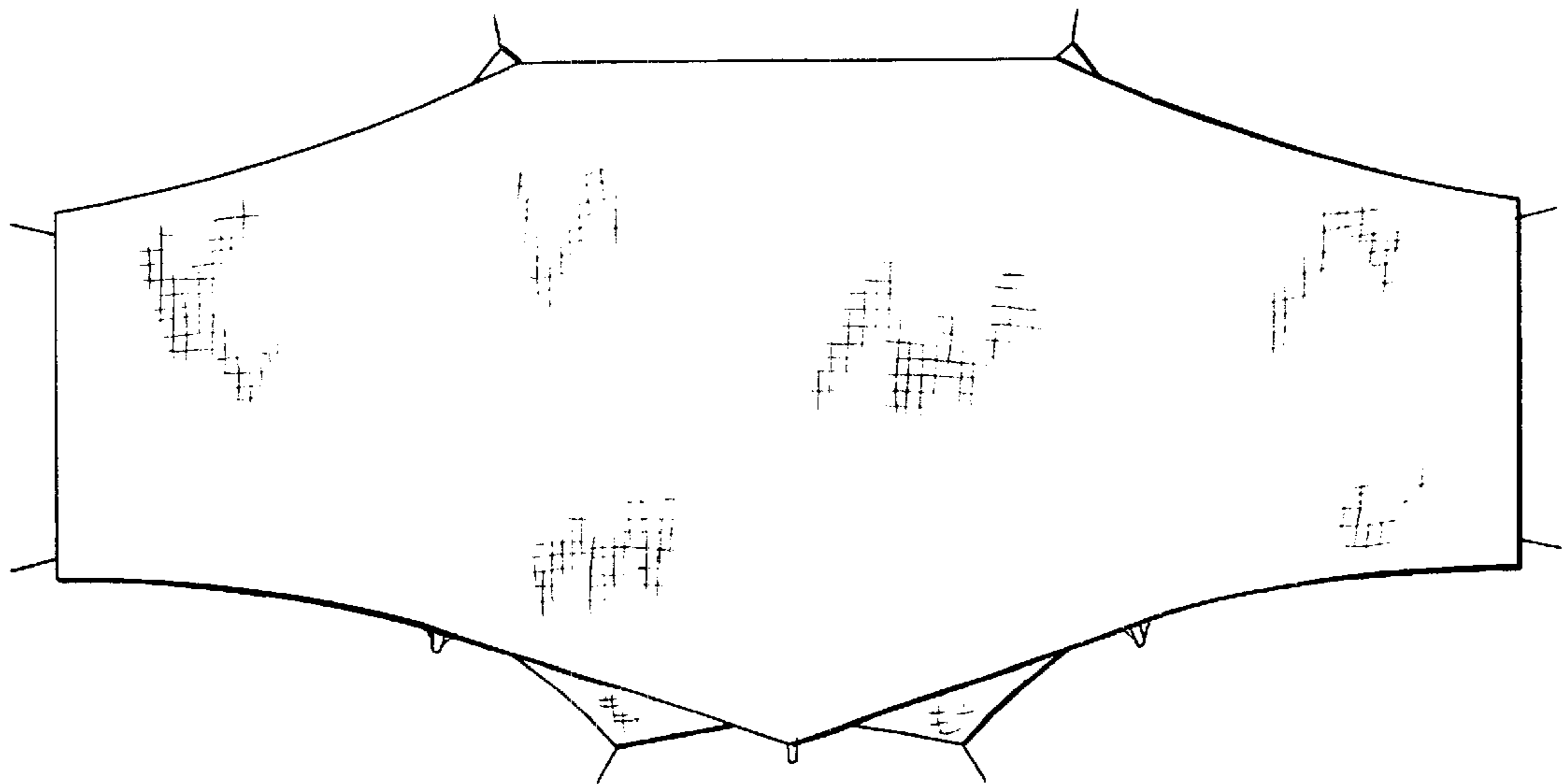

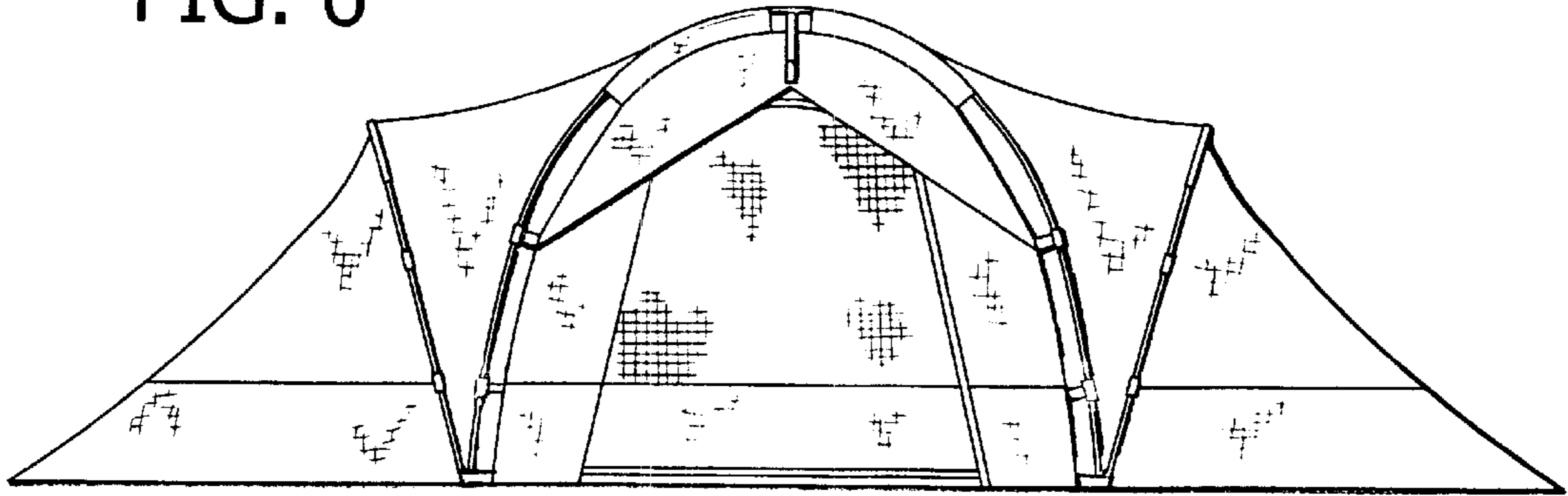

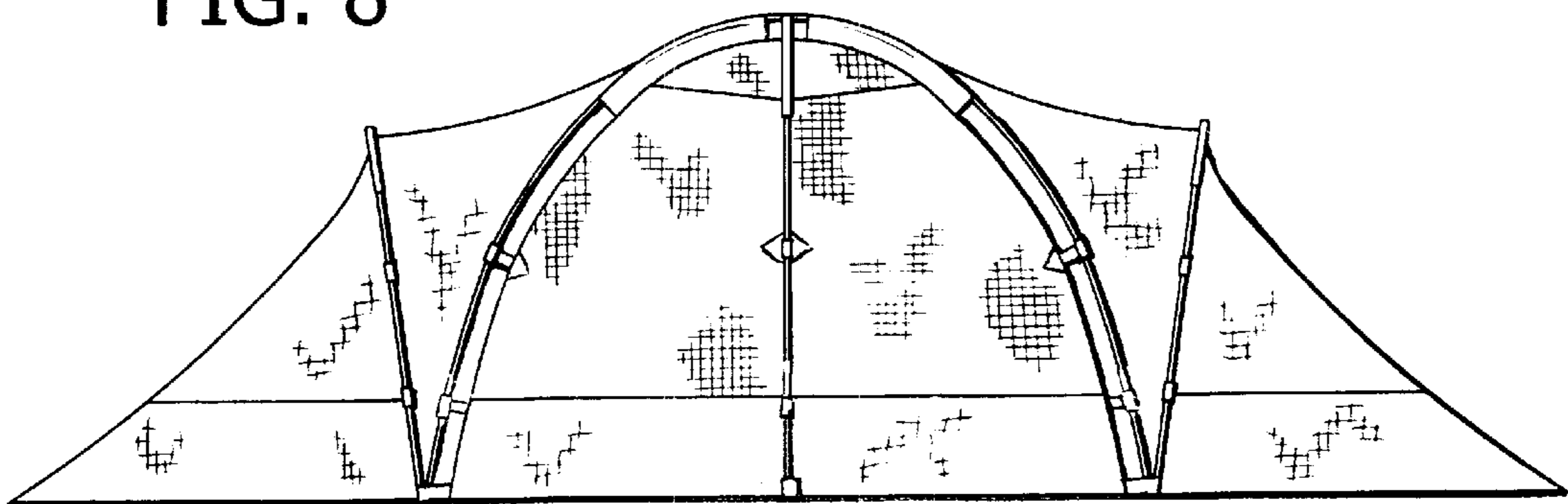

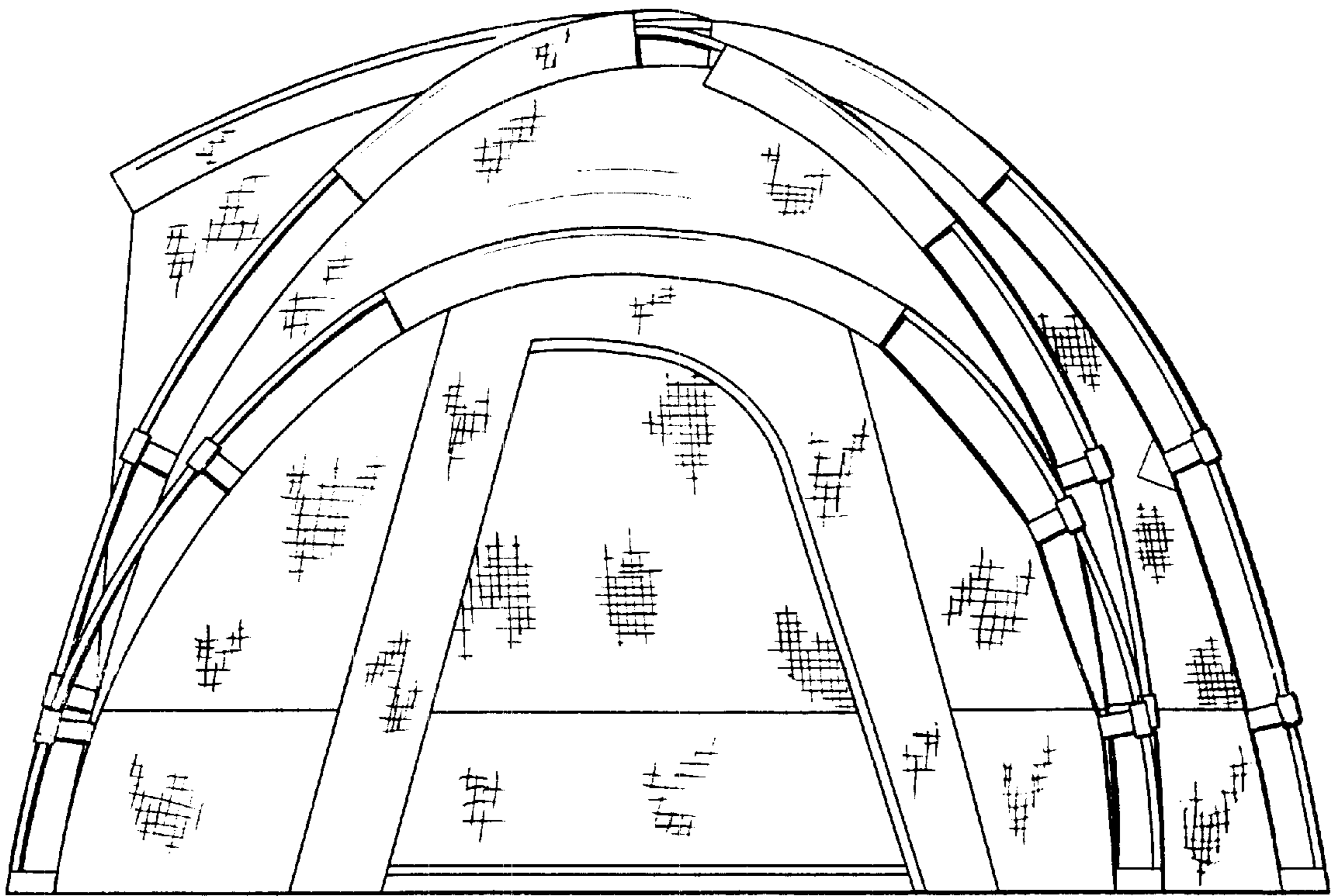

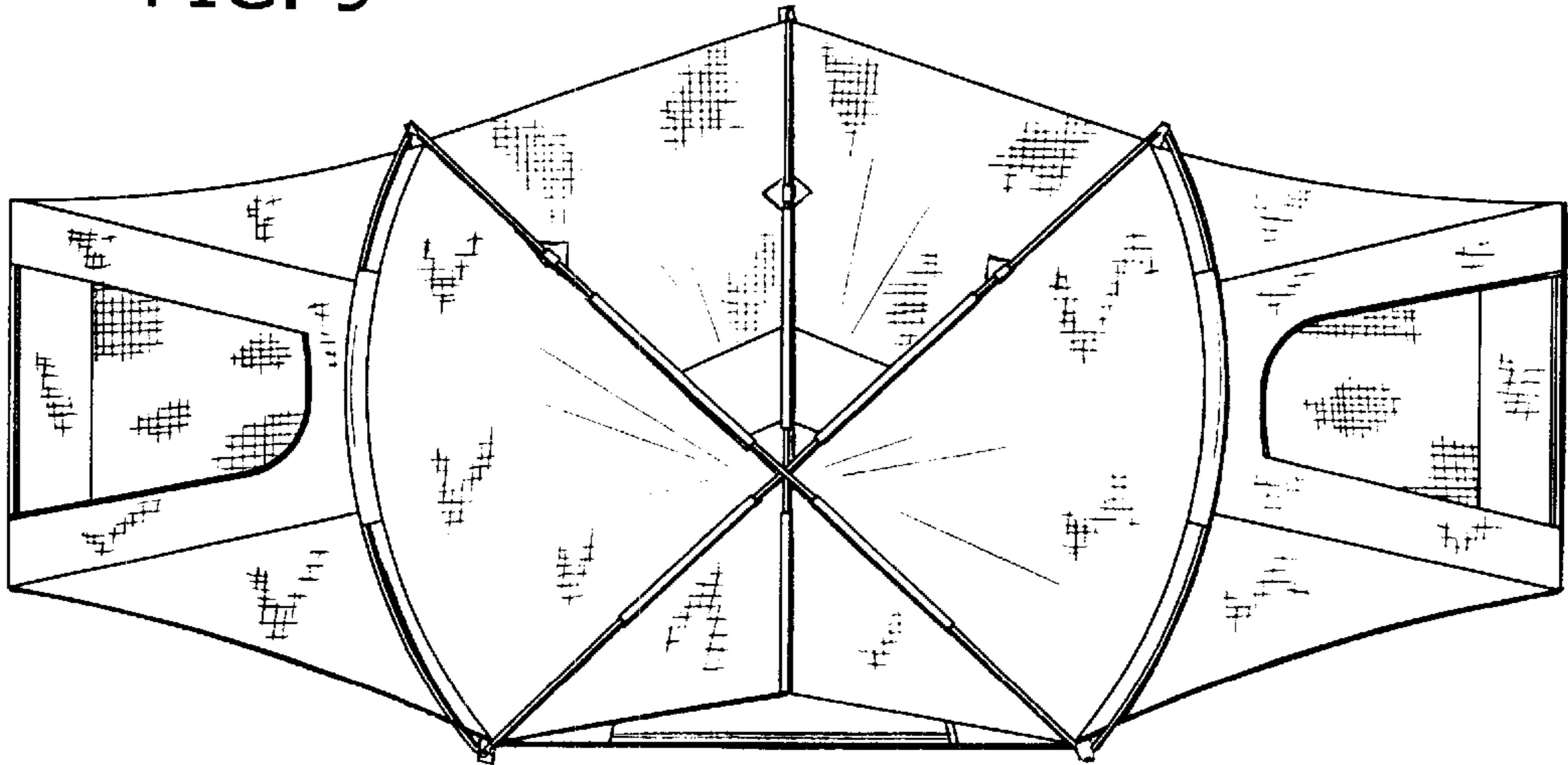
