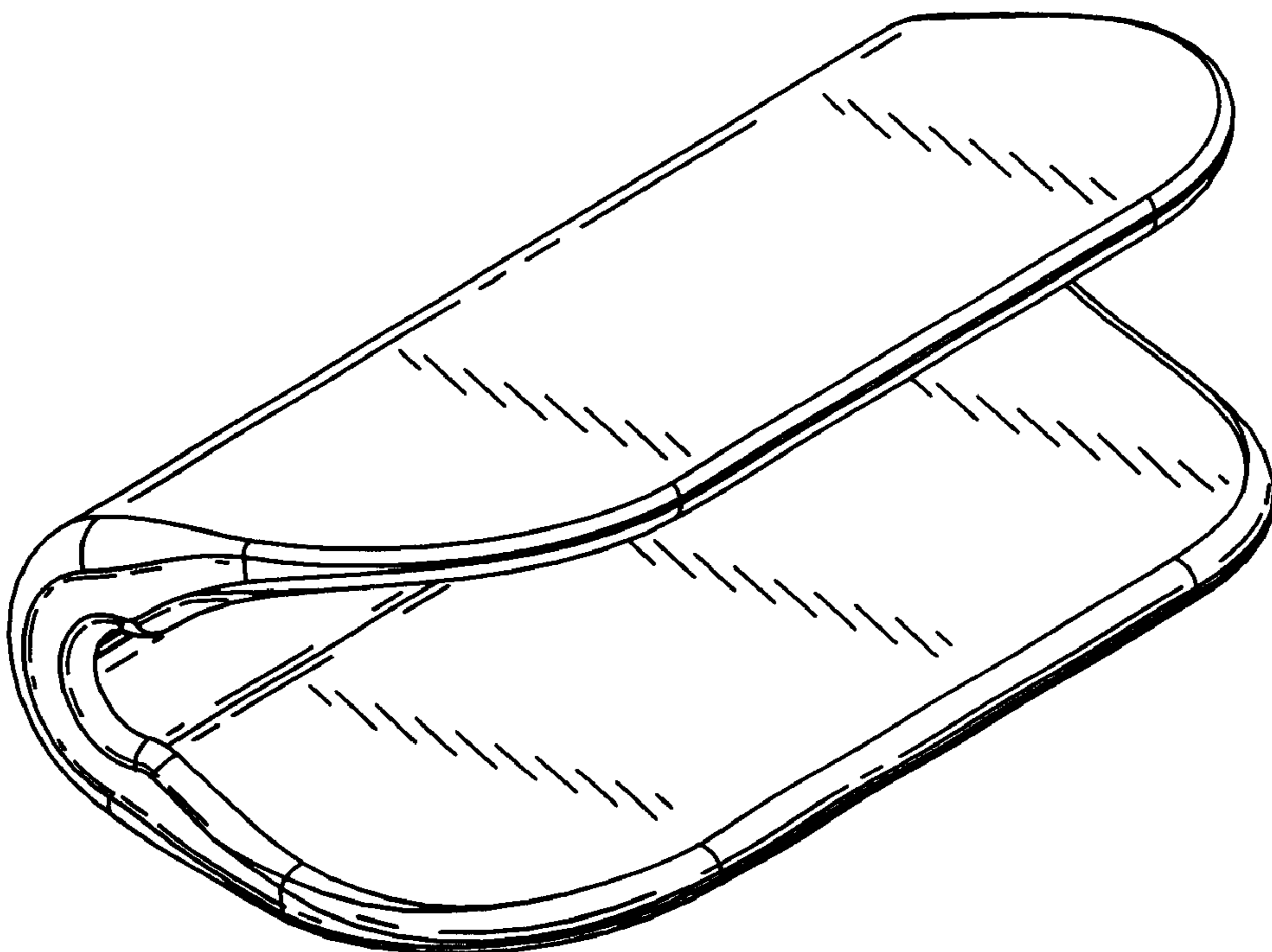

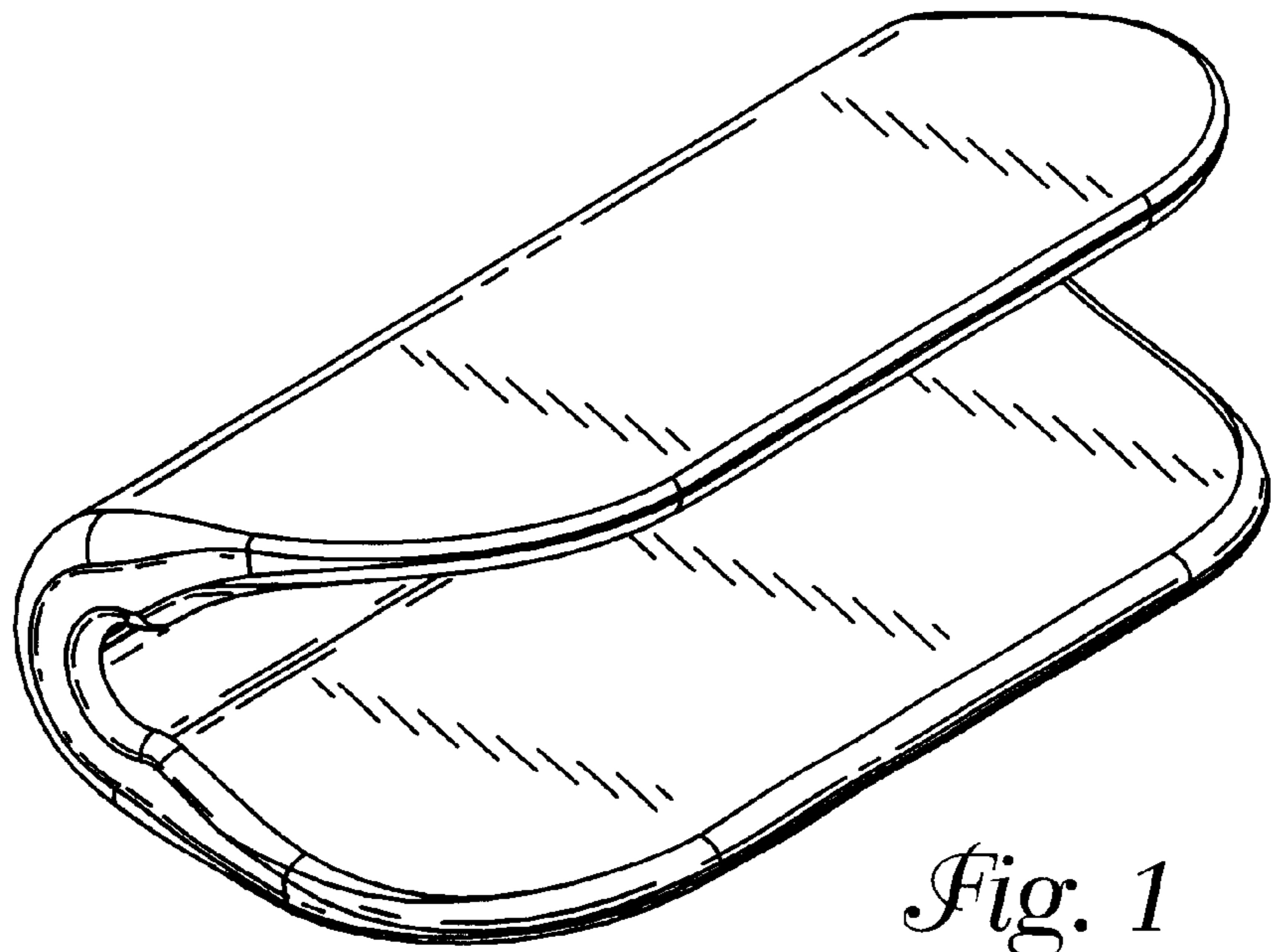
The ornamental design for a soft tissue compression shield, as shown and described.

**DESCRIPTION**

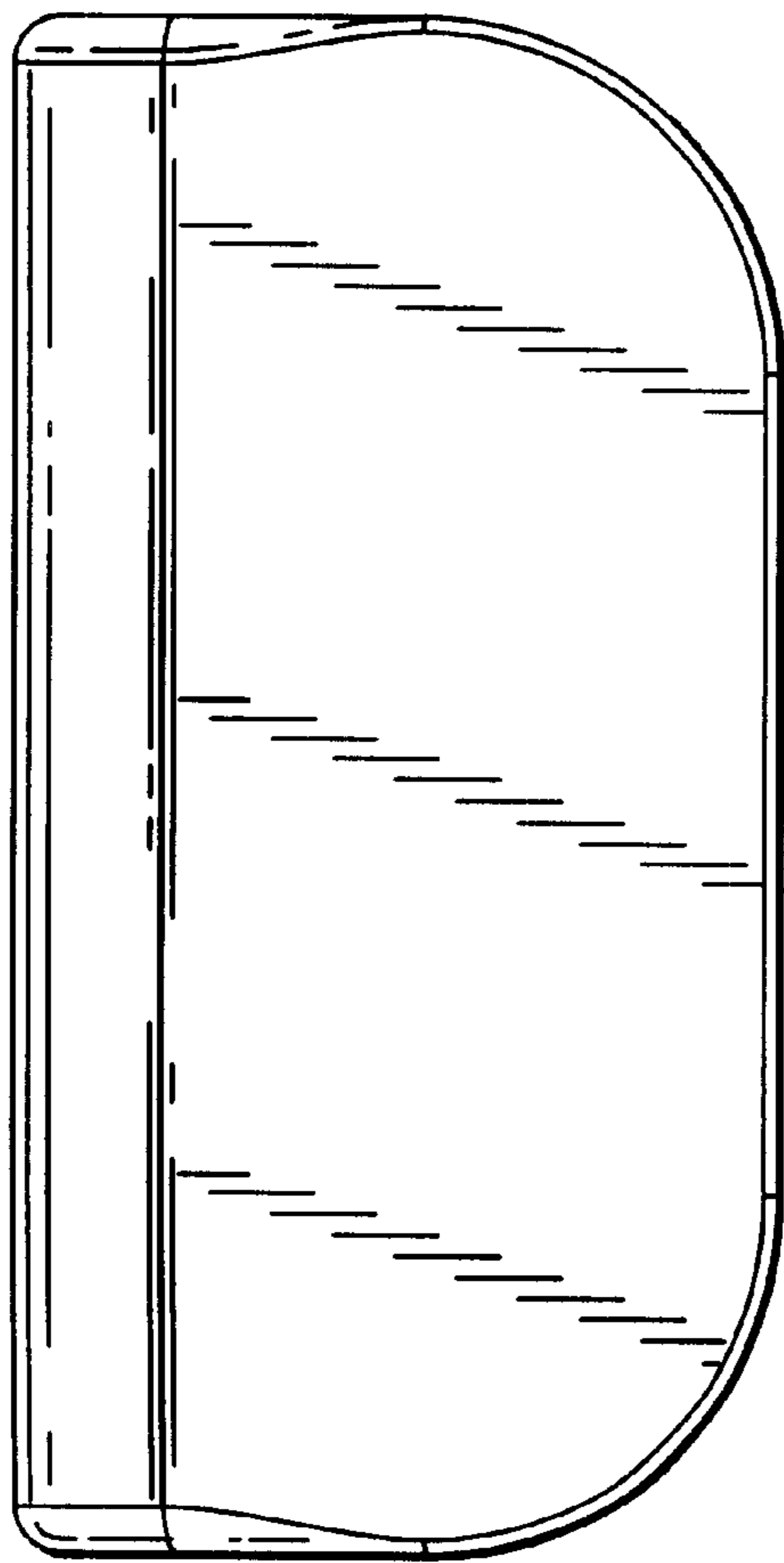
FIG. 1 is a top perspective view of a soft tissue compression shield in accordance with the invention;

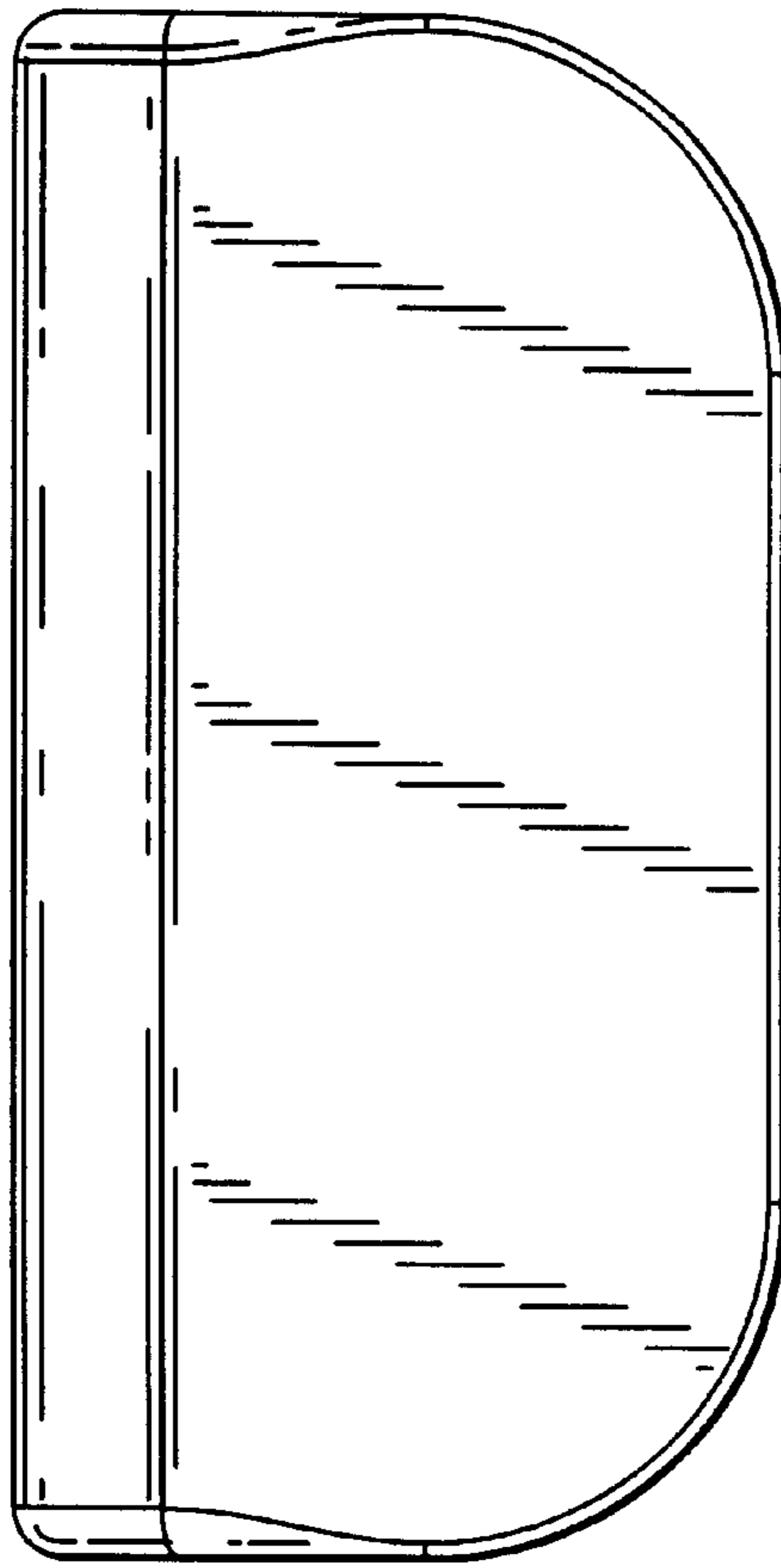




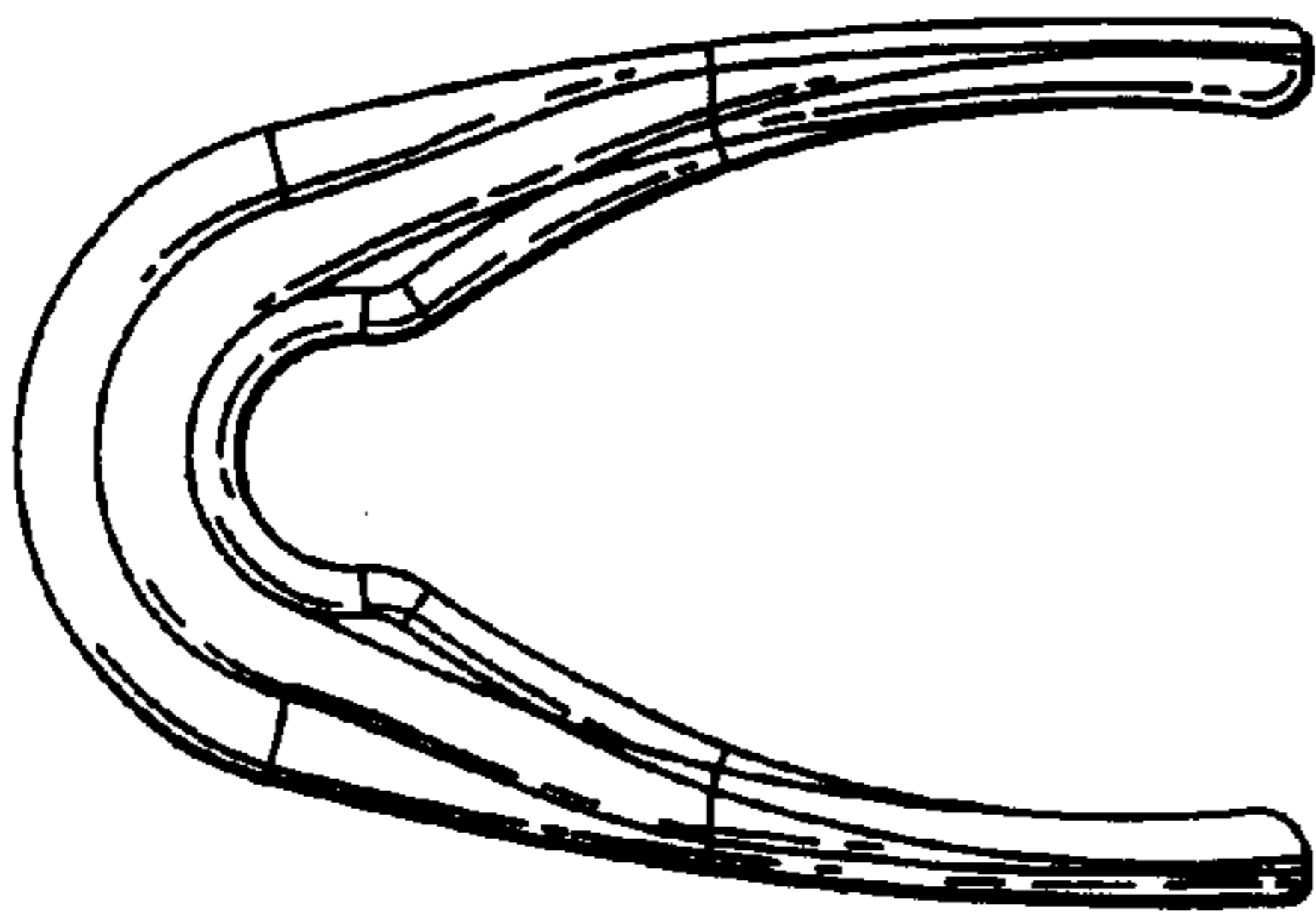

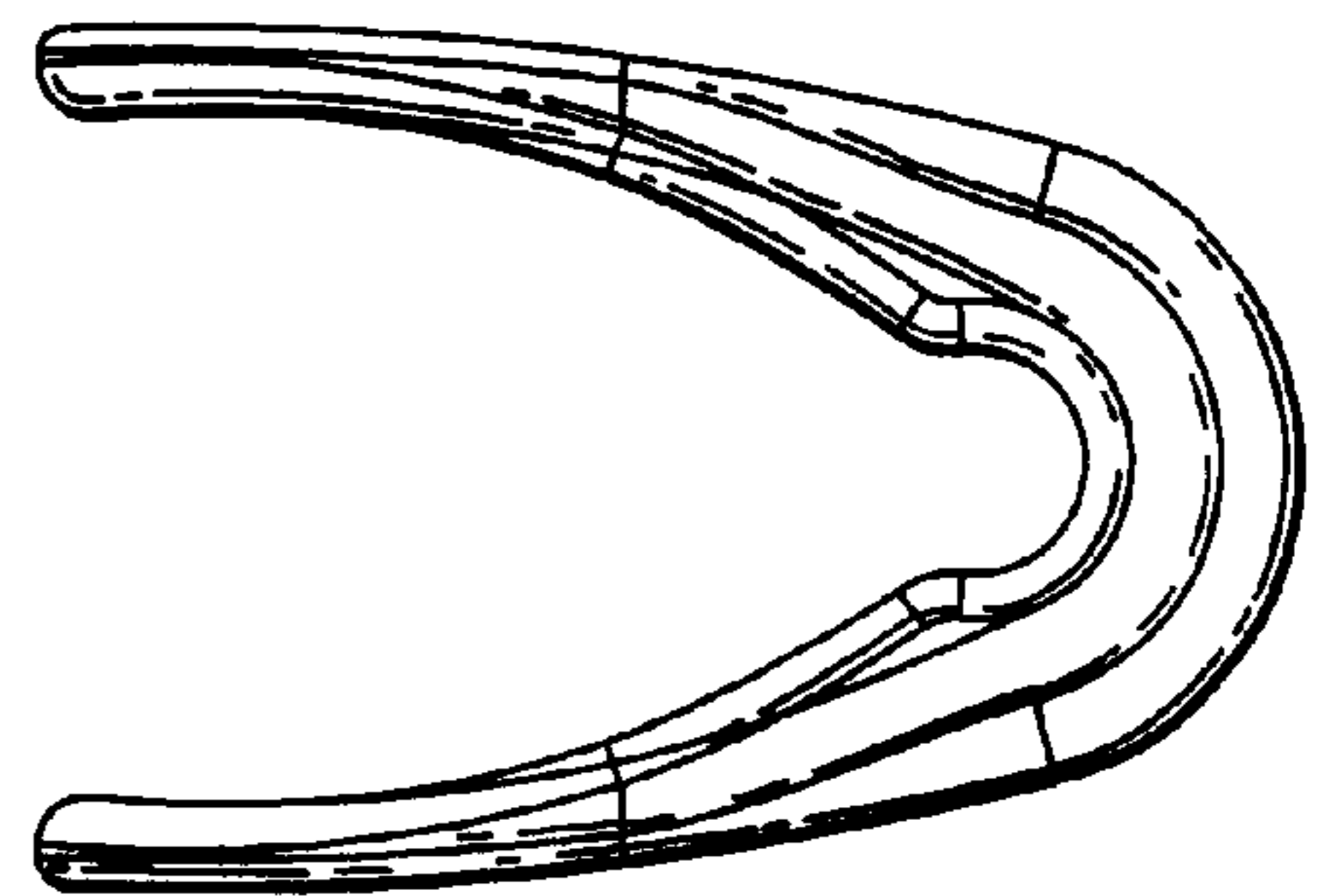

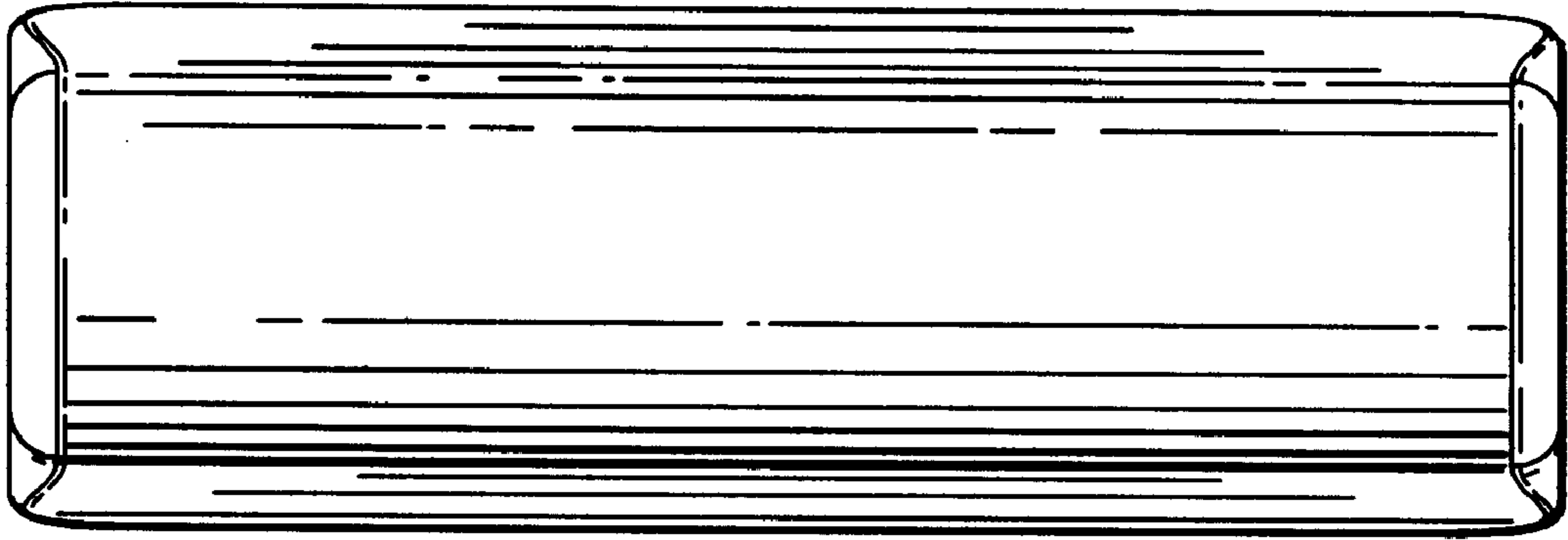

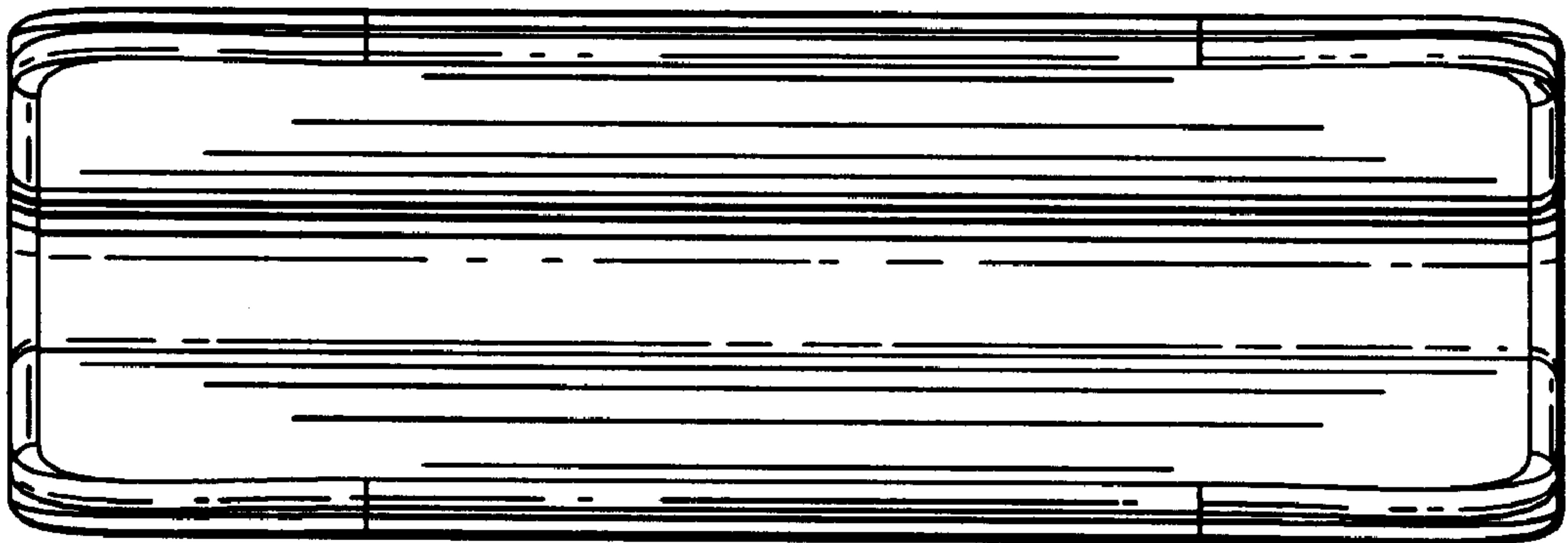
