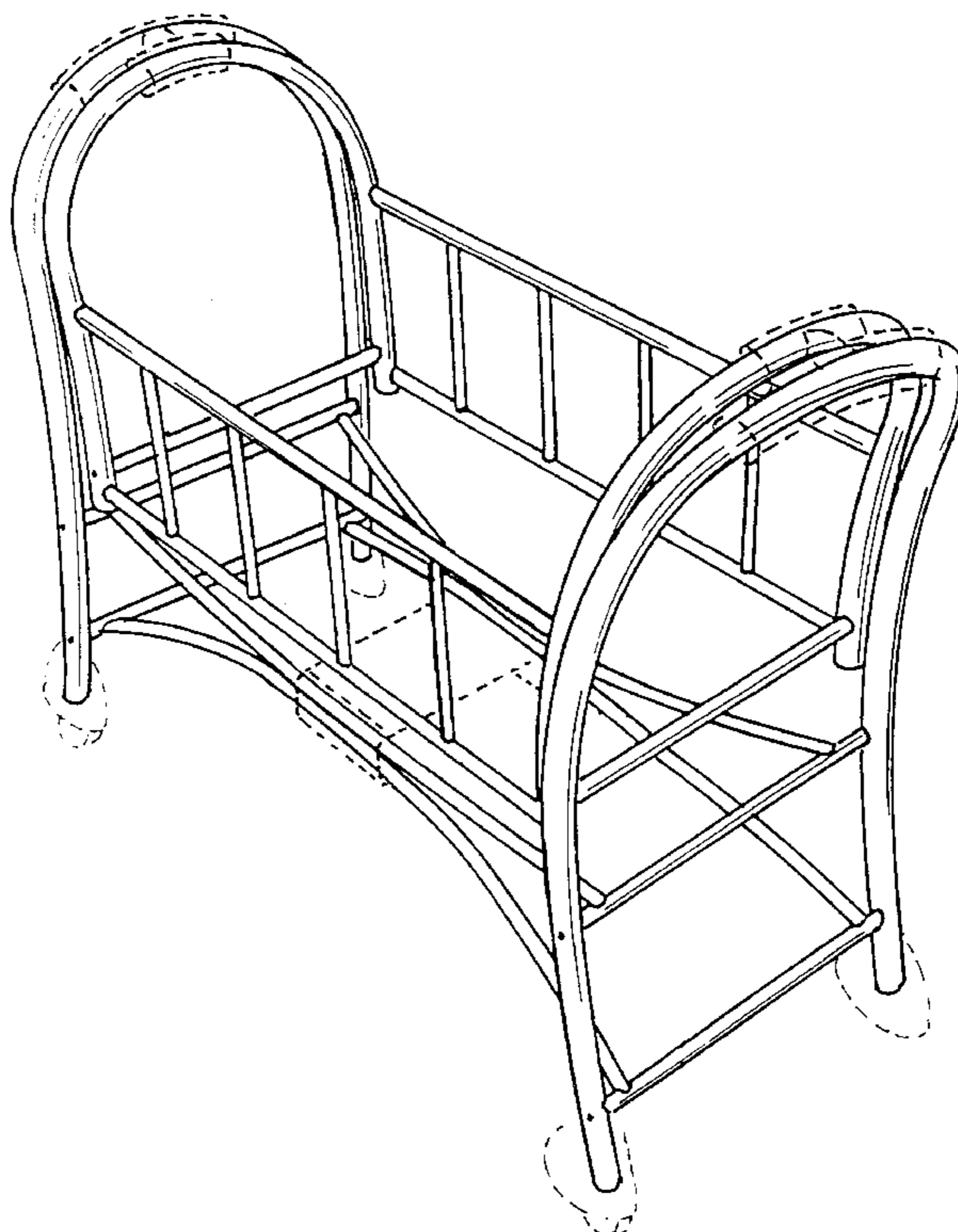

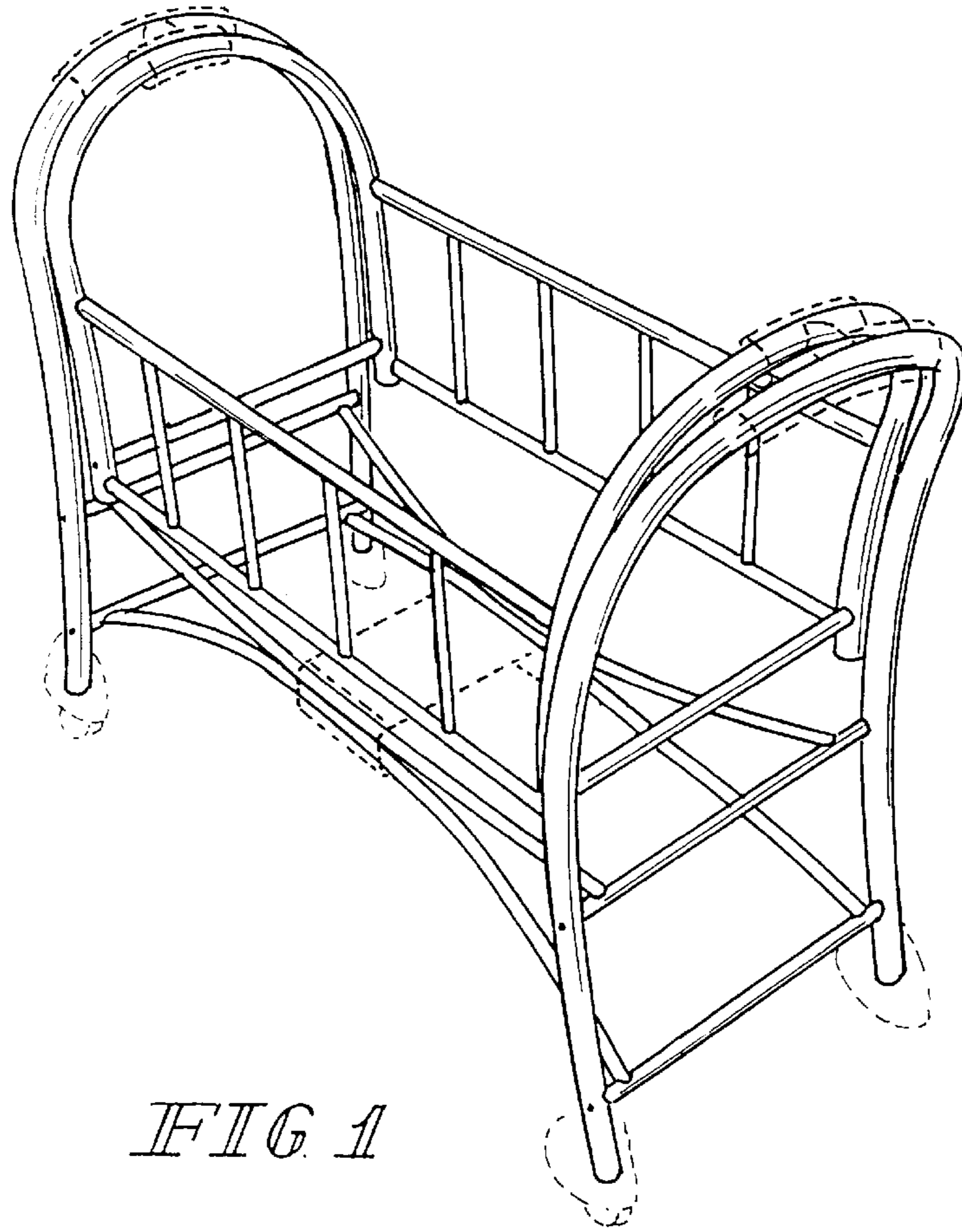
The ornamental design for a cradle frame, as shown and described.

**DESCRIPTION**

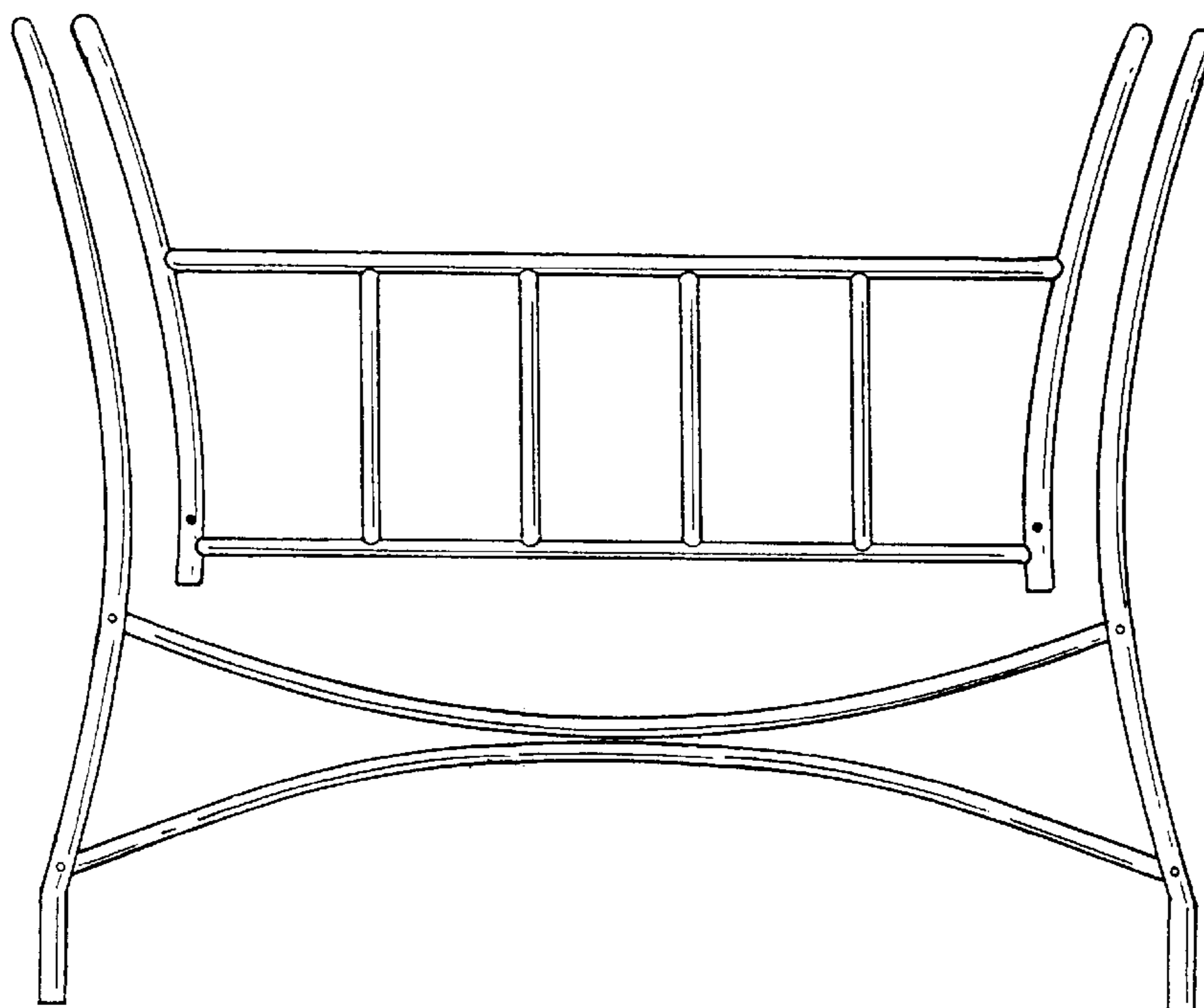
FIG. 1 is a perspective view of a cradle frame showing my new design;

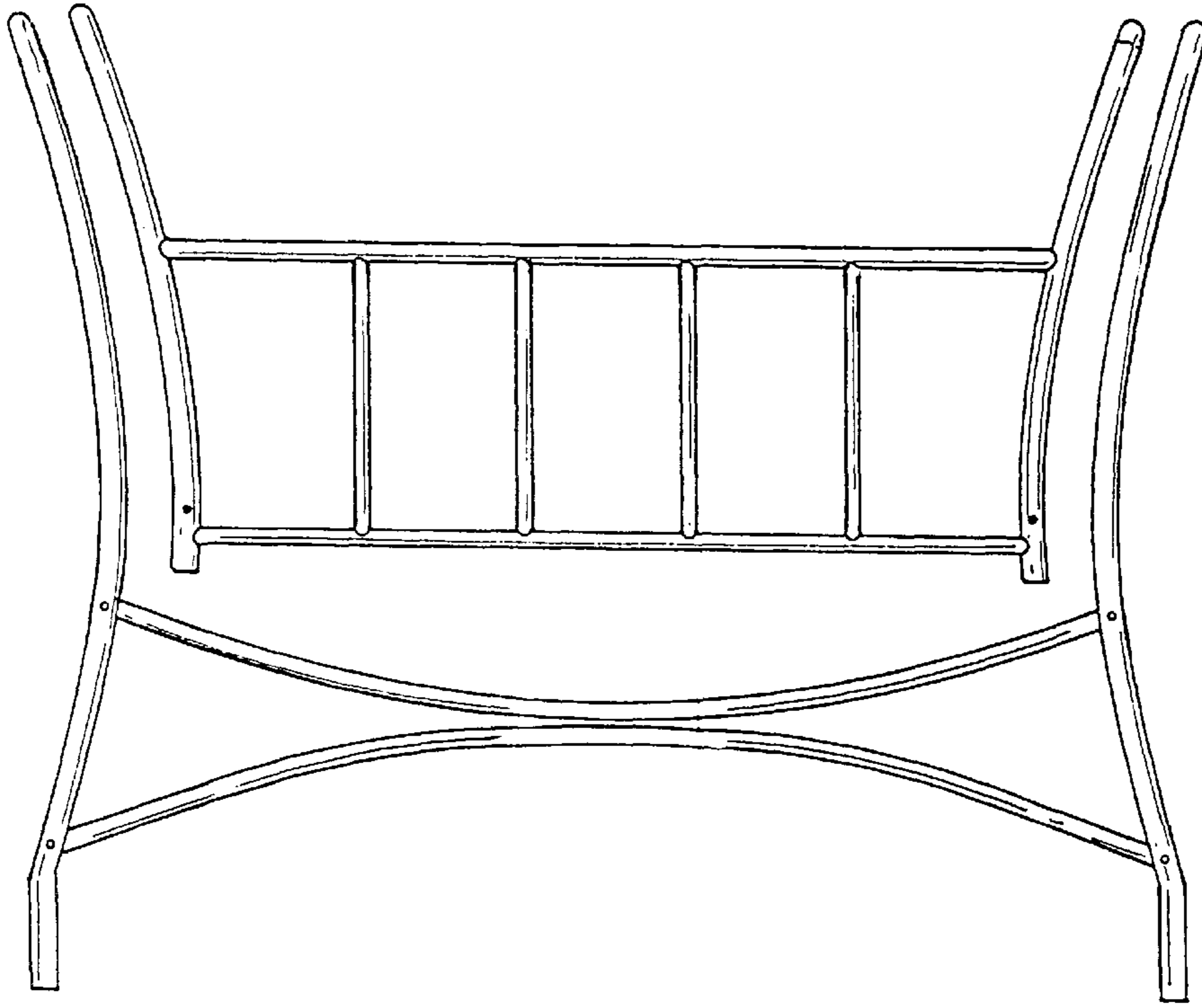




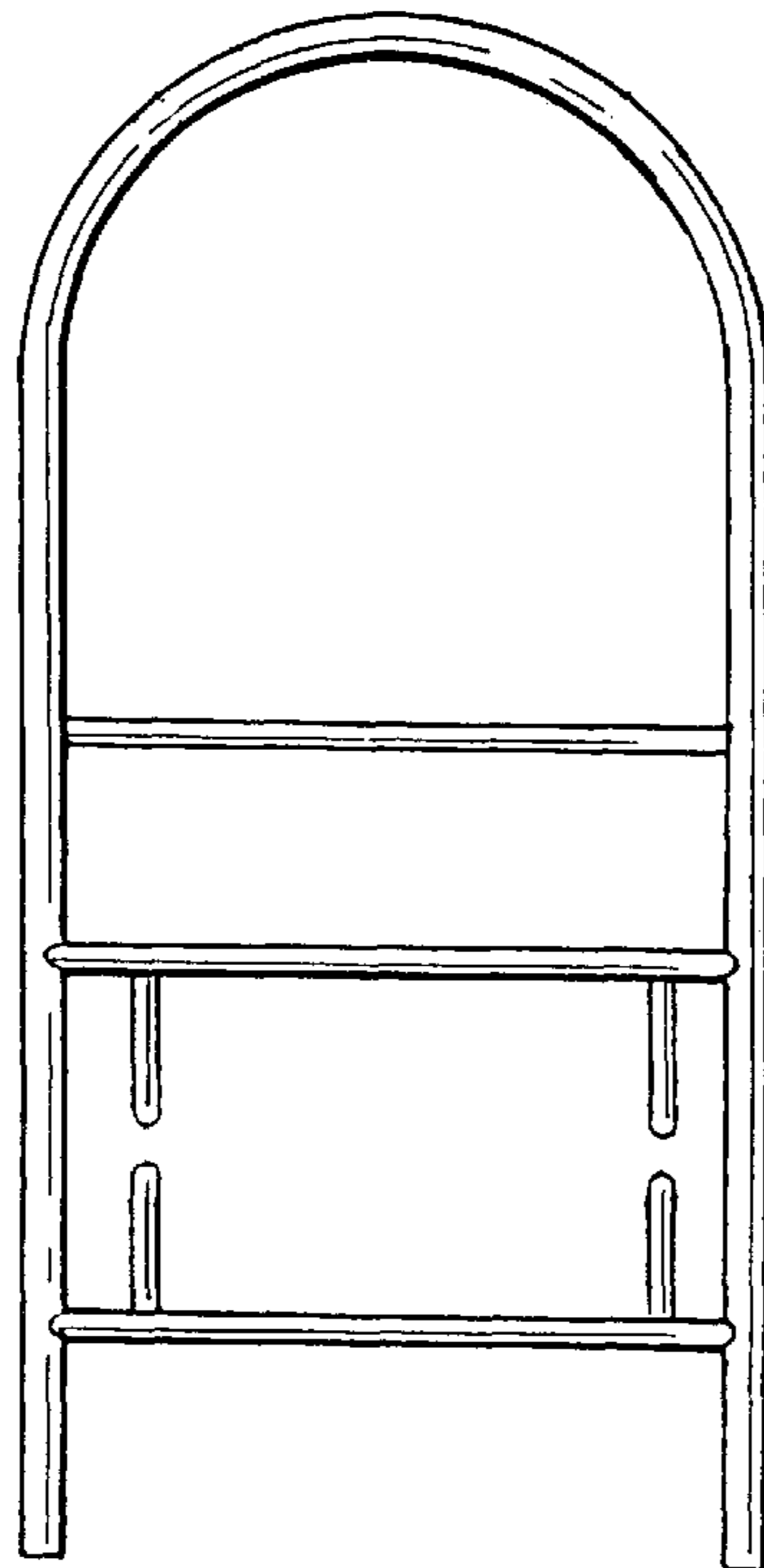

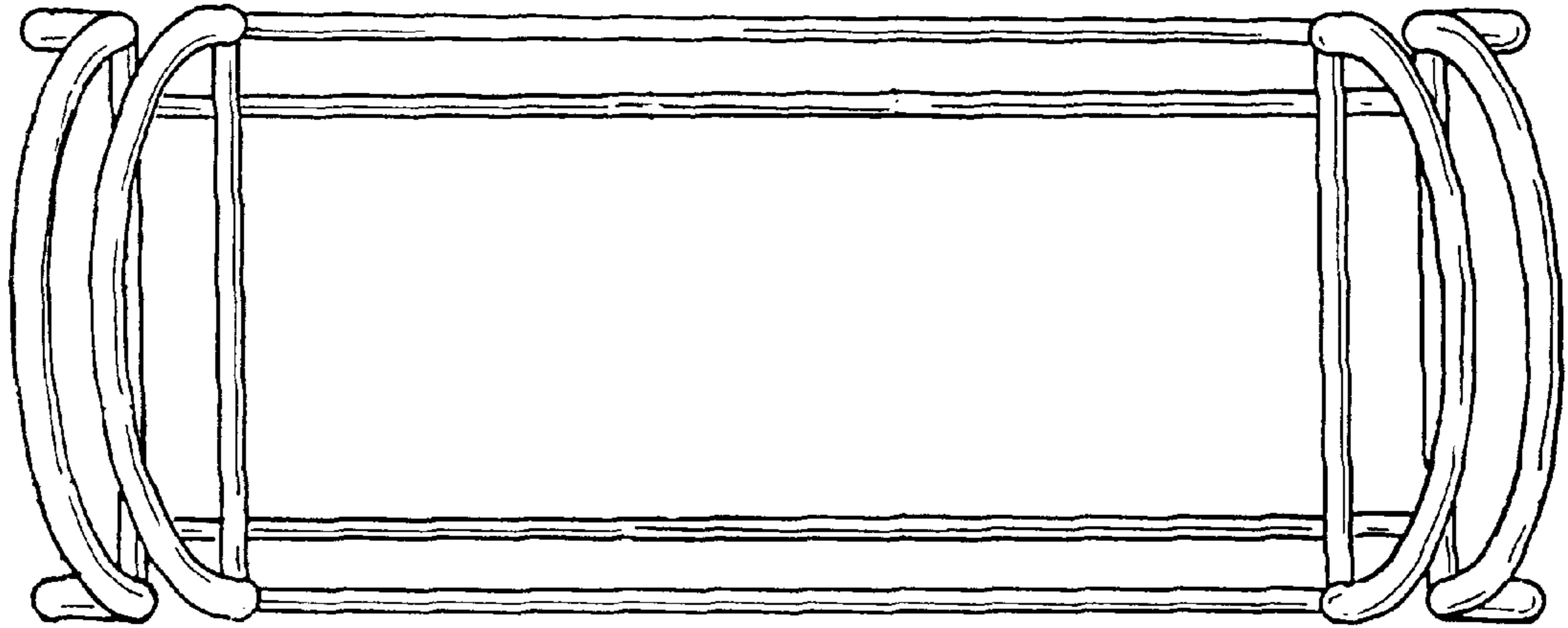

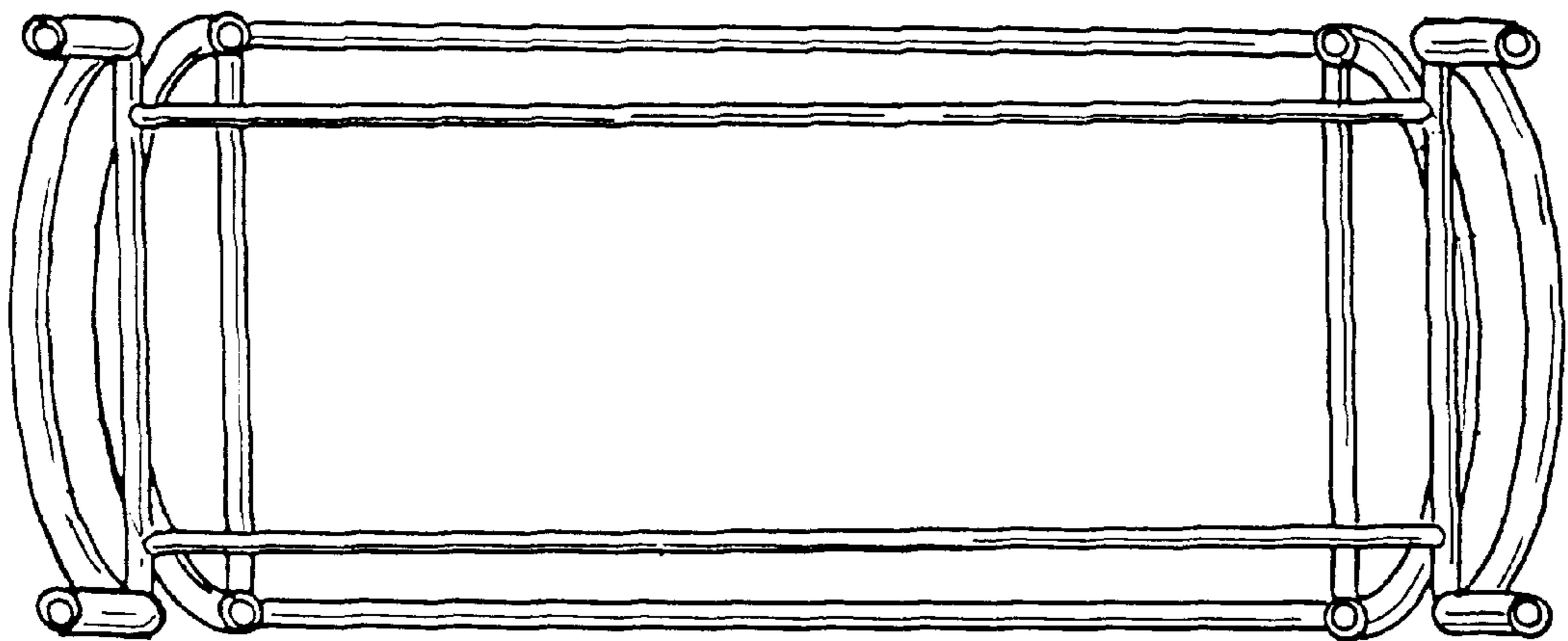
