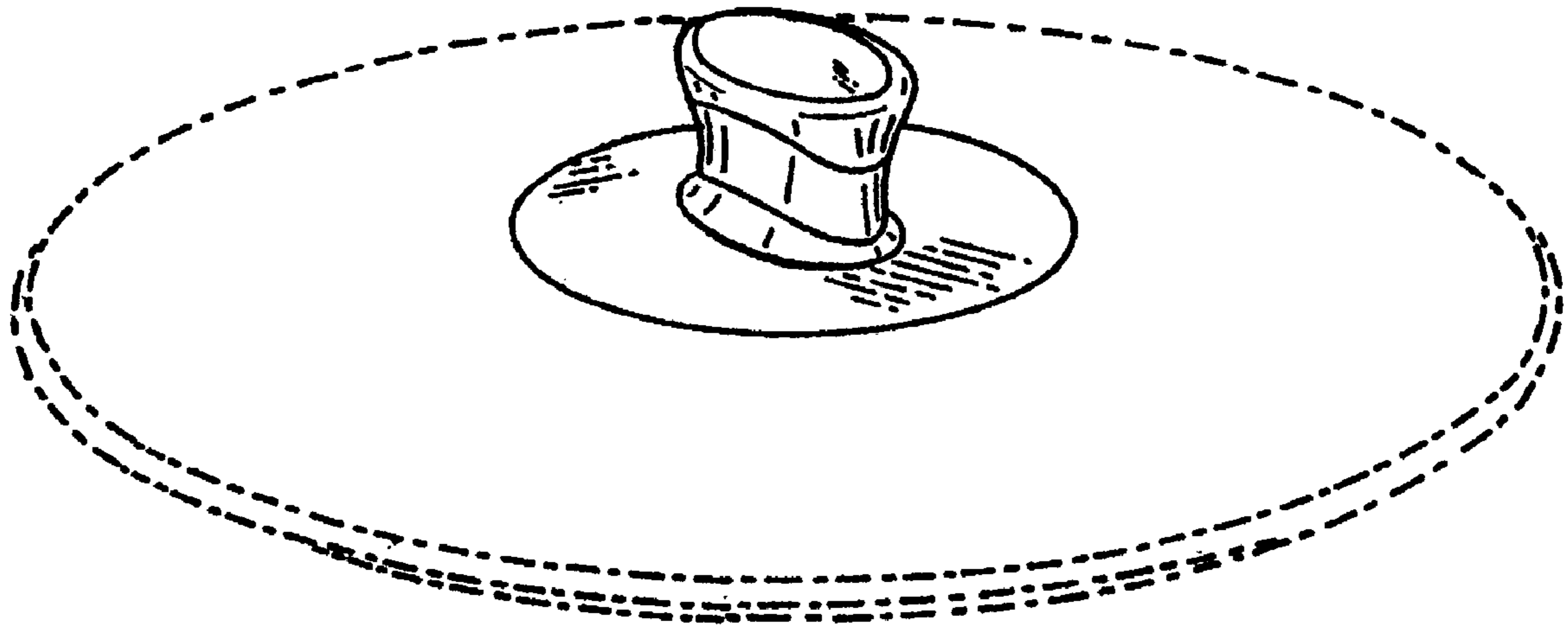

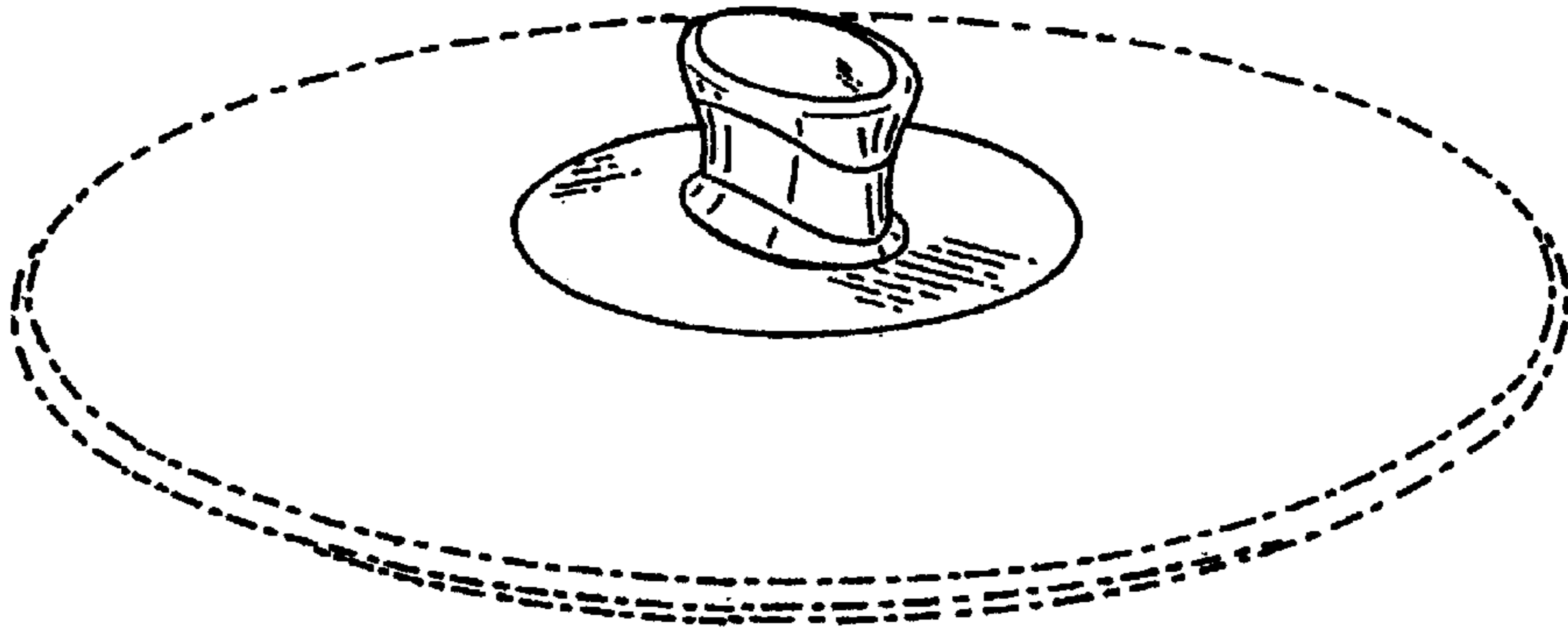
The ornamental design for a container cover, as shown and described.

**DESCRIPTION**

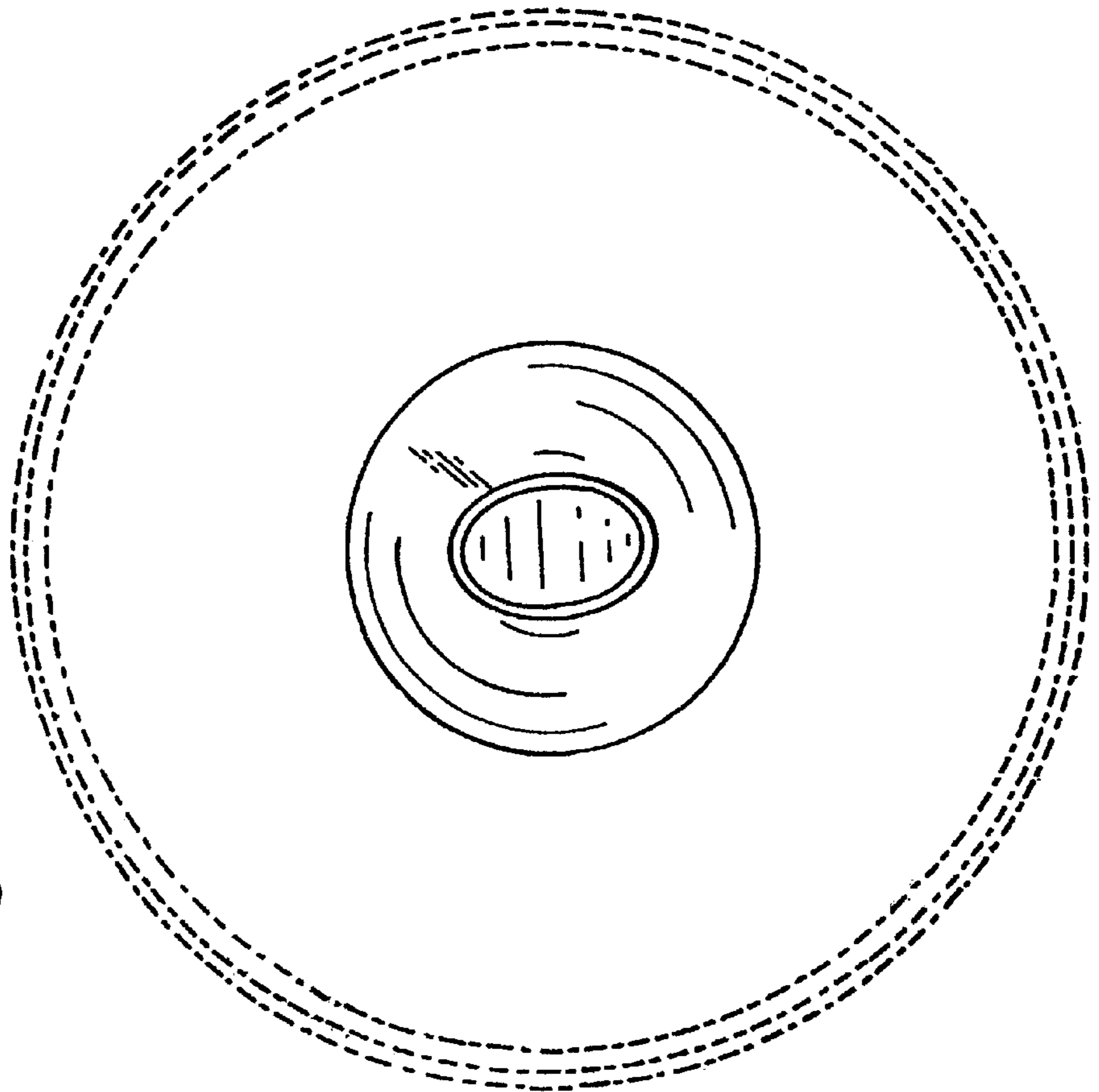
FIG. 1 is a perspective view of a container cover showing our new design, the broken lines are for illustrative purposes only and form no part of the claimed design.

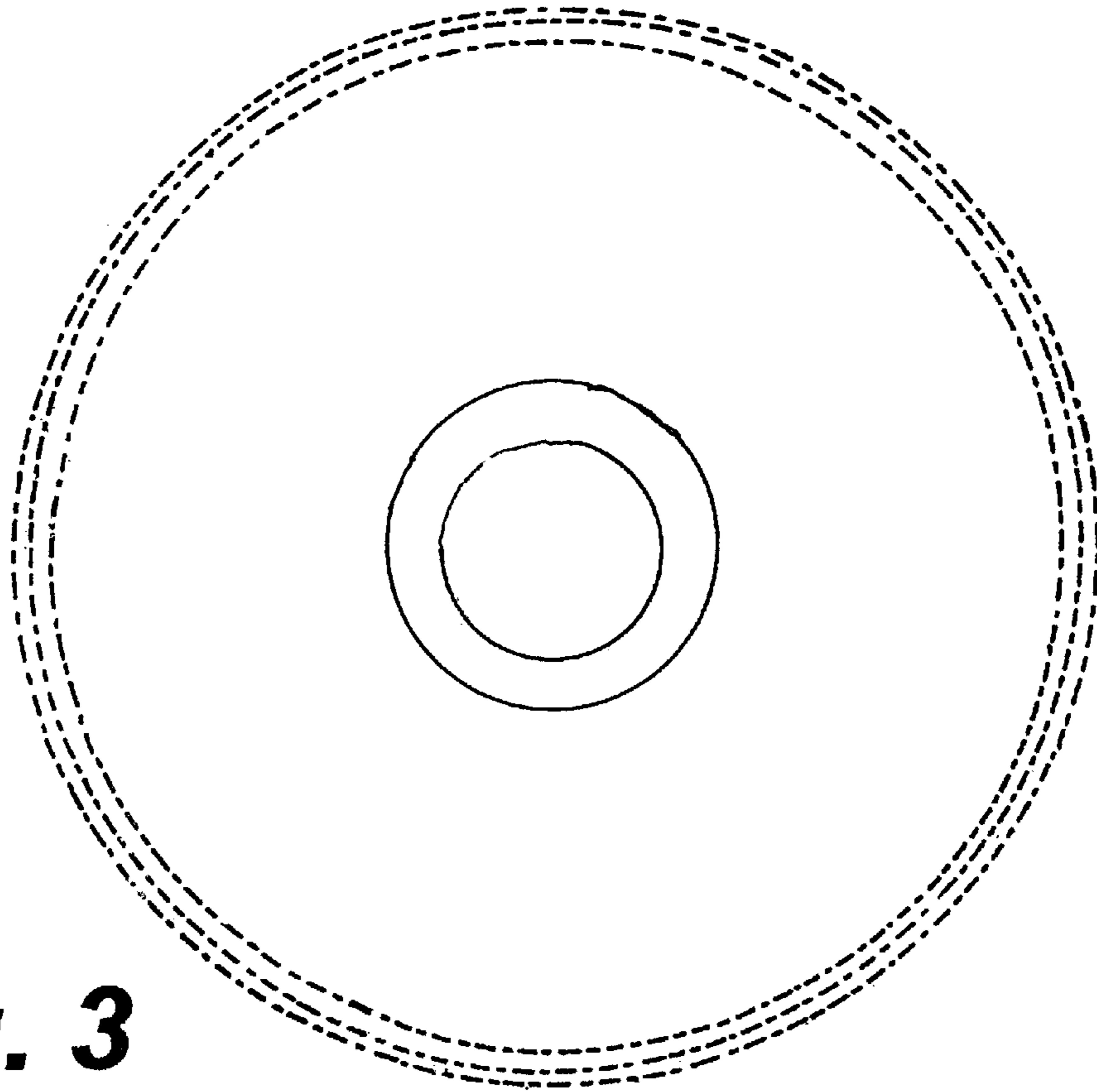




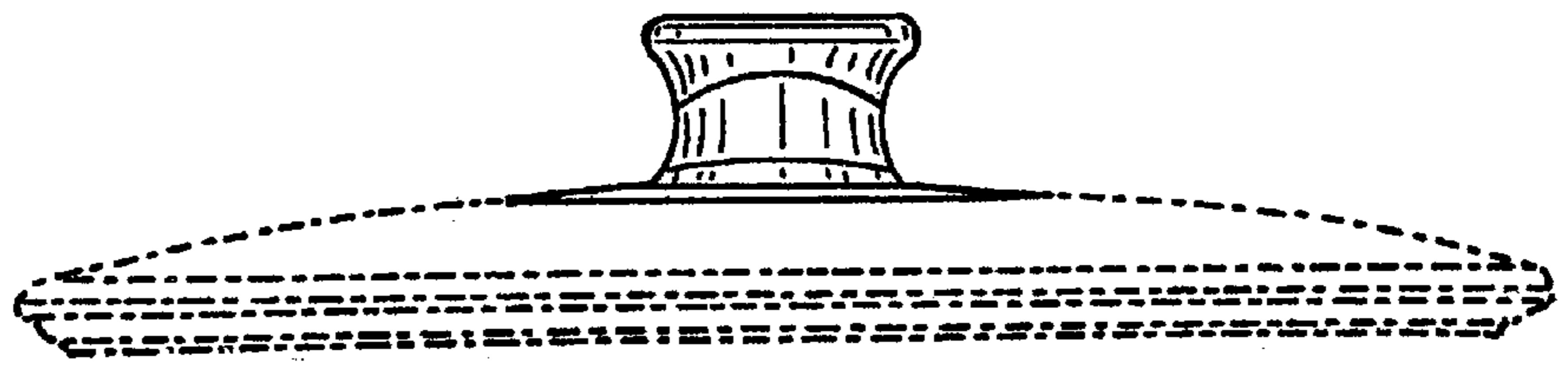

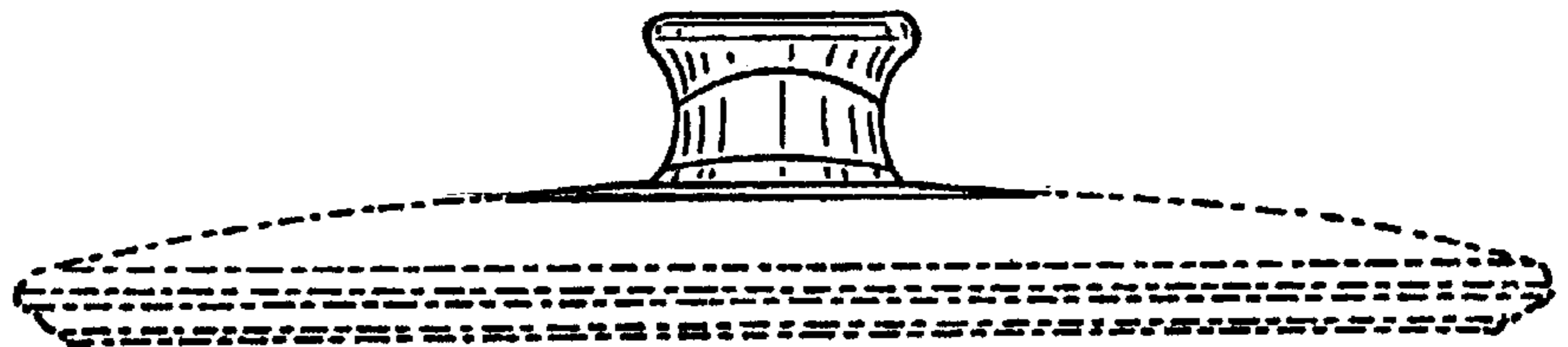

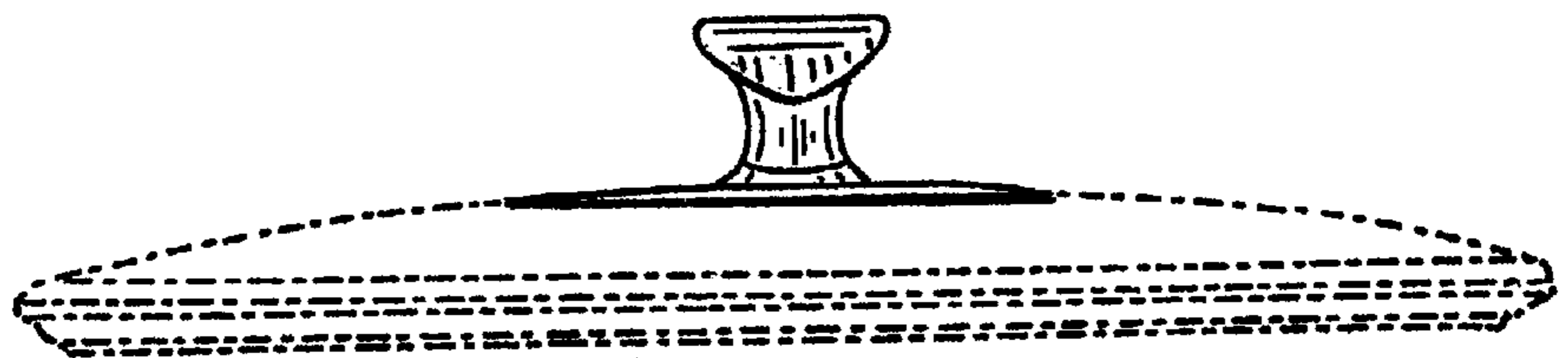

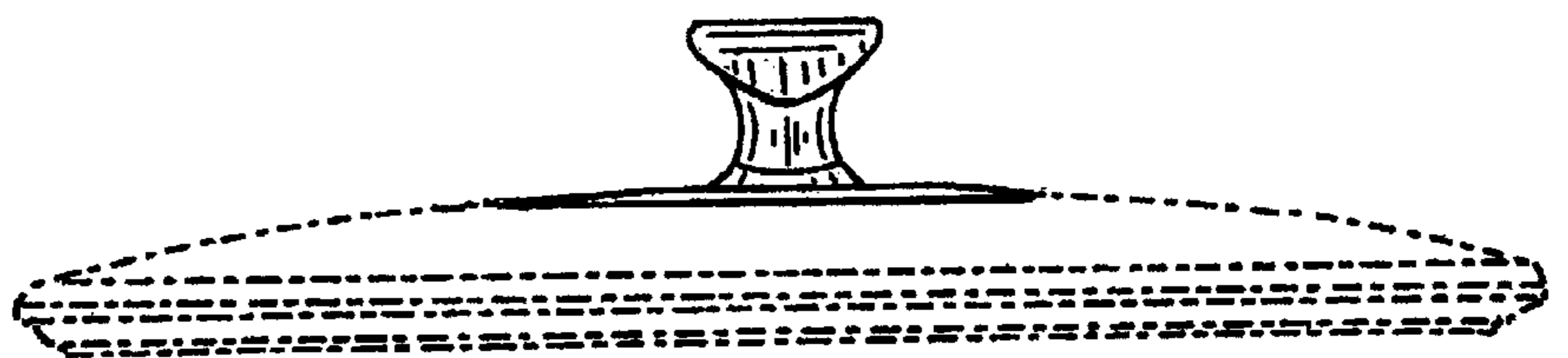
