(57) **CLAIM**

The ornamental design for a cargo box surface, as shown and described.

**DESCRIPTION**

FIG. 1 is a left rear elevated perspective view of a cargo box surface showing our new design.

FIG. 2 is a top plan view of the cargo box surface design of FIG. 1.

FIG. 3 is a left side view of the cargo box surface design of FIG. 1.

FIG. 4 is a right side view of the cargo box surface design of FIG. 1.

FIG. 5 is a rear view of the cargo box surface design of FIG. 1.

FIG. 6 is a left rear elevated perspective view of a cargo box surface showing a second embodiment of our new design.

FIG. 7 is a plan view of the cargo box surface design of FIG. 6.

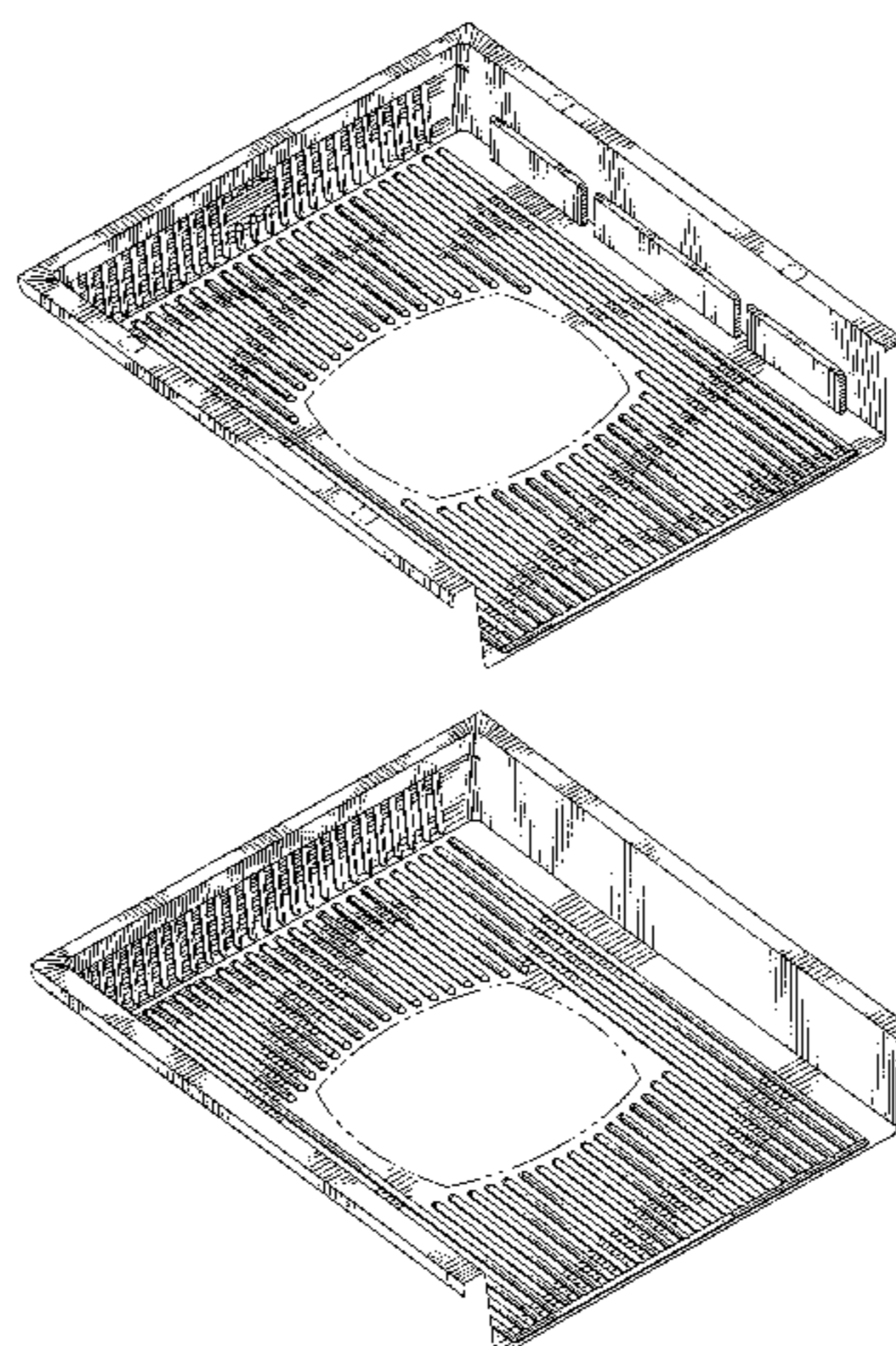
FIG. 8 is a left side view of the cargo box surface design of FIG. 6.

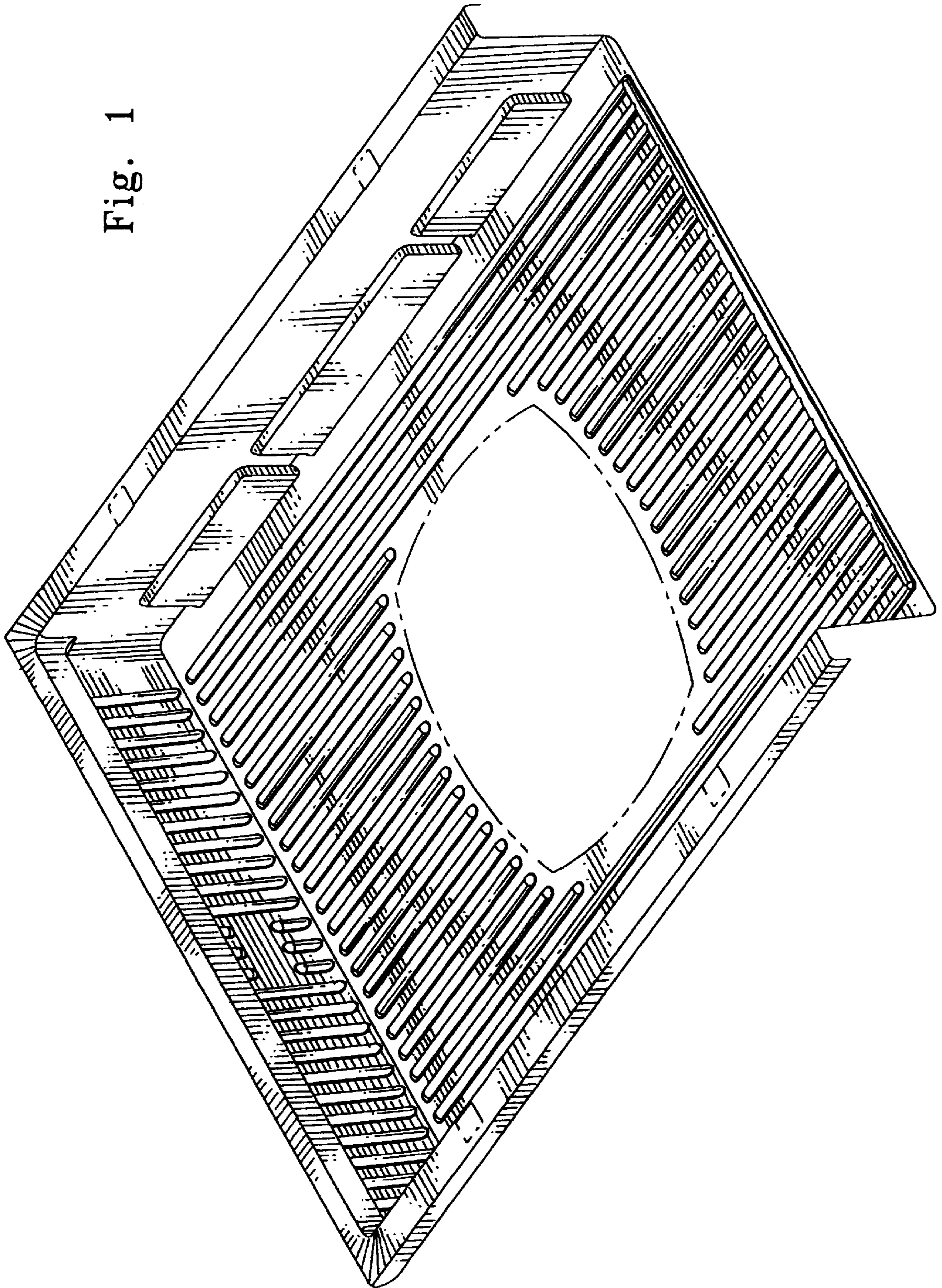

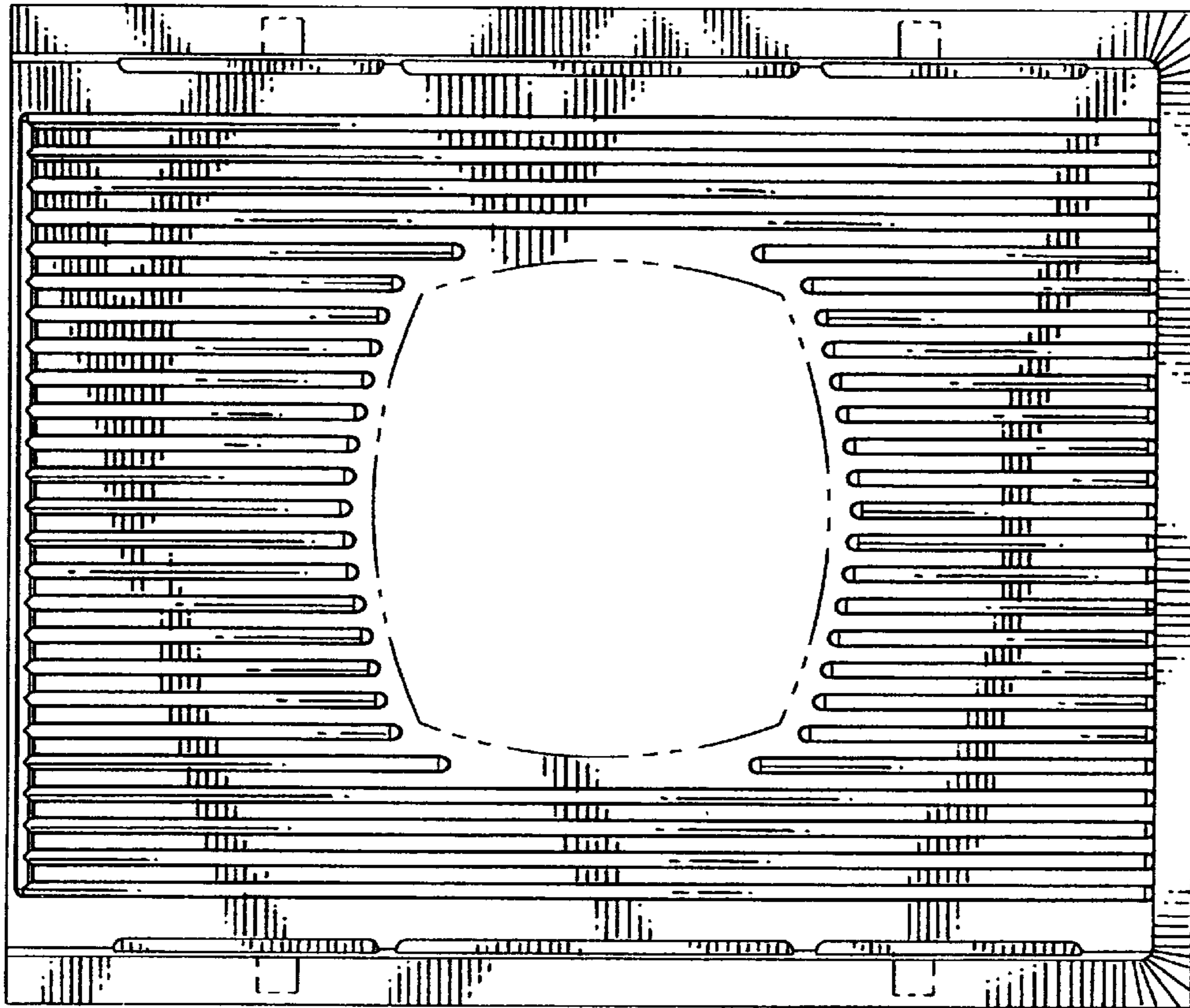

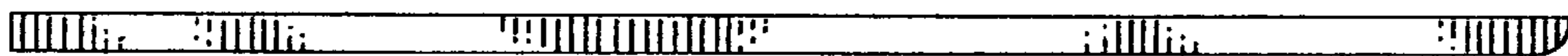

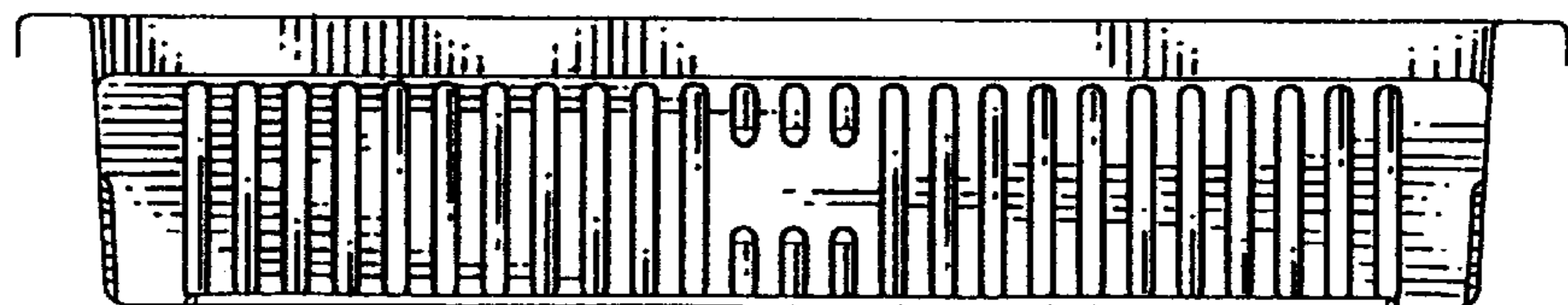

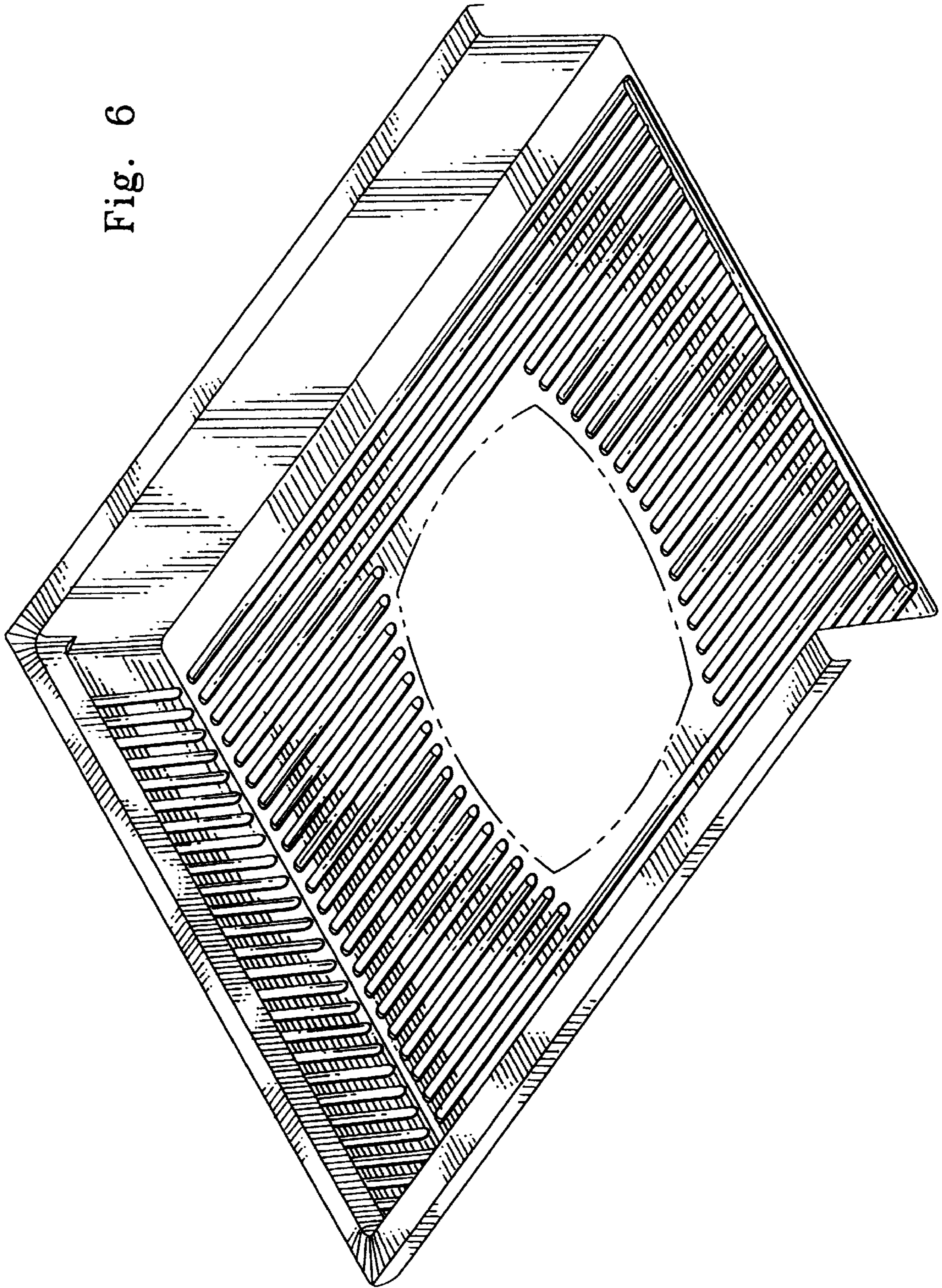

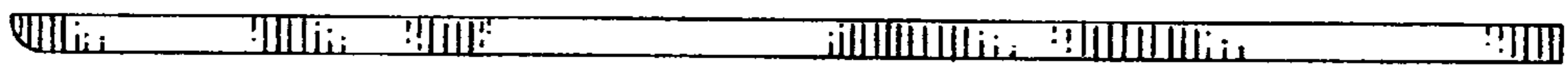
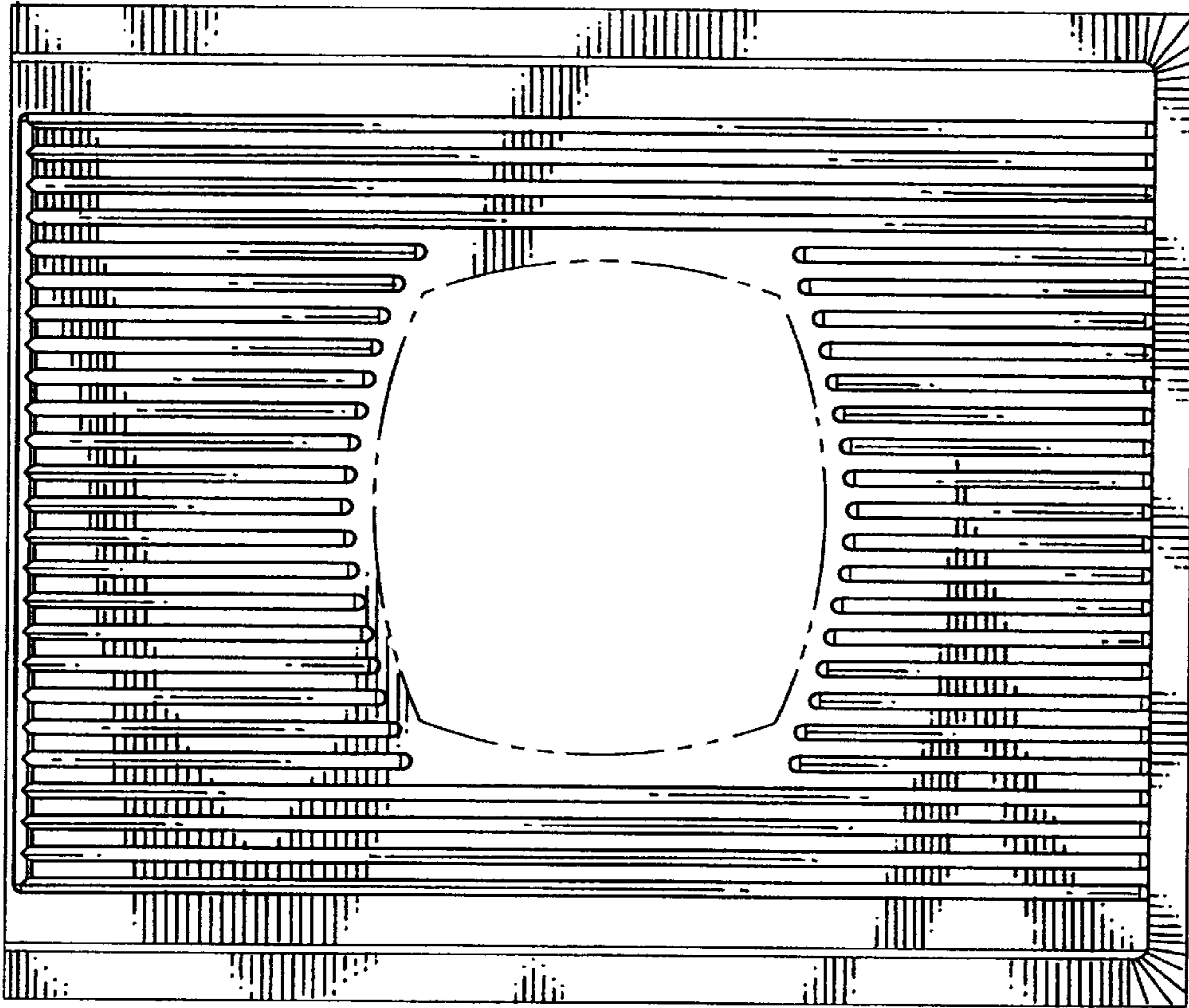

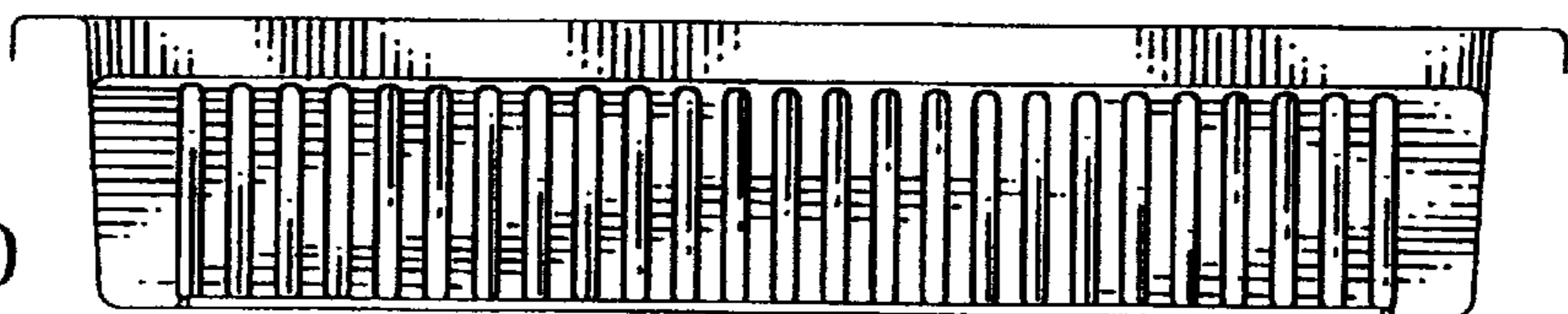
