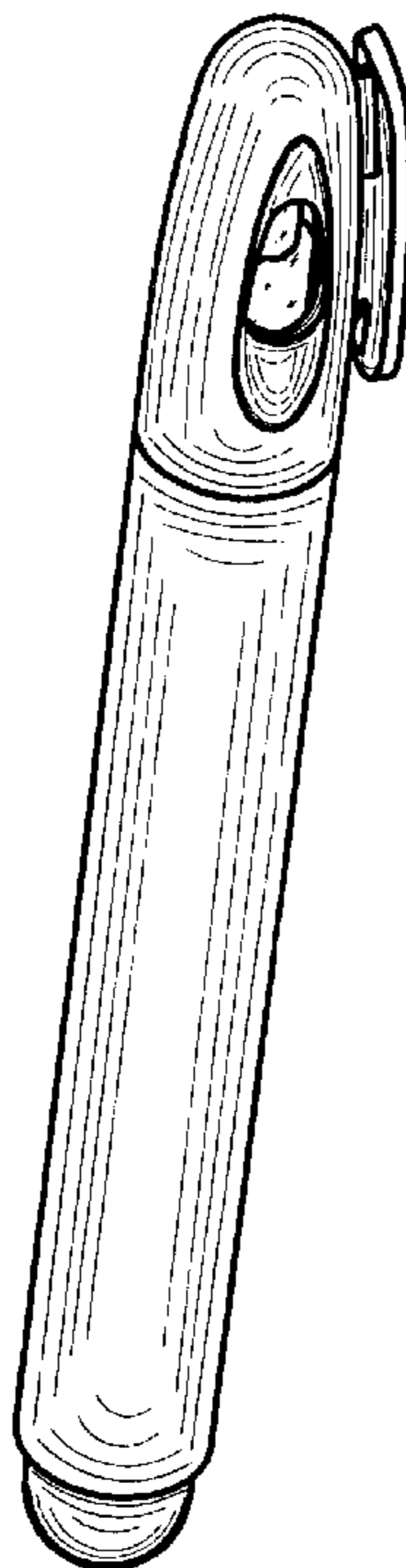

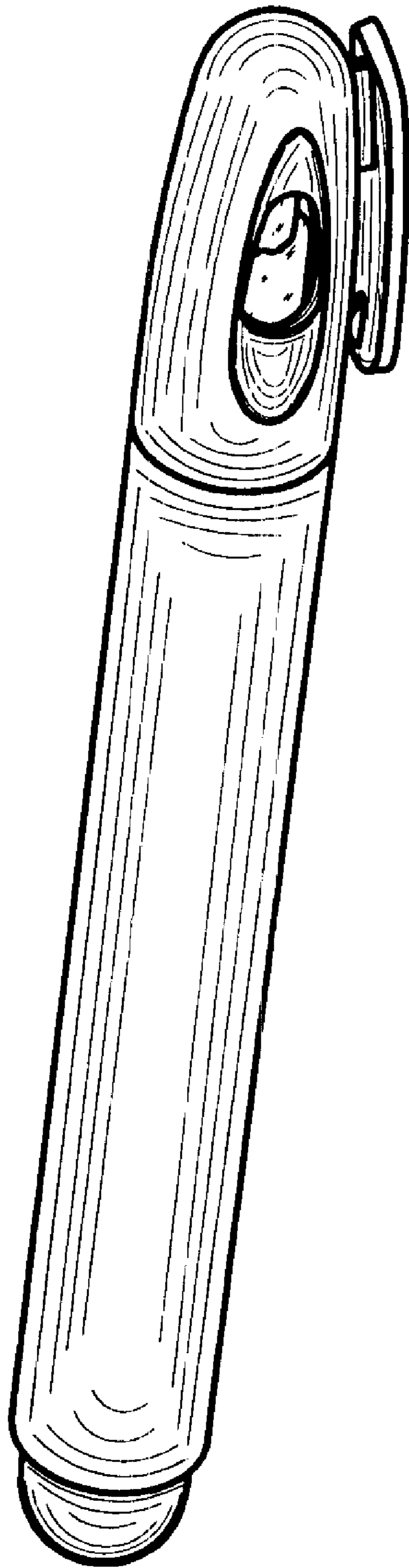
The ornamental design for a pen with cap and barrel, as shown and described.

**DESCRIPTION**

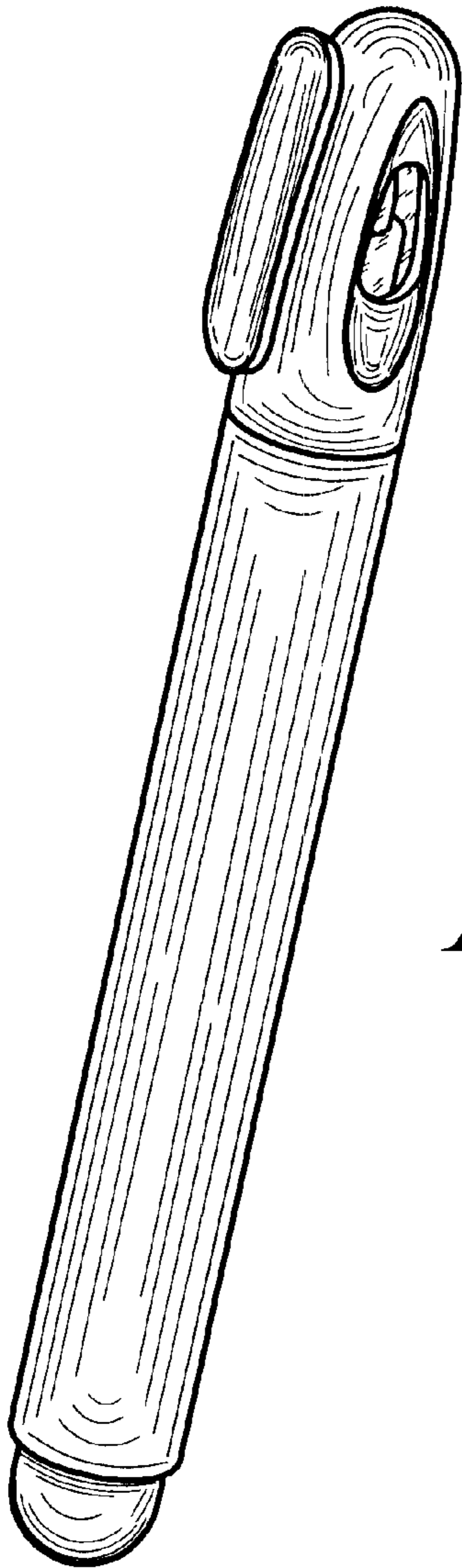
FIG. 1 is a left perspective view of a pen with cap and barrel, showing my new design;

 FIG. 17 is a bottom plan view thereof;  
 FIG. 18 is a front elevational view thereof; and,

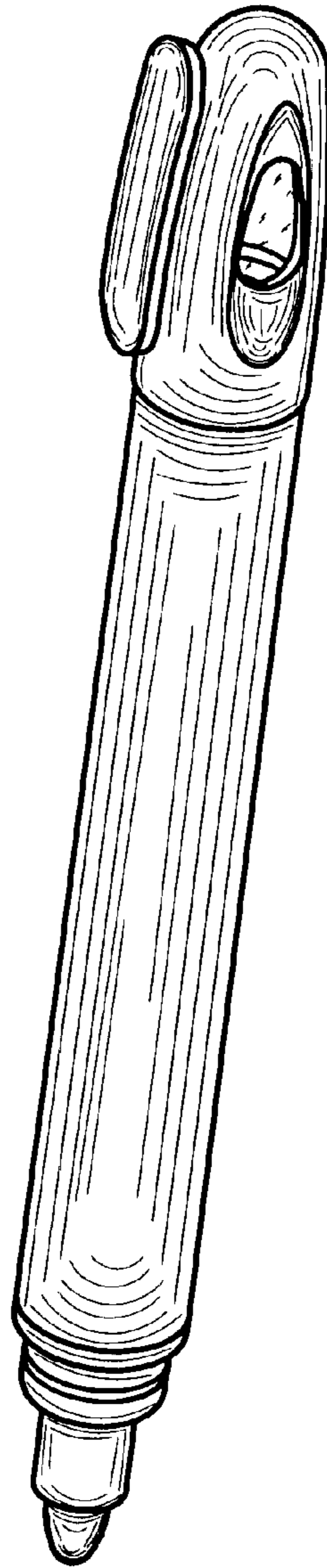




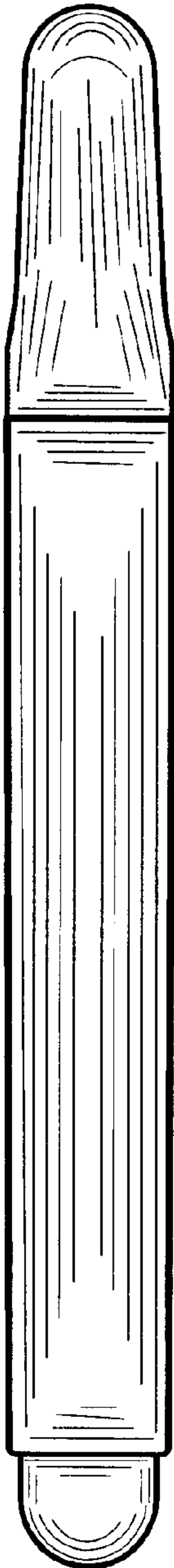

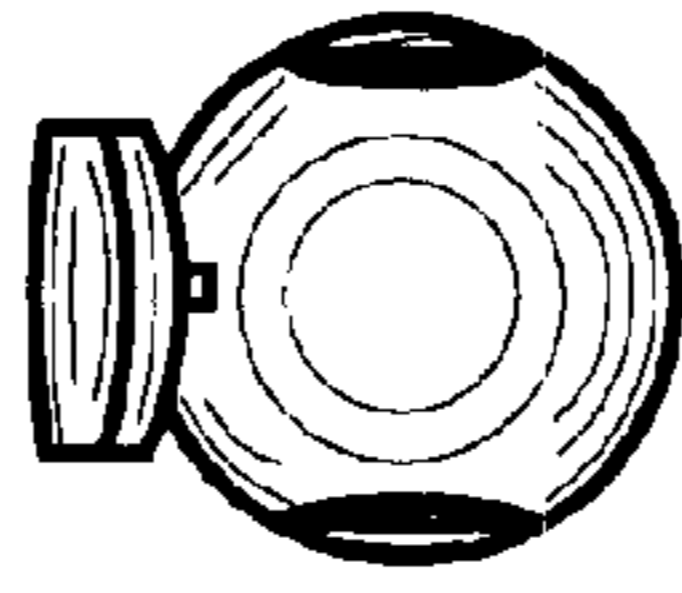

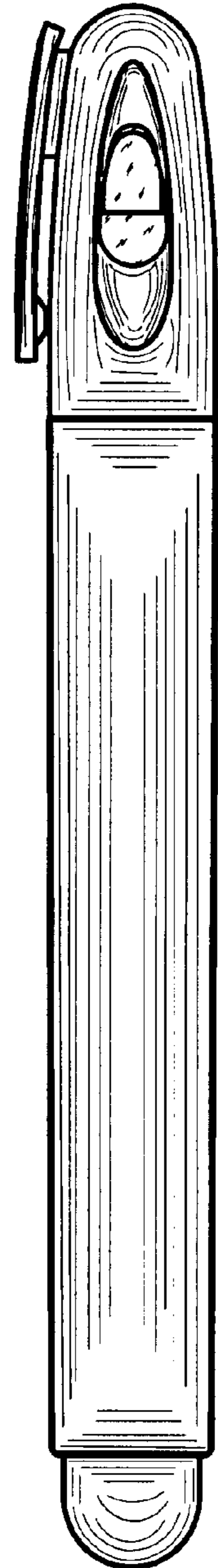

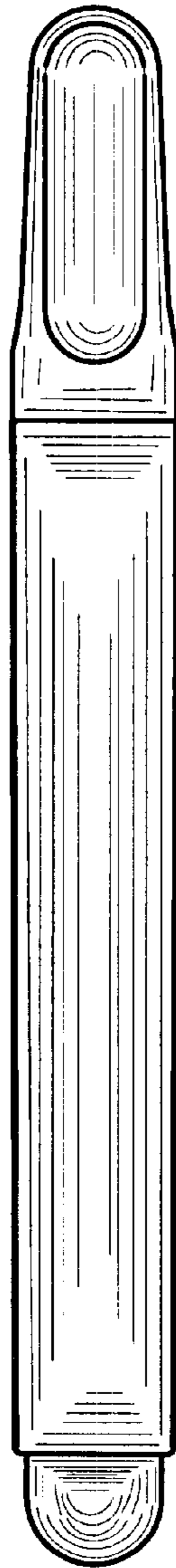

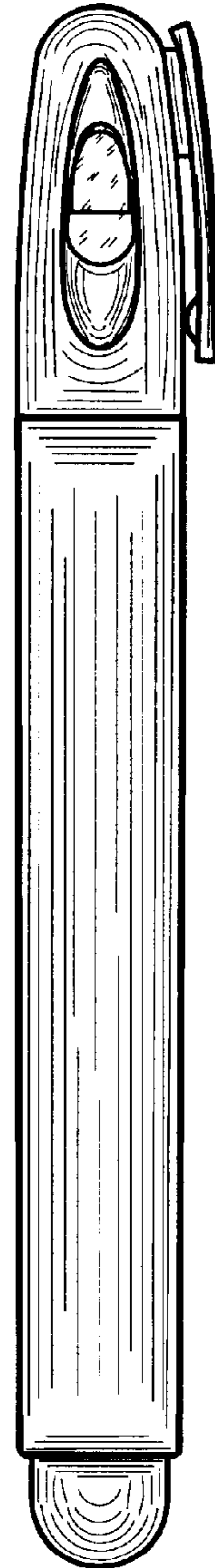

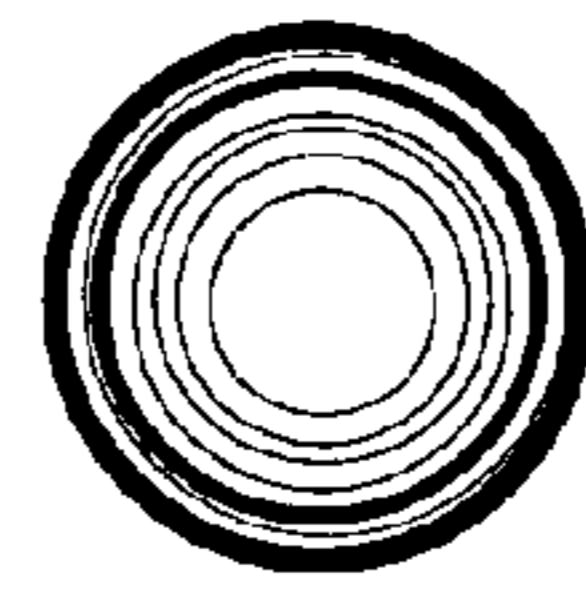
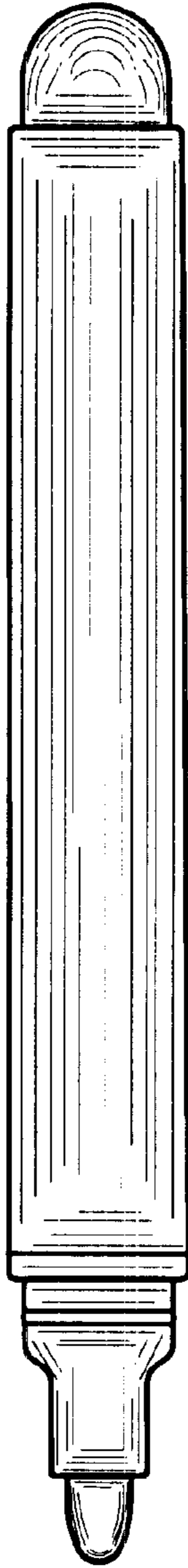

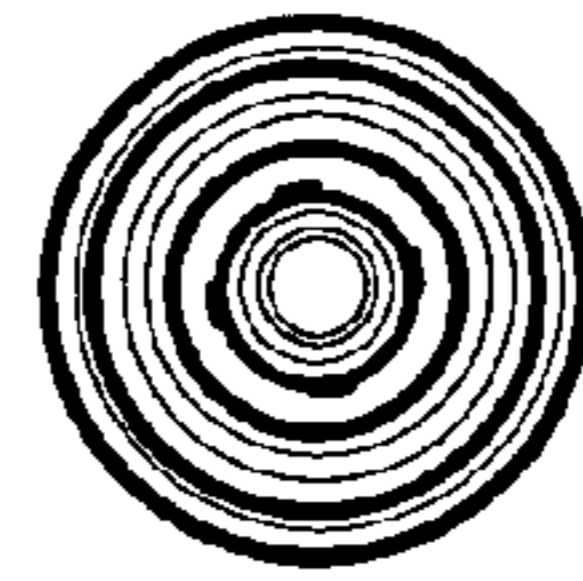

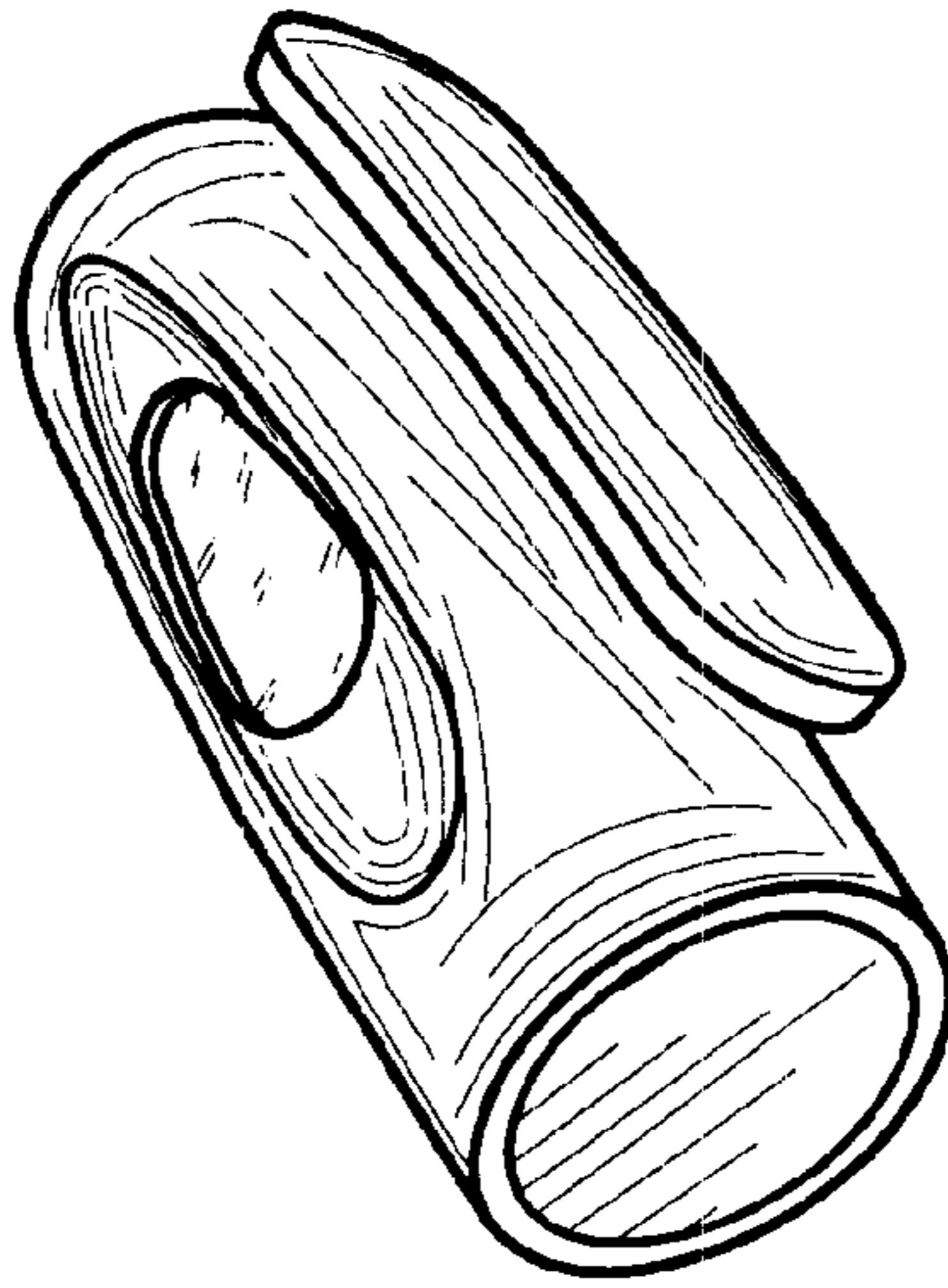

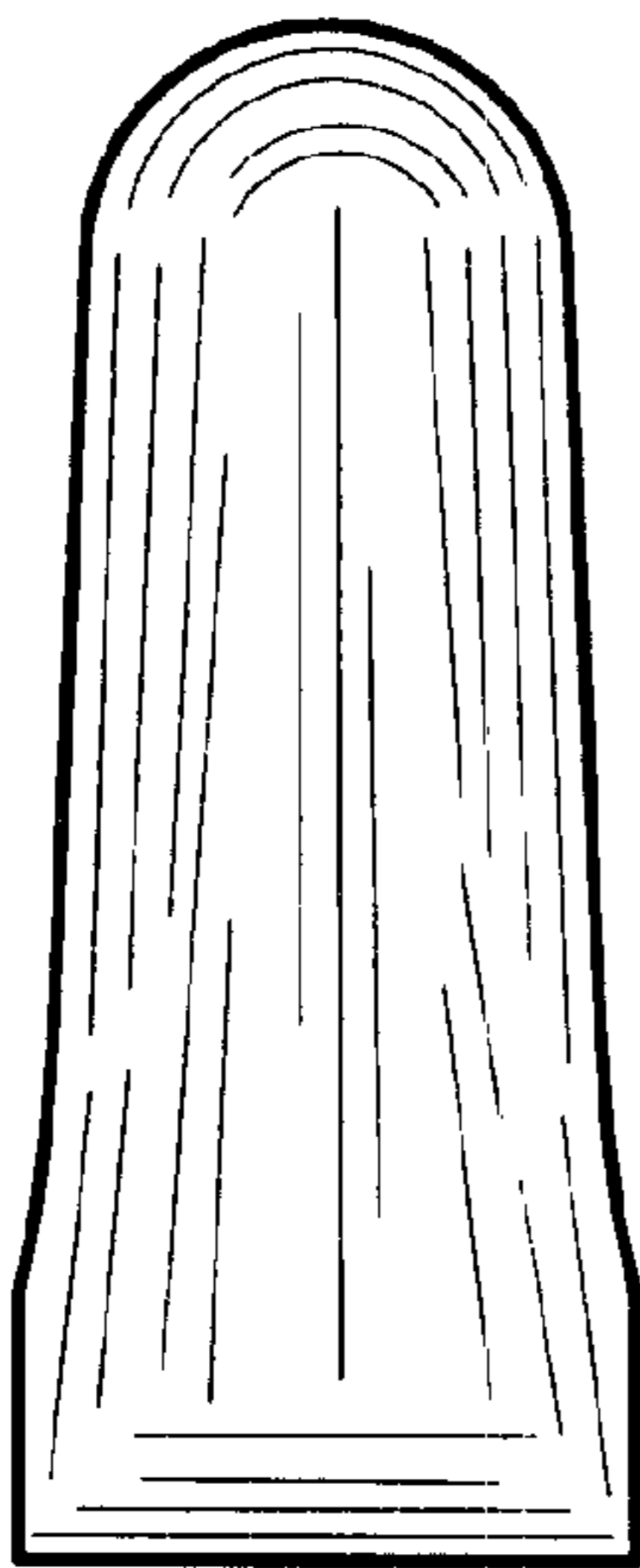

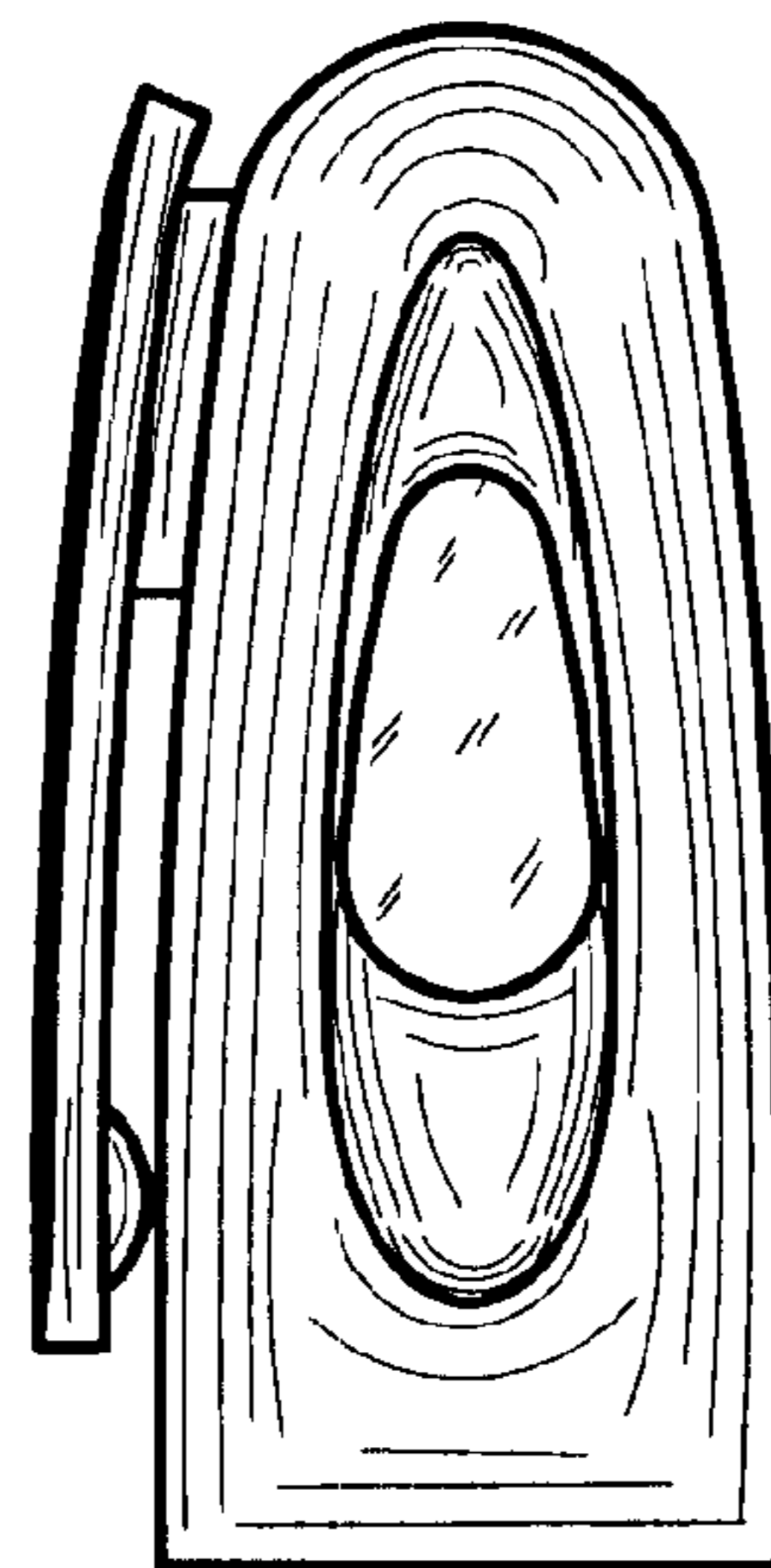

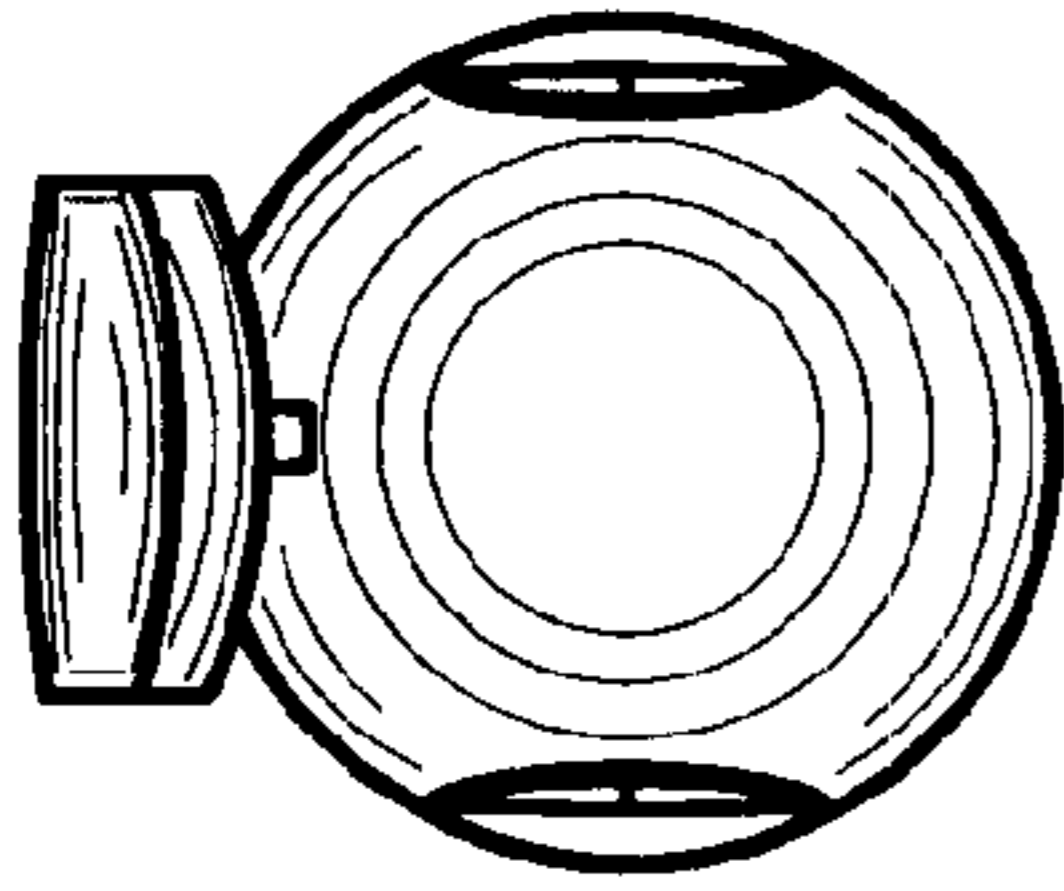

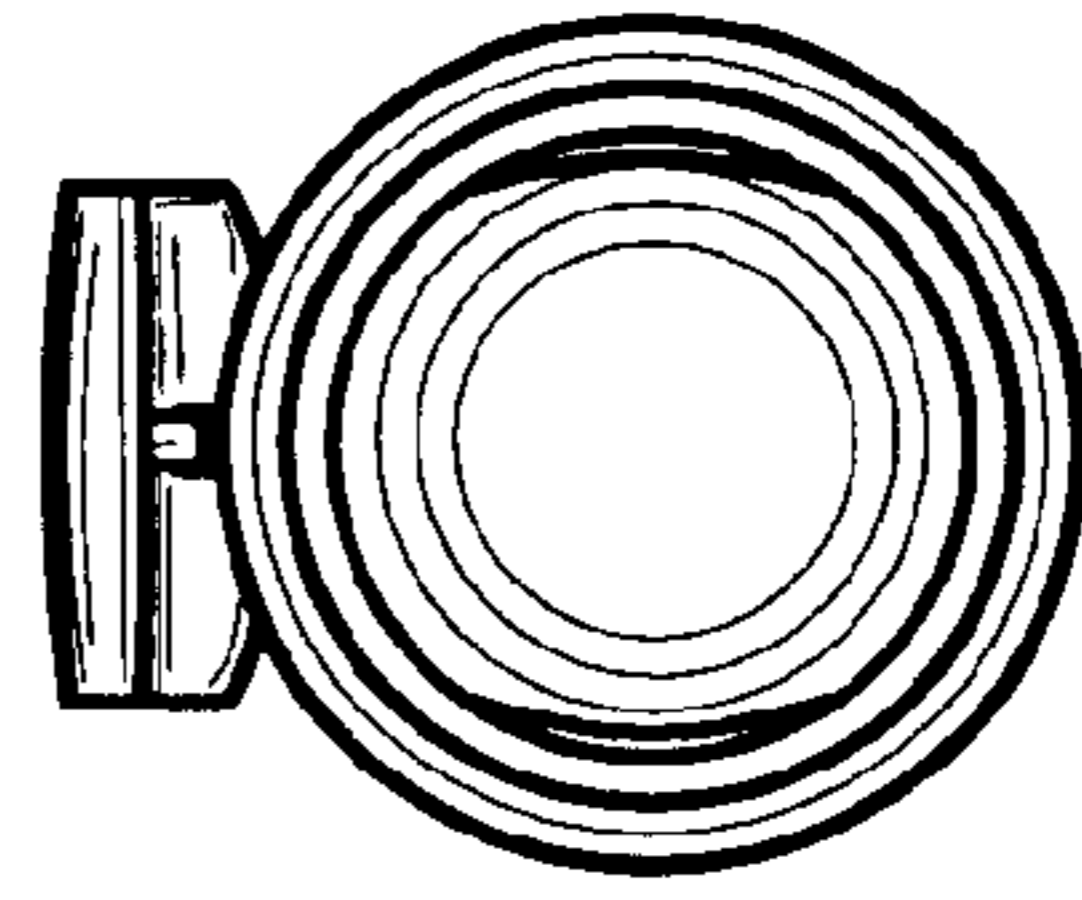

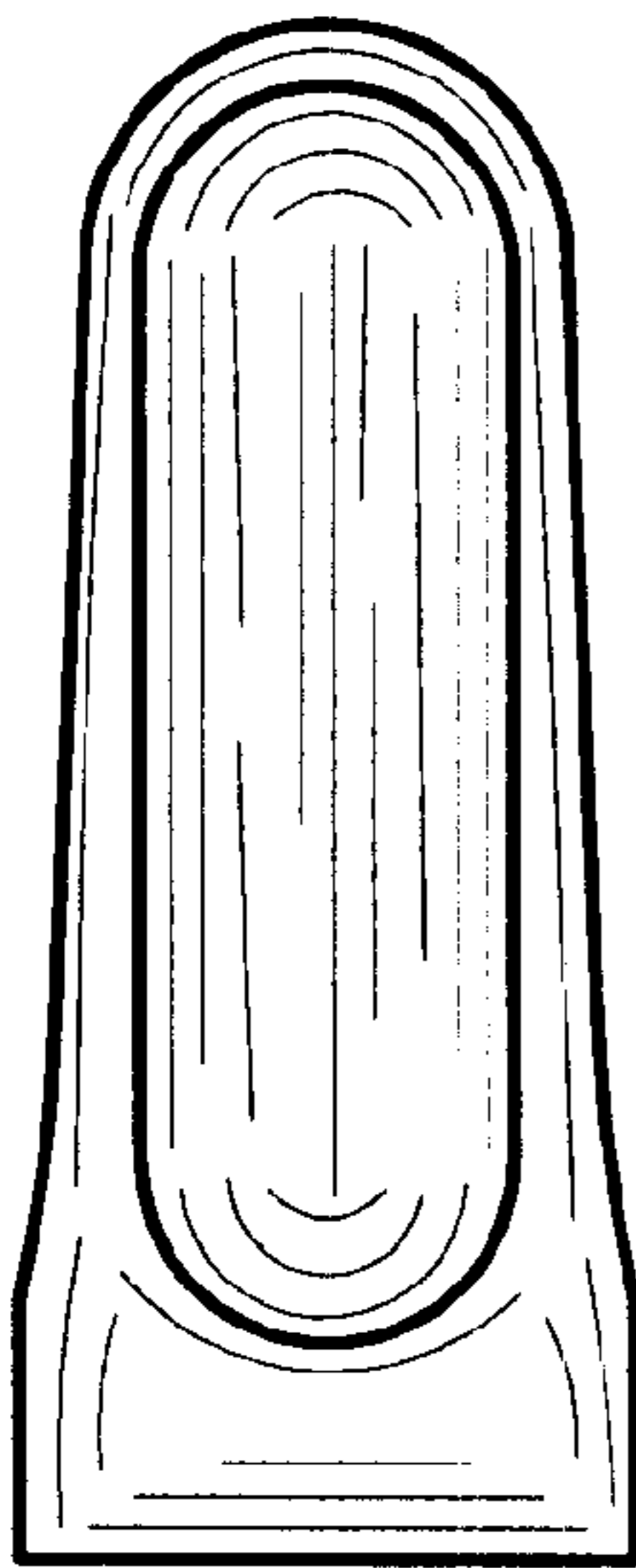

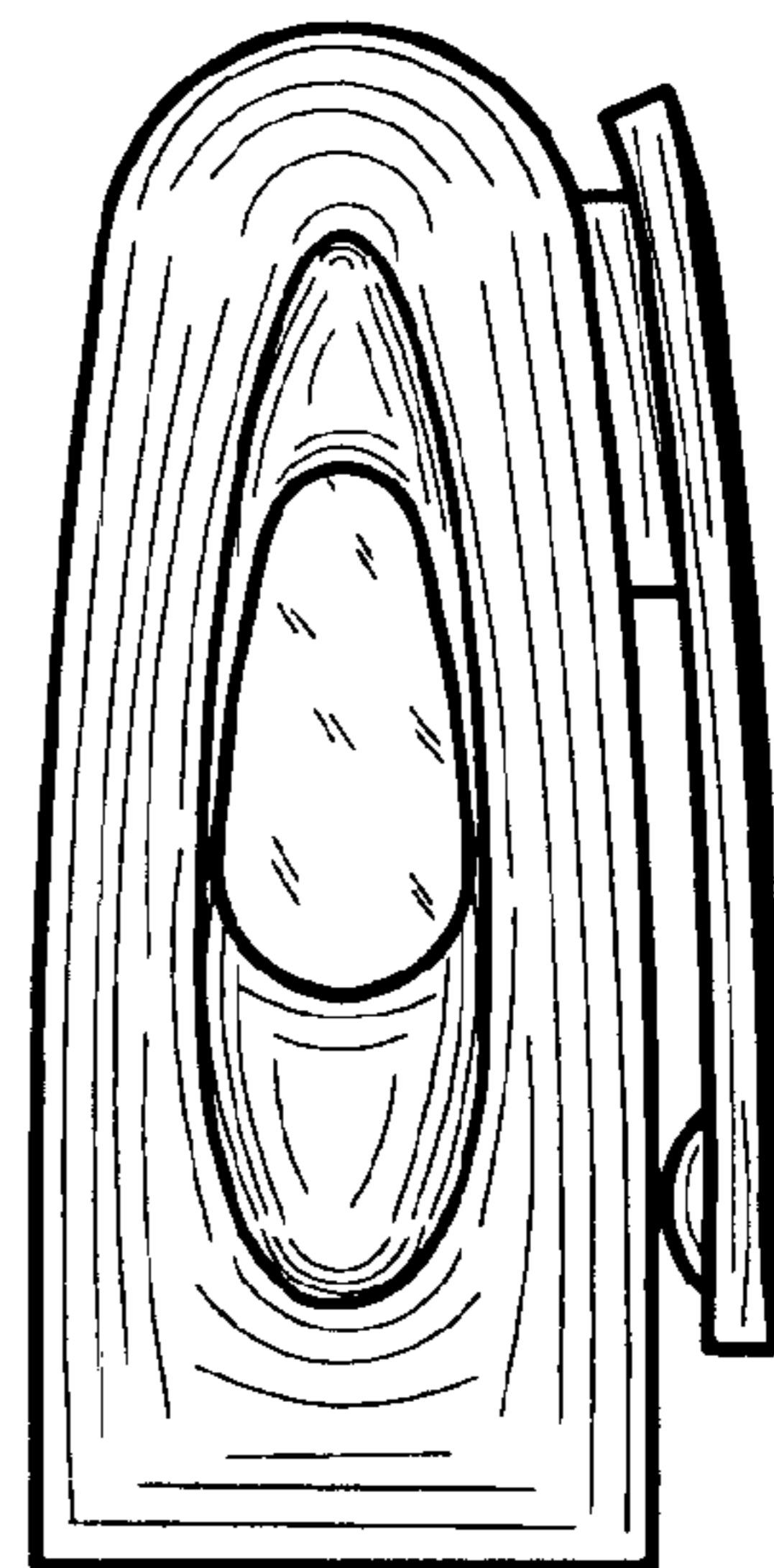
