FIG. 3 is an elevational view thereof with the barrel in a vertical orientation such that the writing end of the barrel is in a downwardly vertical direction;

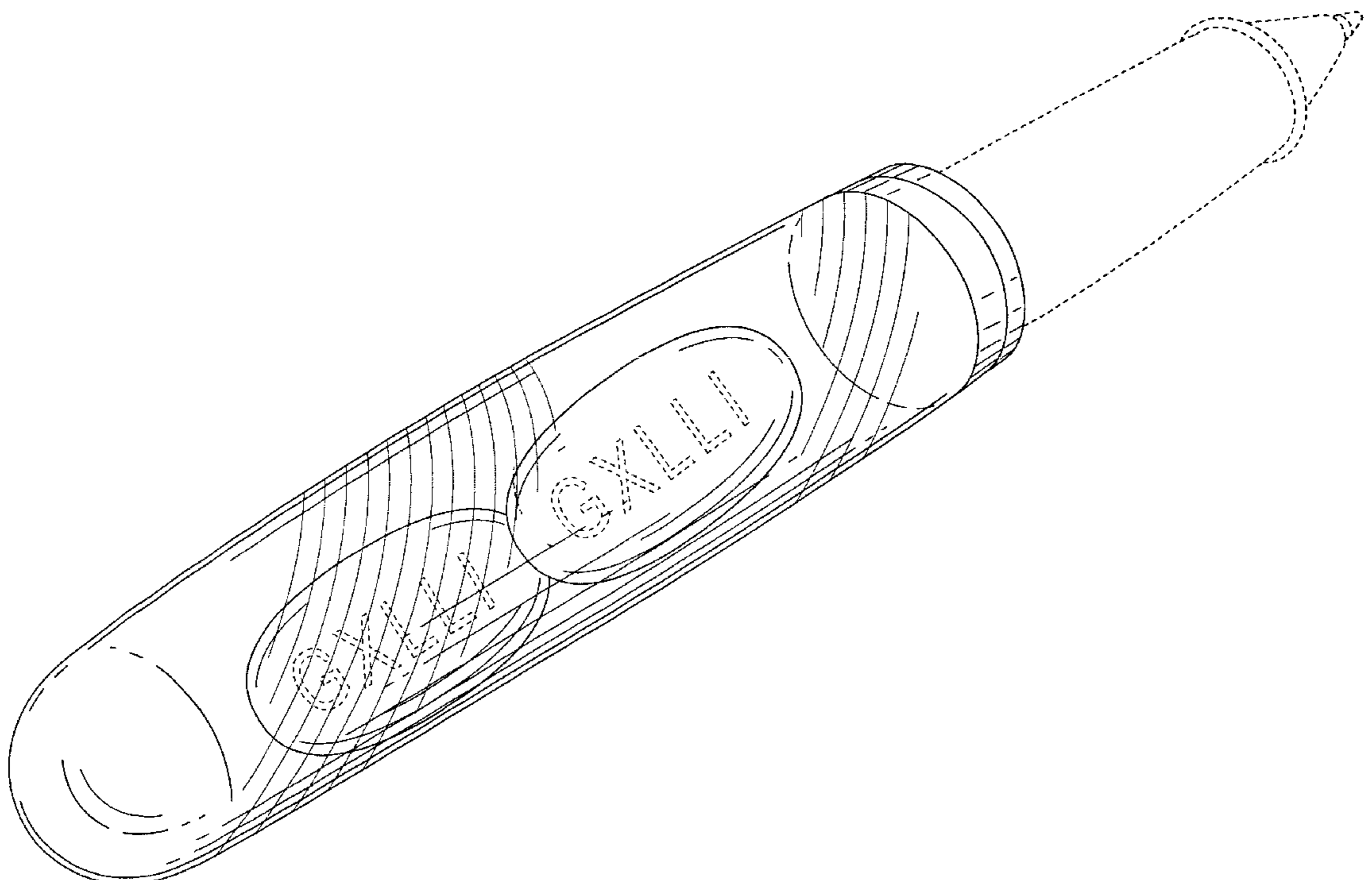
FIG. 4 is an elevational view thereof with the barrel in a horizontal orientation;

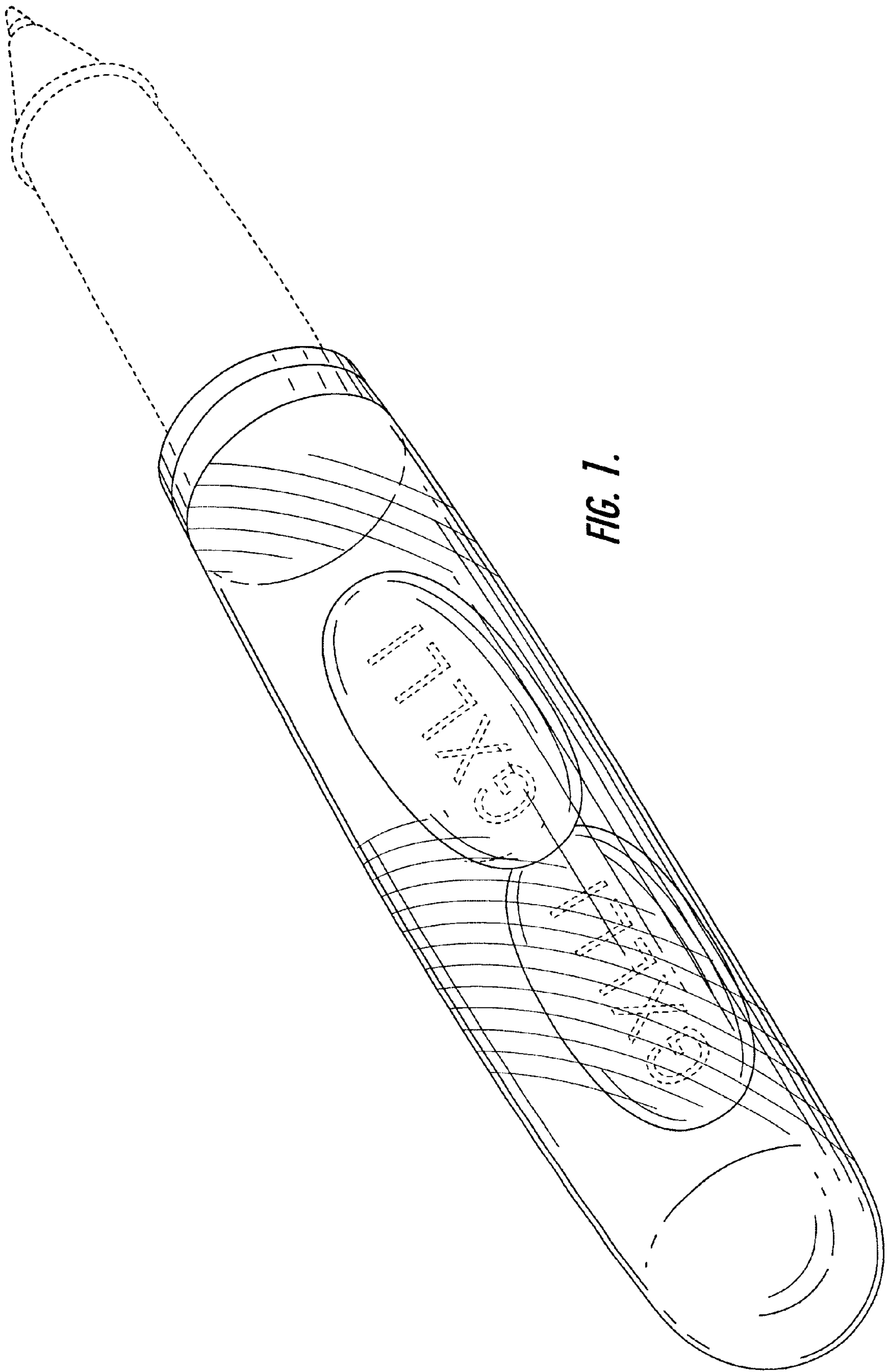
FIG. 5 is a top plan view thereof; and,

FIG. 6 is a bottom plan view thereof.

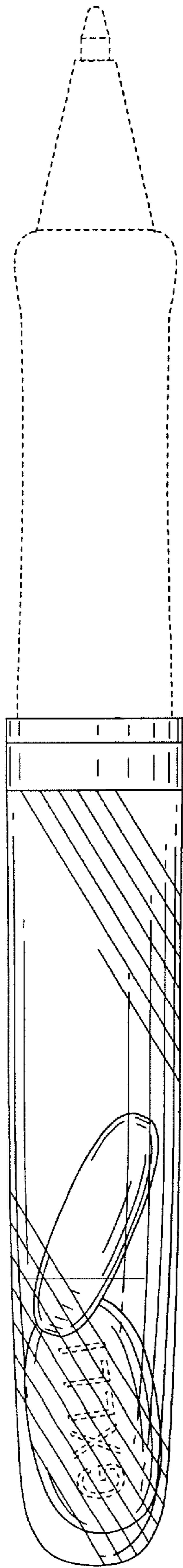

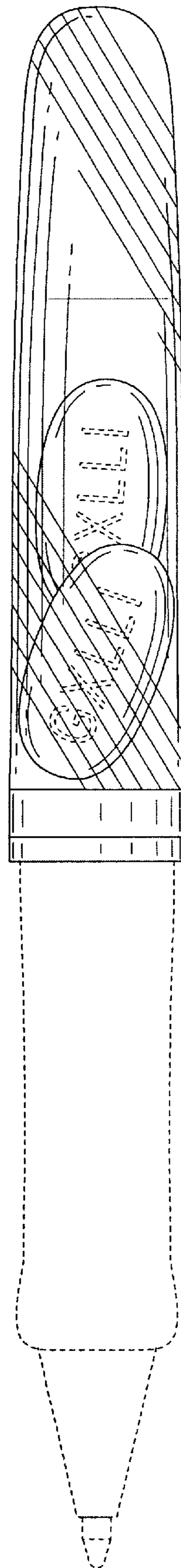

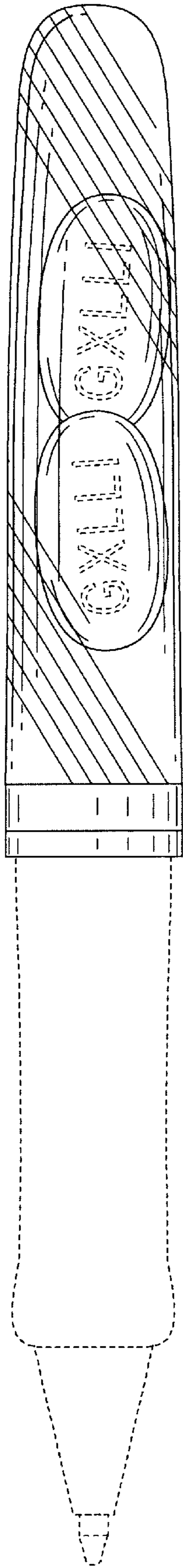

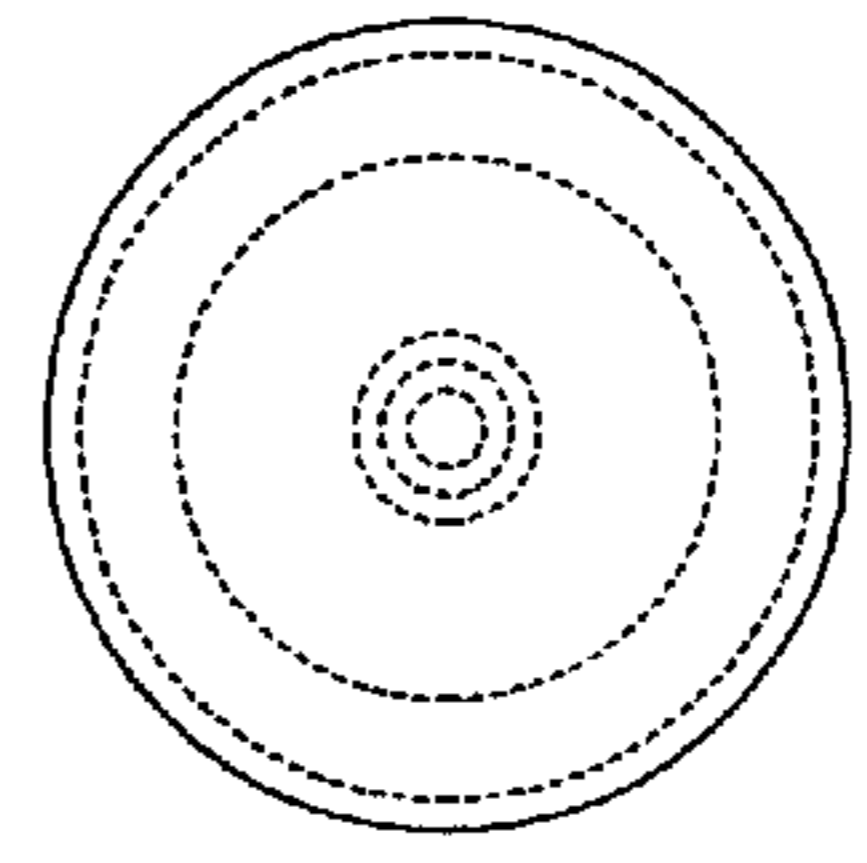

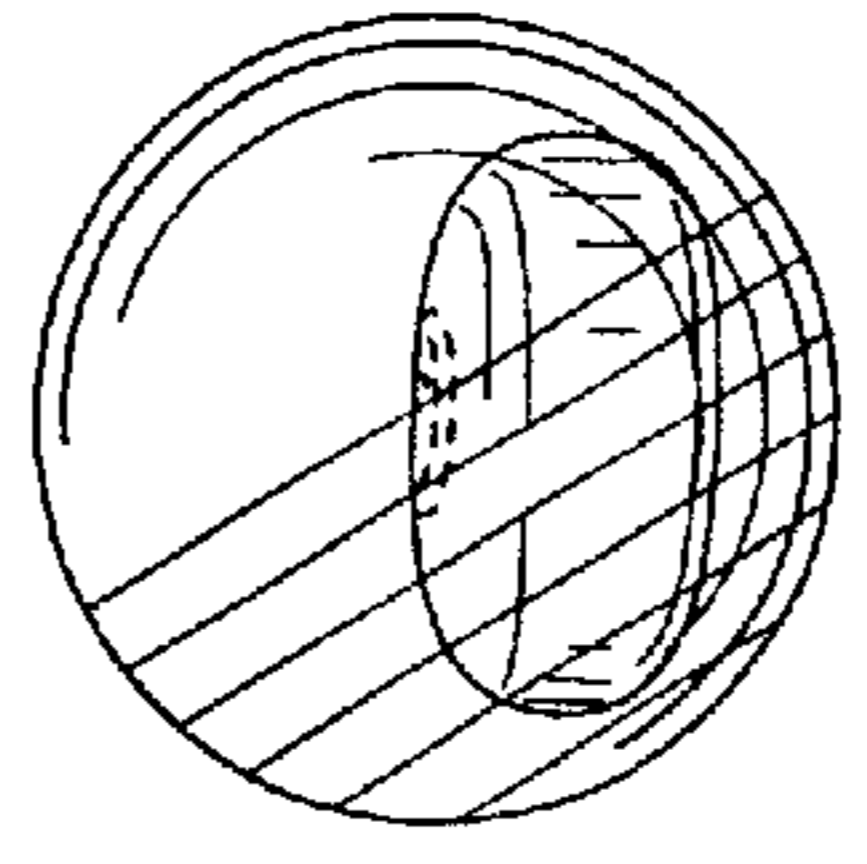
