FIG. 4 shows the front view of the beach towel and poncho on a person.

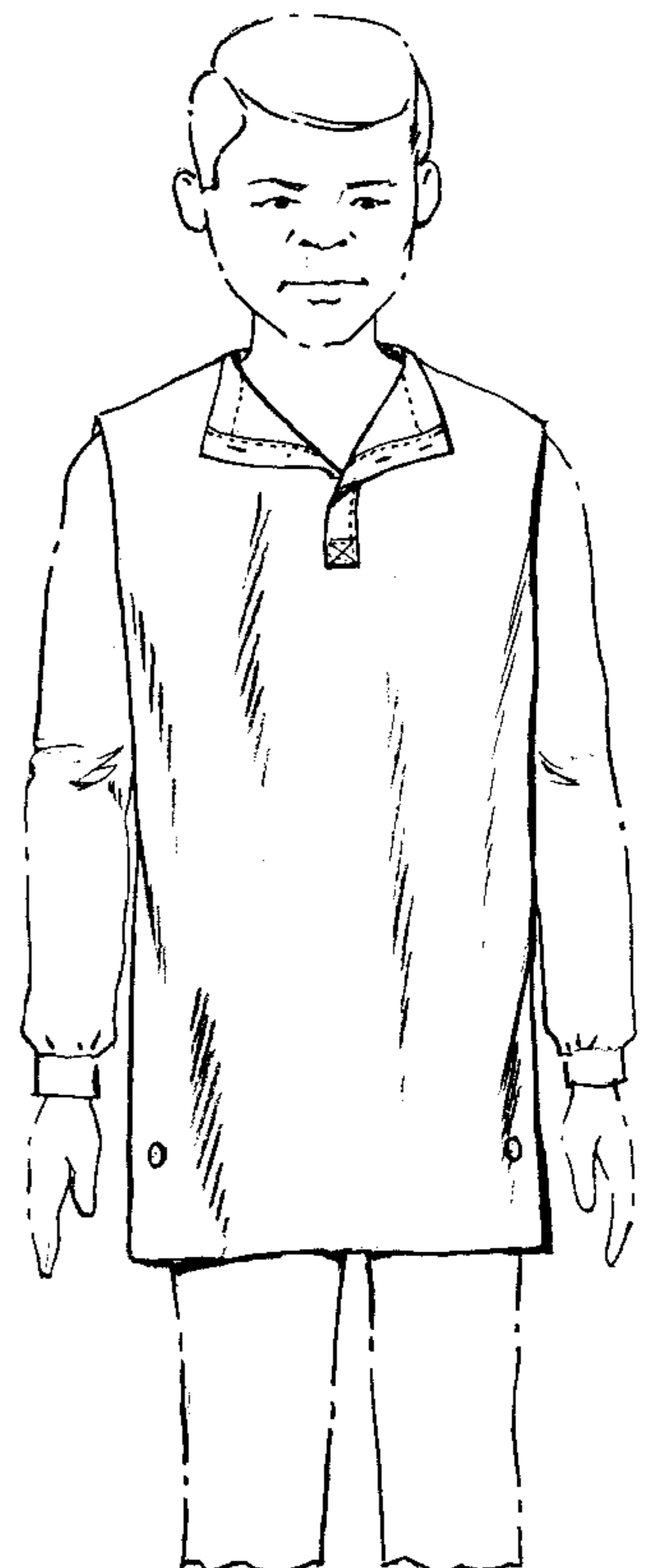
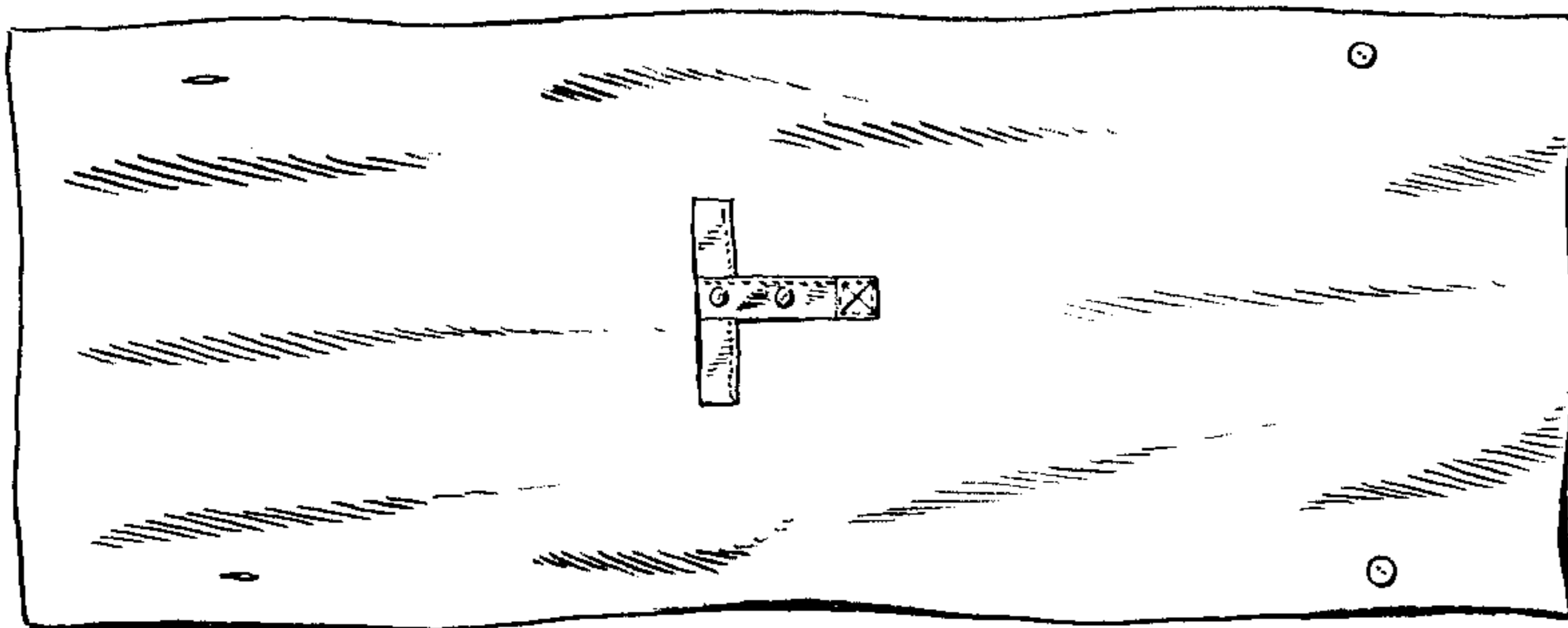
FIG. 5 shows the back view of the beach towel and poncho on a person.

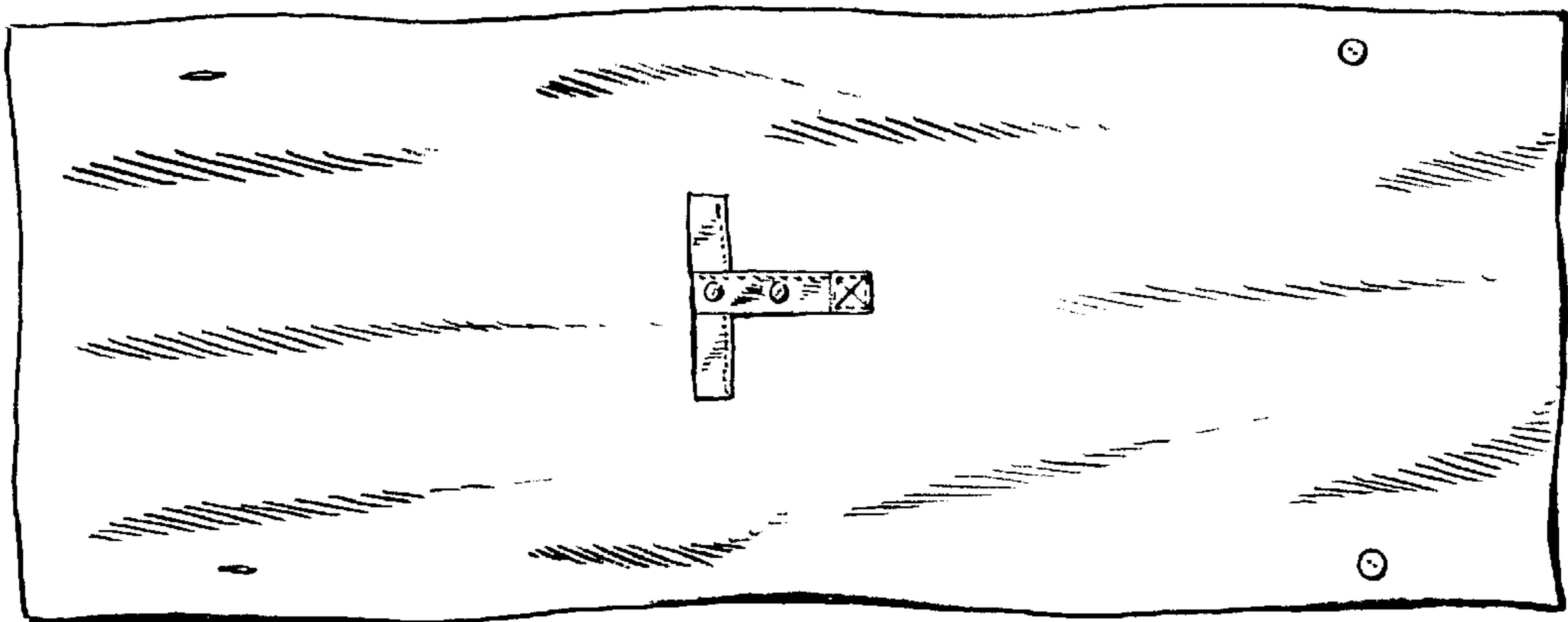

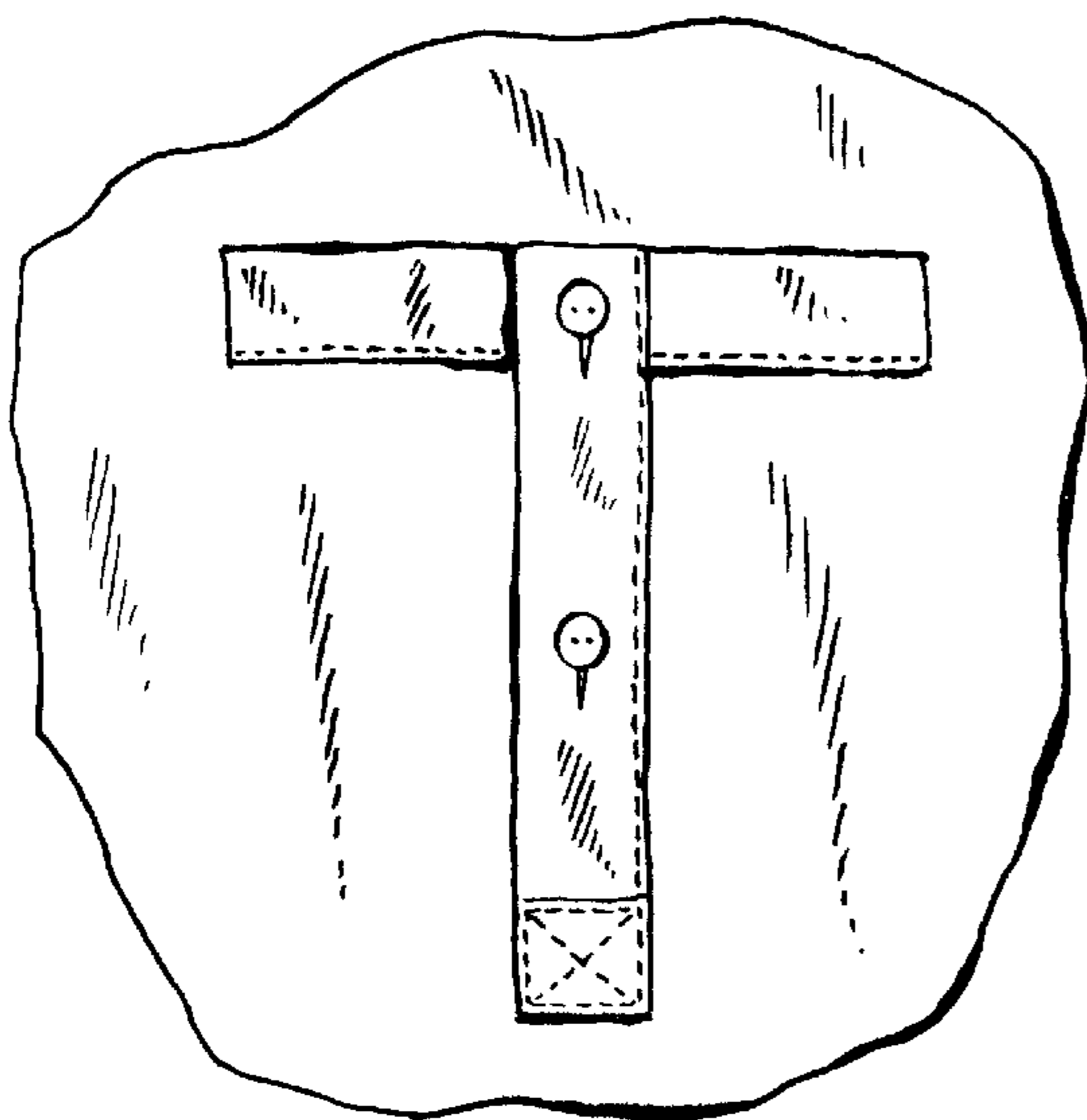
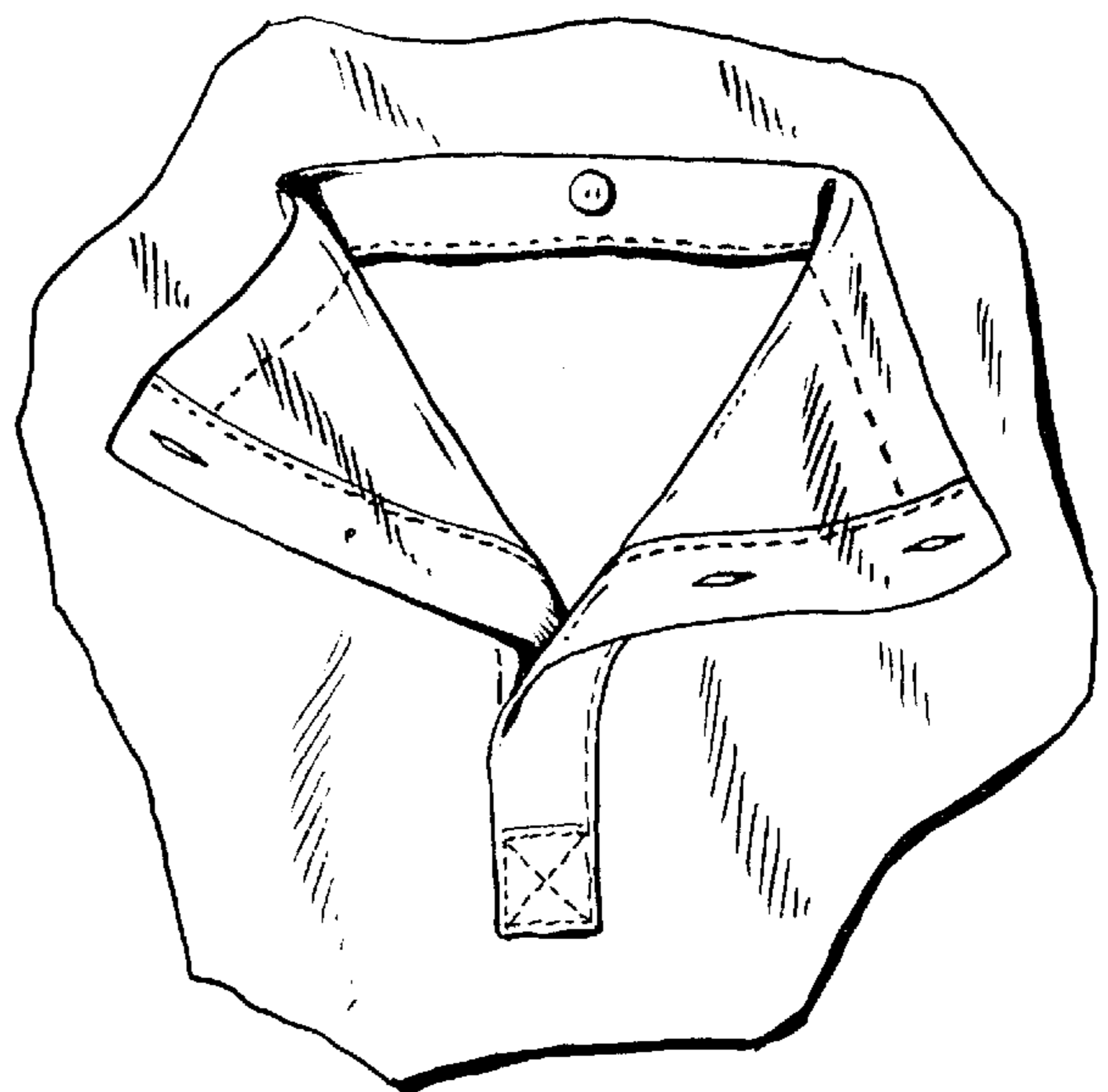

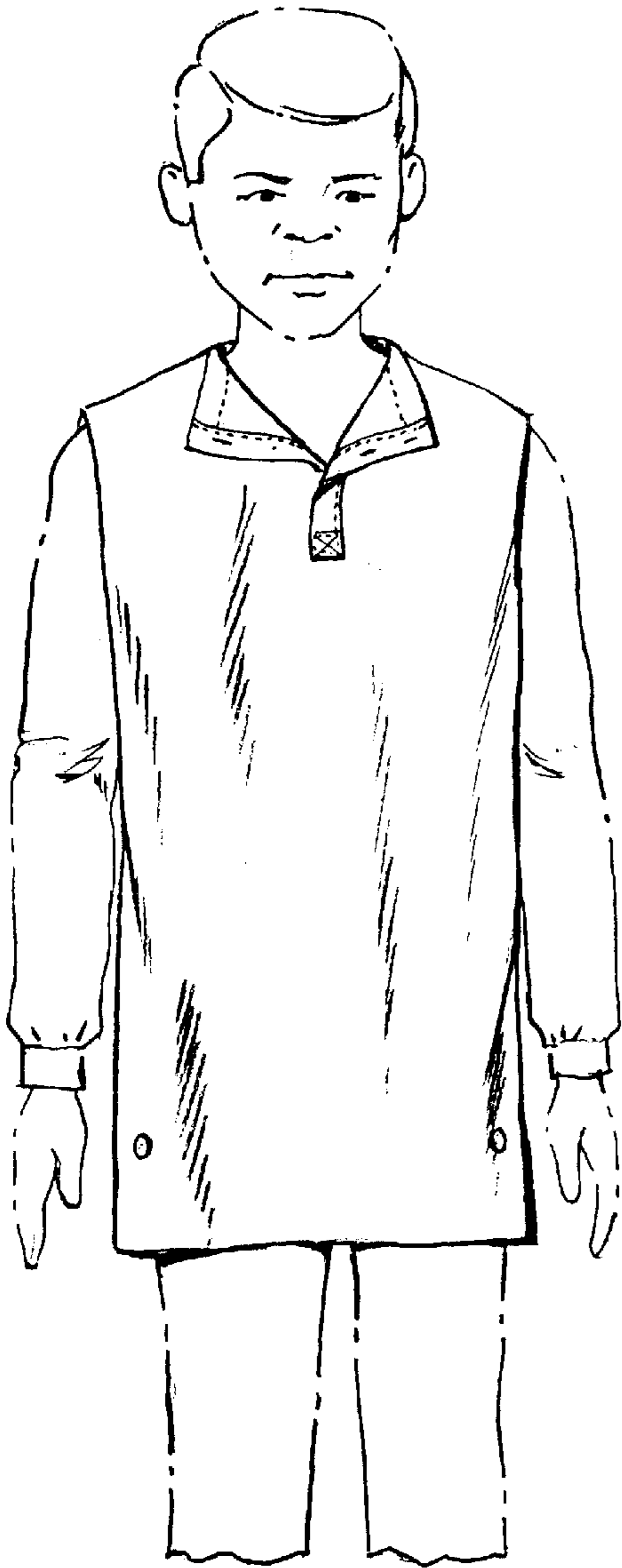

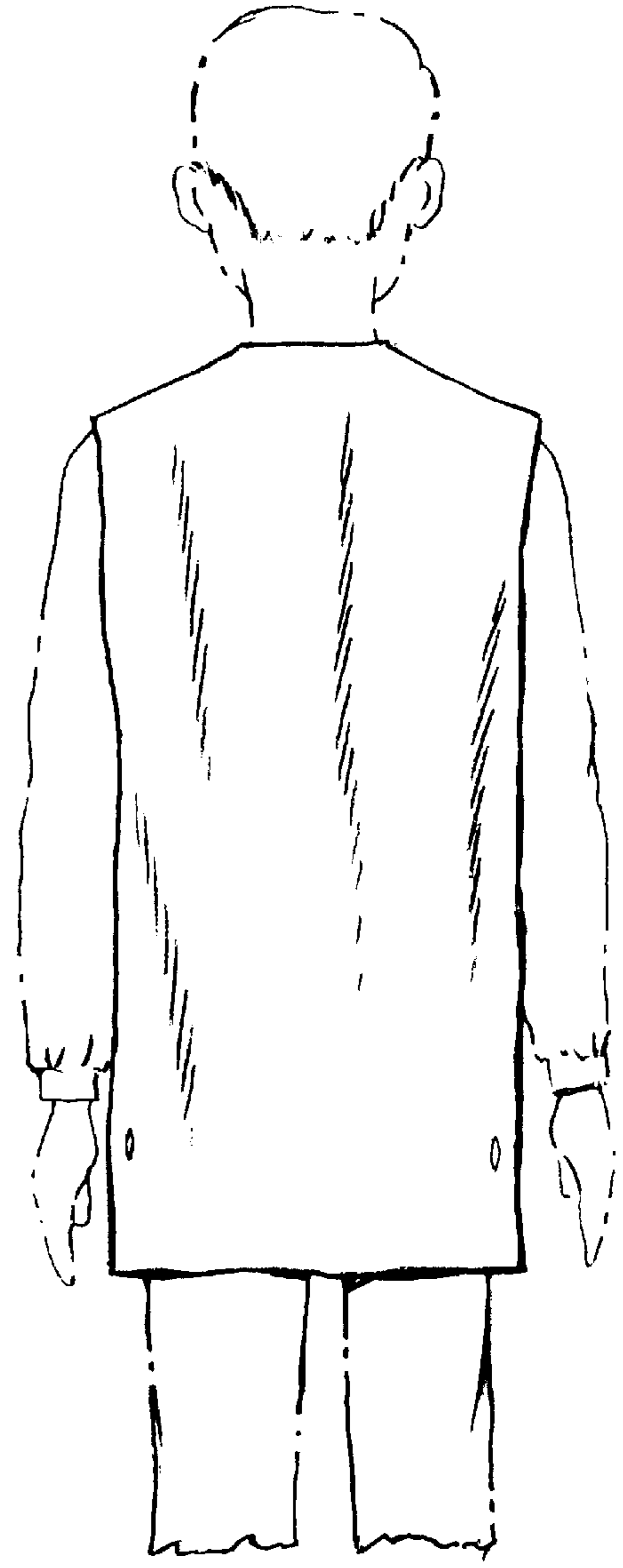

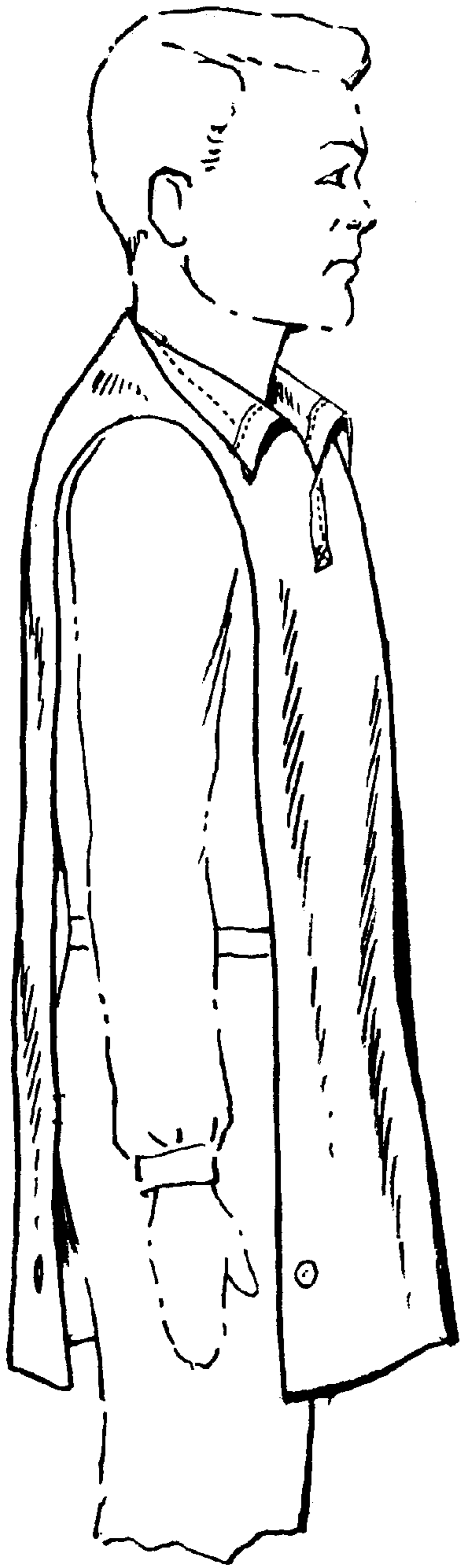

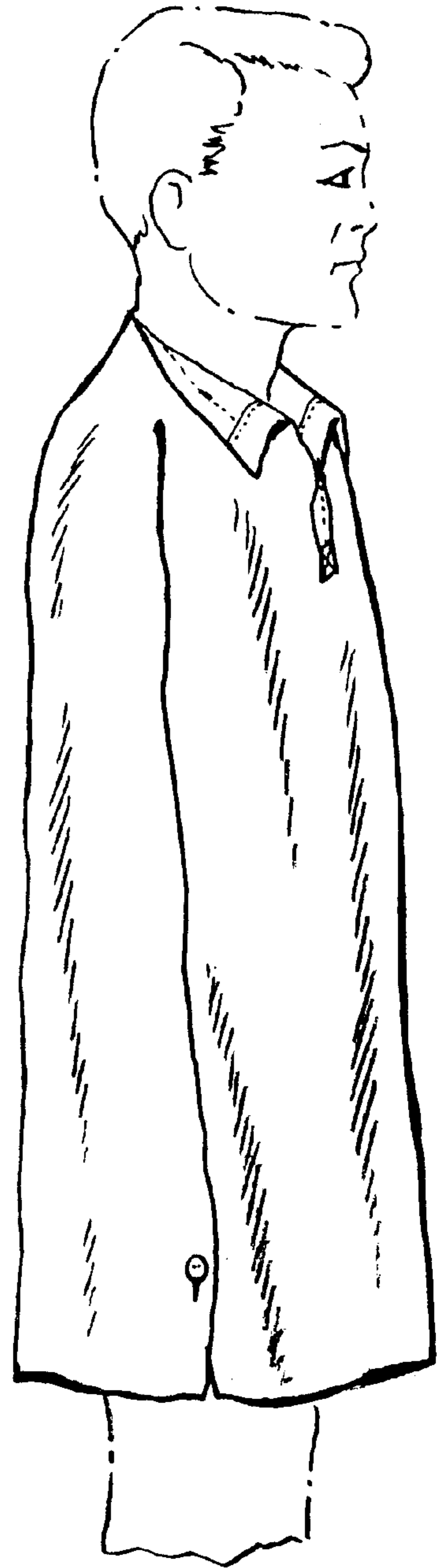
