(57) **CLAIM**
The ornamental design for the lamp, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view from above of the lamp in accordance with my design;
FIG. 2 is a left elevation view of the lamp in accordance with my design;
FIG. 3 is a front elevation view of the lamp in accordance with my design;
FIG. 4 is a right elevation view of the lamp in accordance with my design;
FIG. 5 is a rear elevation view of the lamp in accordance with my design;
FIG. 6 is a top plan view of the lamp in accordance with my design; and,
FIG. 7 is a bottom plan view of the lamp in accordance with my design.
The rear elevation of the lamp backplate follows the contours as shown in FIGS. 1 through 6 and is unornamented and forms no part of the claimed design. Electric cords extending out of the rear of the backplate form no part of the claimed design.

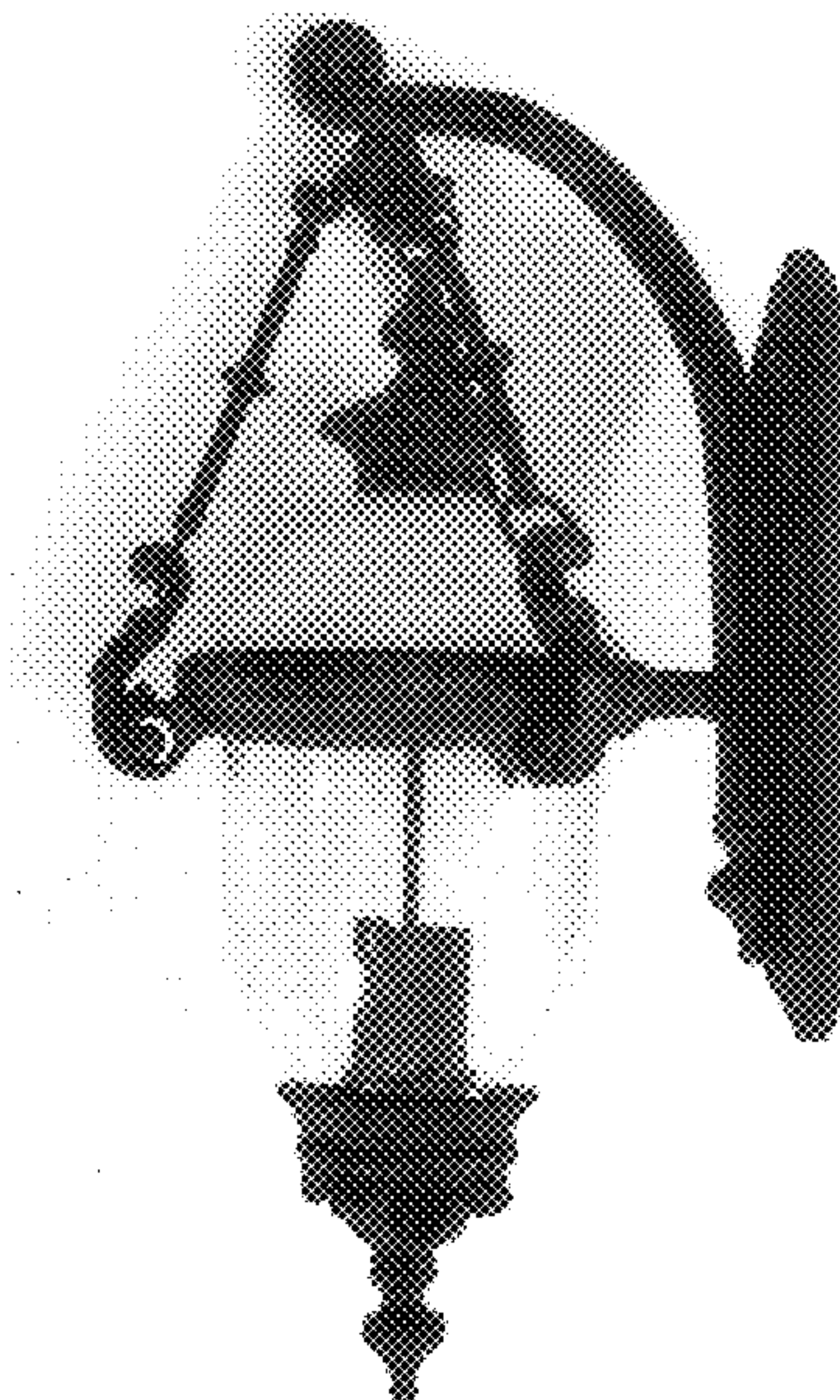

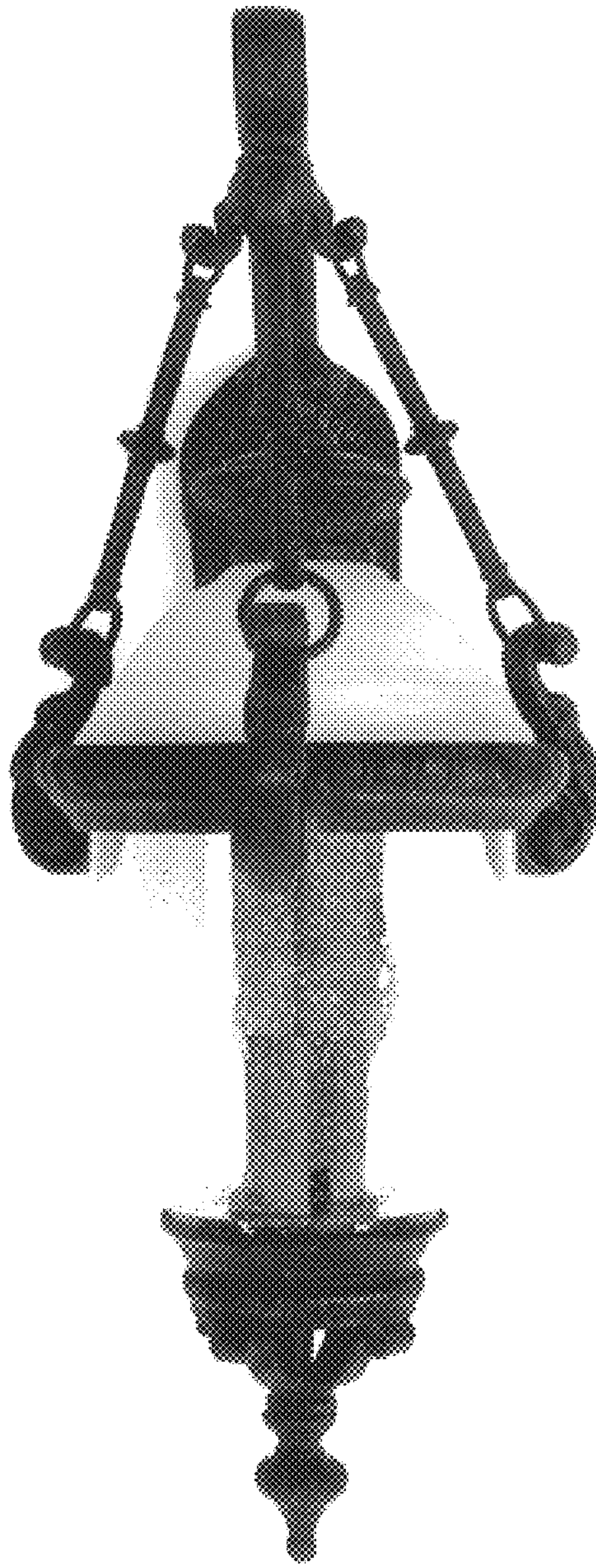

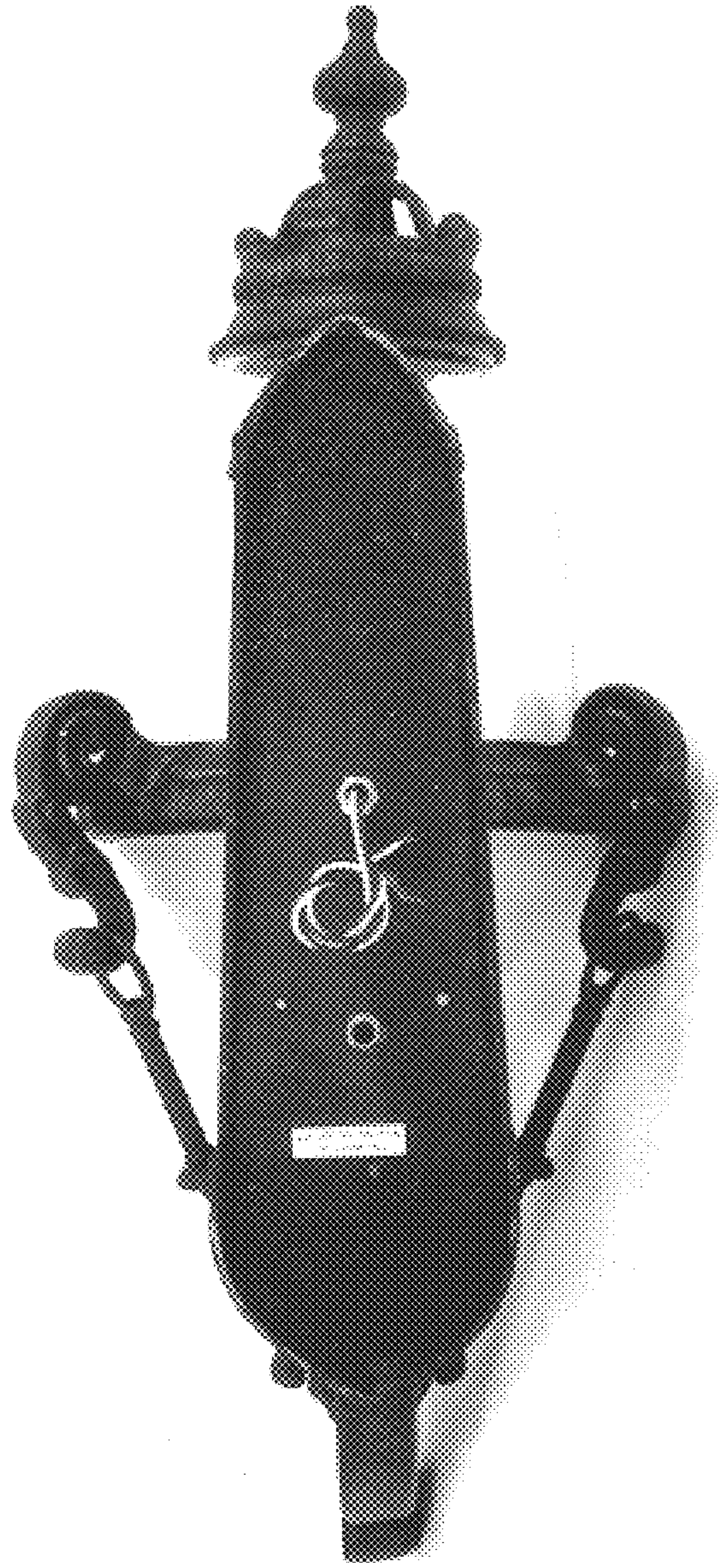

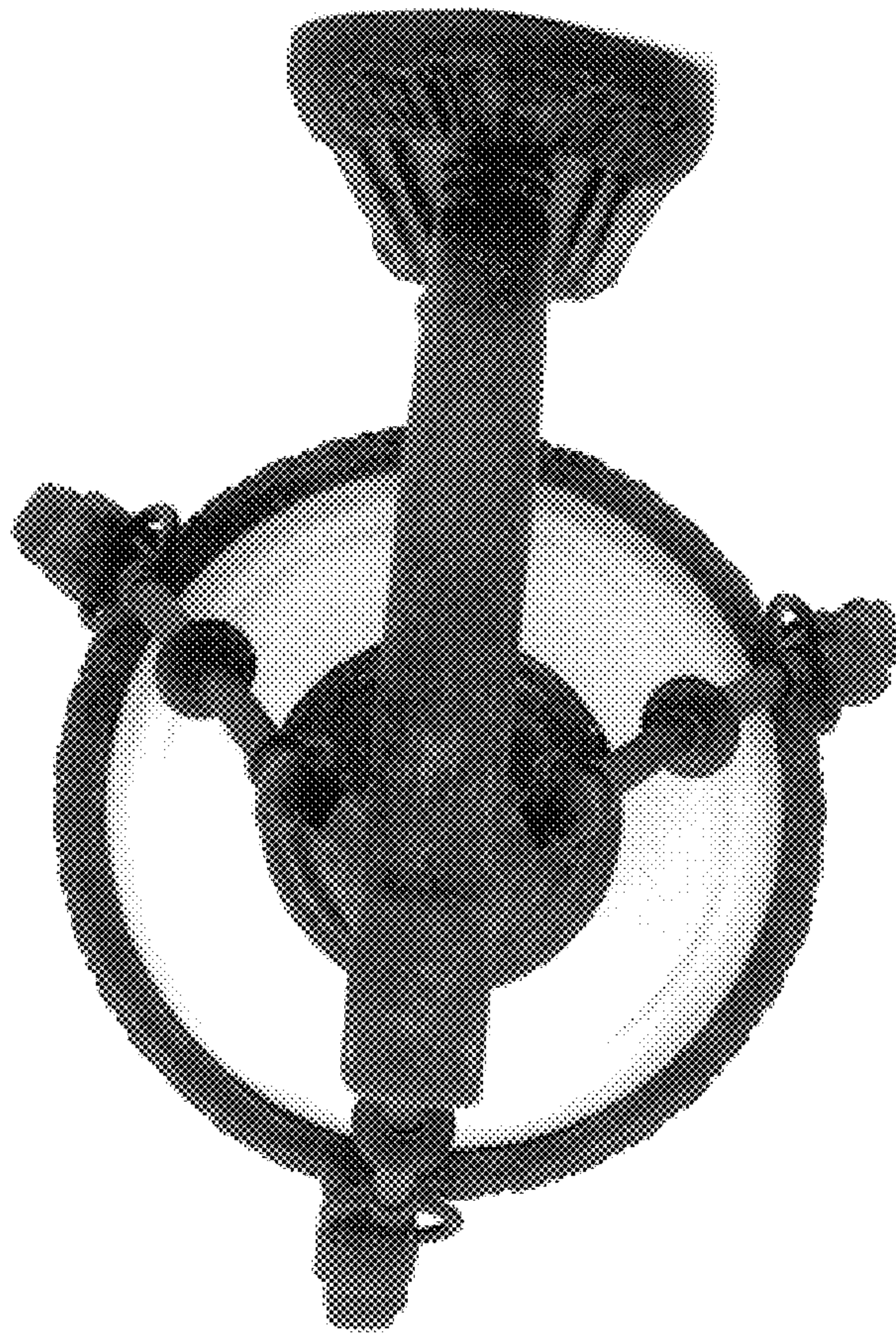

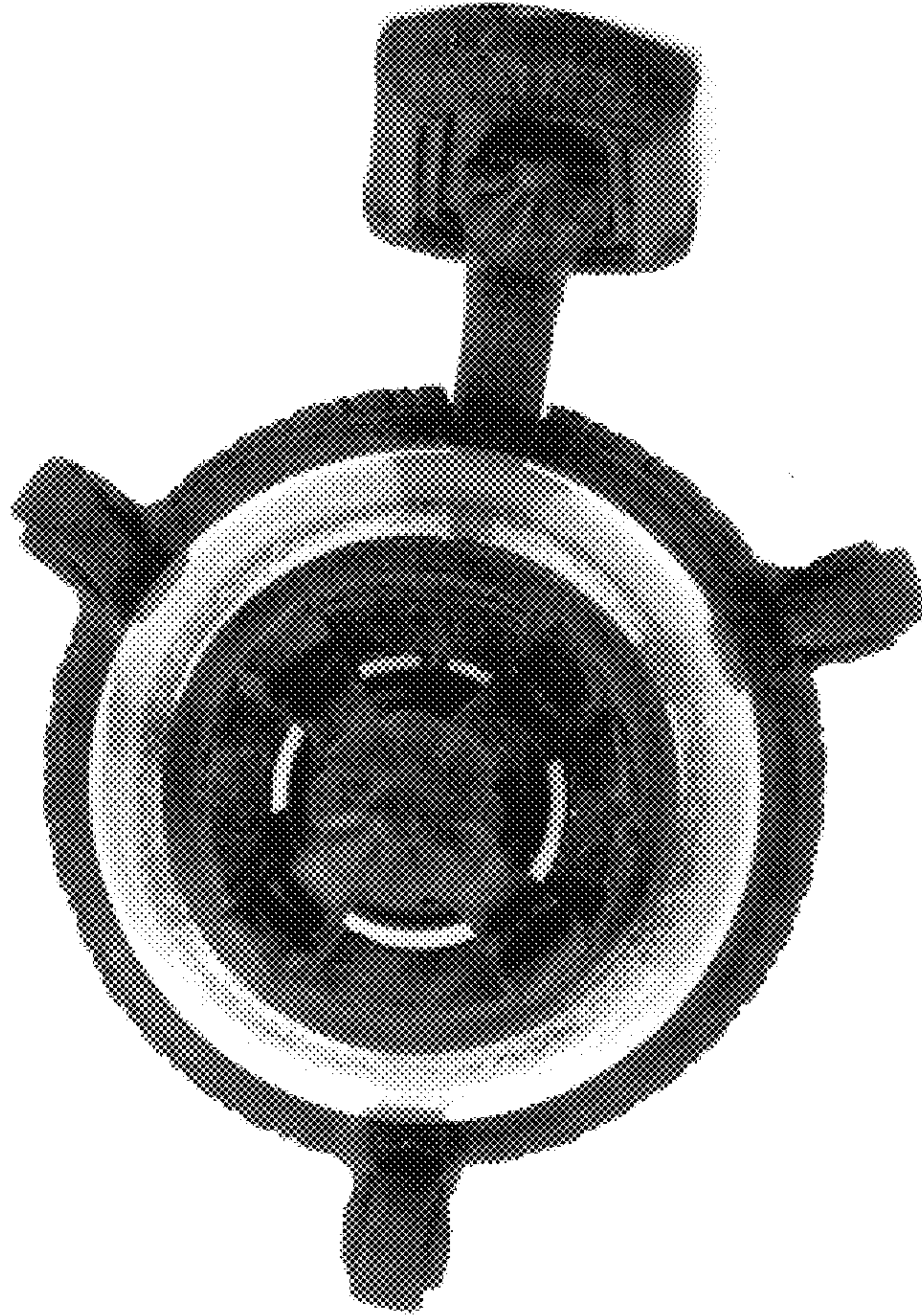
