(57) **CLAIM**

The ornamental design for a clothing swatch with circular pocket, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a clothing swatch with circular pocket attached to at least a portion of an article of clothing; FIG. 2 is a bottom plan view thereof from which only the portion of the article of clothing is viewable;

FIG. 3 is a perspective view thereof;

FIG. 4 is a left side view thereof, the right side view being a mirror image thereof;

FIG. 5 is a top plan view of a clothing swatch with circular pocket showing a second embodiment of my new design, which differs from the first embodiment only by the inclusion of a top-accessed circular pocket;

FIG. 6 is a left side view of the embodiment of FIG. 5, the right side view being a mirror image thereof;

FIG. 7 is a top plan view of the clothing swatch with circular pocket showing a third embodiment of my new design, which differs from the first embodiment only by the inclusion of a surrounding ring;

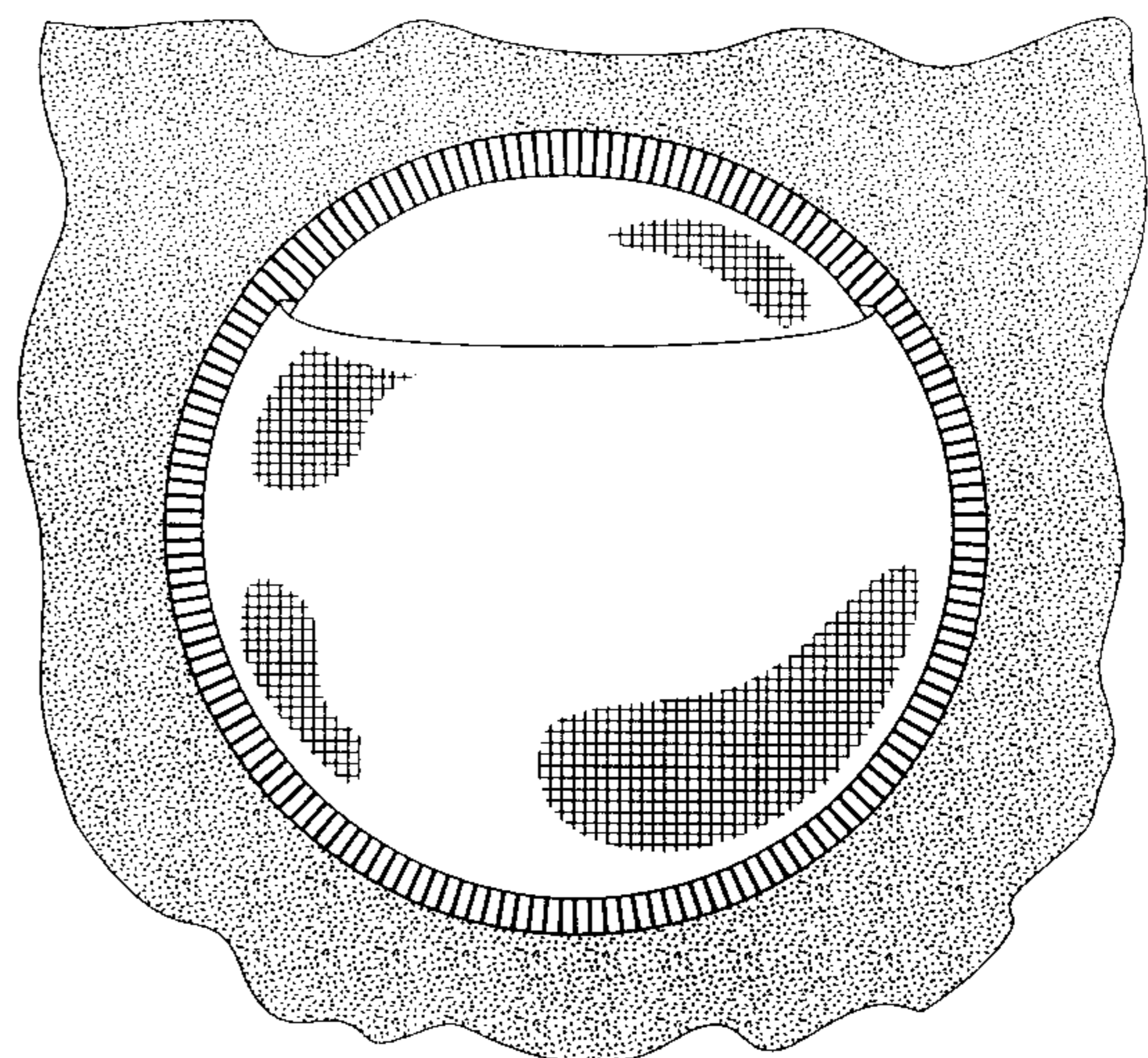
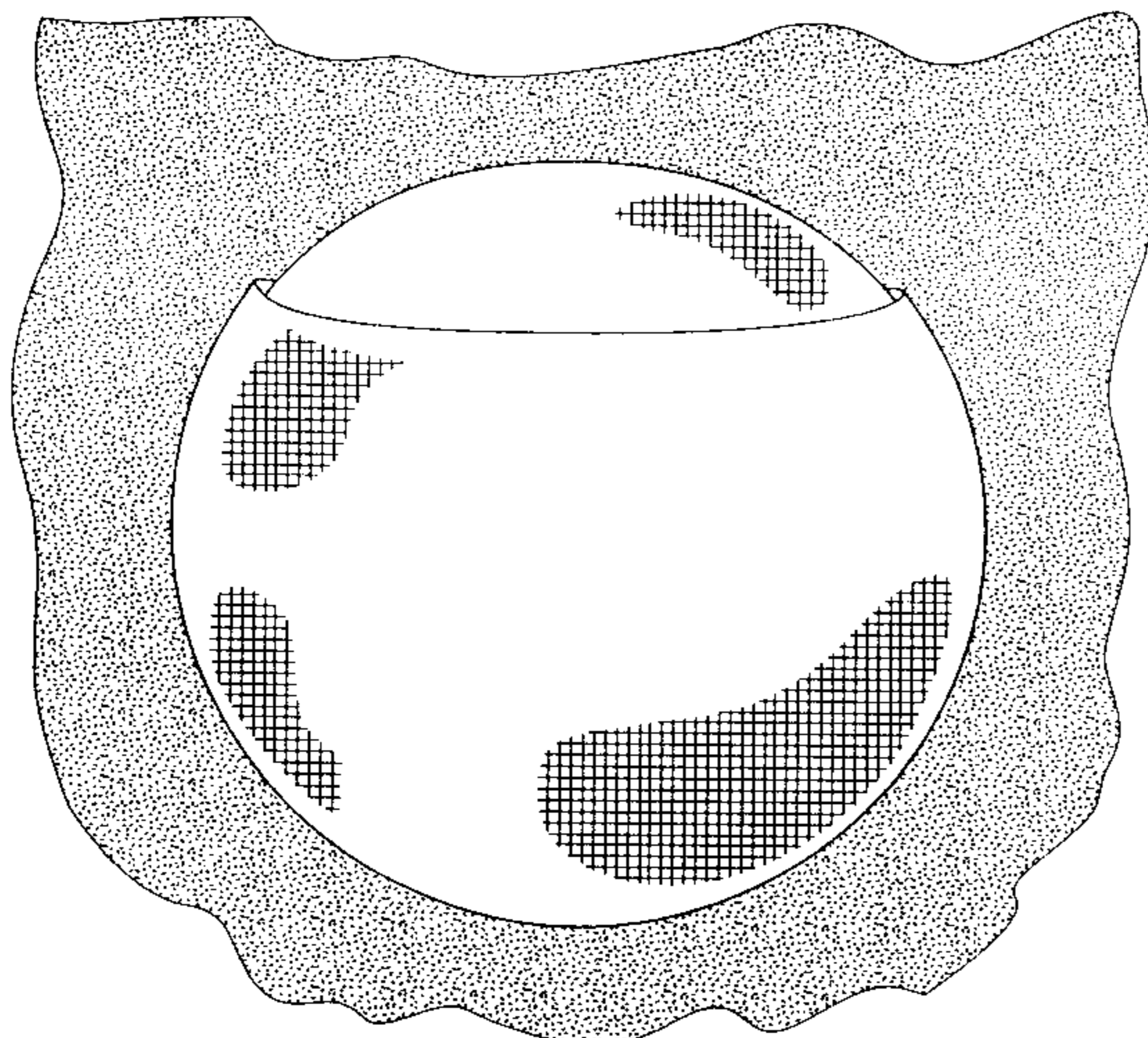
FIG. 8 is a left side view of the pocket of FIG. 7, the right side view being a mirror image thereof;

FIG. 9 is a top plan view of a clothing swatch with circular pocket showing a fourth embodiment of my new design, which differs from the third embodiment only by the inclusion of a top-accessed circular pocket; and,

FIG. 10 is a left side view of the embodiment of FIG. 9, the right side view being a mirror image thereof.

The broken lines are for illustrative purposes only, and their presence and position on the clothing swatch with circular pocket form no part of the claimed design.

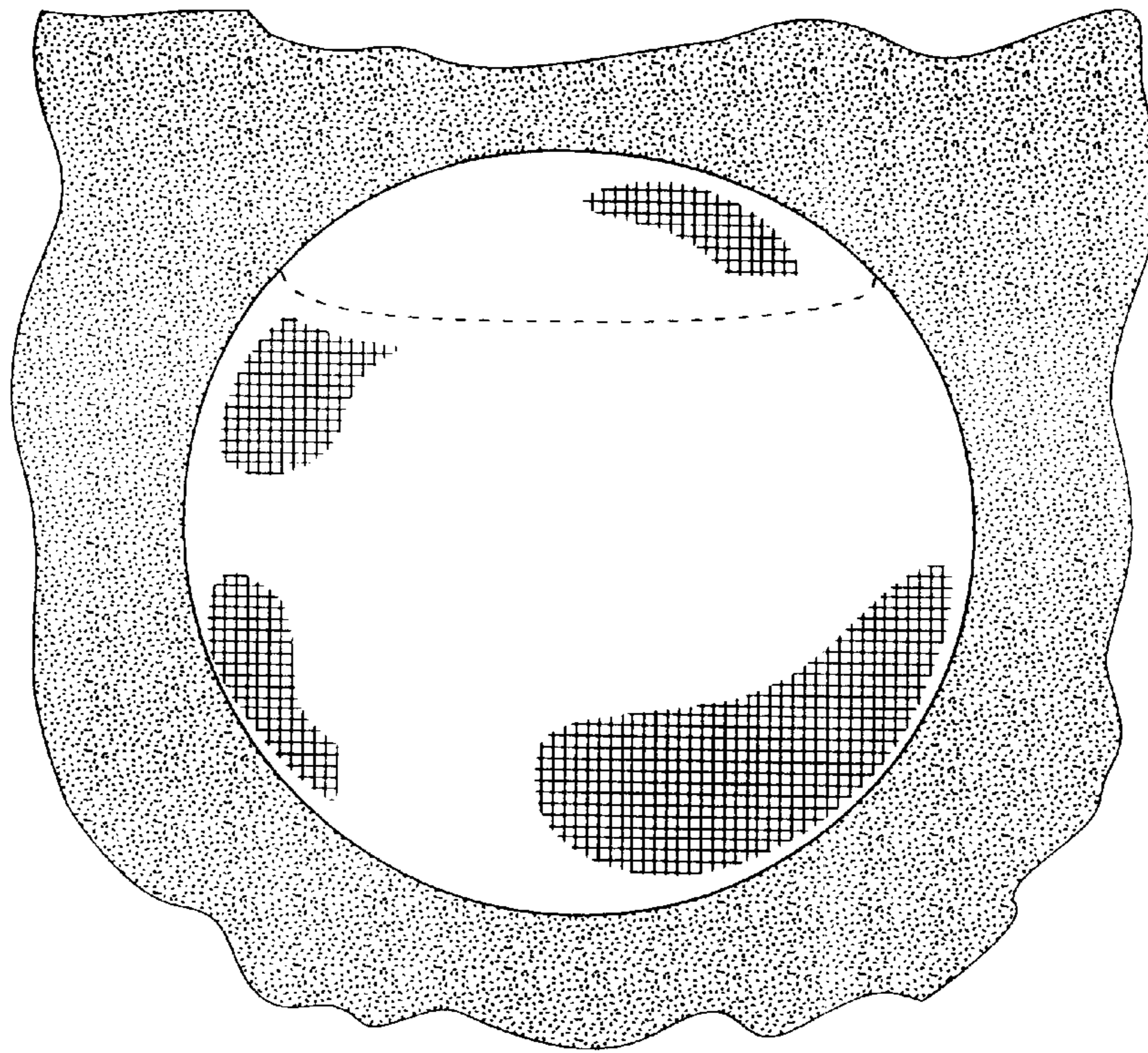

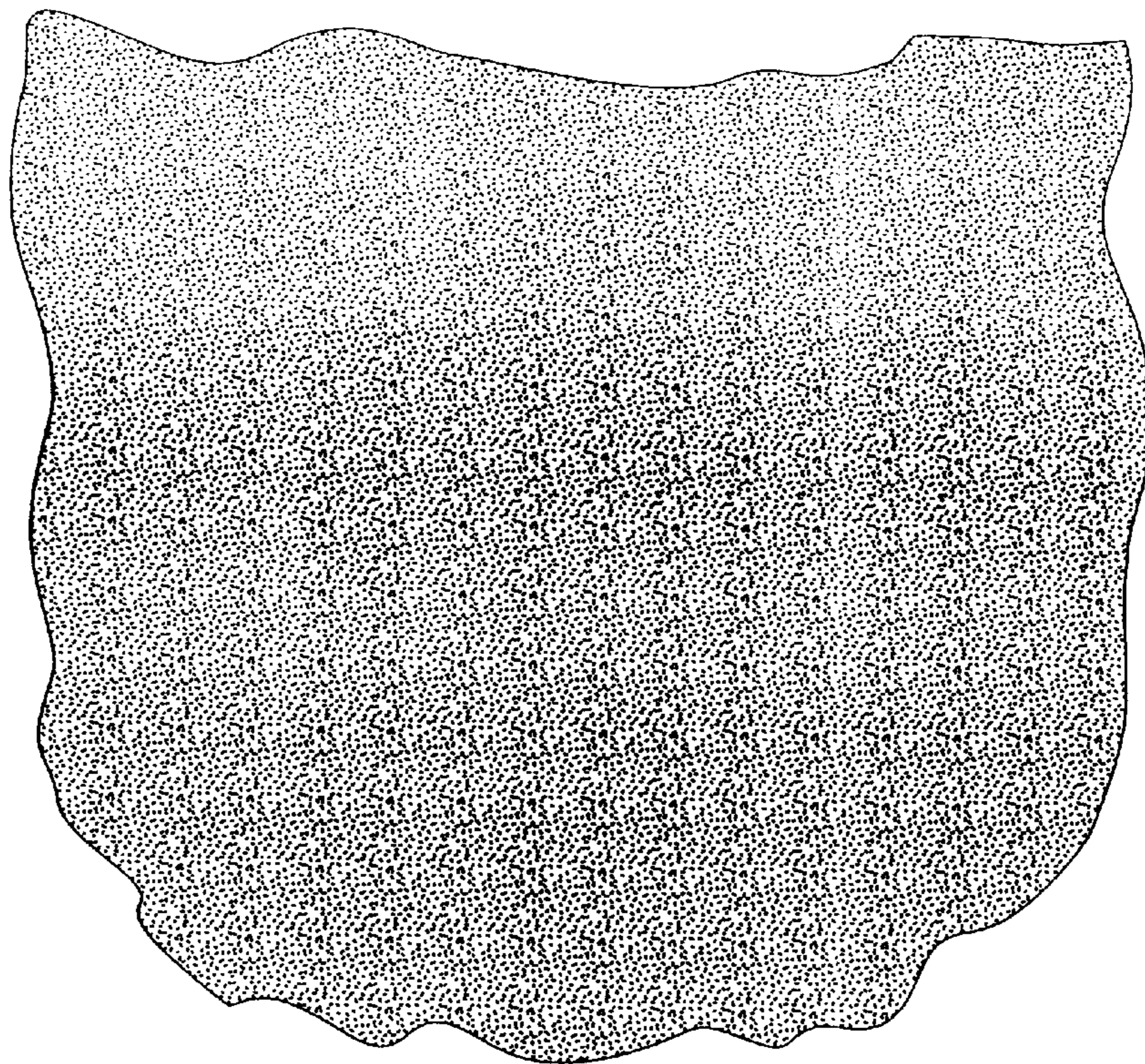

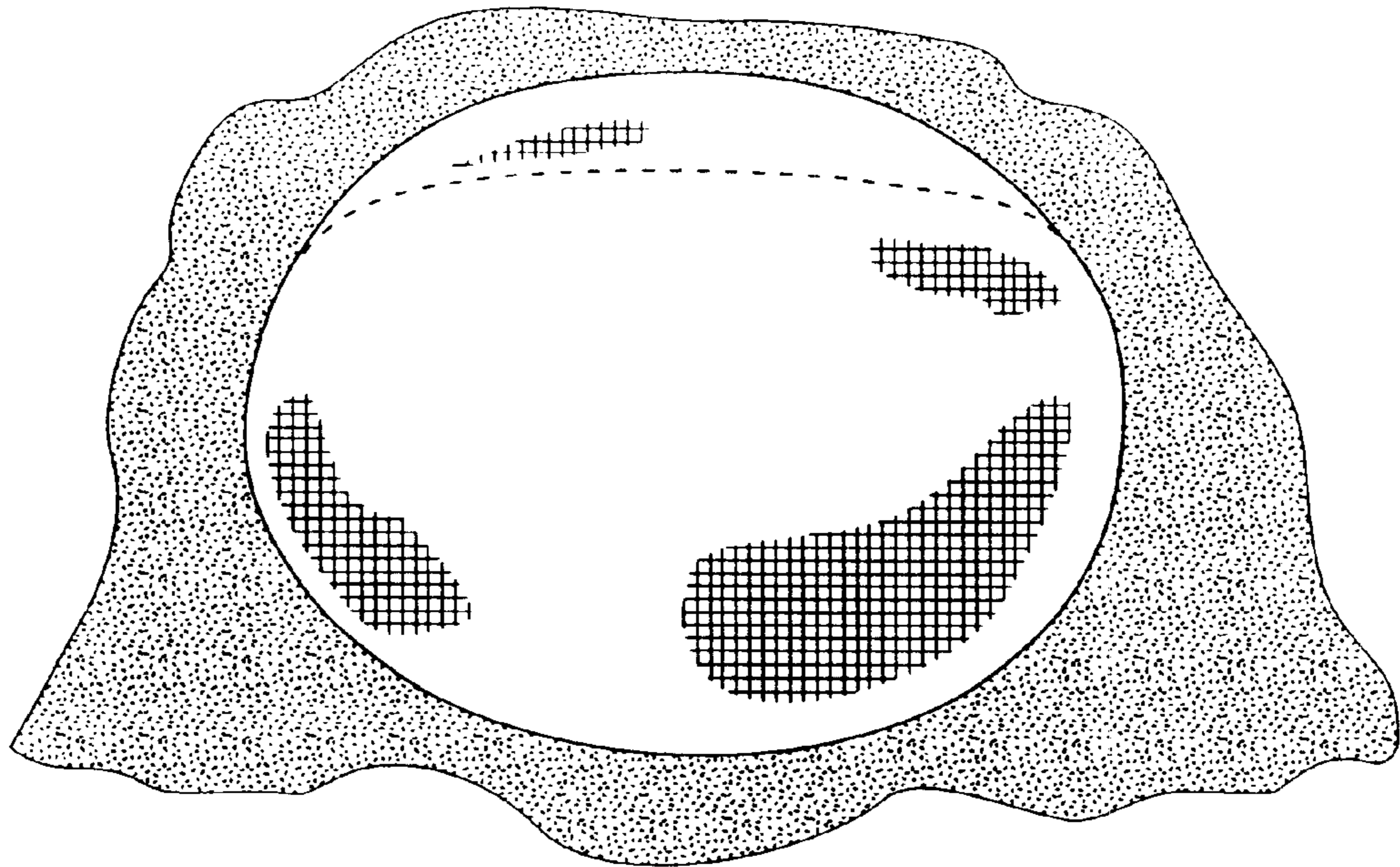

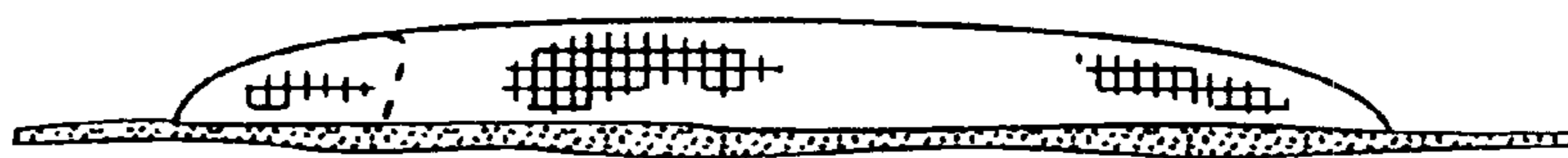

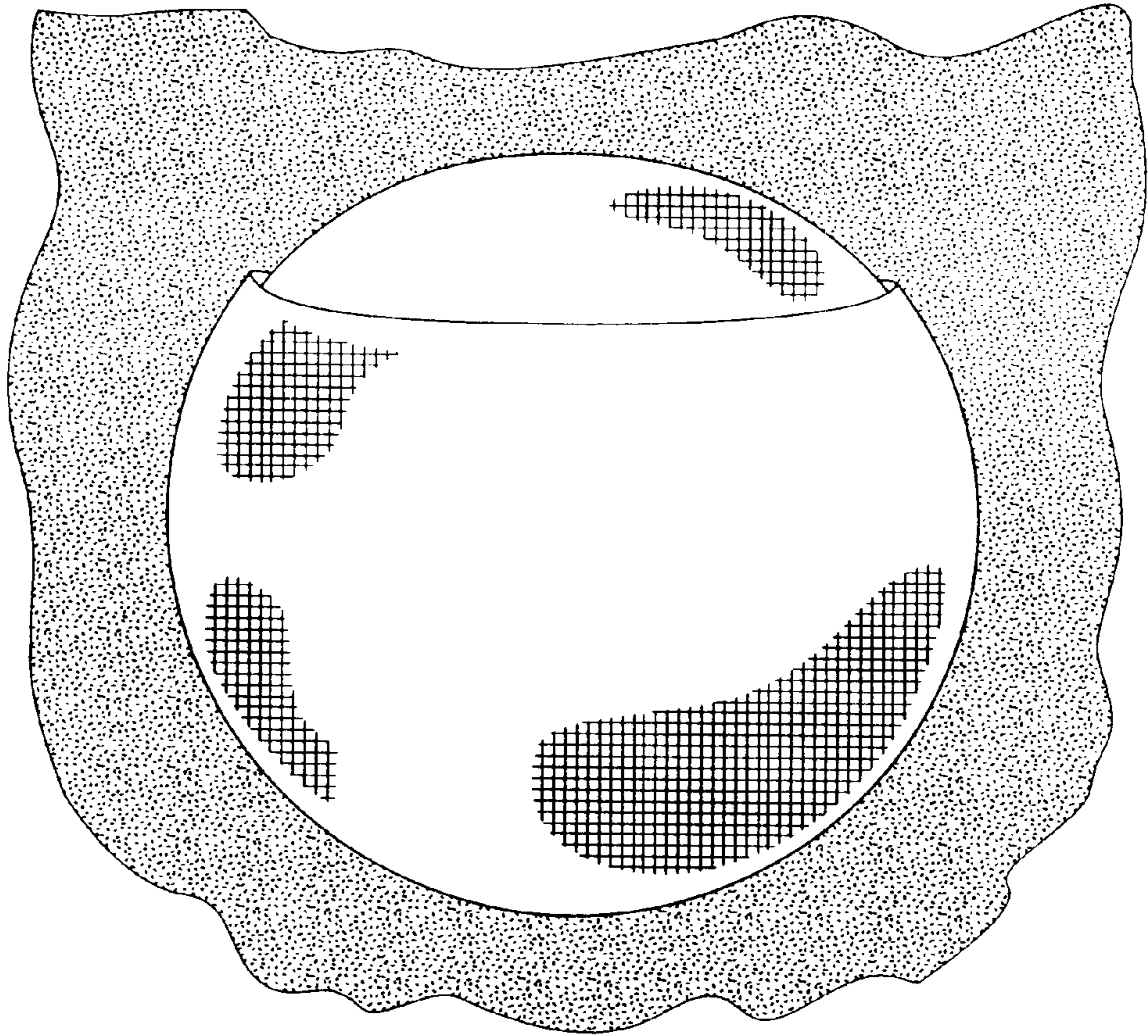

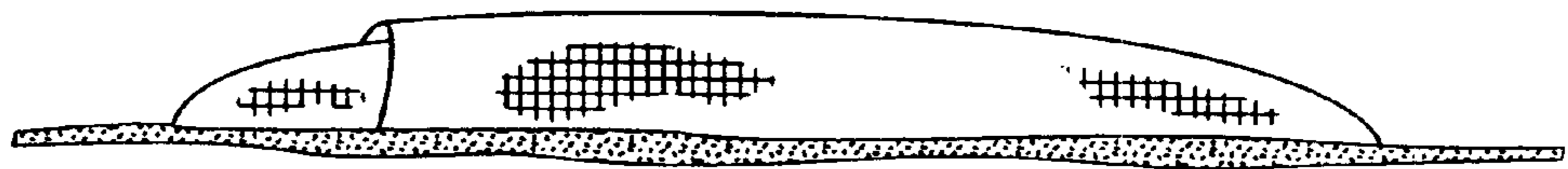

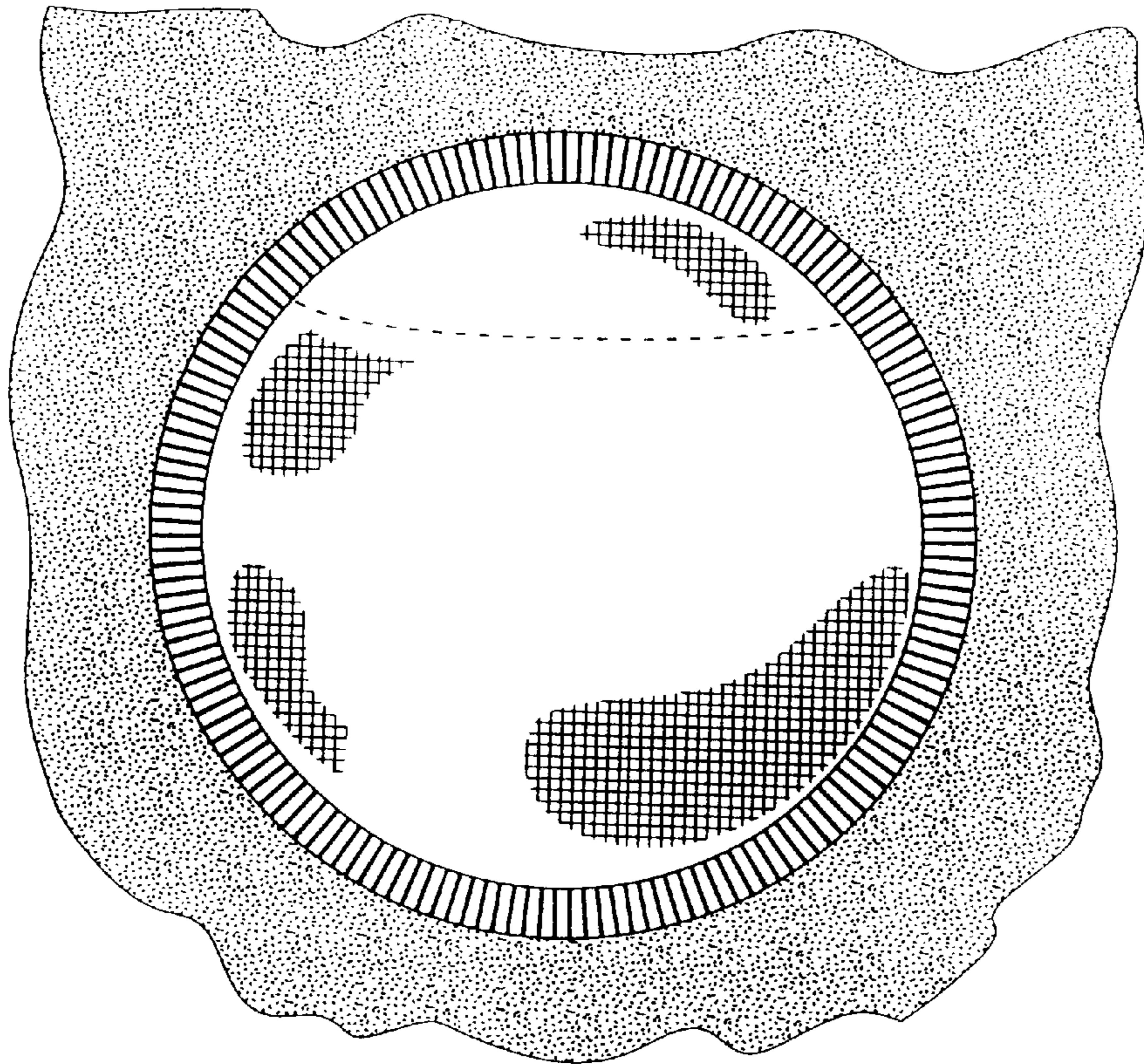

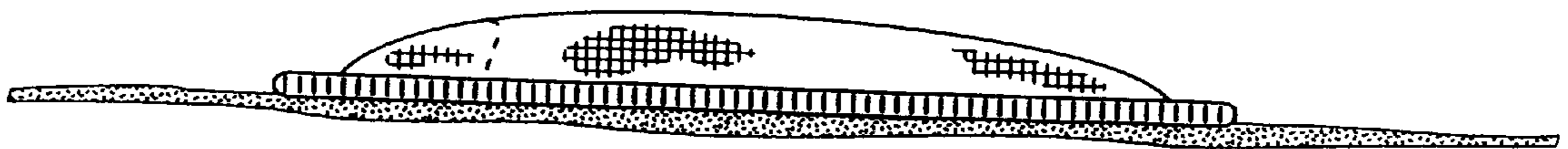

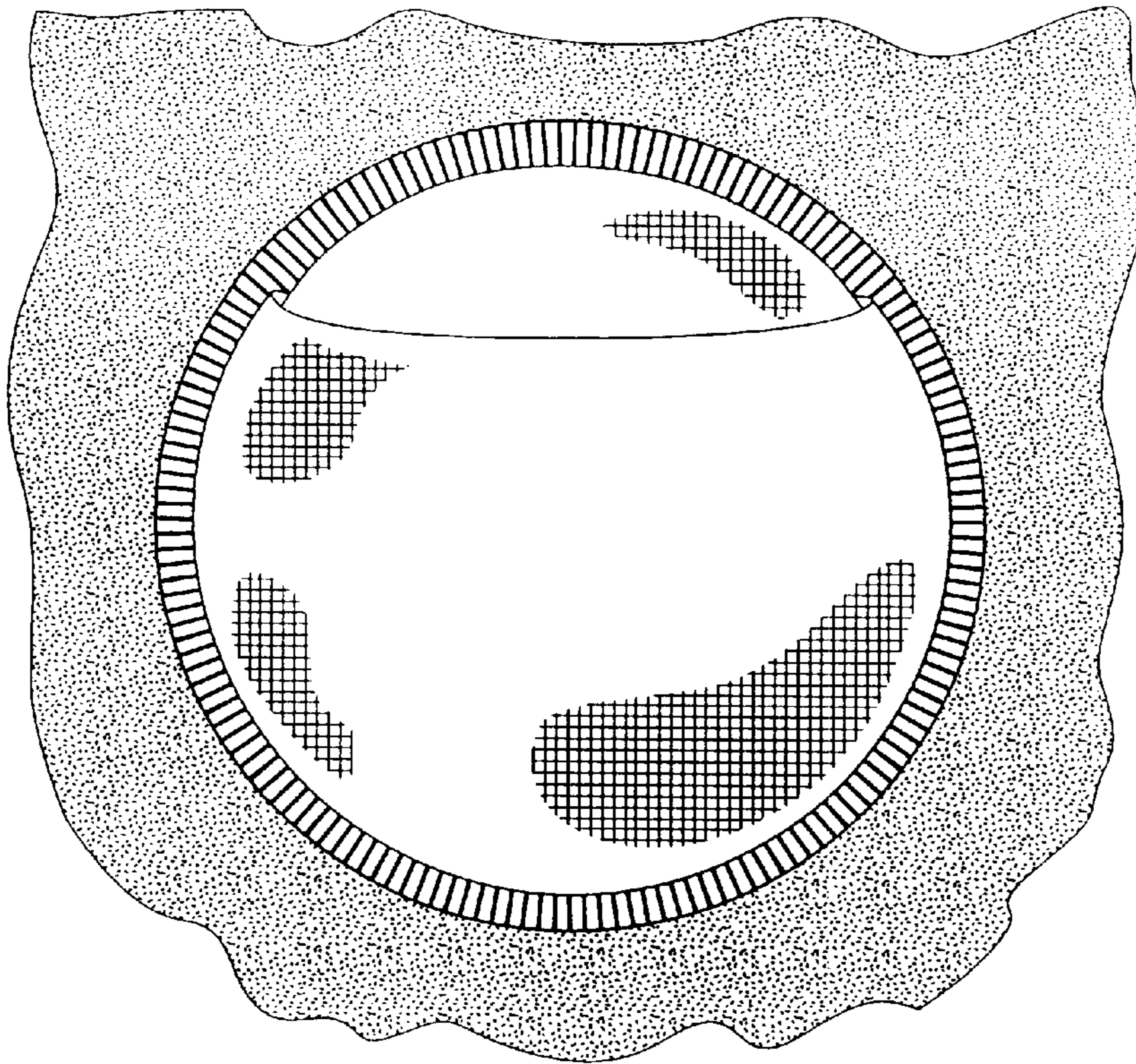

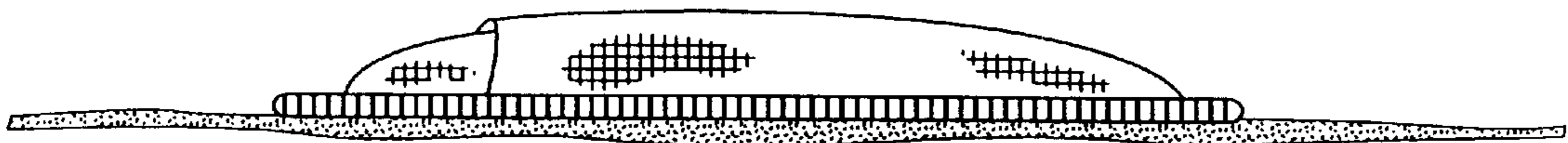
