(57) **CLAIM**

The ornamental design for the bench arms, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of bench arms comprising the new design;

FIG. 2 is a top view thereof;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a left side elevational view thereof, where the right side is a mirror image thereof;

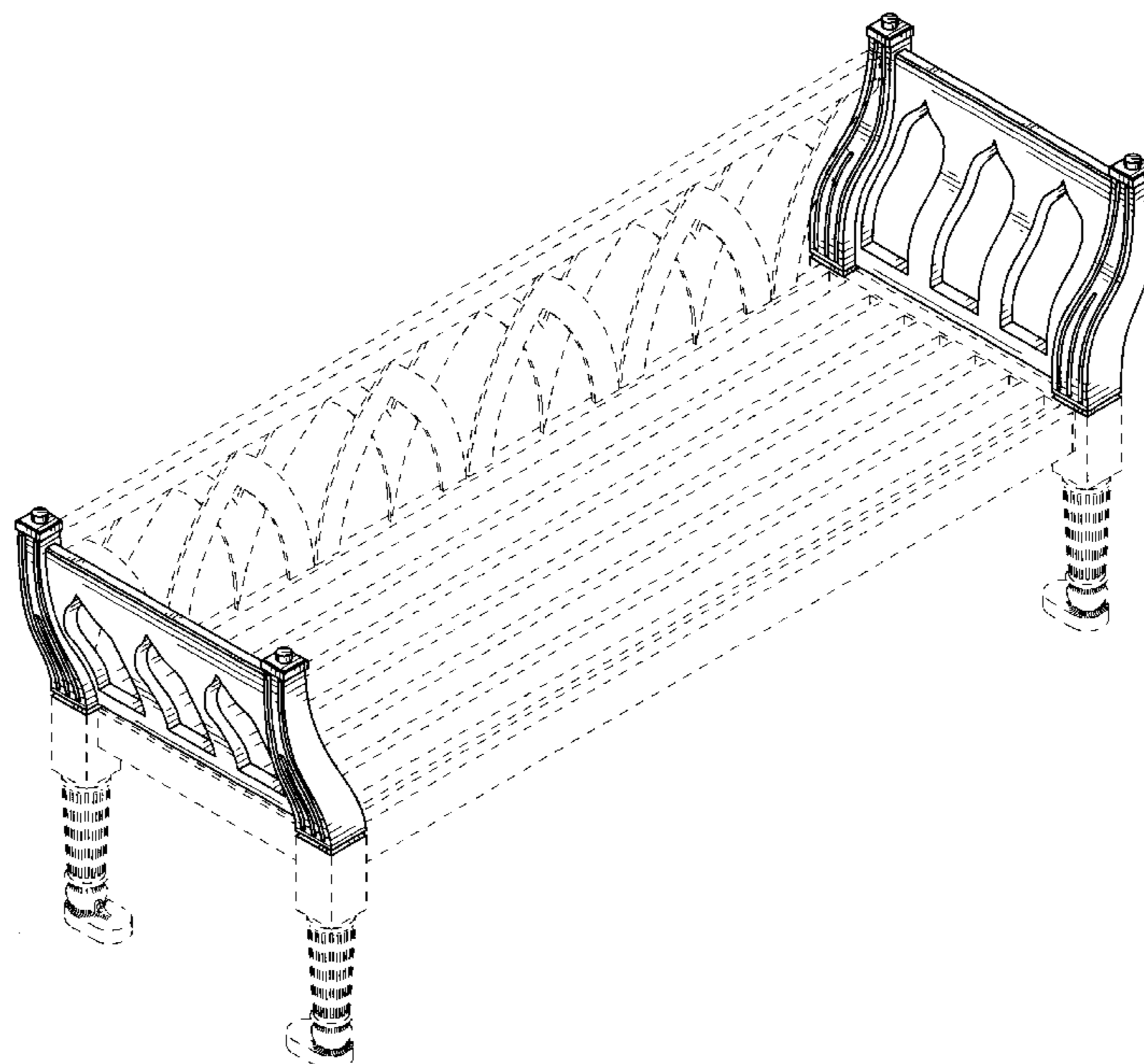
FIG. 5 is a rear elevational view thereof;

FIG. 6 is a bottom view thereof; and,

FIG. 7 is a perspective view of a second embodiment of bench arms, portions of which are cut away to illustrate indeterminate length which is the sole difference between it and FIGS. 1 through 6.

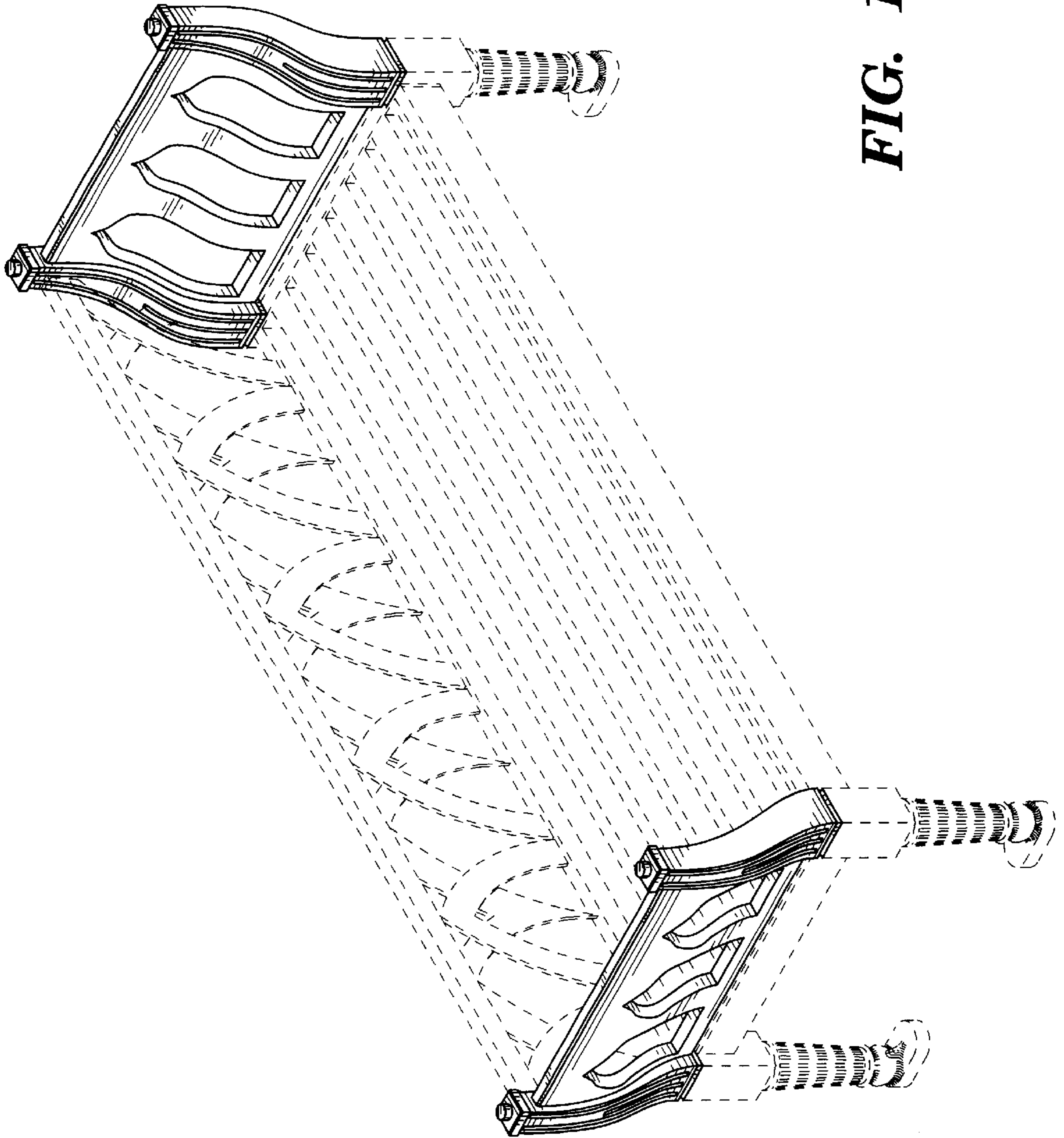

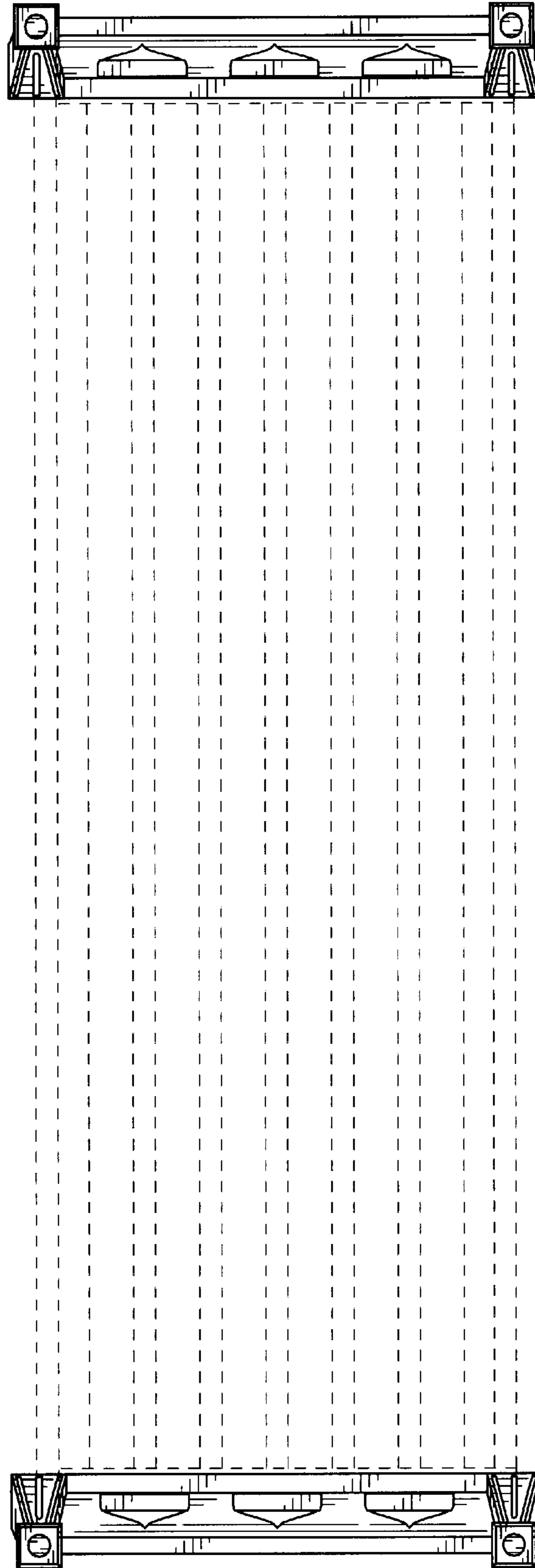

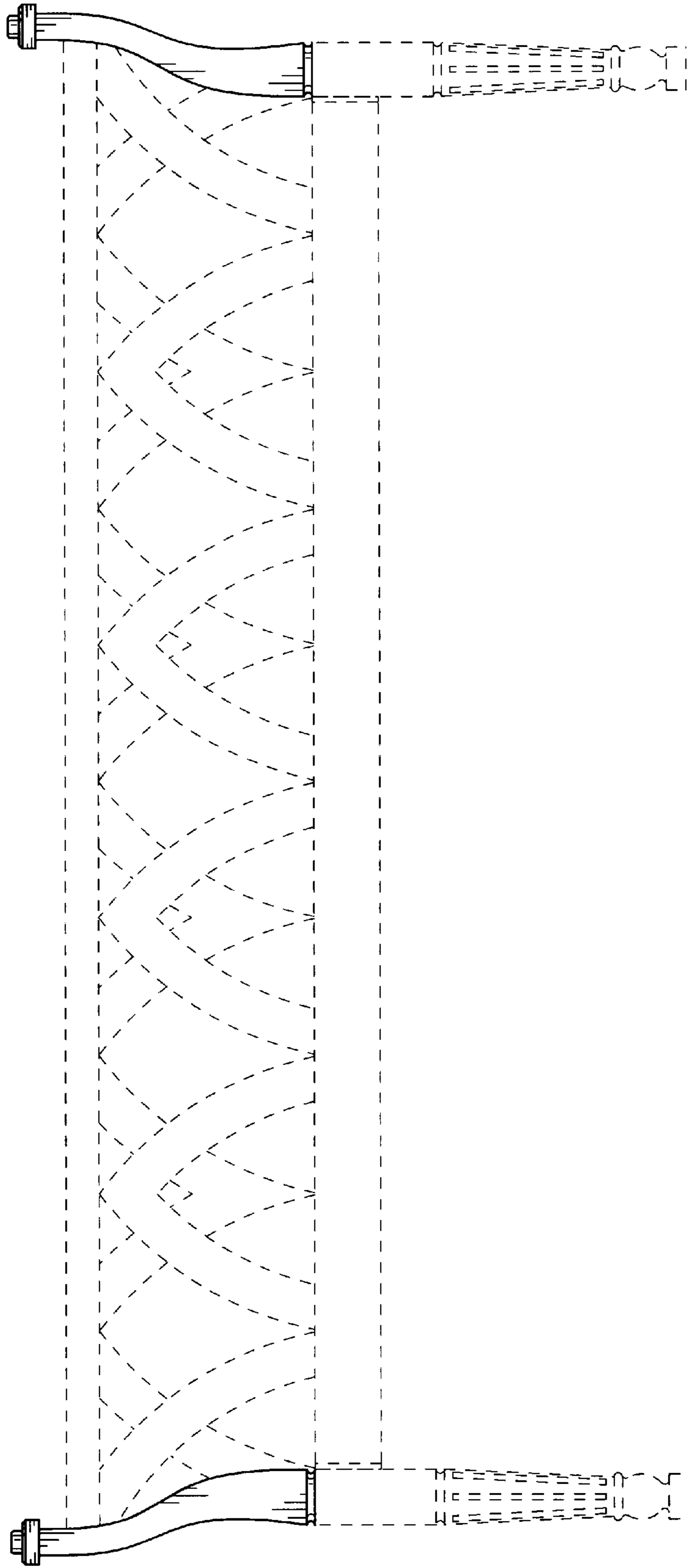

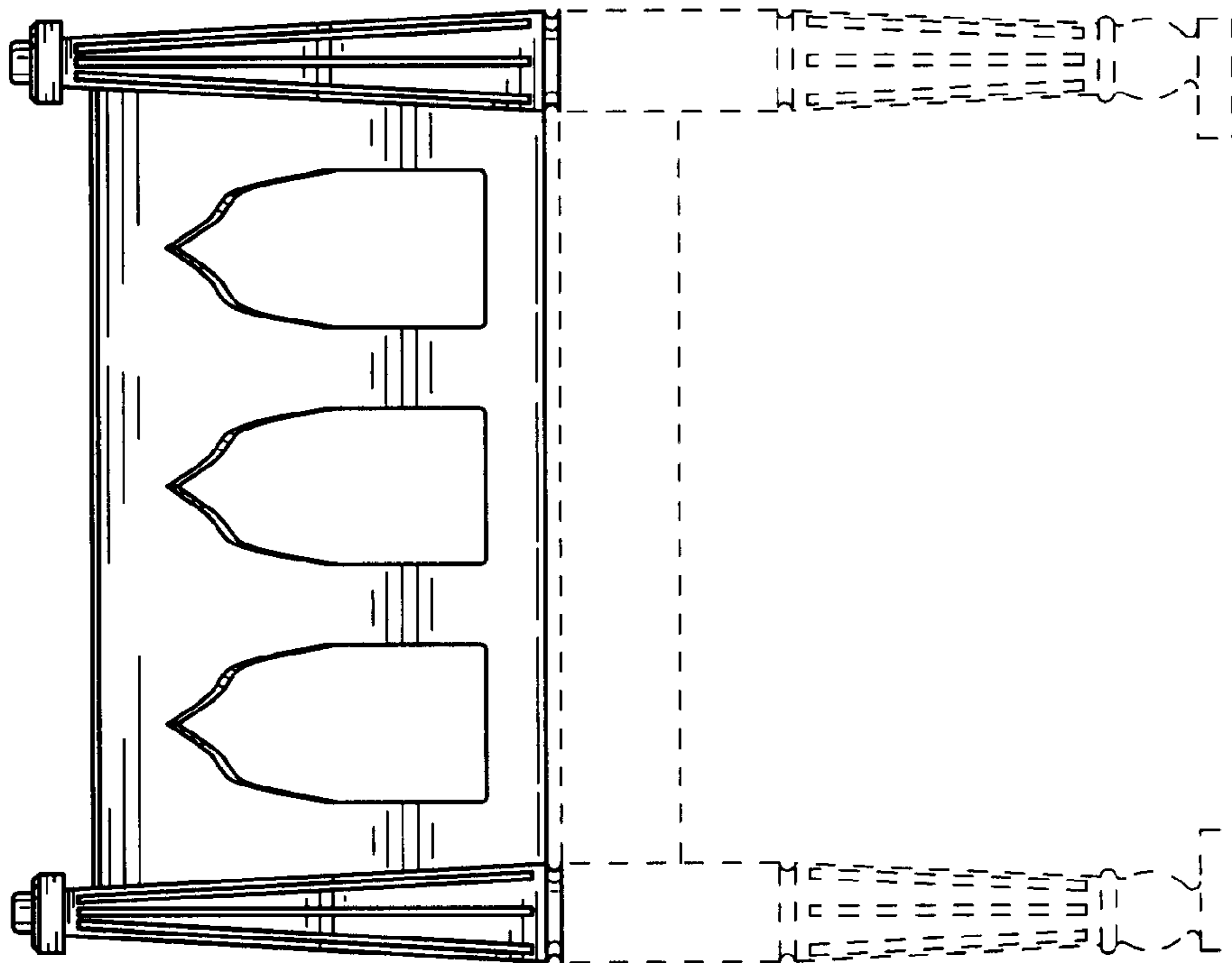

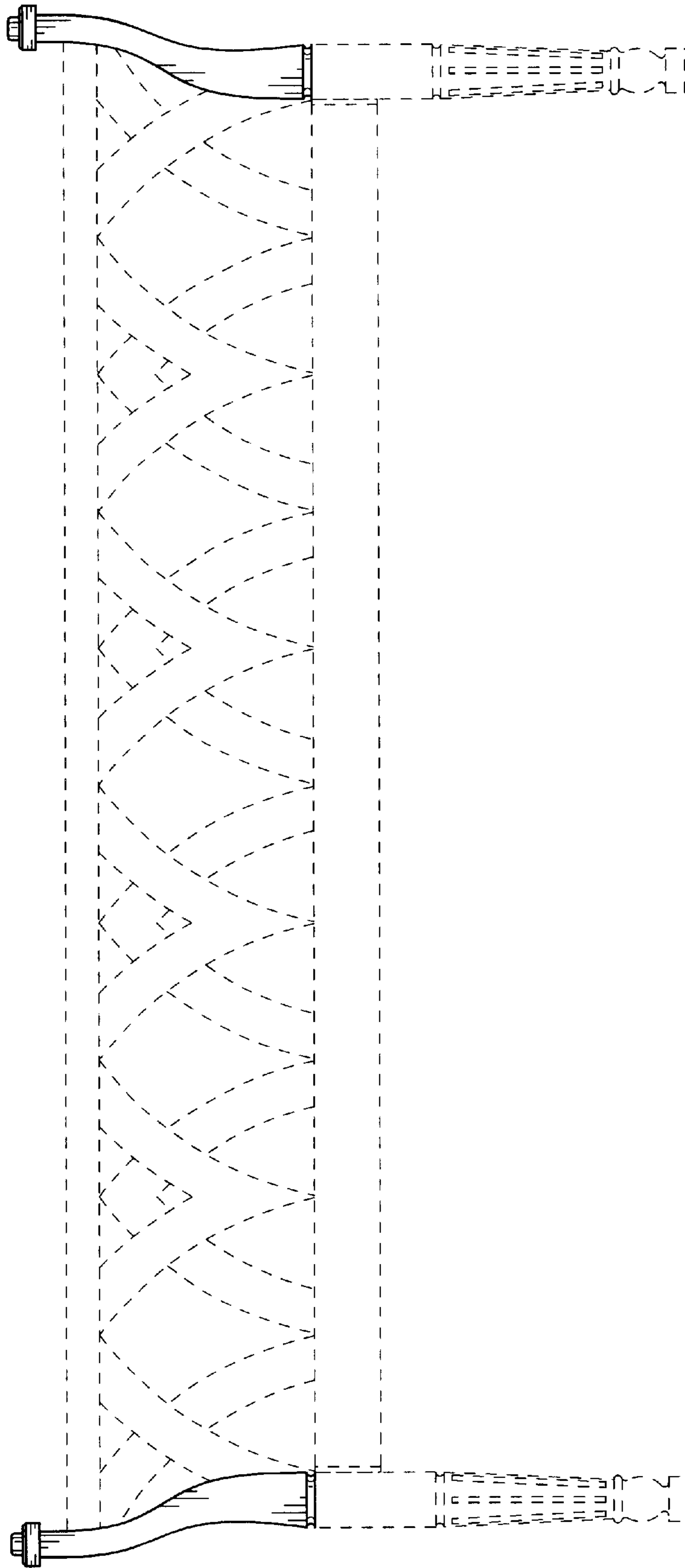

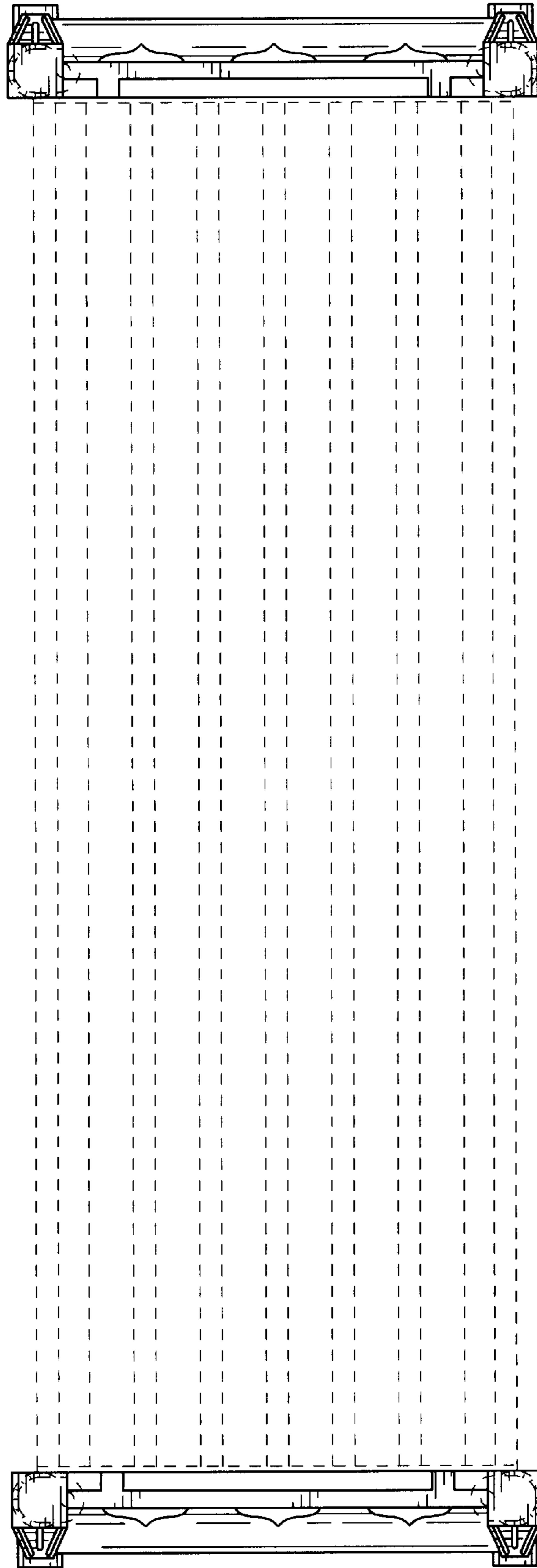

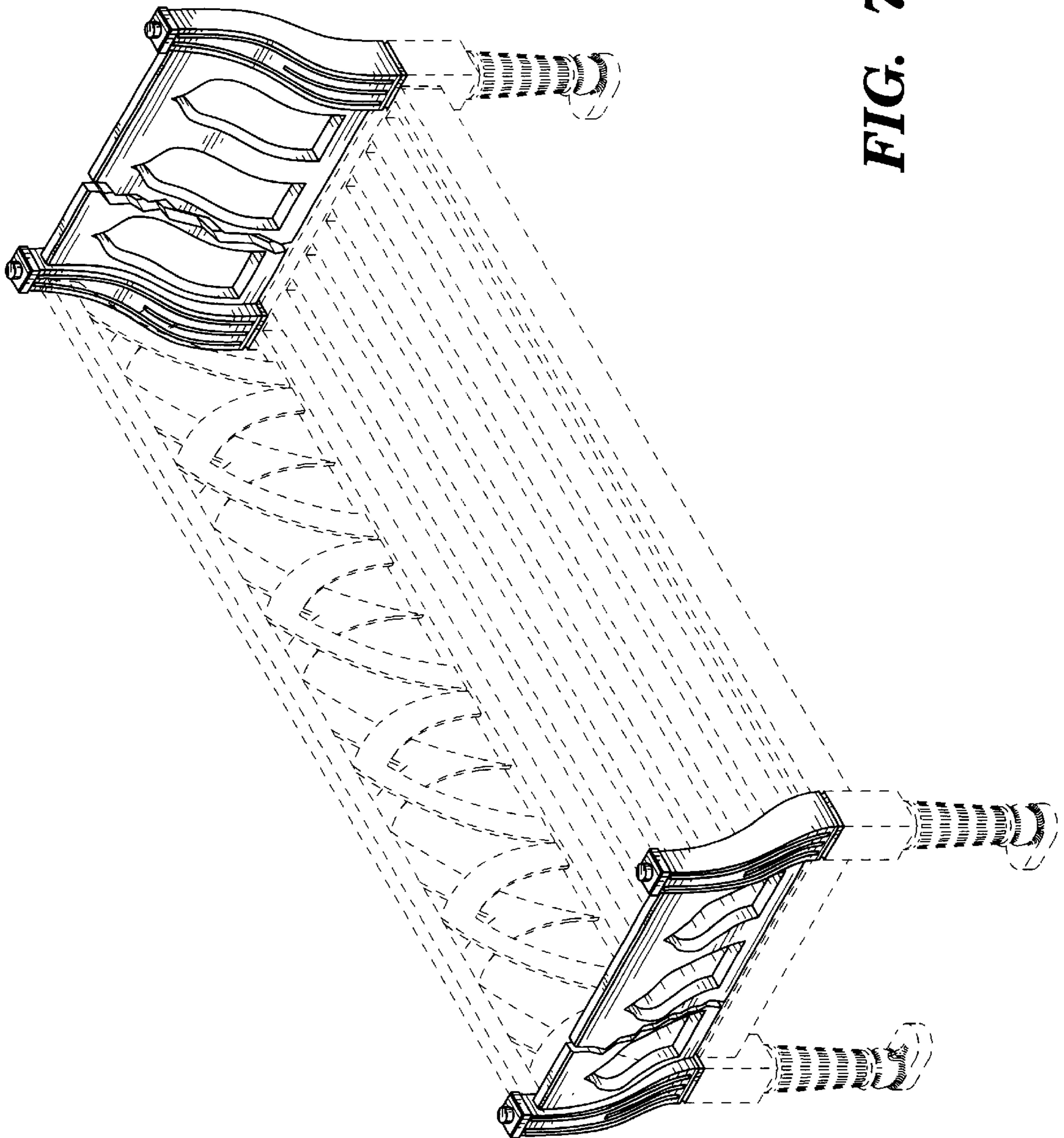
