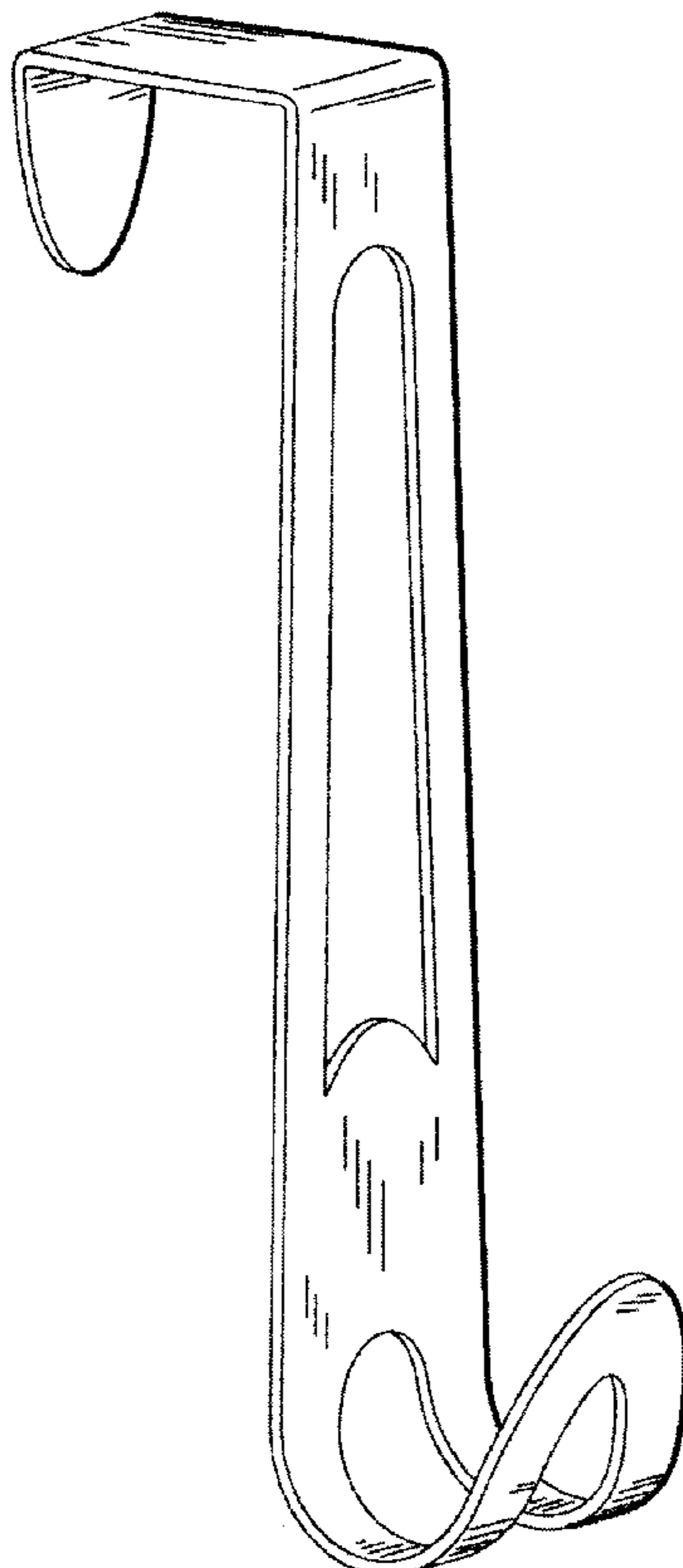
(57) **CLAIM**

The ornamental design for an over-the-door hook, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, side and top perspective view of an over-the-door hook showing our new design; FIG. 2 is a top plan view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a side elevational view thereof; and, FIG. 6 is a bottom plan view thereof.

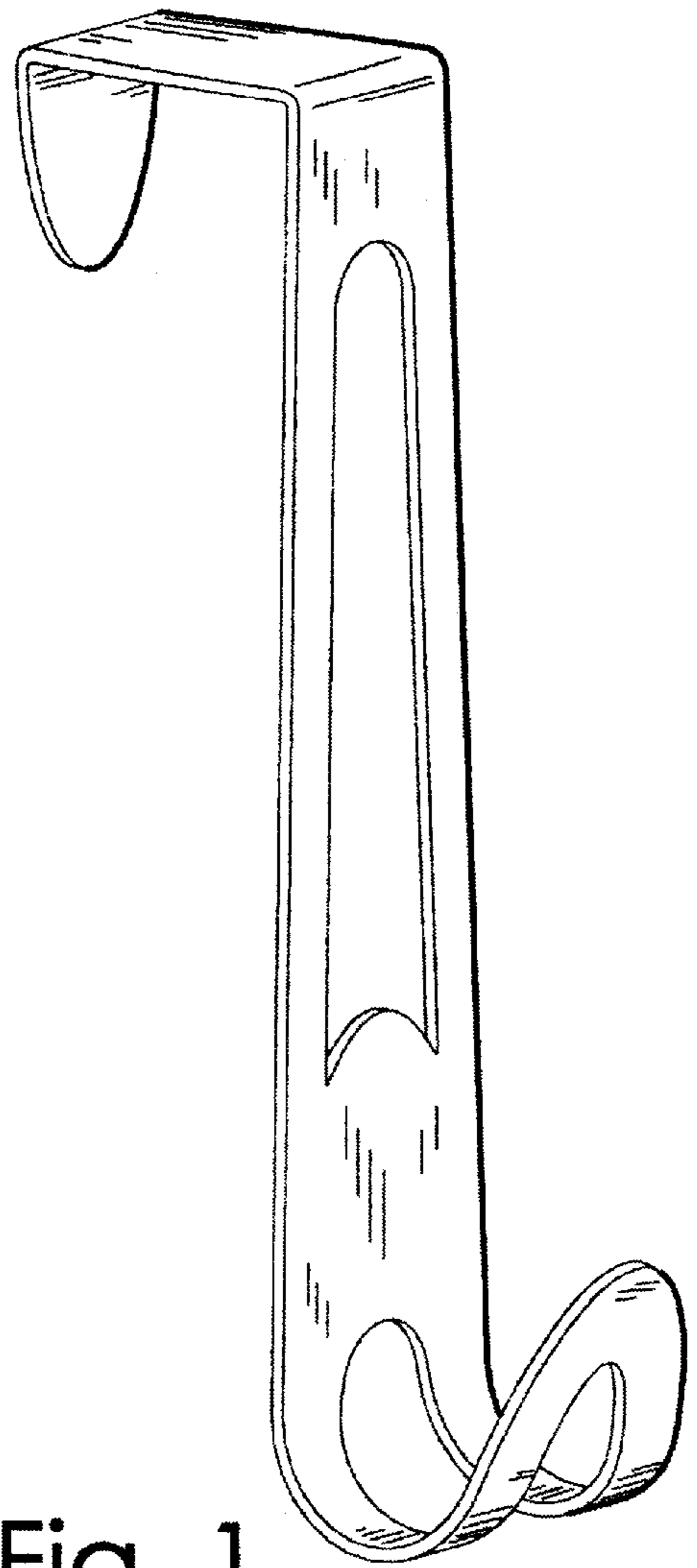

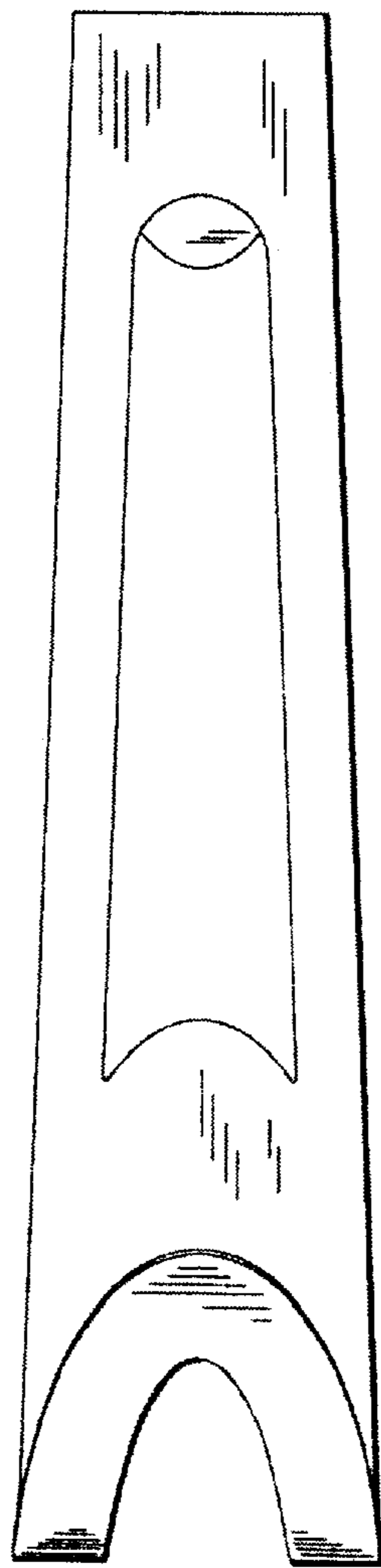

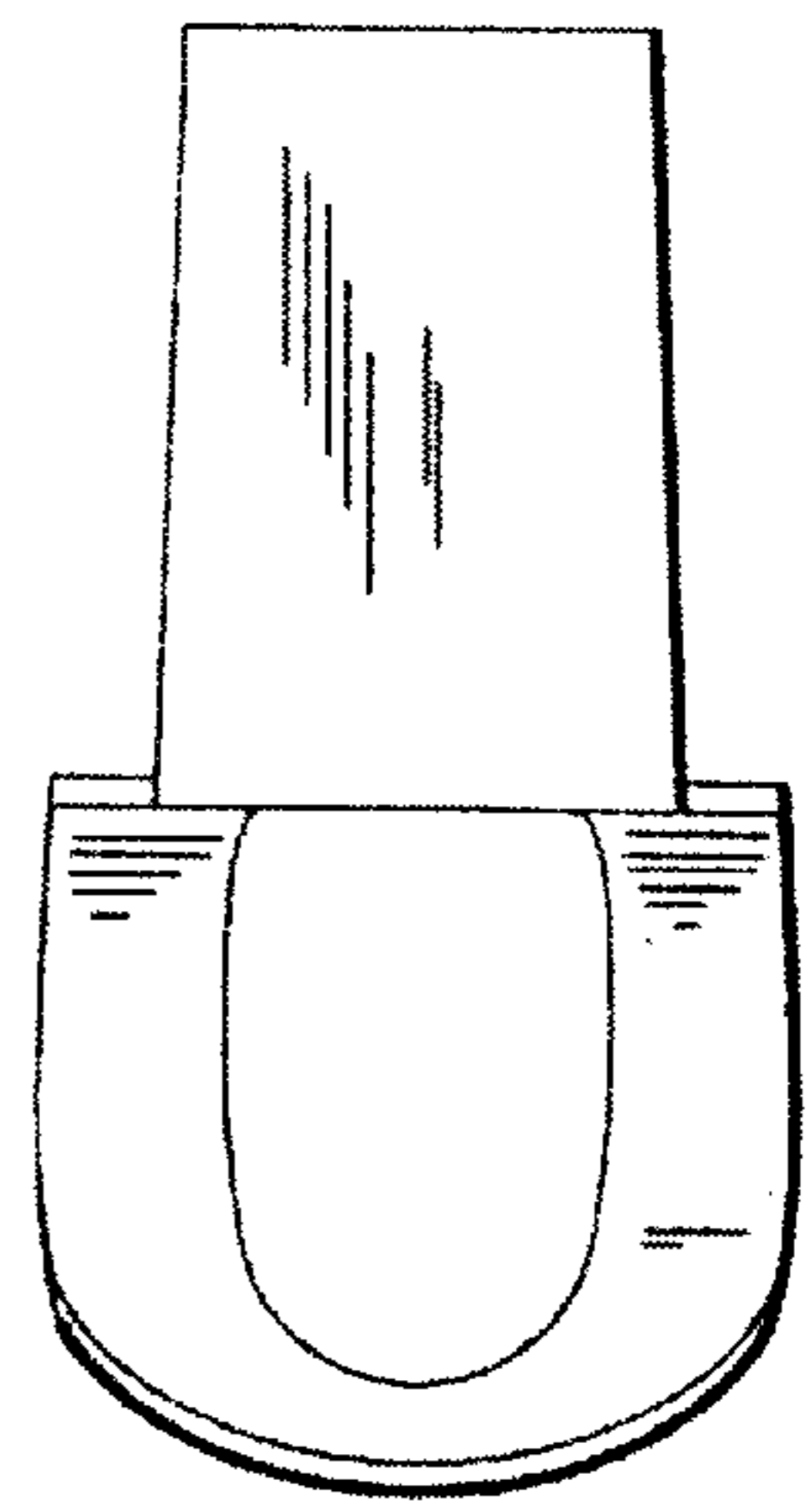

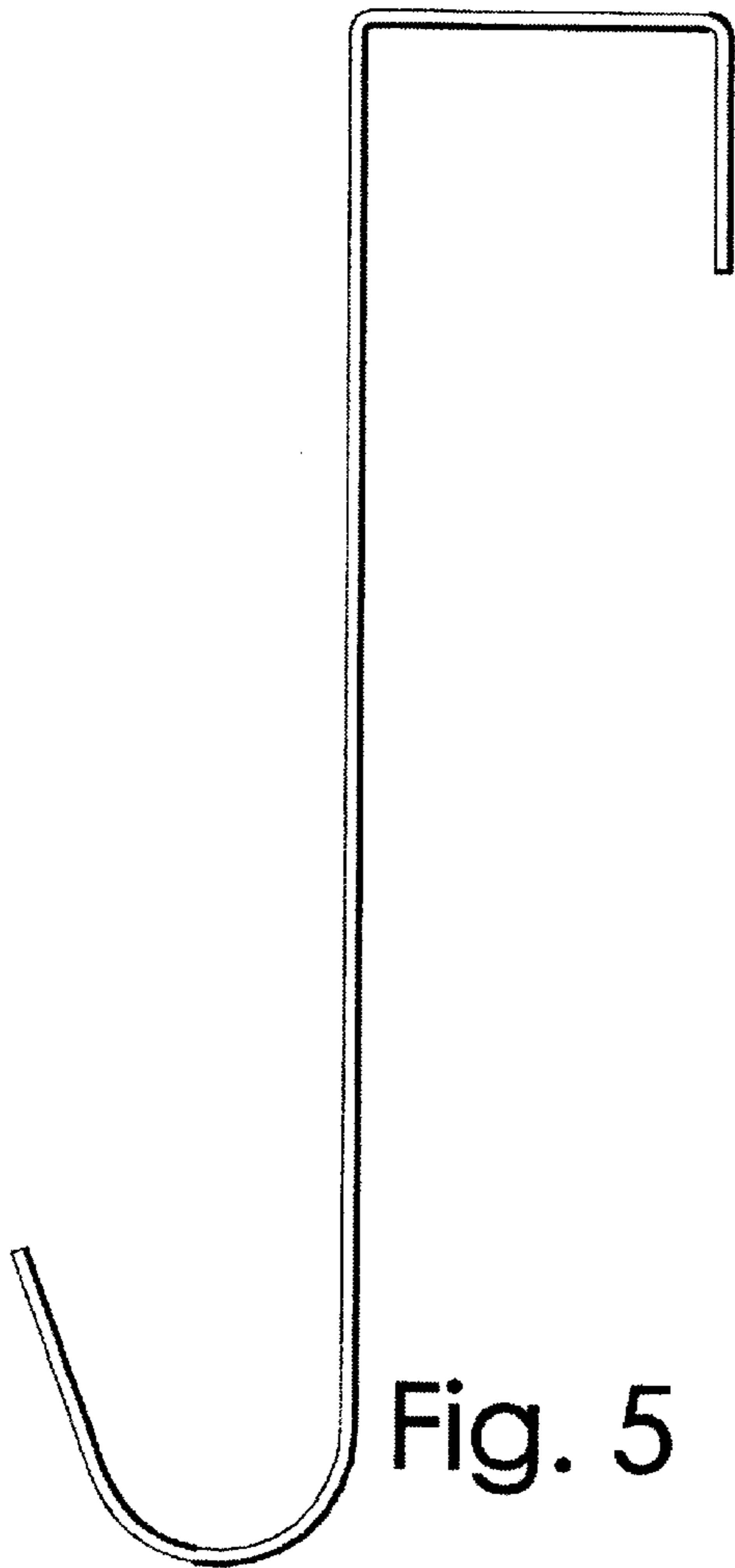

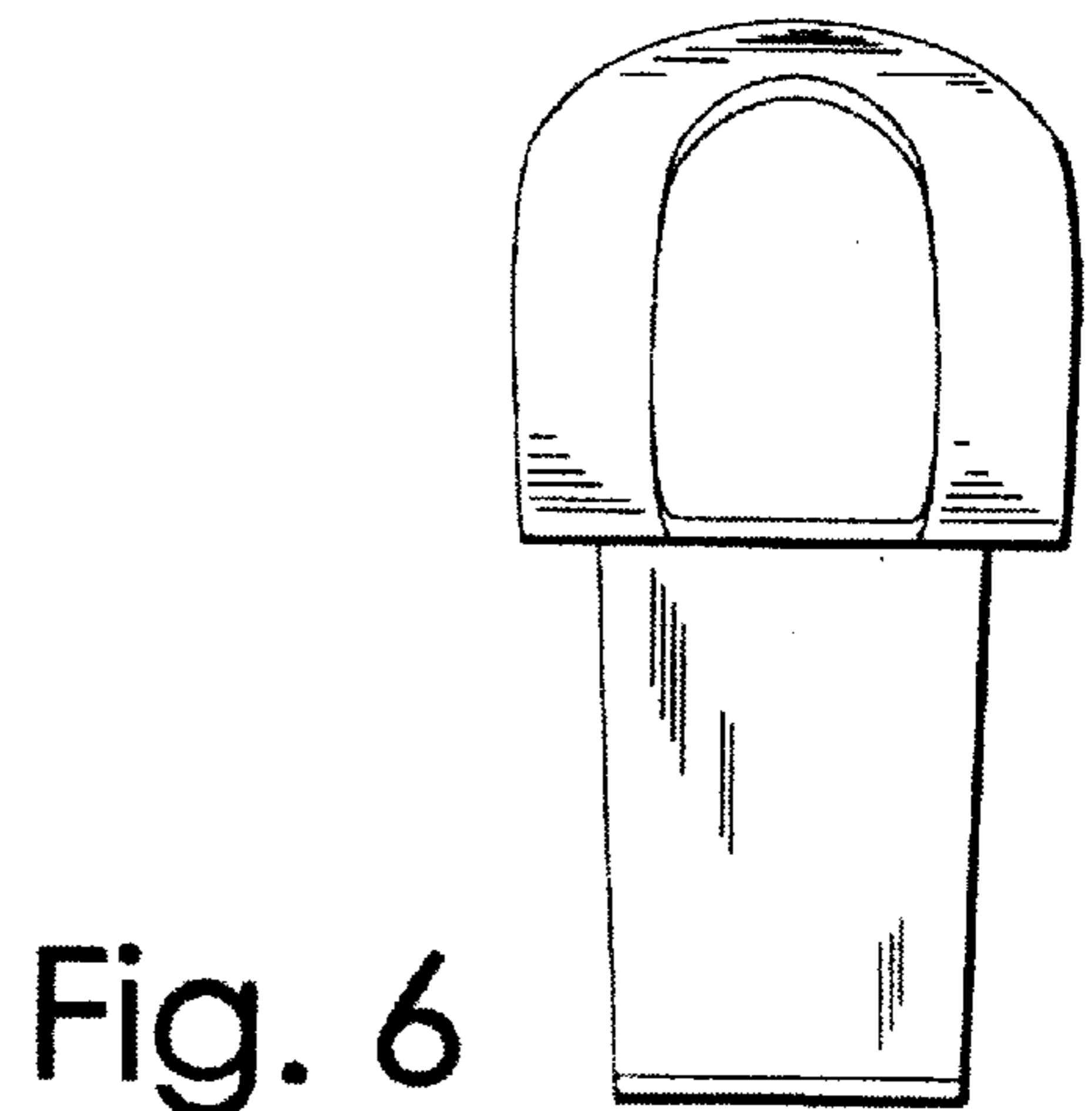
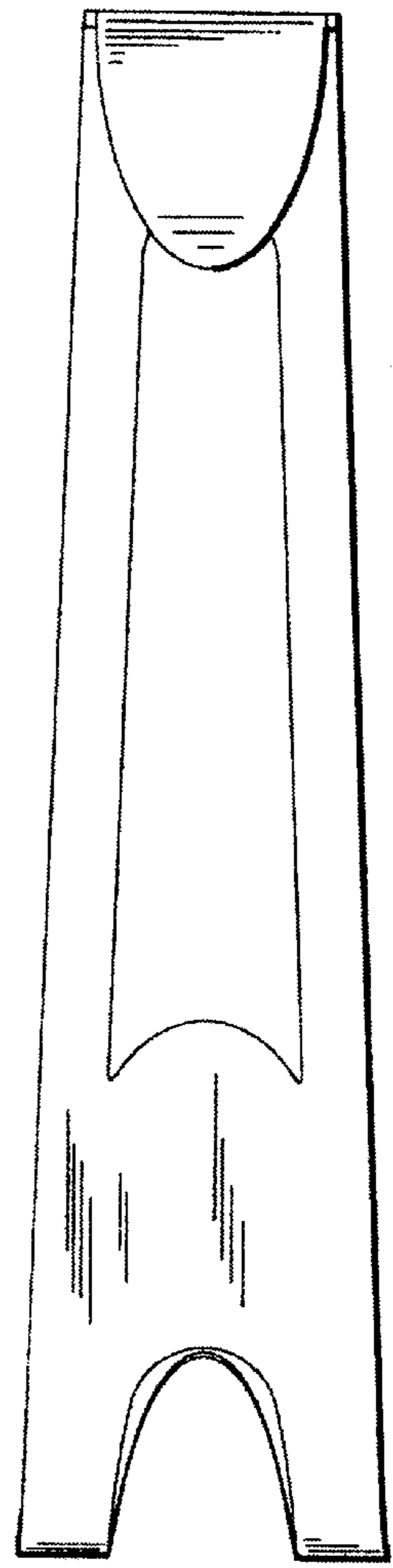
