FIG. 2 is a front elevation view of the present invention;

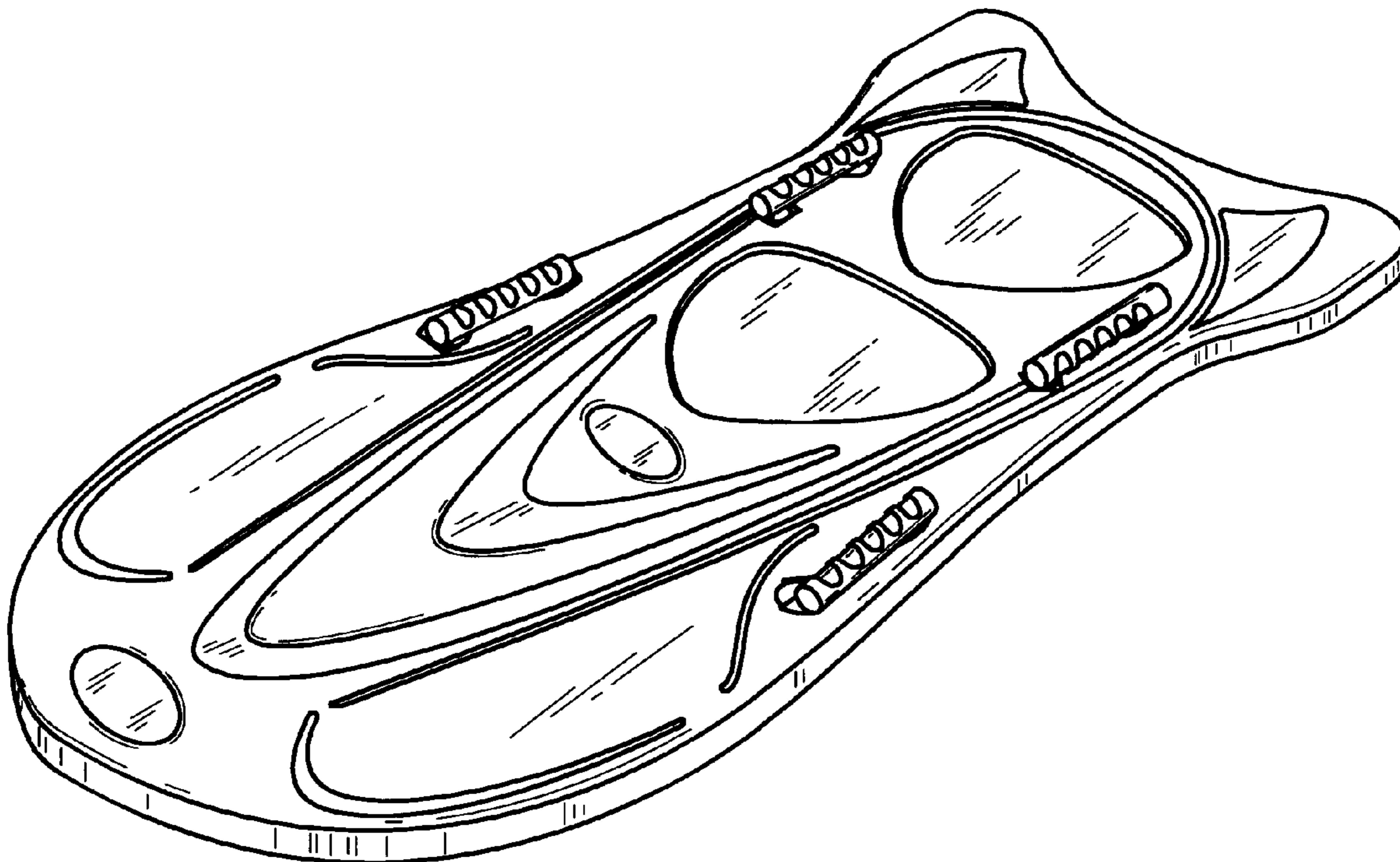
FIG. 3 is a rear elevation view of the present invention;

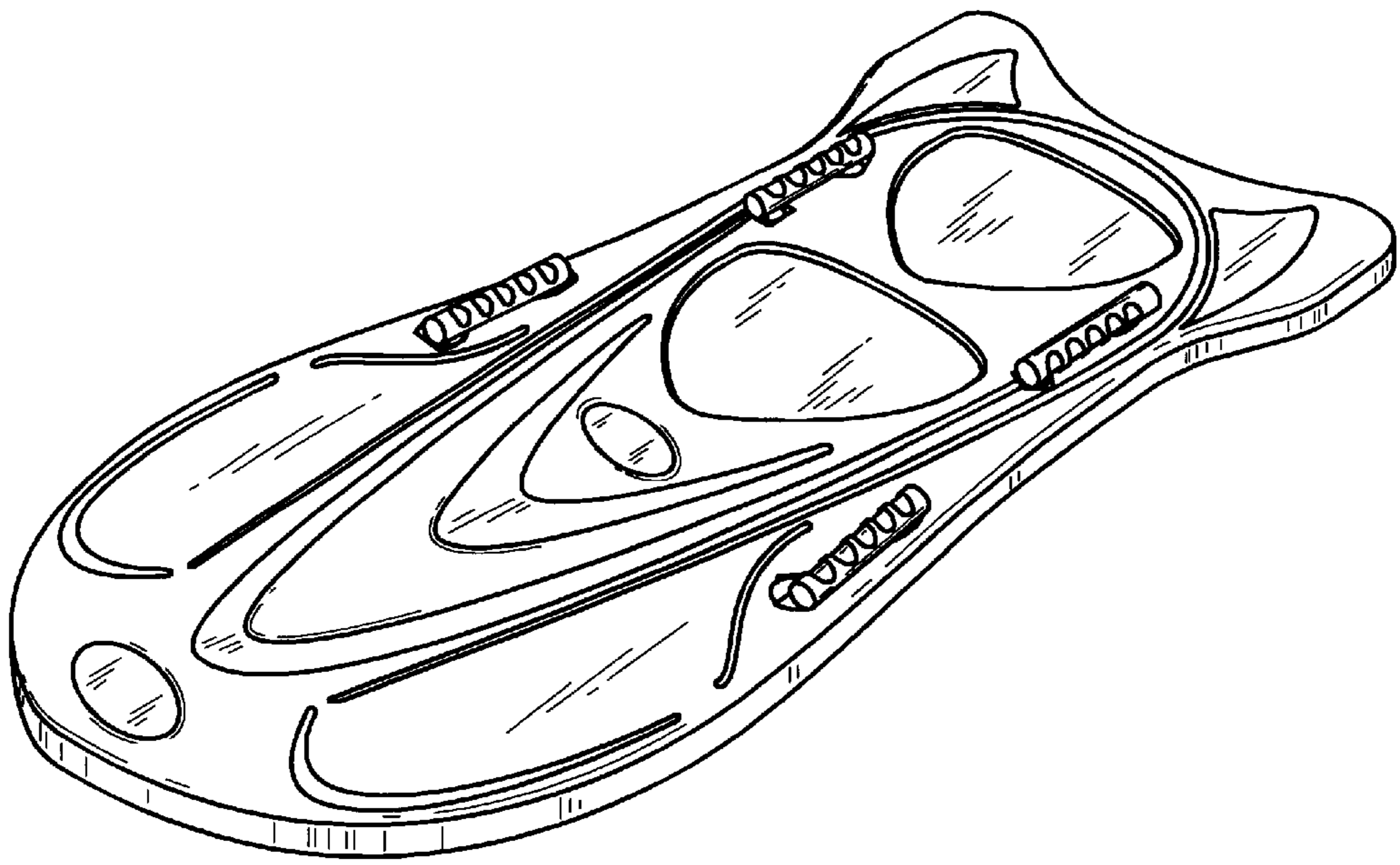

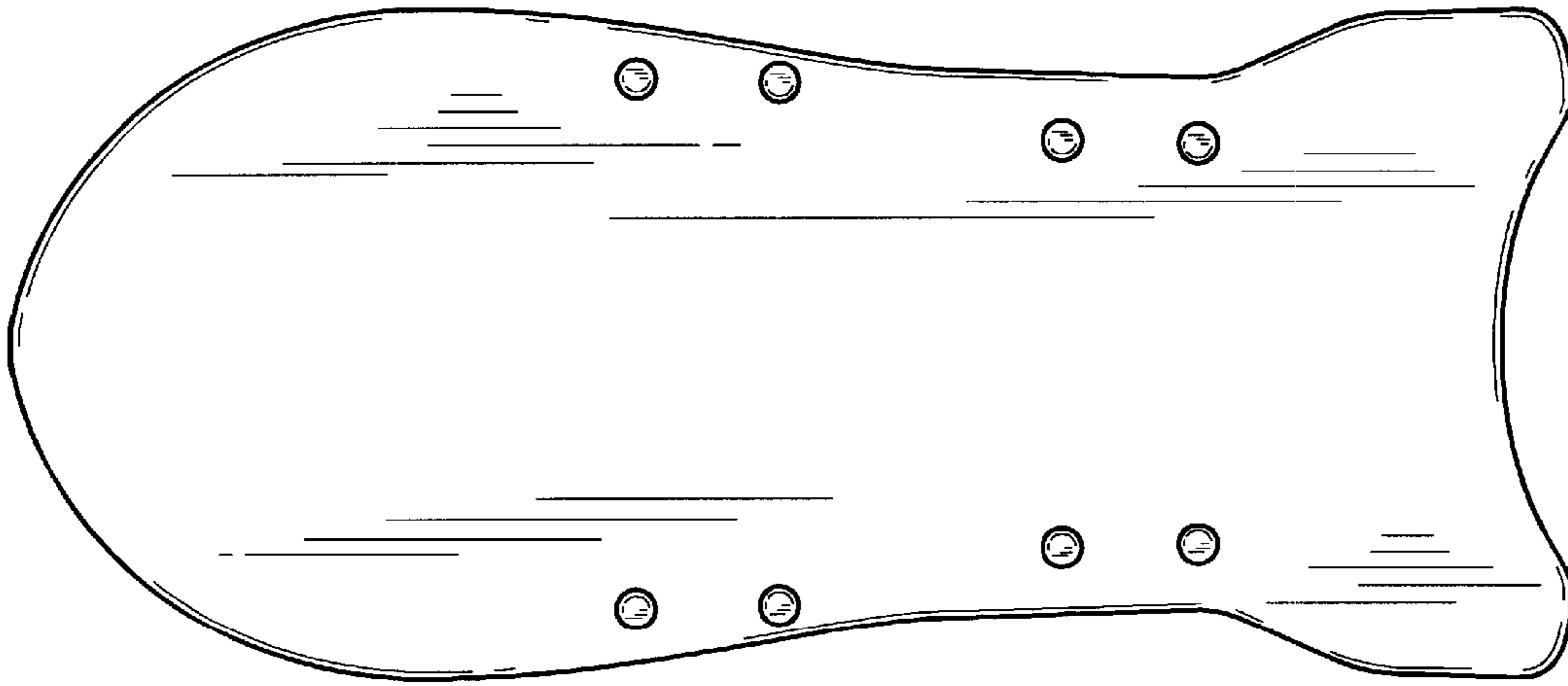

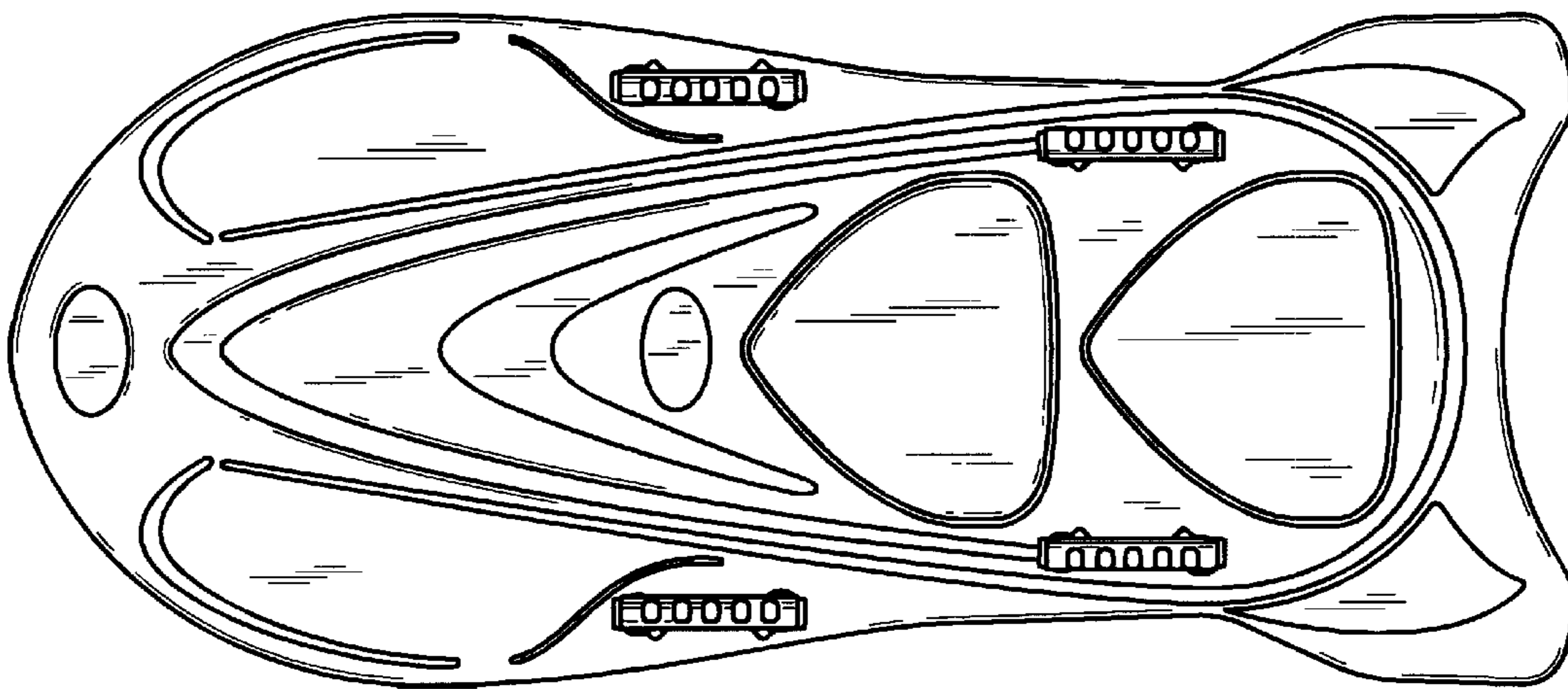
