FIG. 1 is a top view of the vehicle ornament of the present invention;

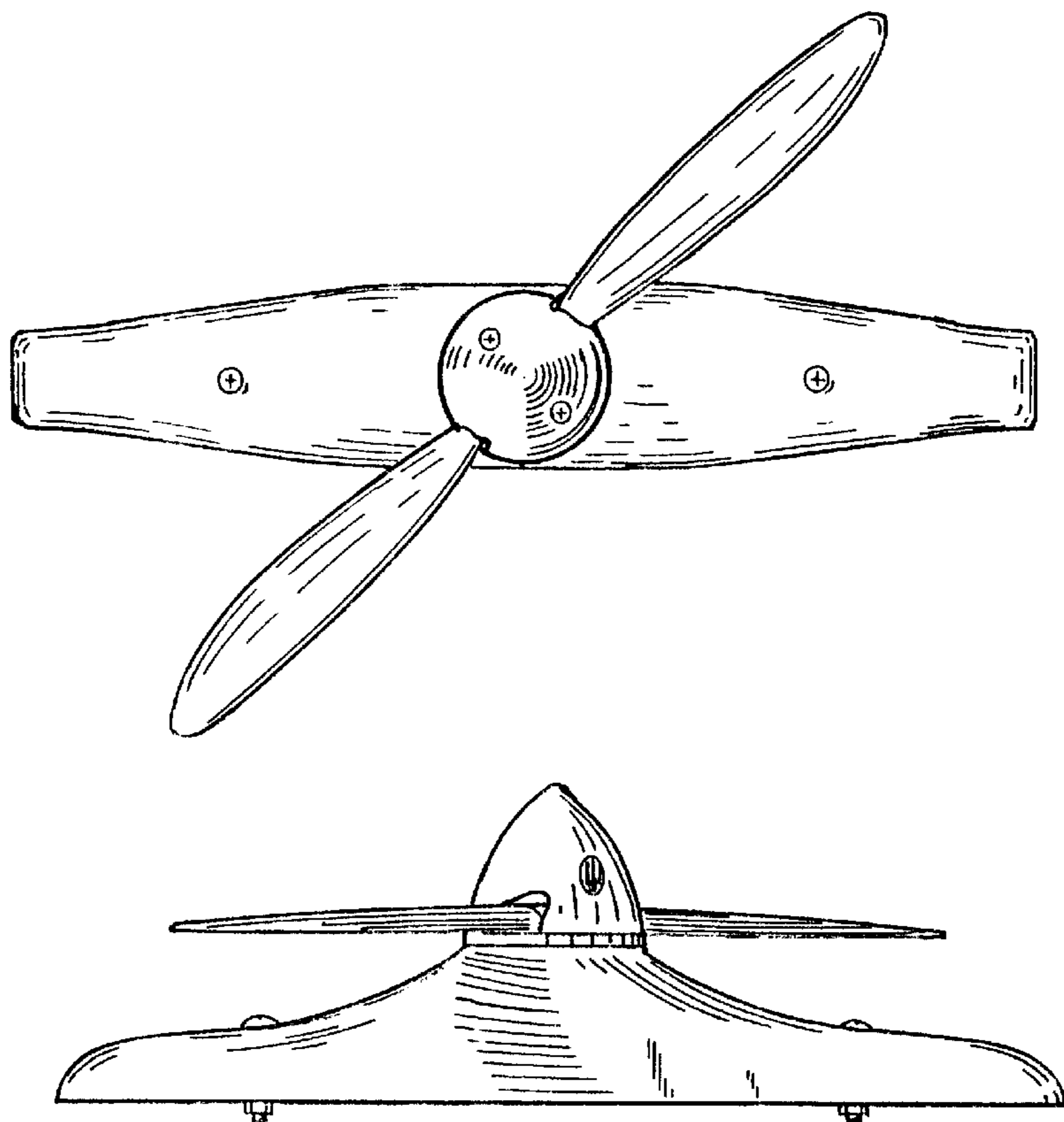

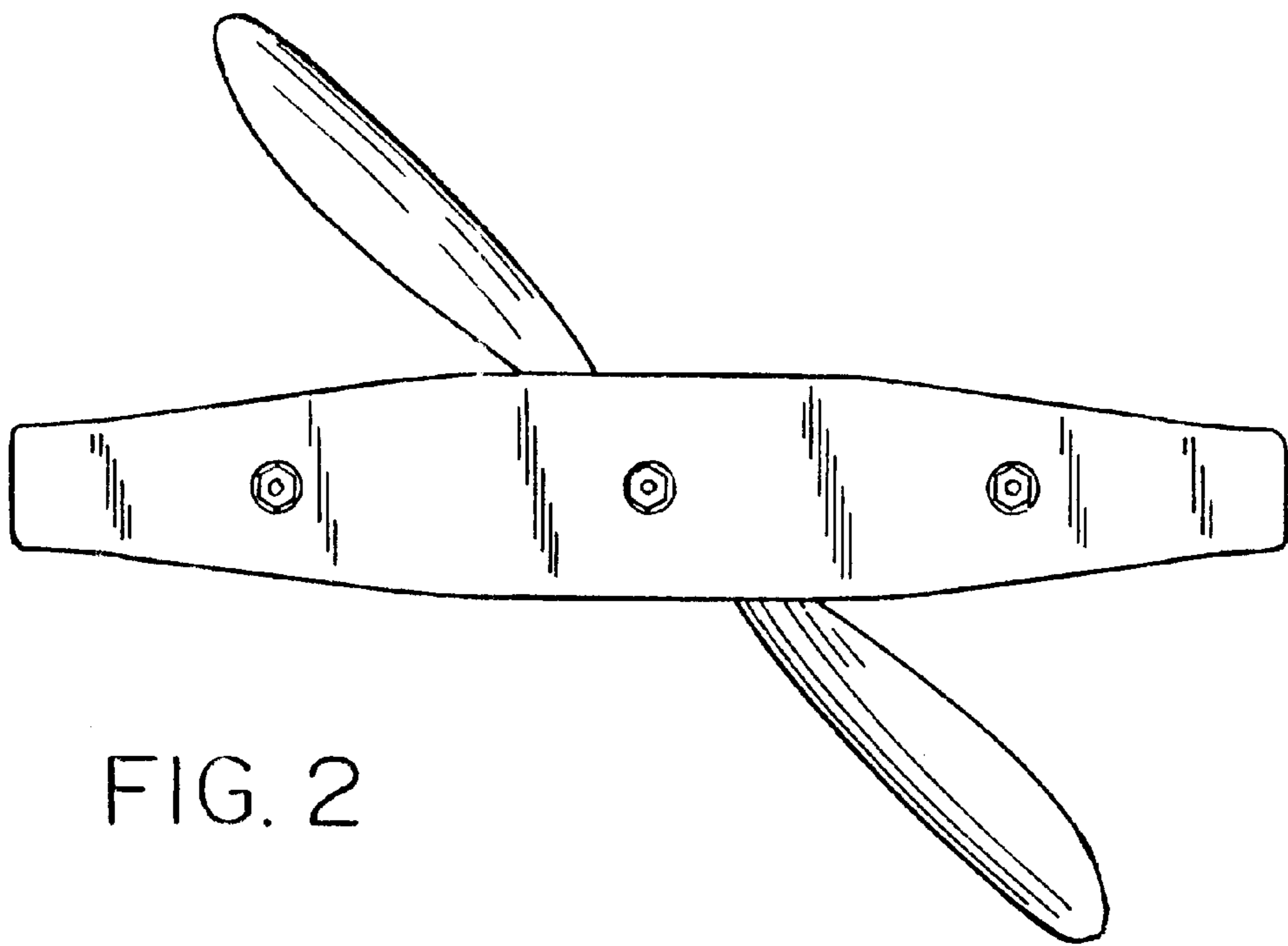
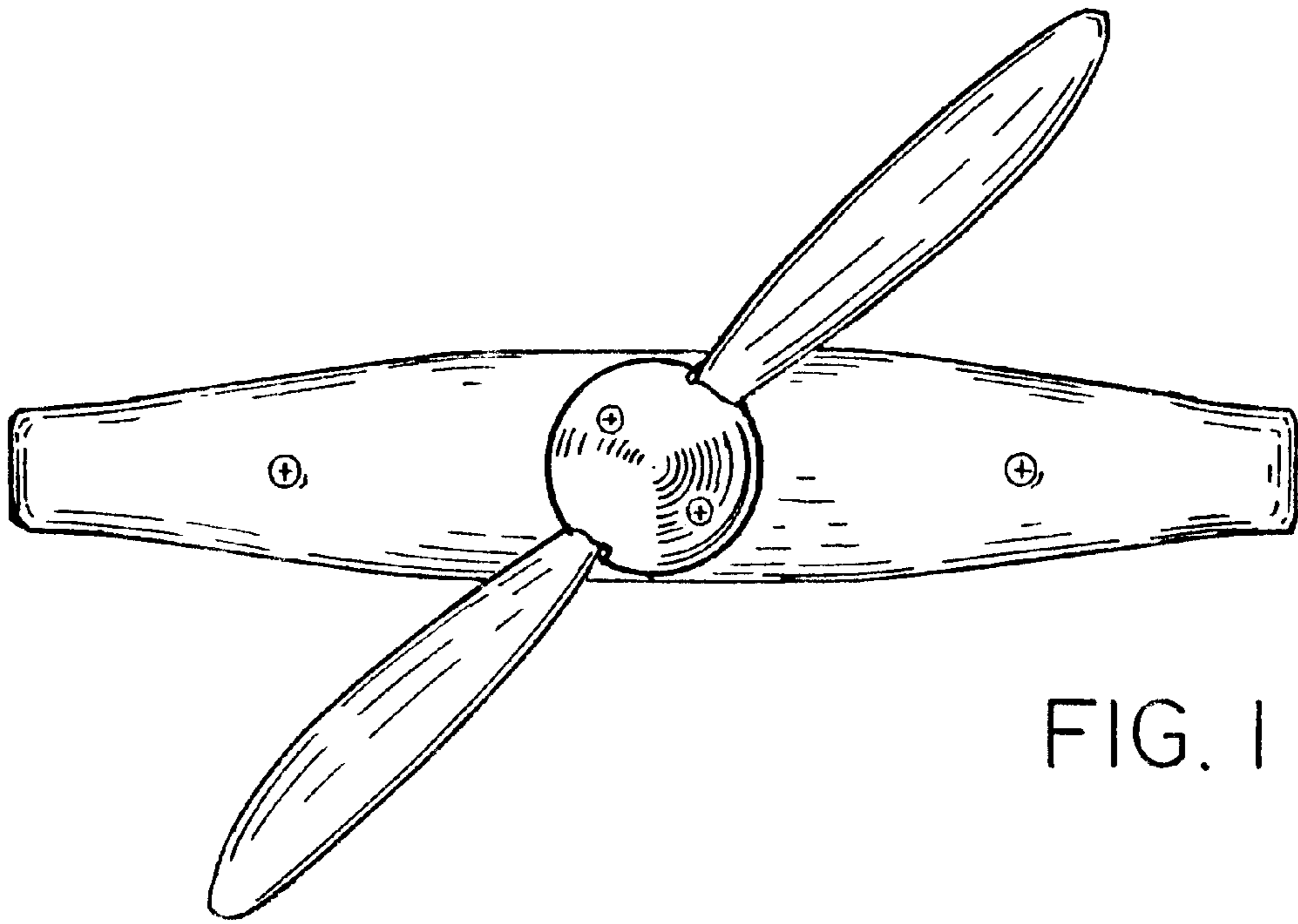
FIG. 4 is a side view of the vehicle ornament of the present invention from the side opposite FIG. 3.

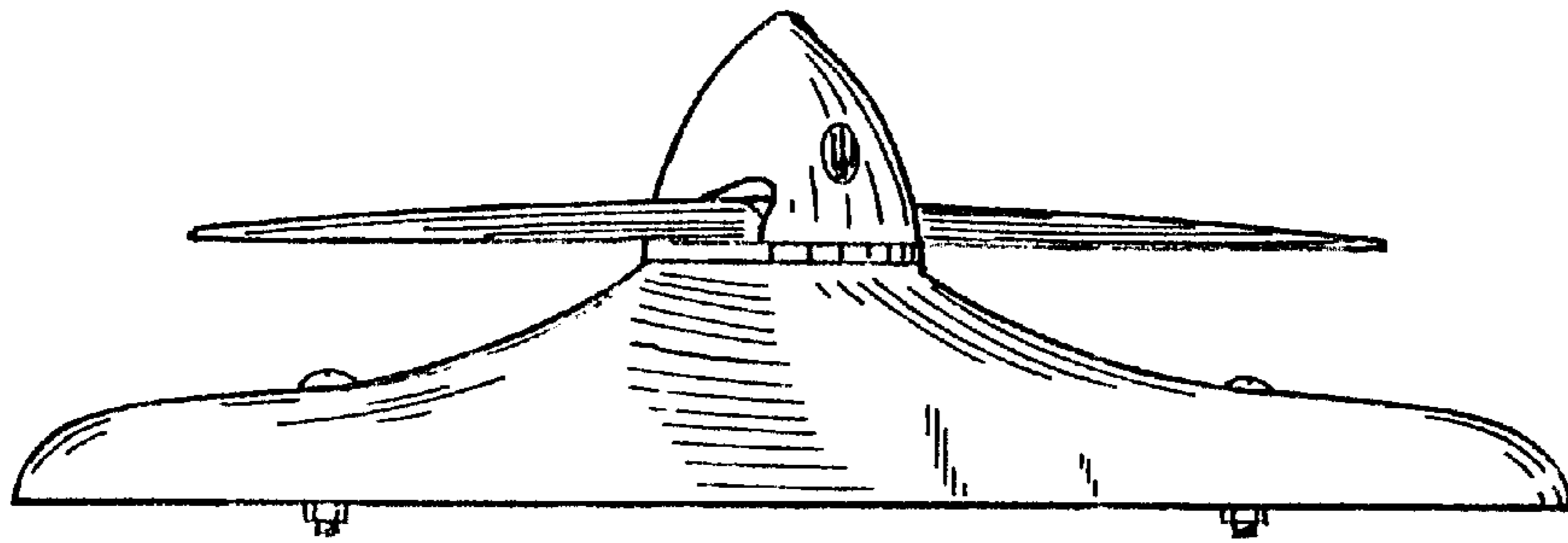

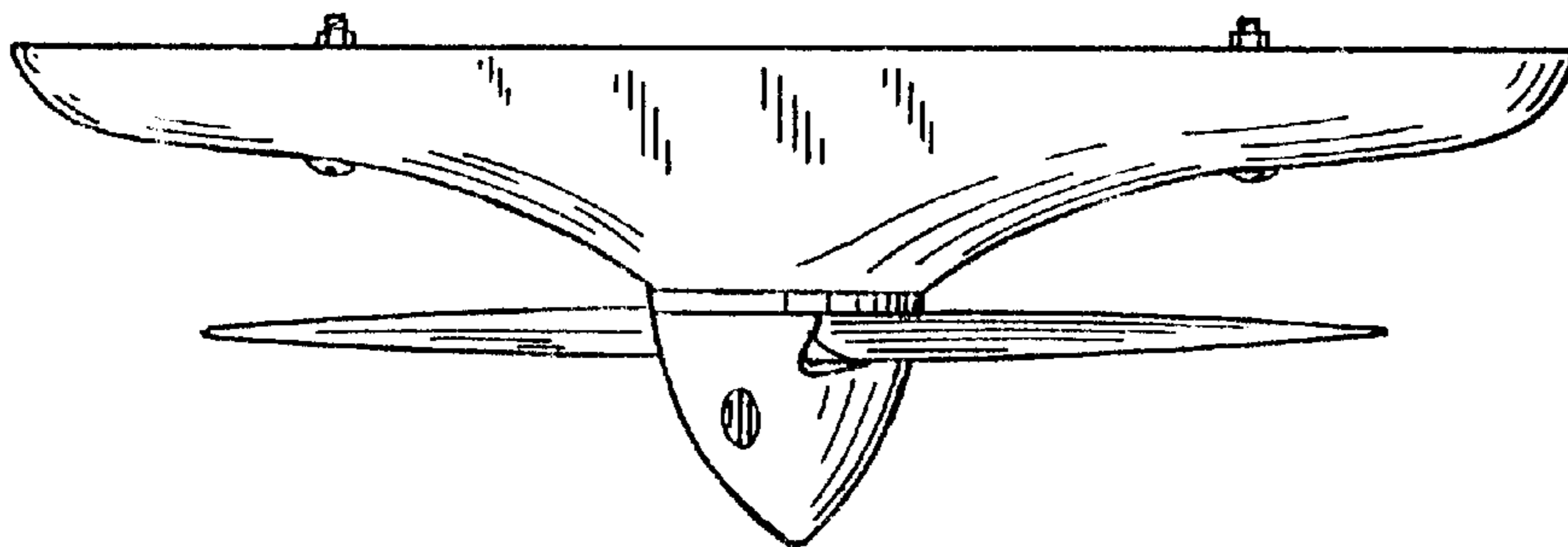

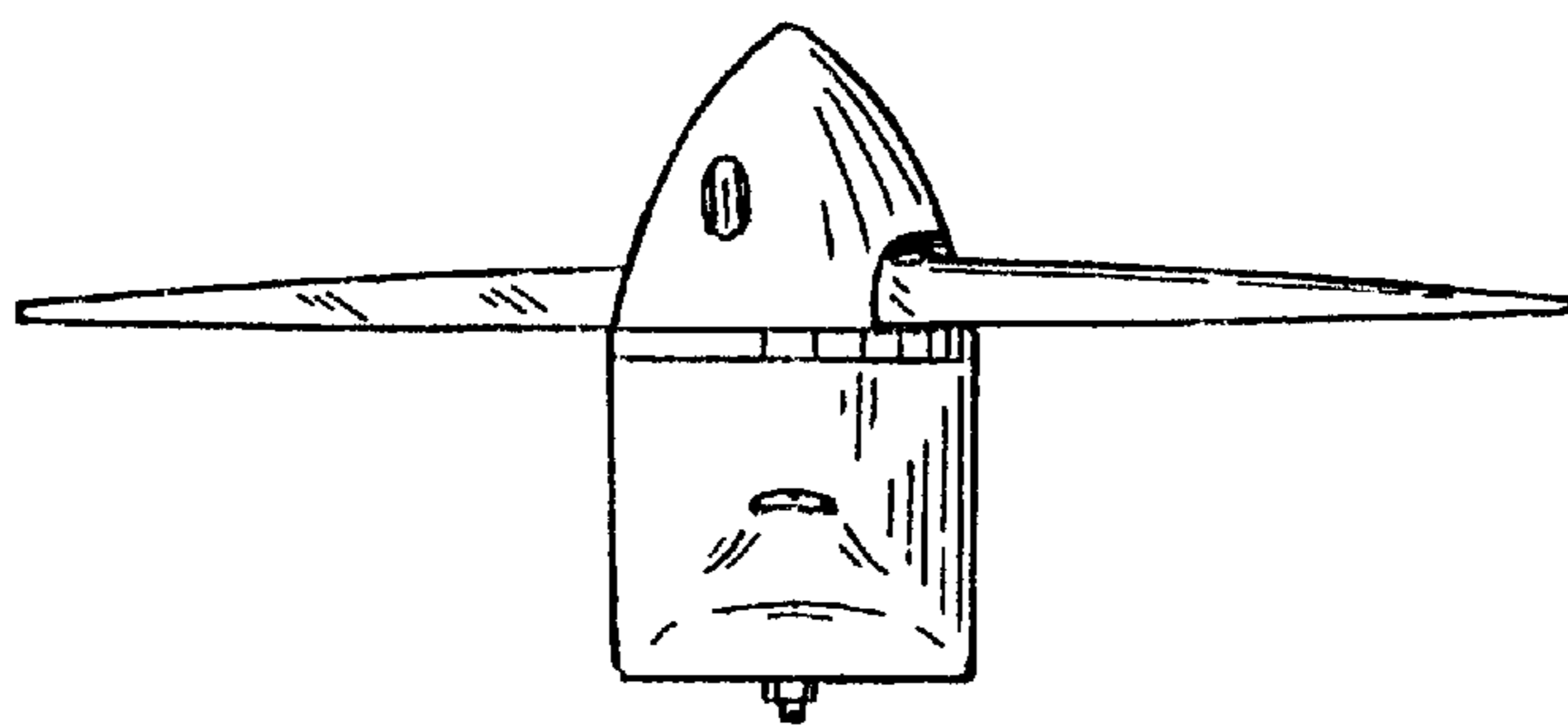

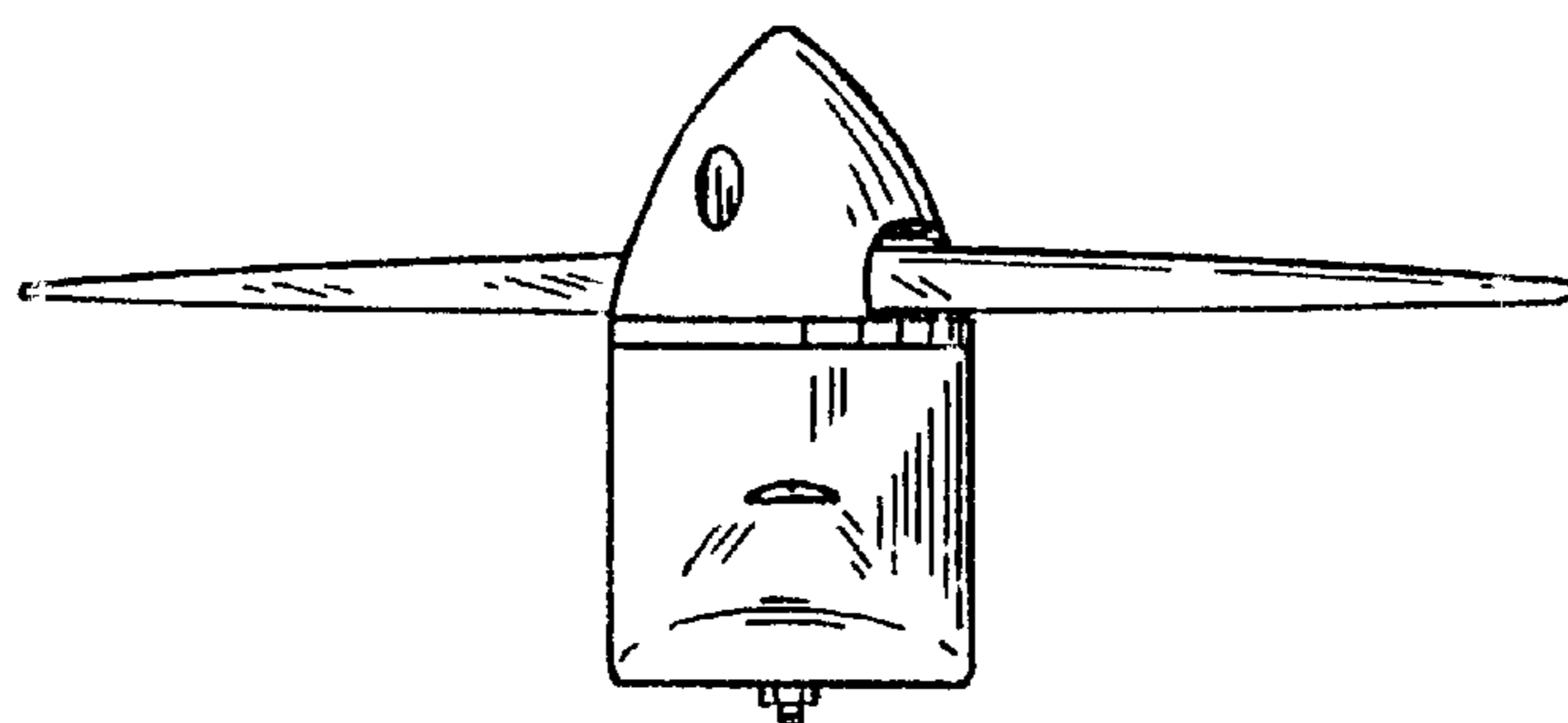
