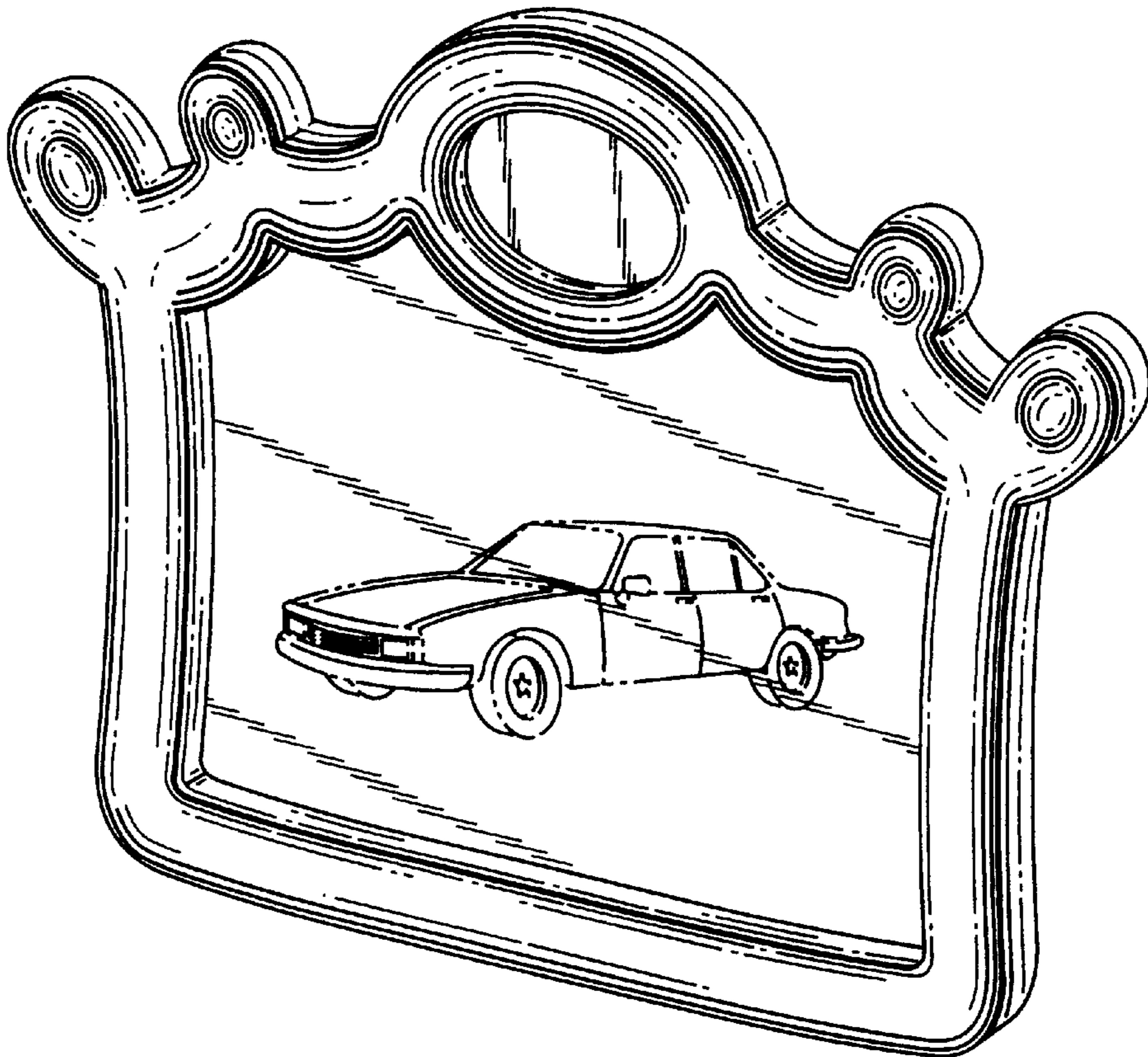
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a merchandising sign of the present invention;
 FIG. 2 is a front view of the merchandising sign of FIG. 1;
 FIG. 3 is a rear plan view of the merchandising sign of FIG. 1;
 FIG. 4 is a top plan view of the merchandising sign of FIG. 1;
 FIG. 5 is a bottom plan view of the merchandising sign of FIG. 1; and,

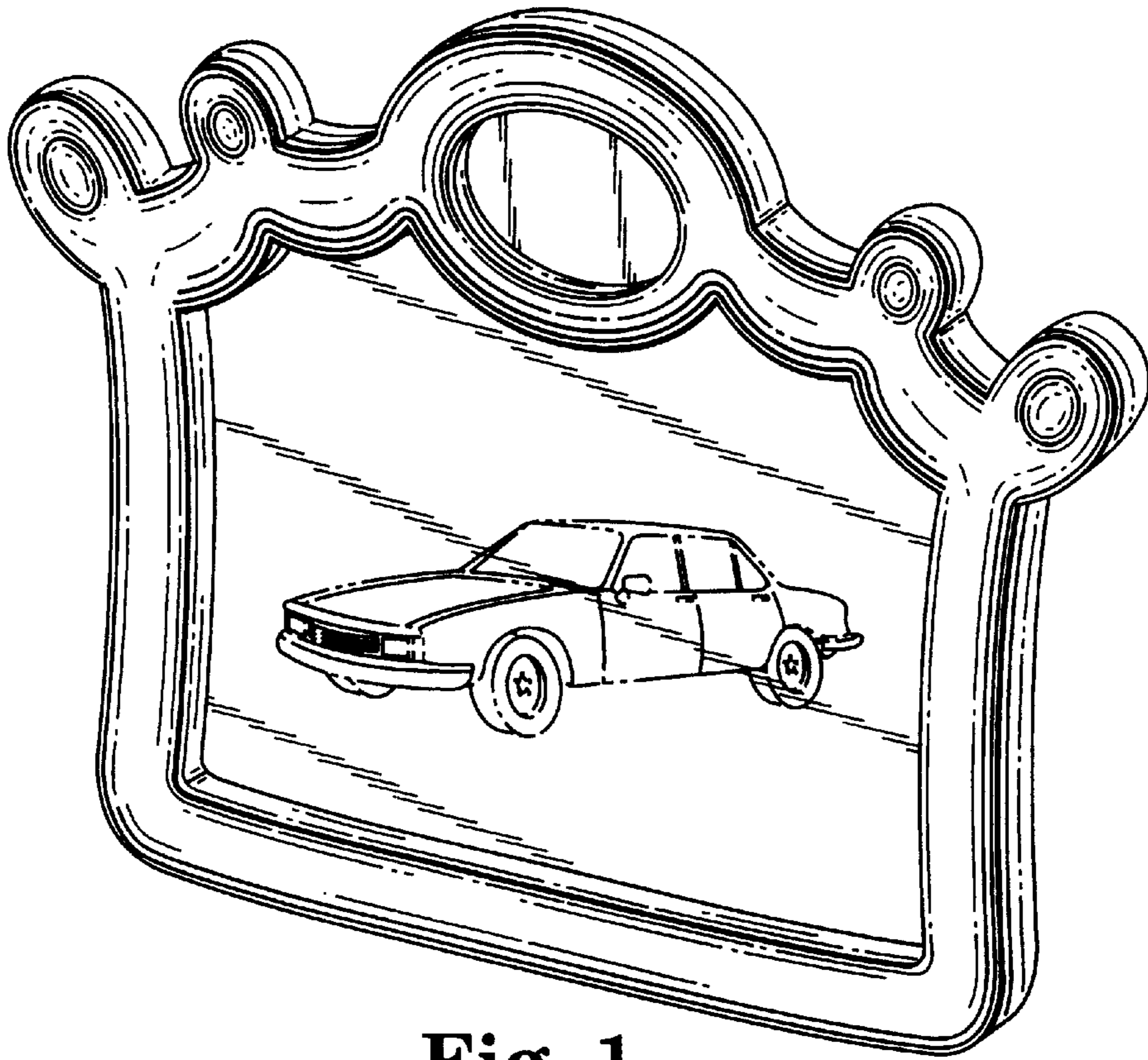

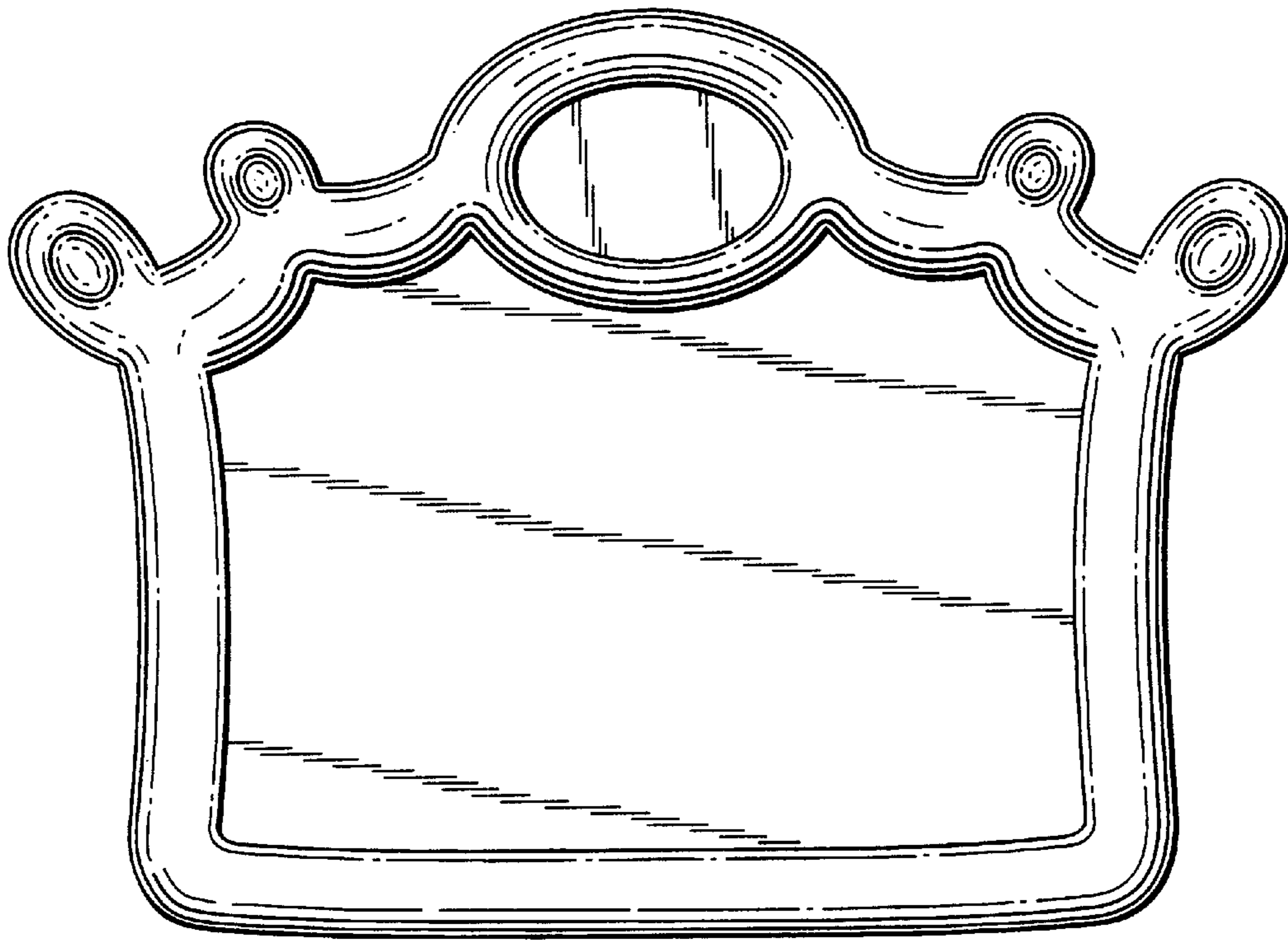

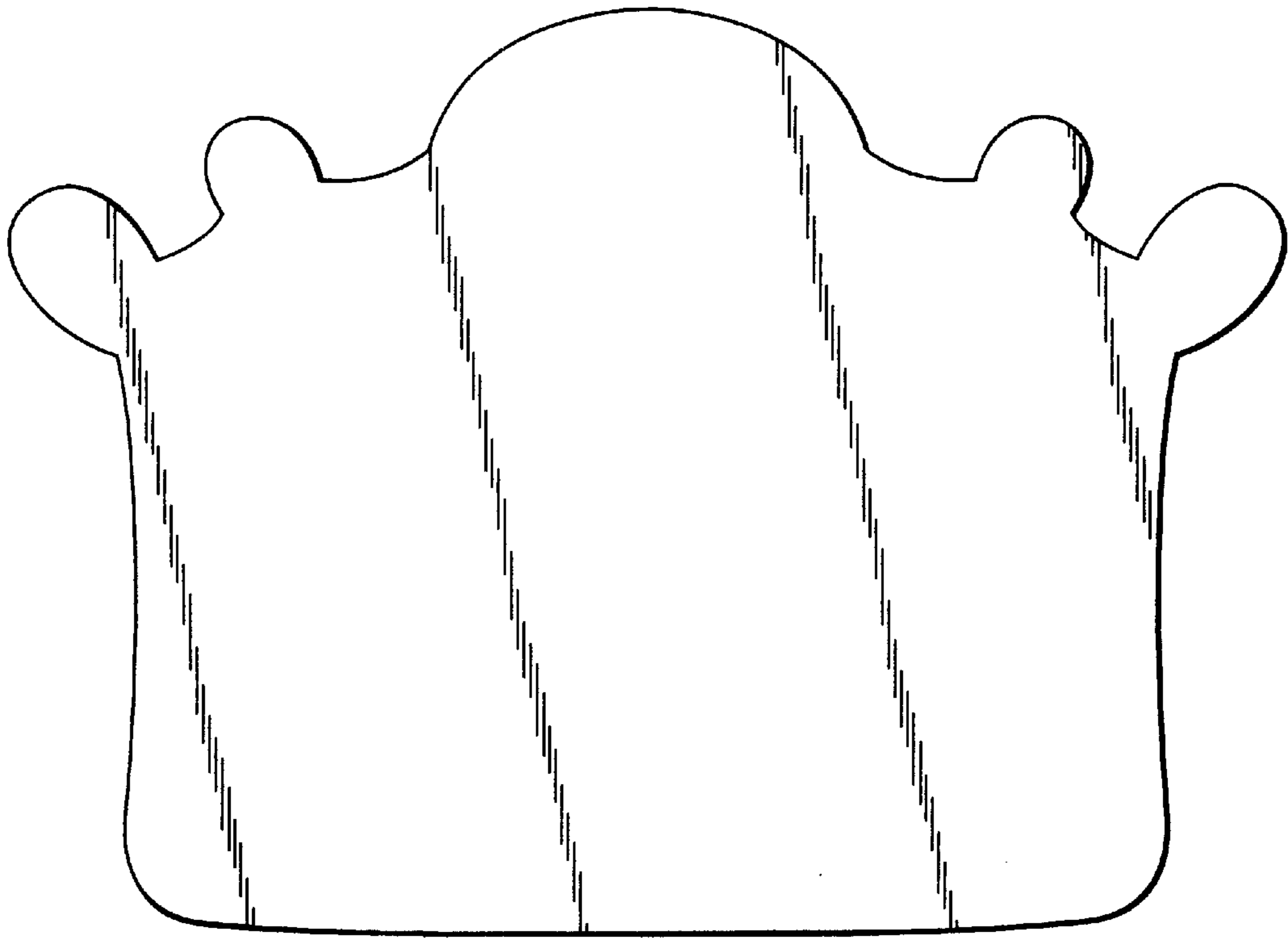

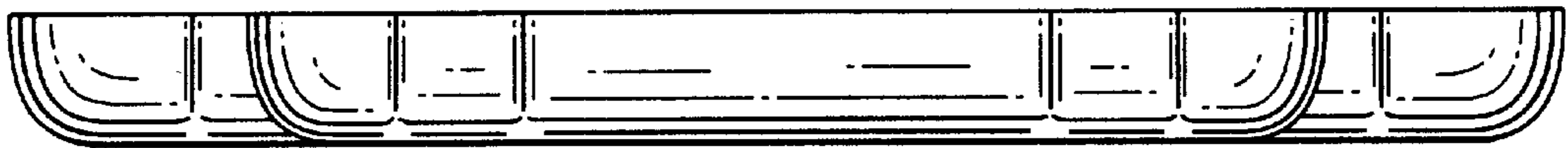

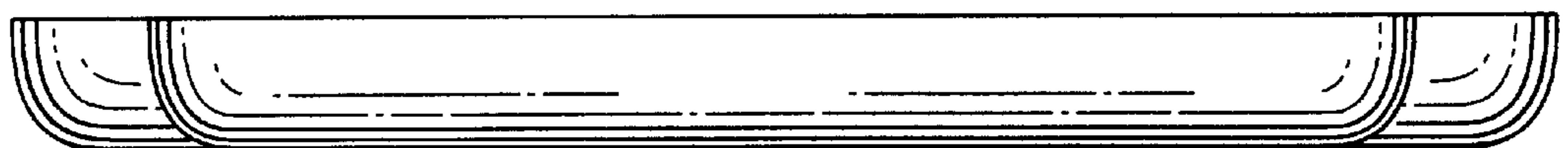

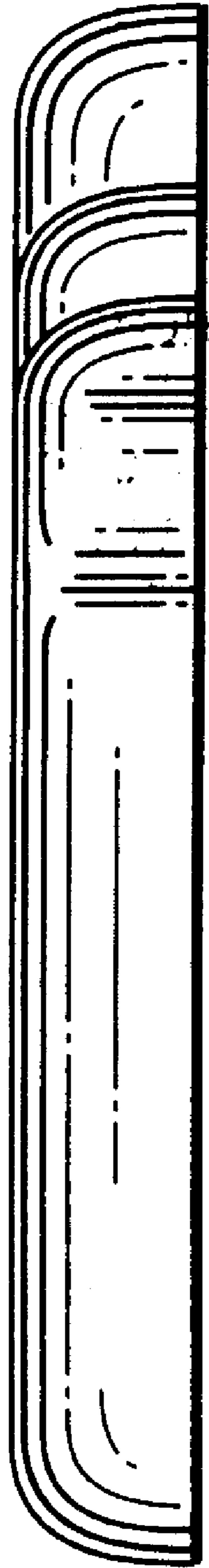
