(57) **CLAIM**

The ornamental design for portion of a footwear upper, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the portion of a footwear upper embodying the new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a right side elevational view thereof;

FIG. 4 is a left side elevational view thereof;

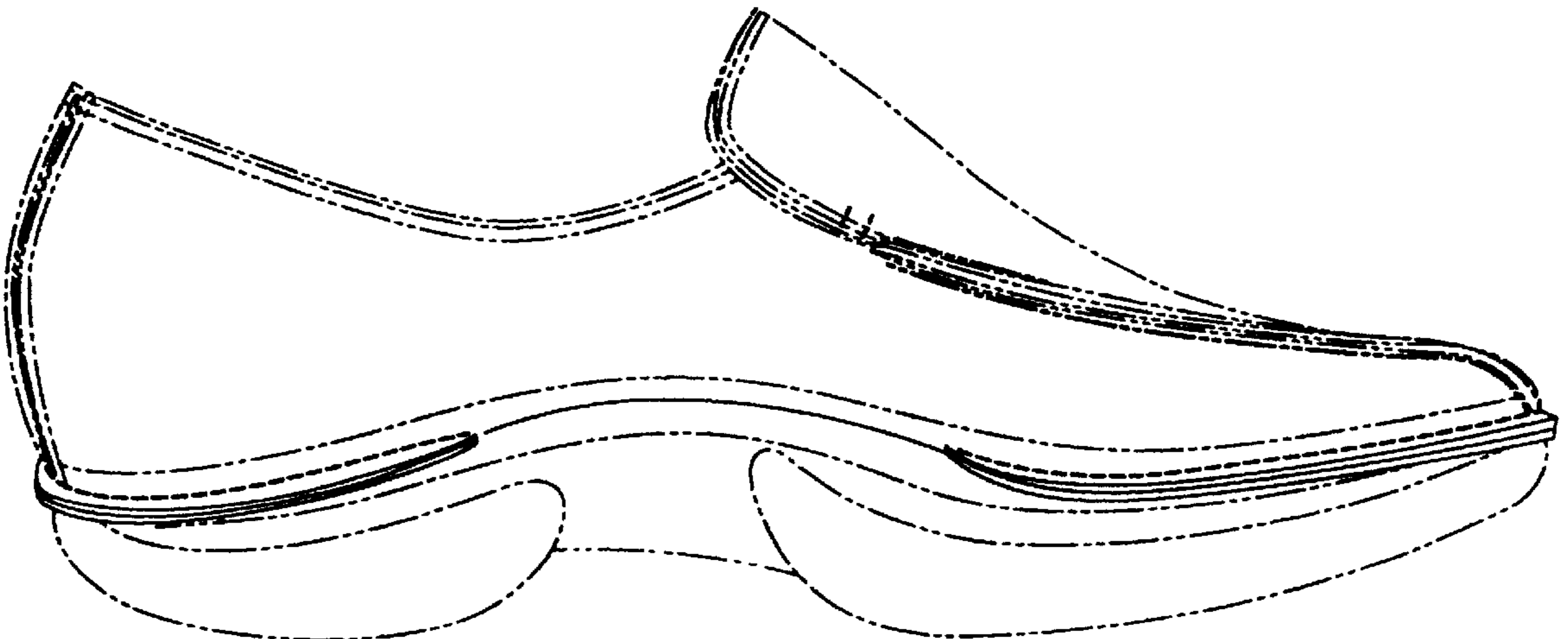
FIG. 5 is a front elevational view thereof;

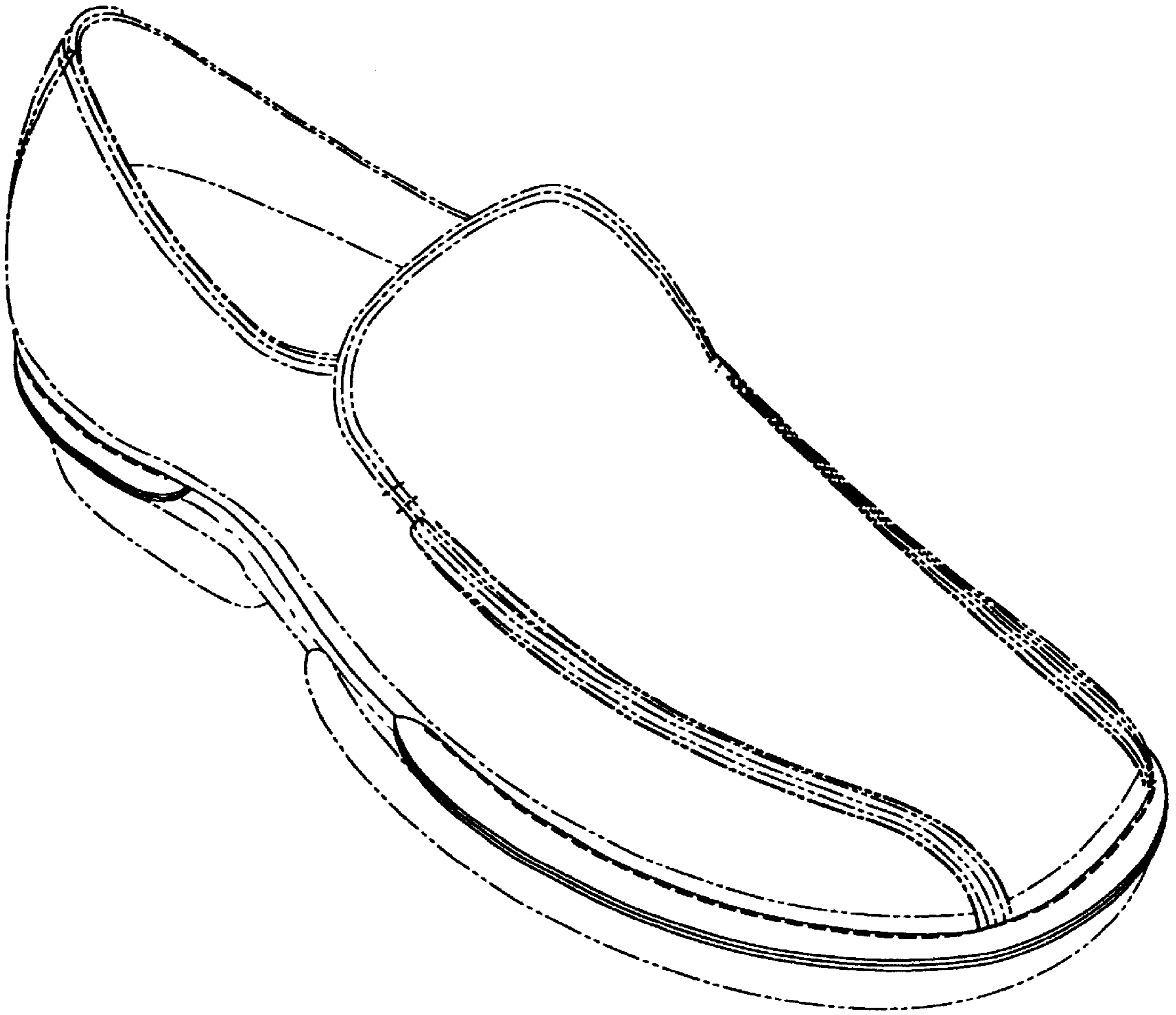

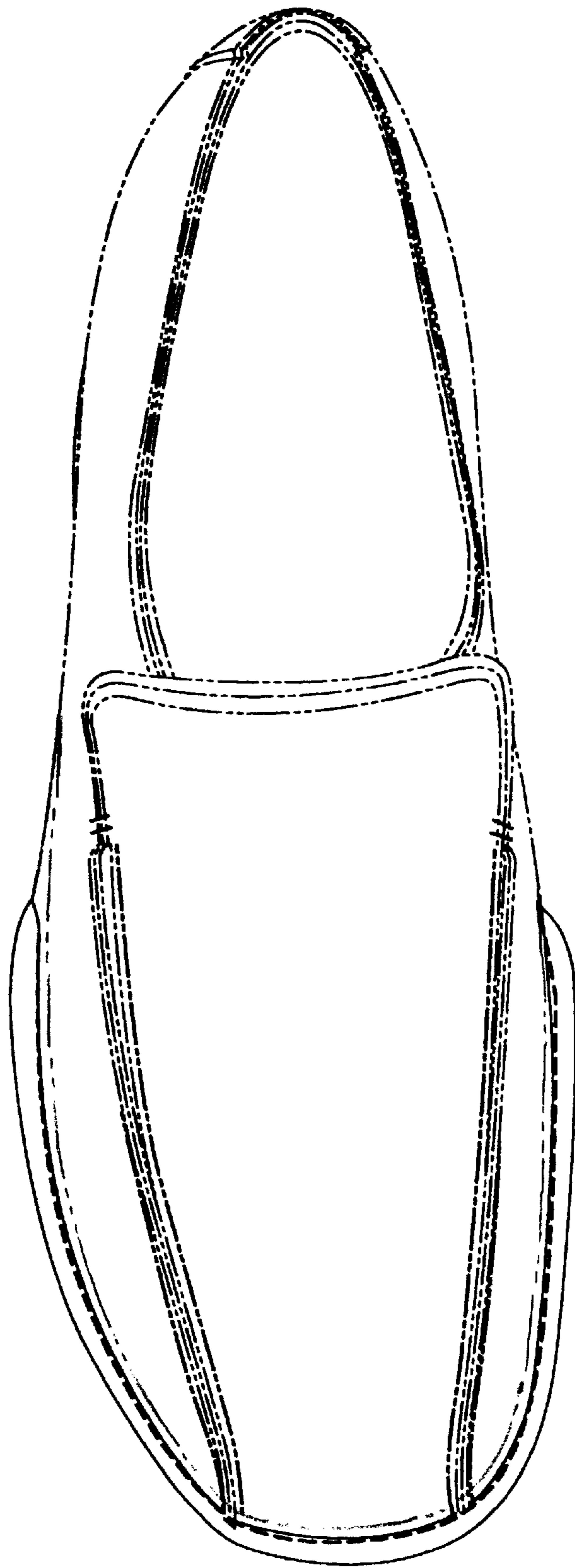

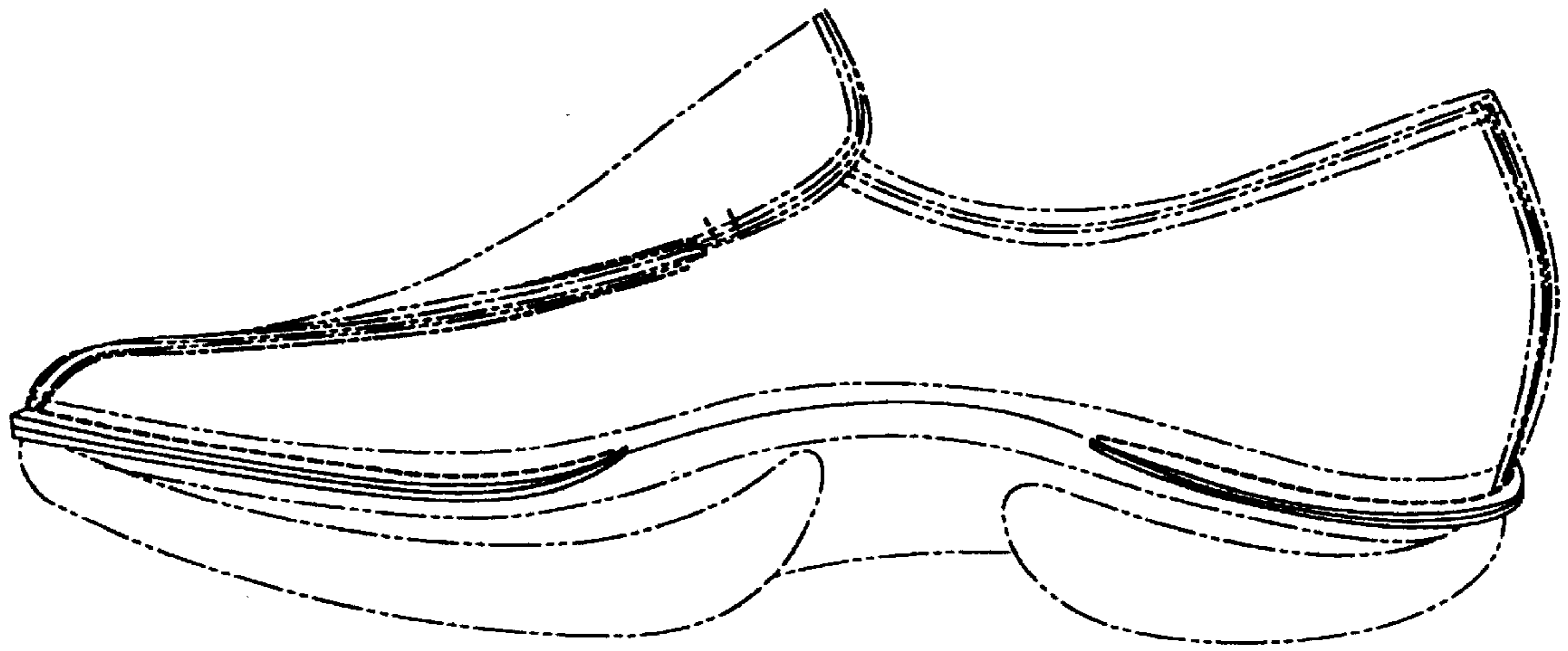

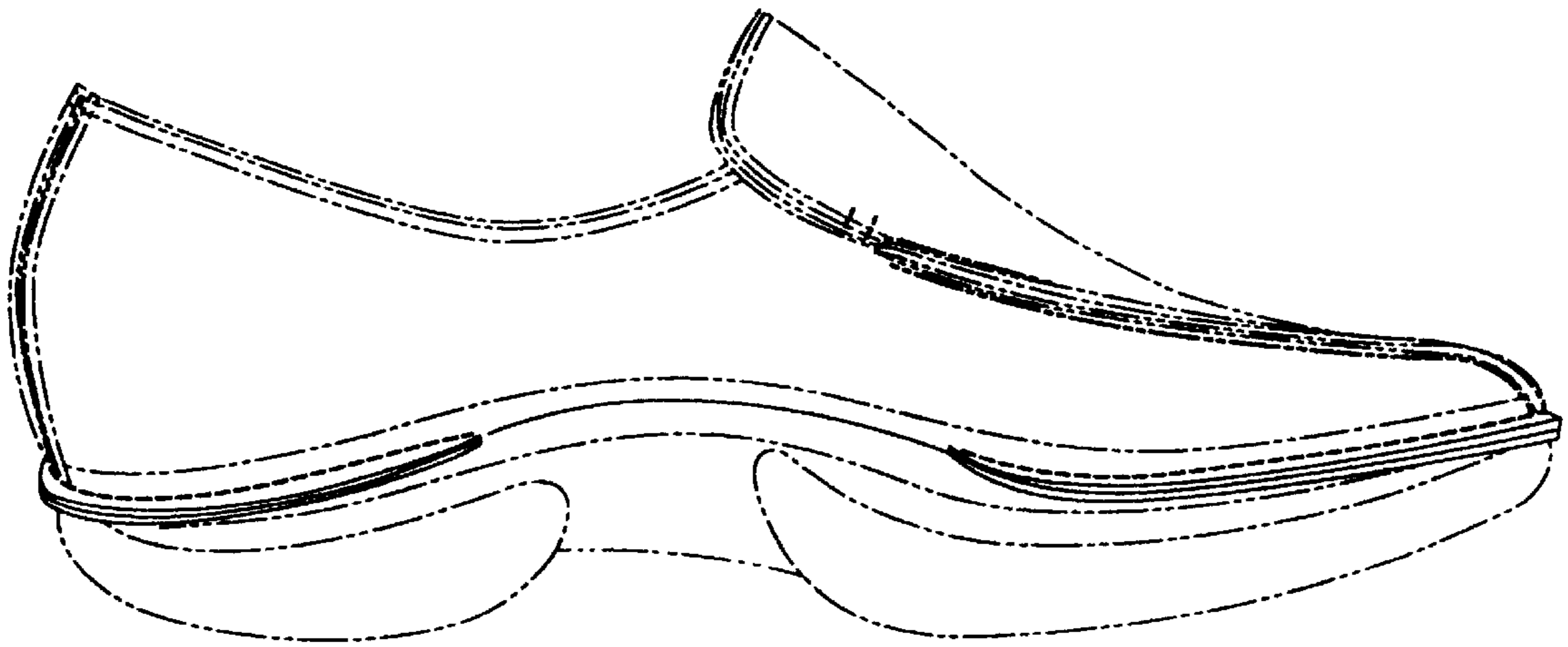

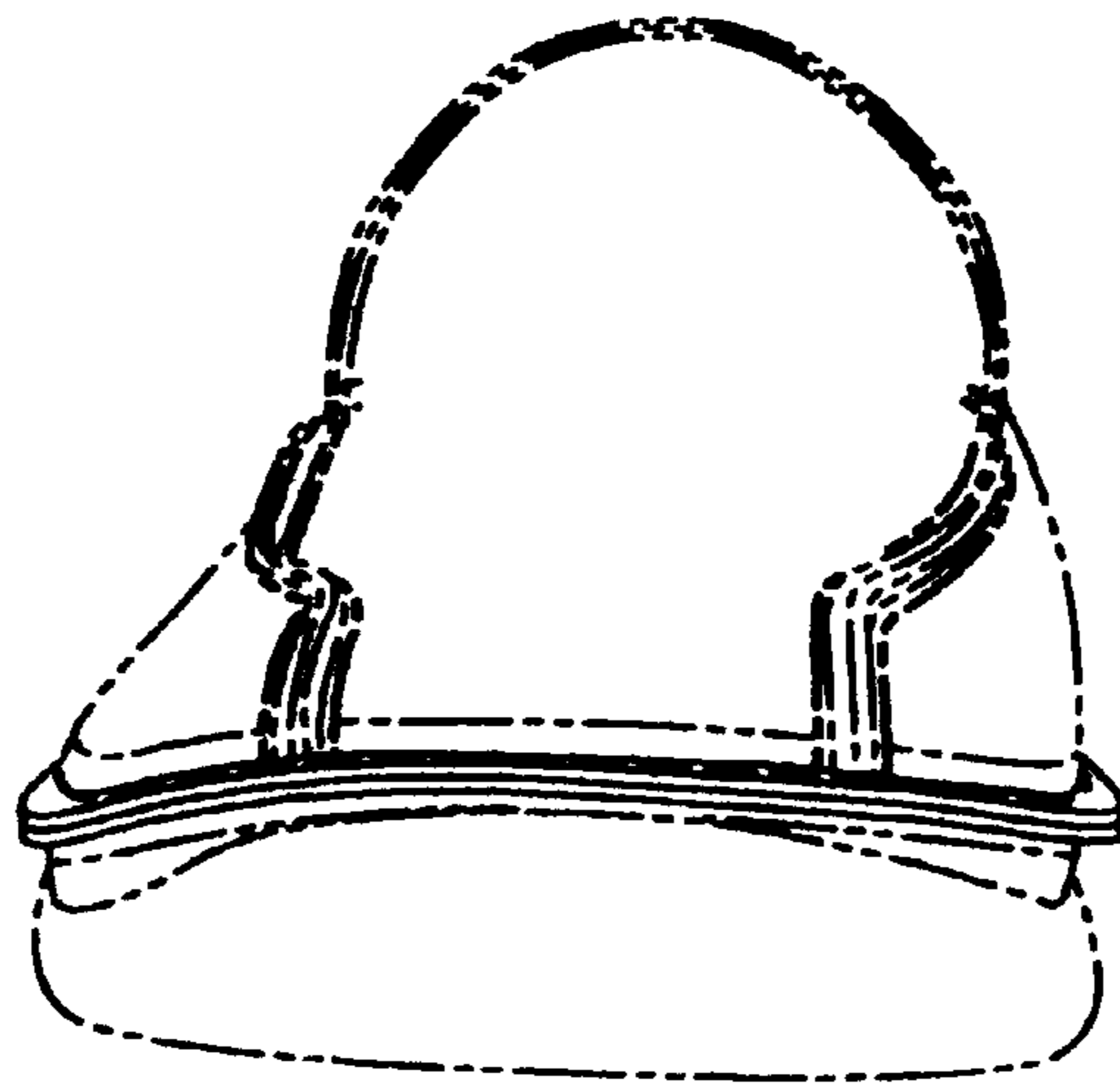

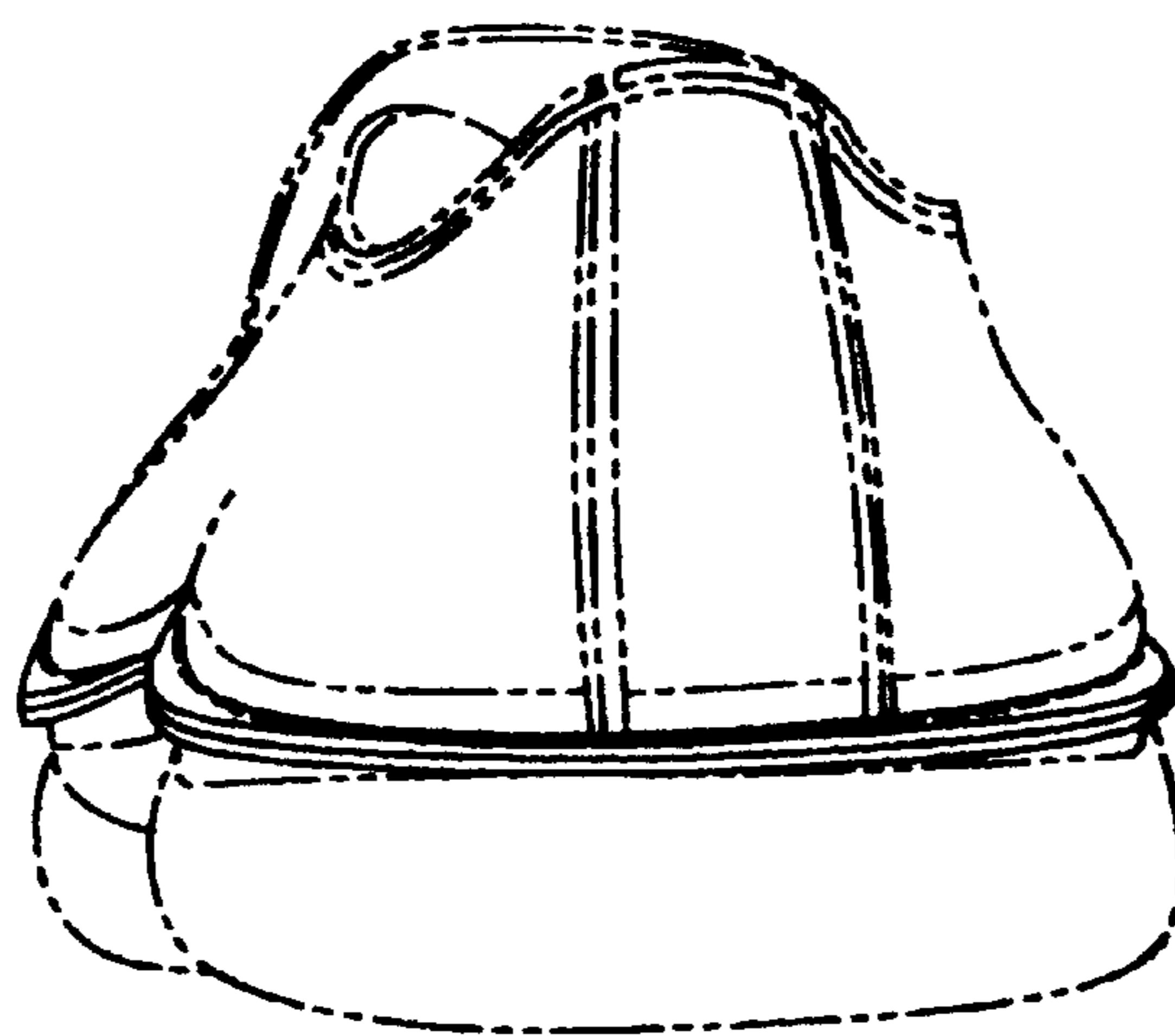

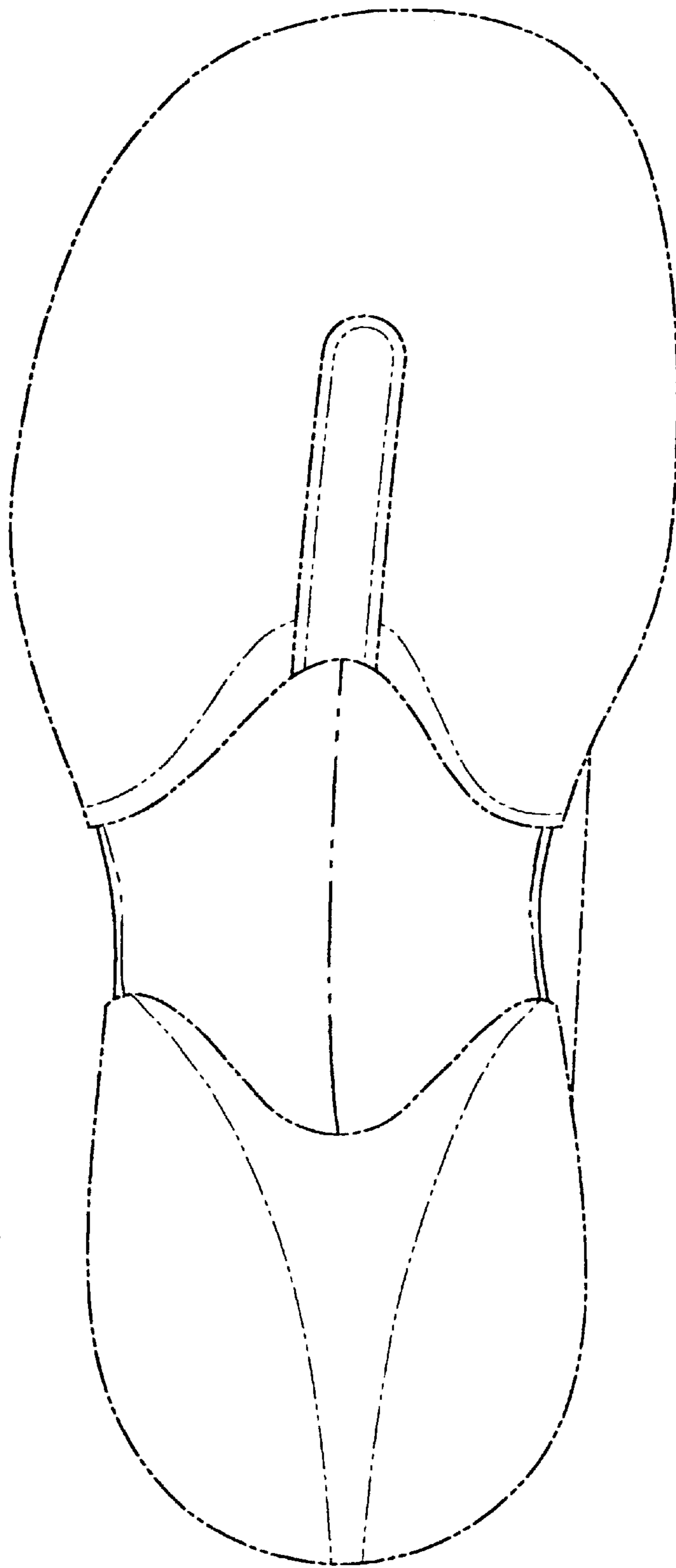
