FIG. 1 is a front perspective view of the sunshade according to the present invention;

FIG. 2 is a top plan view of the sunshade of FIG. 1;

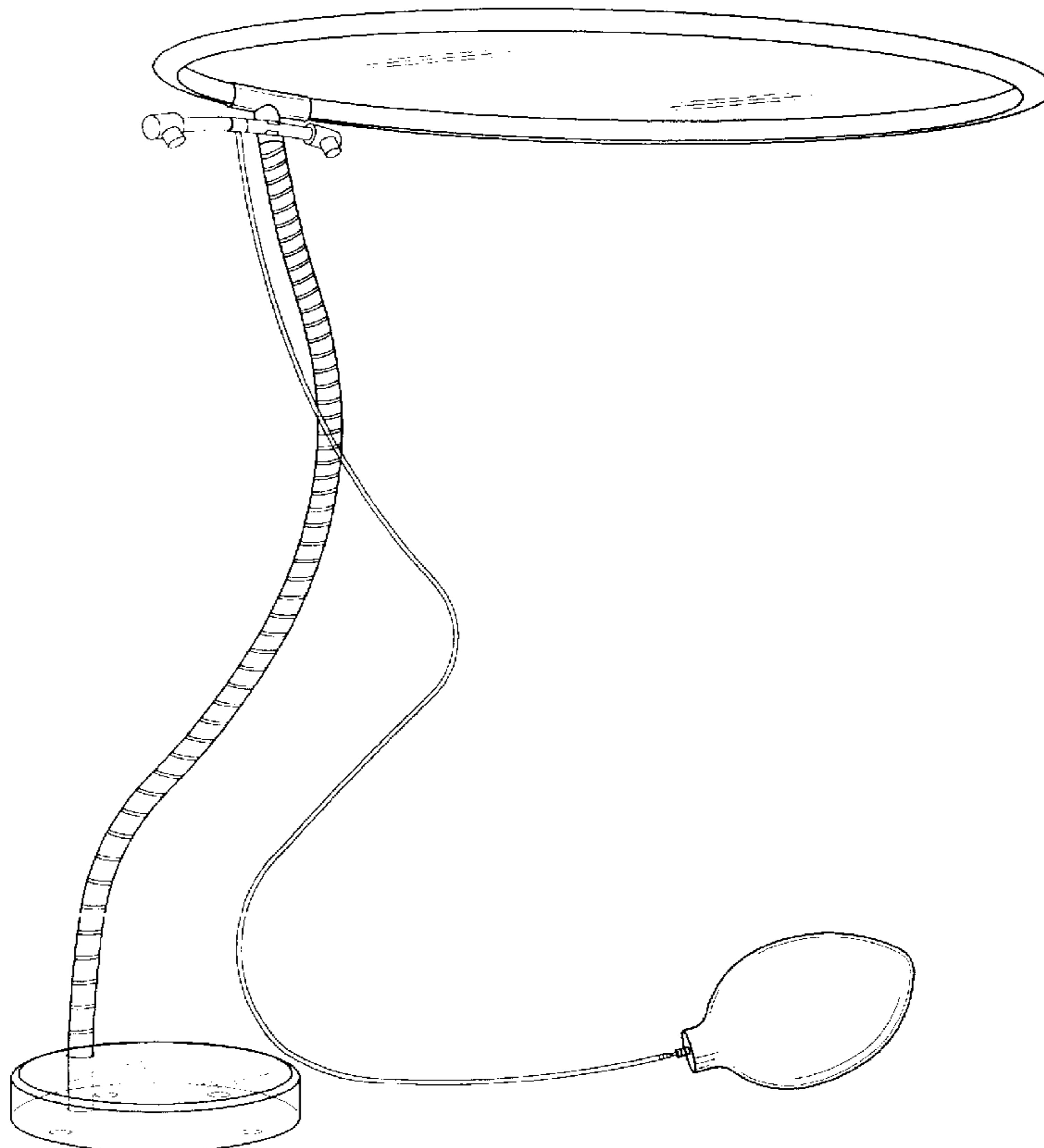
FIG. 3 is a bottom plan view of the sunshade of FIG. 1;

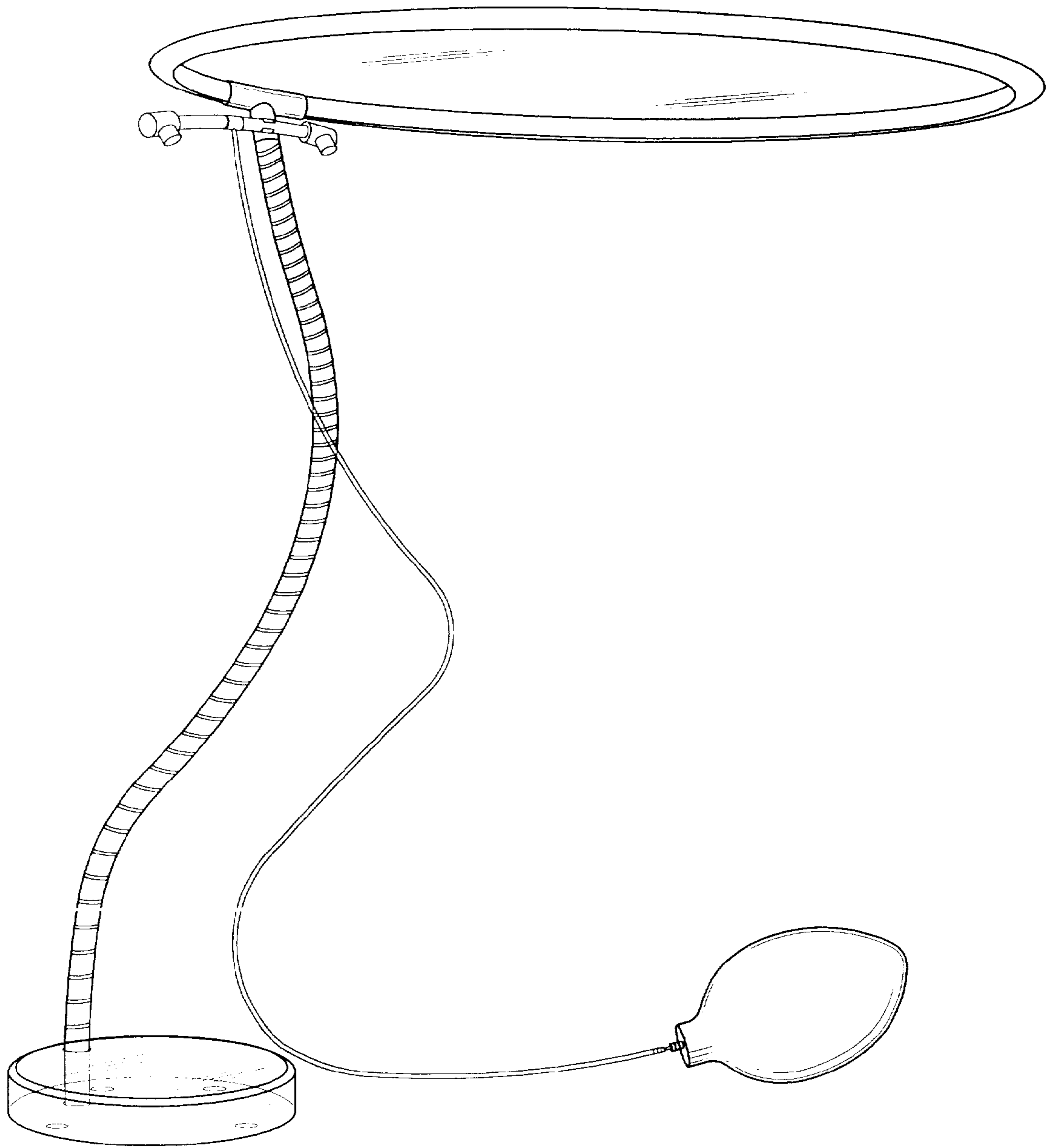

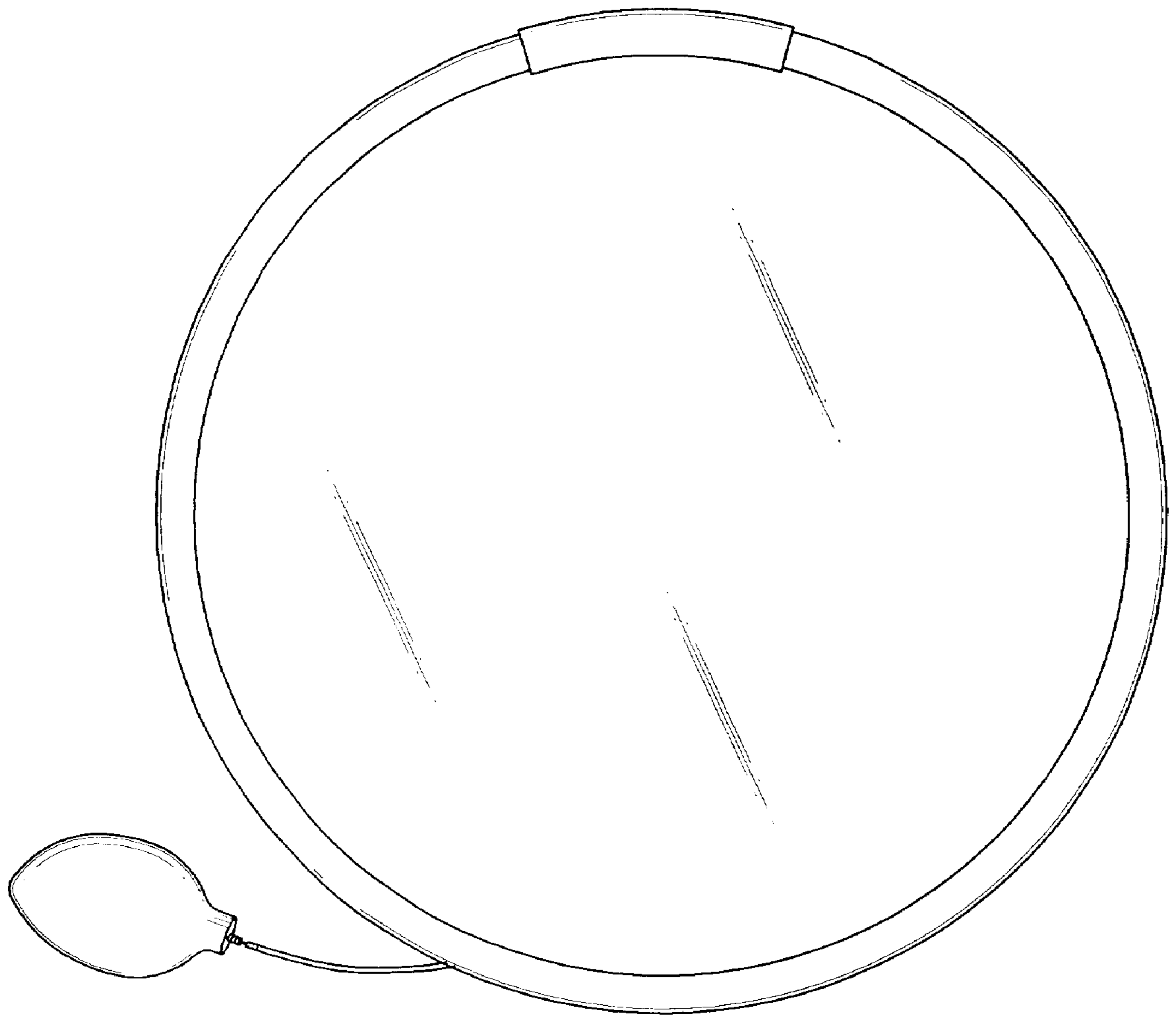

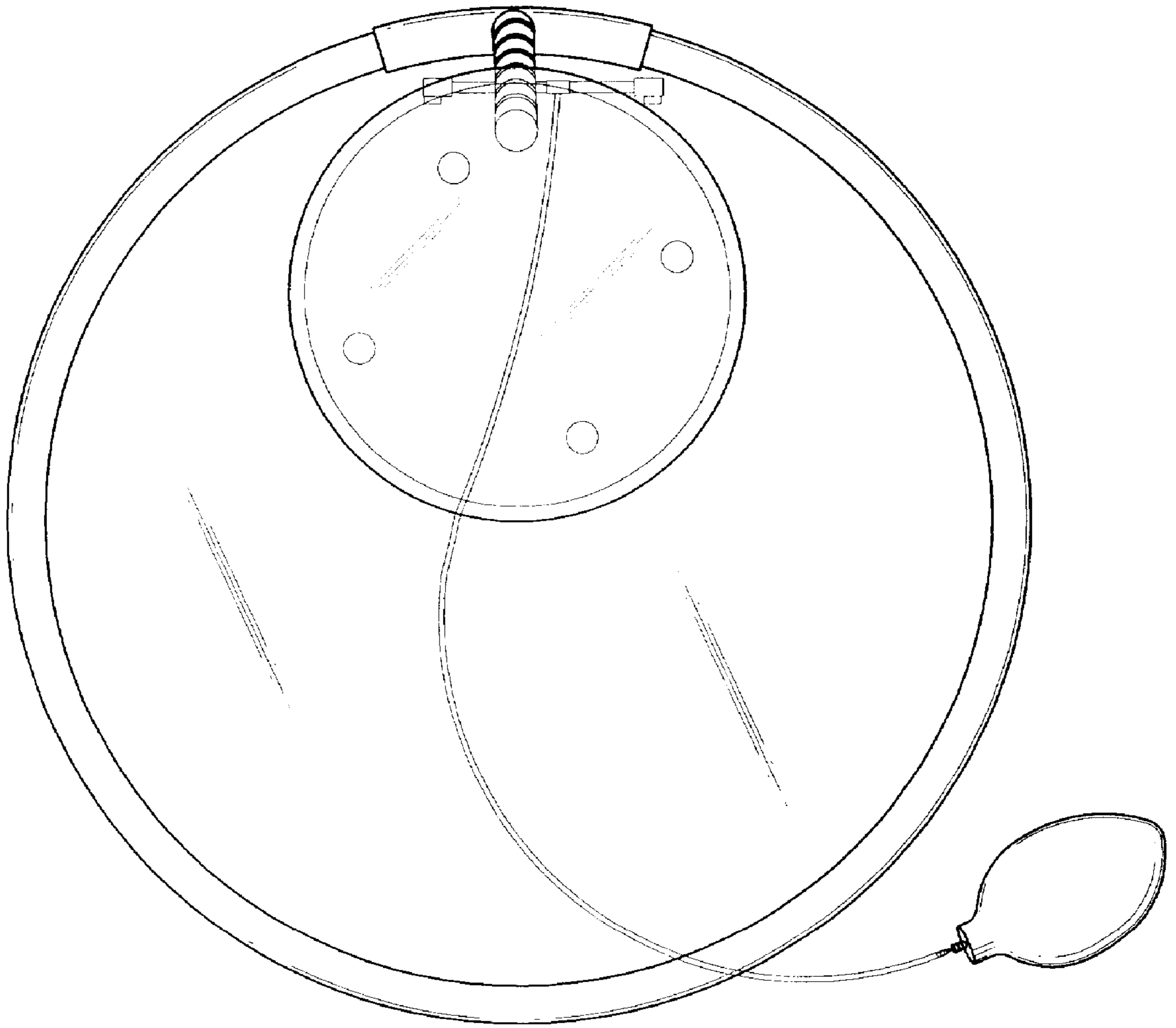

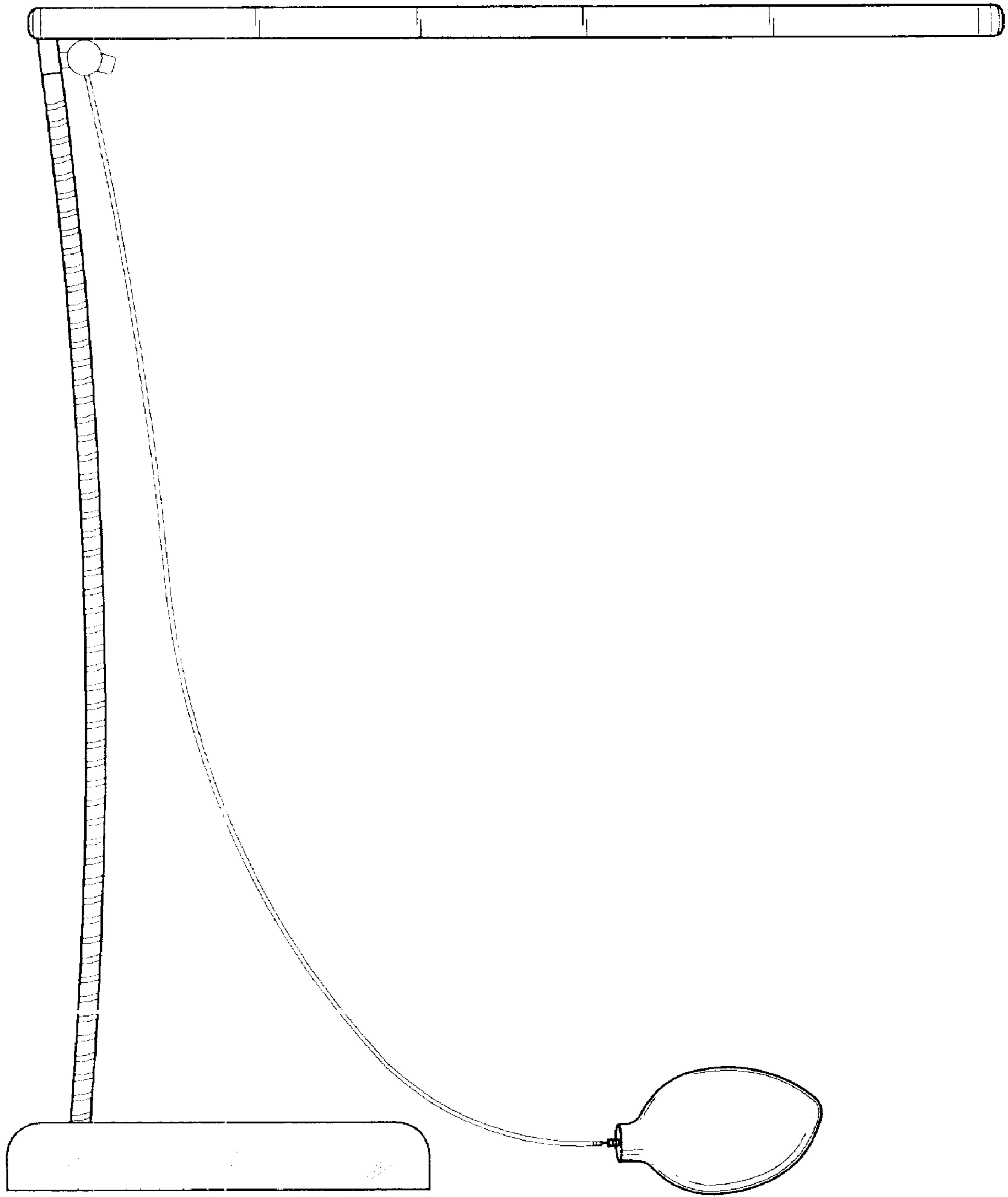

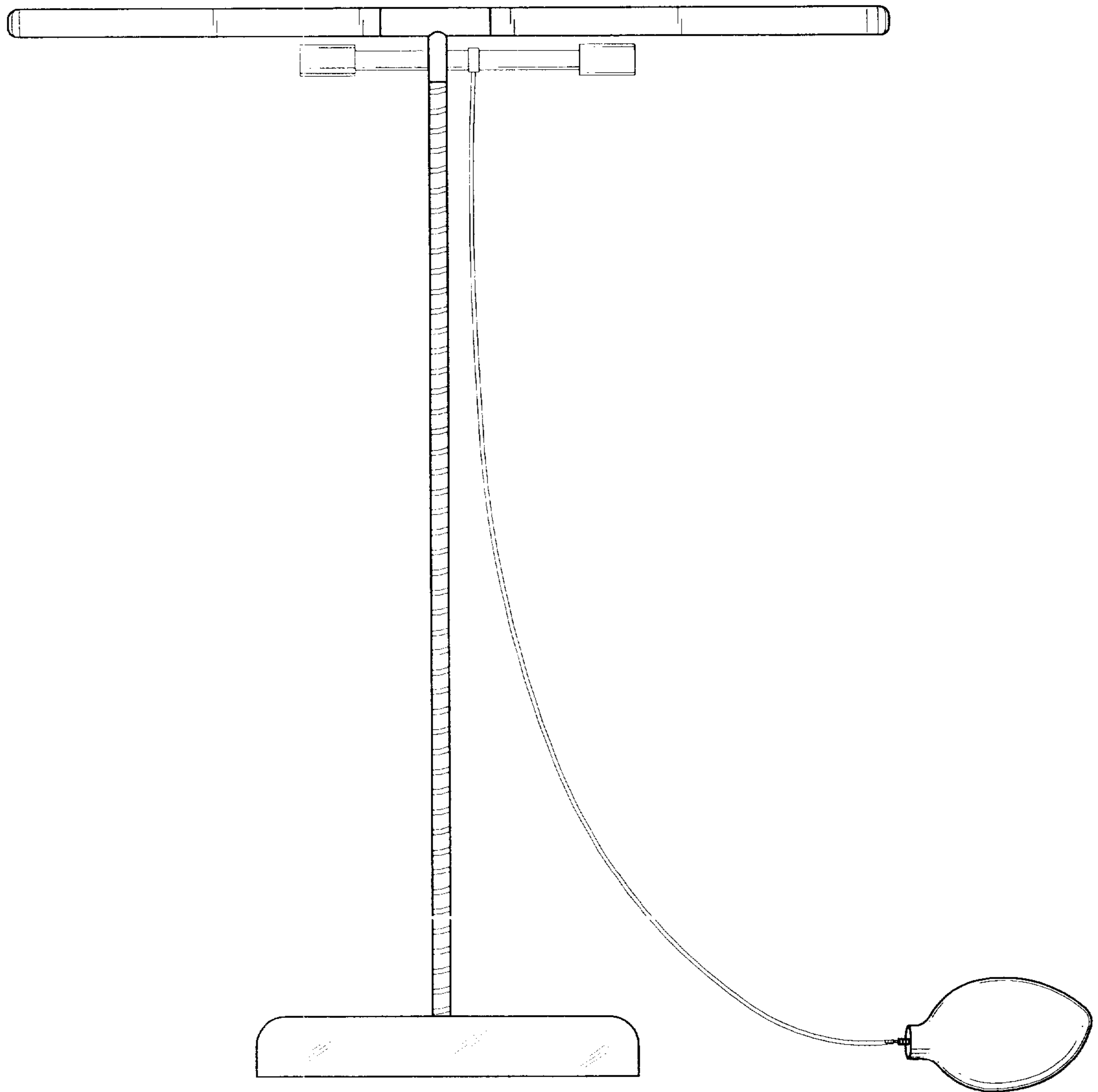

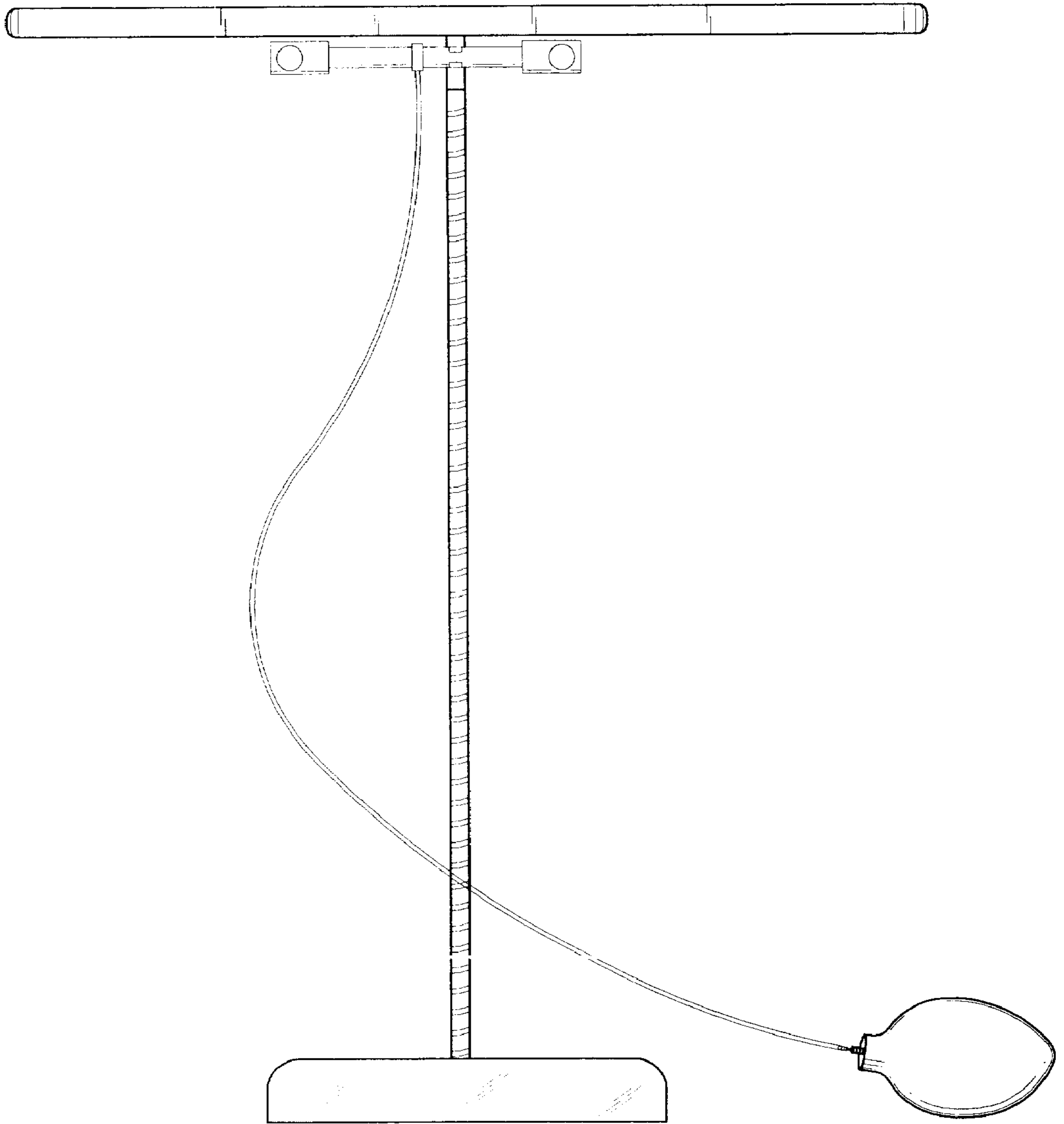
