DESCRIPTION

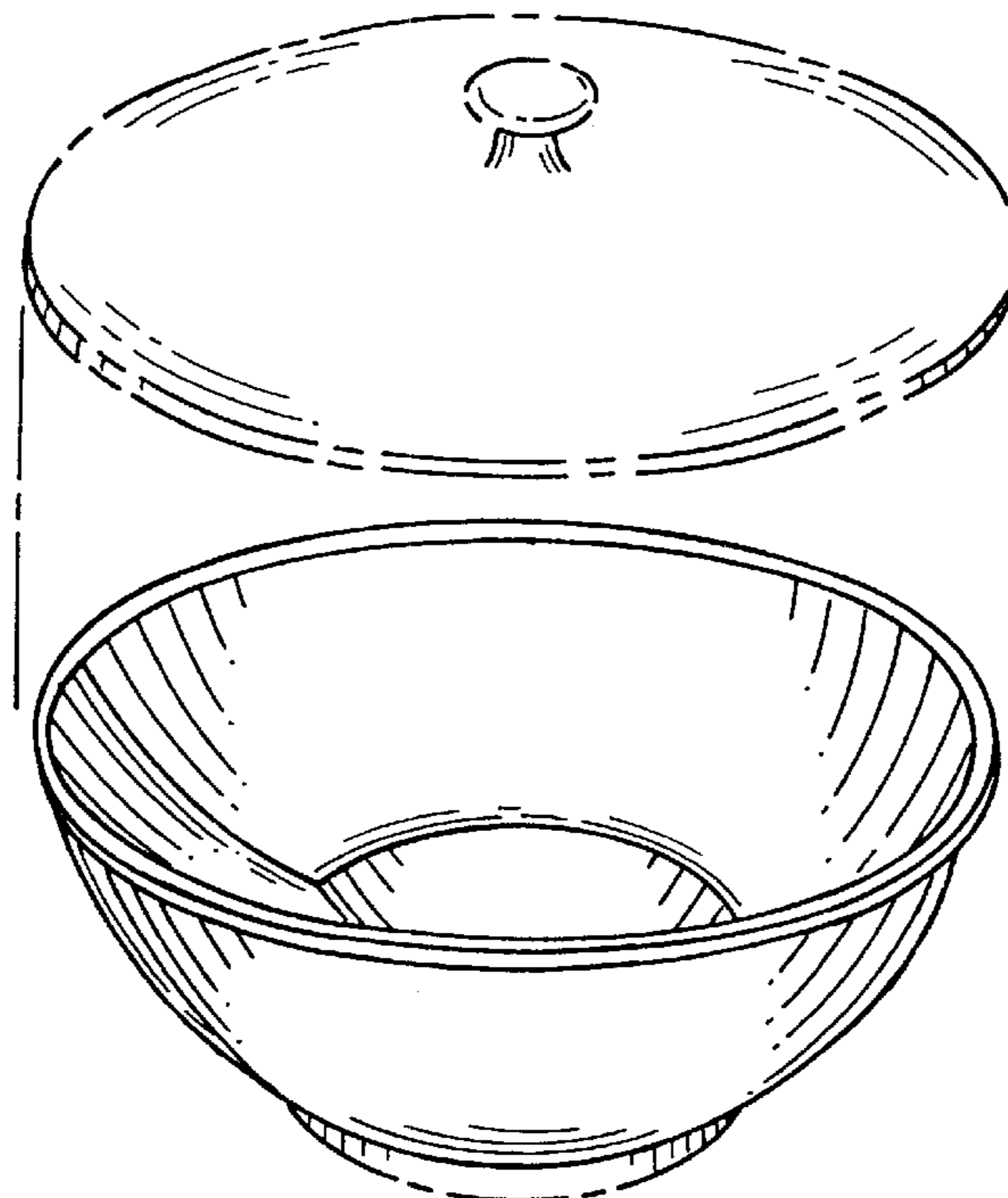
FIG. 1 is a perspective side view of the soup and cereal bowl;

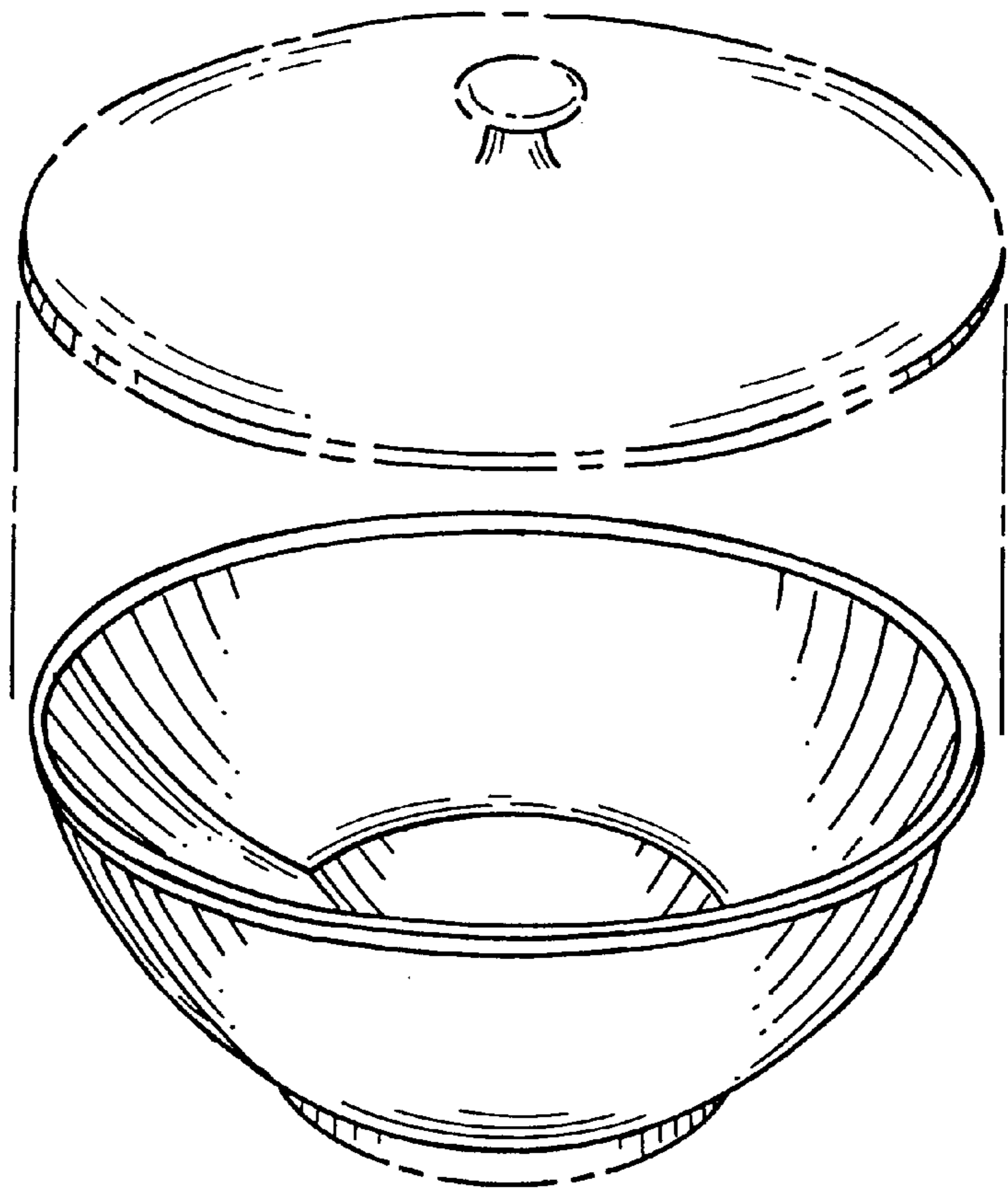

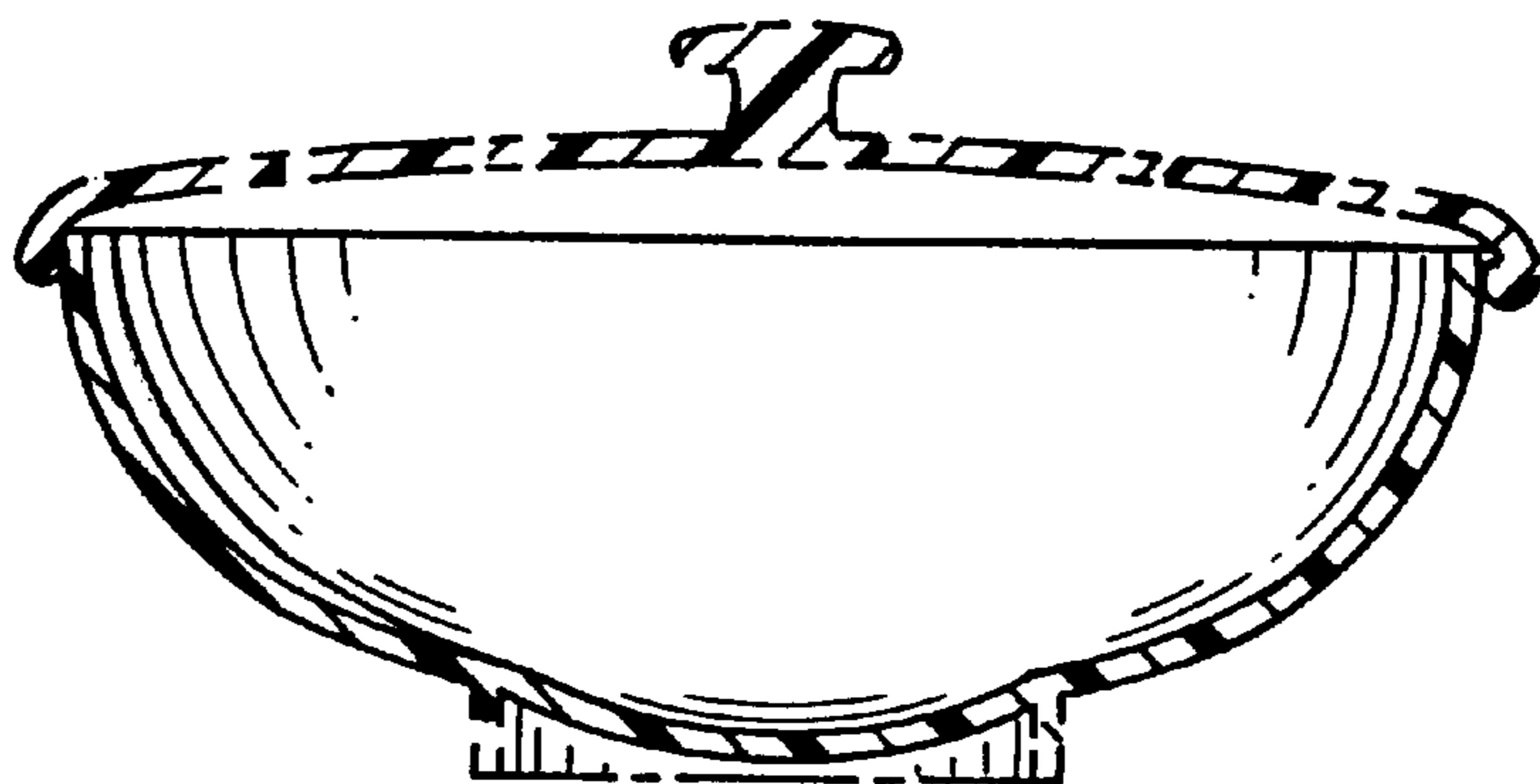

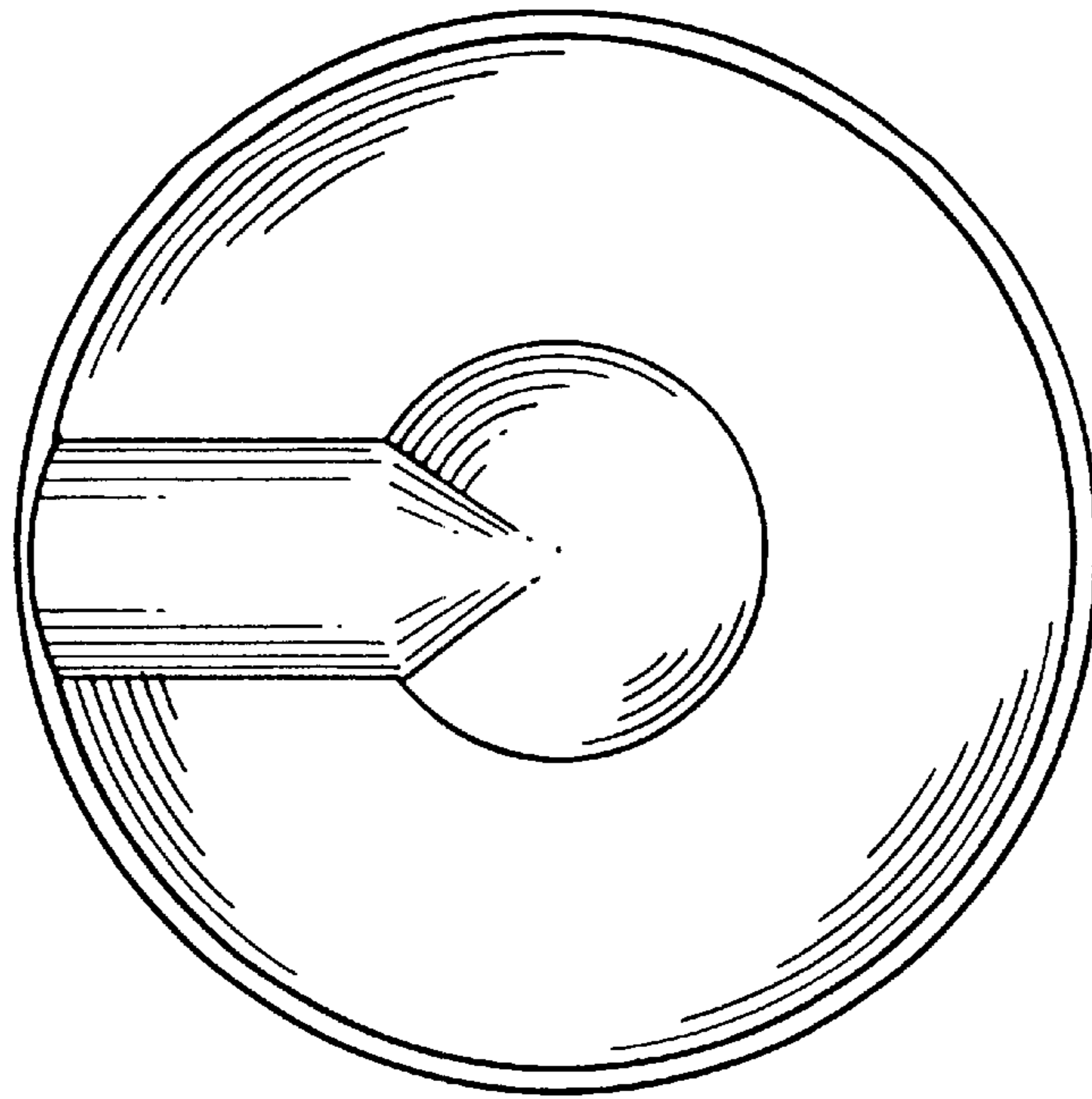

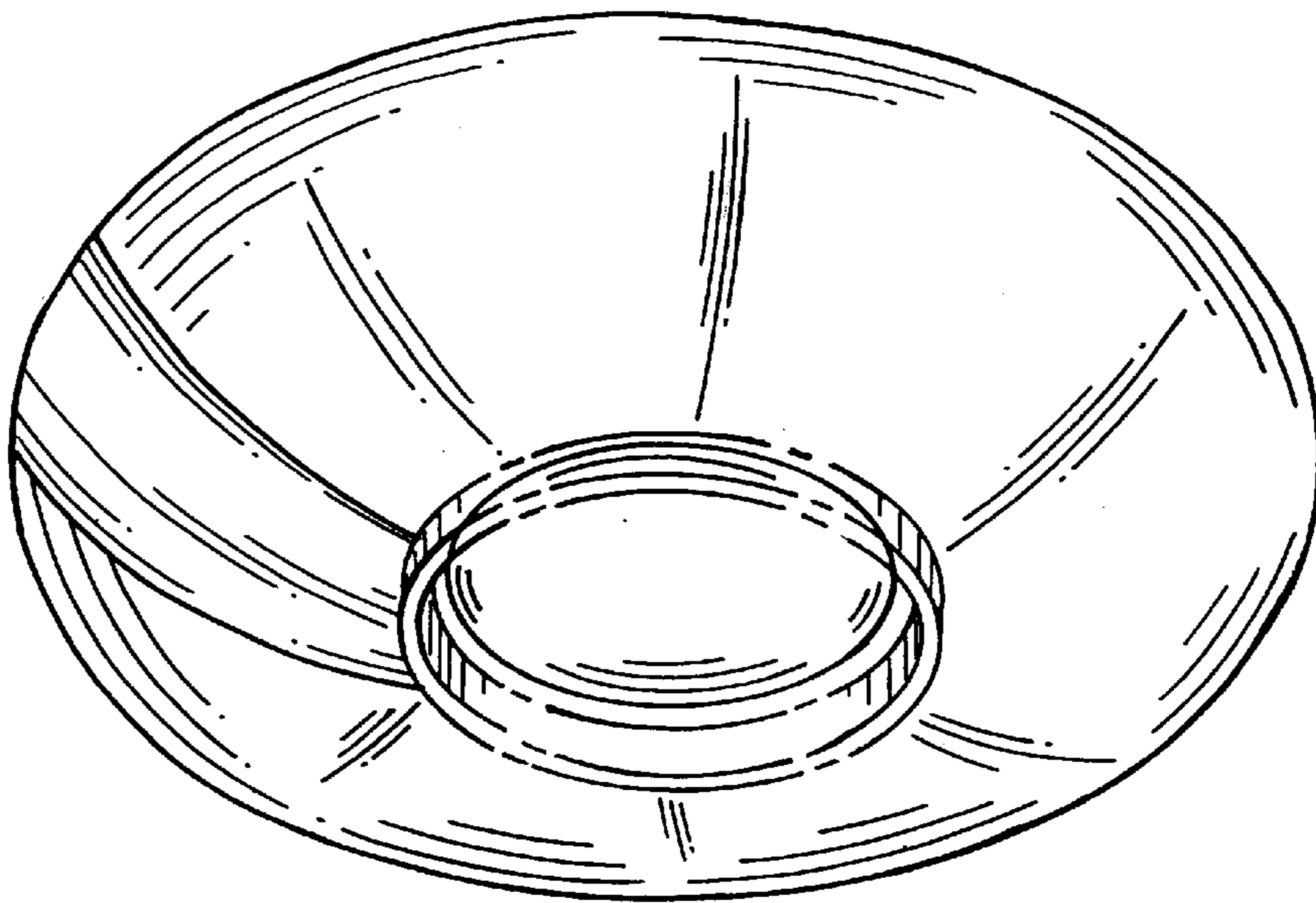

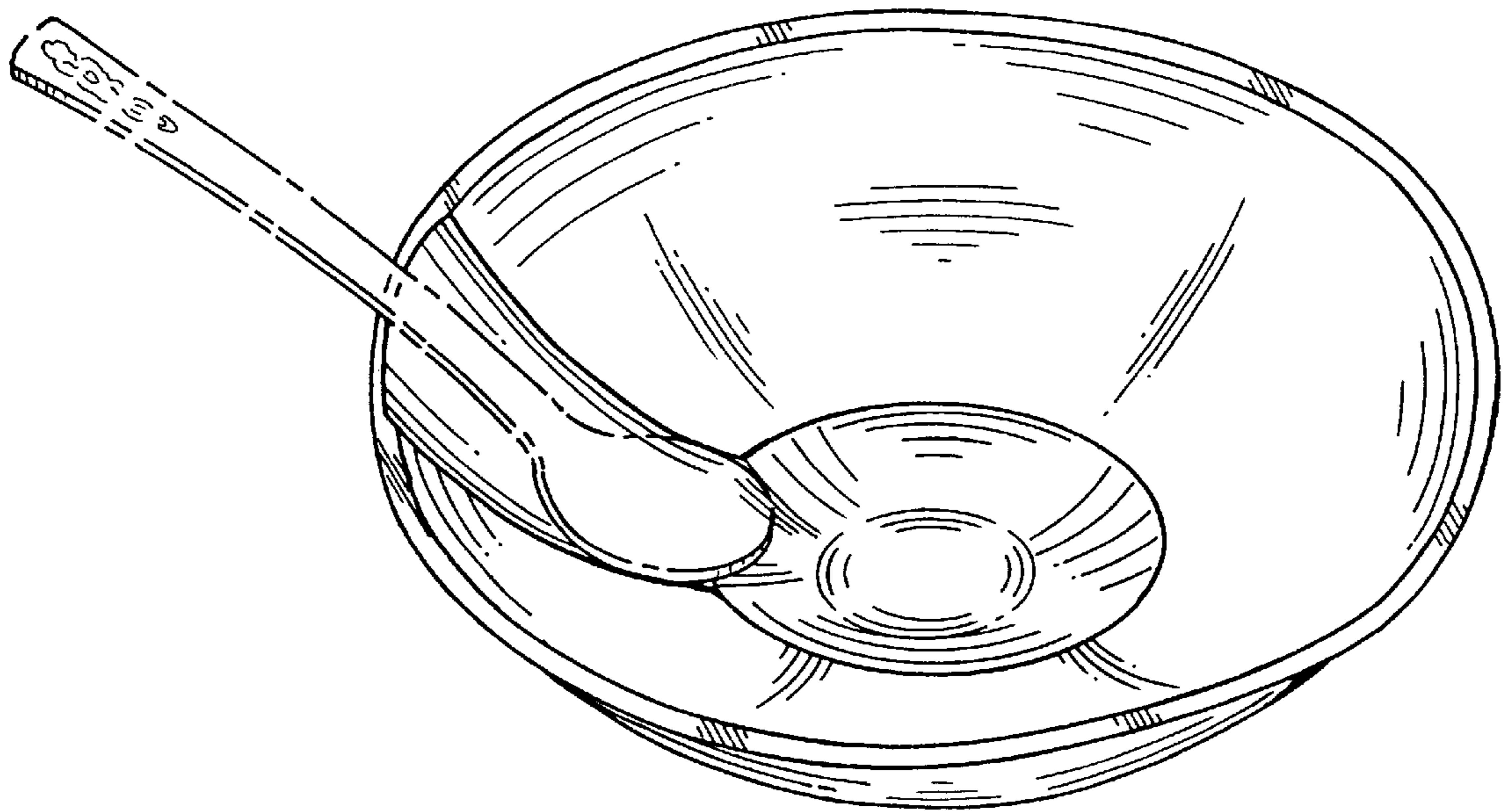
