FIG. 4 is a top plan view of a third embodiment of a rotary saw blade wherein the bottom plan view is a mirror image.

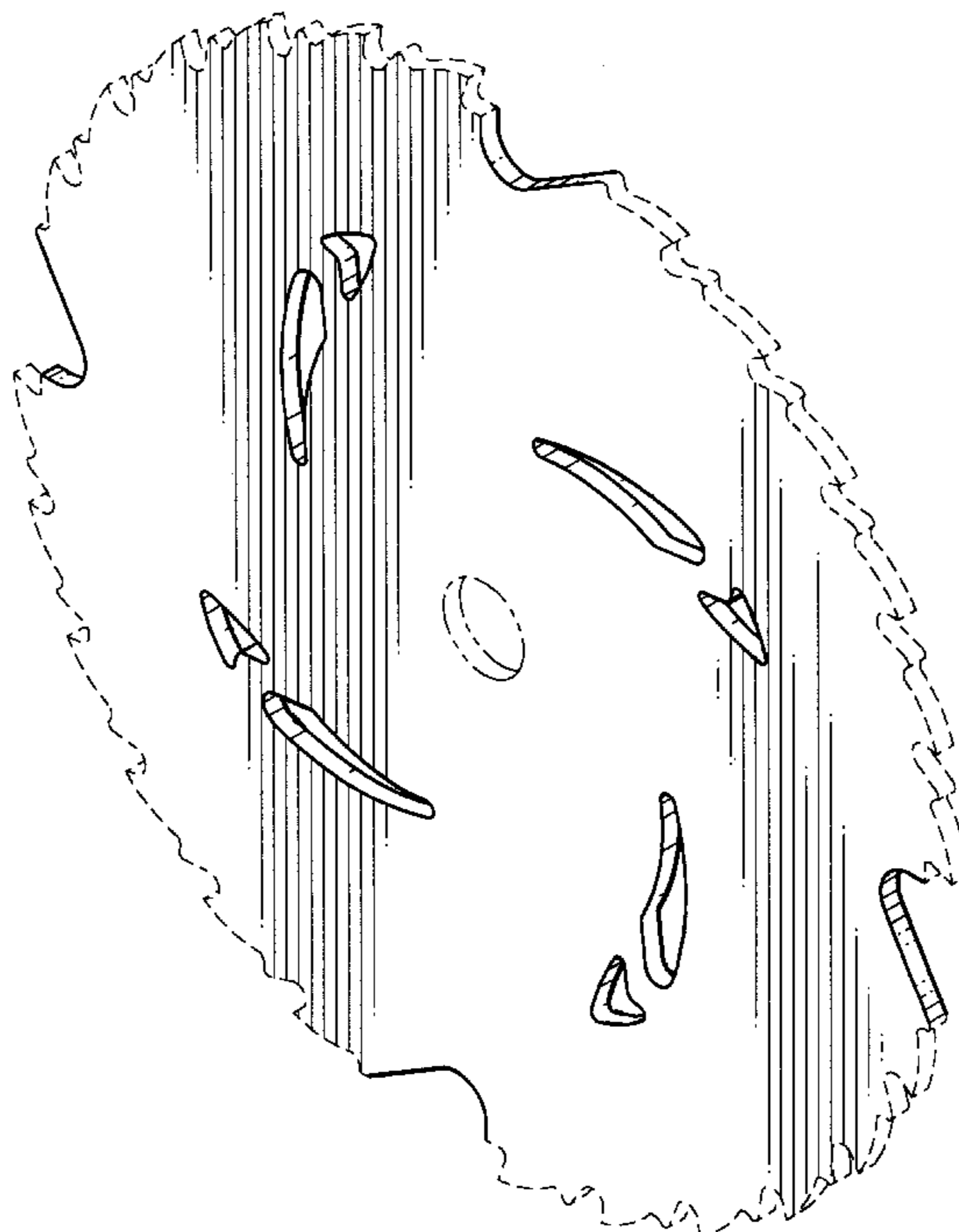
The broken lines of FIGS. 1–4 indicate components for illustrative purposes only and form no part of the subject design.

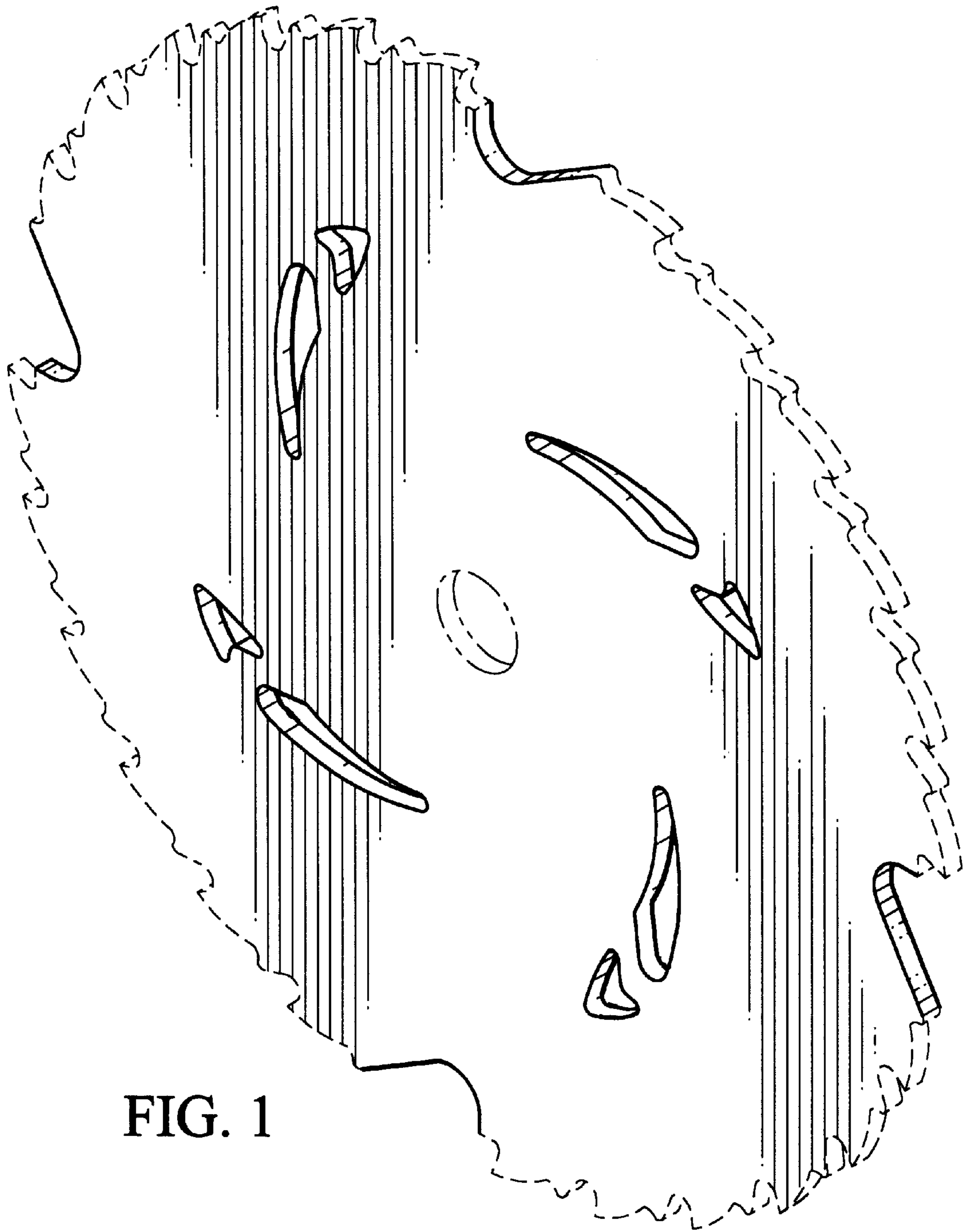

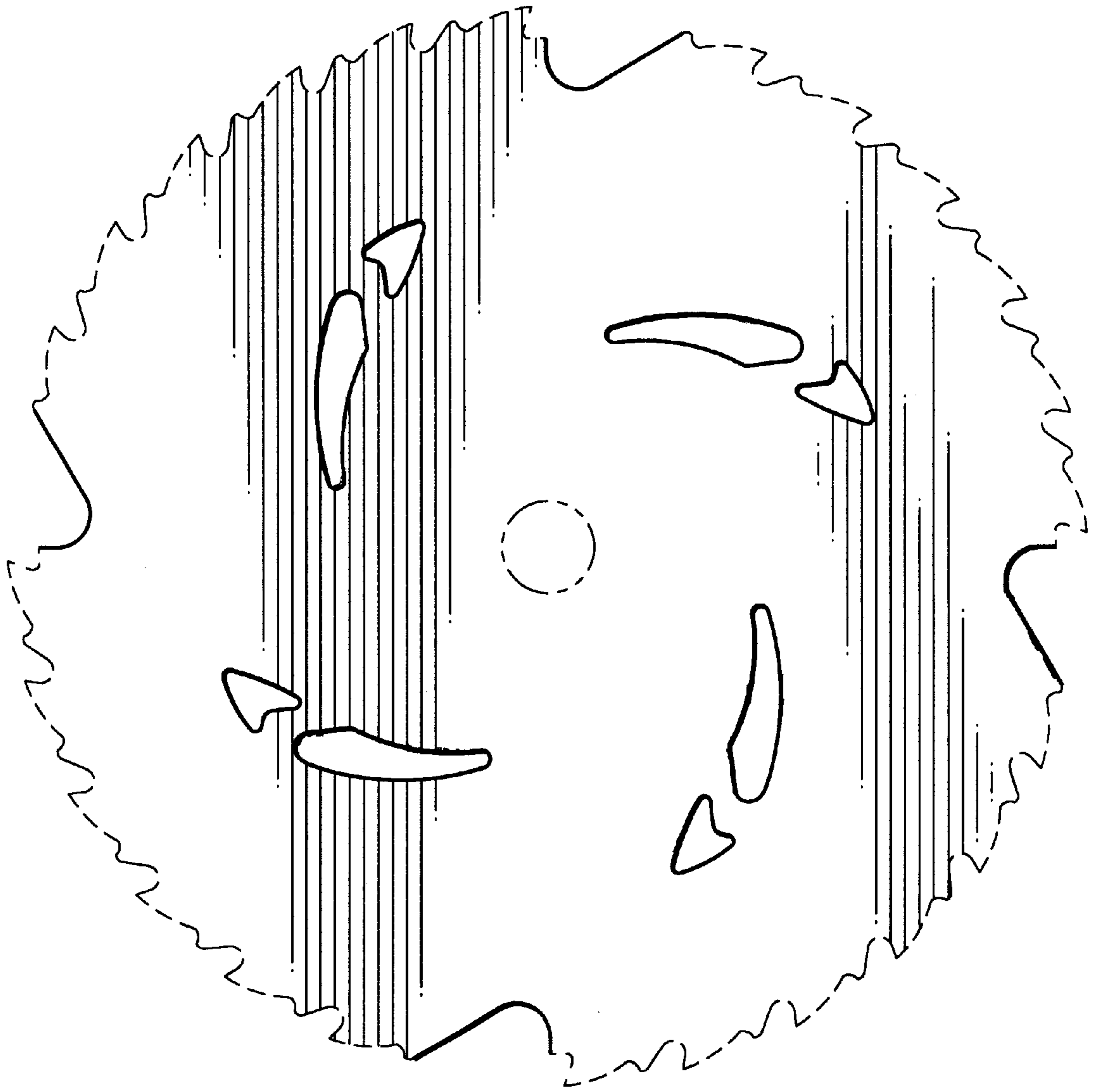

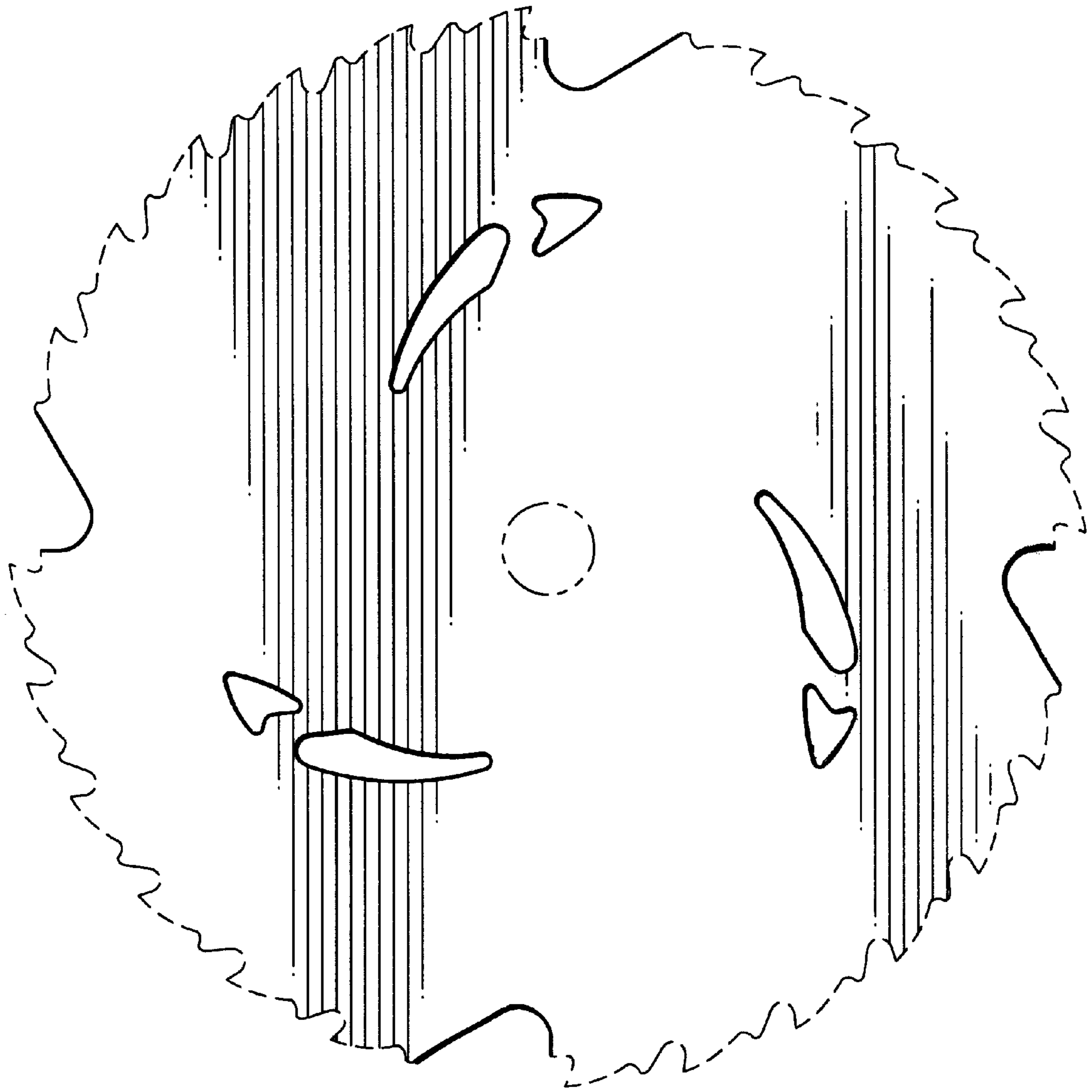

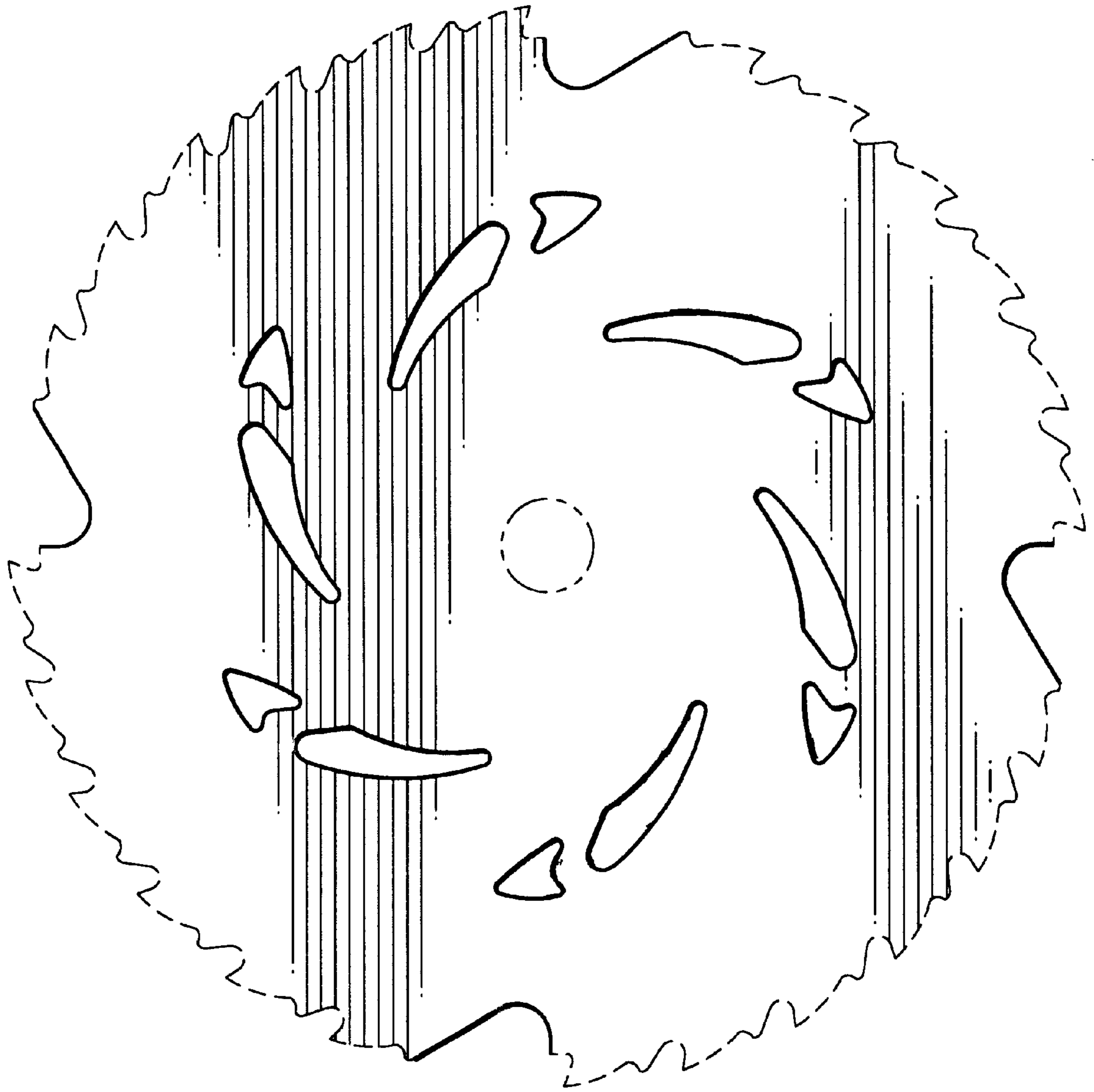
