(57) **CLAIM**

The ornamental design for a housing of an electronic extender, as shown in the Figures.

DESCRIPTION

FIG. 1 is a front perspective view of the housing of an electronic extender, showing the front, top and one side of the housing;

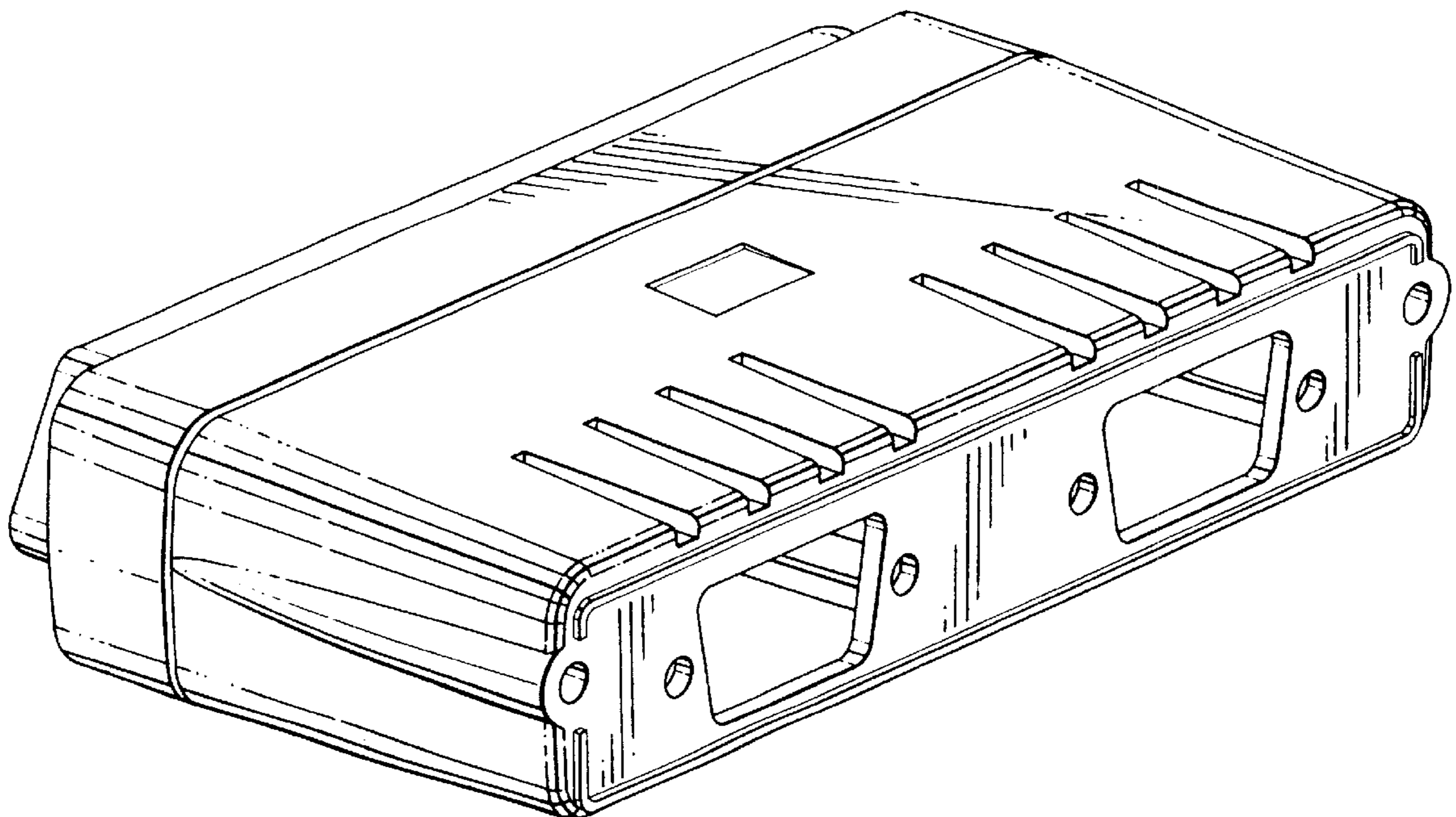
FIG. 2 is a perspective rear view of the housing, showing the top, rear and a said one side of the housing;

FIG. 3 is a perspective view from underneath of the housing, showing the front, the said one side and the bottom side of the housing;

FIG. 4 is a plan view from above of the housing; and,

FIG. 5 is a side view showing a second side of the housing.

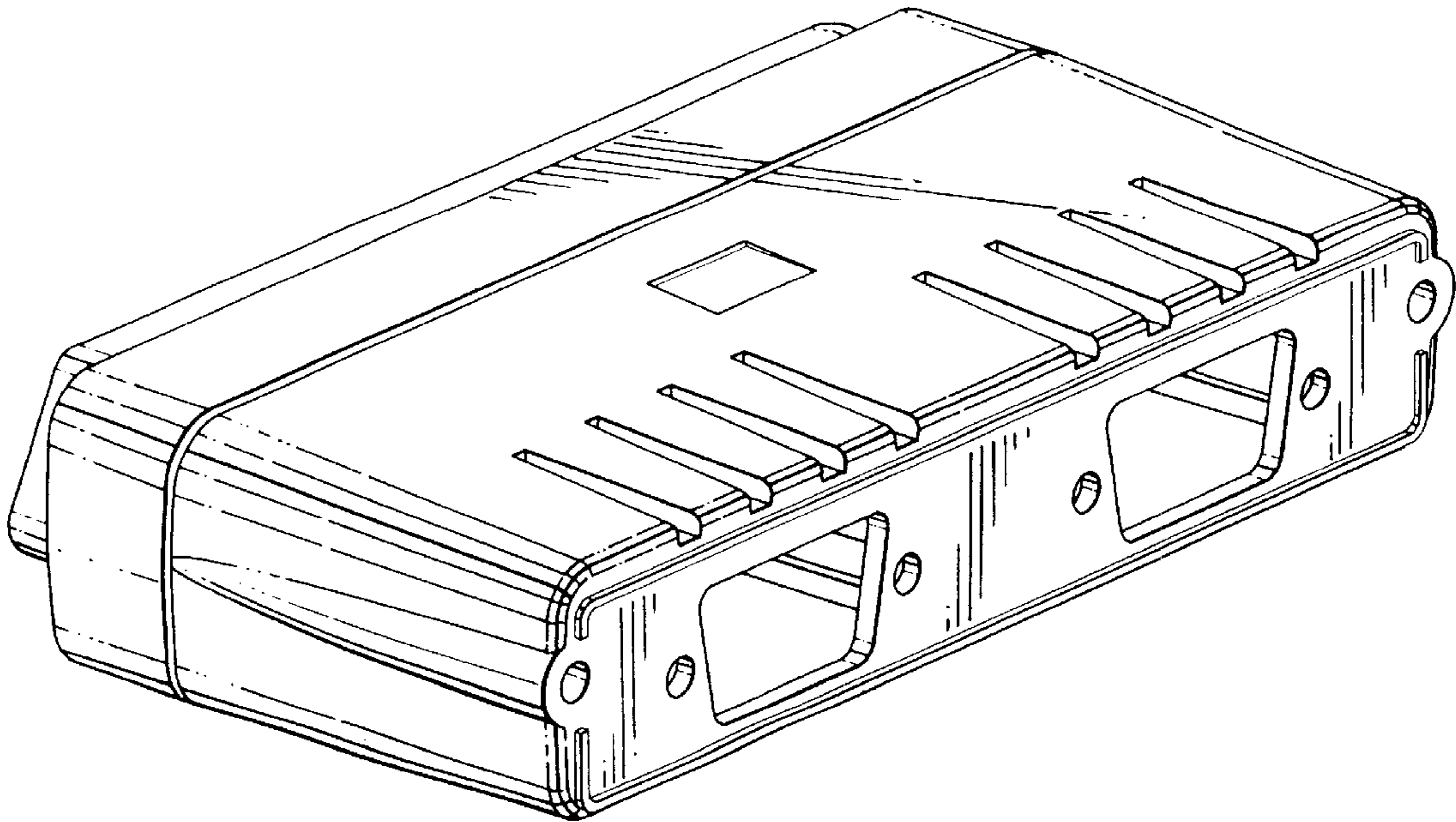

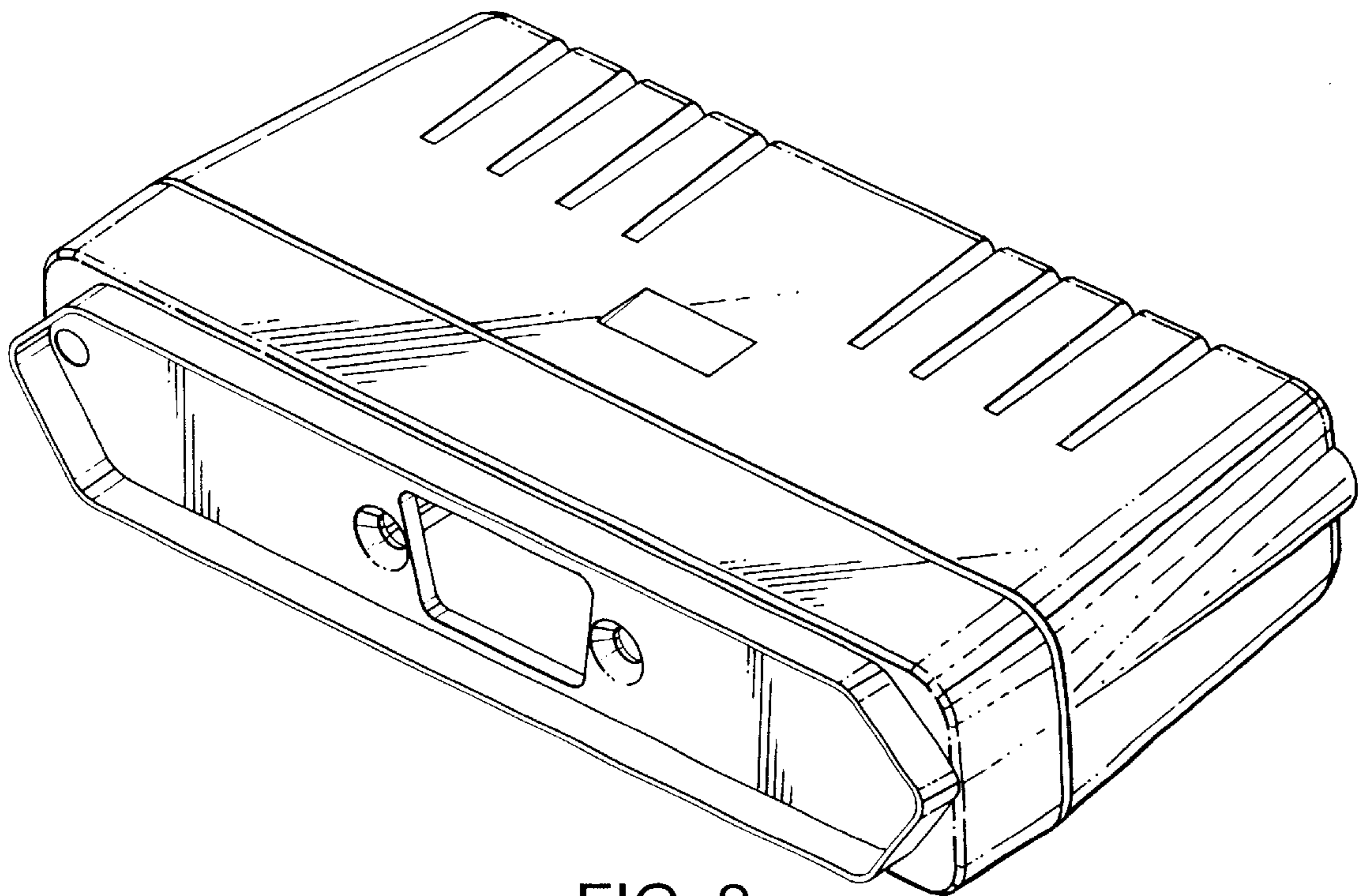

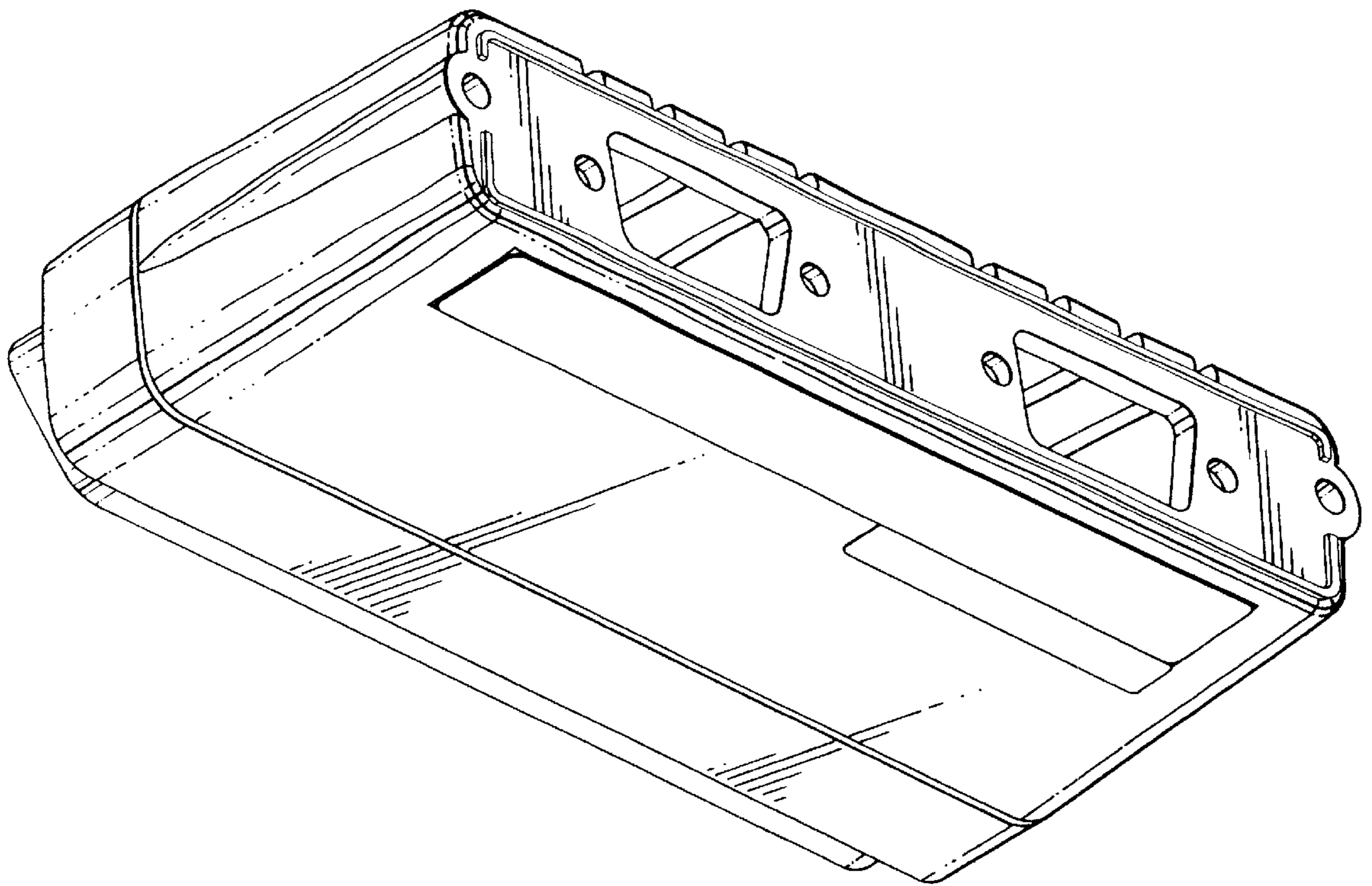

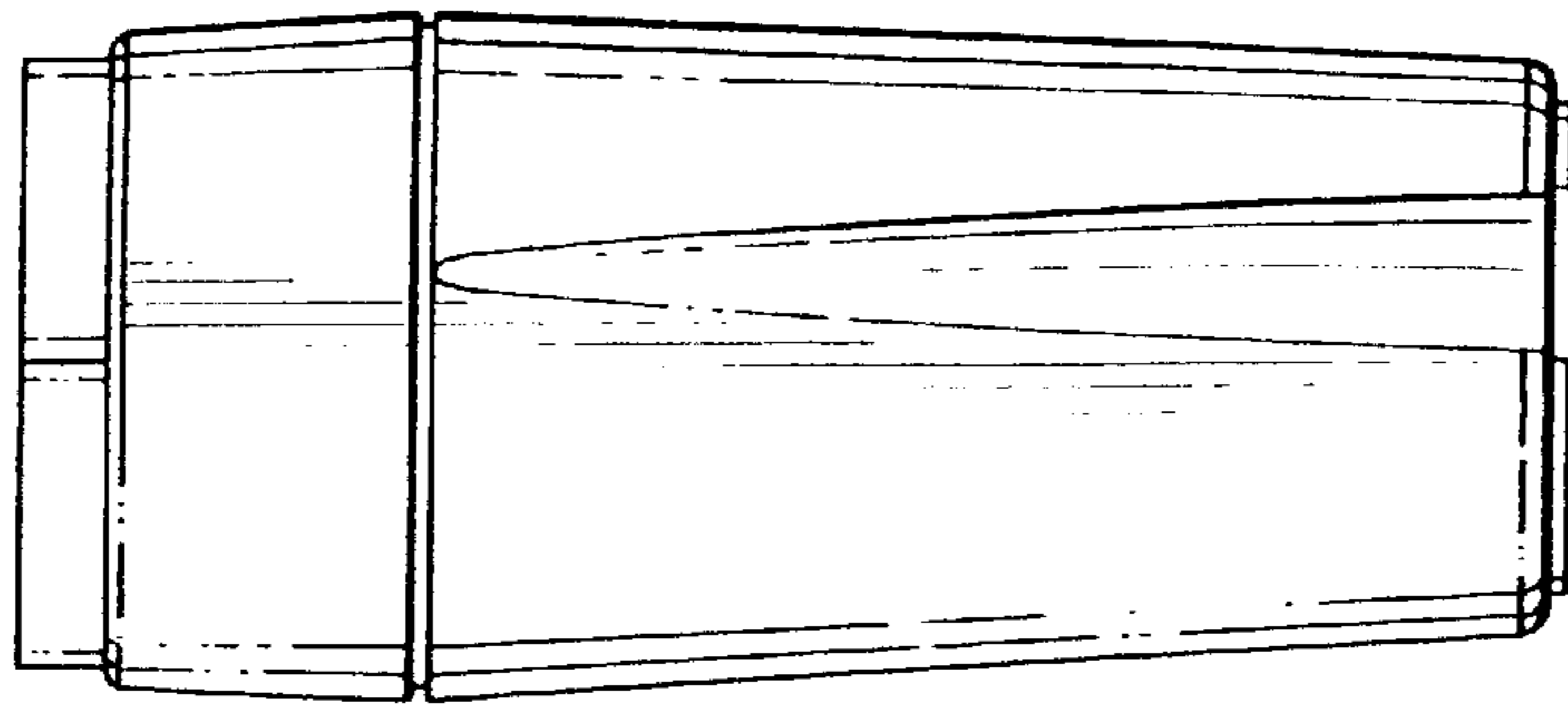

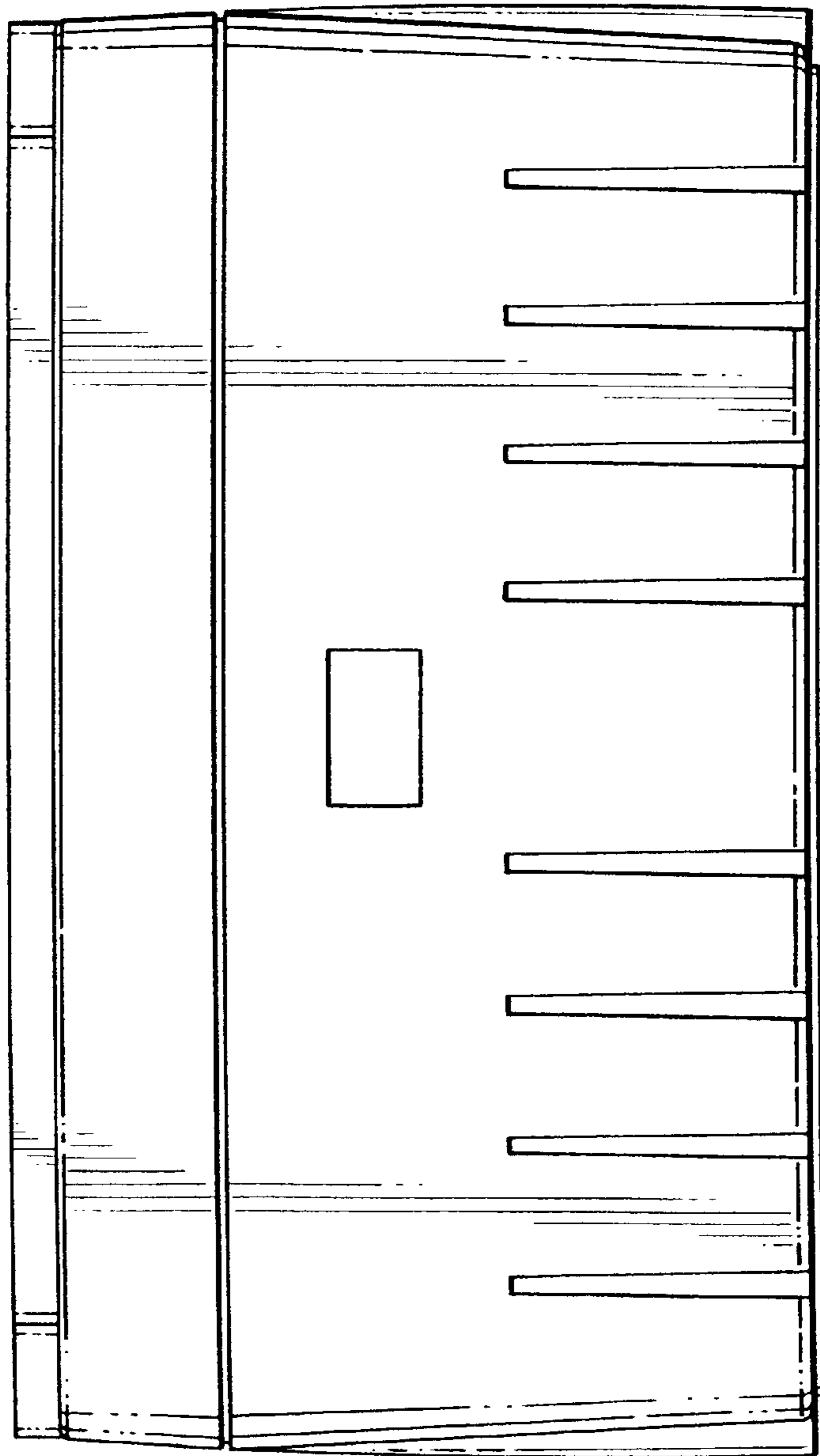
