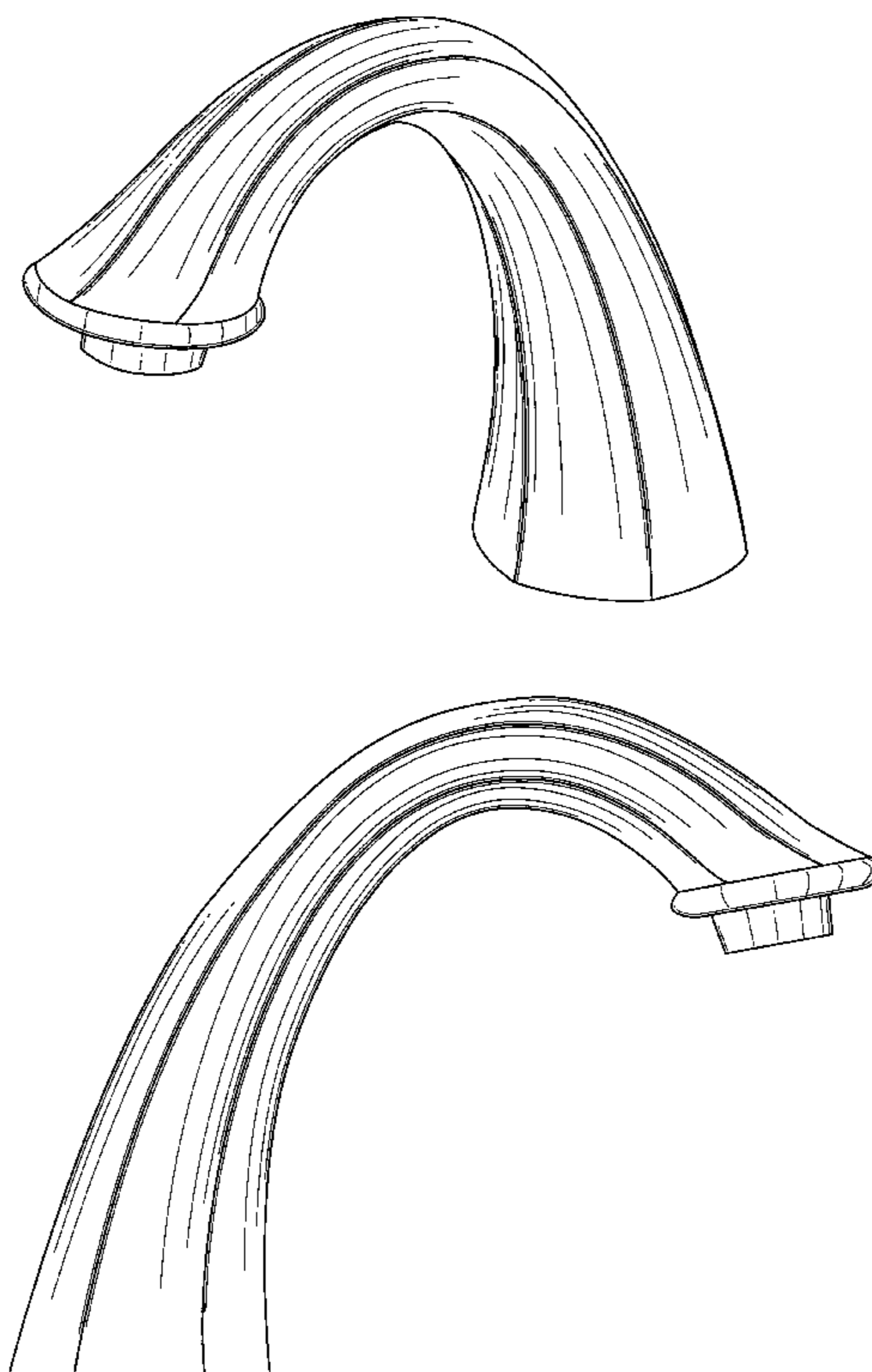
(57) **CLAIM**

The ornamental design for a spout, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the new design for a spout; FIG. 2 is a front elevational view of the new design for a spout; FIG. 3 is a rear elevational view of the new design for a spout; FIG. 4 is a right side elevational view of the new design for a spout, the left side elevational view being a mirror image; FIG. 5 is a top plan view of the new design for a spout; and, FIG. 6 is a bottom plan view of the new design for a spout.

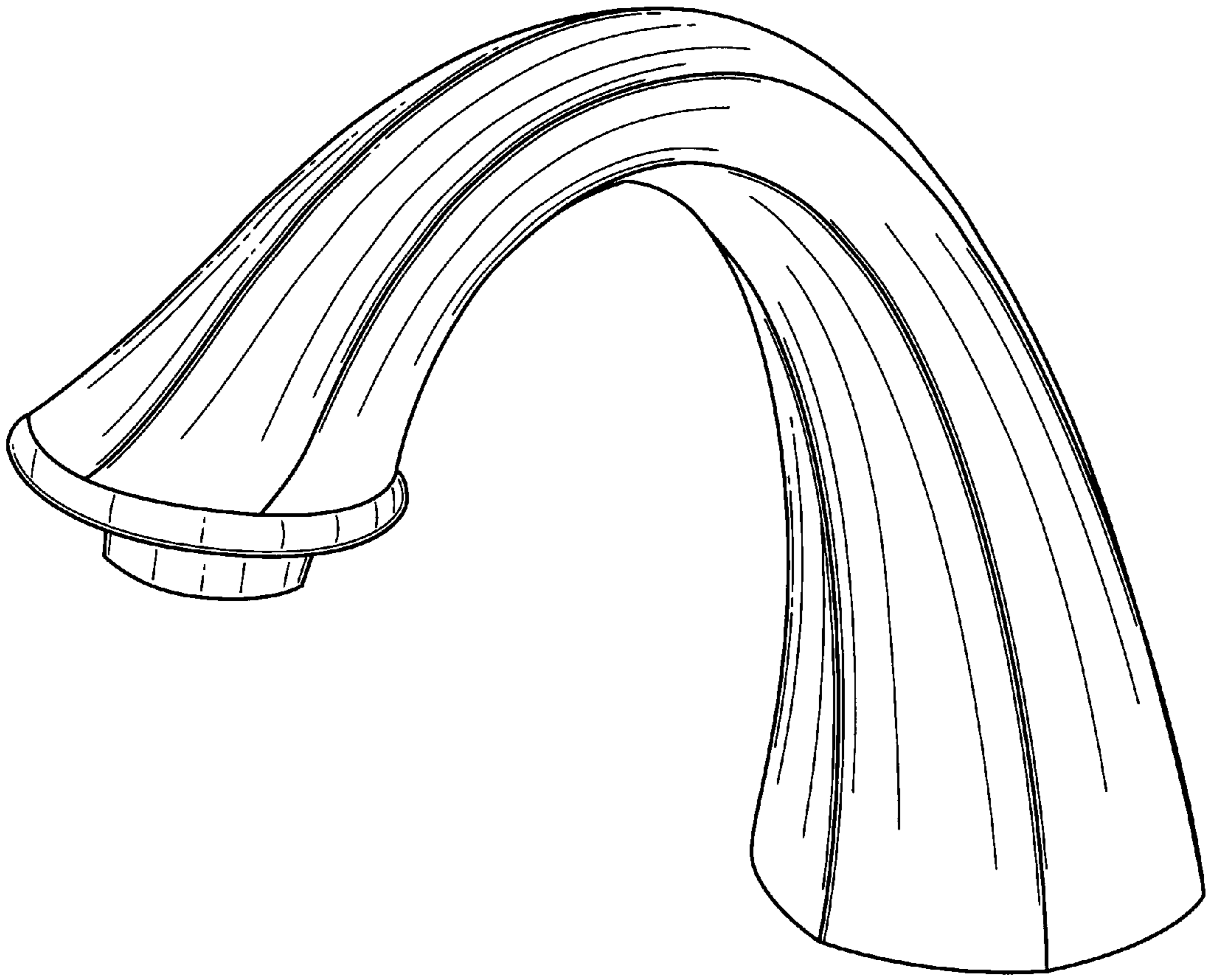

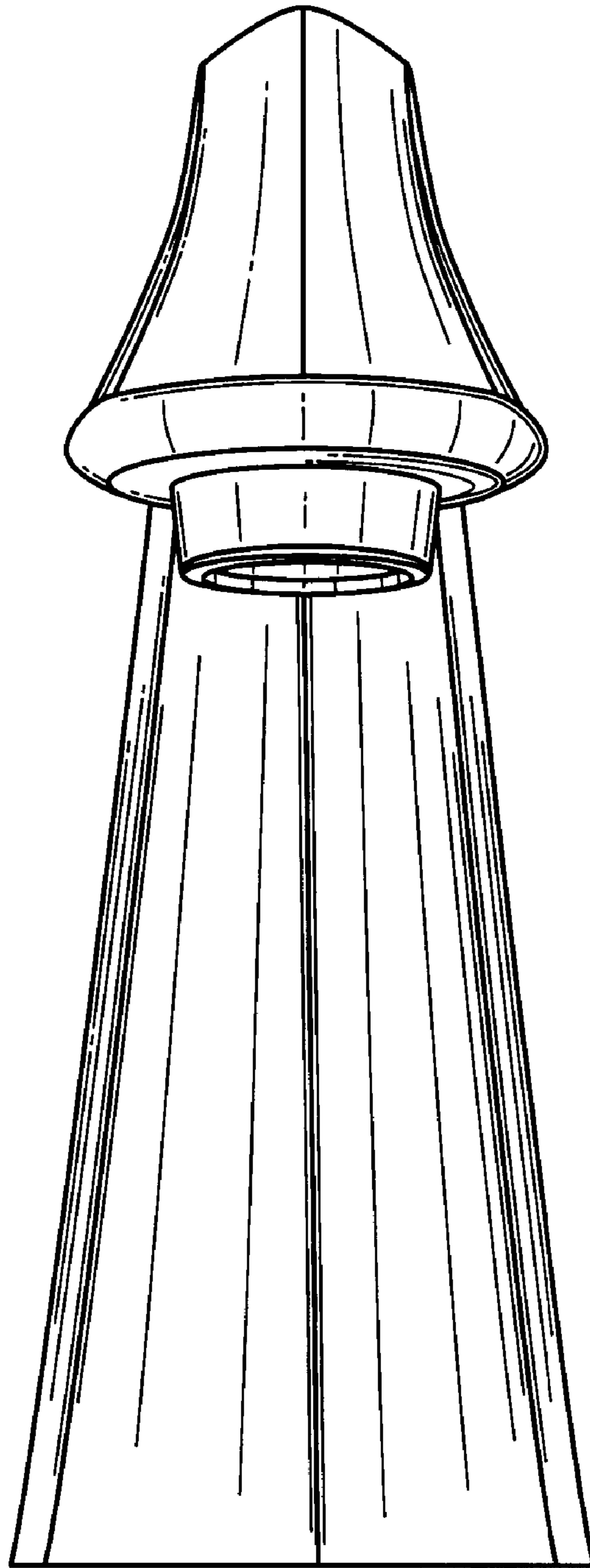

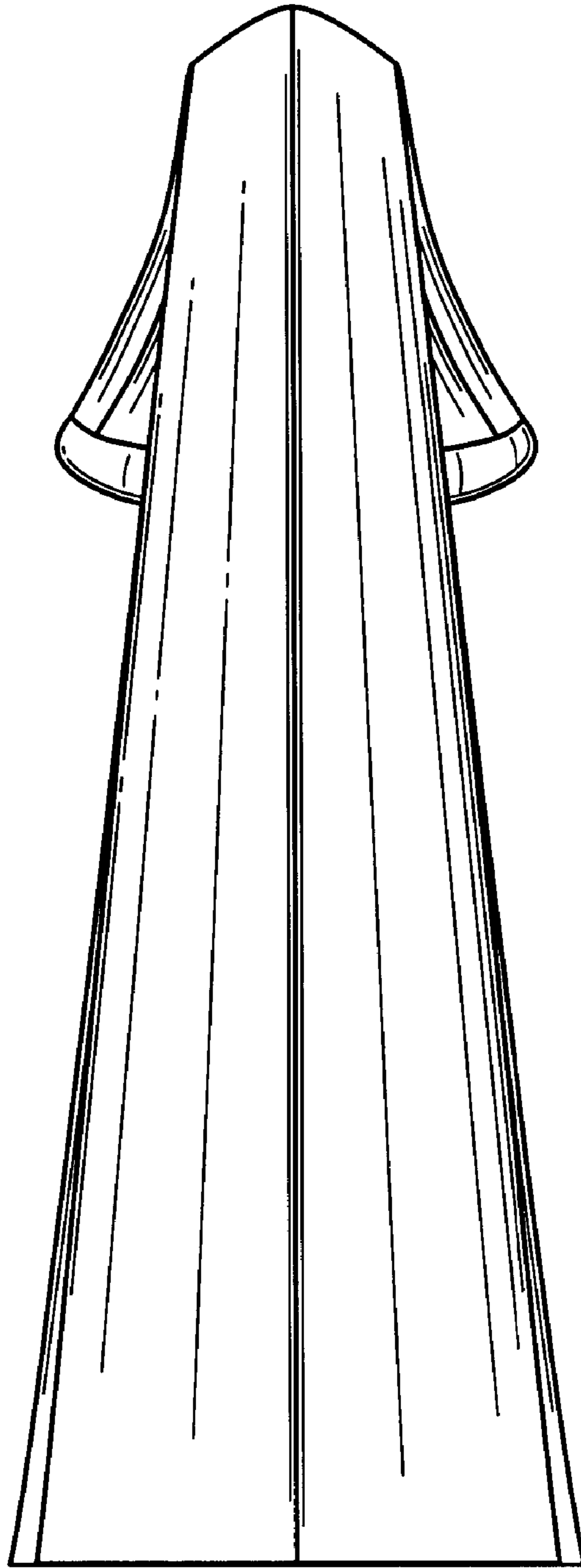

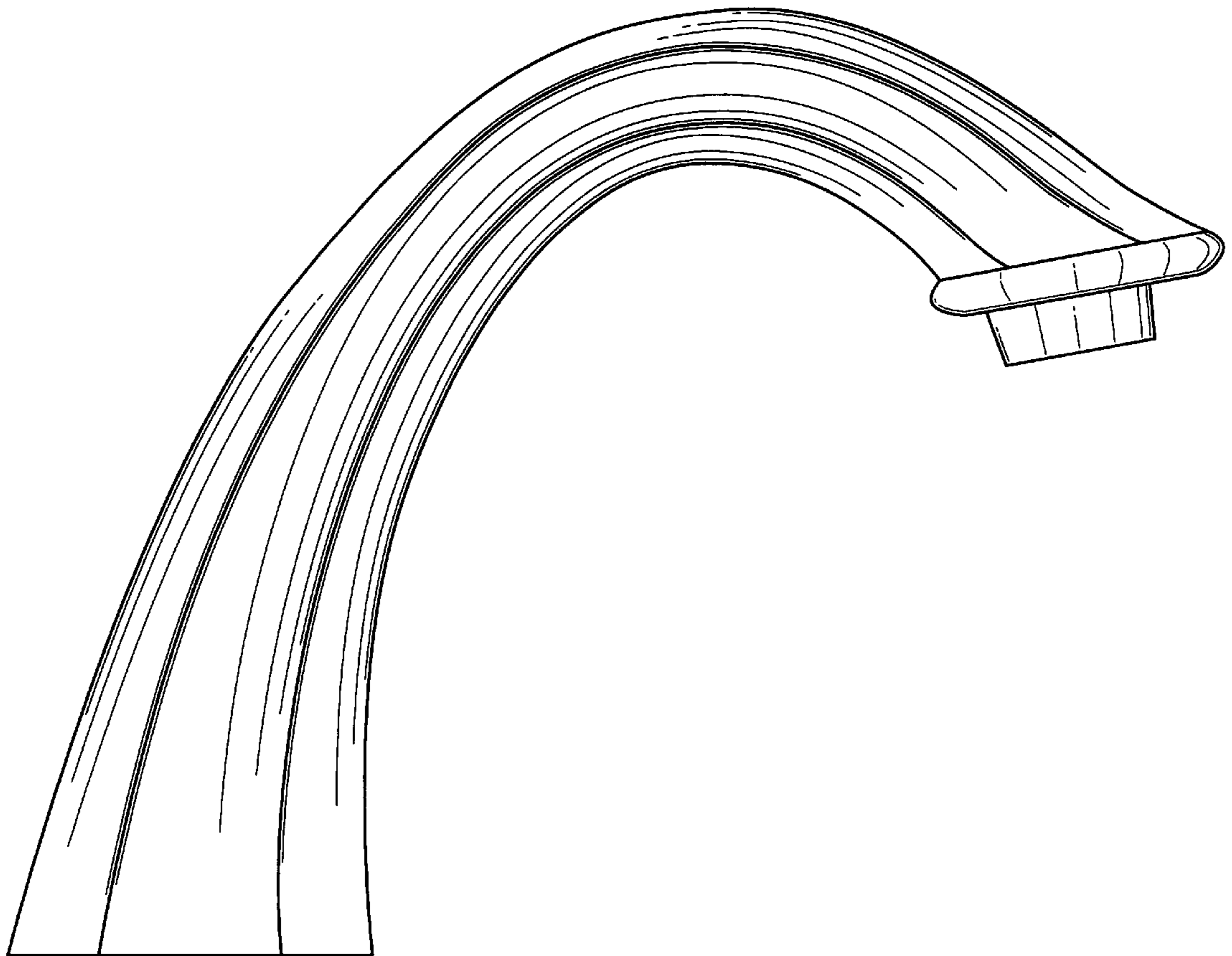

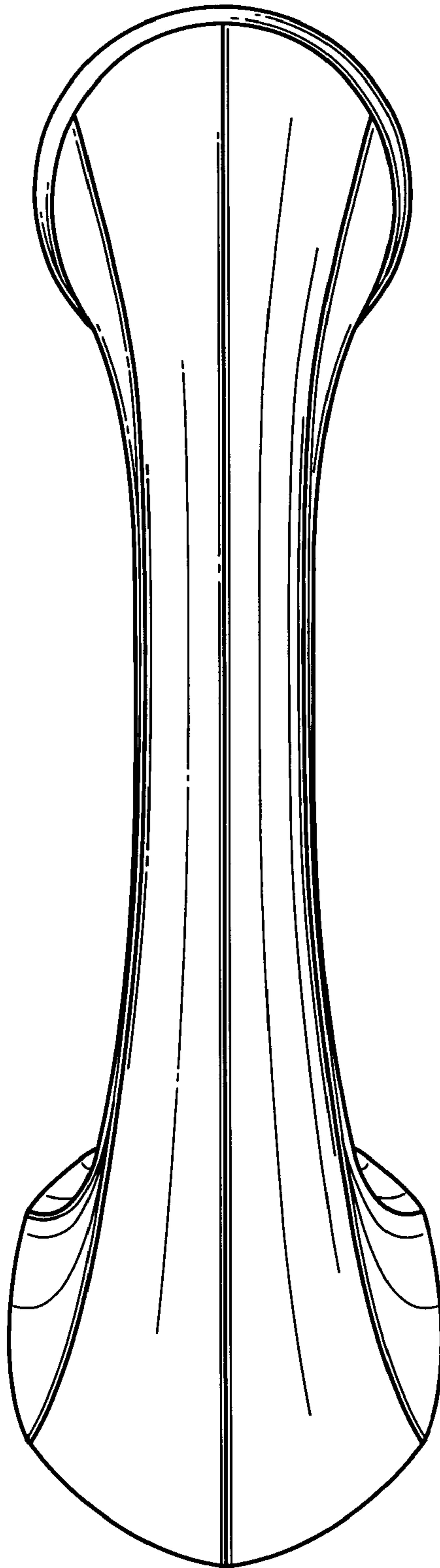

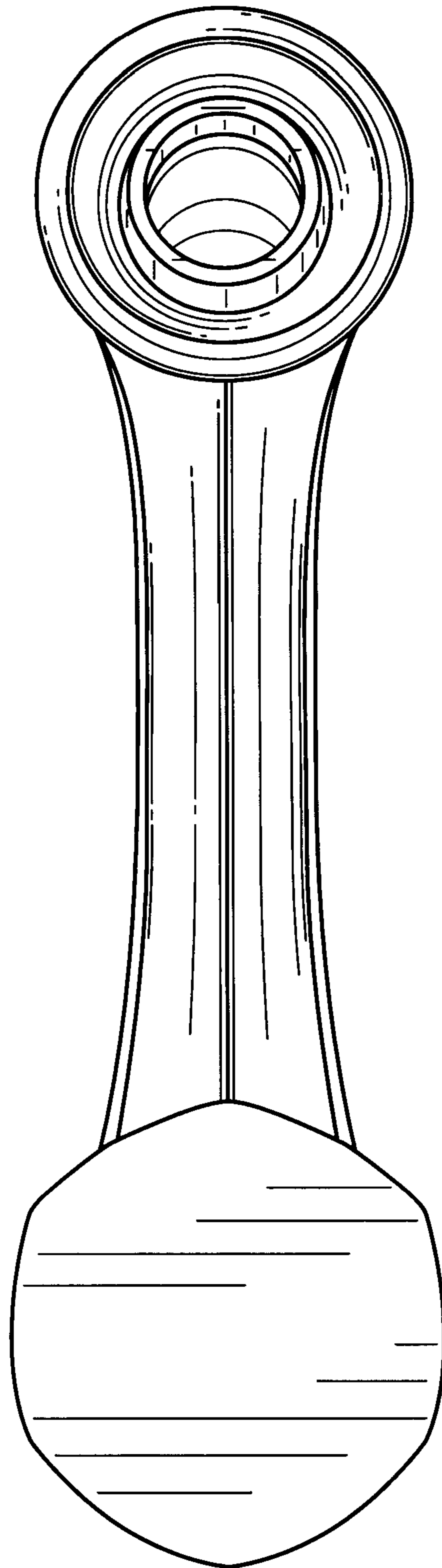
