FIG. 2 is a bottom plan view thereof.

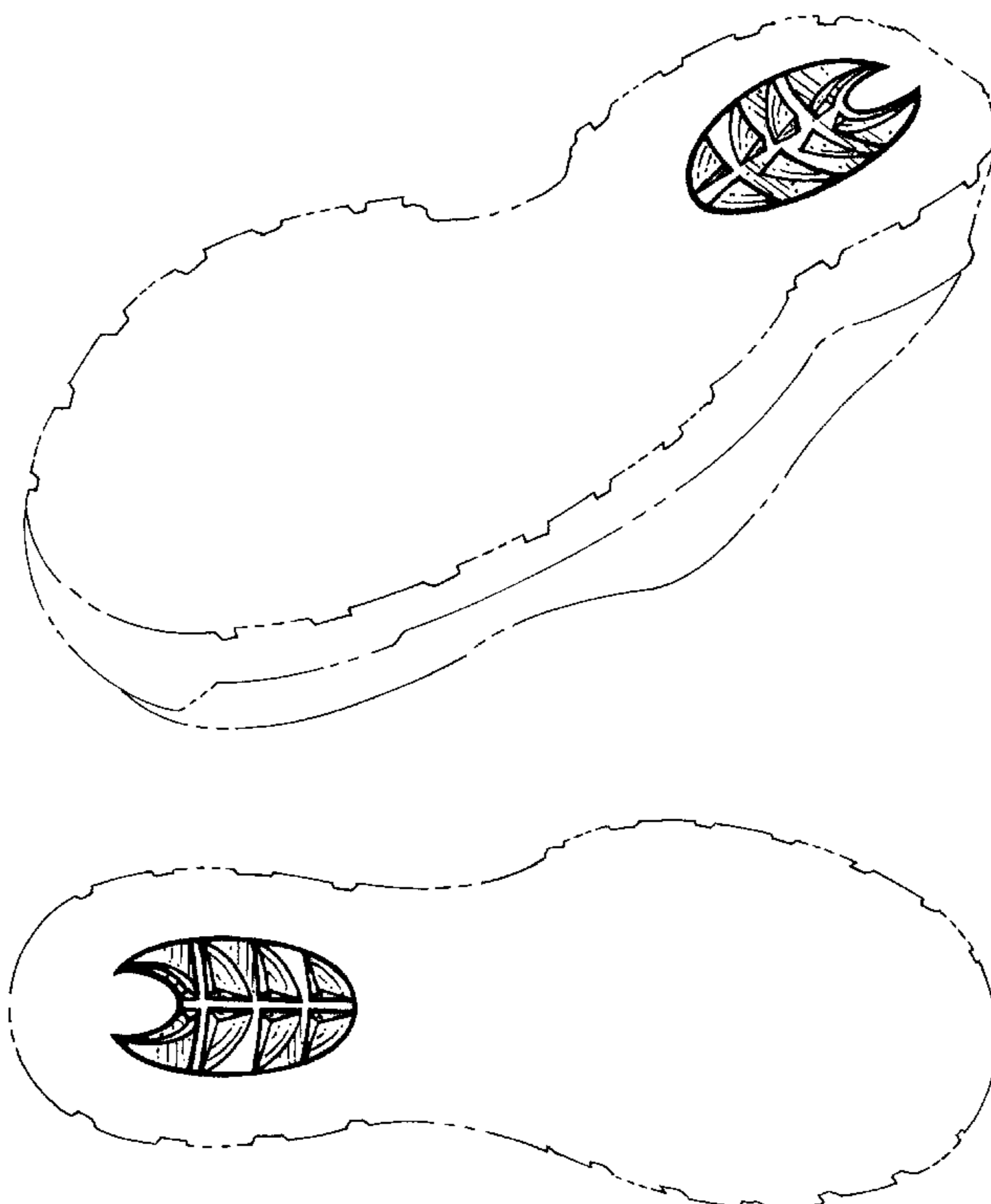
The broken line showing the sole in the Figures is for illustrative purposes only and forms no part of the claimed design.

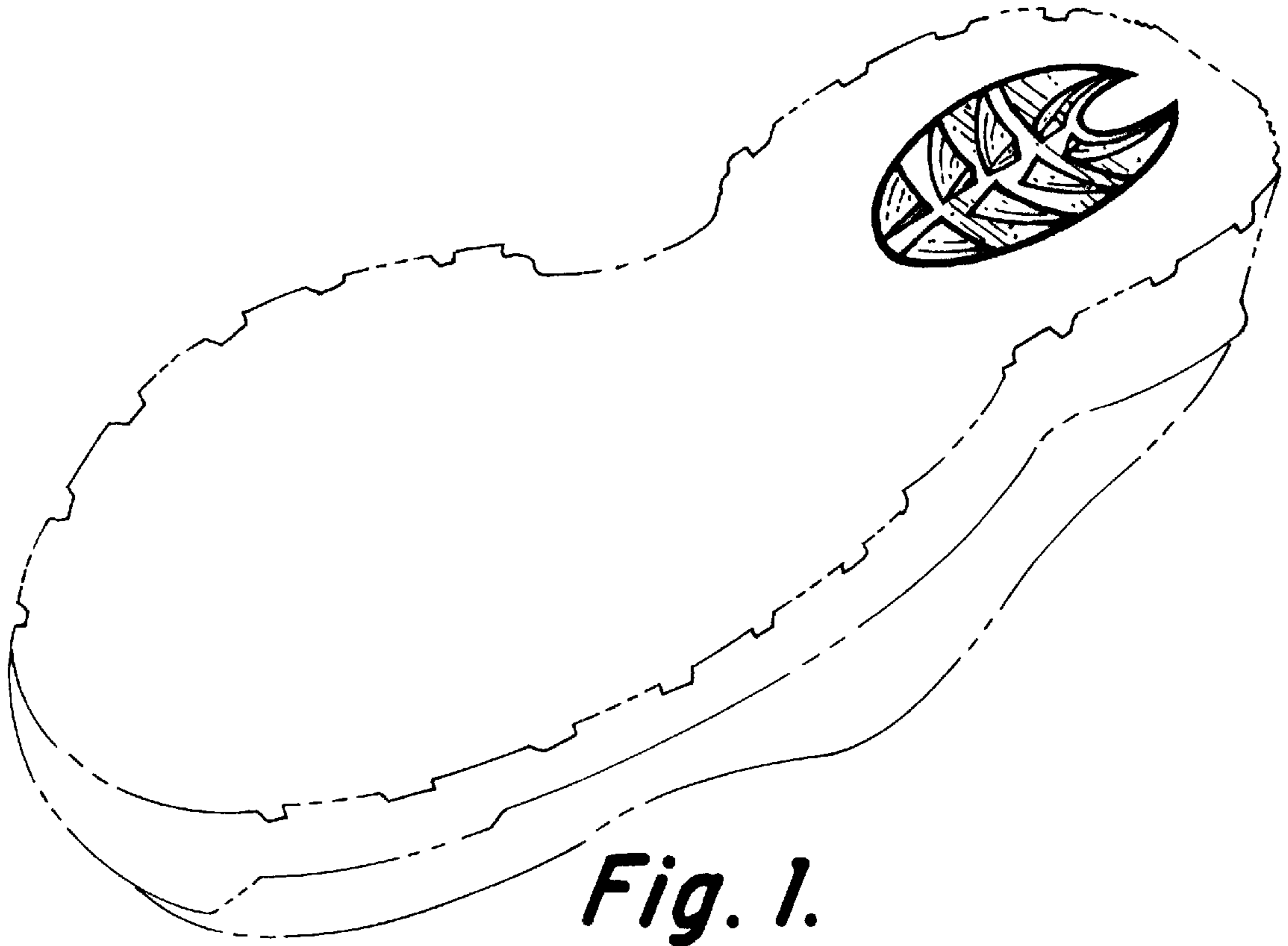

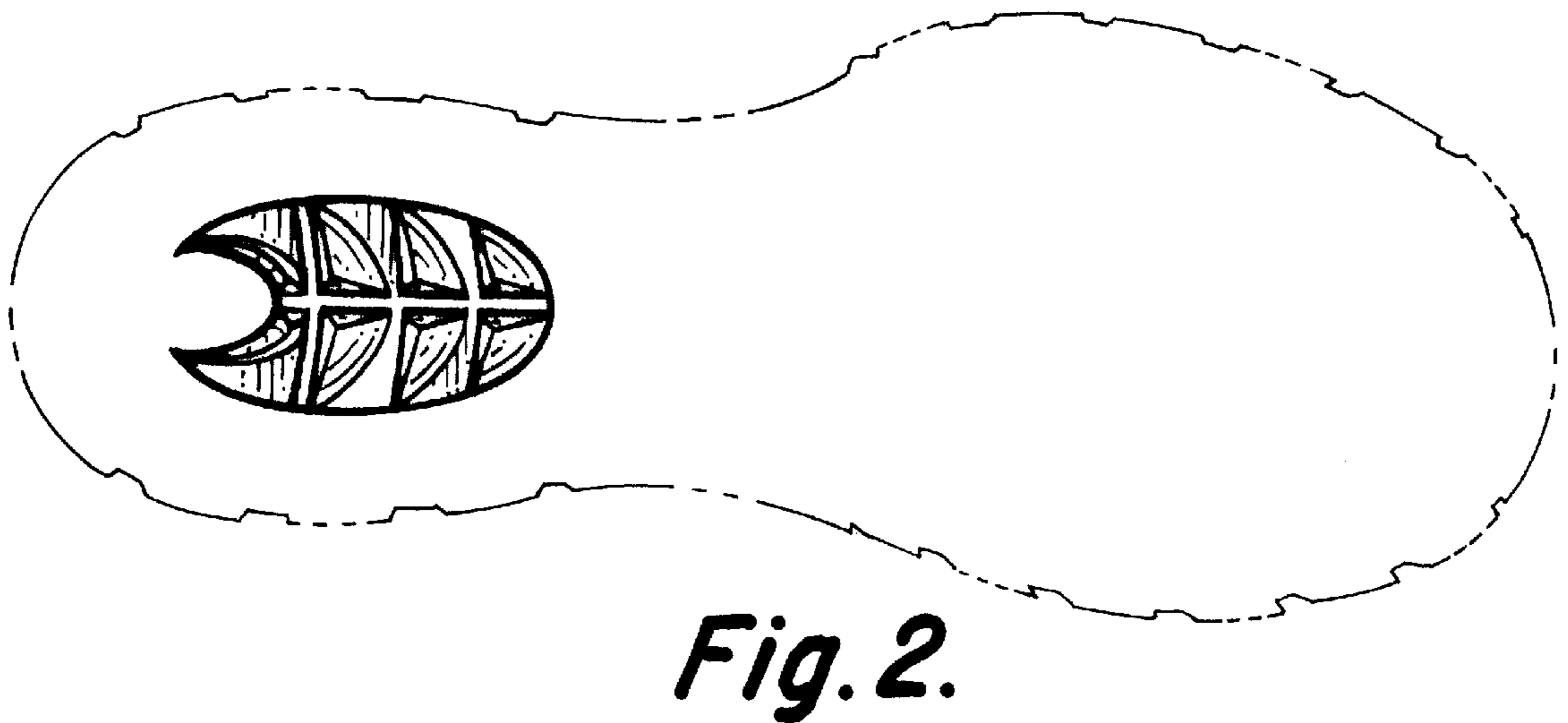
