(57) **CLAIM**

The ornamental design for a portion of a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a portion of a shoe showing my new design;

FIG. 2 is a rear perspective view thereof; and,

FIG. 3 is a side view thereof.

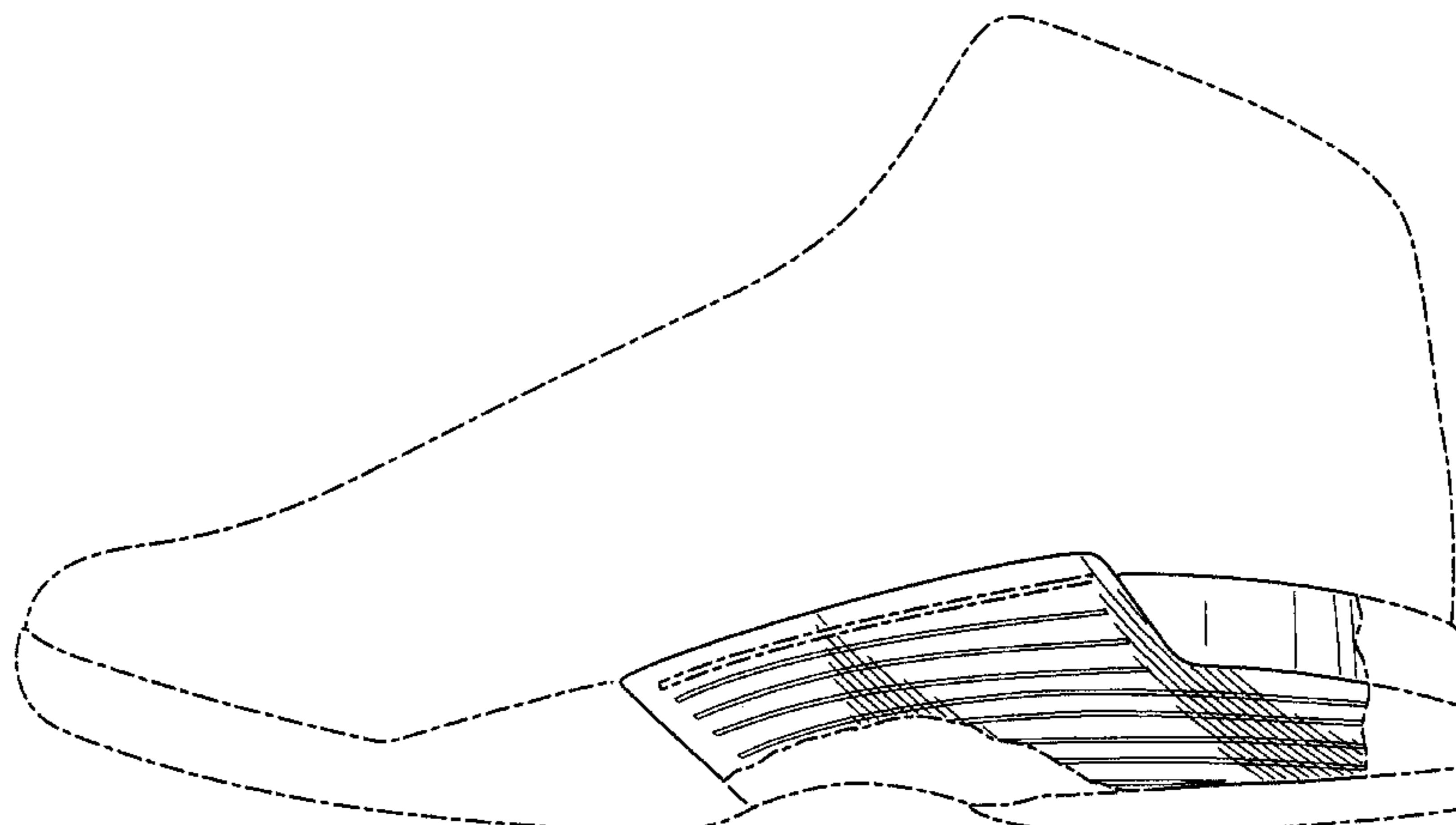

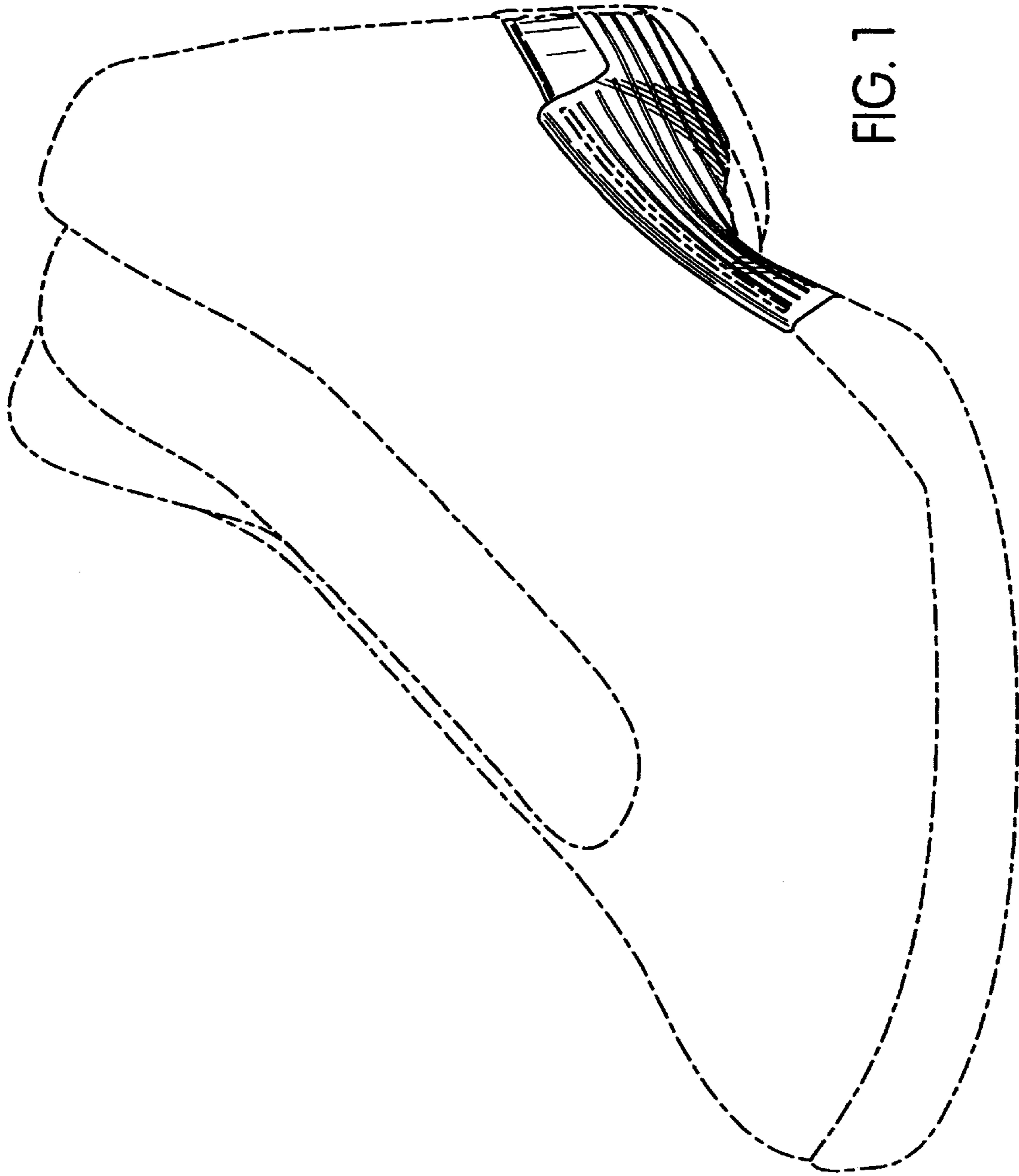

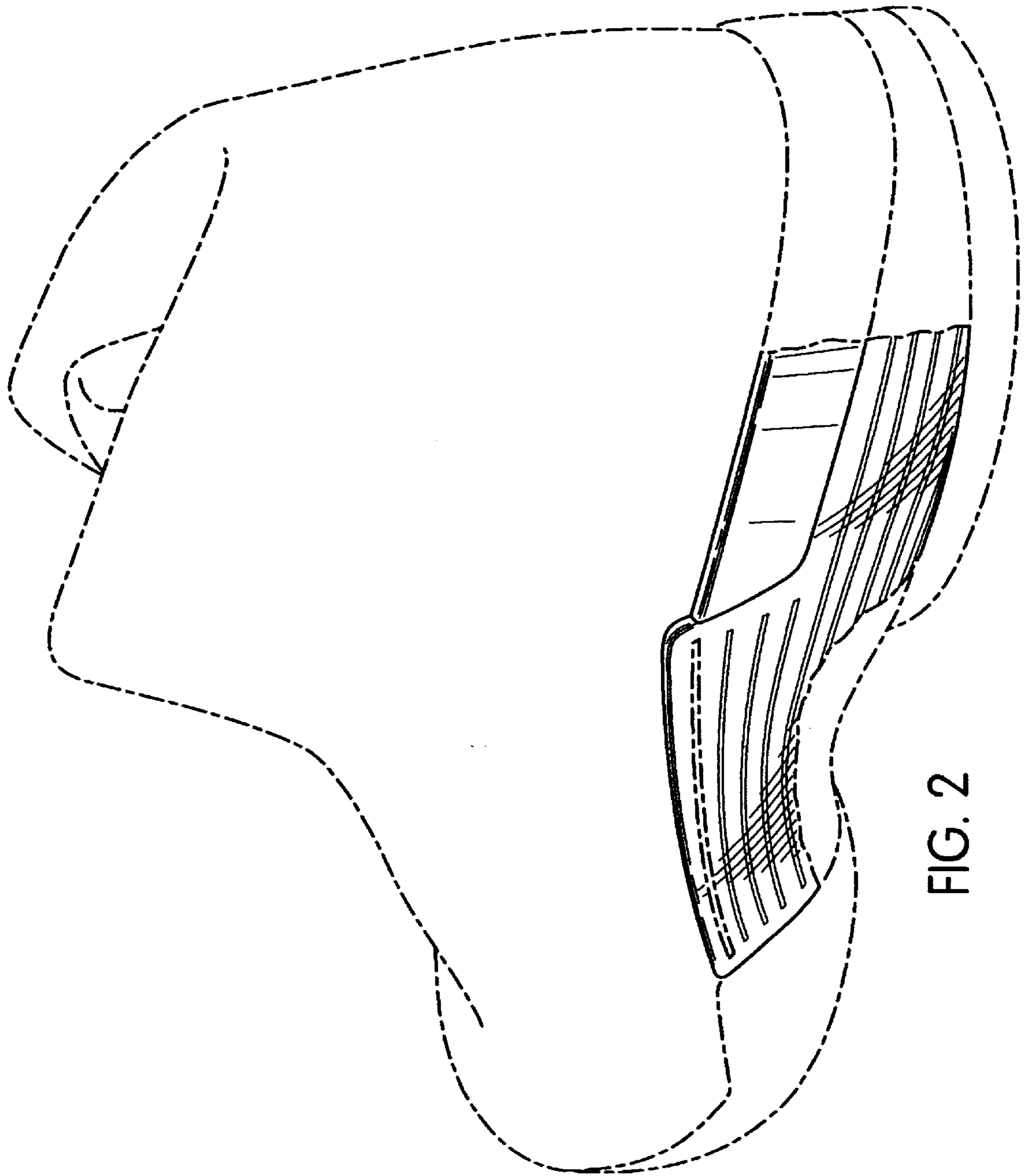

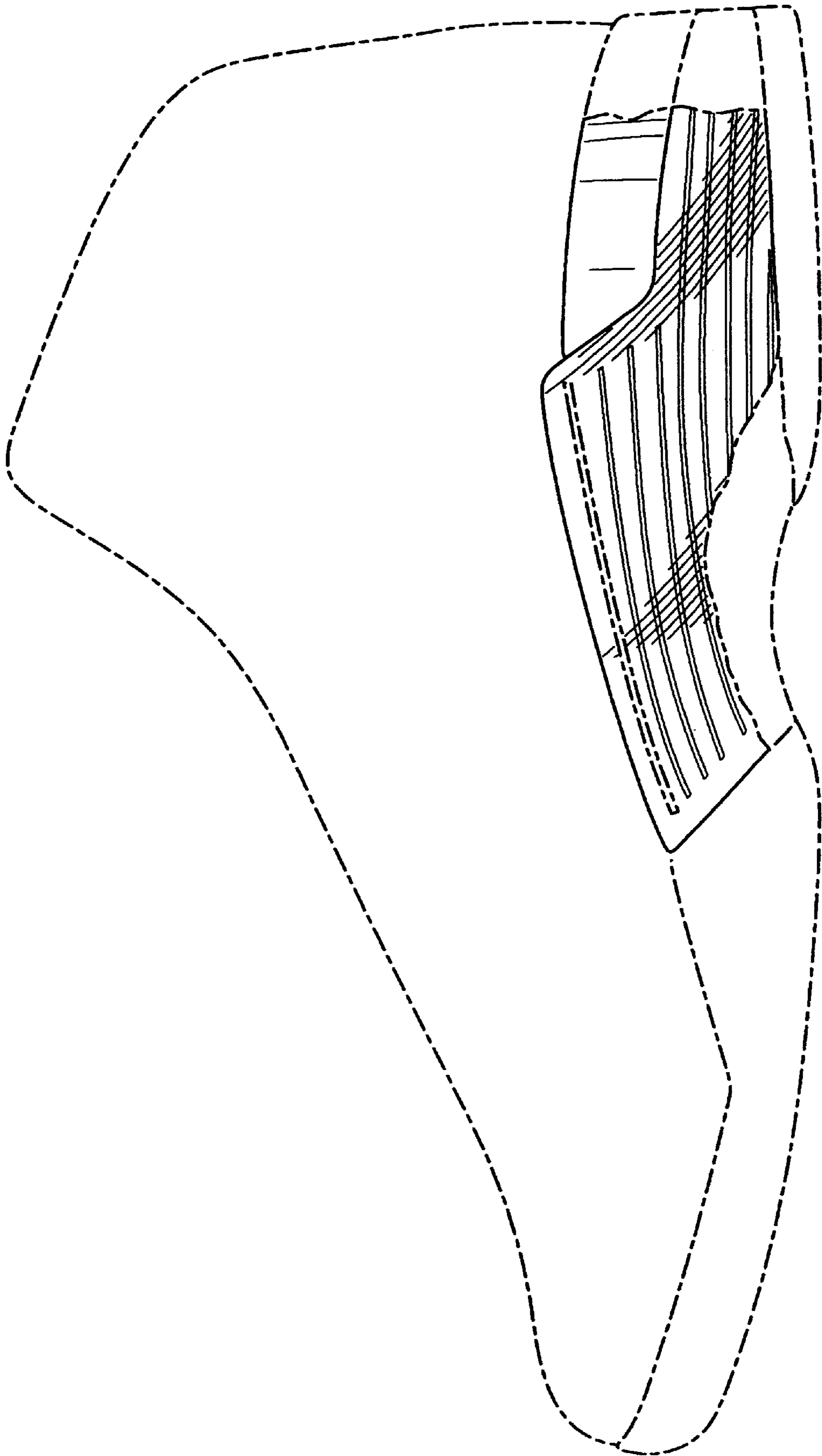
